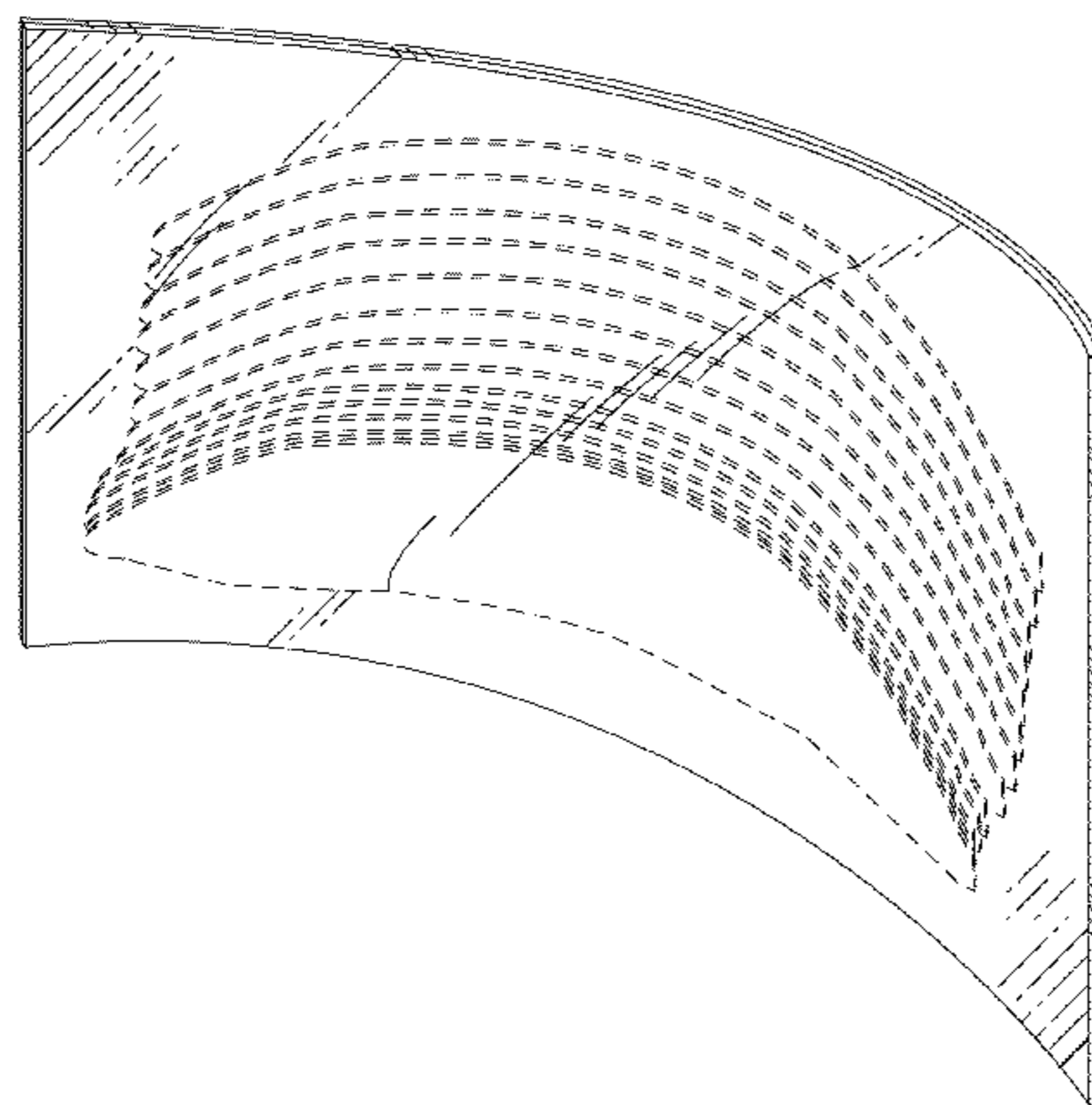
(57) **CLAIM**

The ornamental design for a package, as shown and described.

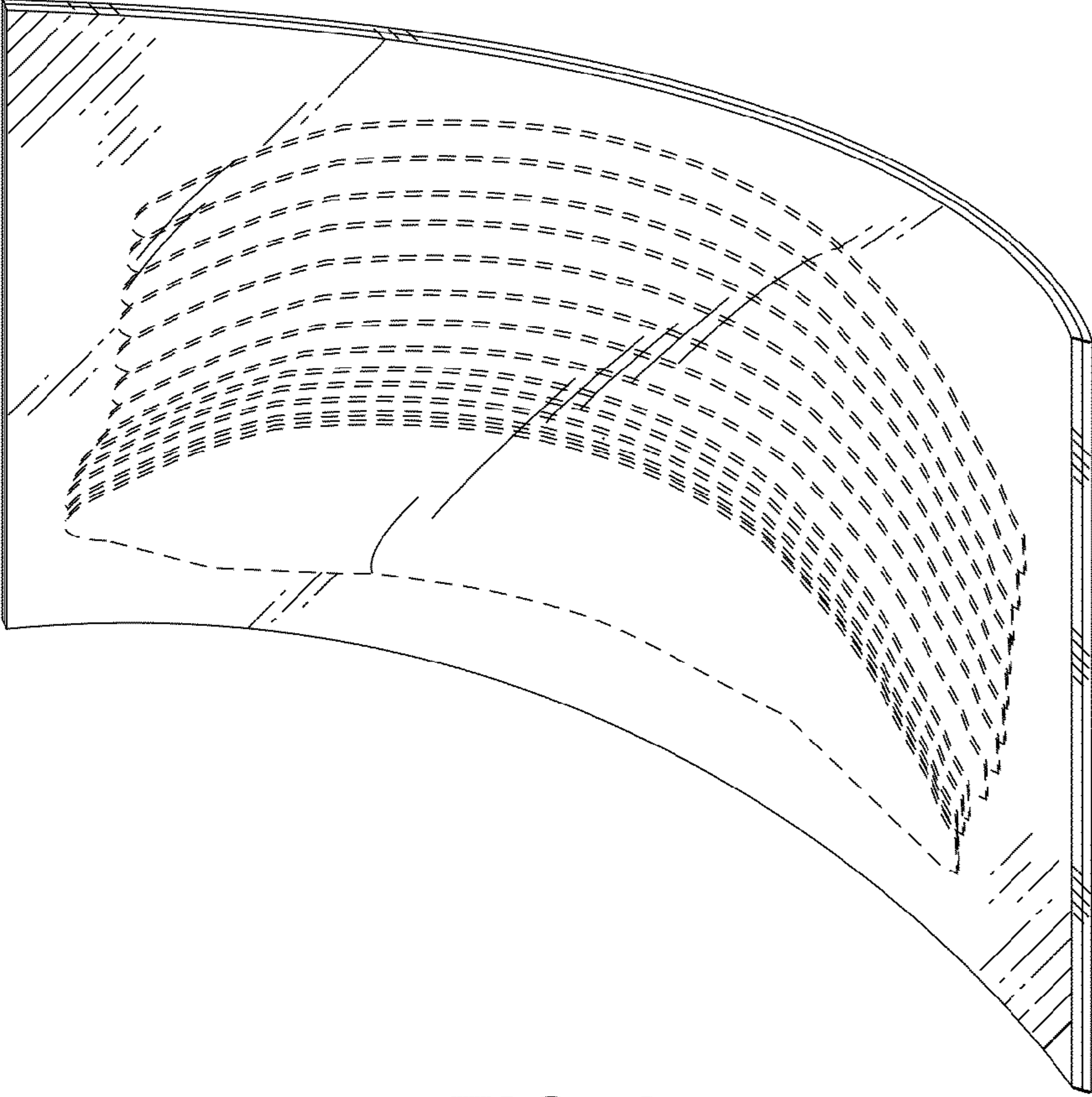
**DESCRIPTION**

 The broken lines shown represent unclaimed subject matter and form no part of the claimed design.

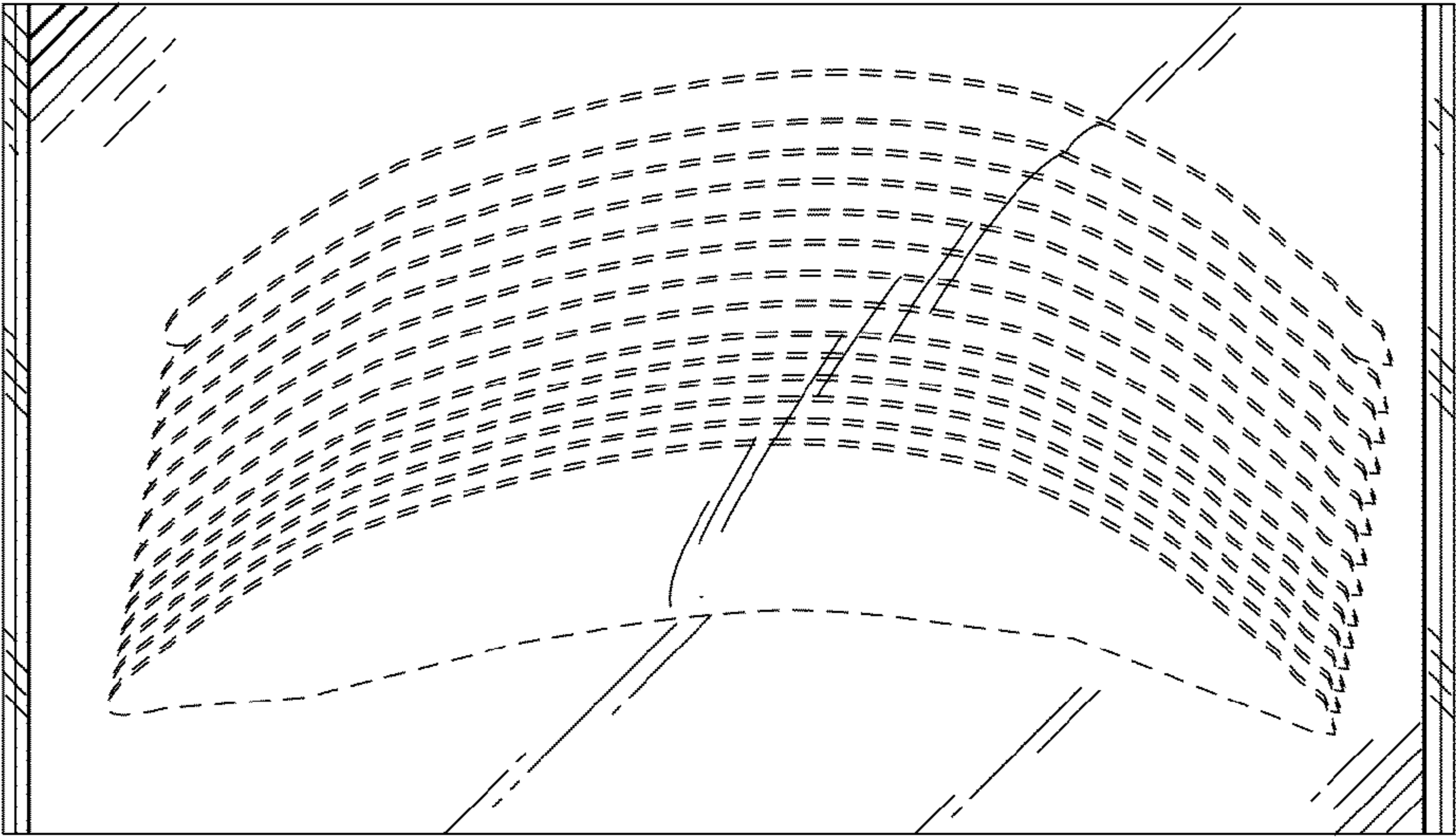

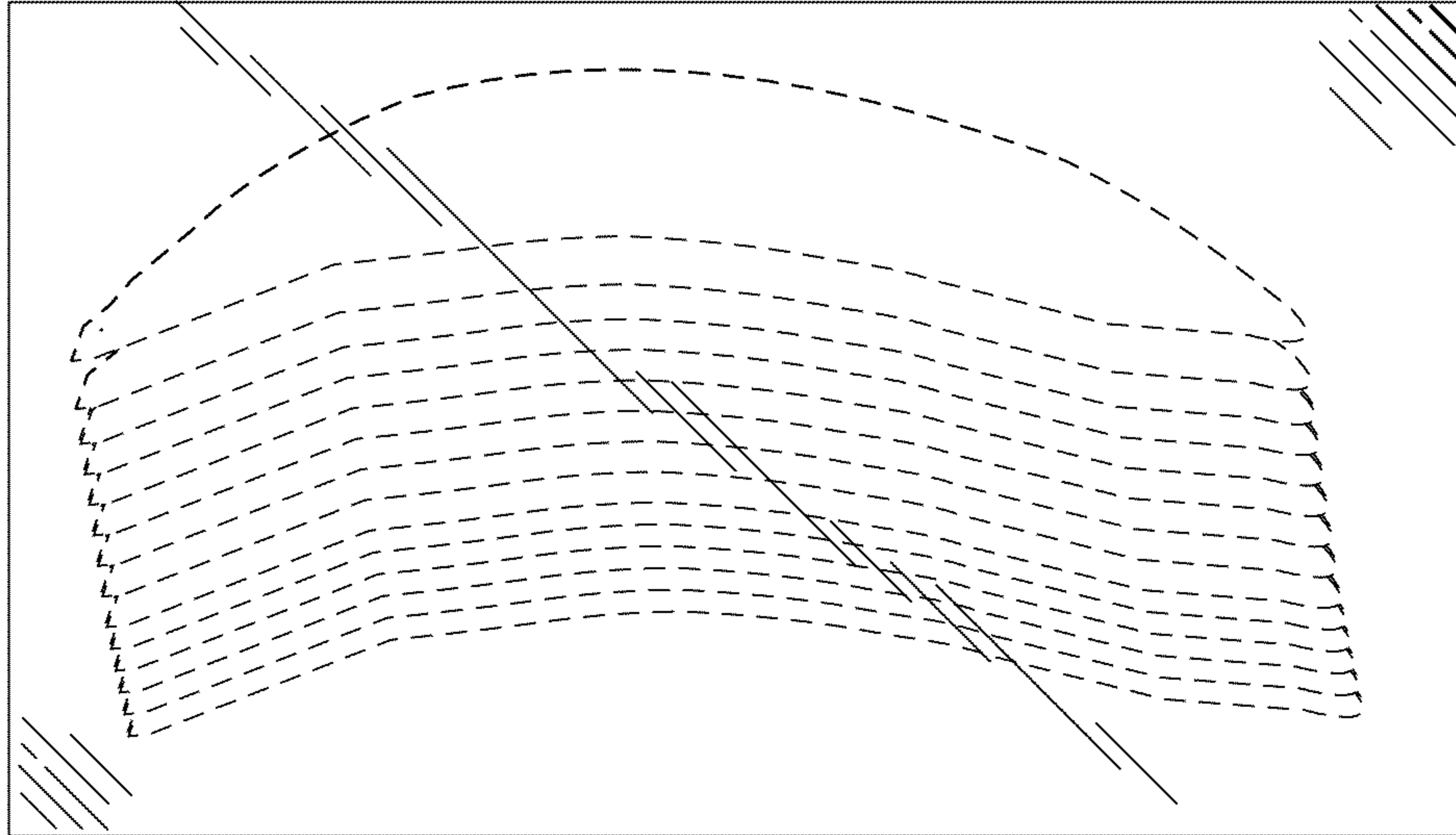

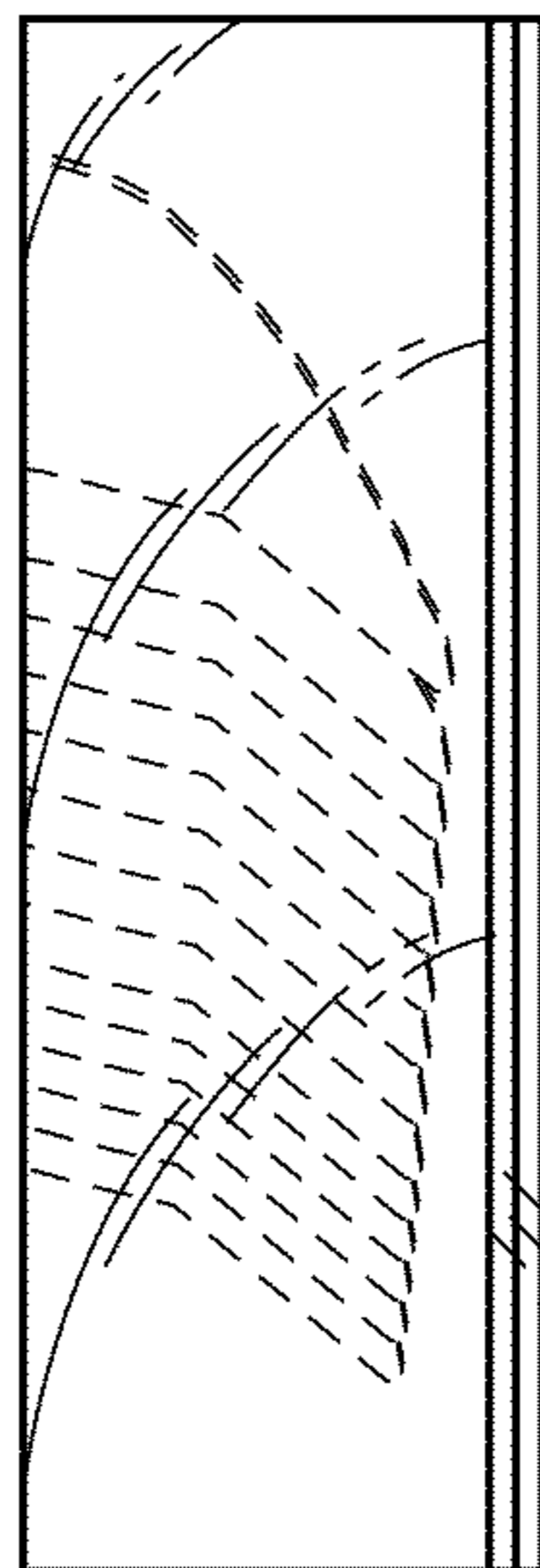

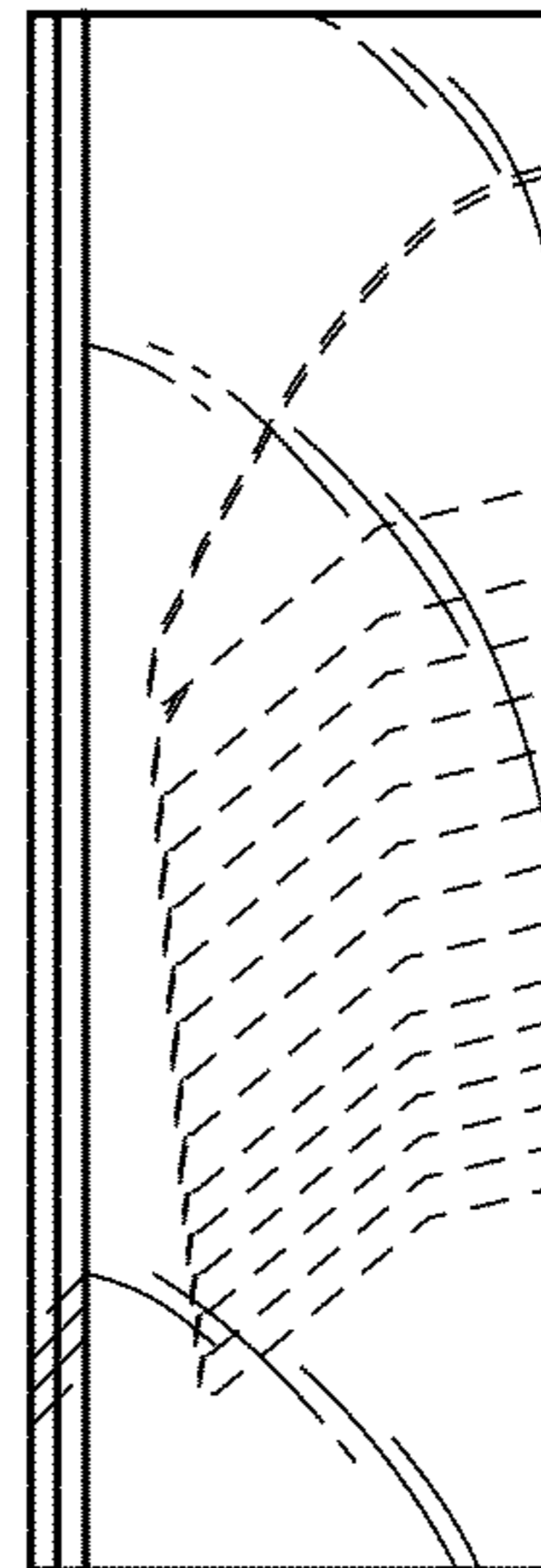

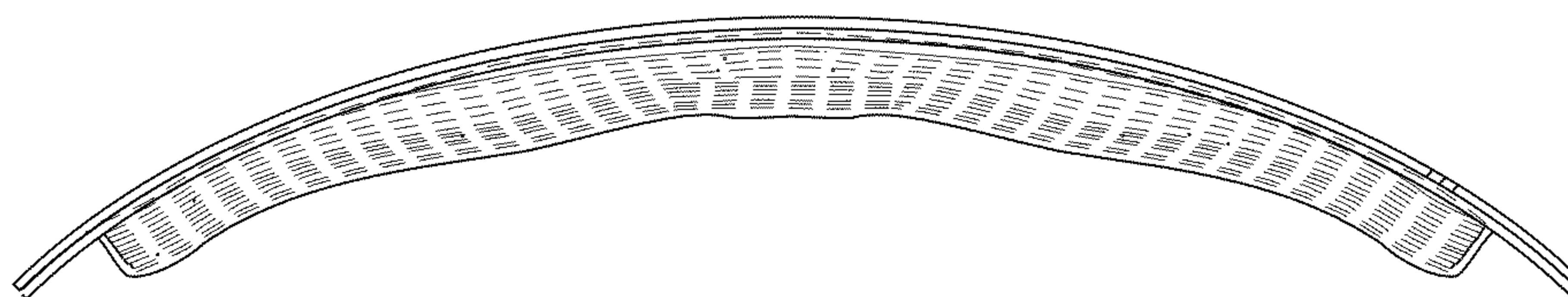
