(57) **CLAIM**

The ornamental design for a hopper wagon, as shown and described.

**DESCRIPTION**

FIG. 1 depicts a perspective underside view of a hopper railway wagon in accordance with the invention with the inlet doors and the outlet doors closed;

FIG. 2 depicts a perspective view of the hopper railway wagon of FIG. 1 with the inlet doors open and the outlet doors closed;

FIG. 3 depicts an end view of the hopper railway wagon of FIG. 1 with the inlet doors and the outlet doors closed;

FIG. 4 depicts an end view of the hopper railway wagon of FIG. 1 with the inlet doors open and the outlet doors closed;

FIG. 5 depicts a side view of the hopper railway wagon of FIG. 1 with the inlet doors and the outlet doors closed;

FIG. 6 depicts a perspective view of the hopper railway wagon of FIG. 1 with the inlet doors and the outlet doors closed; and,

FIG. 7 depicts a top view of the hopper railway wagon of FIG. 1 with the inlet doors closed.

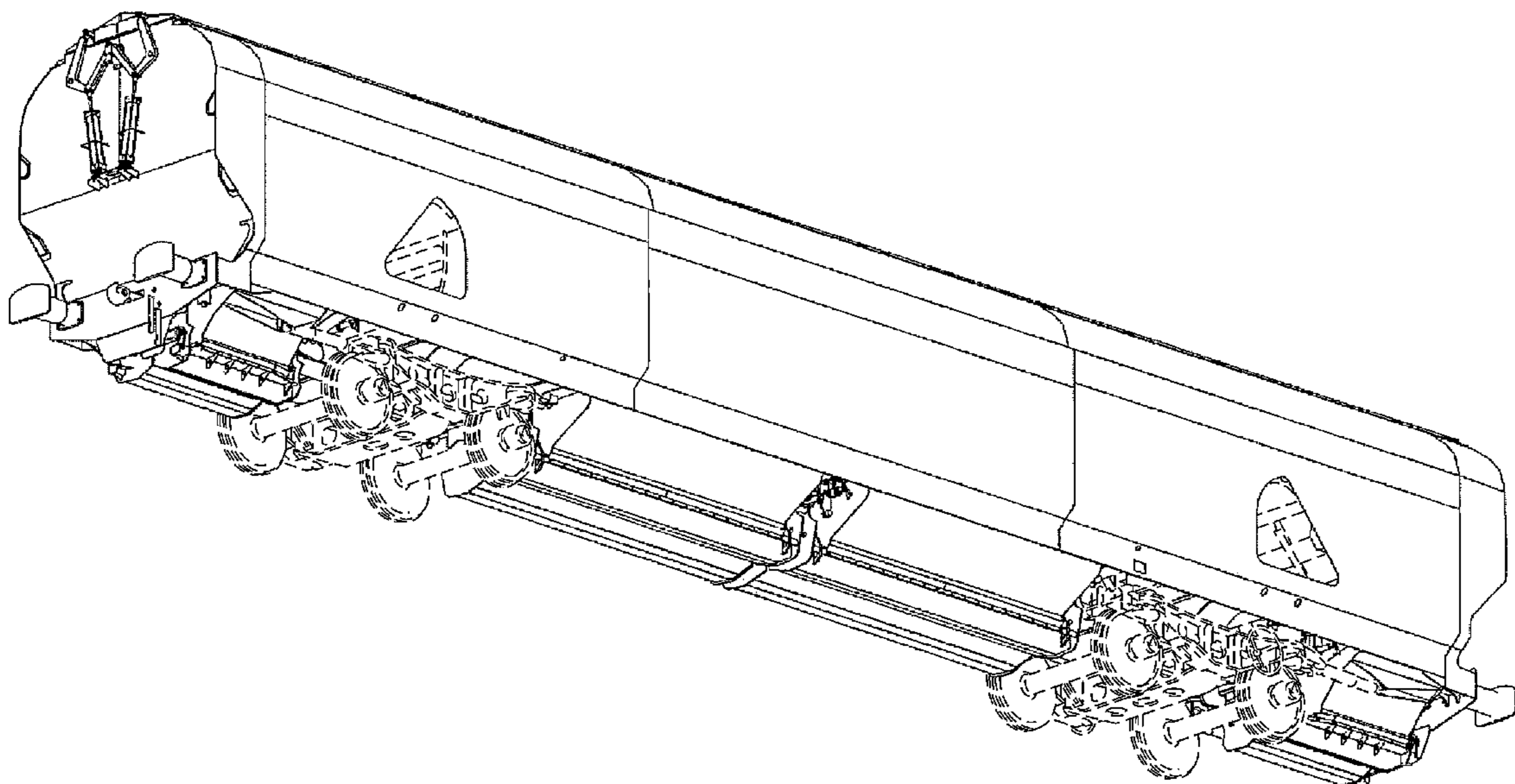
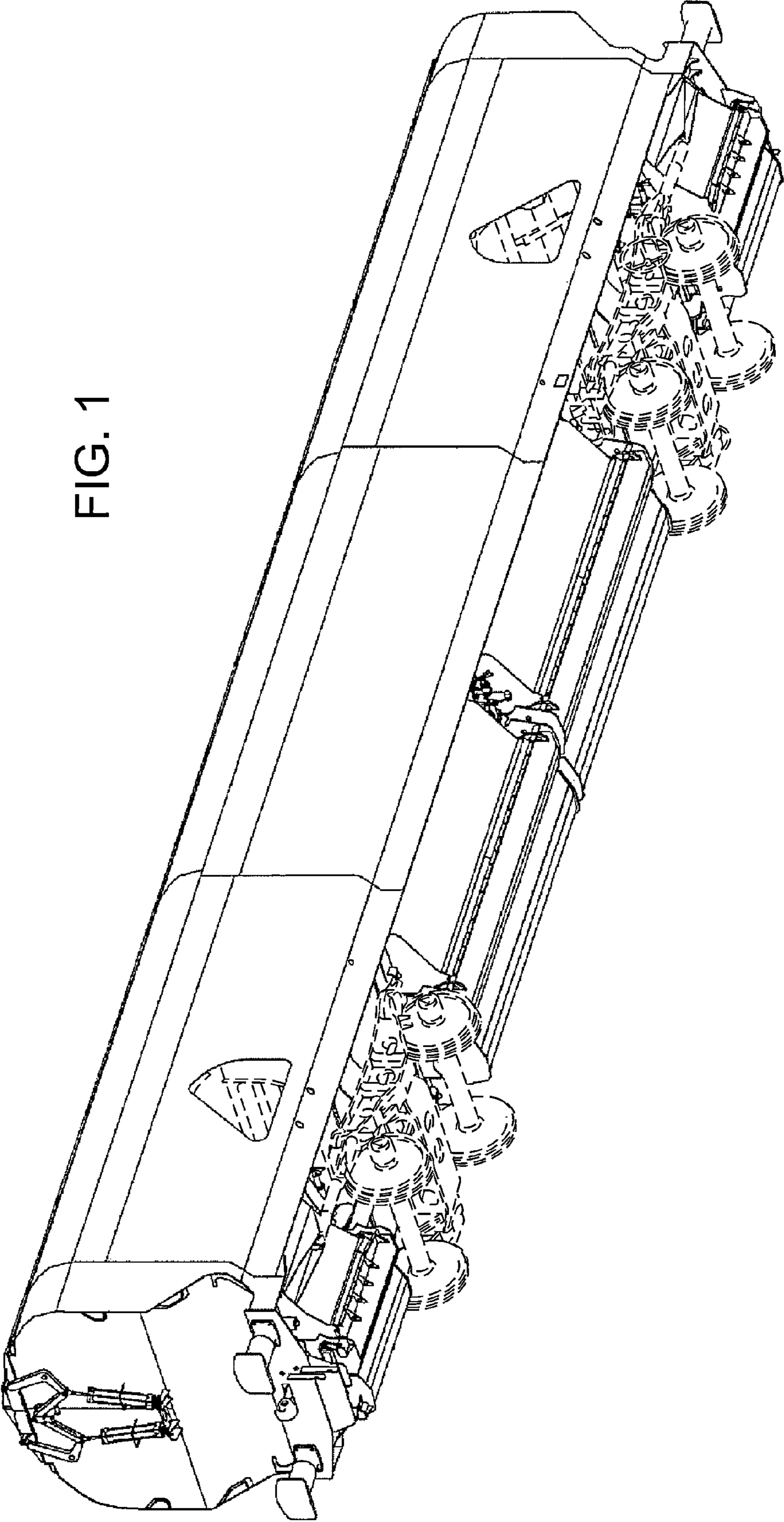

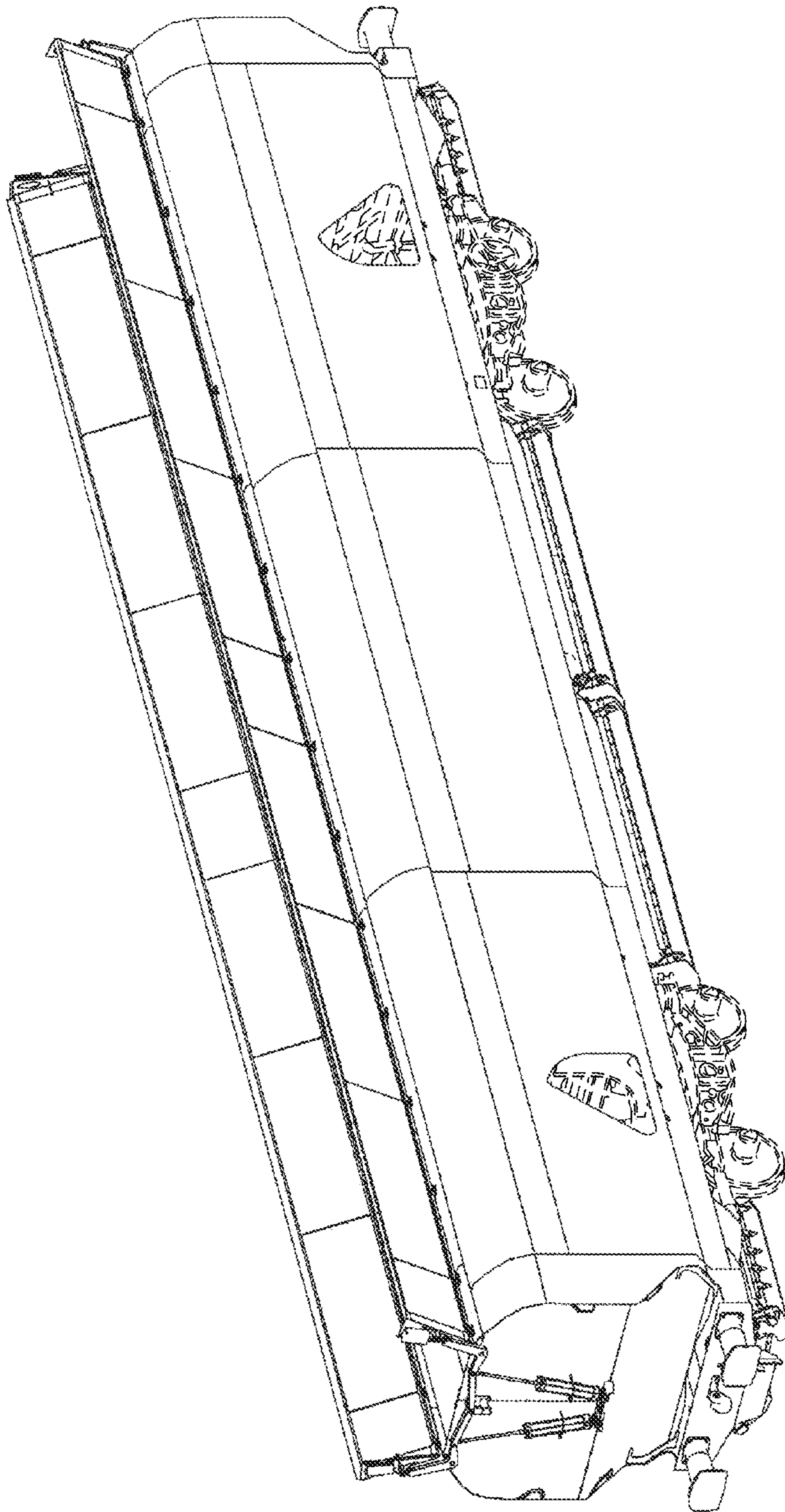

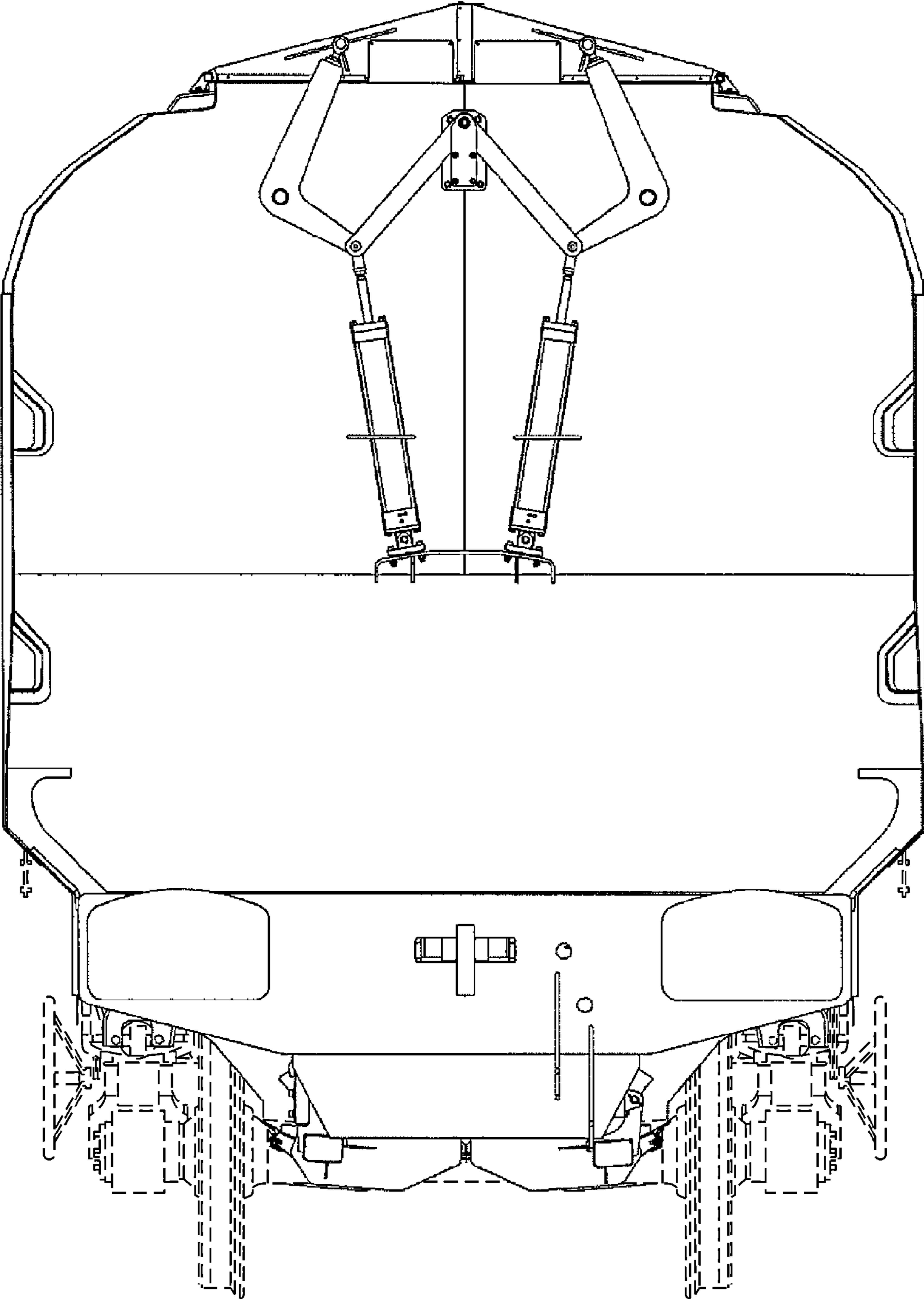

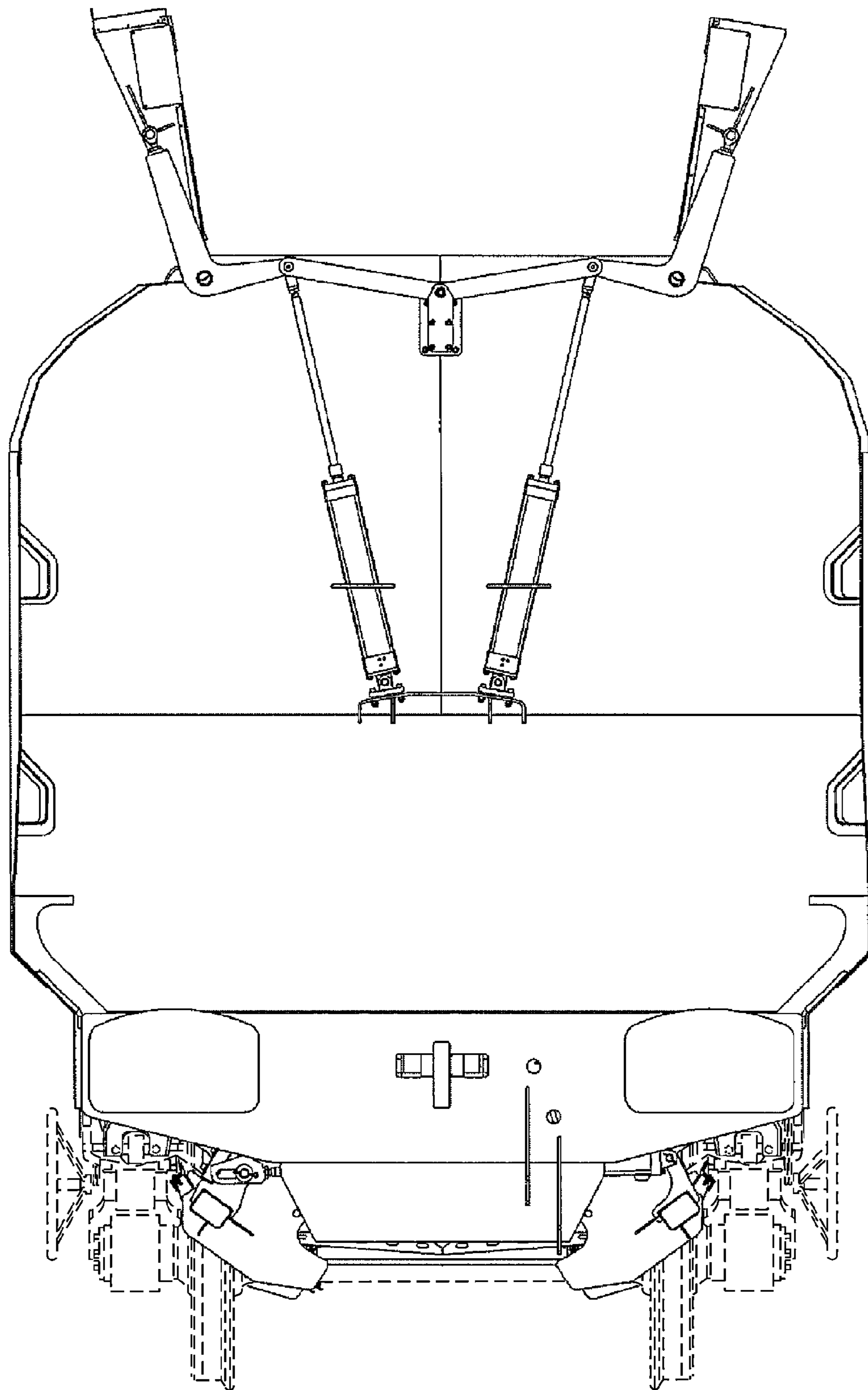

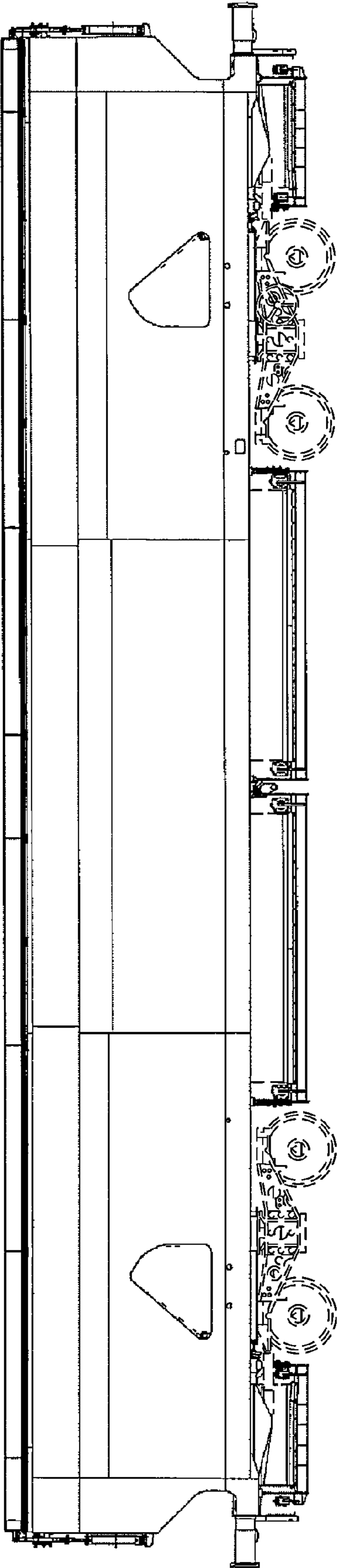

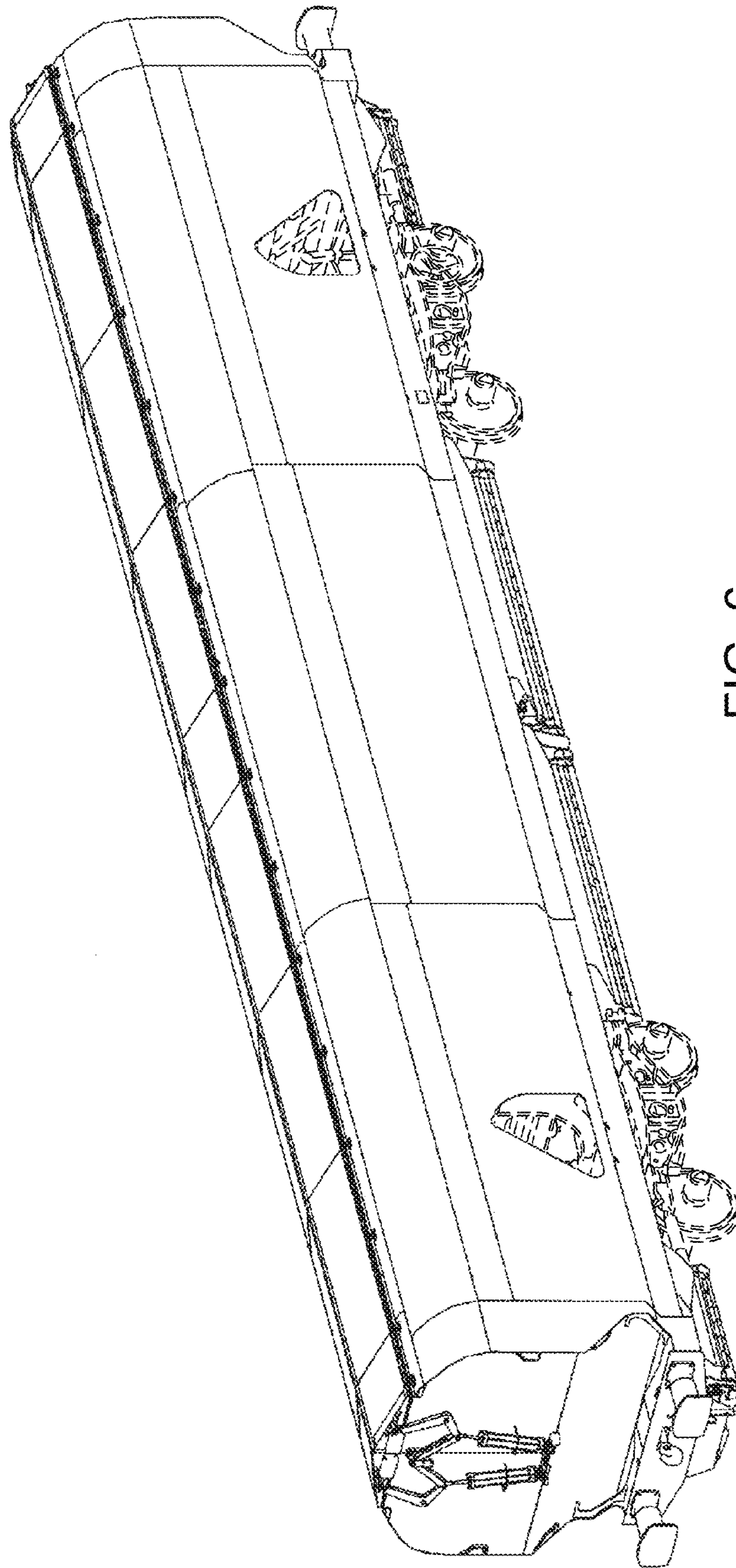

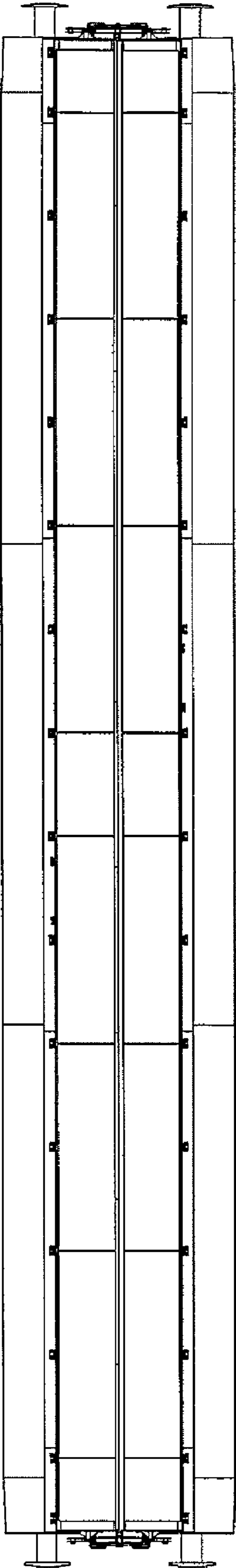
