(57) **CLAIM**

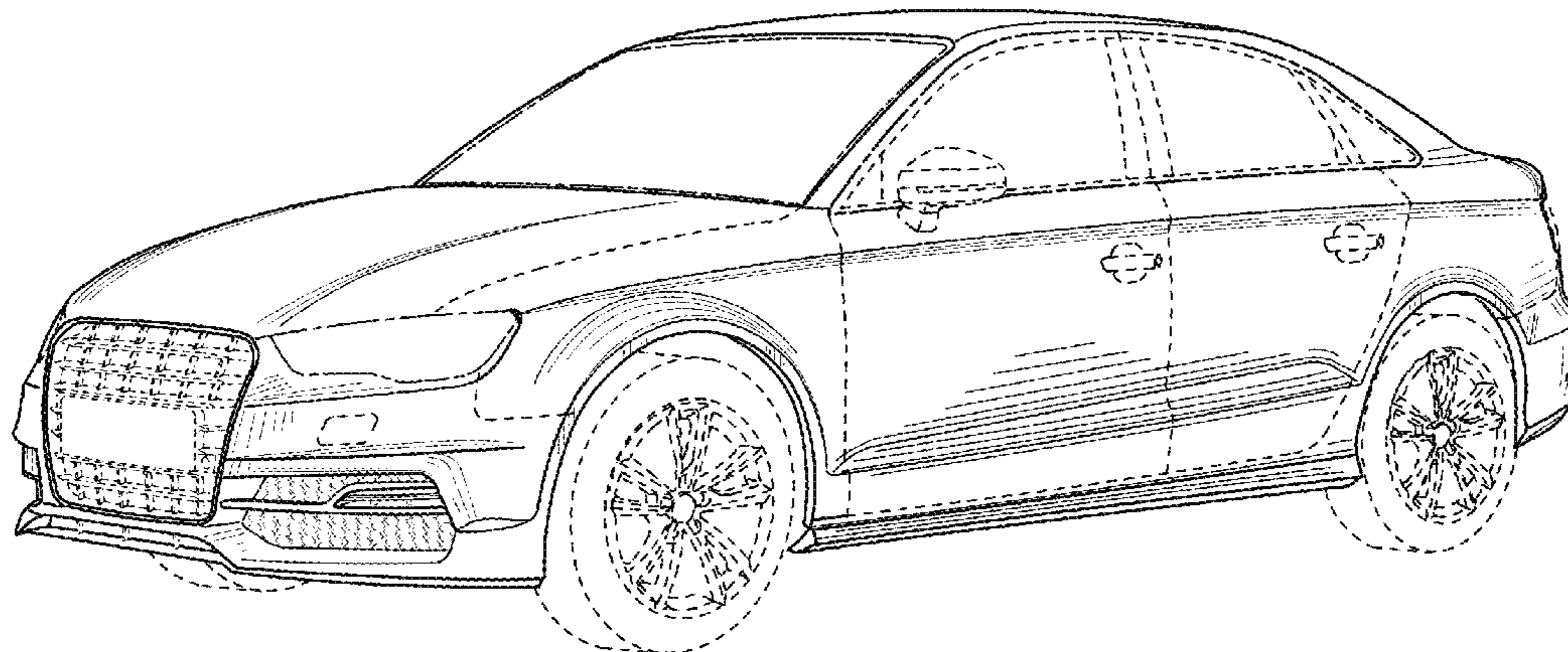
The ornamental design for motor vehicle, toy replica or replica, as shown and described.

DESCRIPTION

FIG. 1 is a front and left side perspective view of the motor vehicle, toy replica or replica, showing our new design; FIG. 2 is a rear and left side perspective view of the motor vehicle, toy replica or replica, of FIG. 1; FIG. 3 is a right side elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a rear elevation view thereof; and, FIG. 7 is a front elevation view thereof.

The uniform broken lines shown in the drawings illustrate portions of the motor vehicle, toy replica or replica that form no part of the claimed design. The dash-dot broken lines illustrate boundaries between claimed and unclaimed surfaces and form no part of the claimed design.

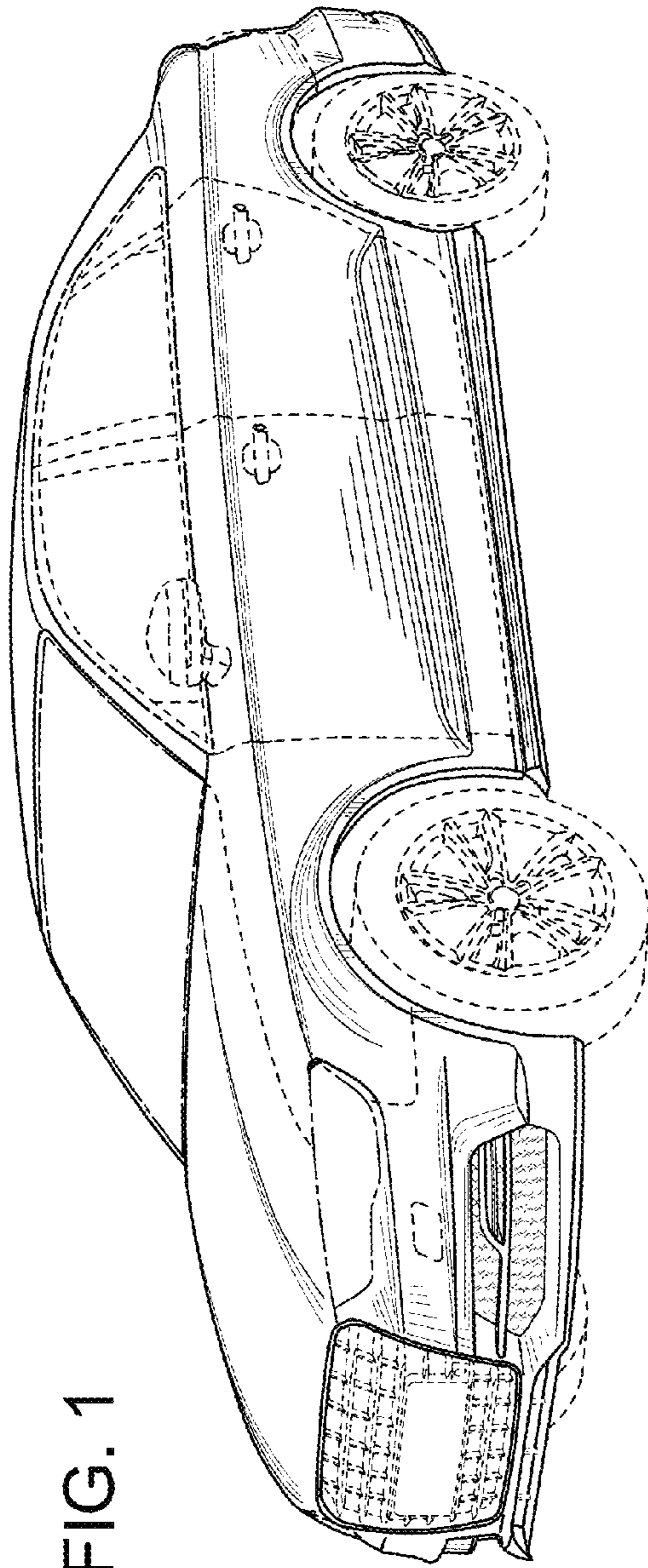

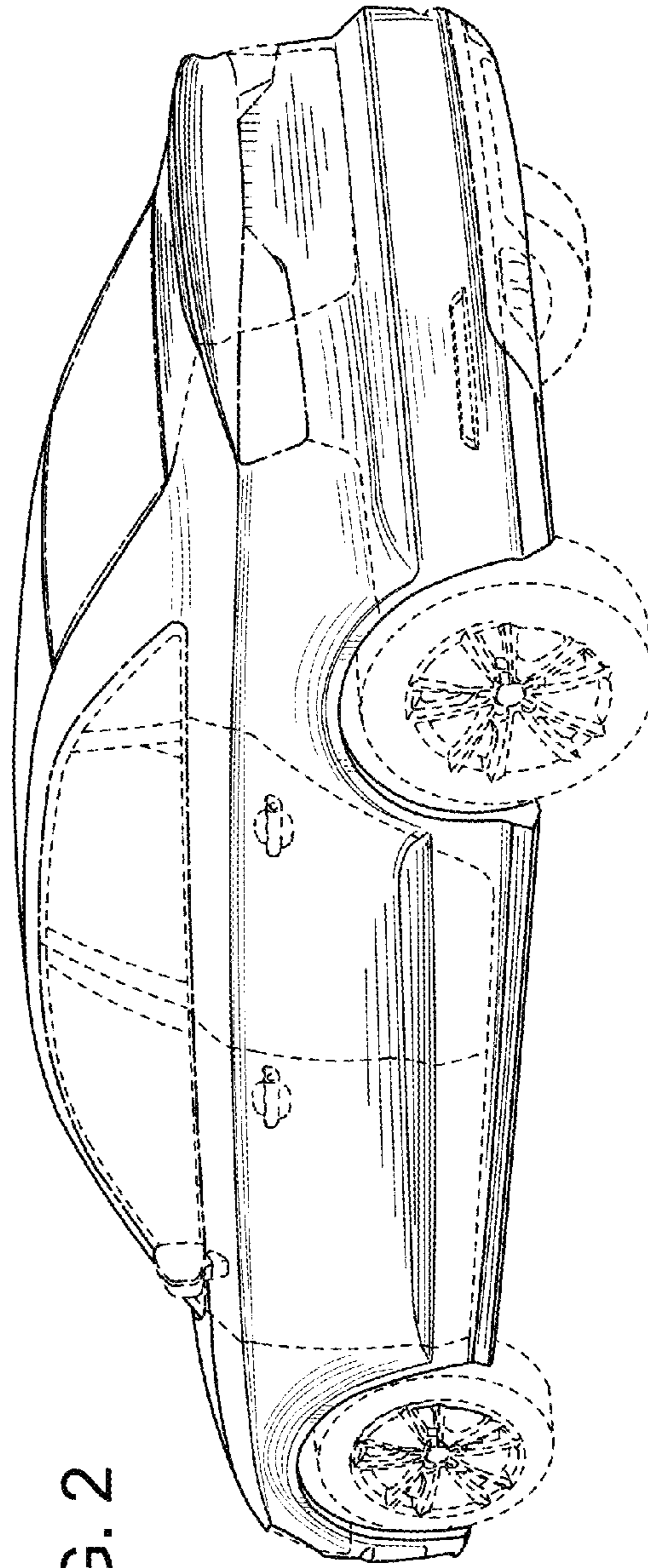

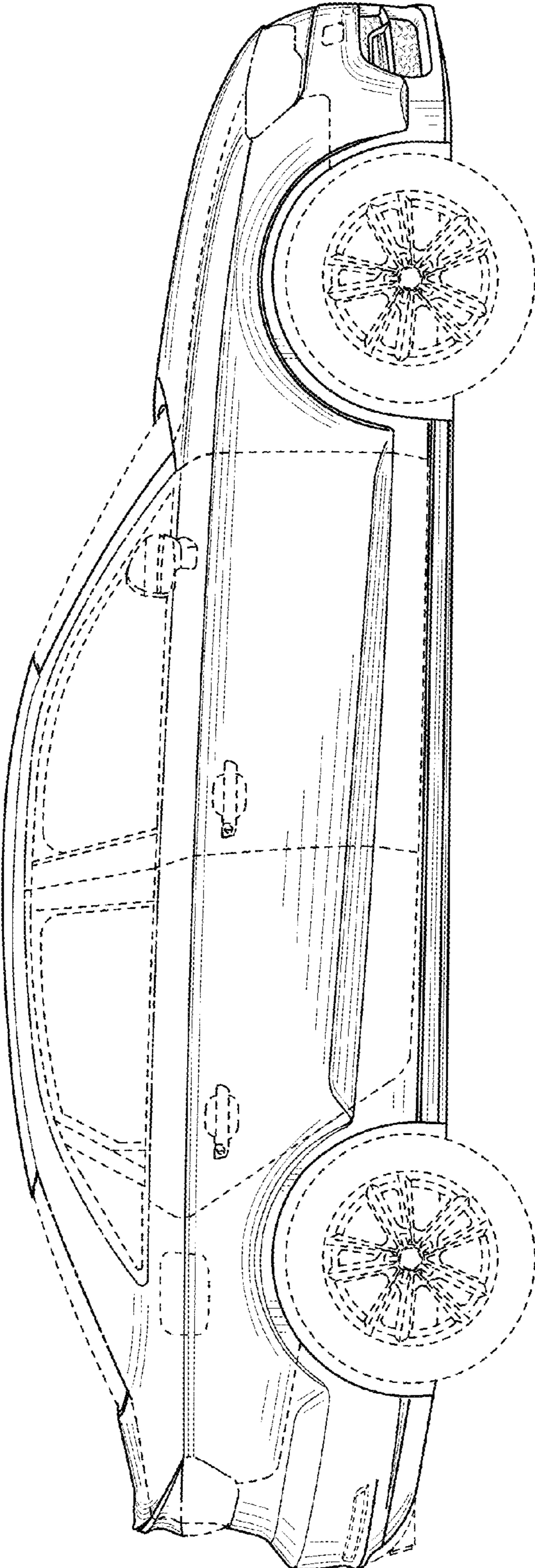
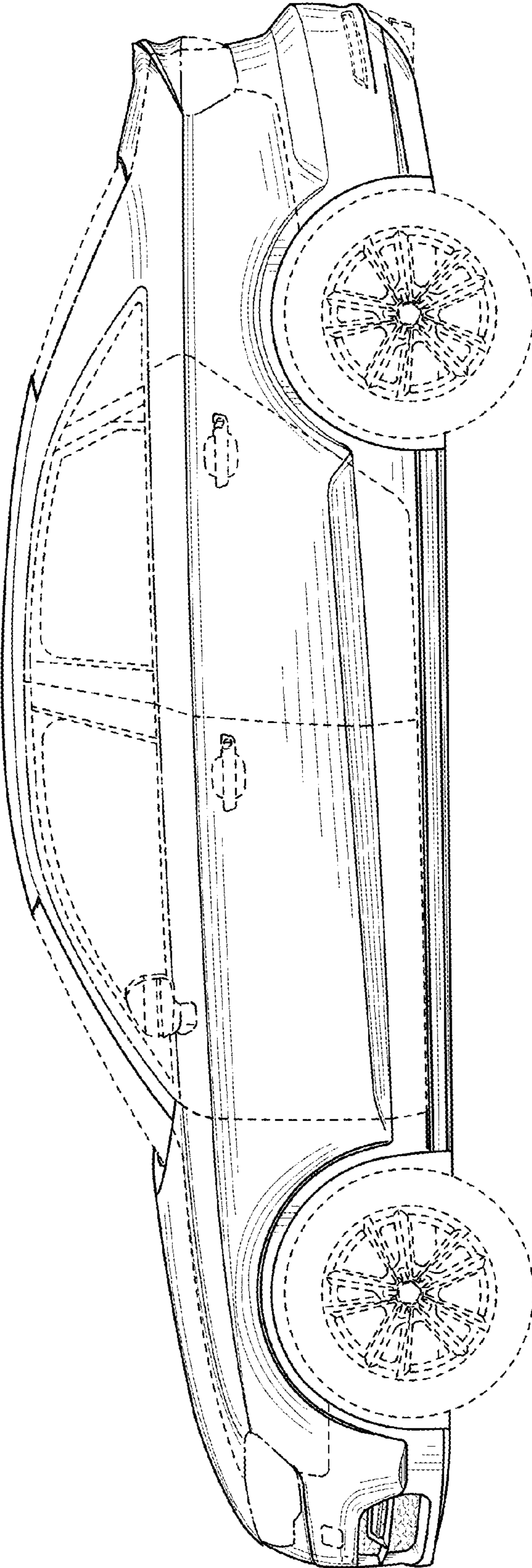

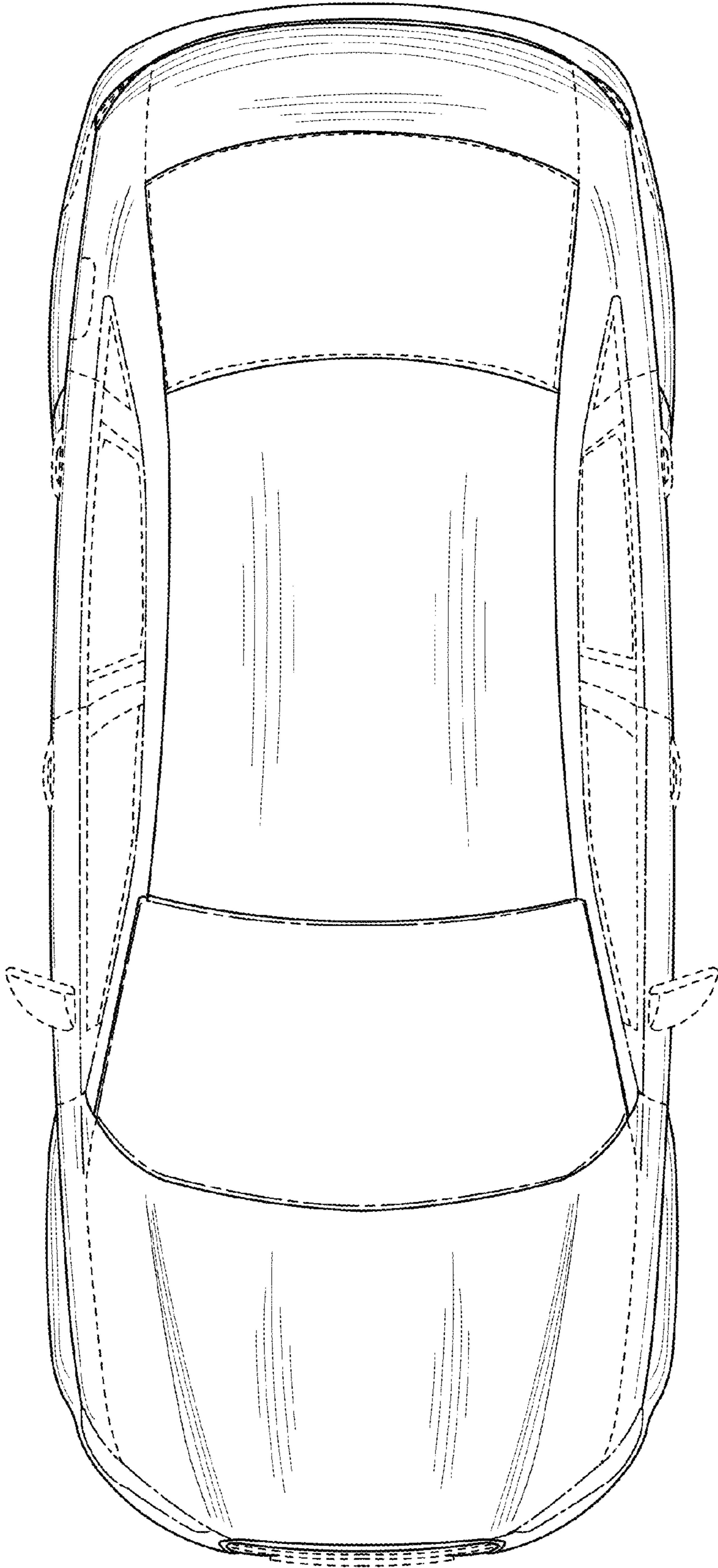

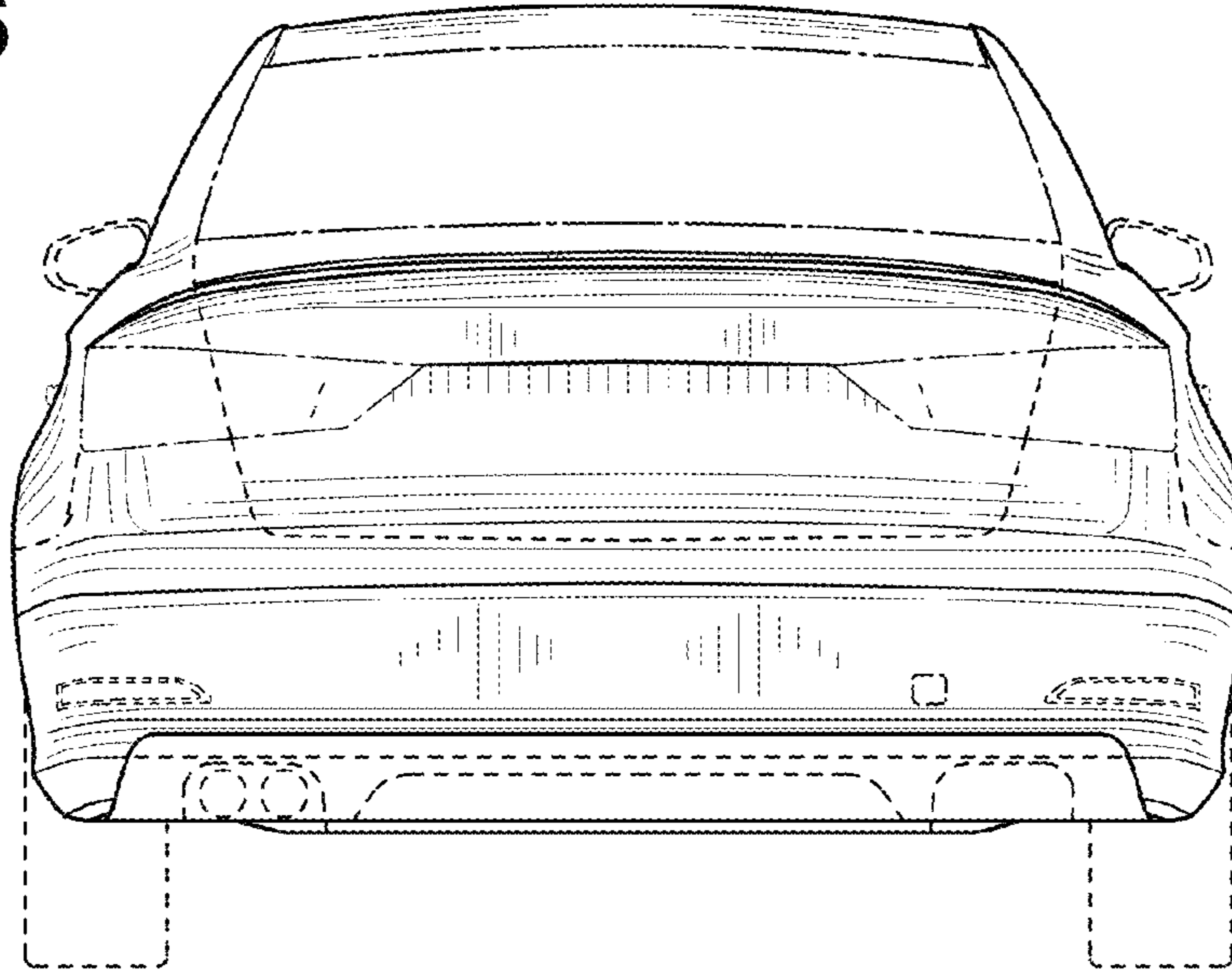
