The ornamental design for a coupling adapter base, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a coupling adapter base of the present design, which view also shows the bottom end and right side thereof;

FIG. 2 is another front perspective view thereof, which view also shows the top end and right side thereof;

FIG. 3 is a top end view thereof;

FIG. 4 is a front view thereof, the rear view being identical;

FIG. 5 is a right side view thereof, the left side view being identical;

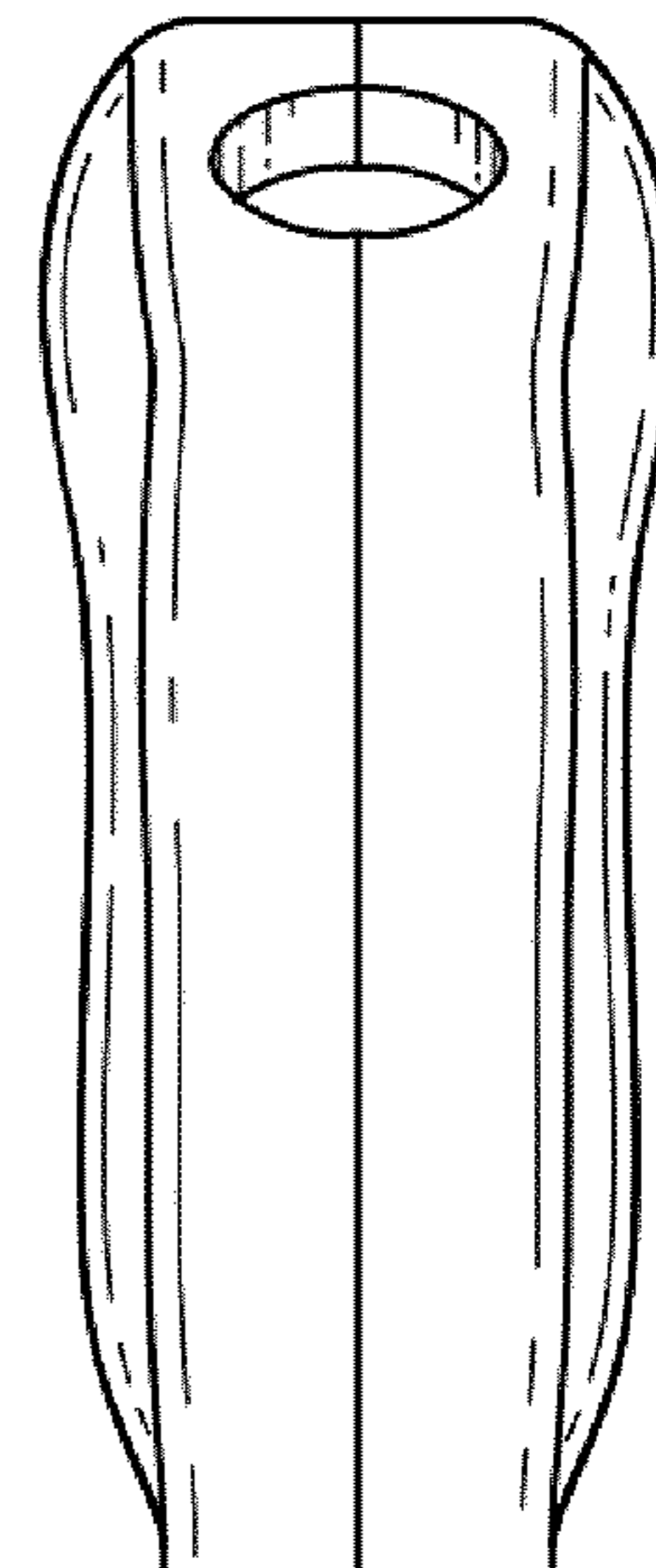
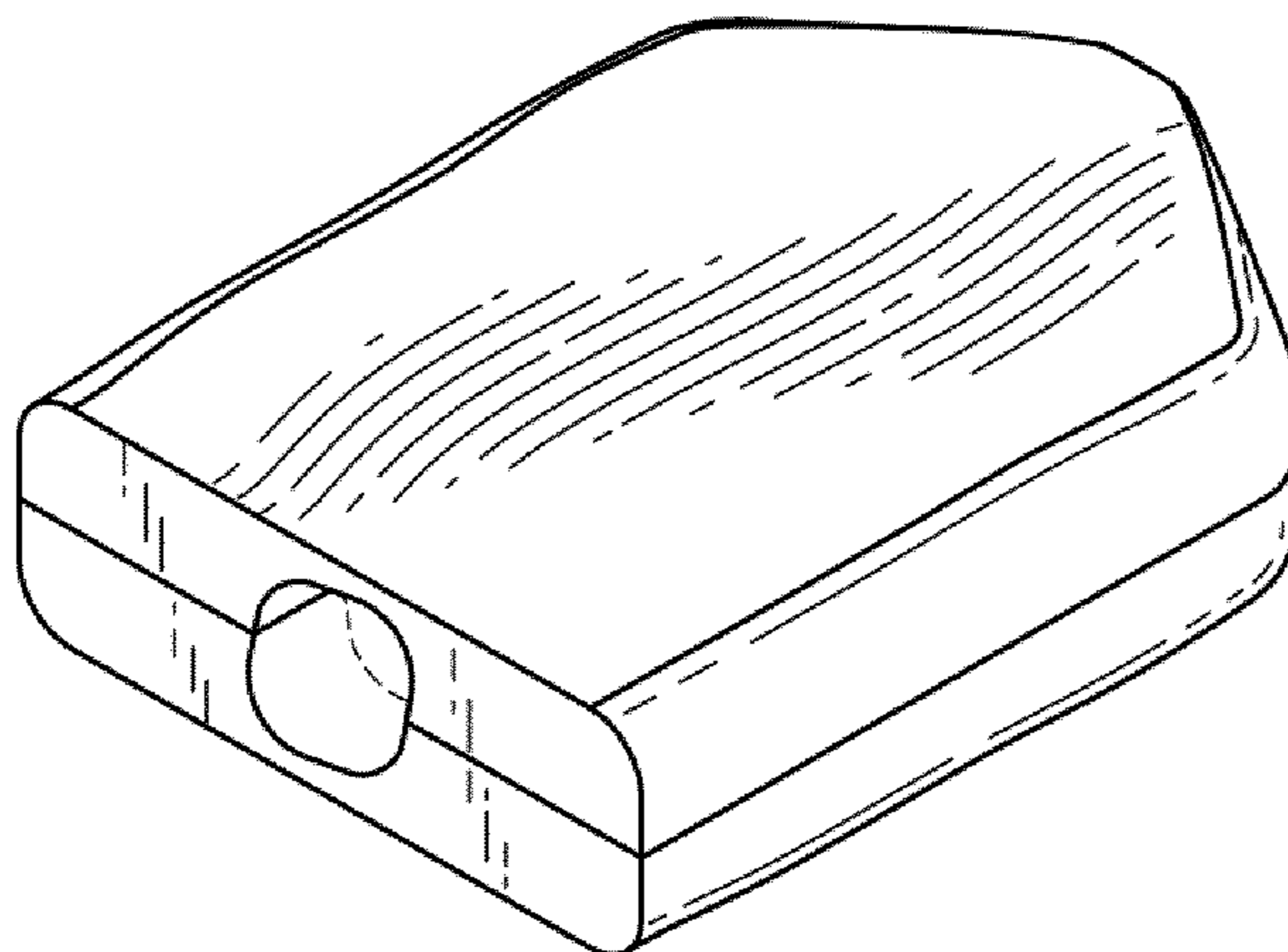
FIG. 6 is a bottom end view thereof;

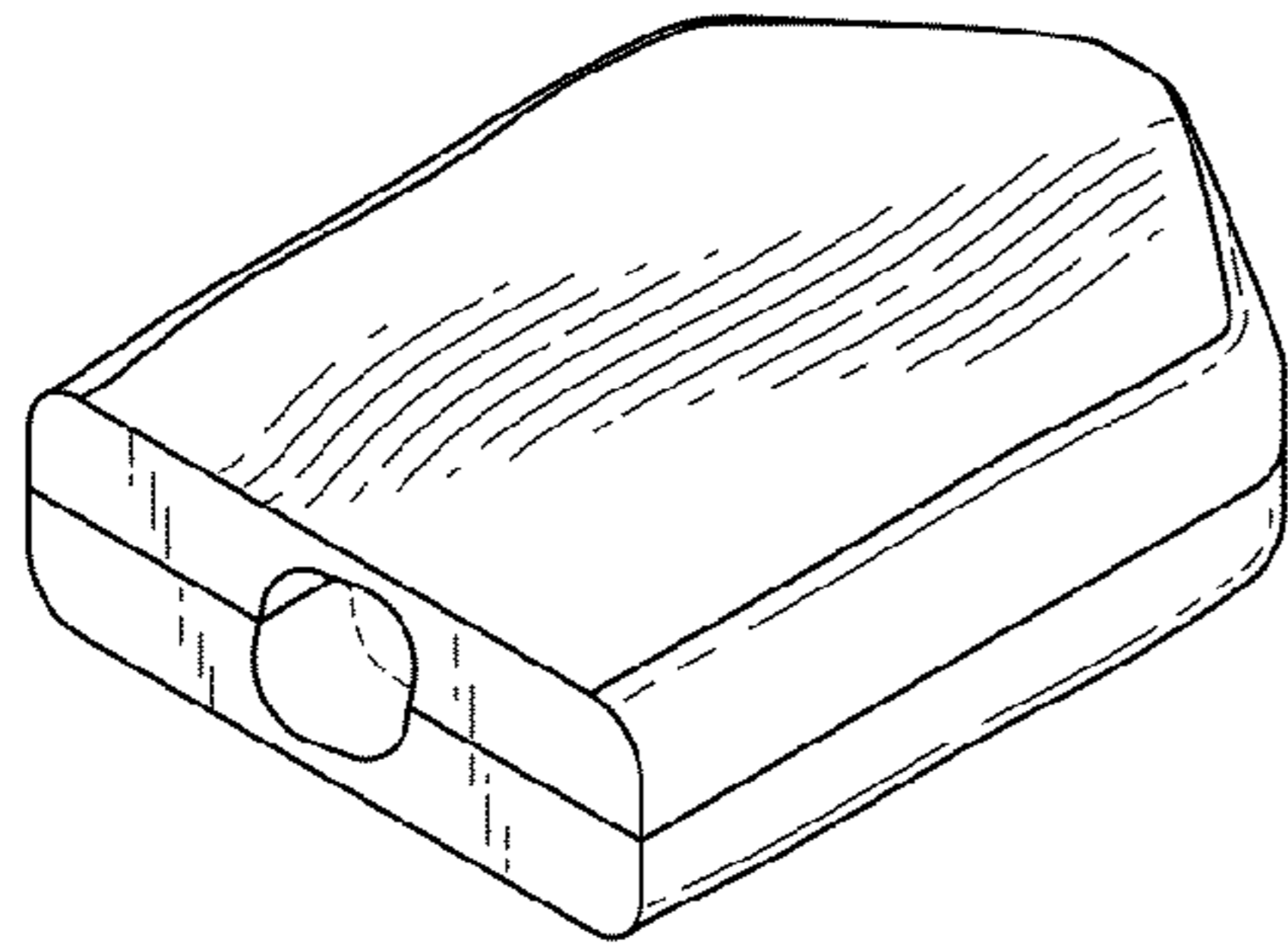

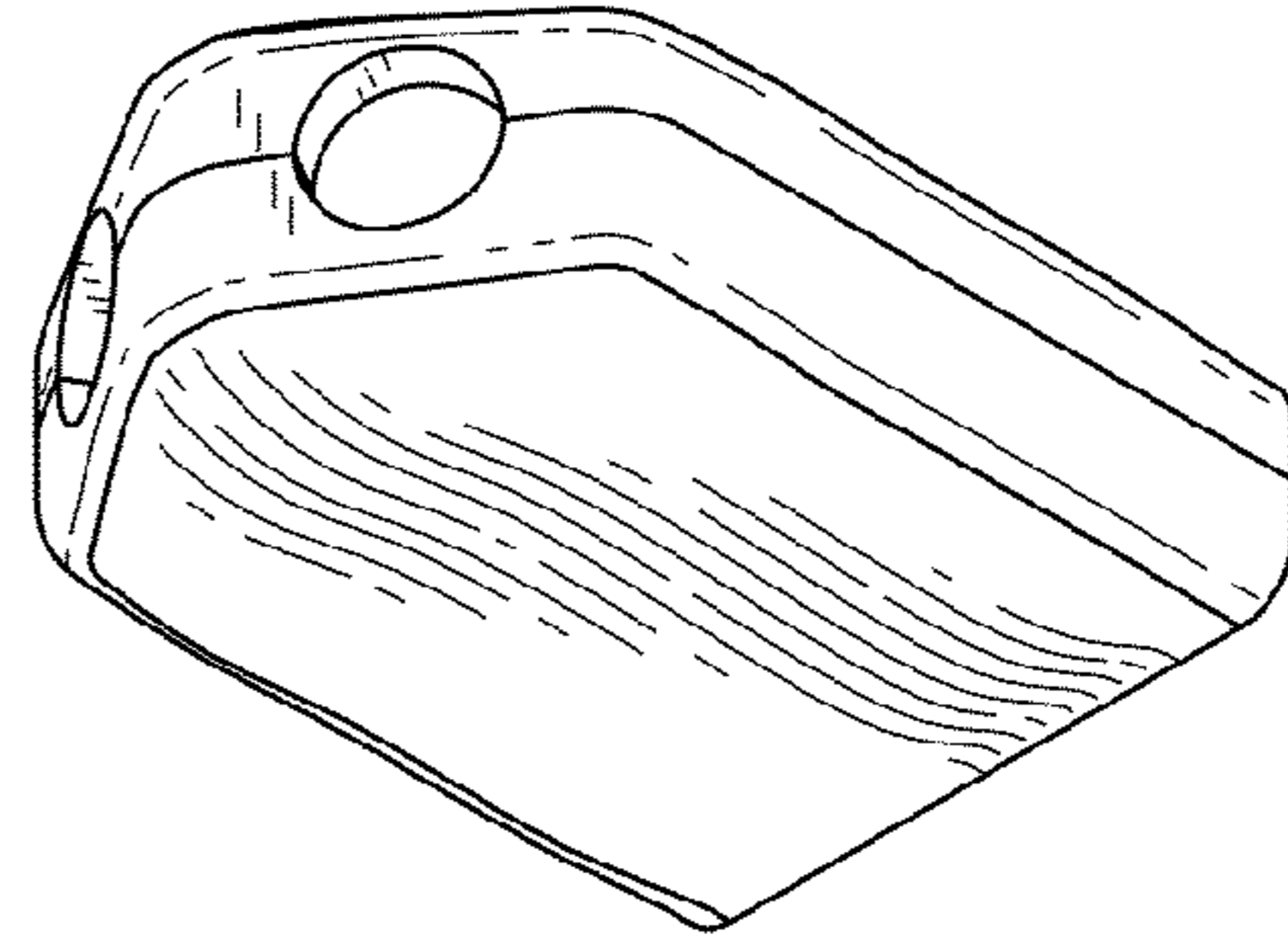

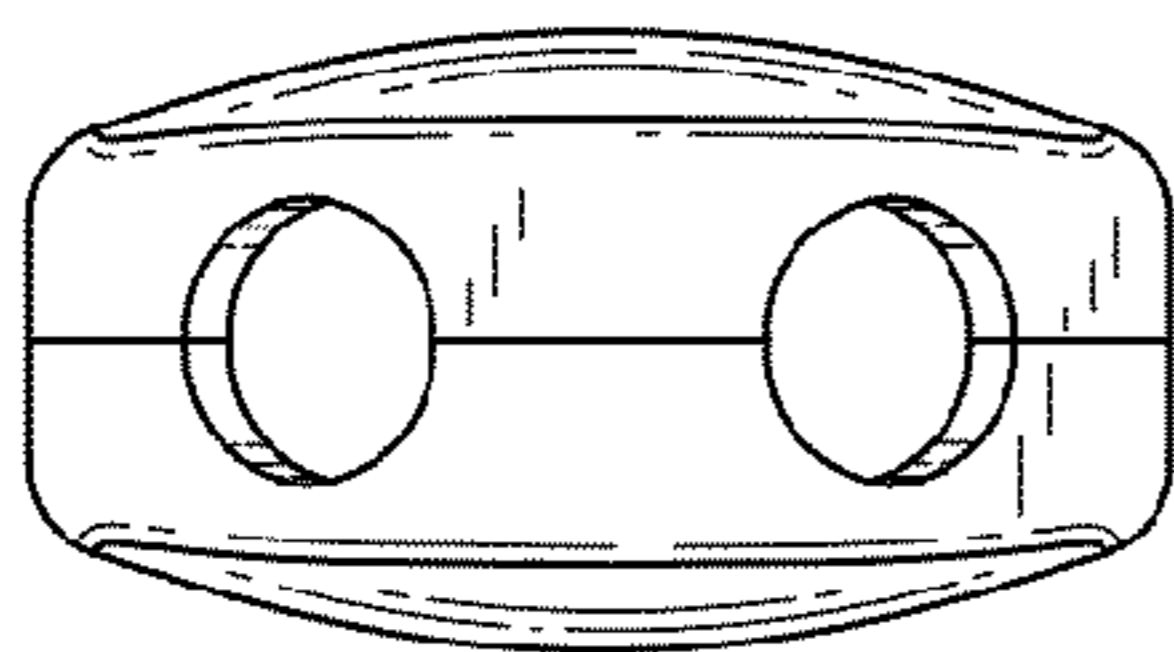

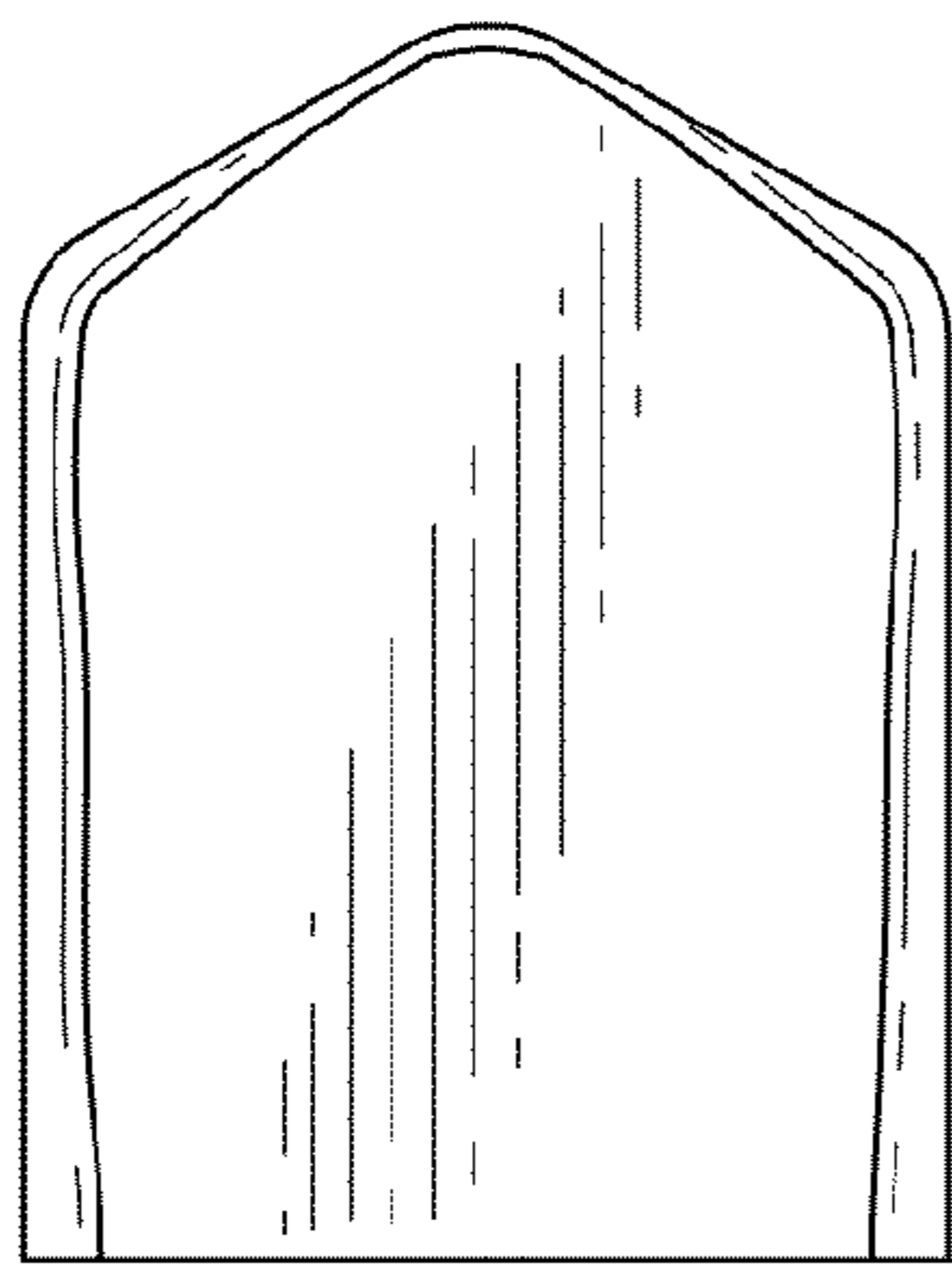

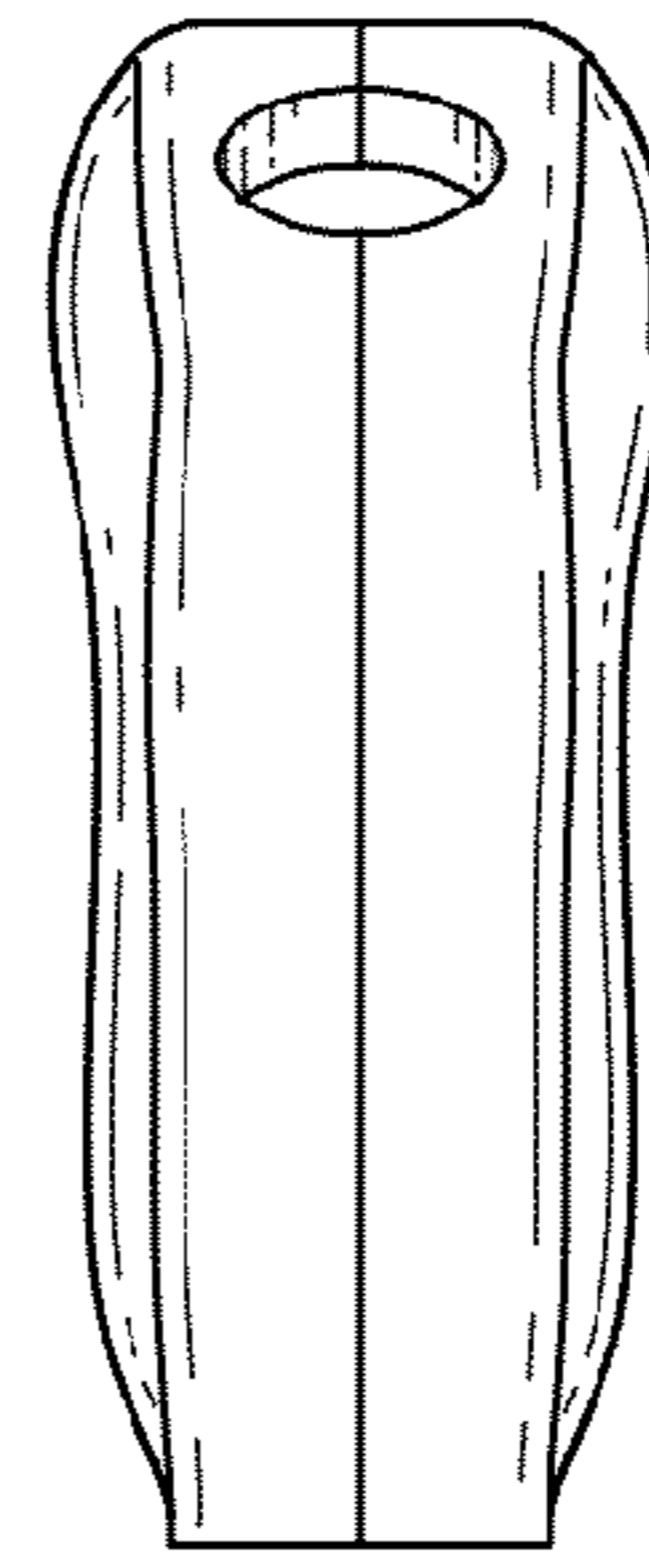

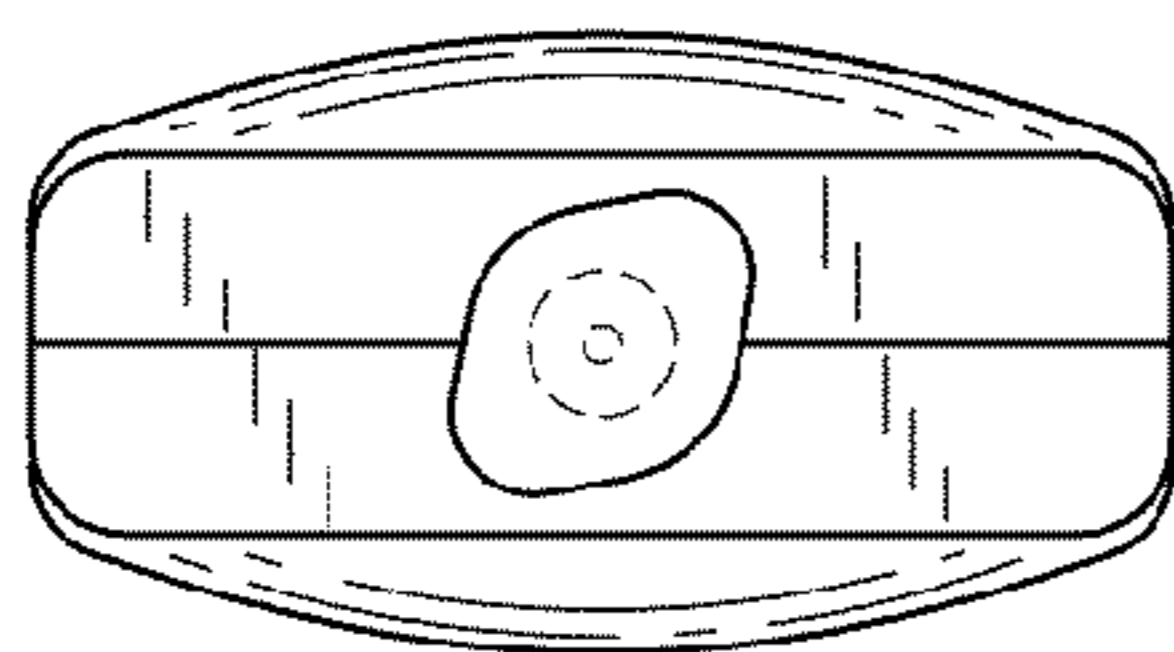

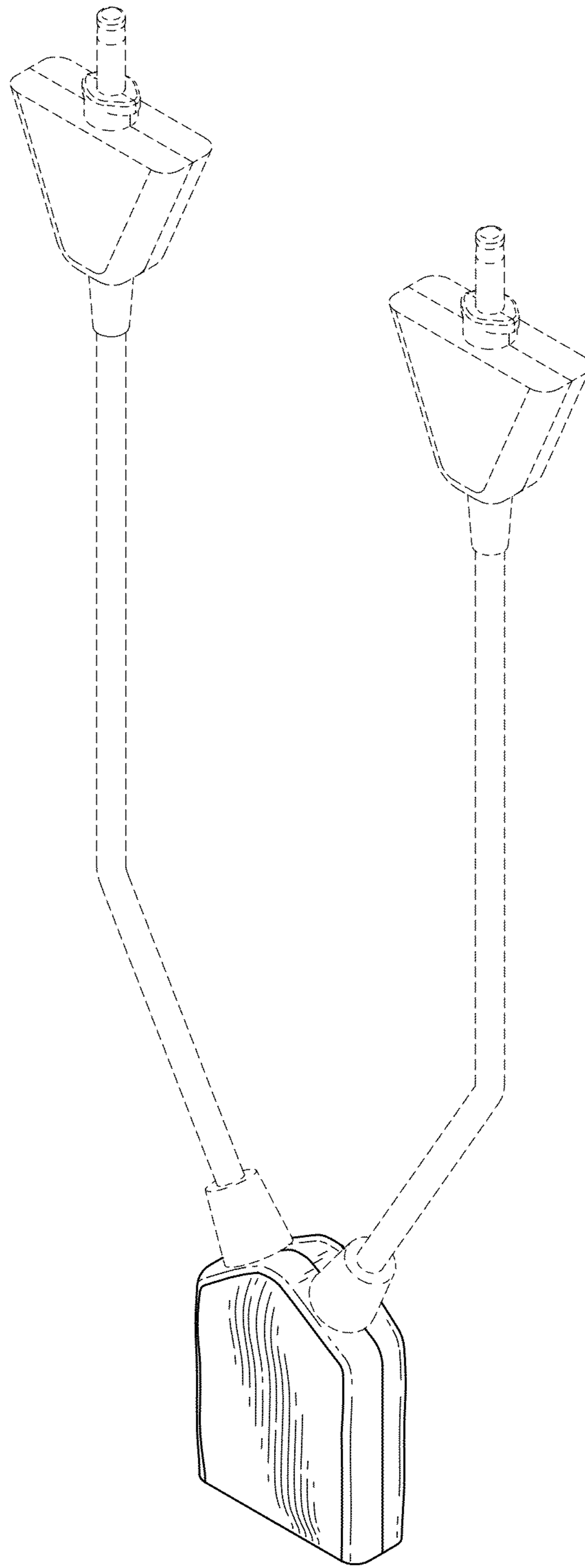

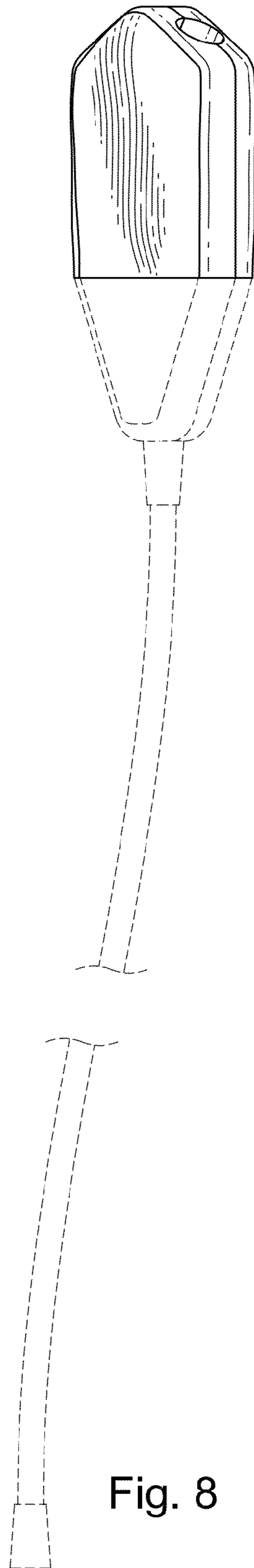
