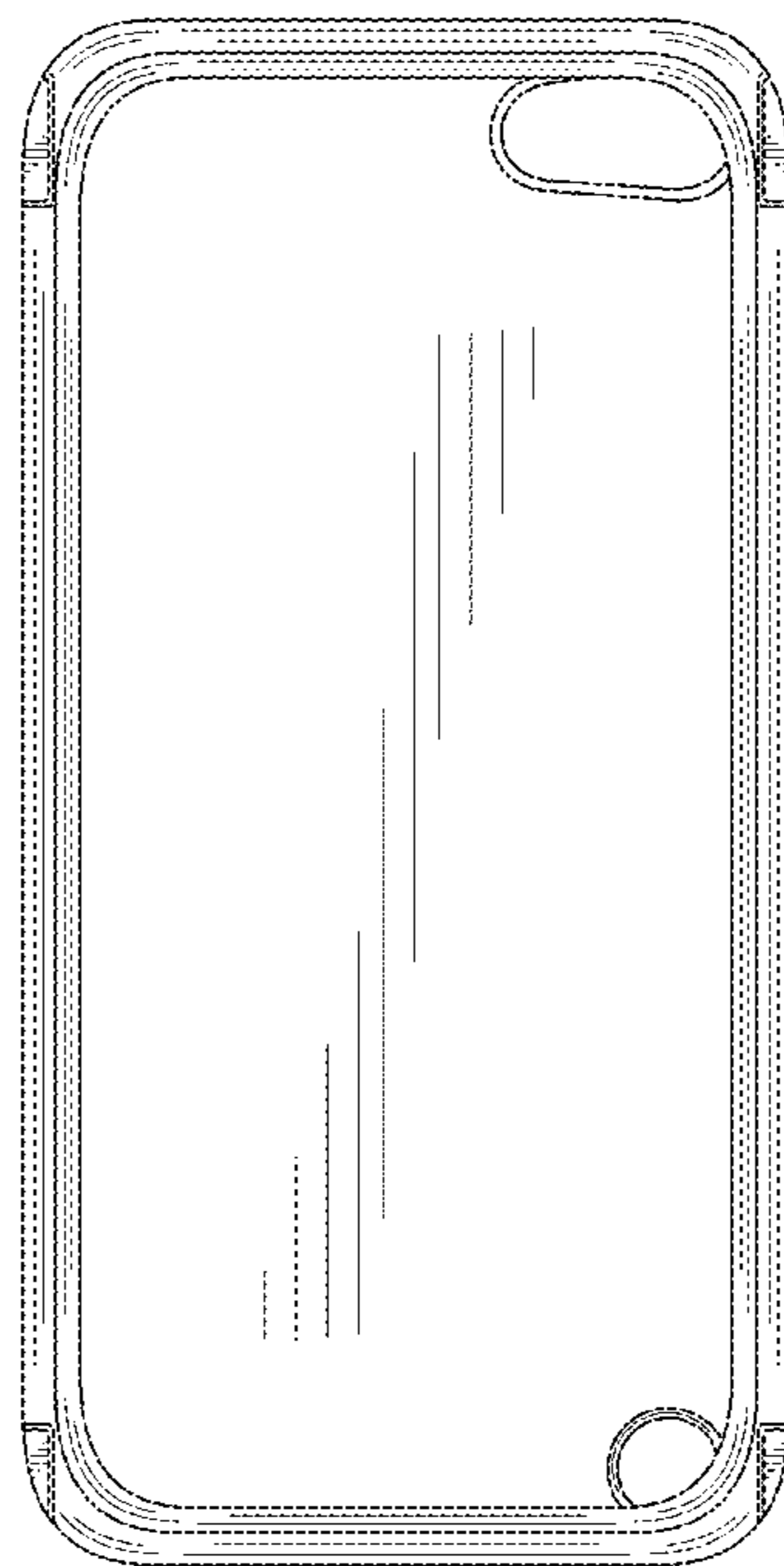
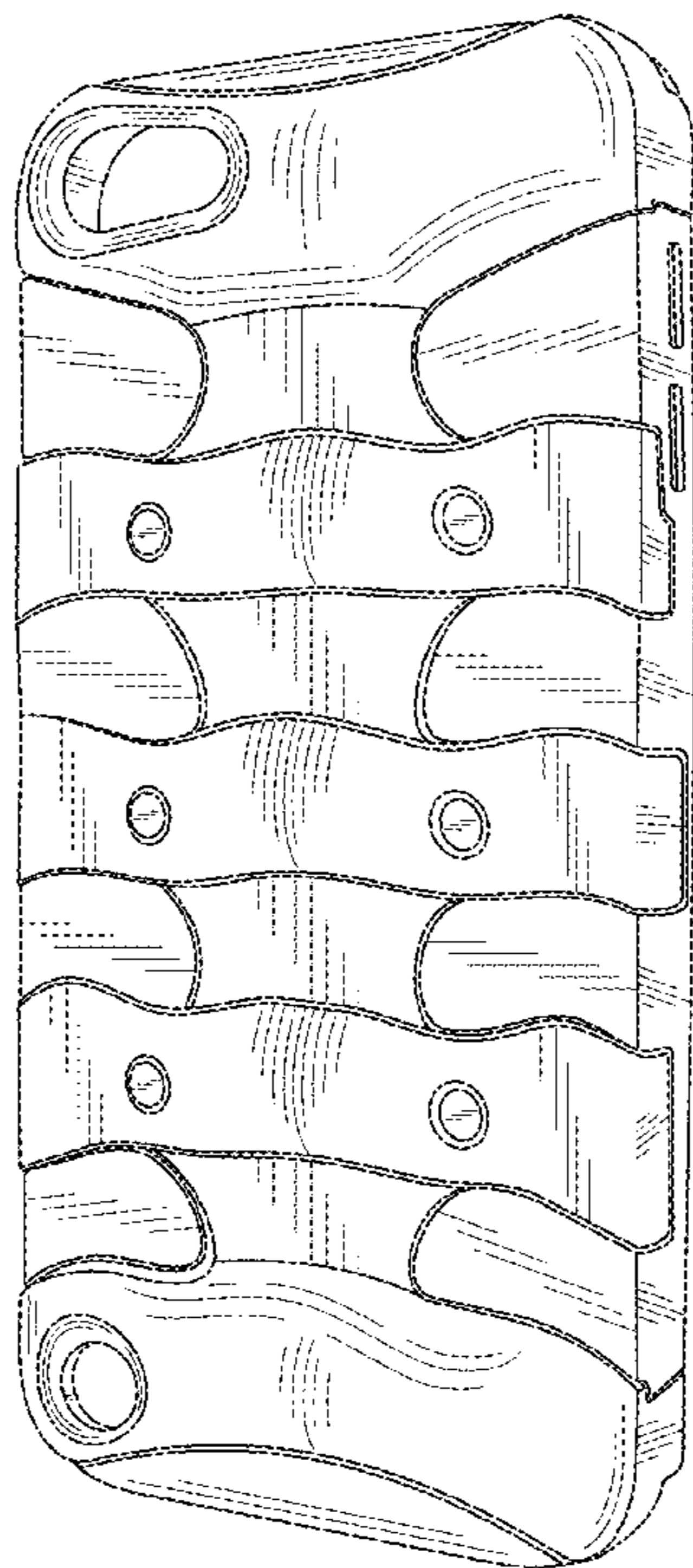
(57) **CLAIM**

The ornamental design for a cell phone protector case with fishbone design, as shown and described.

DESCRIPTION

FIG. 1 is a front side perspective view of a cell phone protector case with fishbone design, showing my new design; FIG. 2 is a rear side perspective view thereof; FIG. 3 is front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a left side elevational view thereof; FIG. 7 is a top plan view thereof; FIG. 8 is a bottom plan view thereof; and, FIG. 9 is a separated rear elevational view with the fishbone design attachment separated from the cell phone protector case.

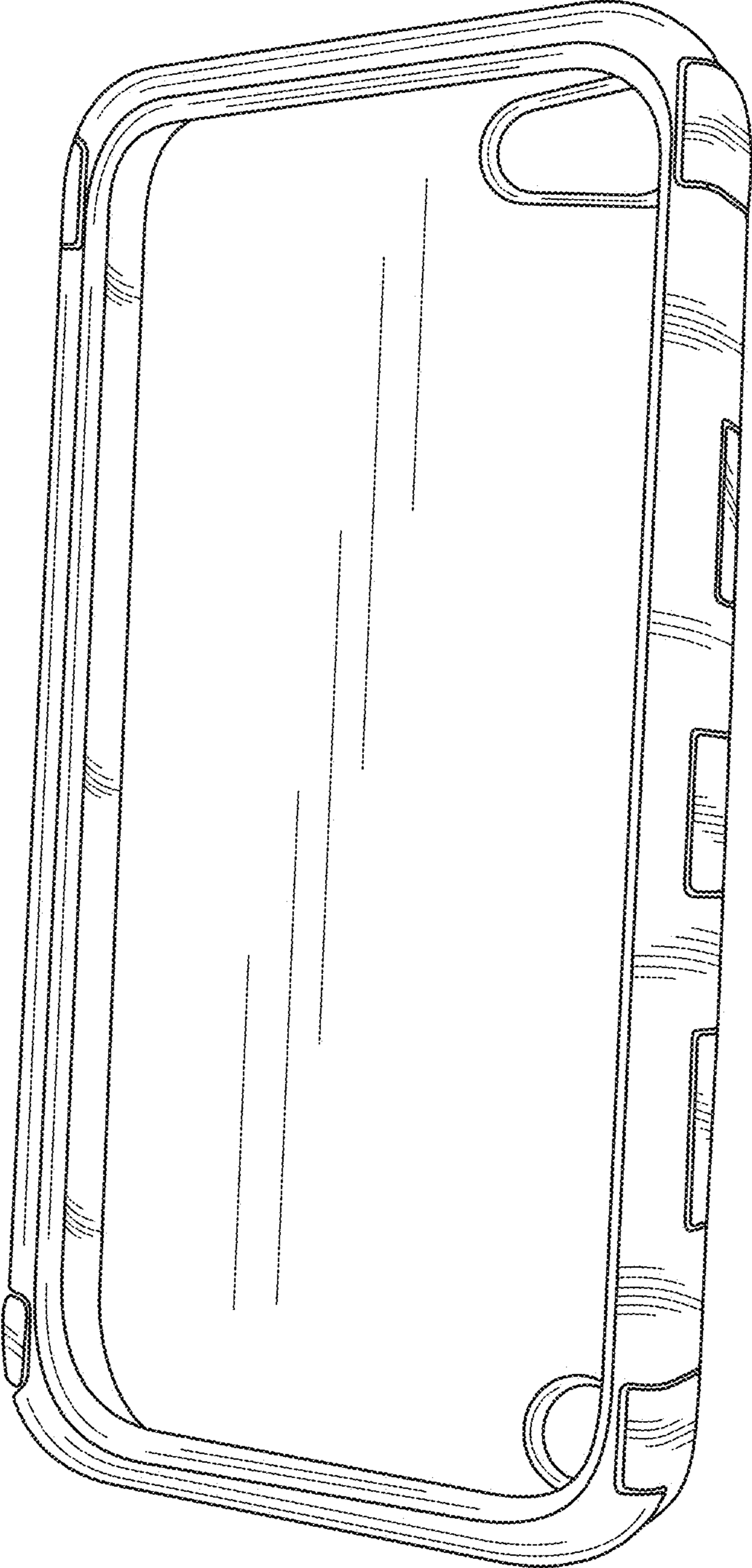

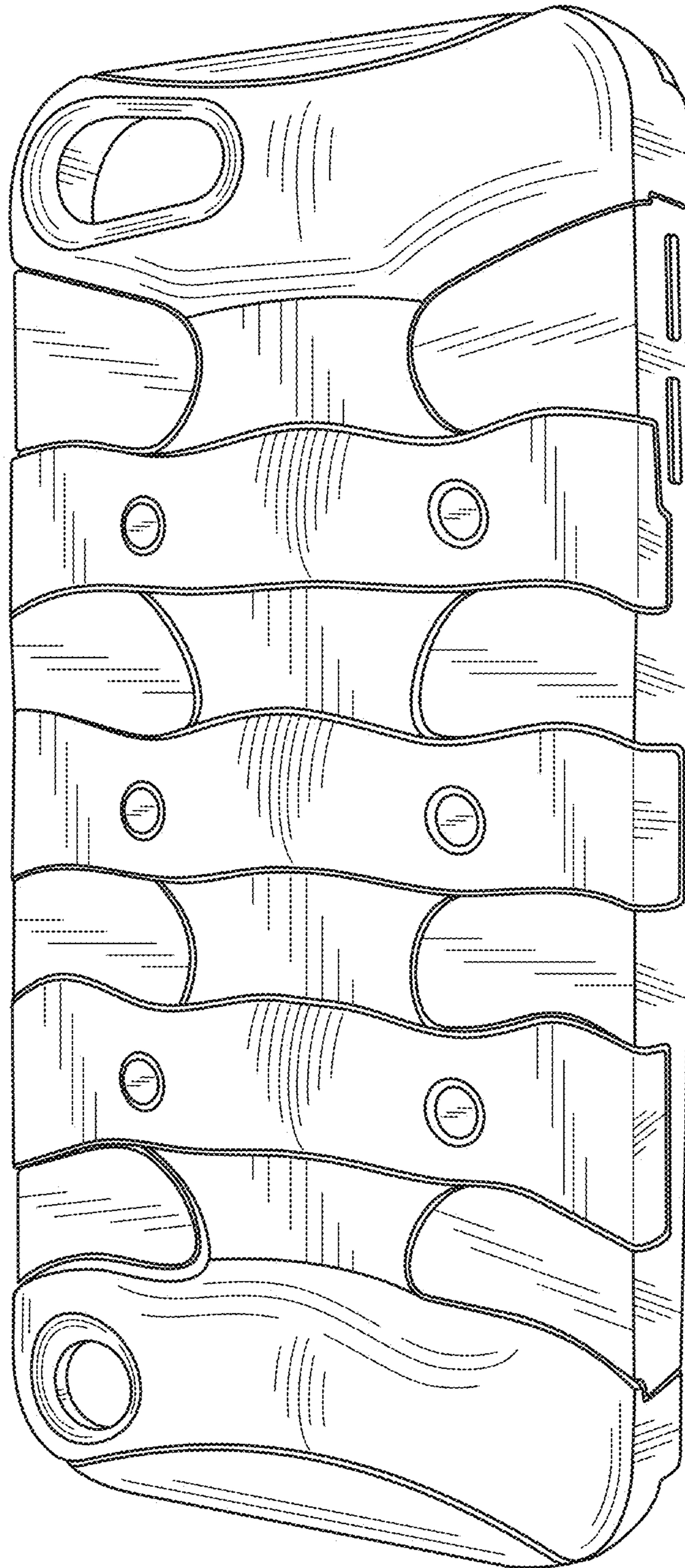

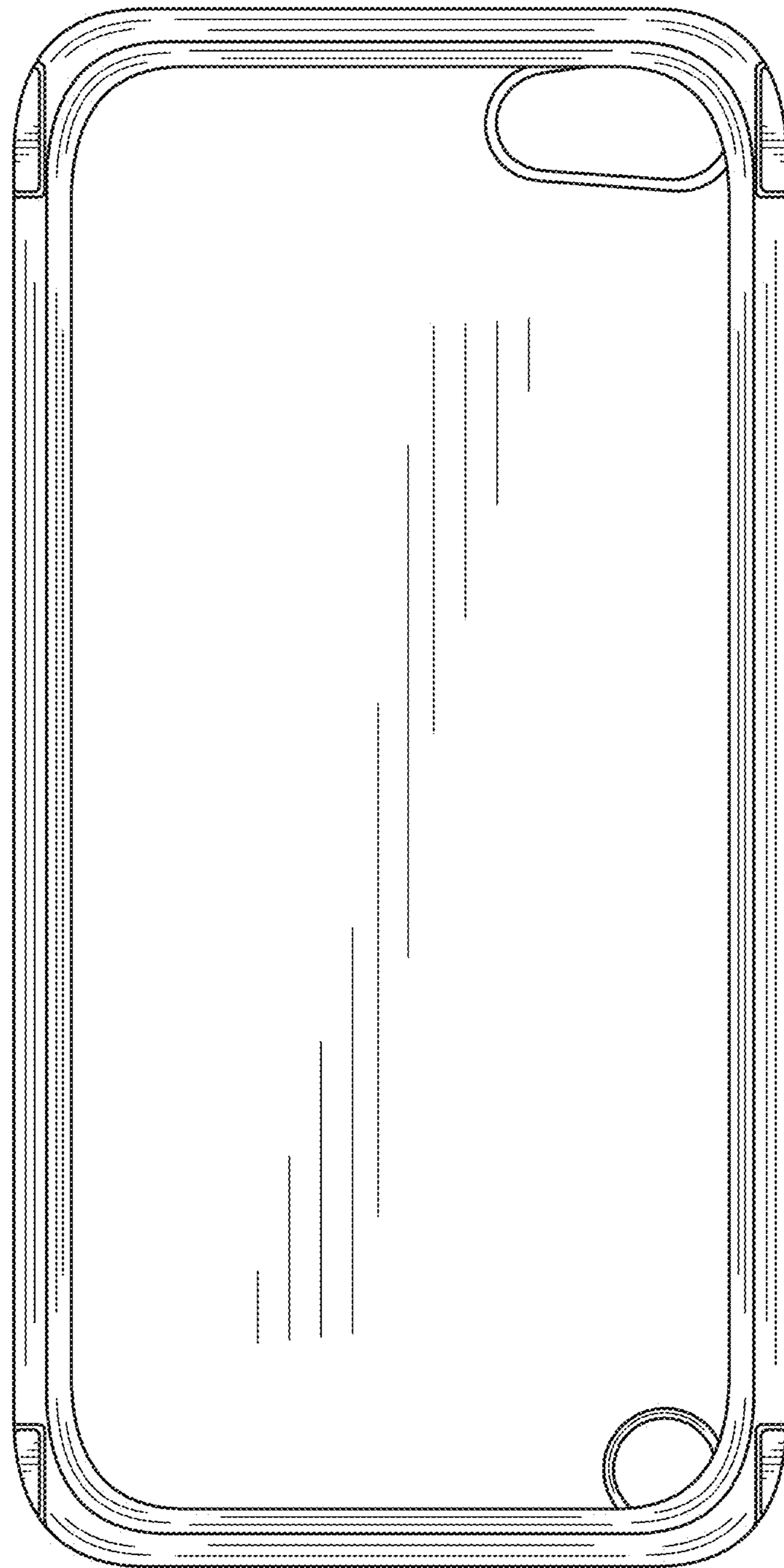

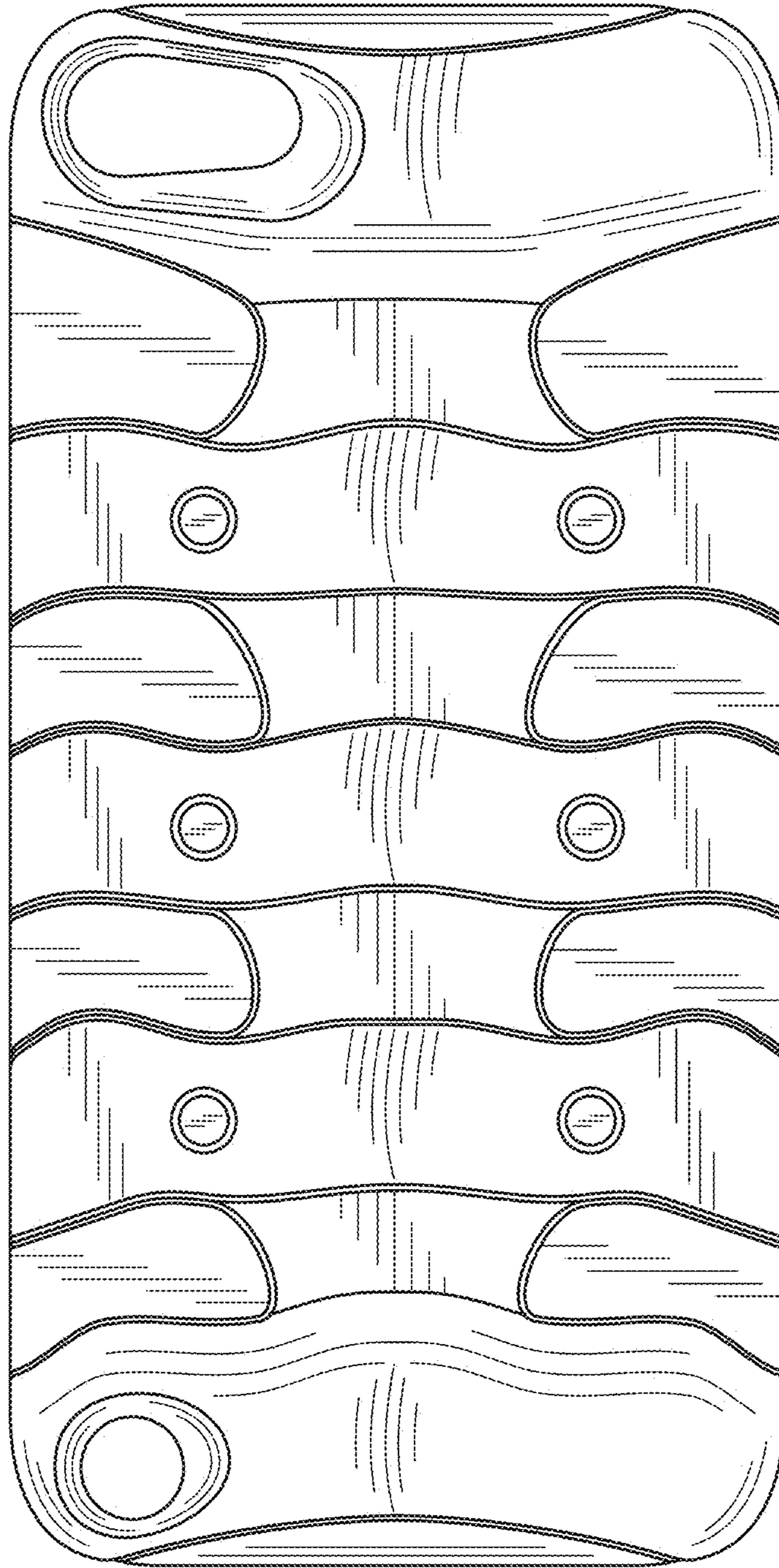

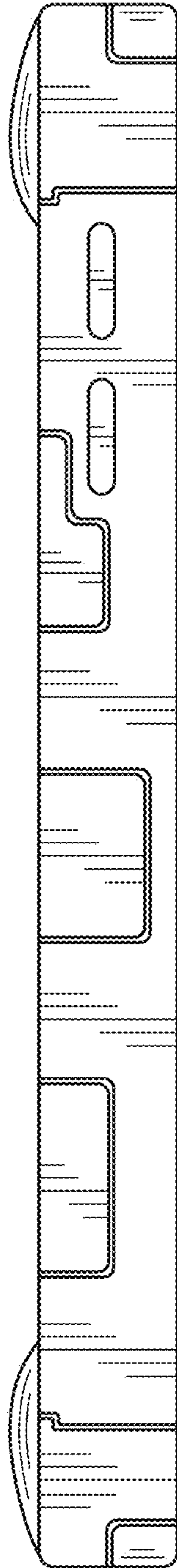

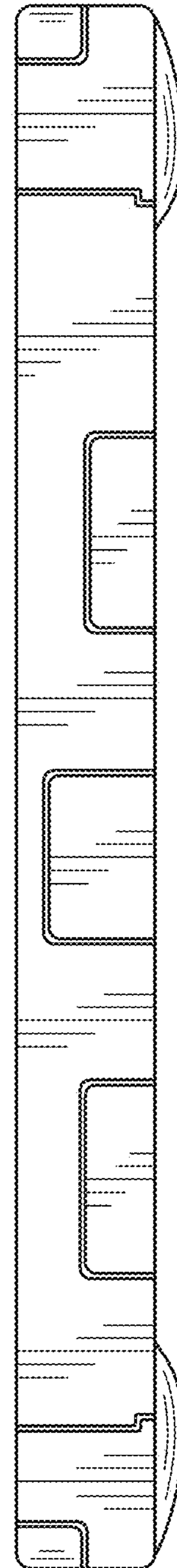

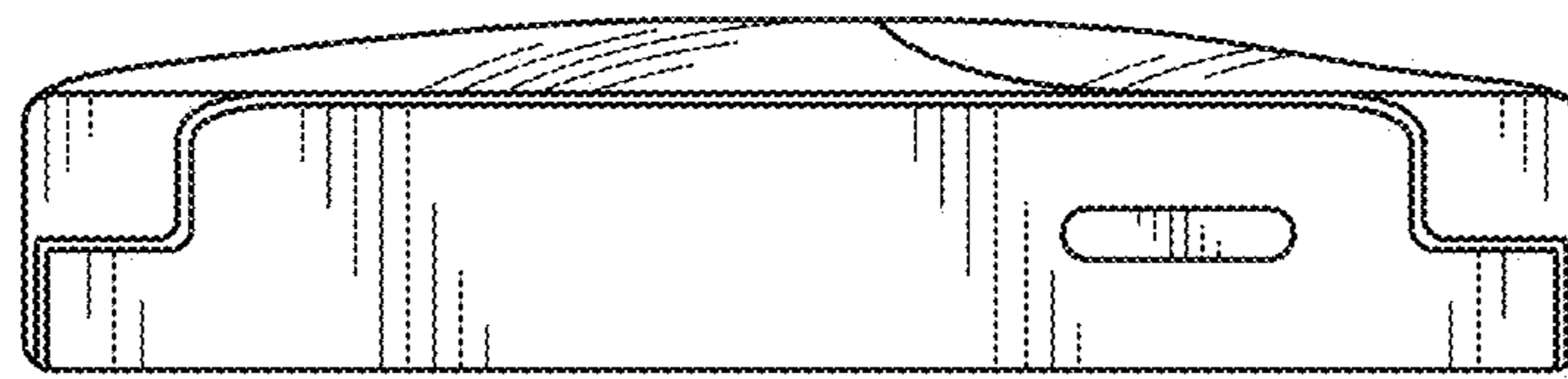

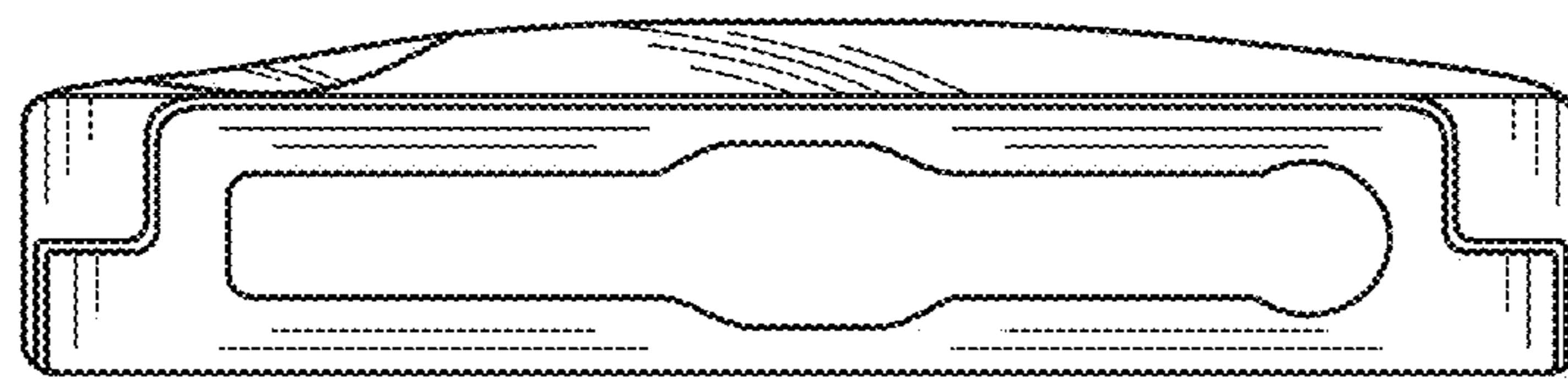

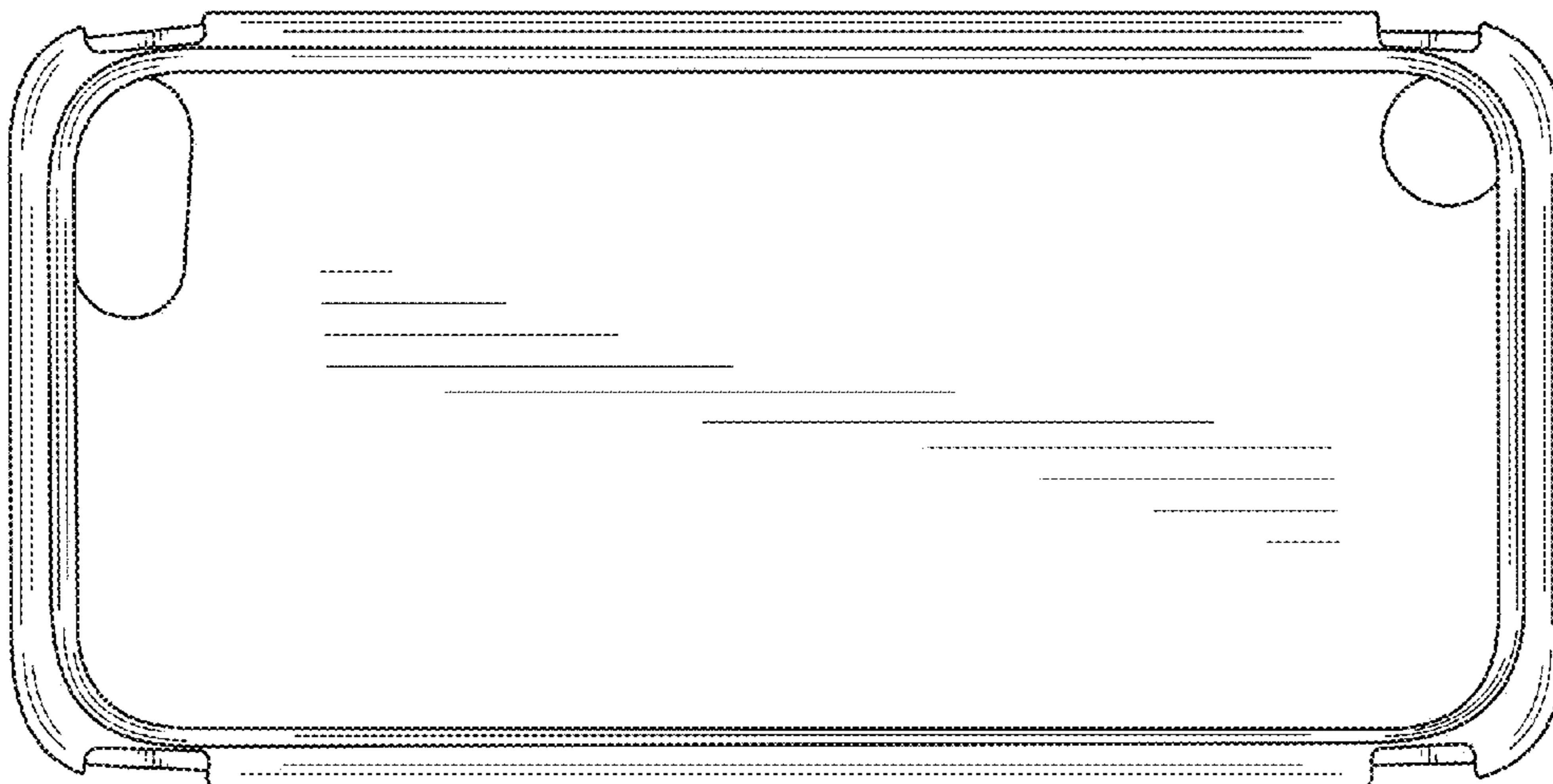
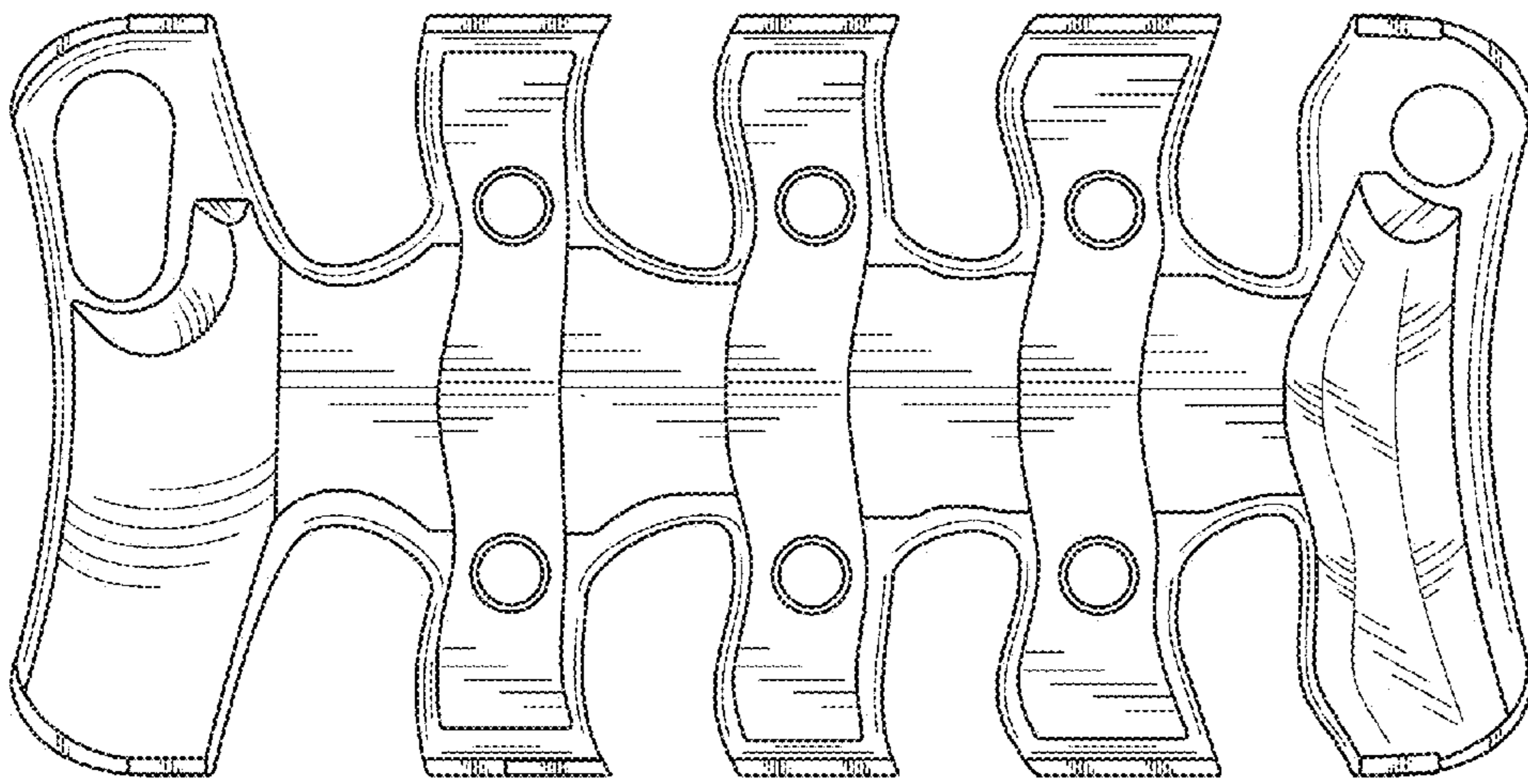
