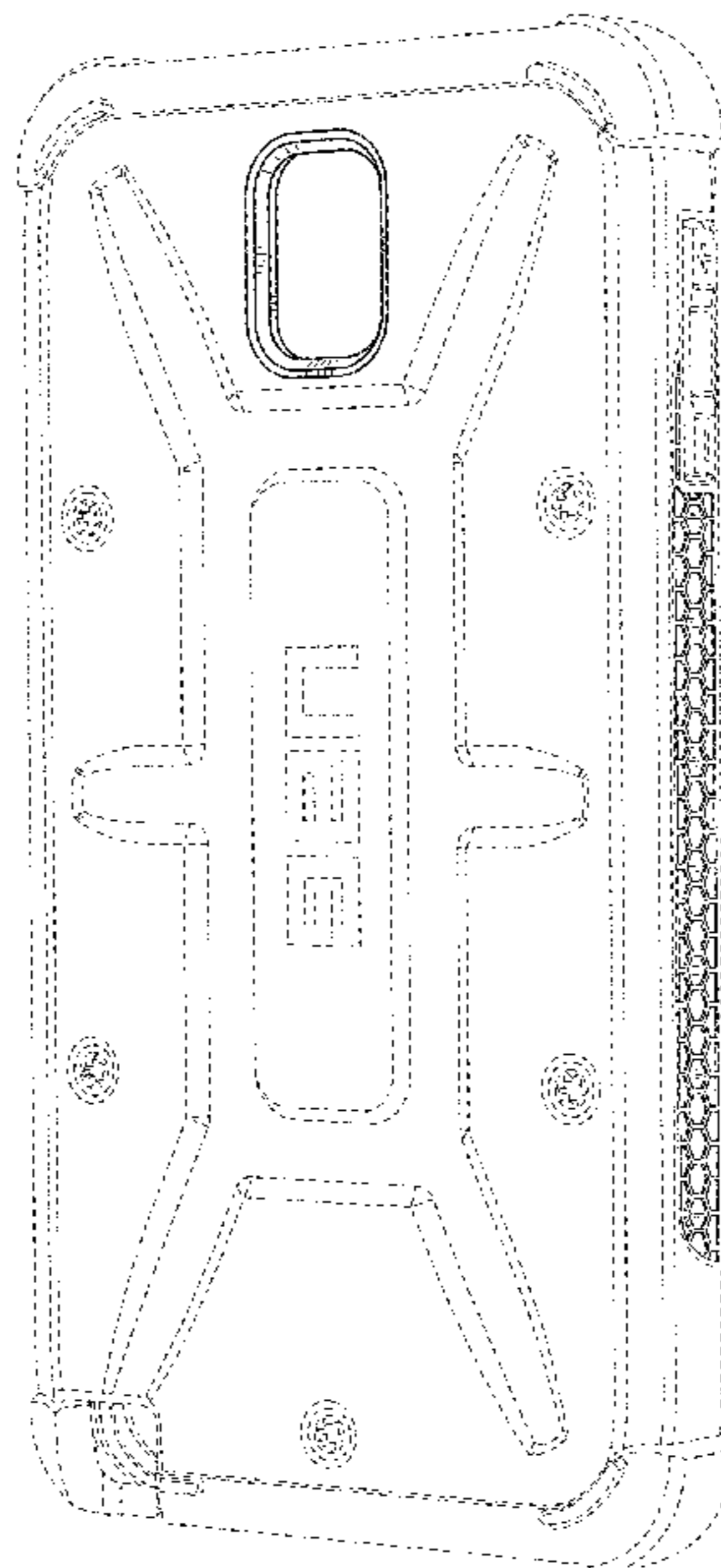

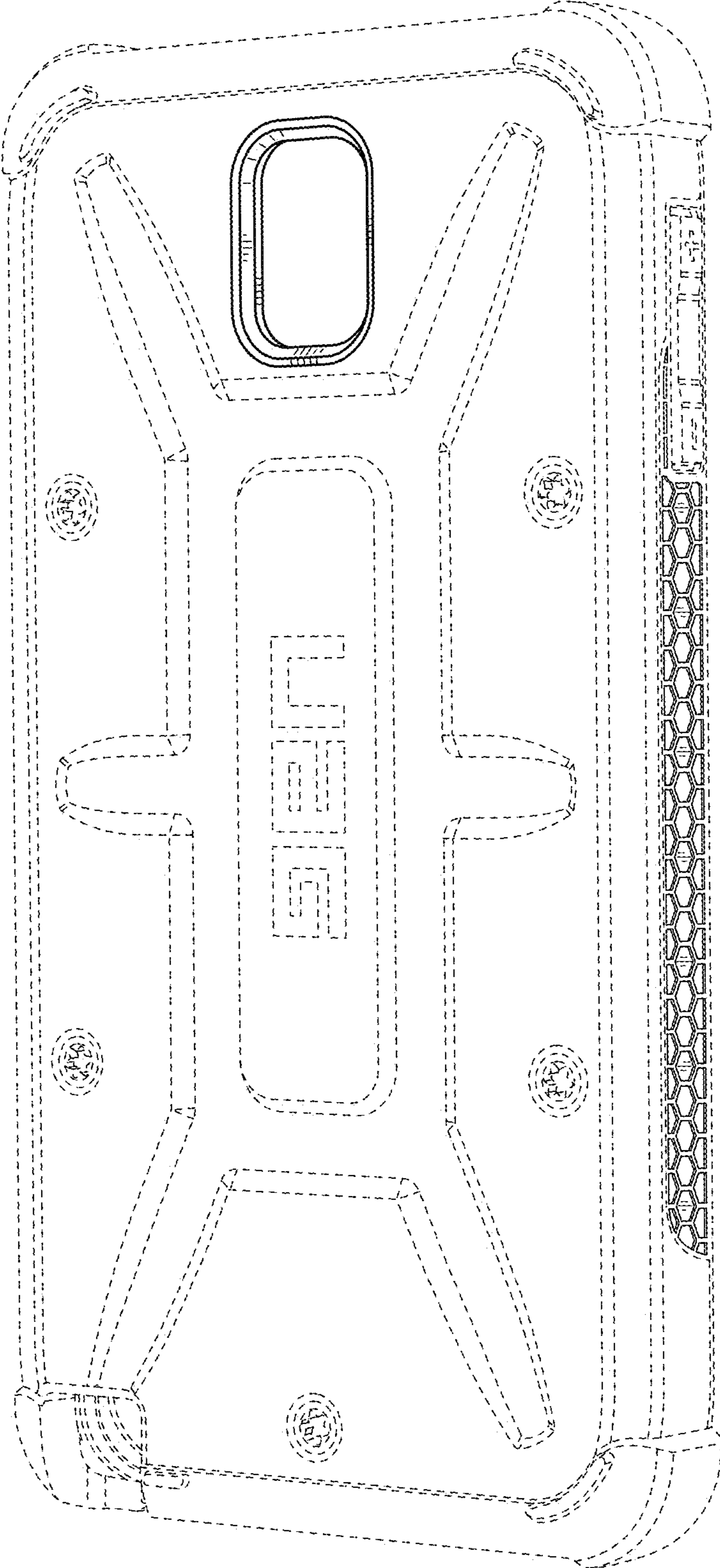
The ornamental design for a protective case for phone, as shown and described.

**DESCRIPTION**

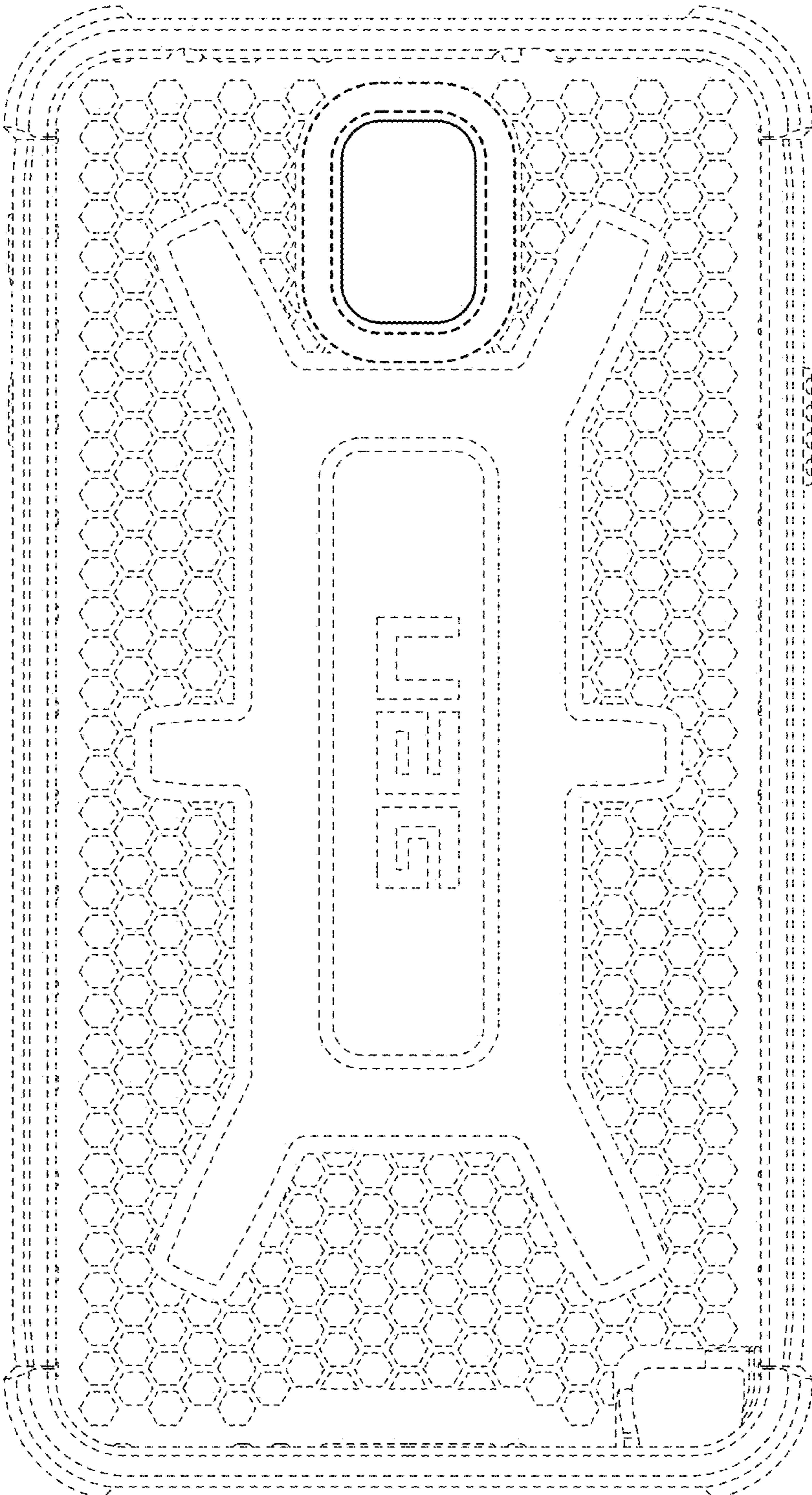
FIG. 1 is a front perspective view of a protective case for phone showing our new design;

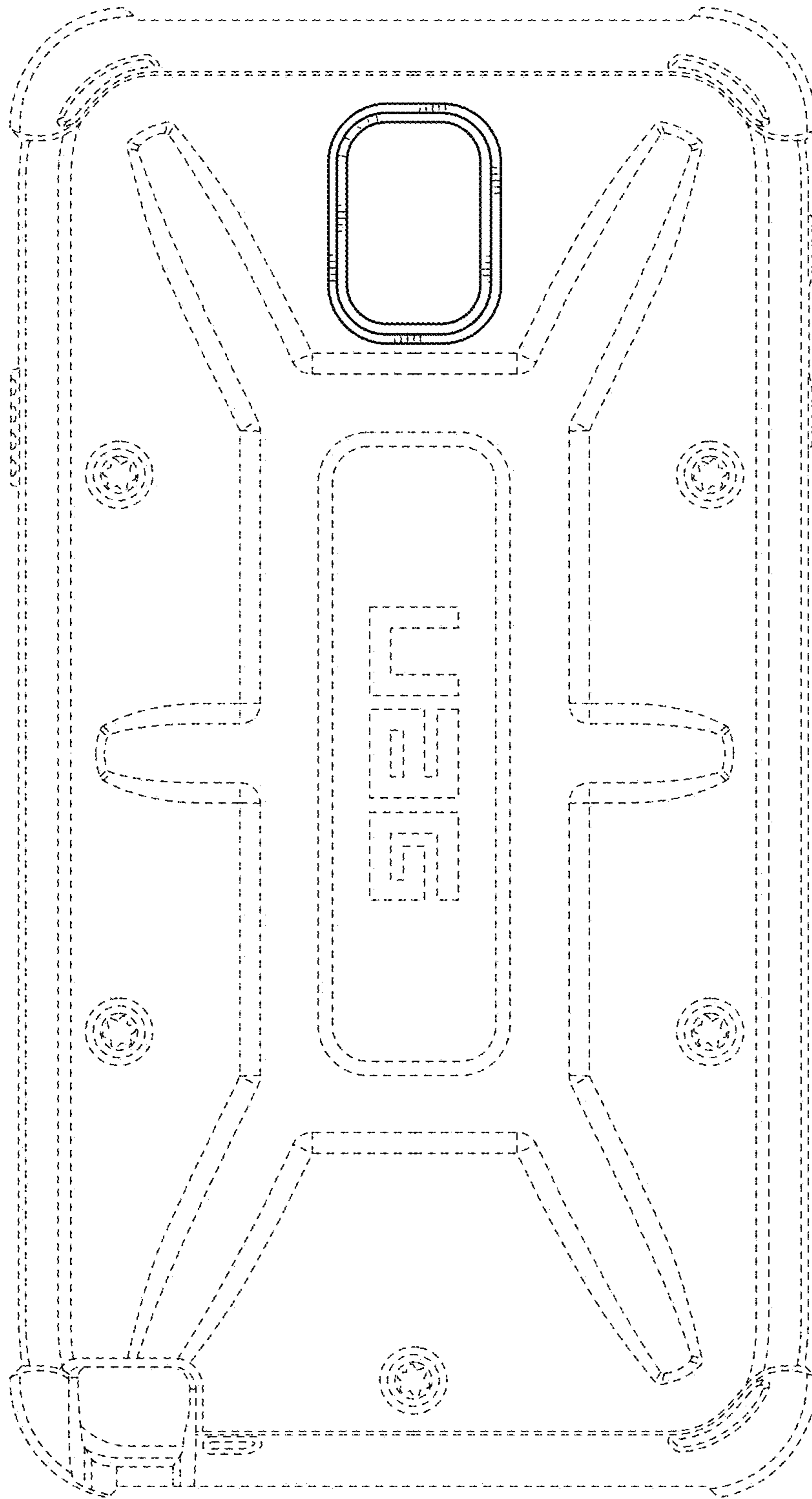




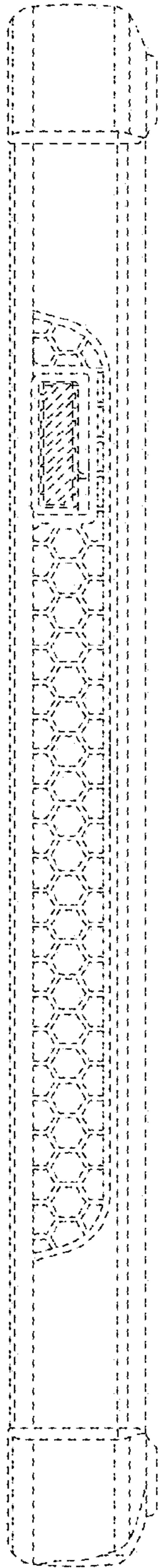

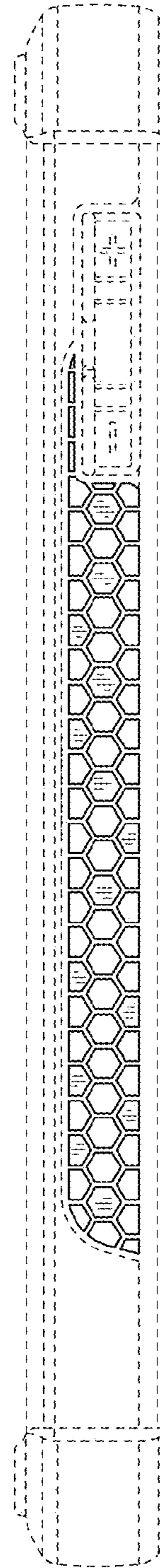

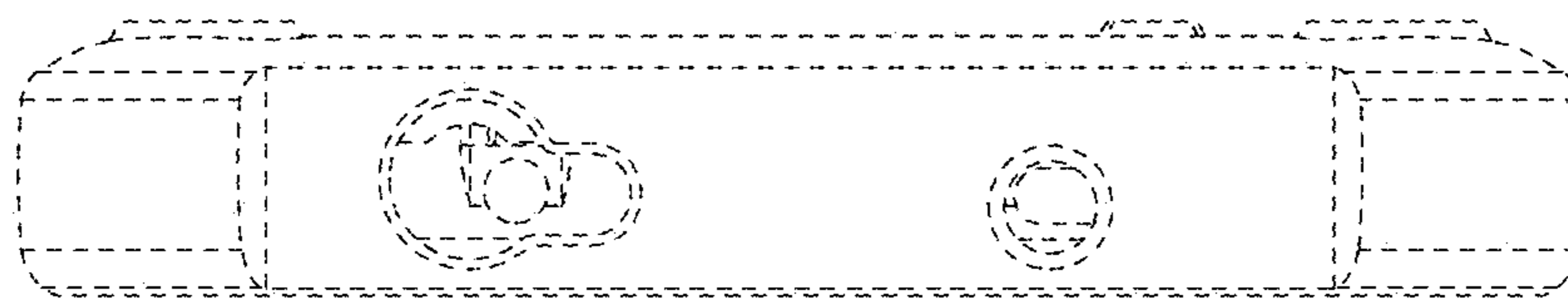

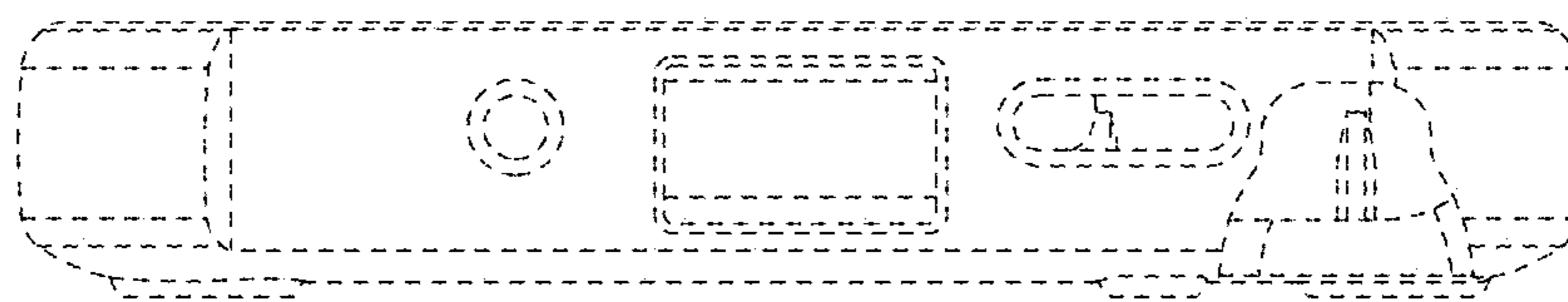
