The ornamental design for a display screen with icon group and display screen with icon set, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a display screen with icon group showing the new design;

FIG. 3 is a front view of a display screen with icon set showing the new design;

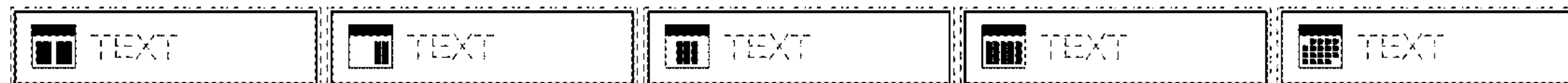
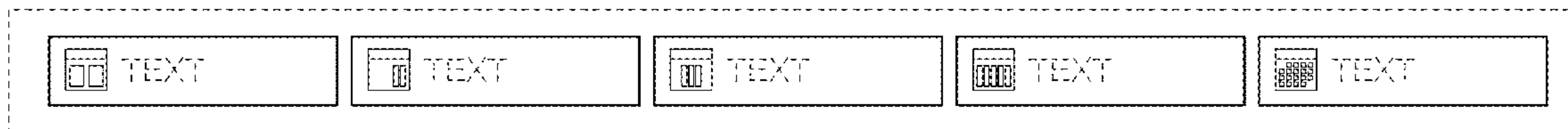
FIG. 4 is another embodiment thereof; and,

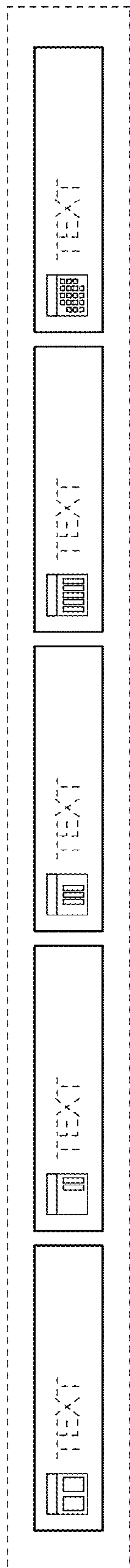

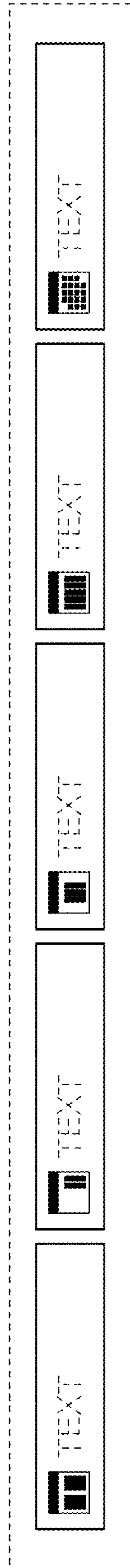

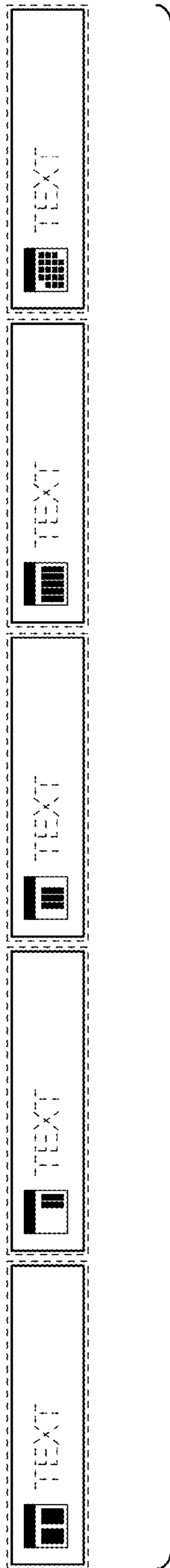

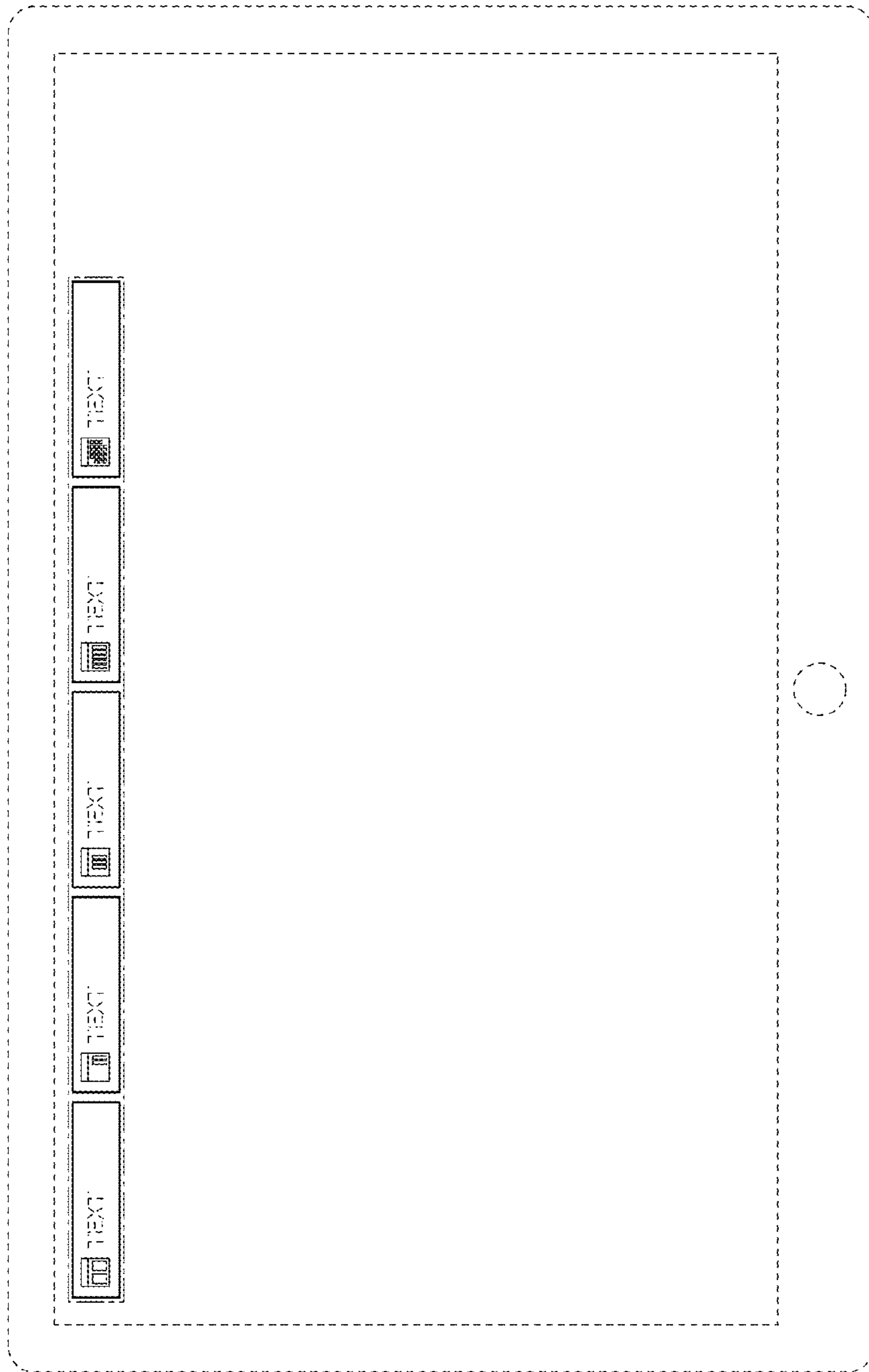
