DESCRIPTION

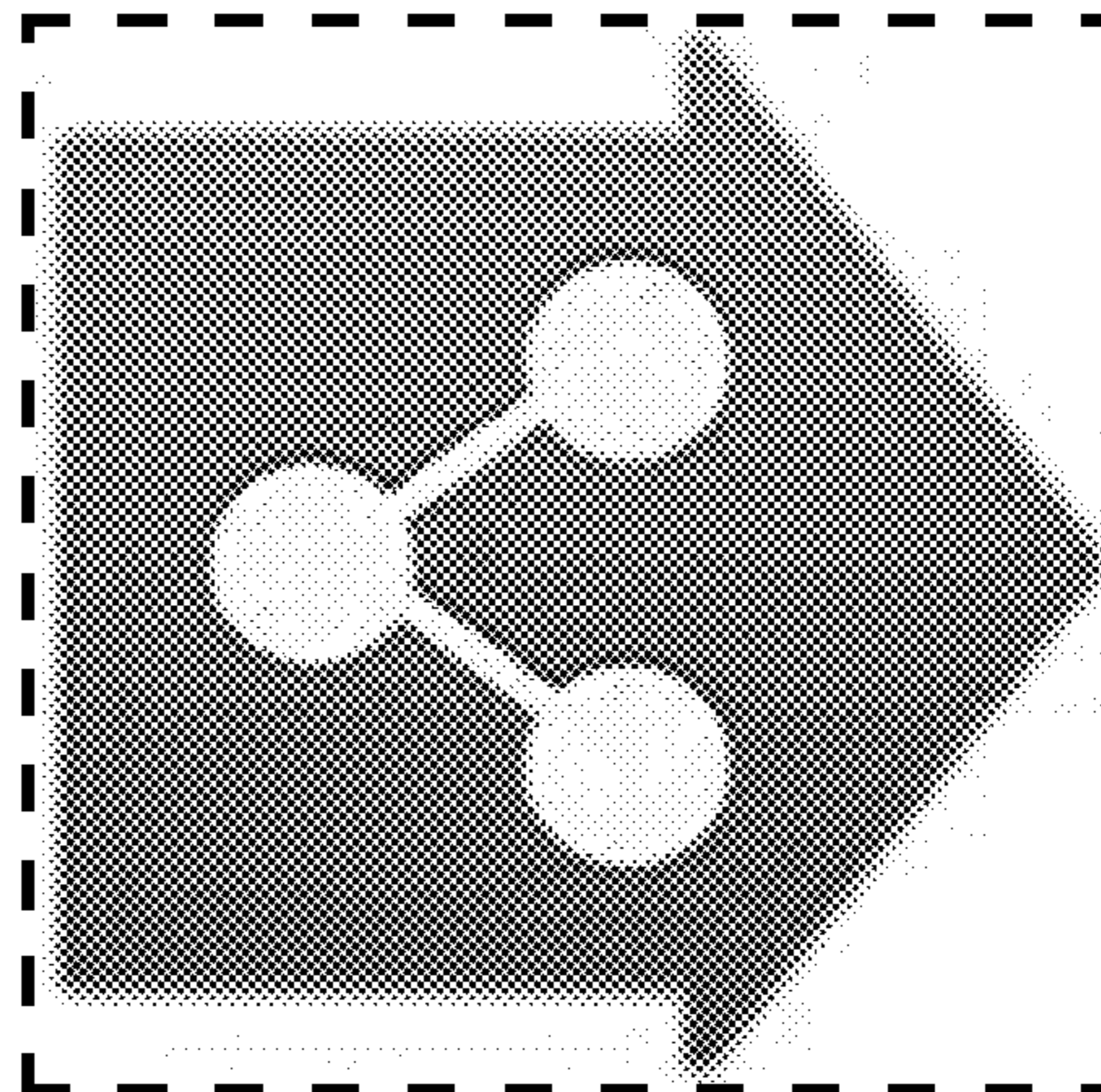
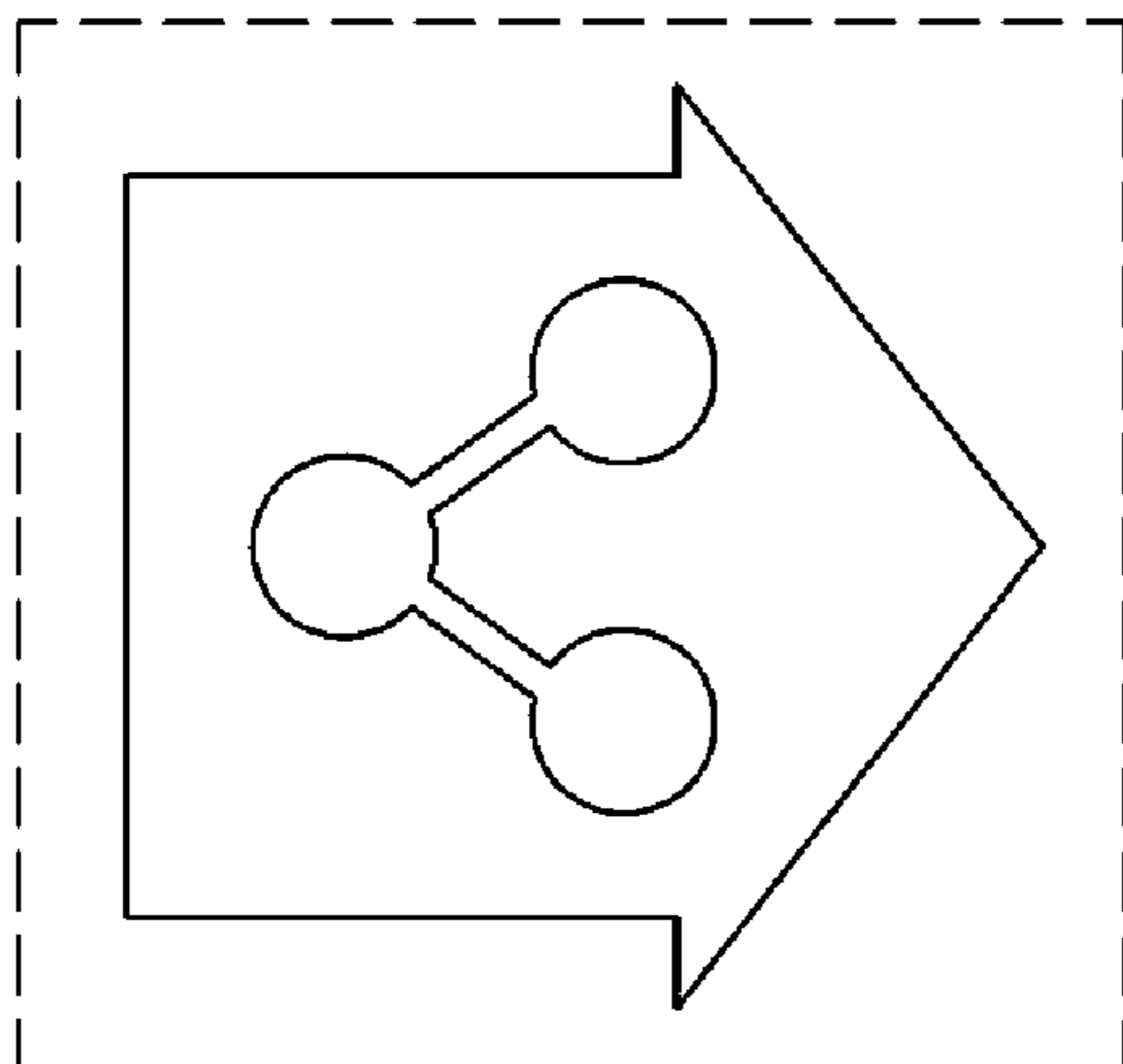
FIG. 1 is a front view of a display screen or portion thereof with icon, showing my new design; and,

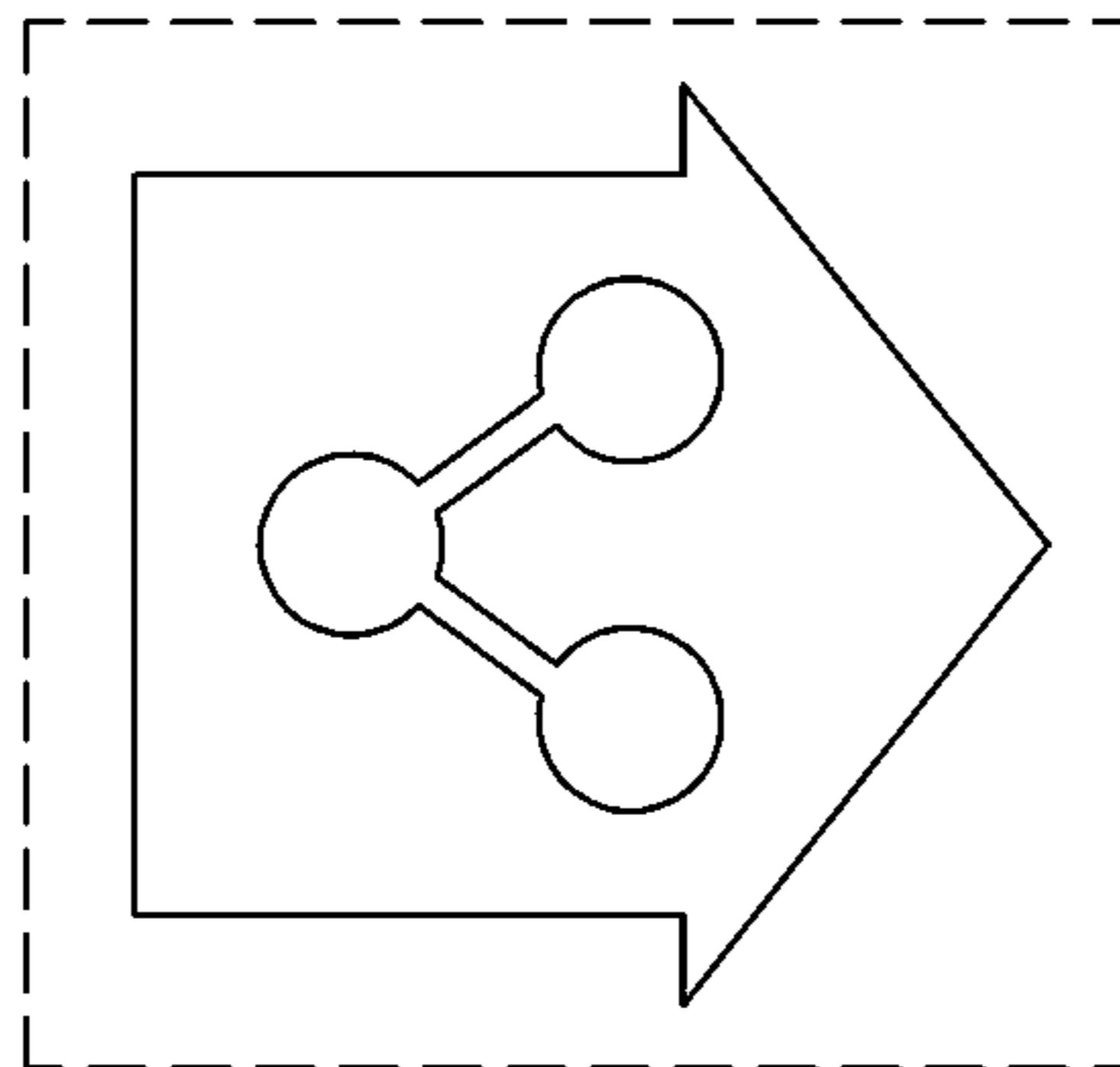
