(57) **CLAIM**

The ornamental design for an icon for a display screen or packaging with surface ornamentation, as shown and described.

**DESCRIPTION**

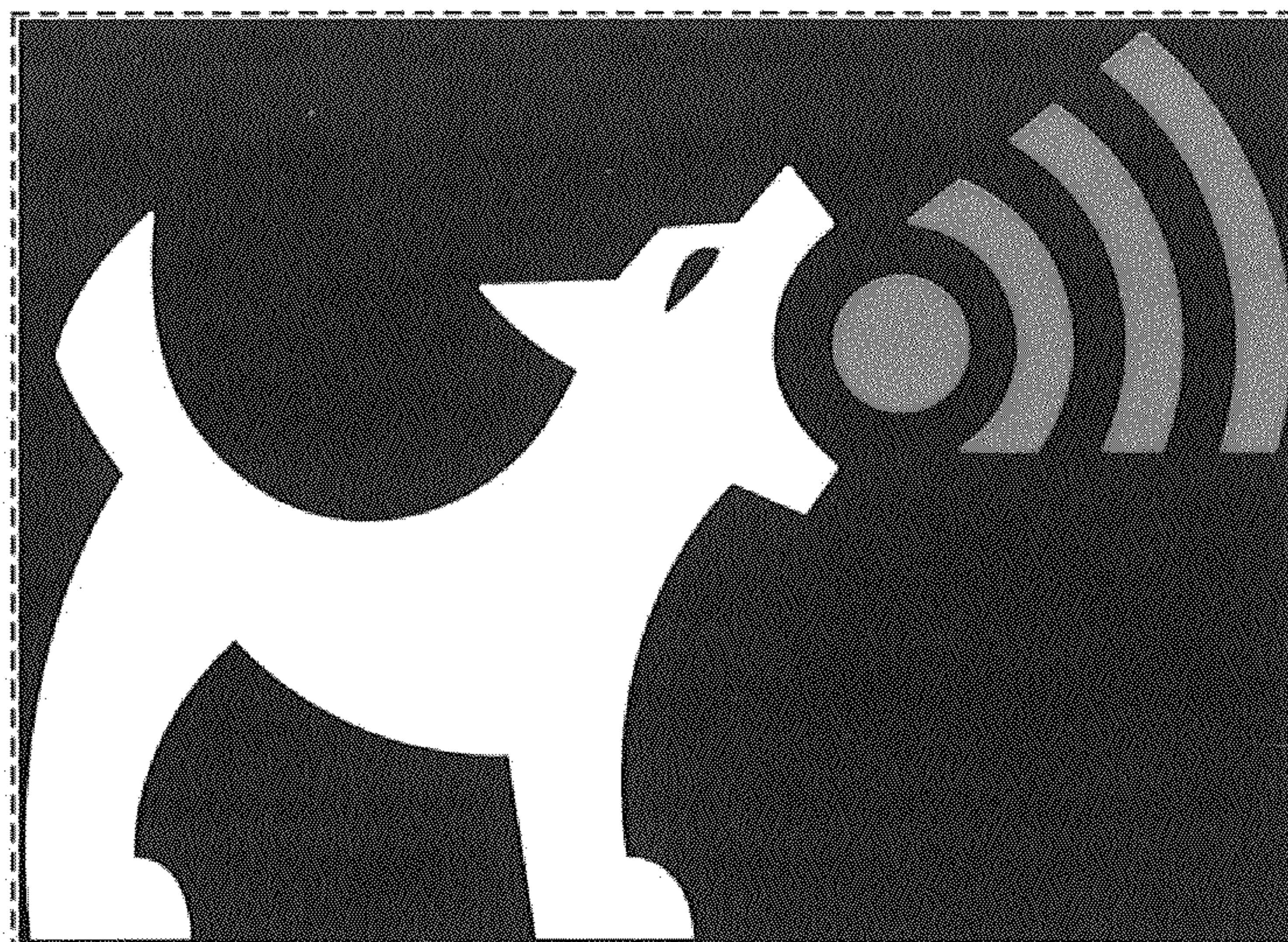

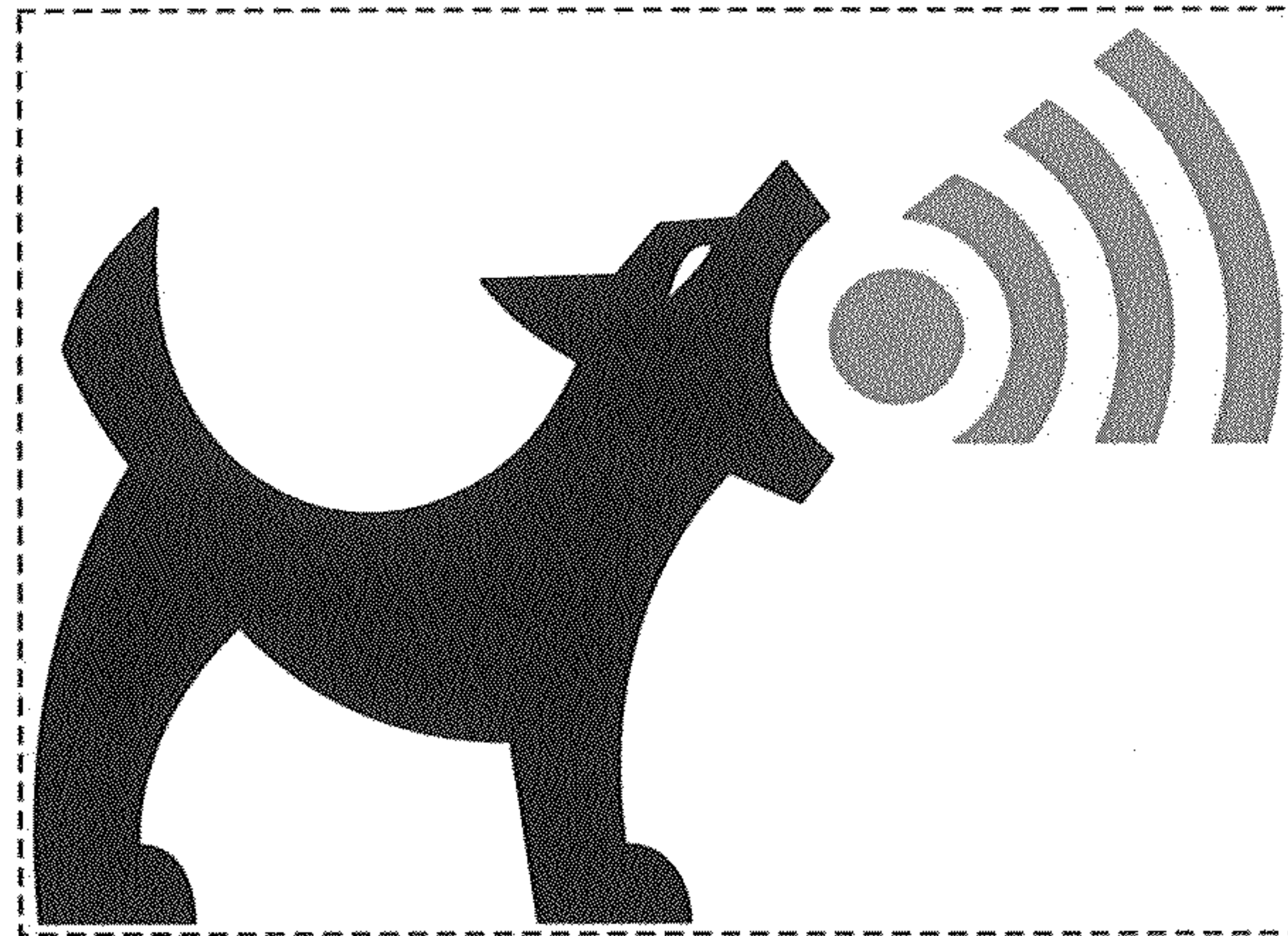

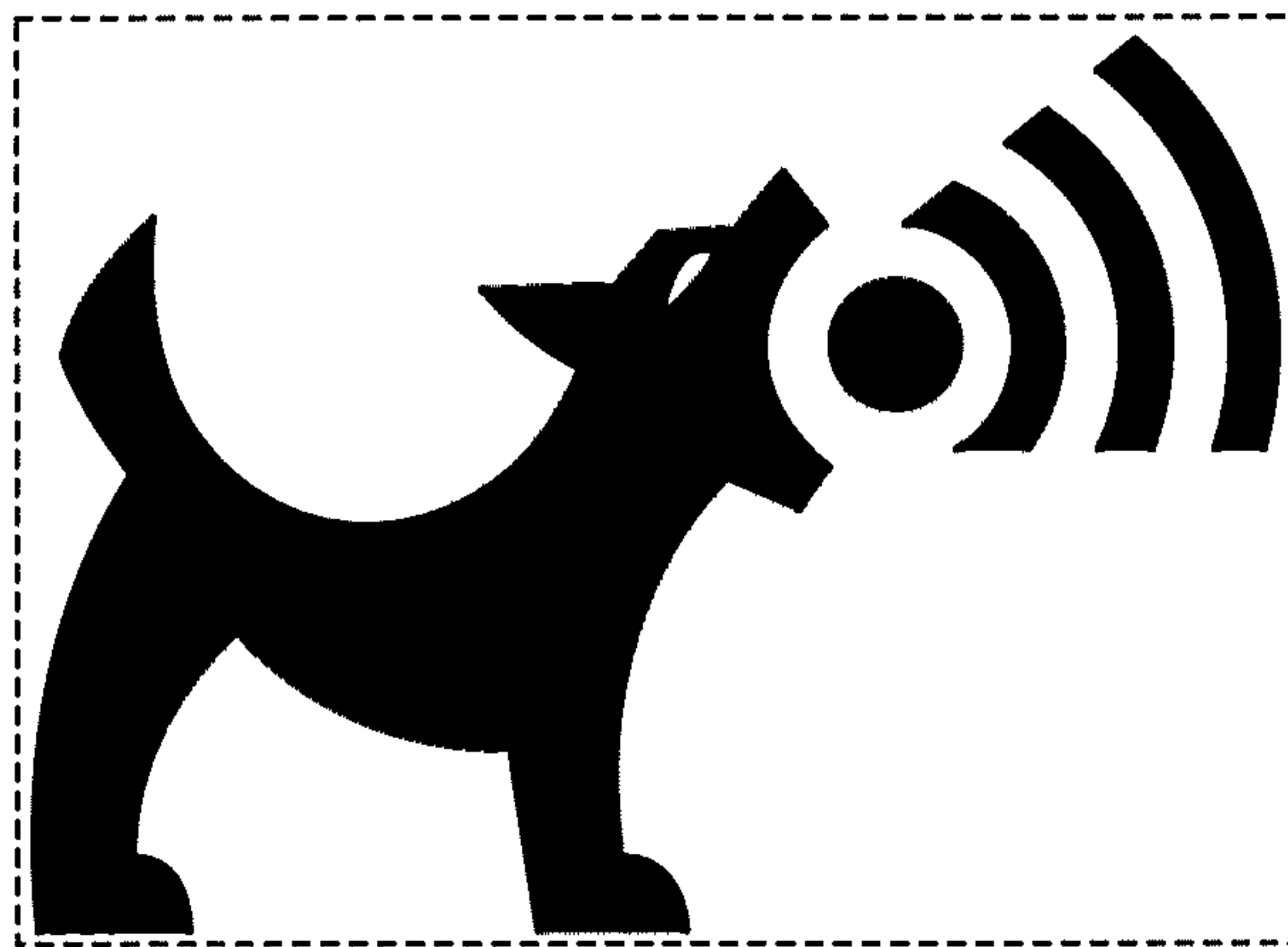

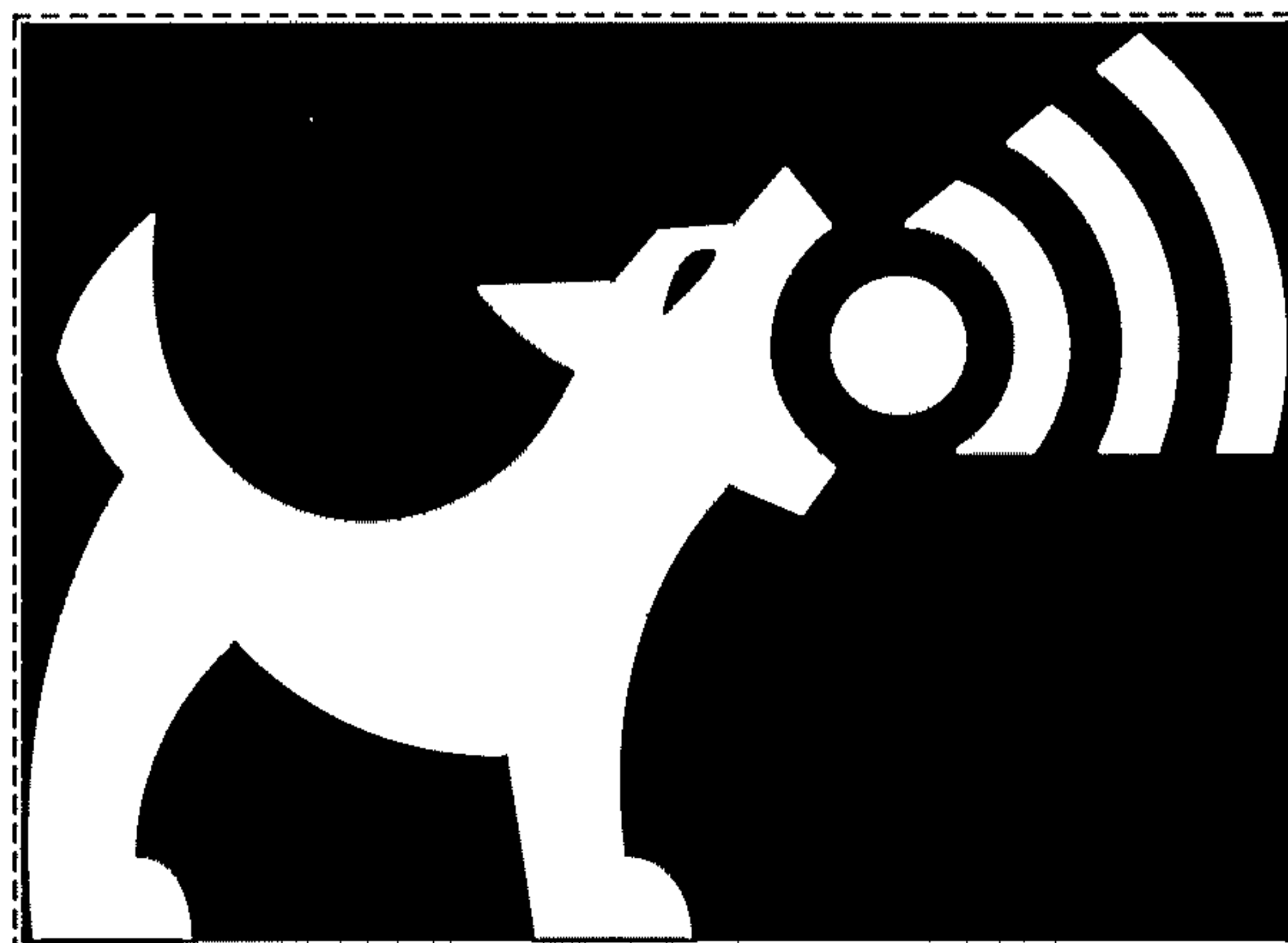
