(57) **CLAIM**

The ornamental design for a refrigerated cooler, as shown and described.

**DESCRIPTION**

FIG. 1 is the front right side perspective view of the refrigerated cooler according to the present invention;

FIG. 2 is a right side view of the refrigerated cooler as shown in FIG. 1; the left side view of the refrigerated cooler is a mirror image of the right side view, and therefore omitted;

FIG. 3 is a top view of the refrigerated cooler as shown in FIG. 1; and,

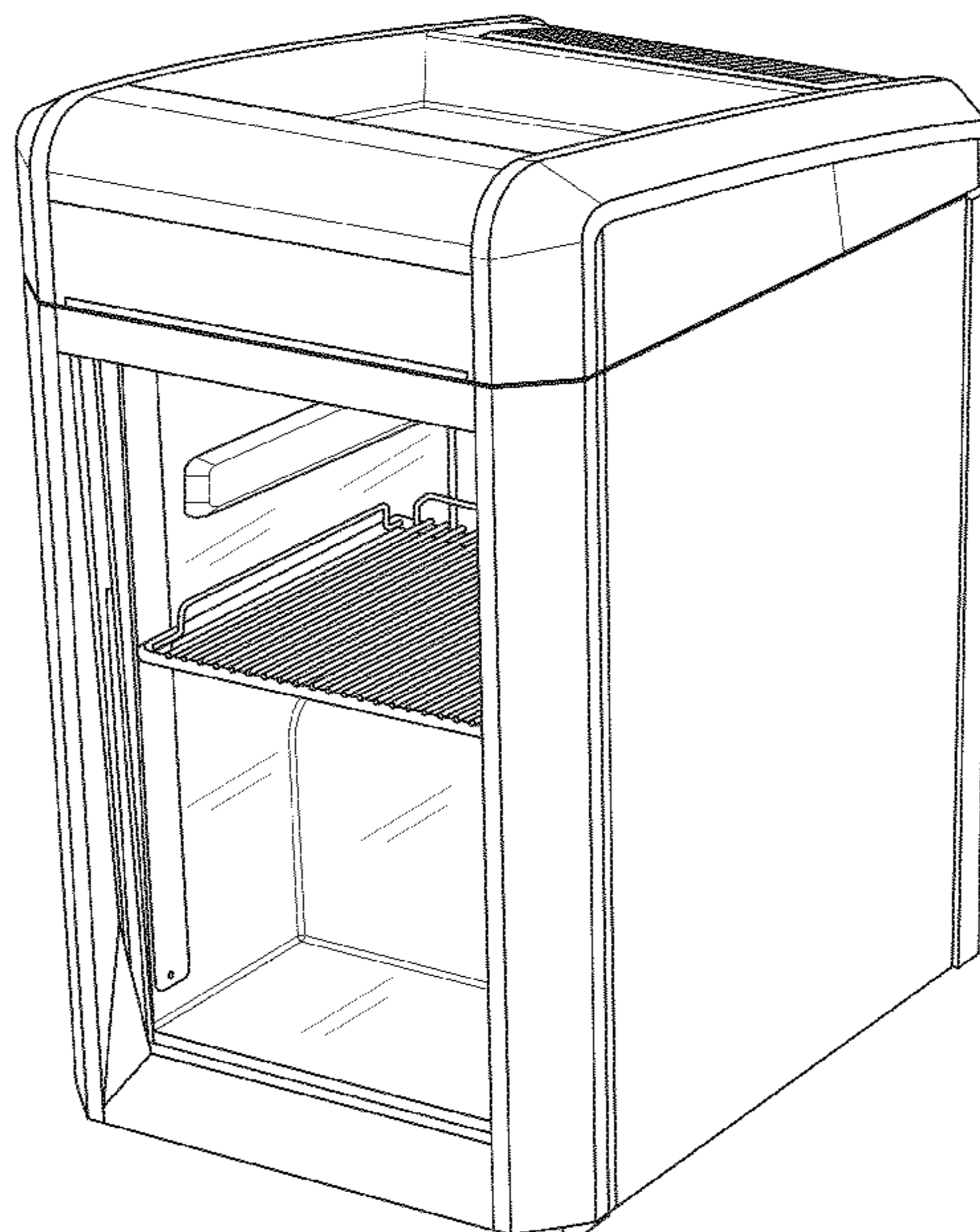
FIG. 4 is a front view of the refrigerated cooler as shown in FIG. 1.

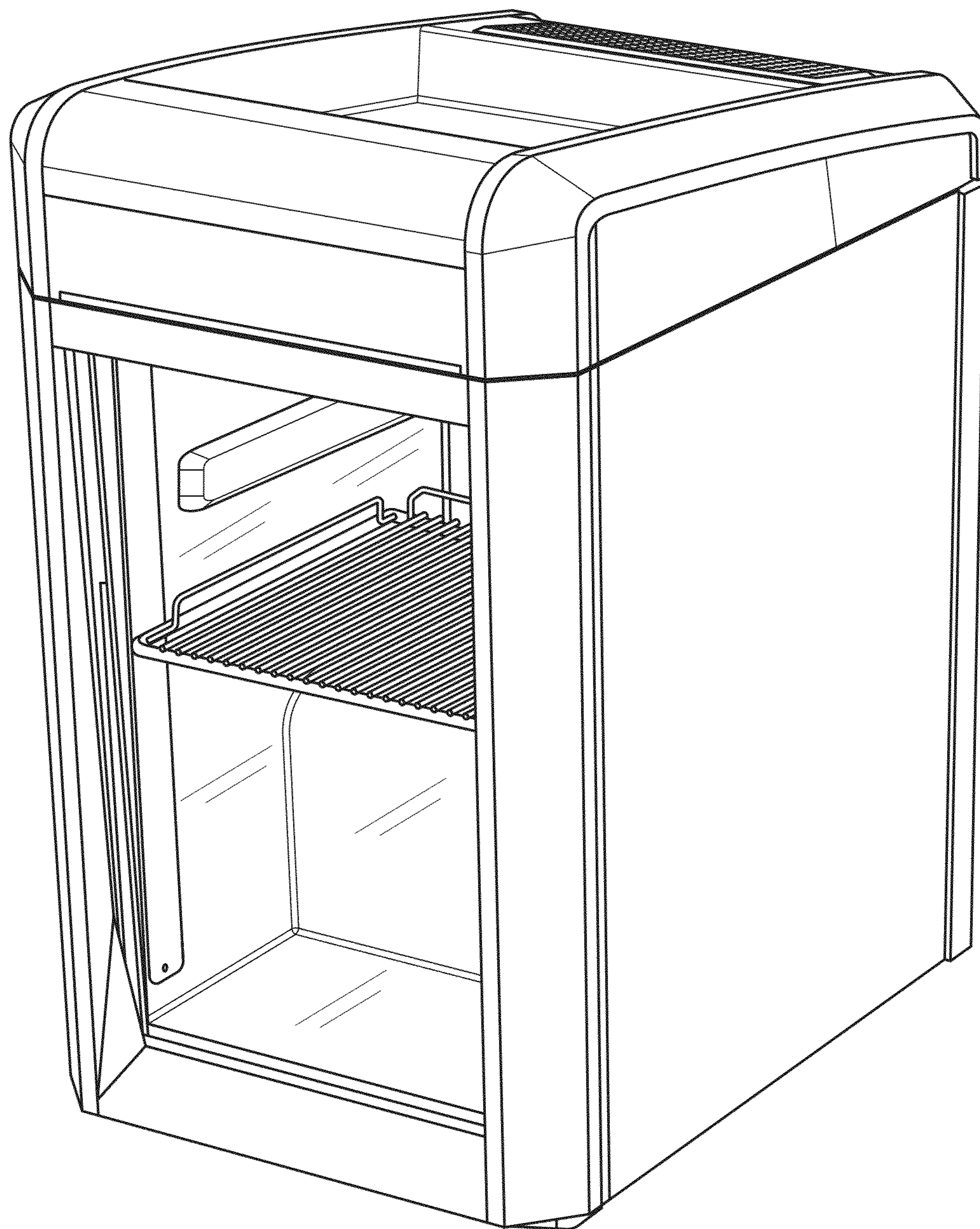

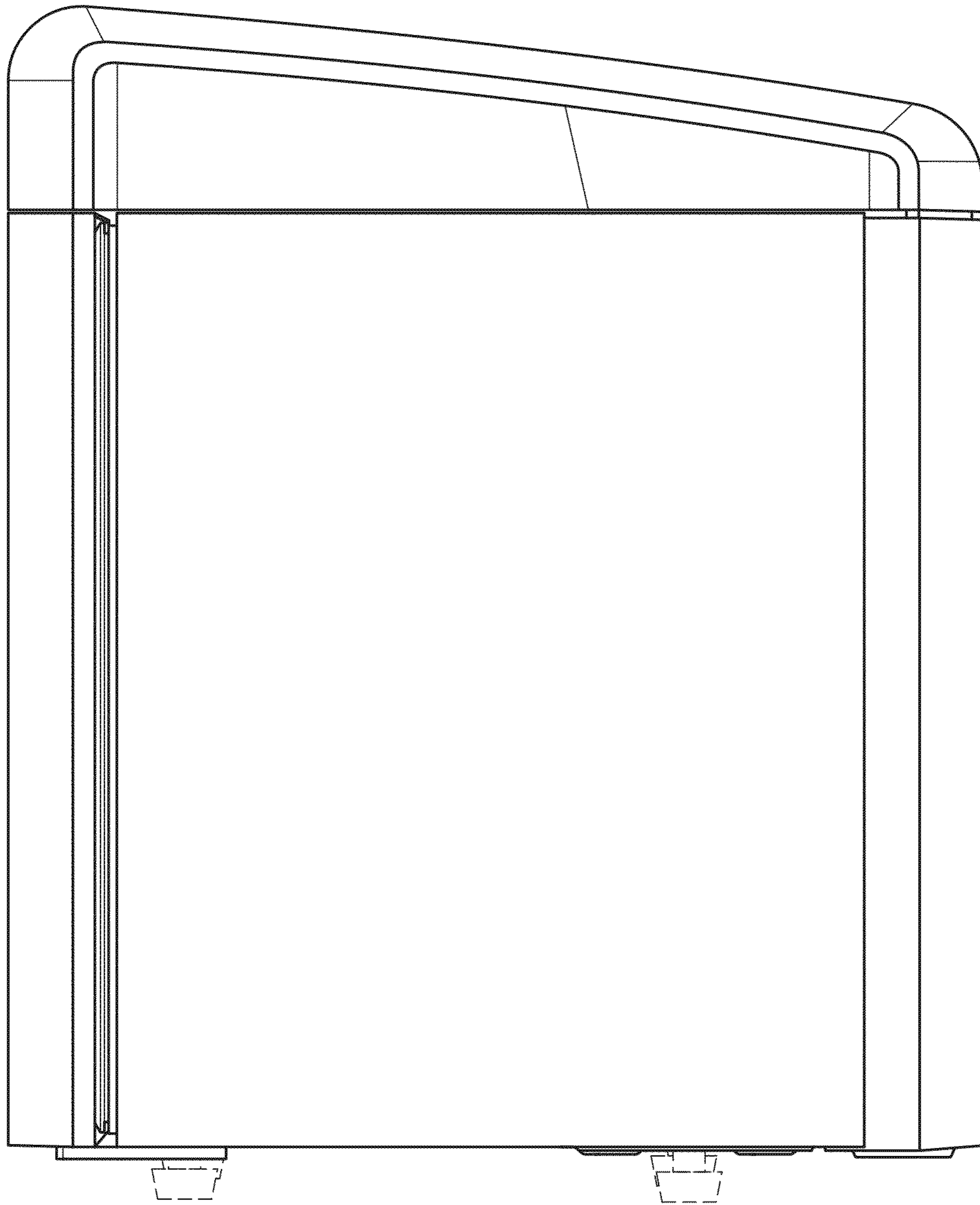

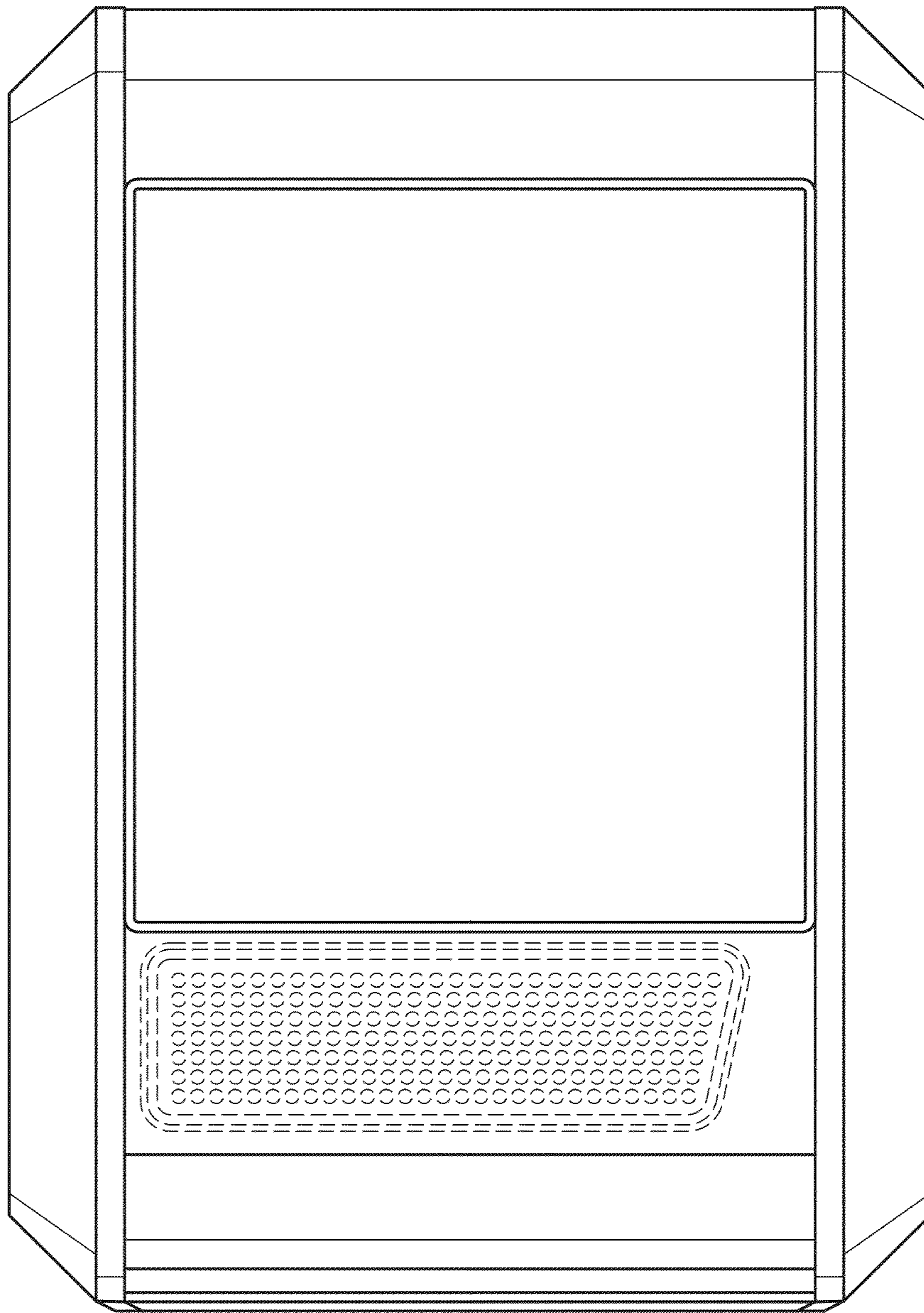

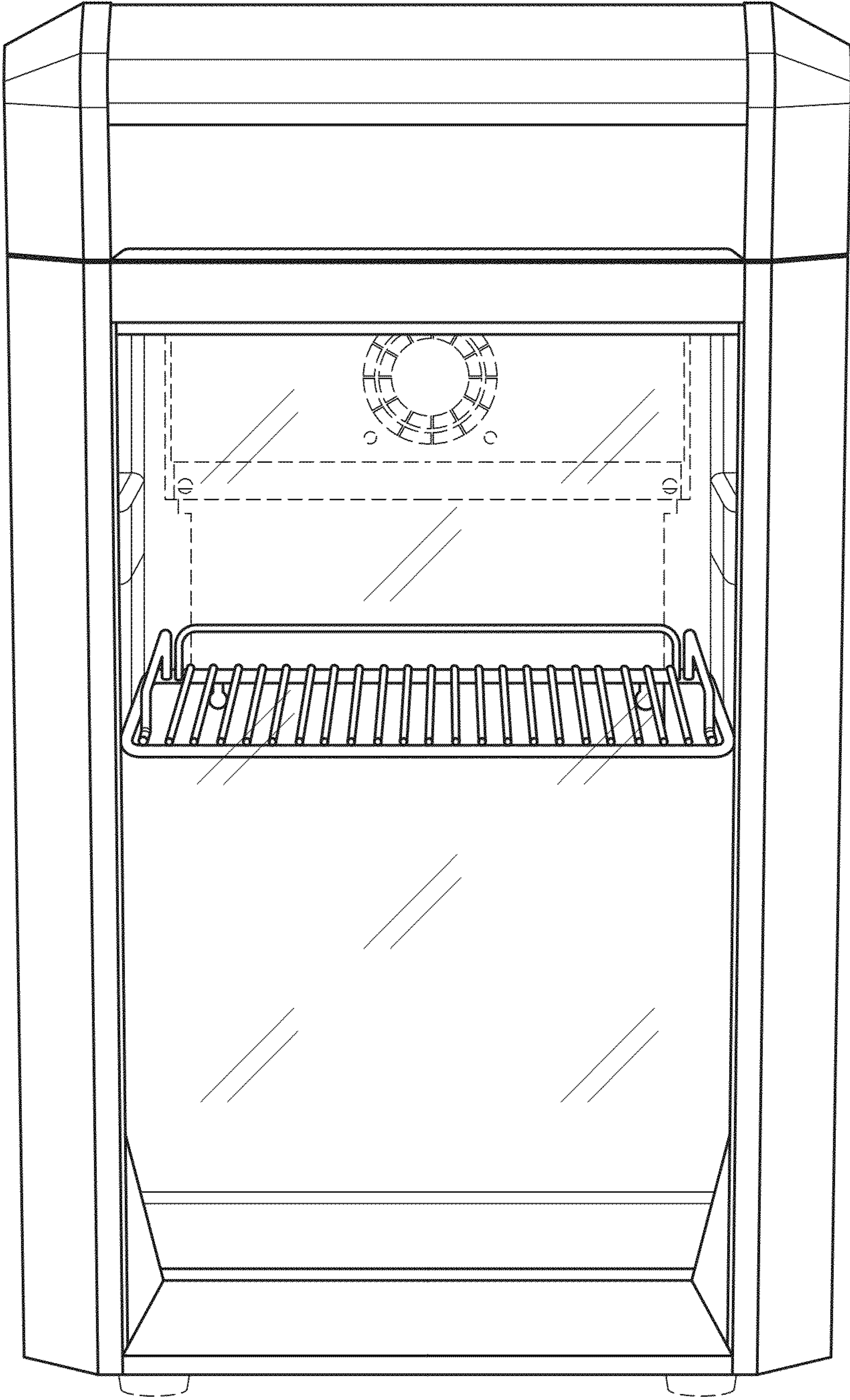
