FIG. 7 is a left side view thereof, the right side view, top view, and bottom view being identical.

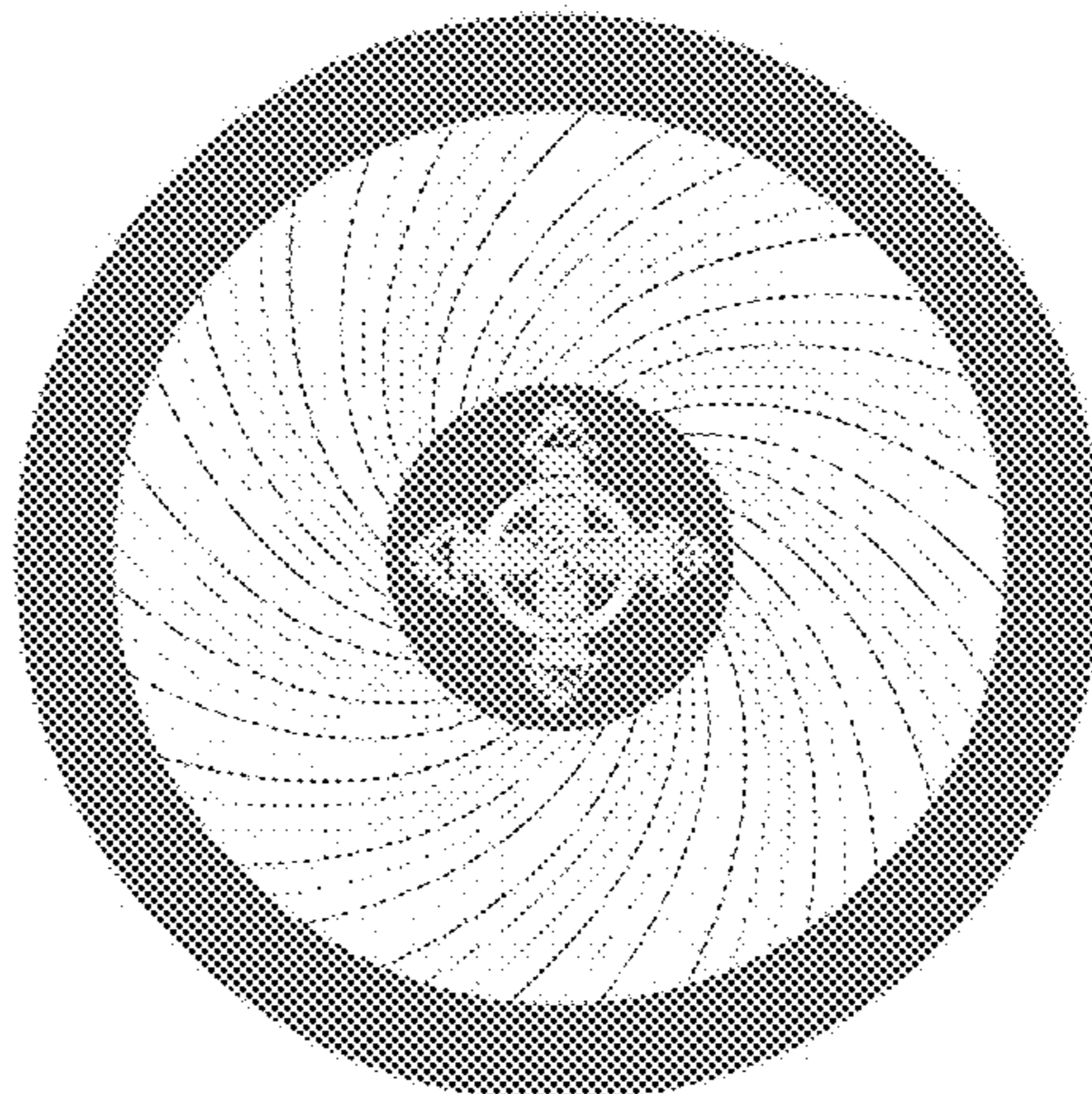

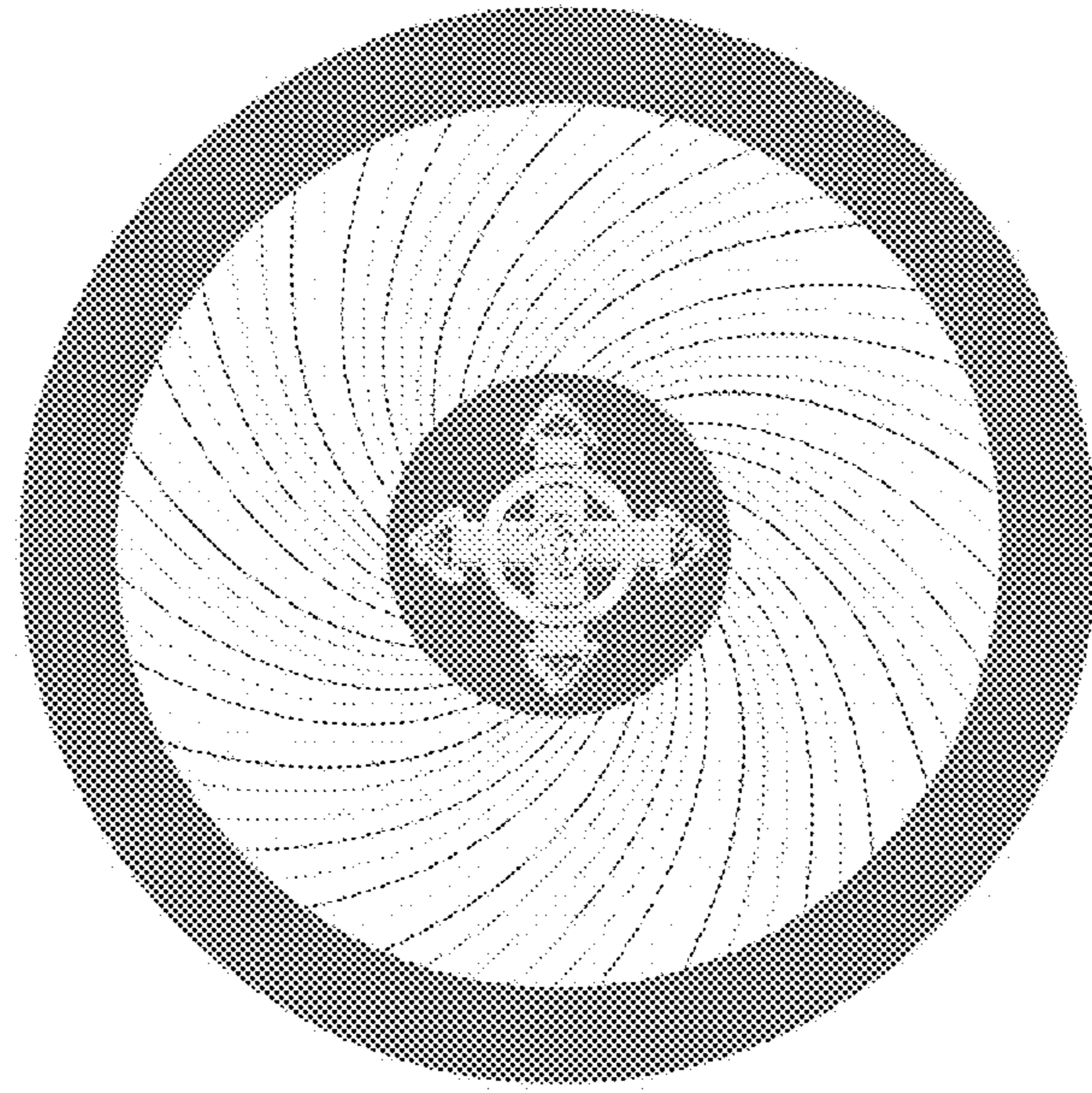

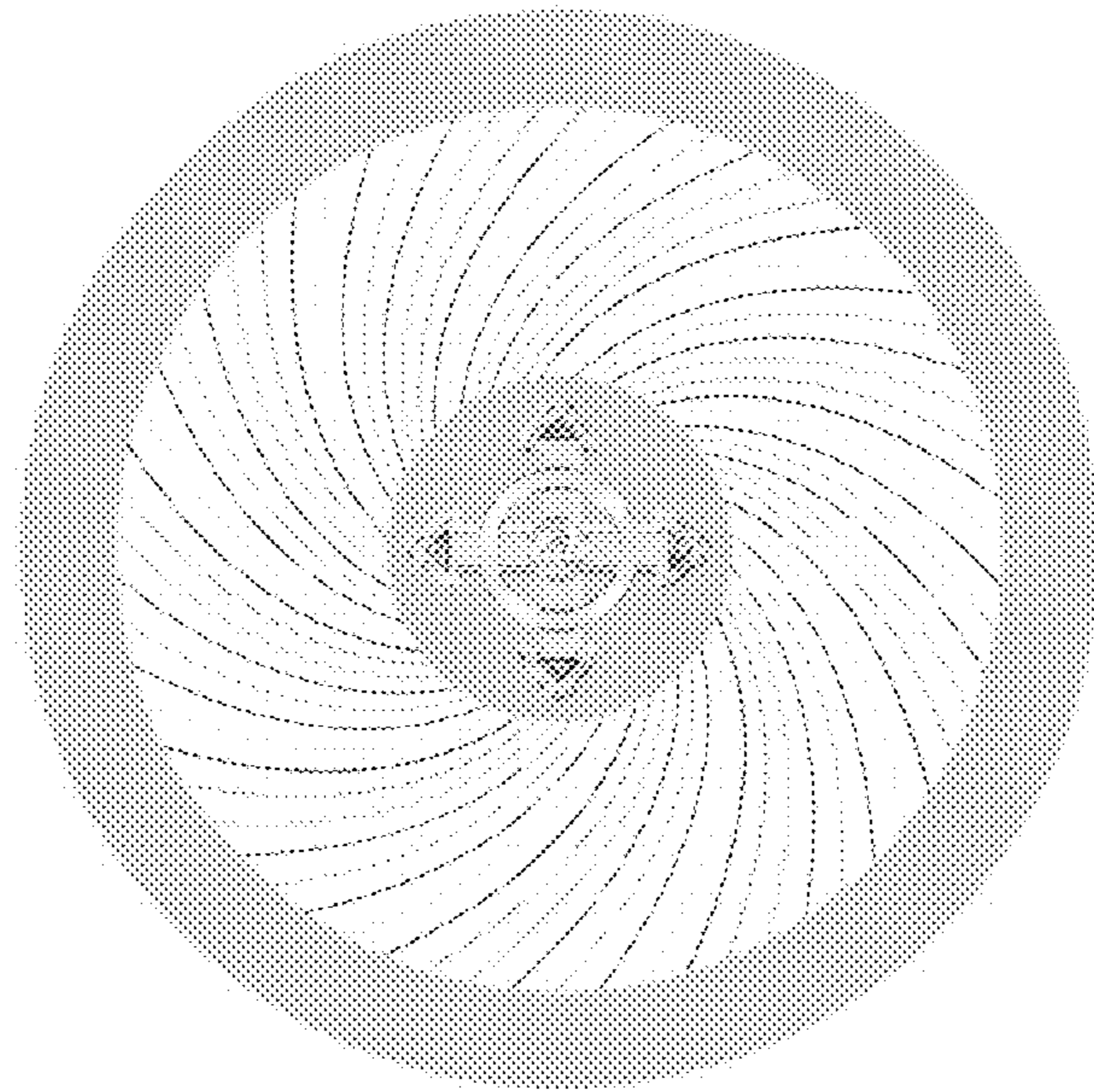

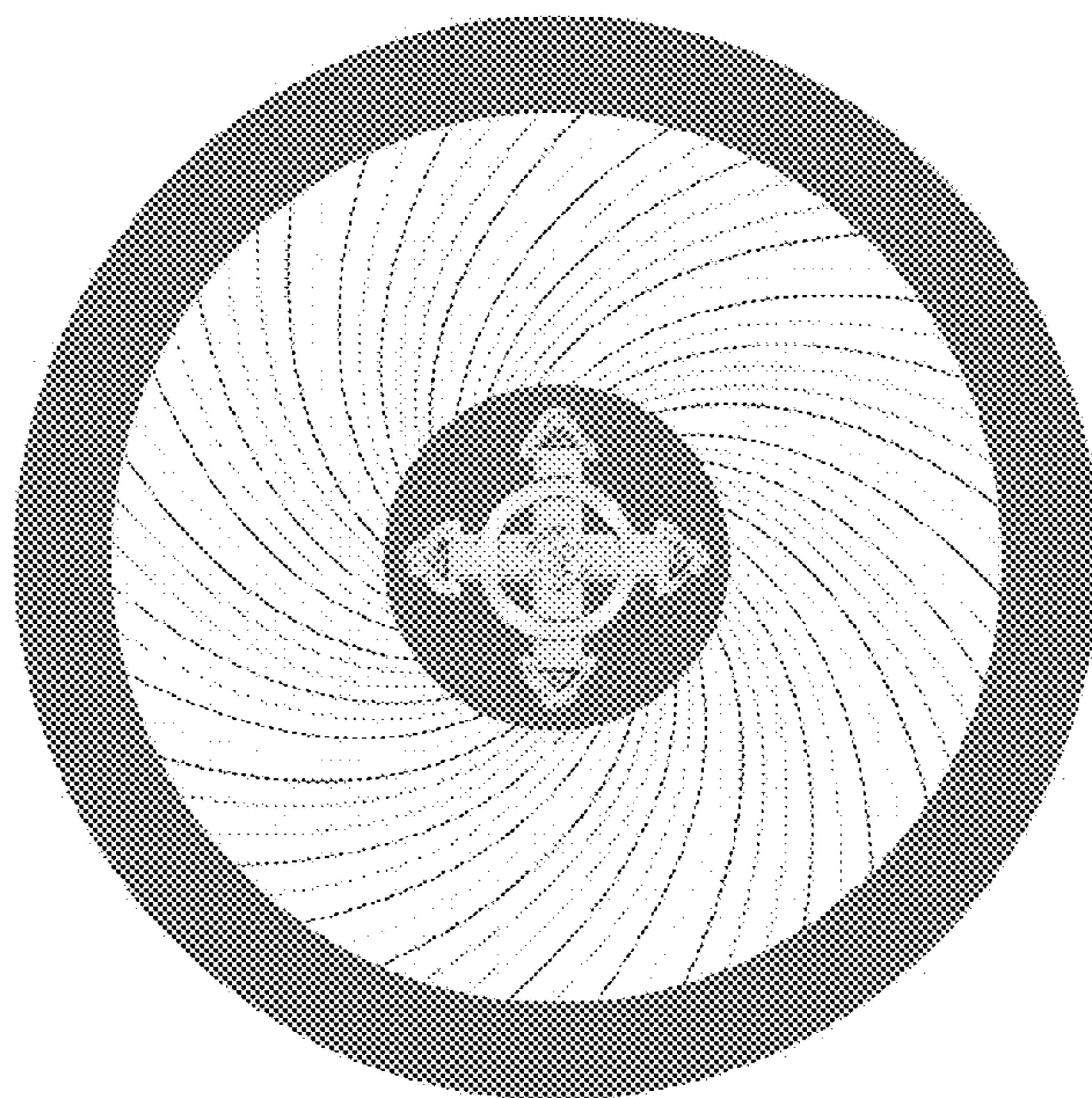

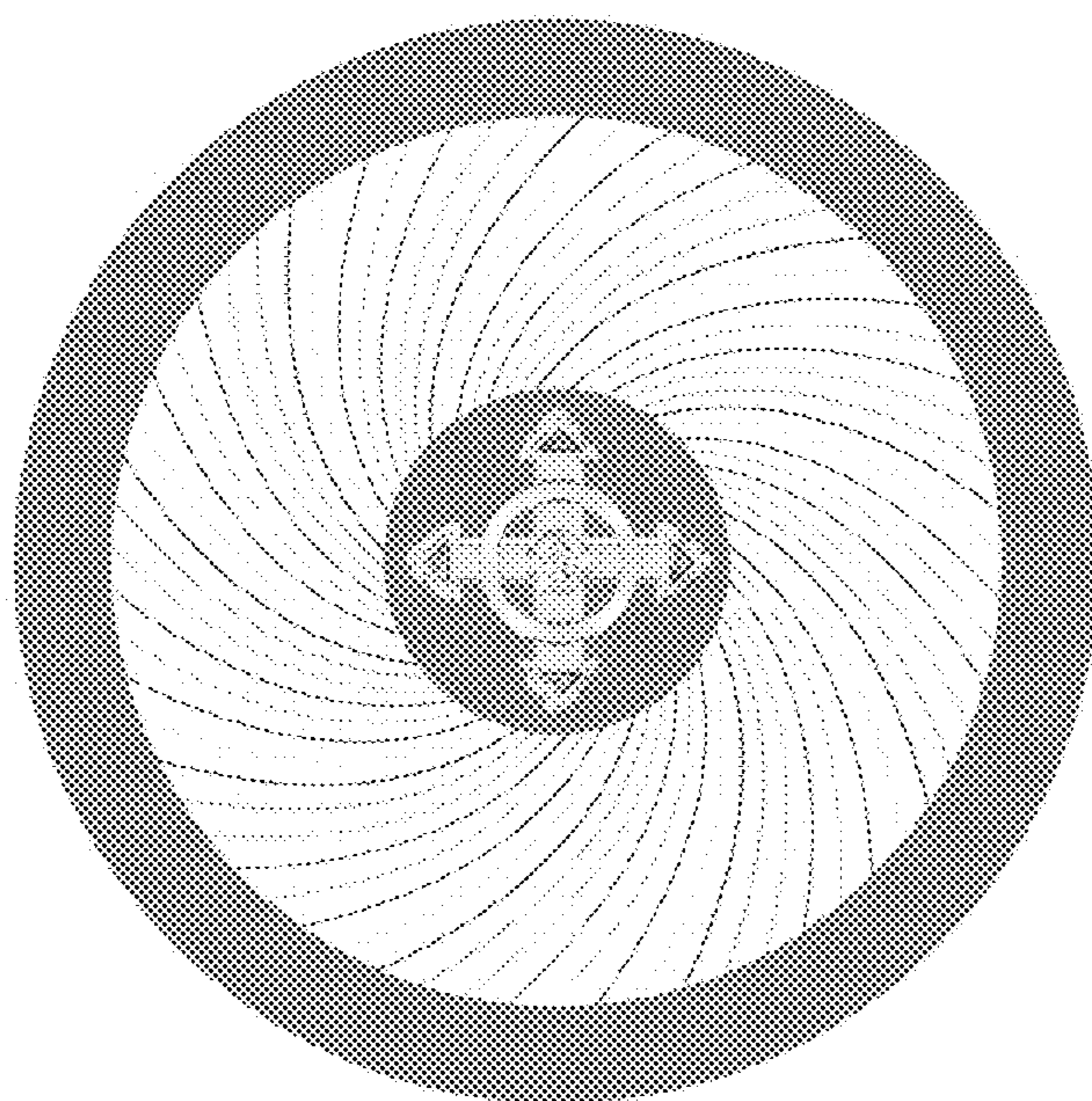

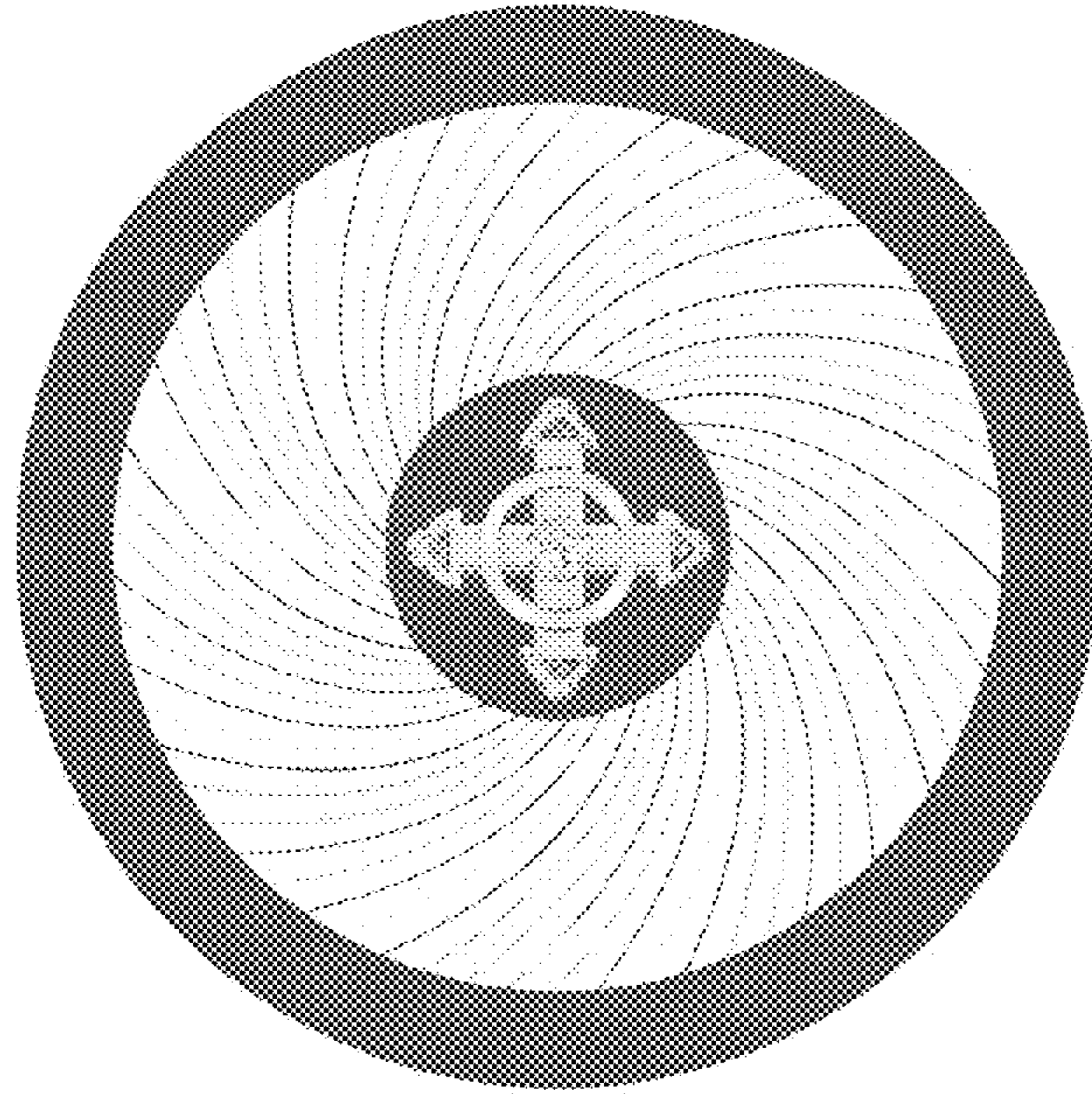

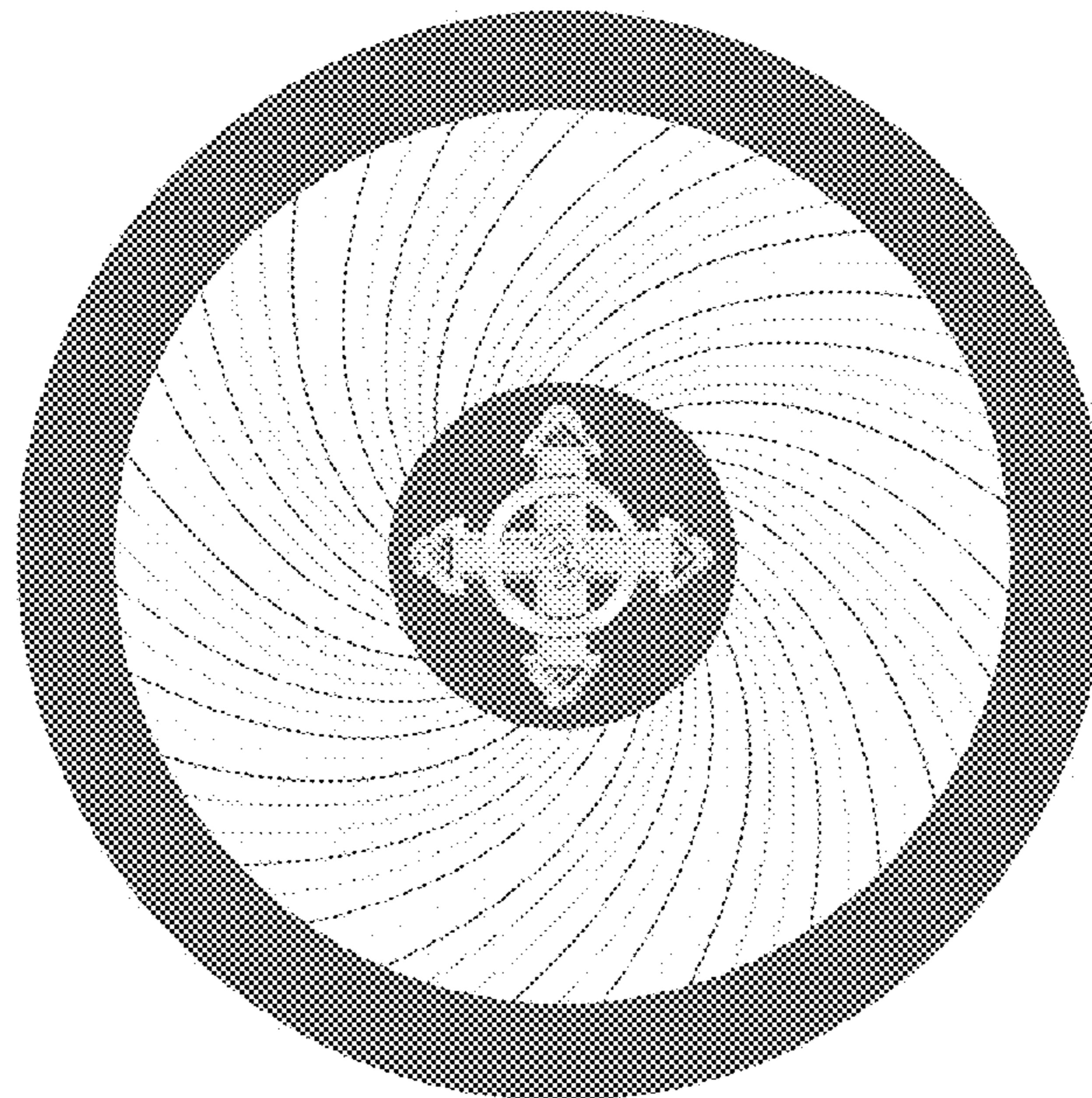
