(57) **CLAIM**

We claim the ornamental design for a pipe coupling segment, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a design of a pipe coupling segment according to our invention;

FIG. 2 is a front view of the pipe coupling segment shown in FIG. 1;

FIG. 3 is a back view of the pipe coupling segment shown in FIG. 1;

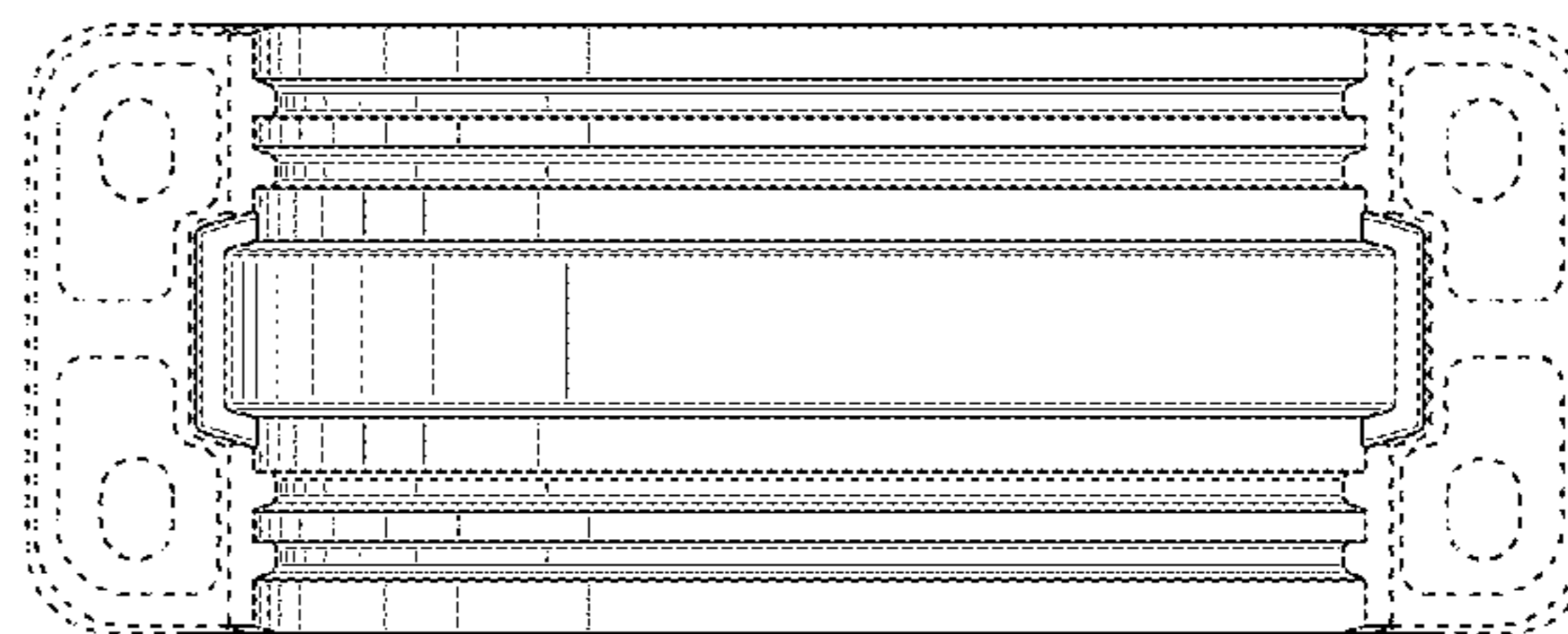
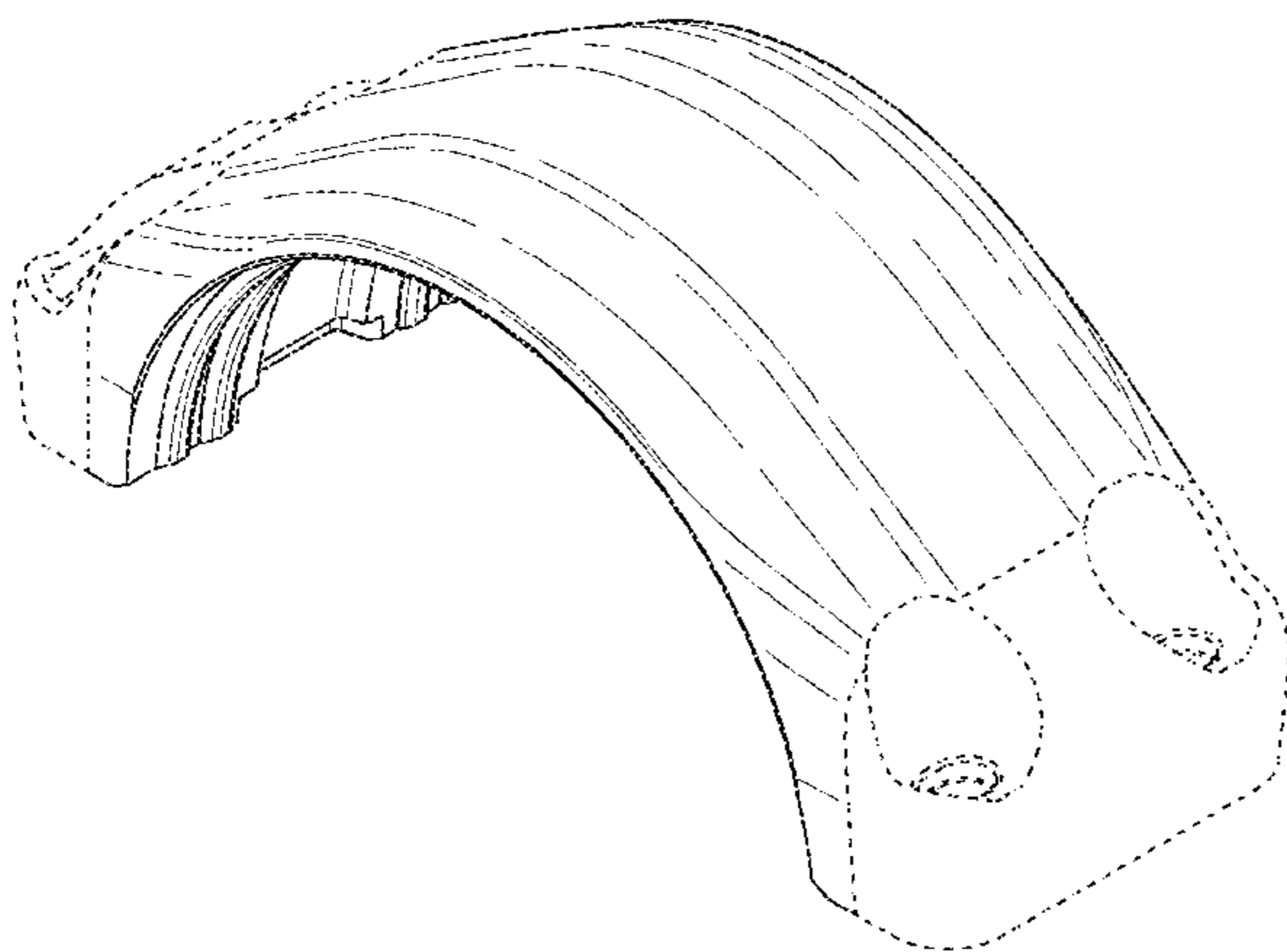
FIG. 4 is a left side view of the pipe coupling segment shown in FIG. 1, the right side view being identical;

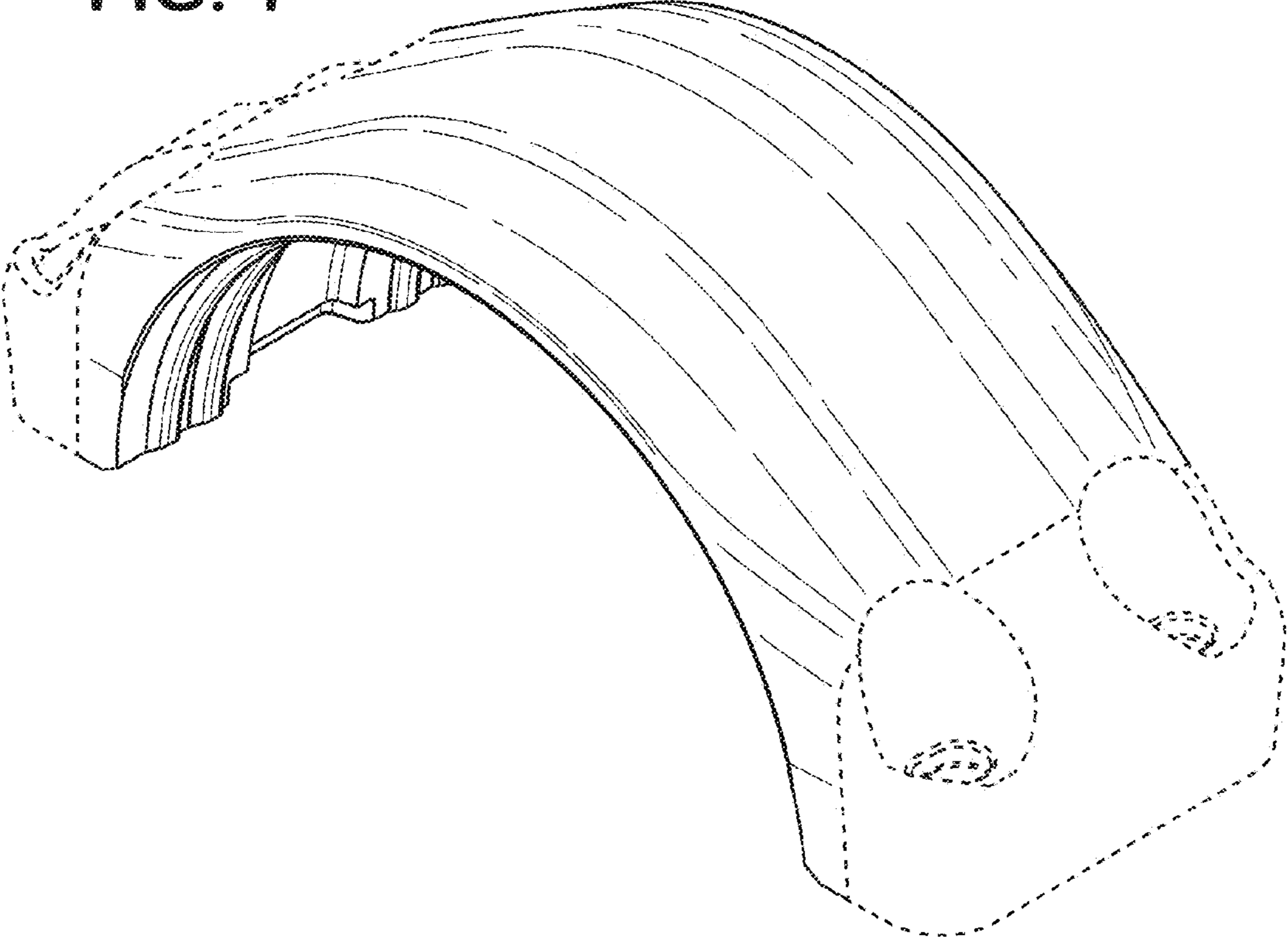

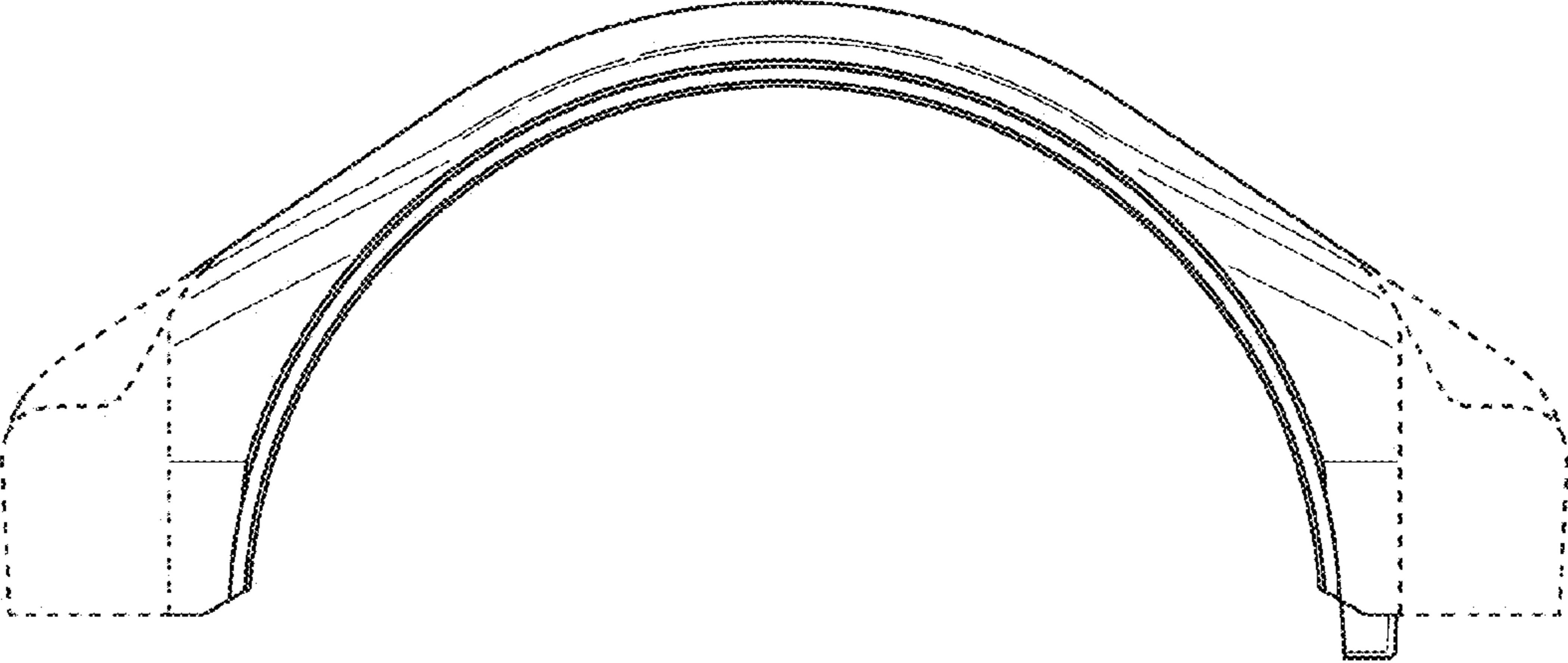

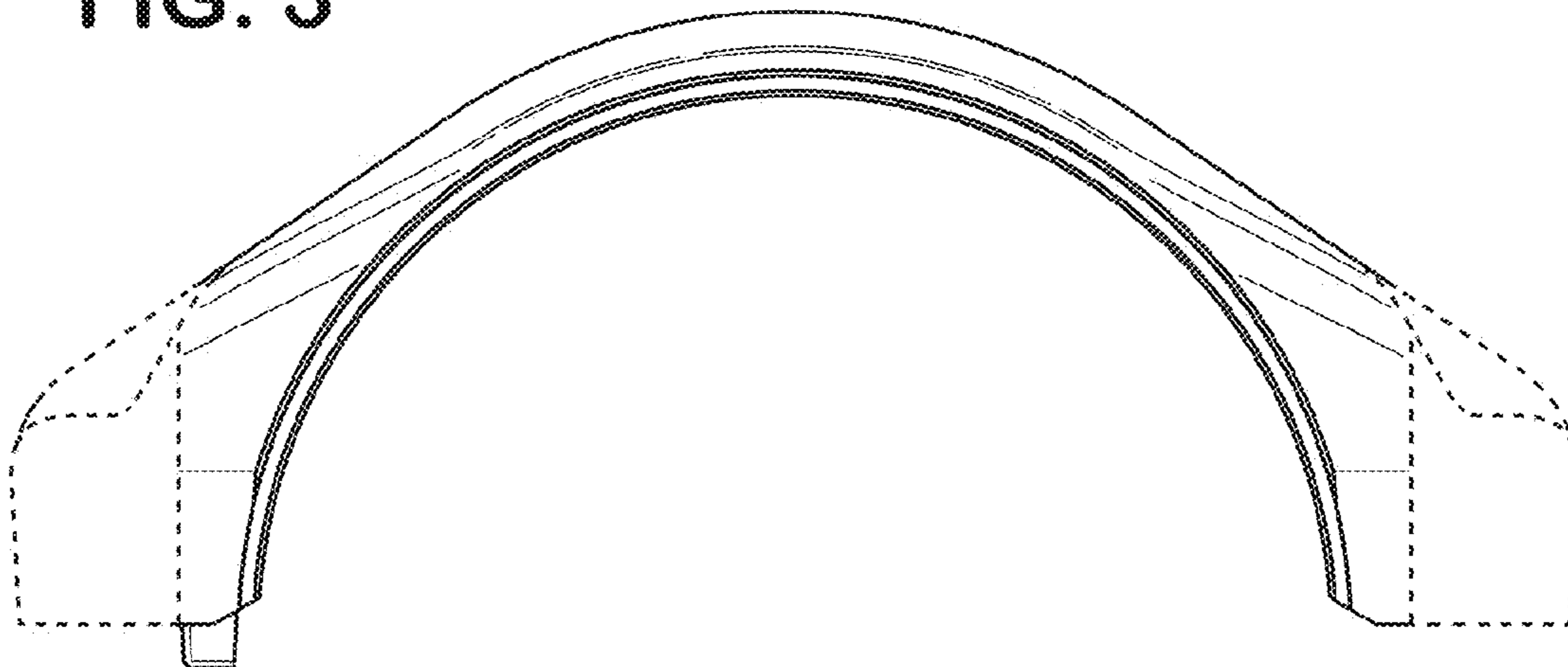

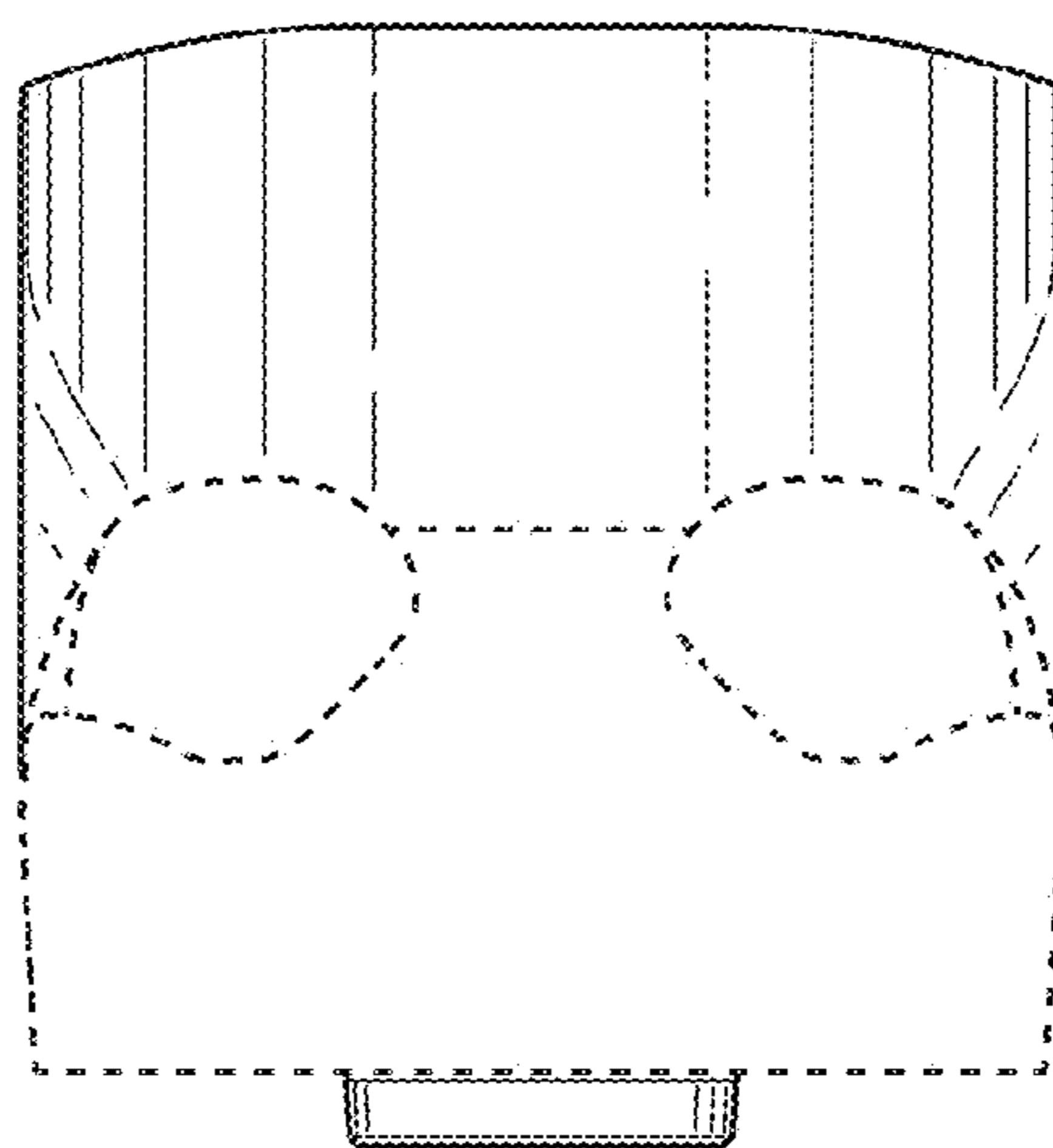

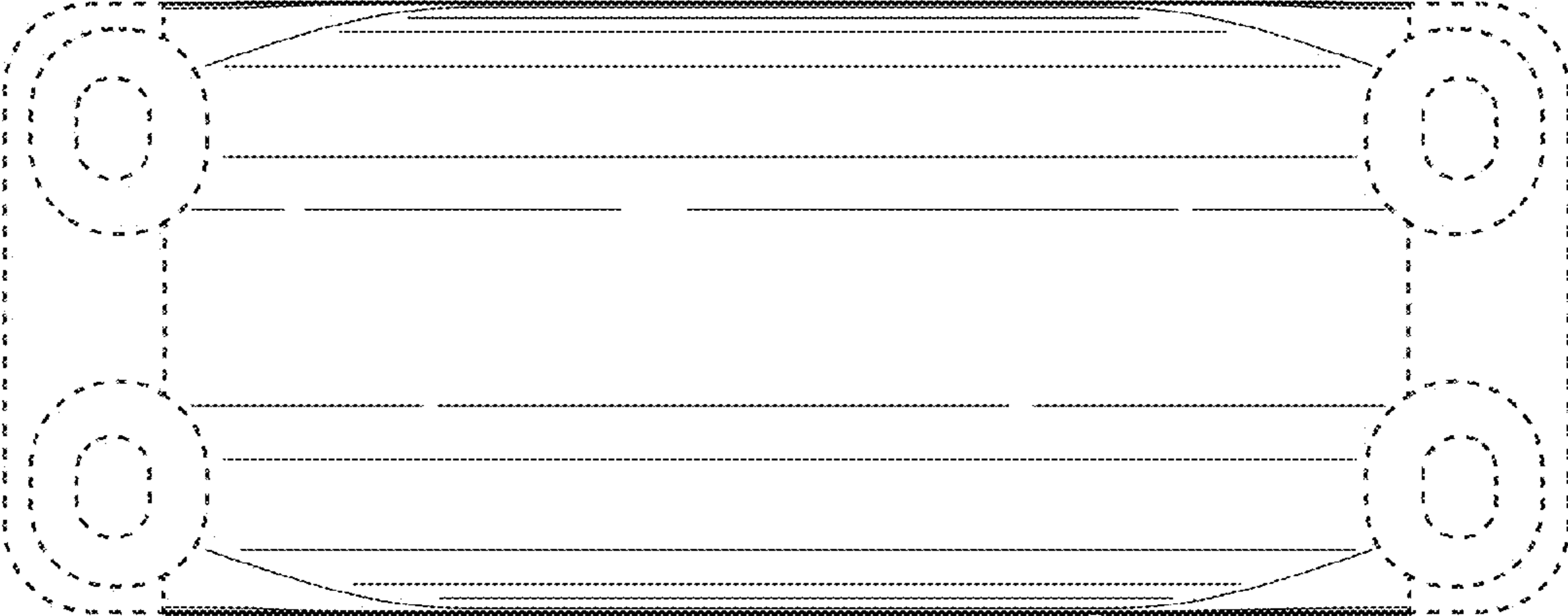
