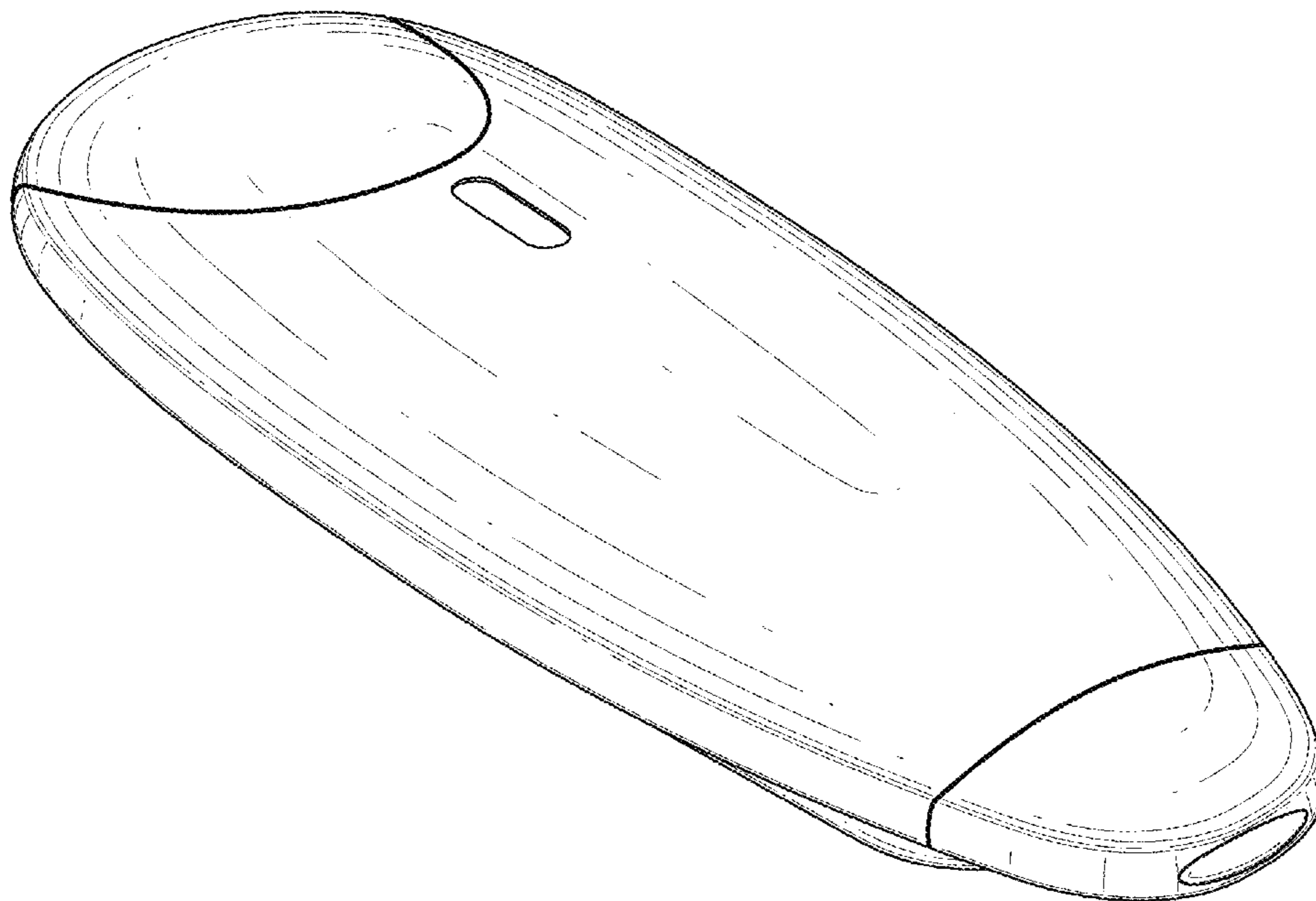
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top rear perspective view of the vaporizer;

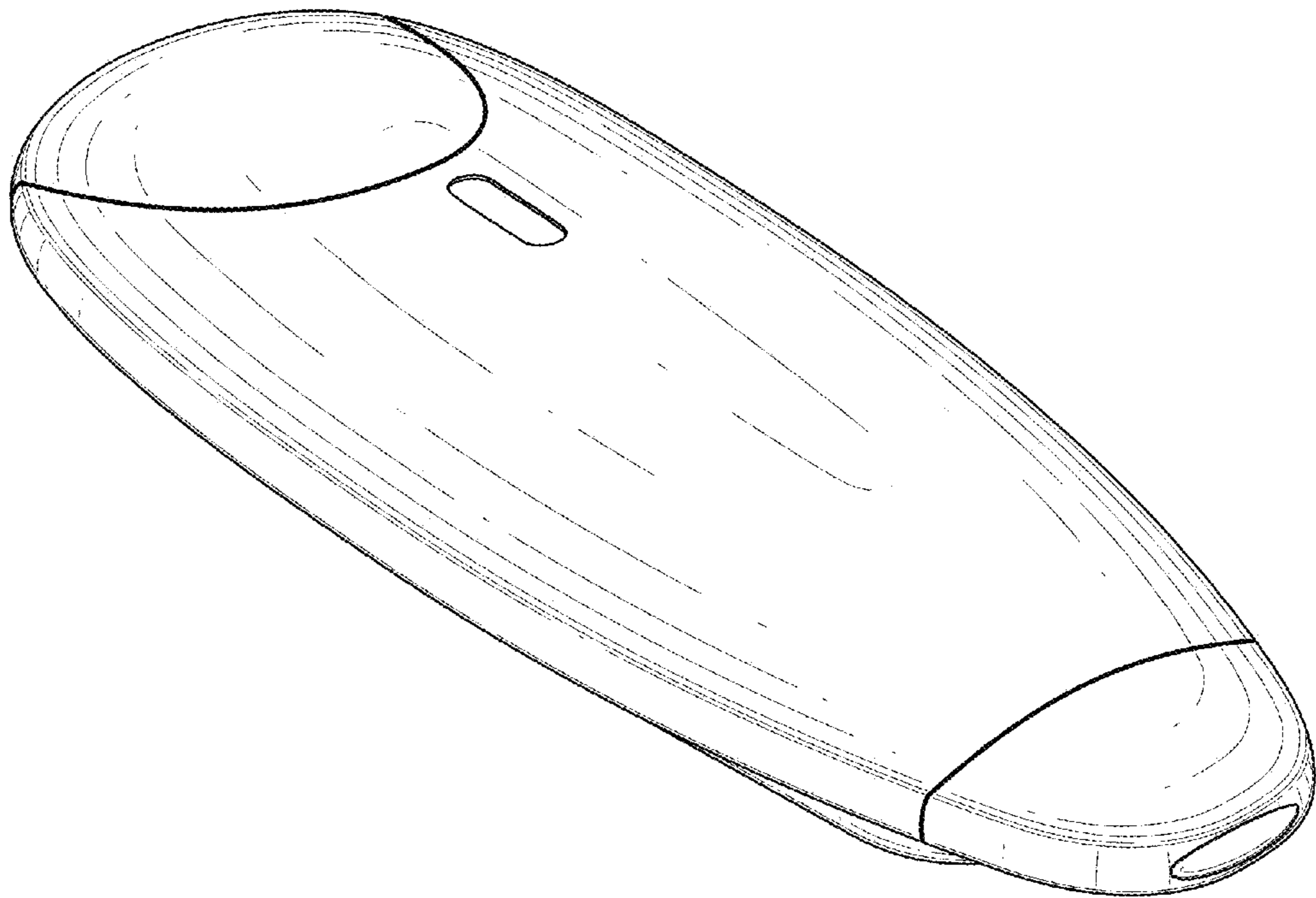

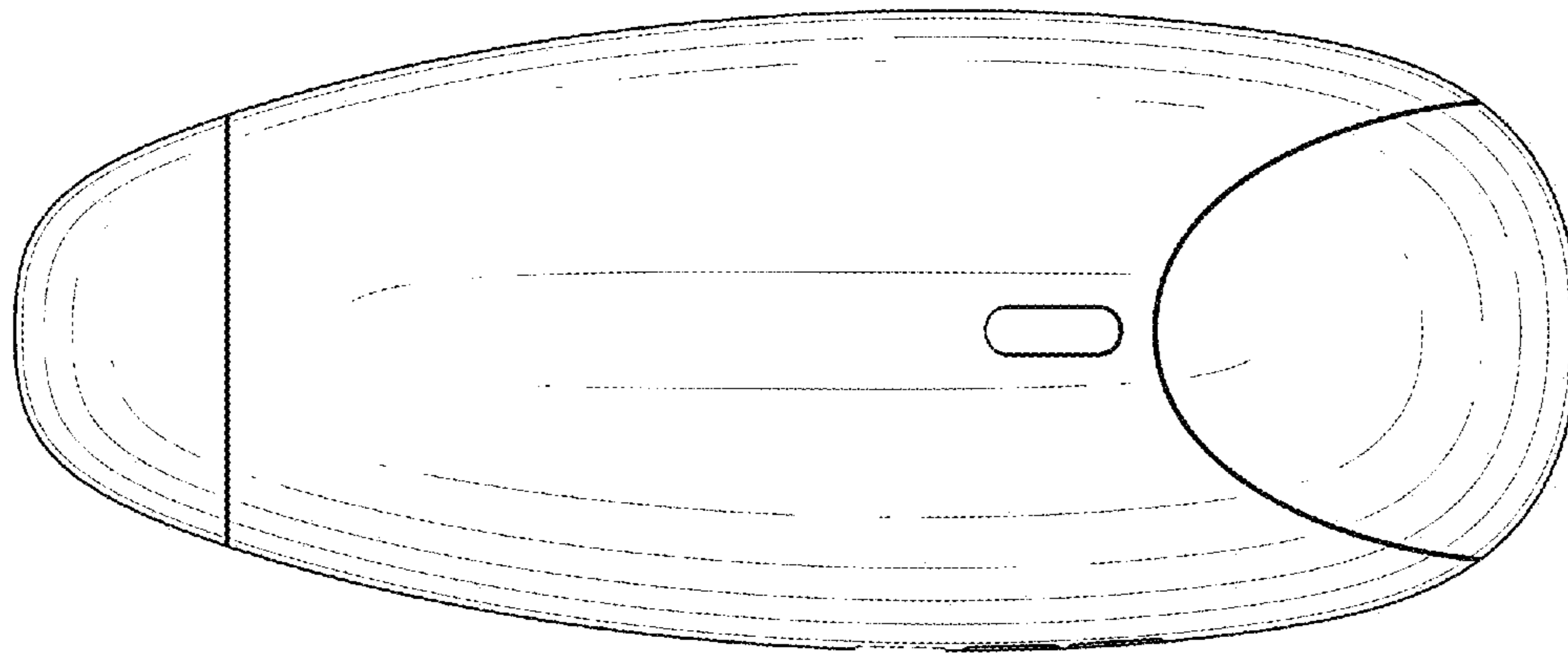

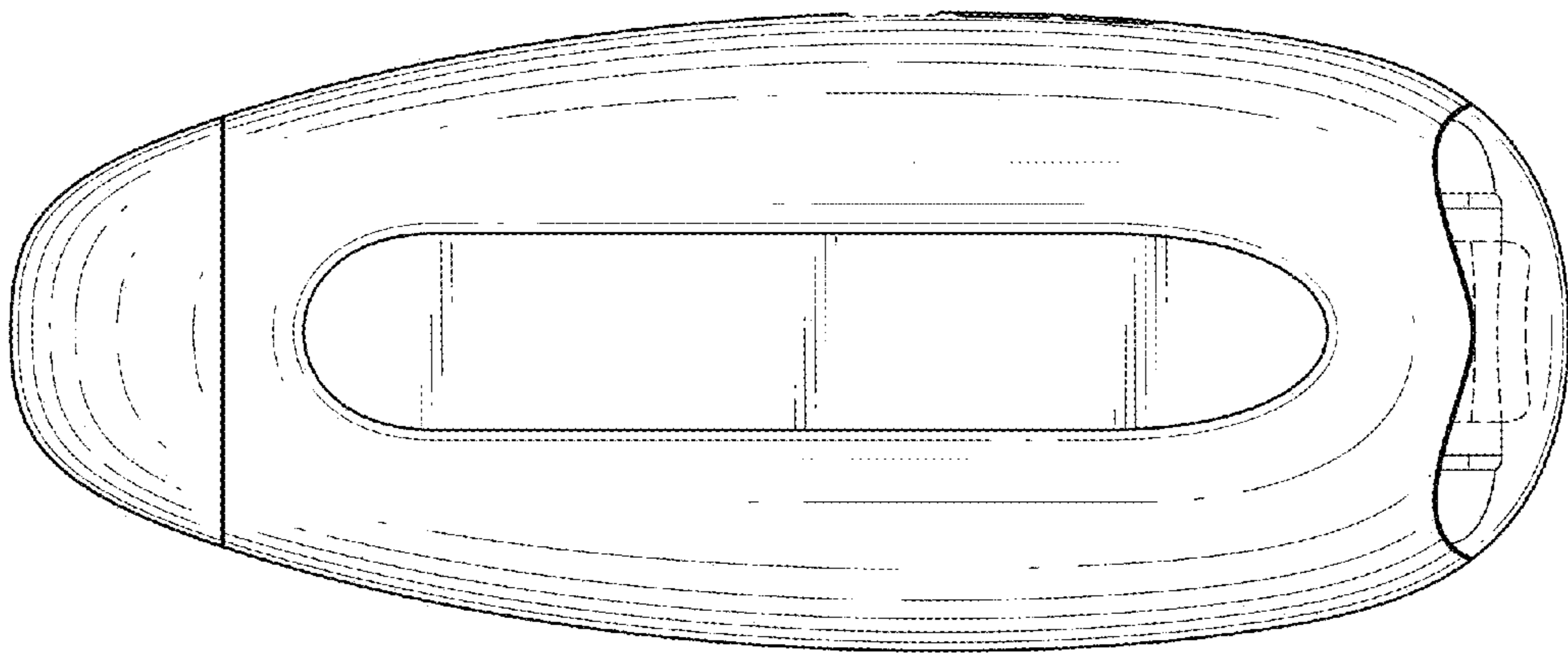

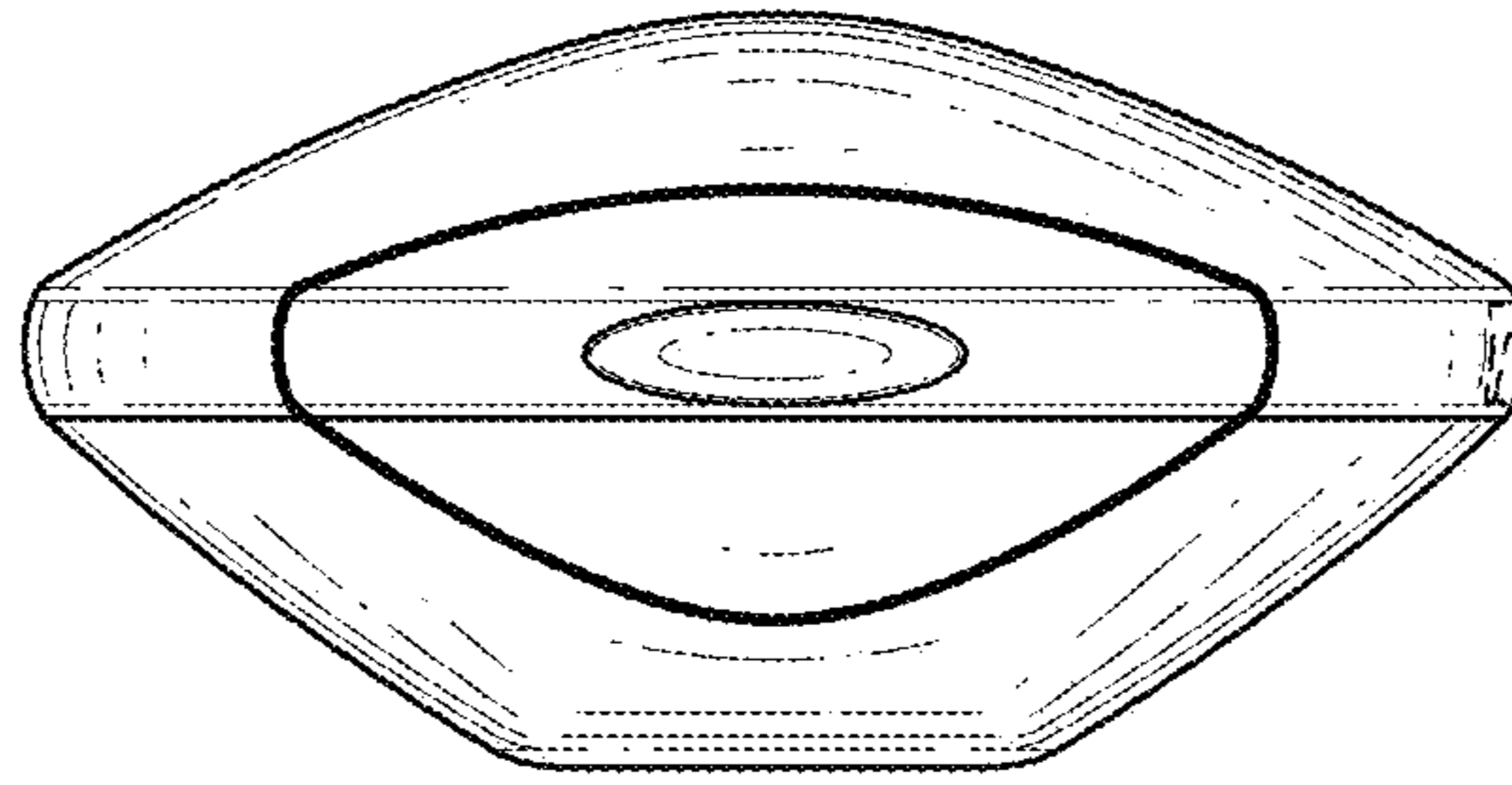

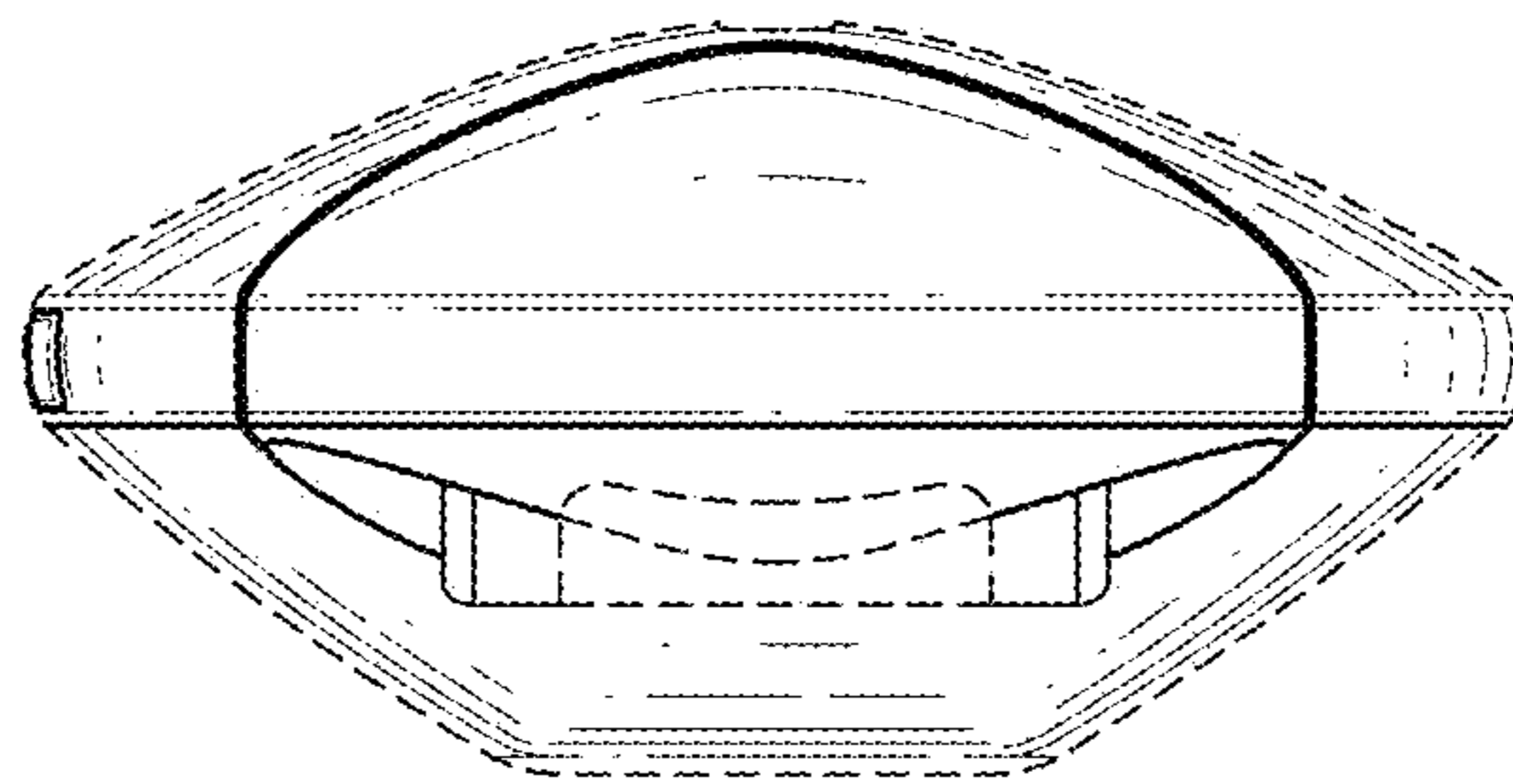

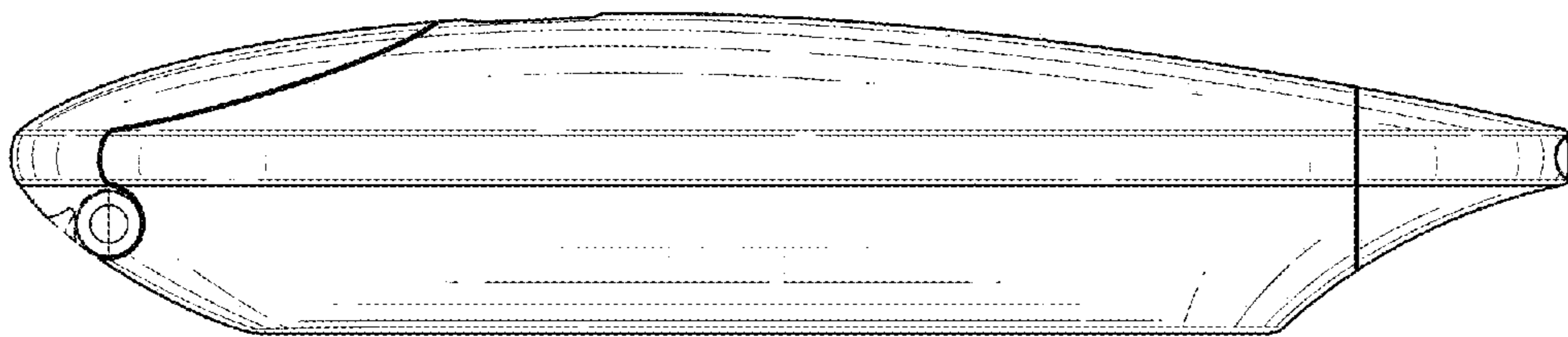

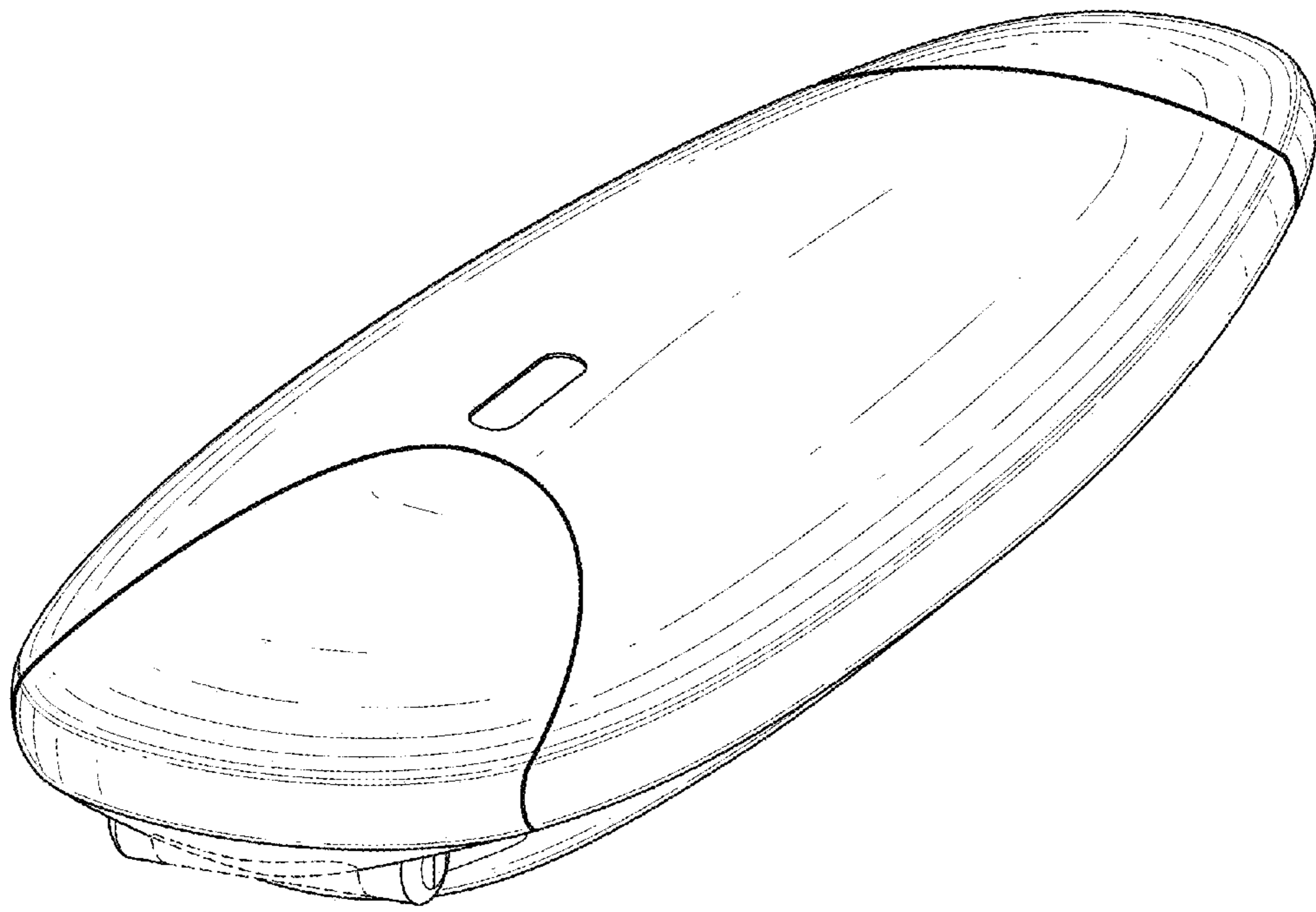

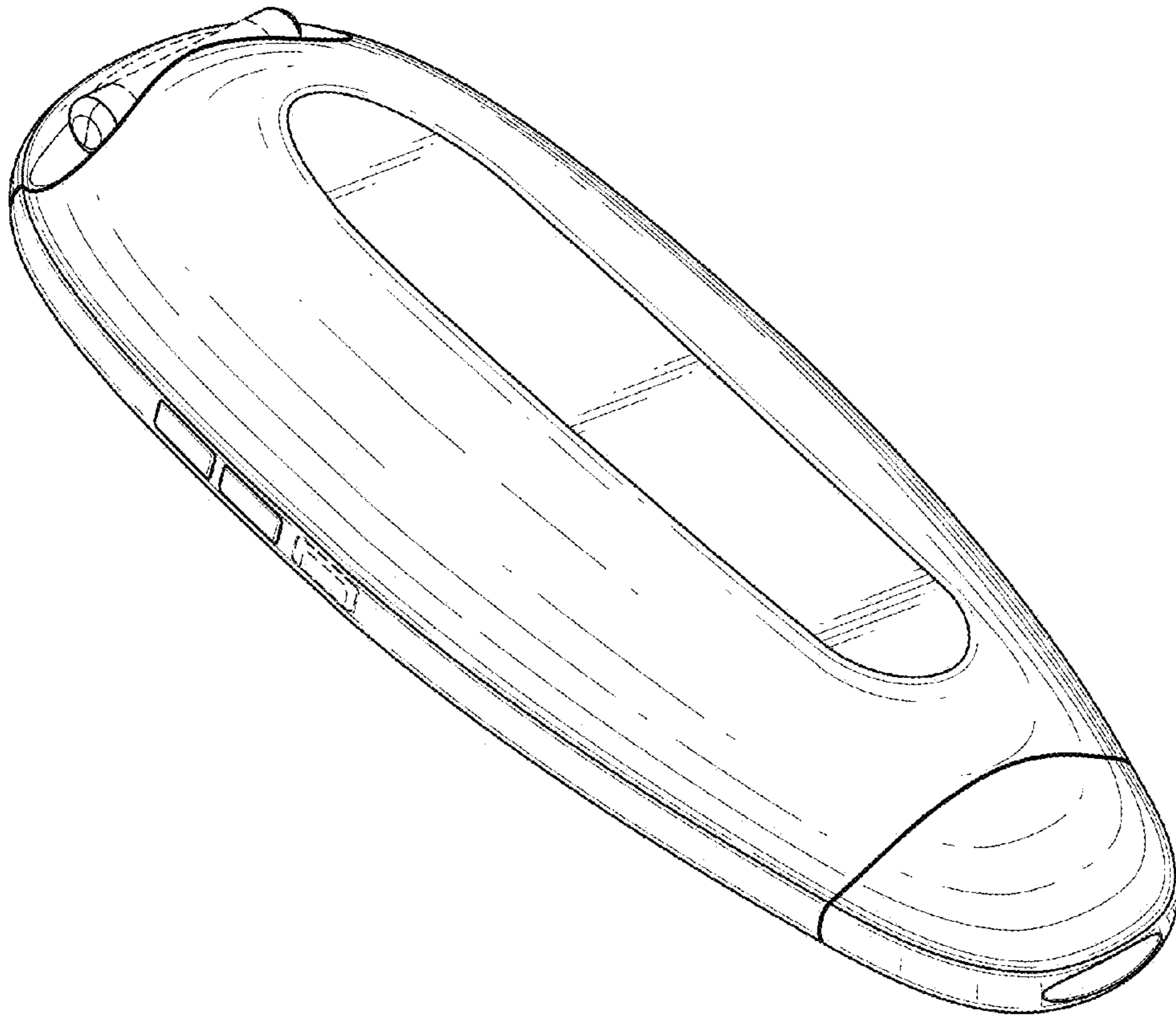

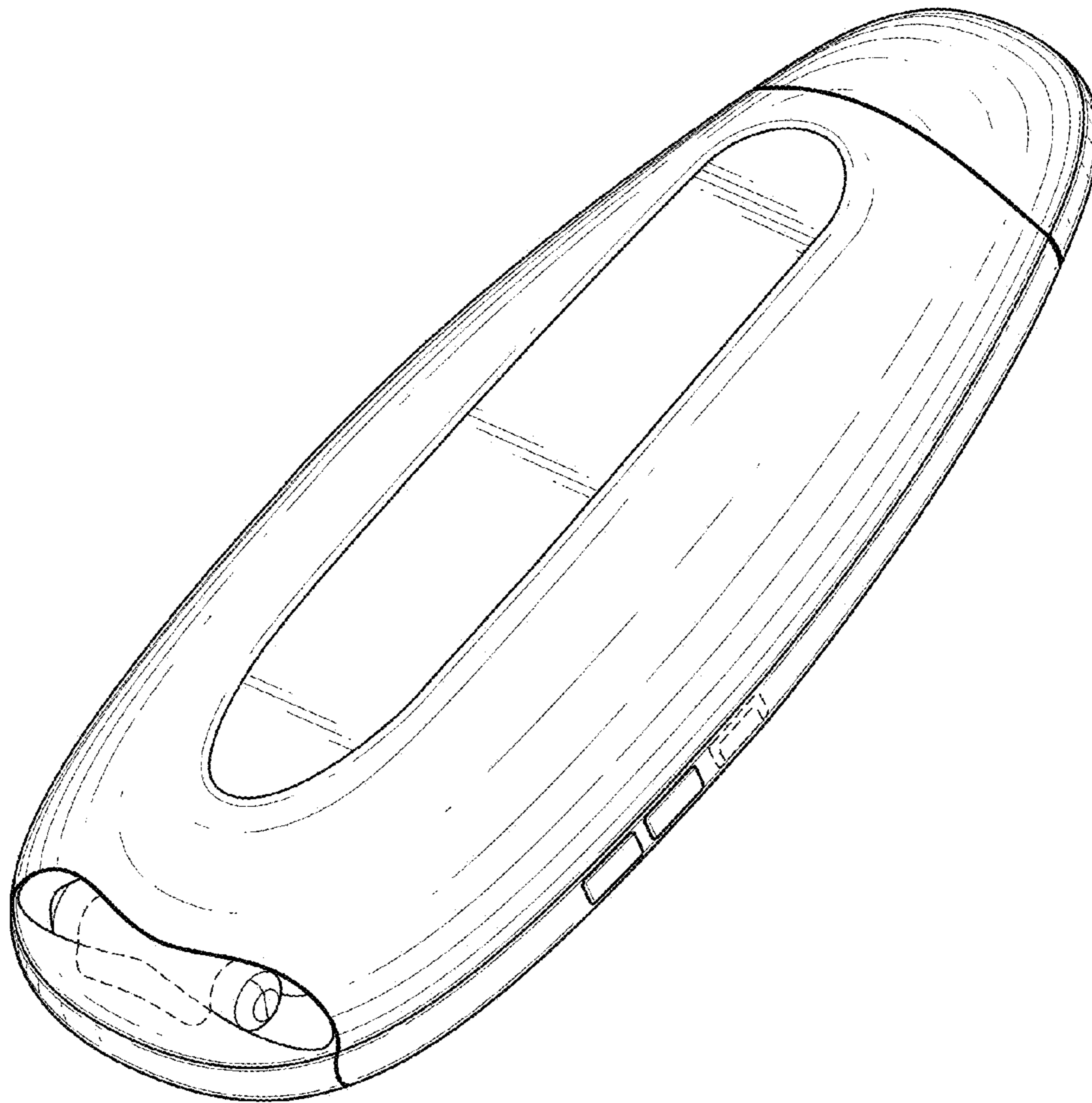
