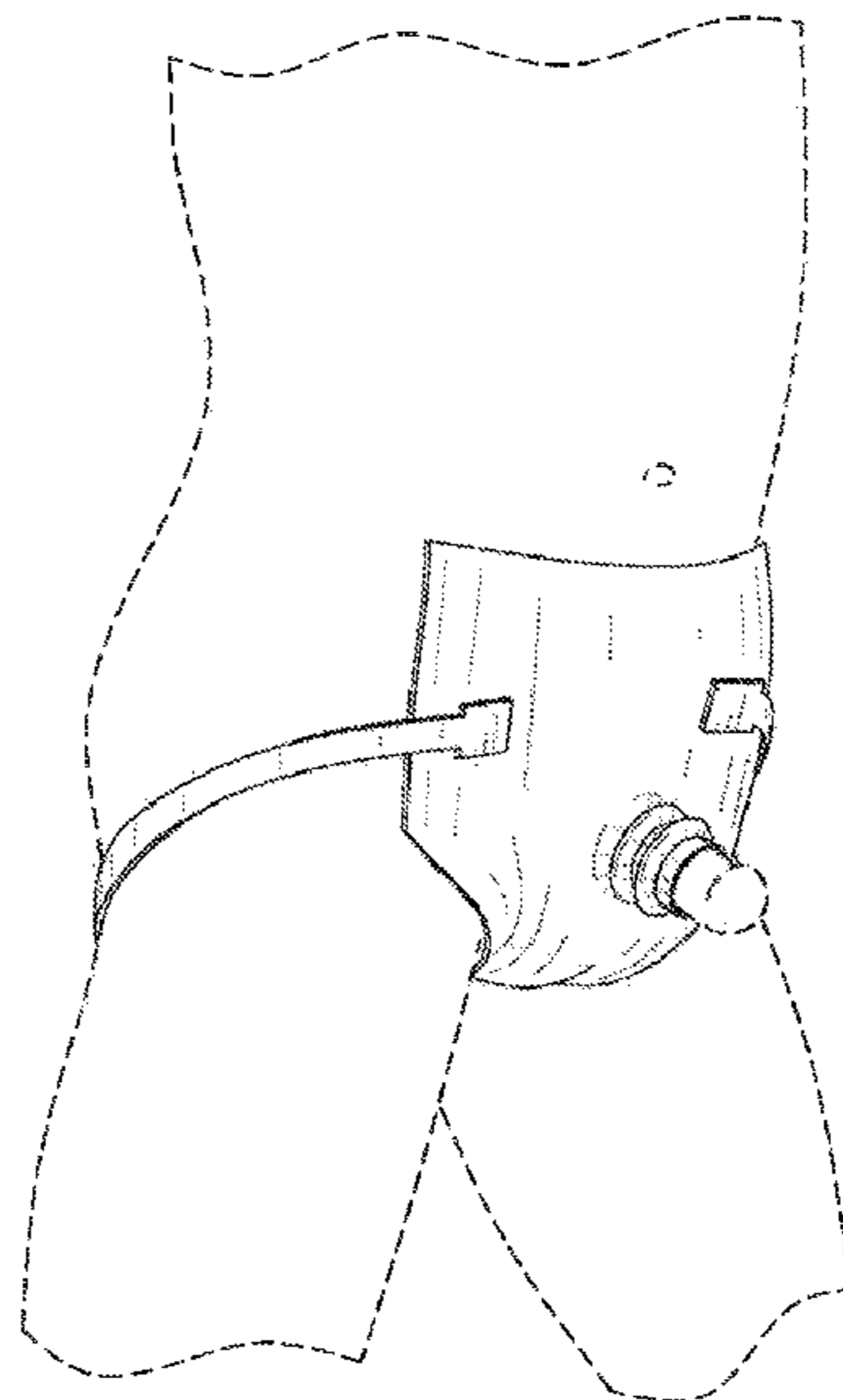
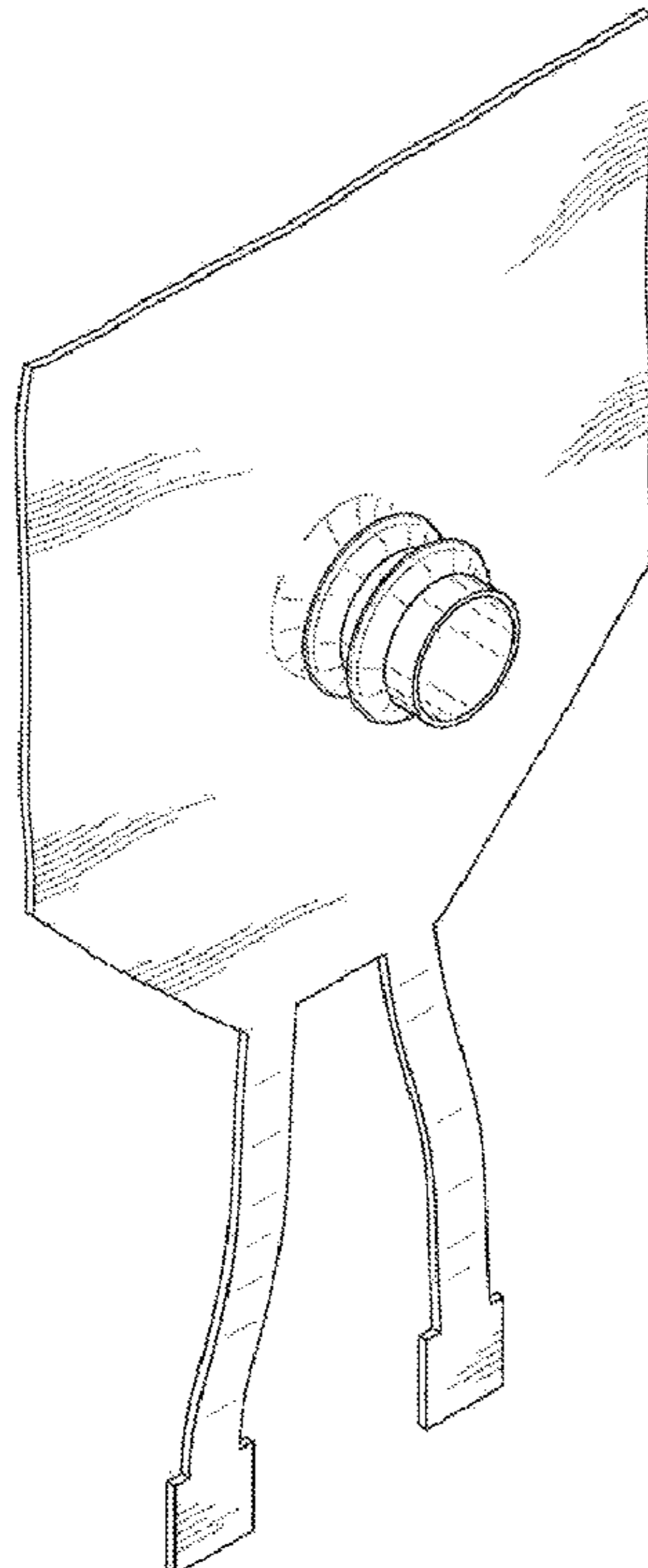
The ornamental design for a sexually transmitted disease prevention shield, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a sexually transmitted disease prevention shield;

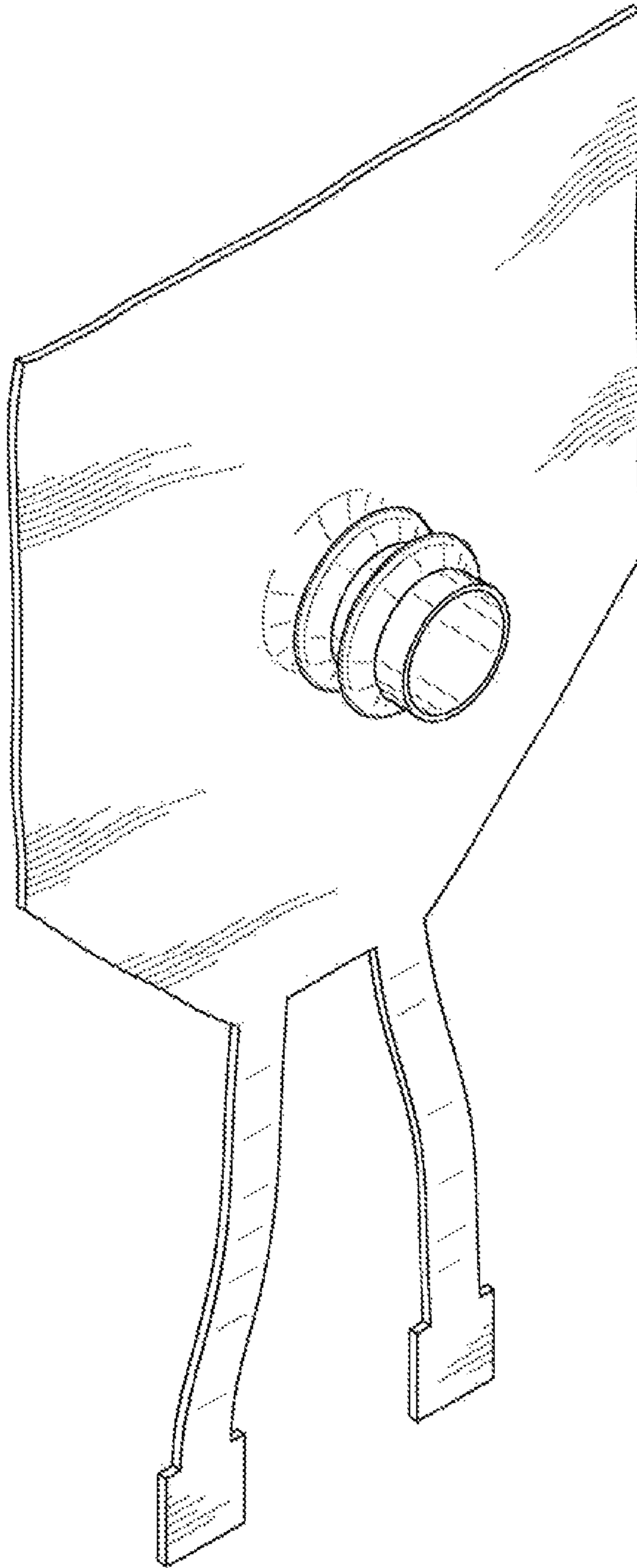

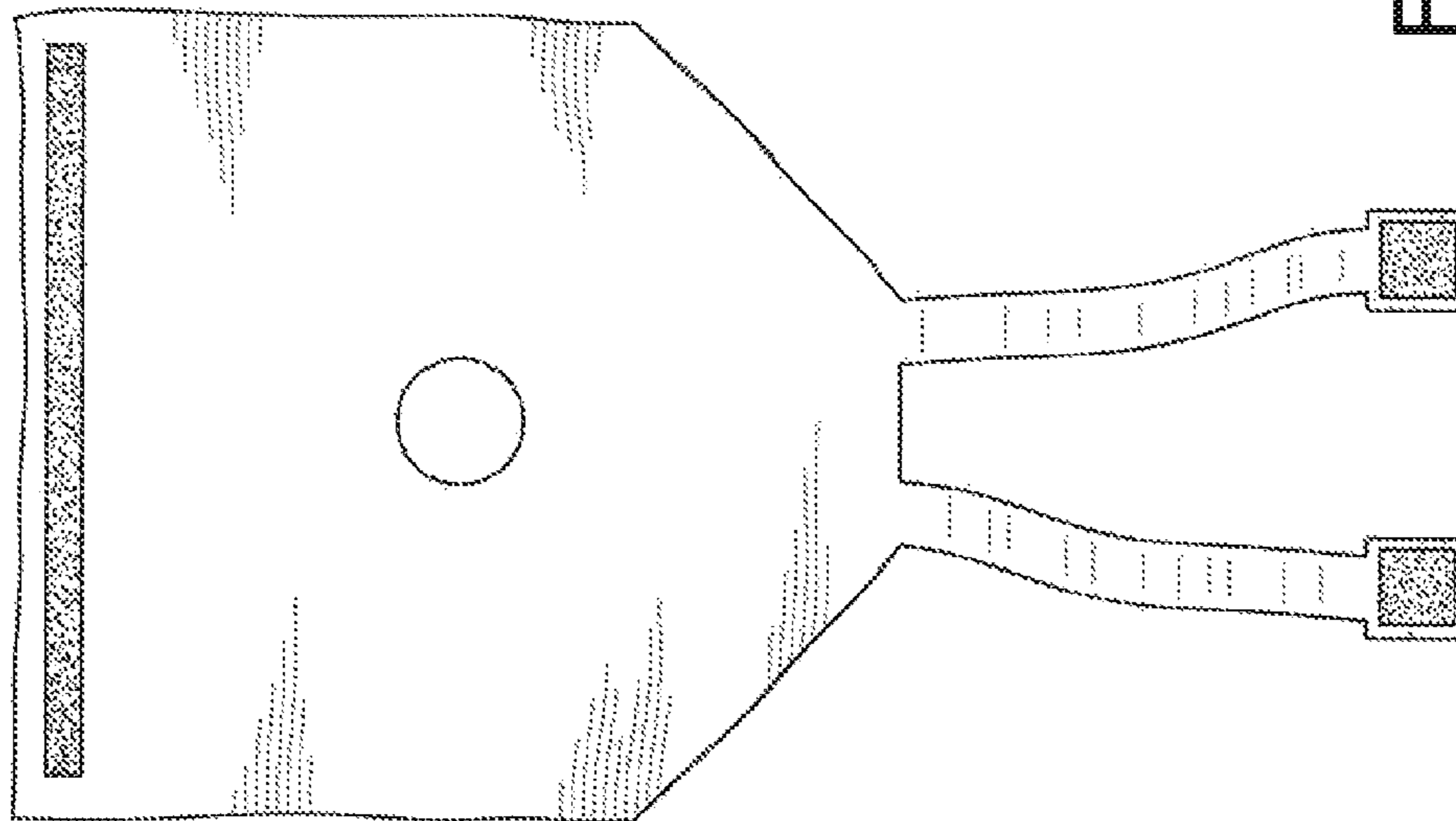

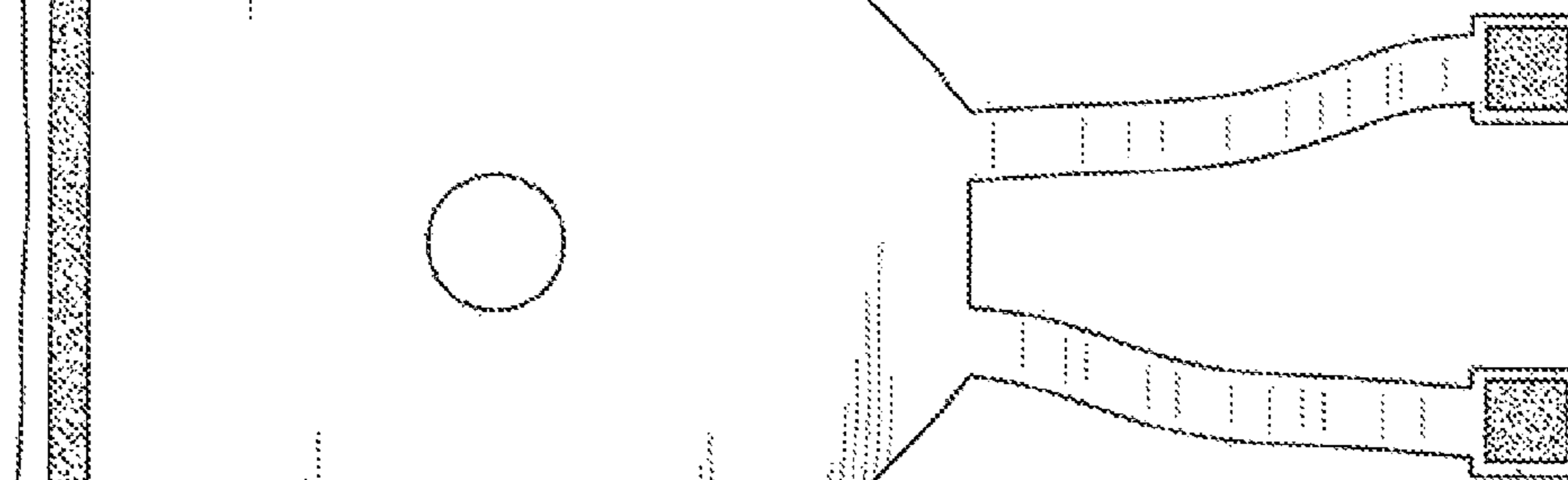

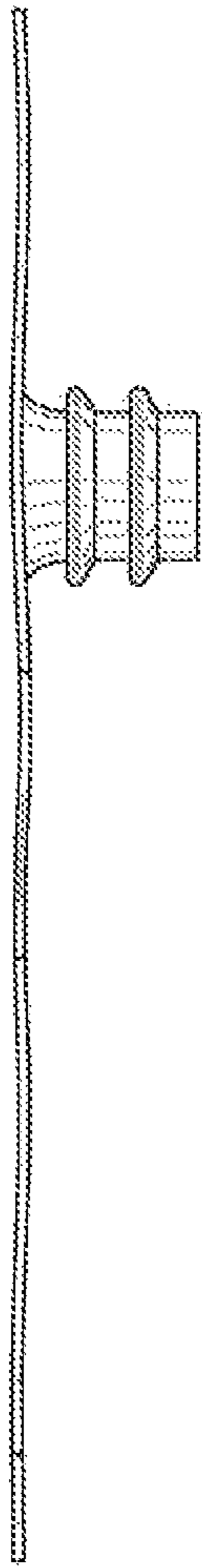

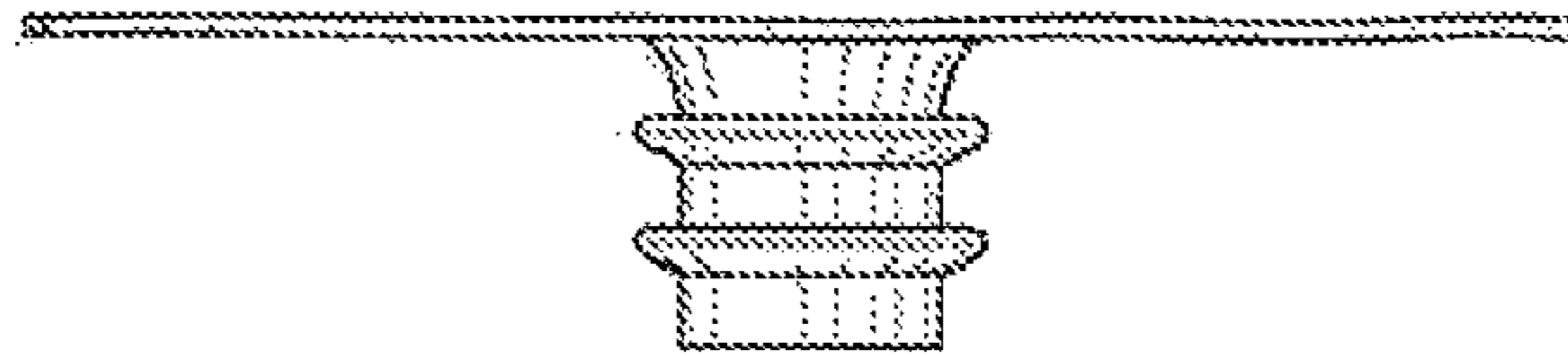

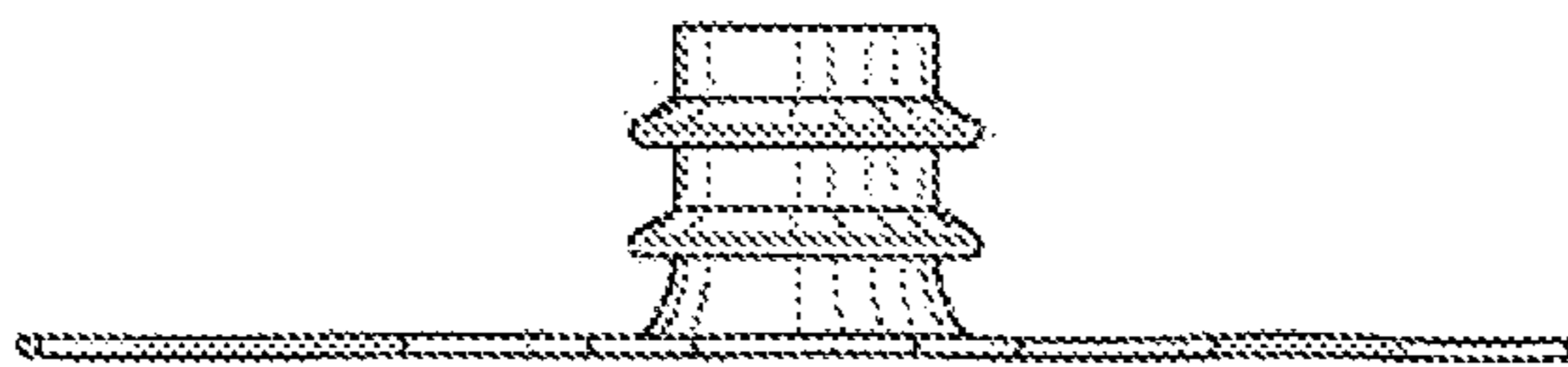

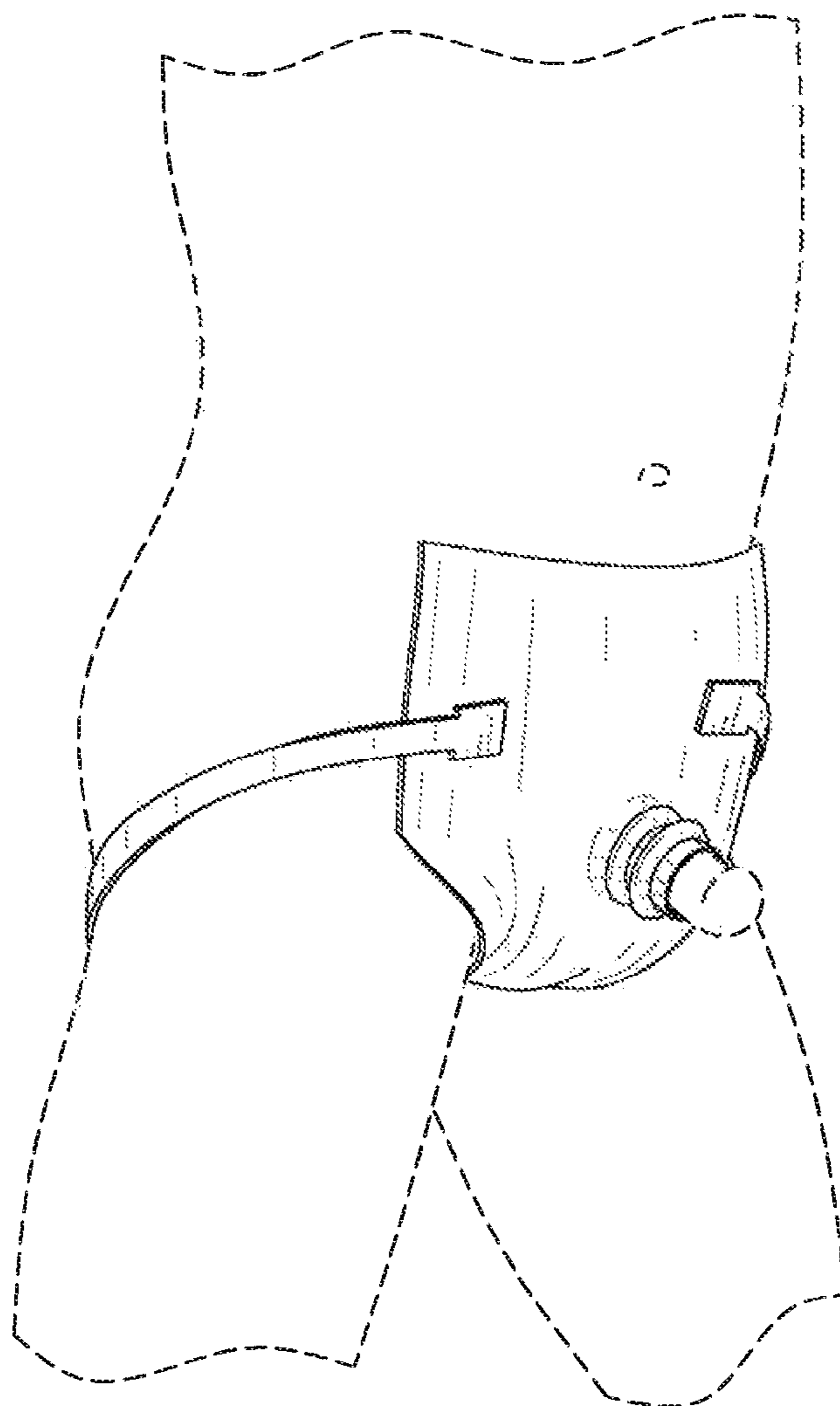
