The ornamental design for a diaper shield, as shown and
described.

DESCRIPTION

FIG. 1 is a first perspective view of a diaper shield of my new
design;

FIG. 2 is a front view thereof;

FIG. 6 is a top view thereof;

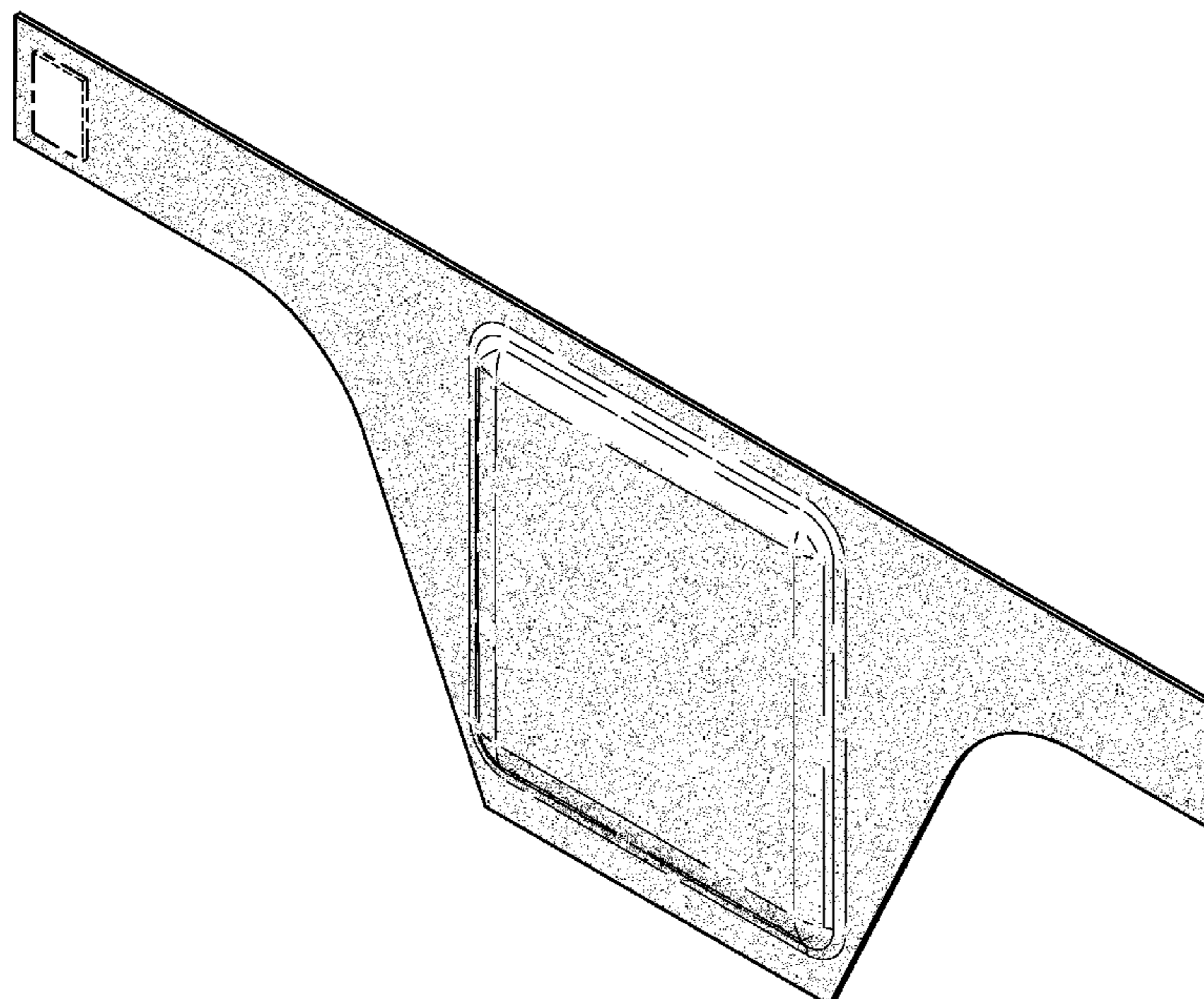
FIG. 7 is a bottom view thereof; and,

included for the purpose of illustrating portions of the diaper

showing of the baby and diaper are included to show envi-
ronment and form no part of the claim design.

The broken lines shown in the center portion of FIGS. 3 and
8 are included for the purpose of illustrating stitching and are
a part of the claimed design.

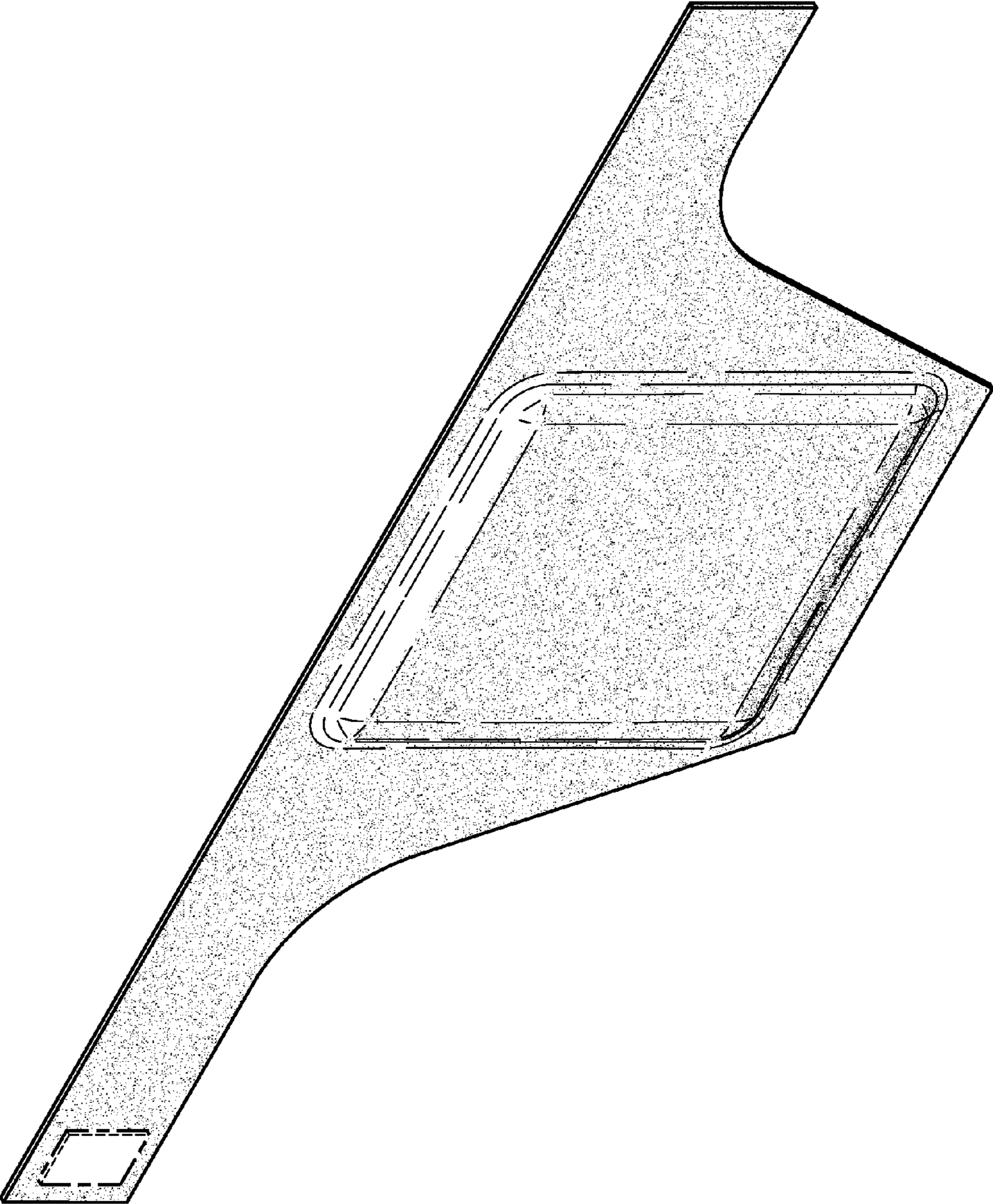

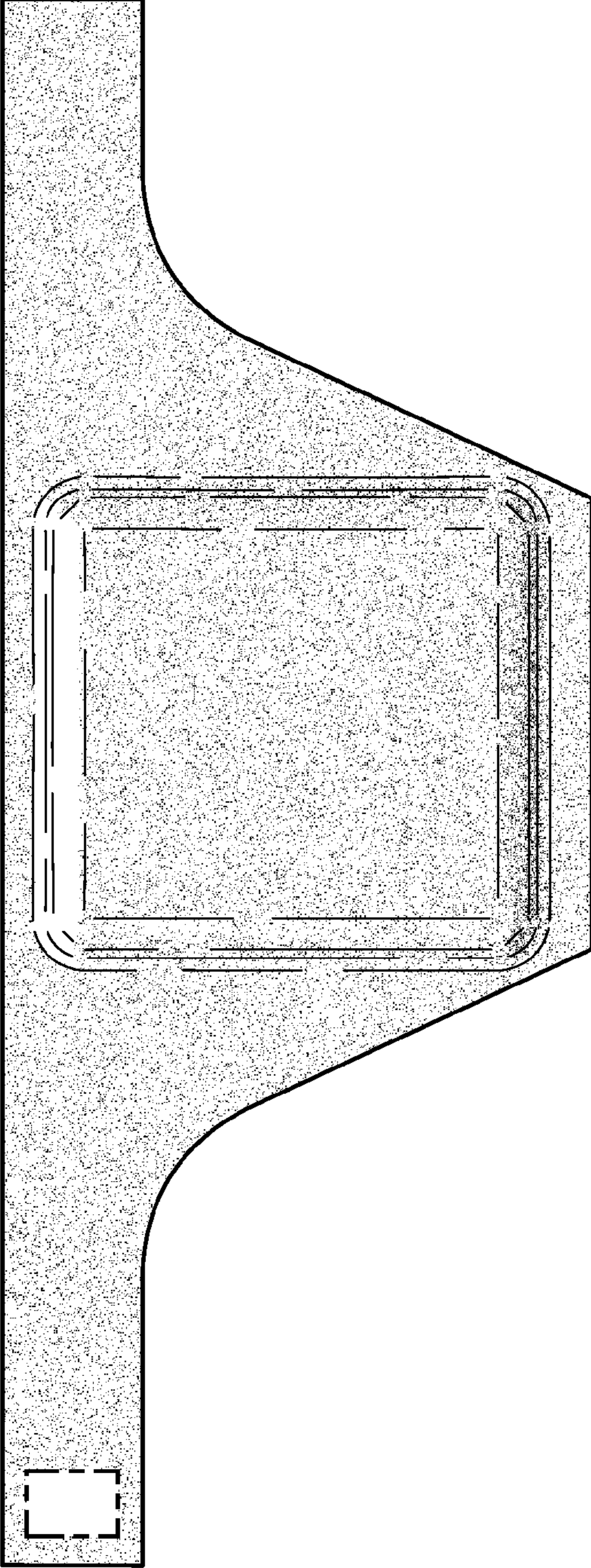

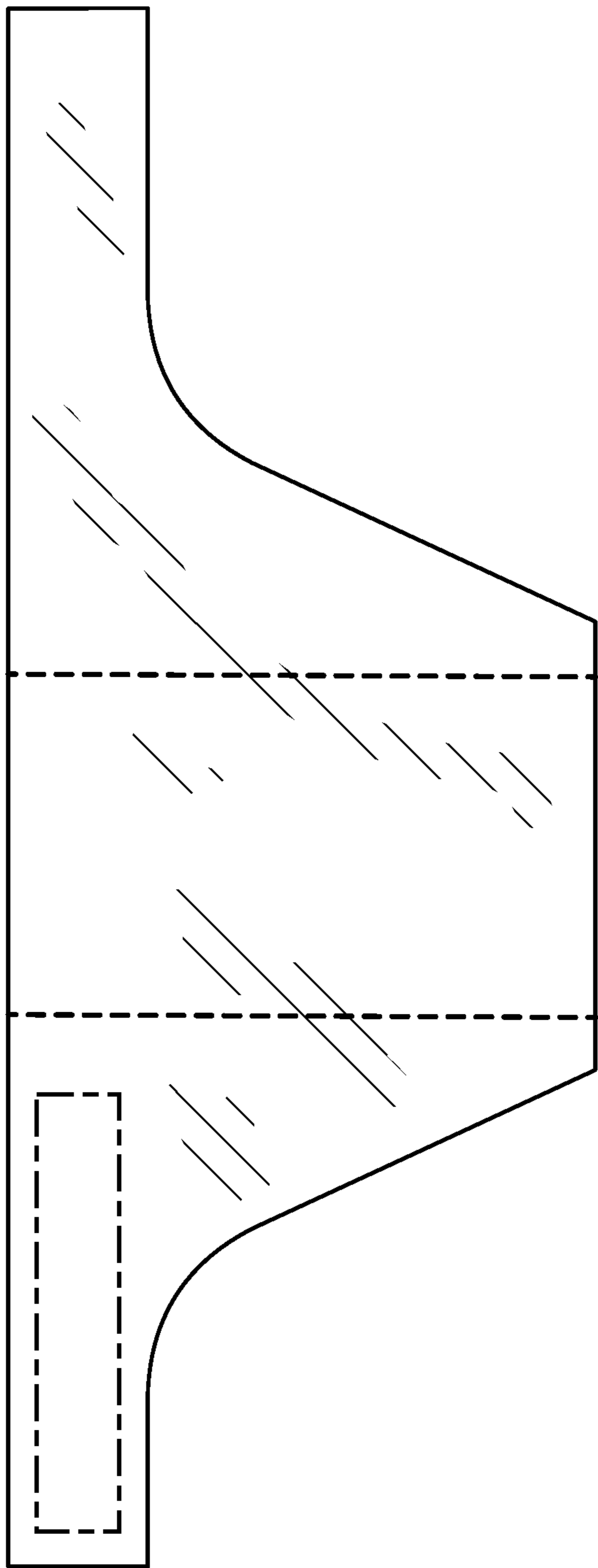

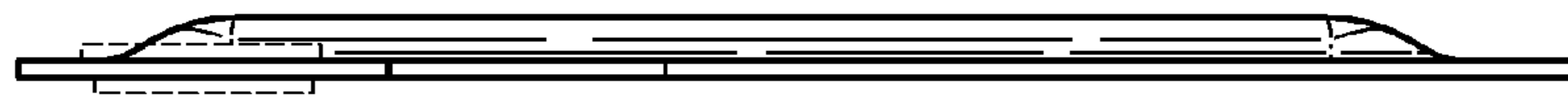

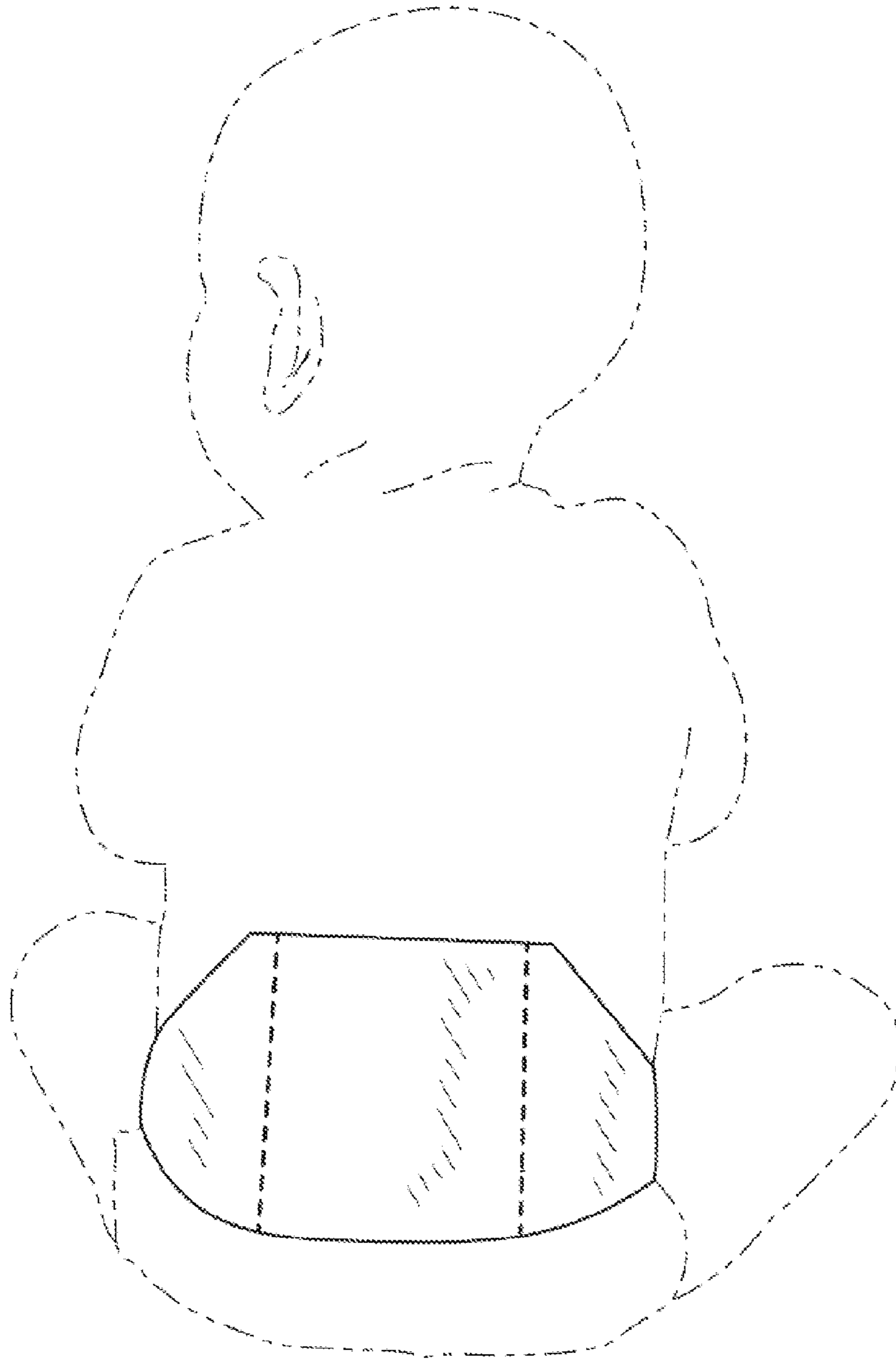
