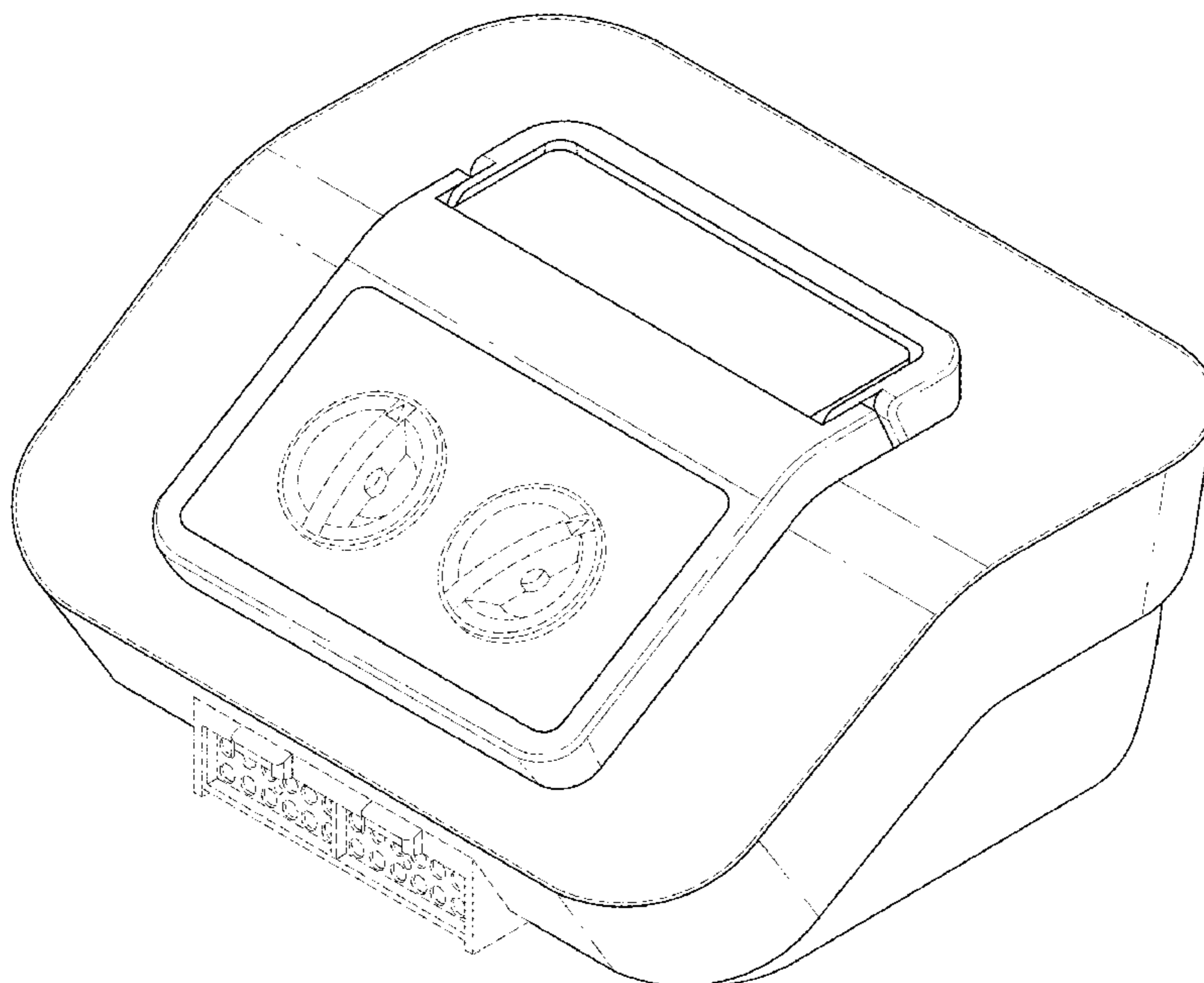
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a device for medical treatment showing the new design;

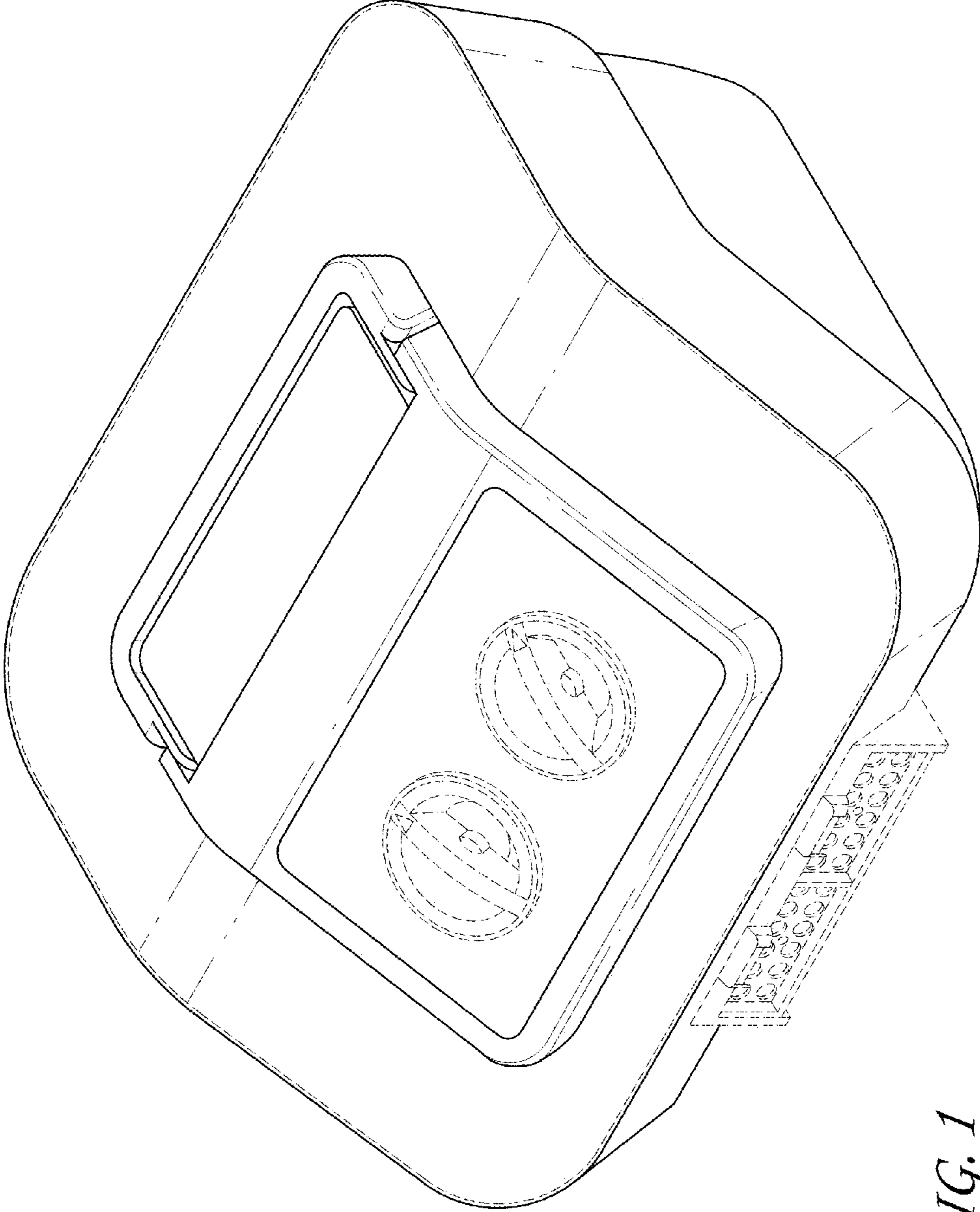

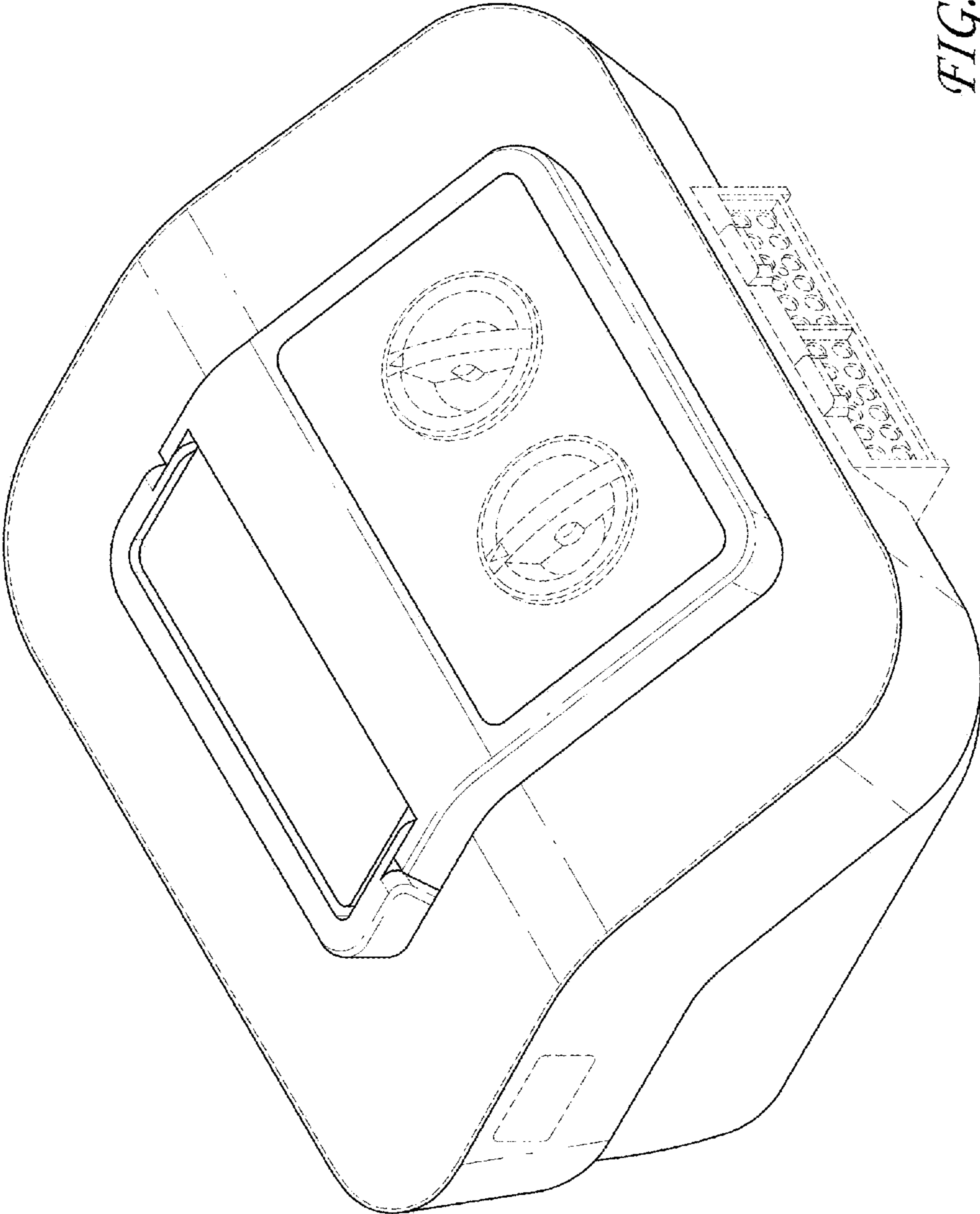

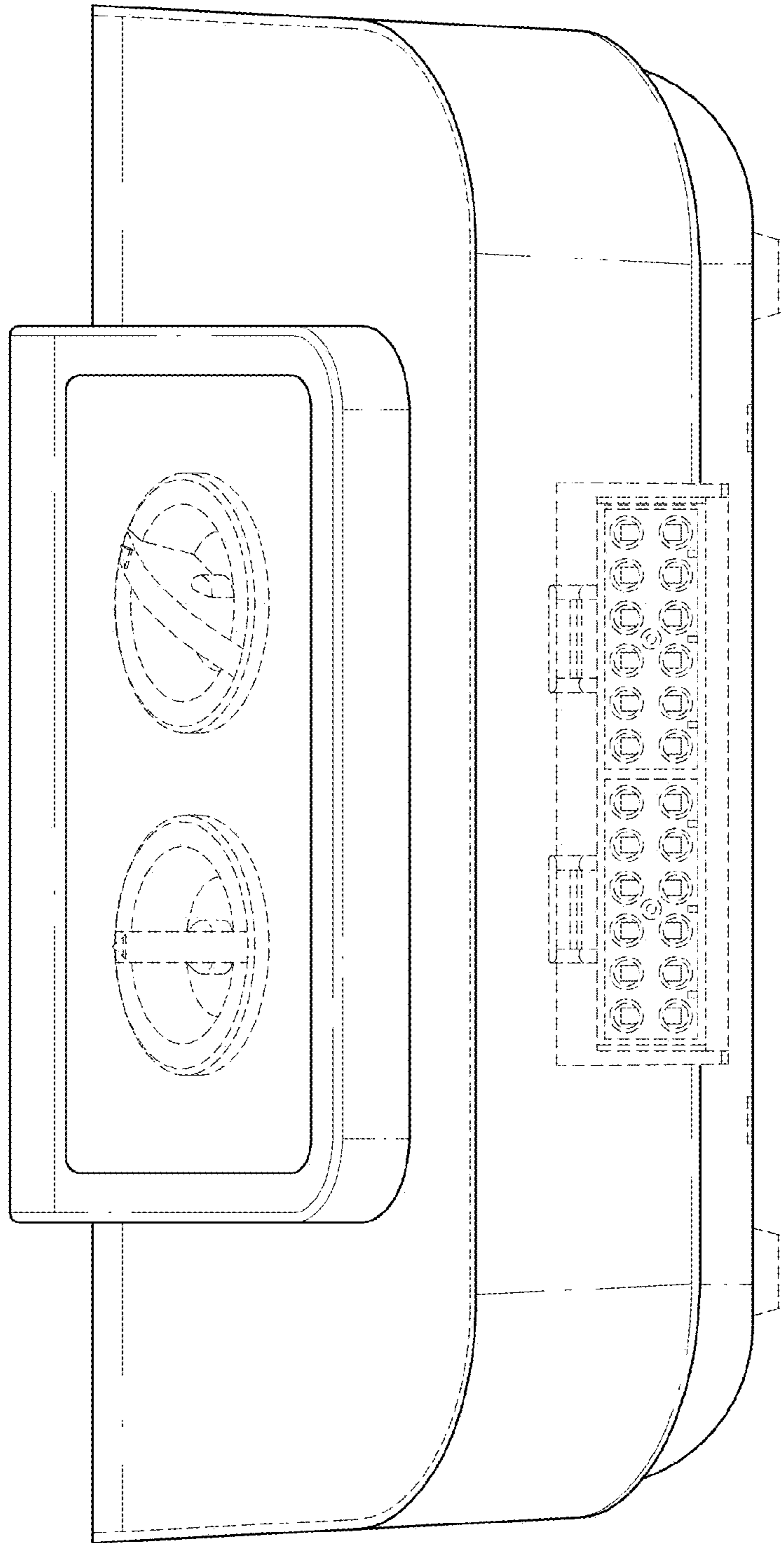

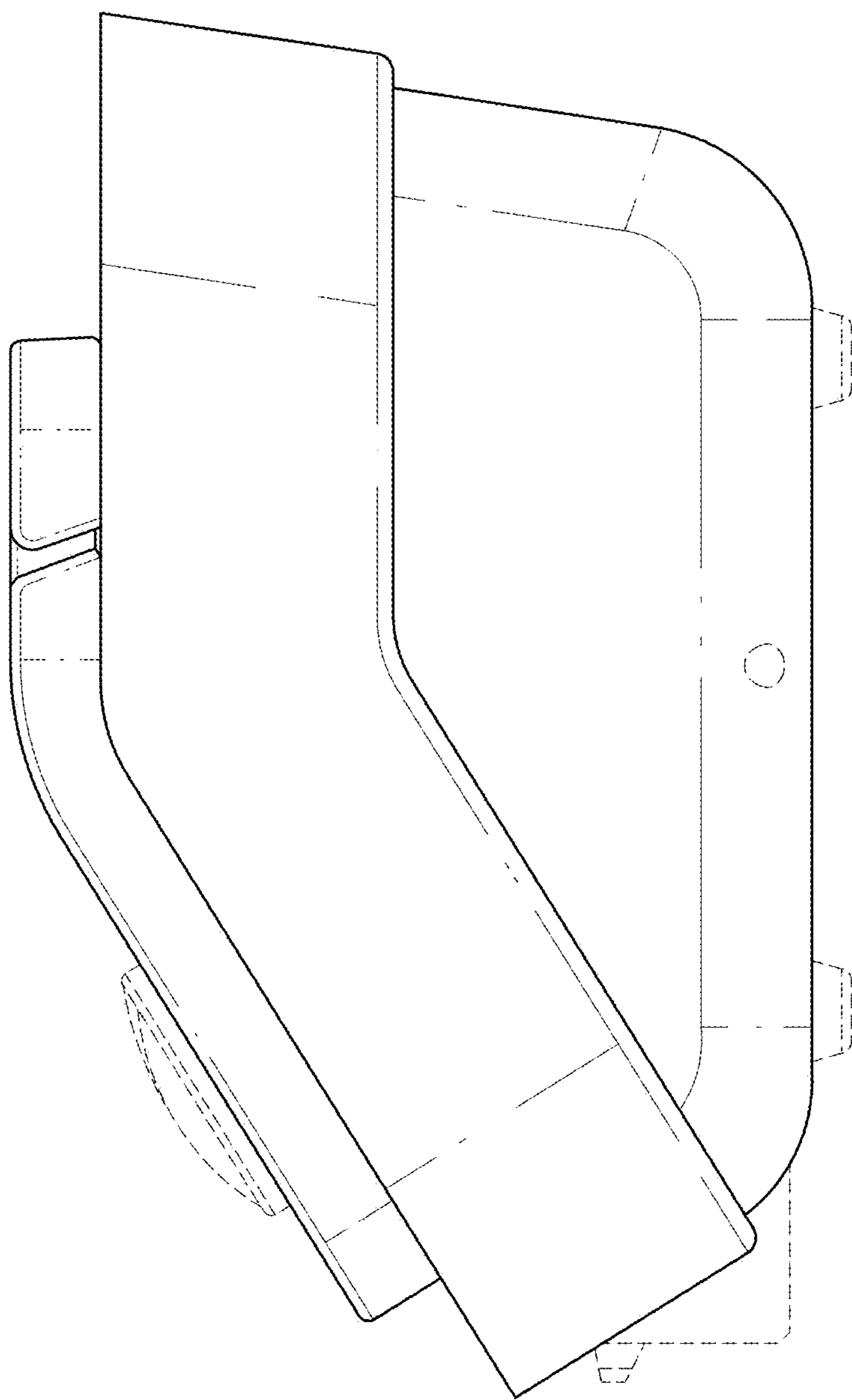

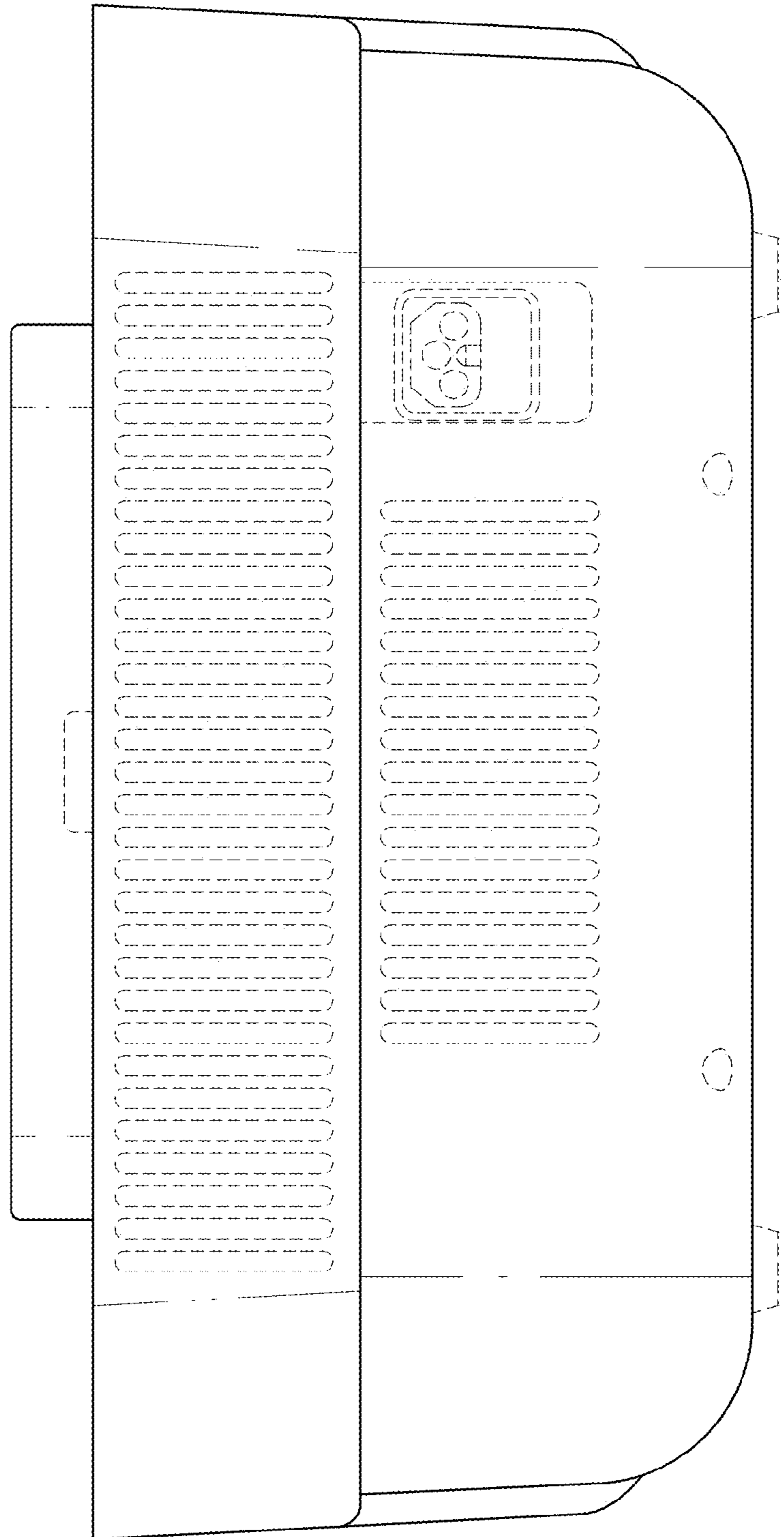

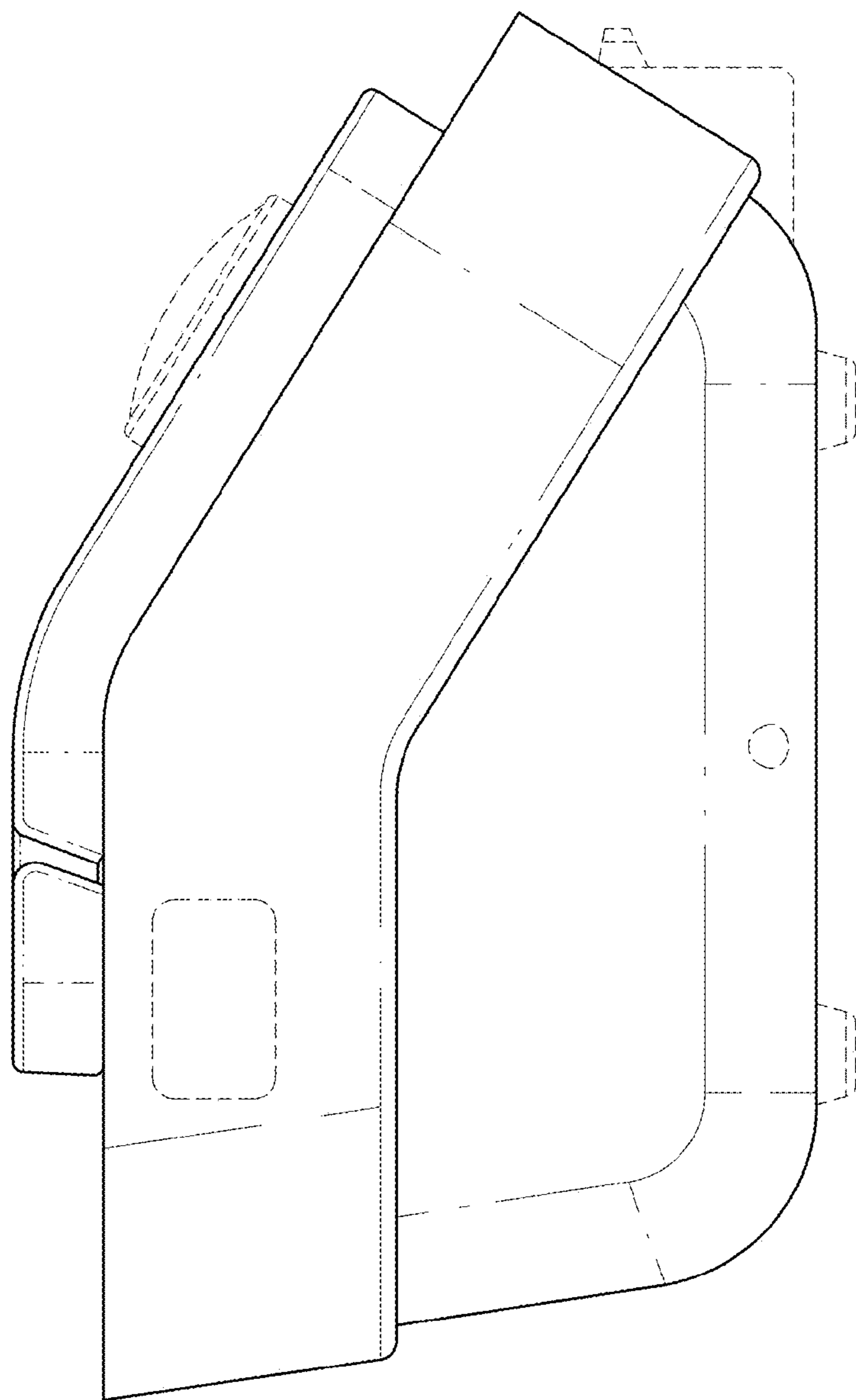

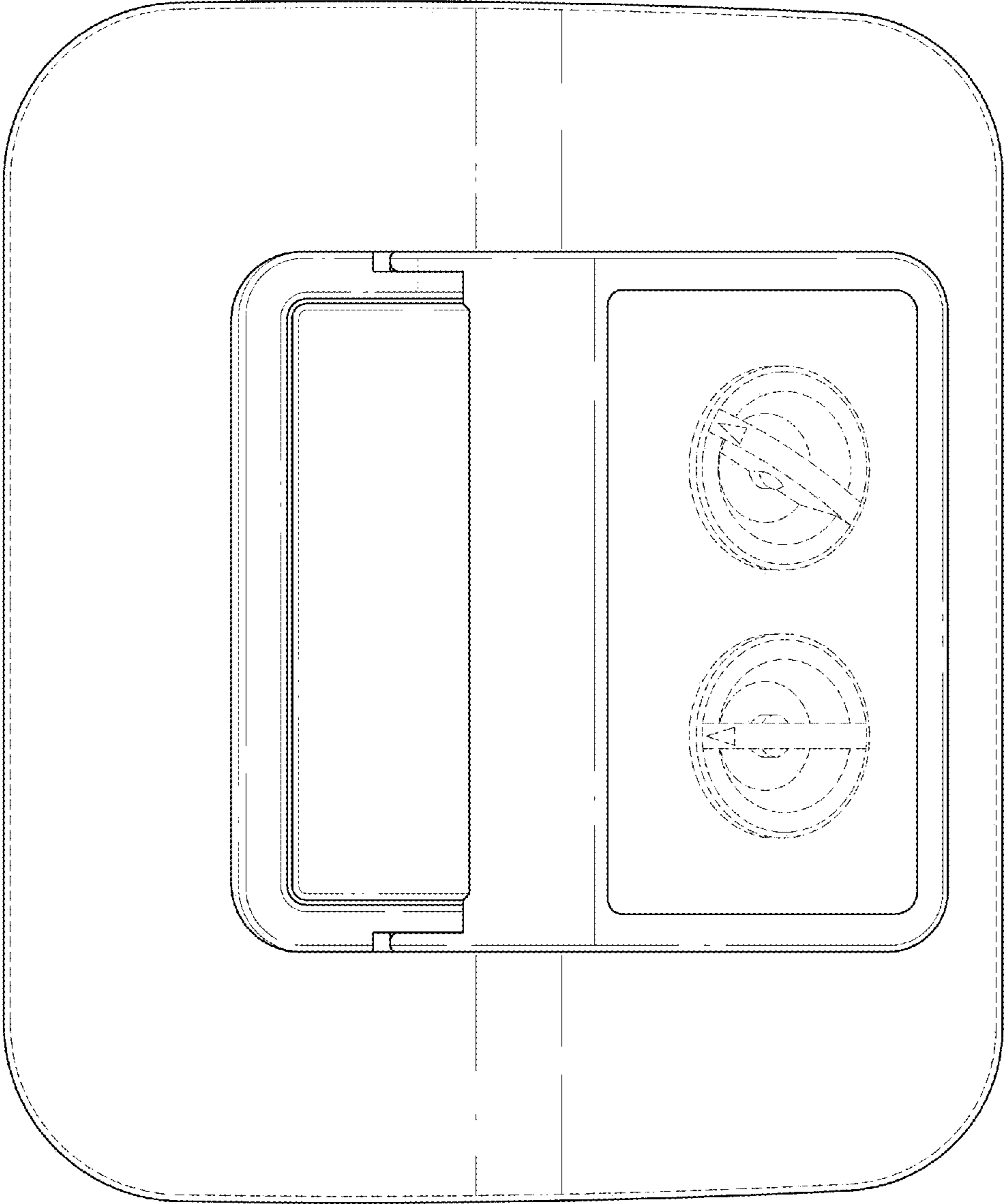

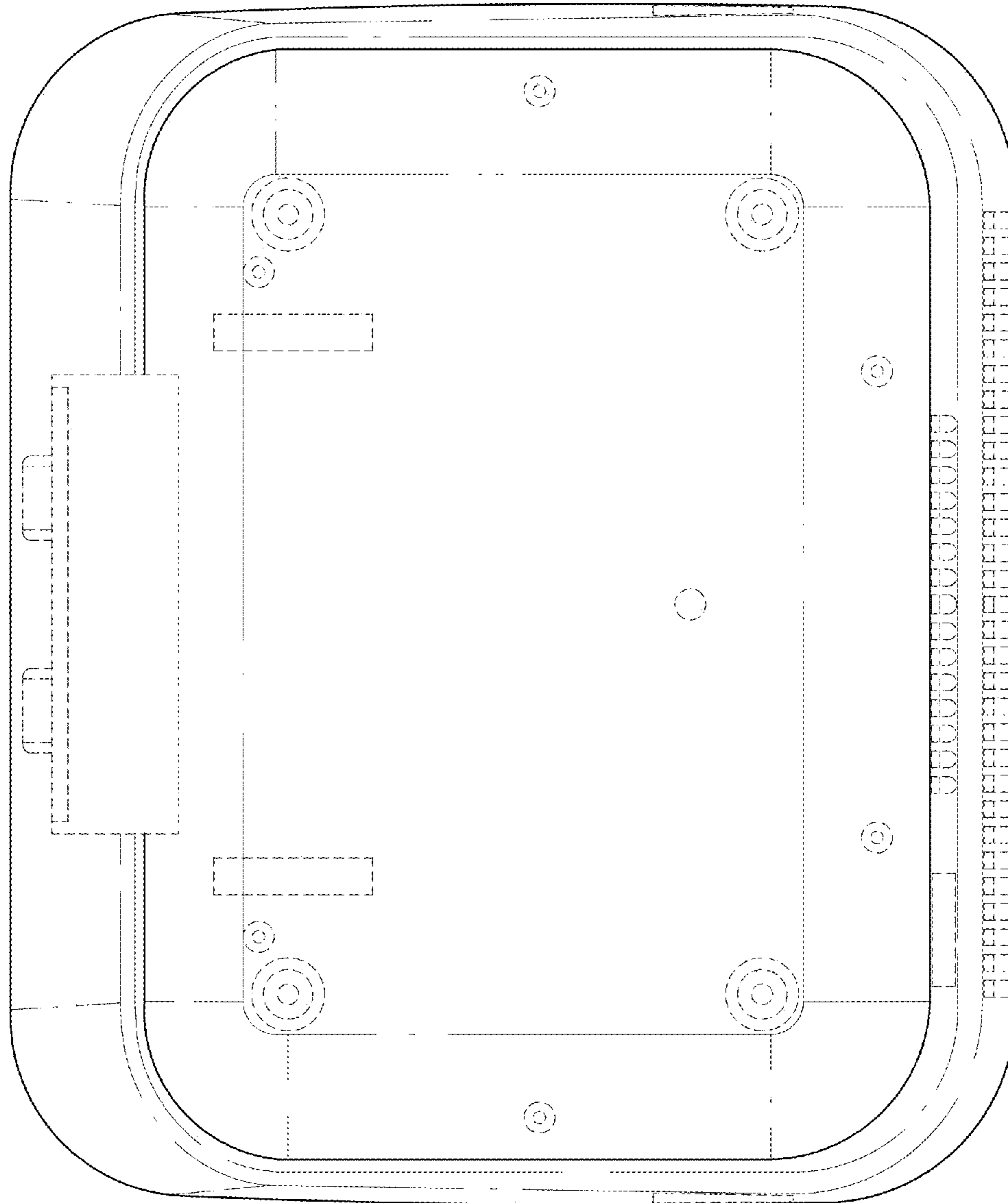
