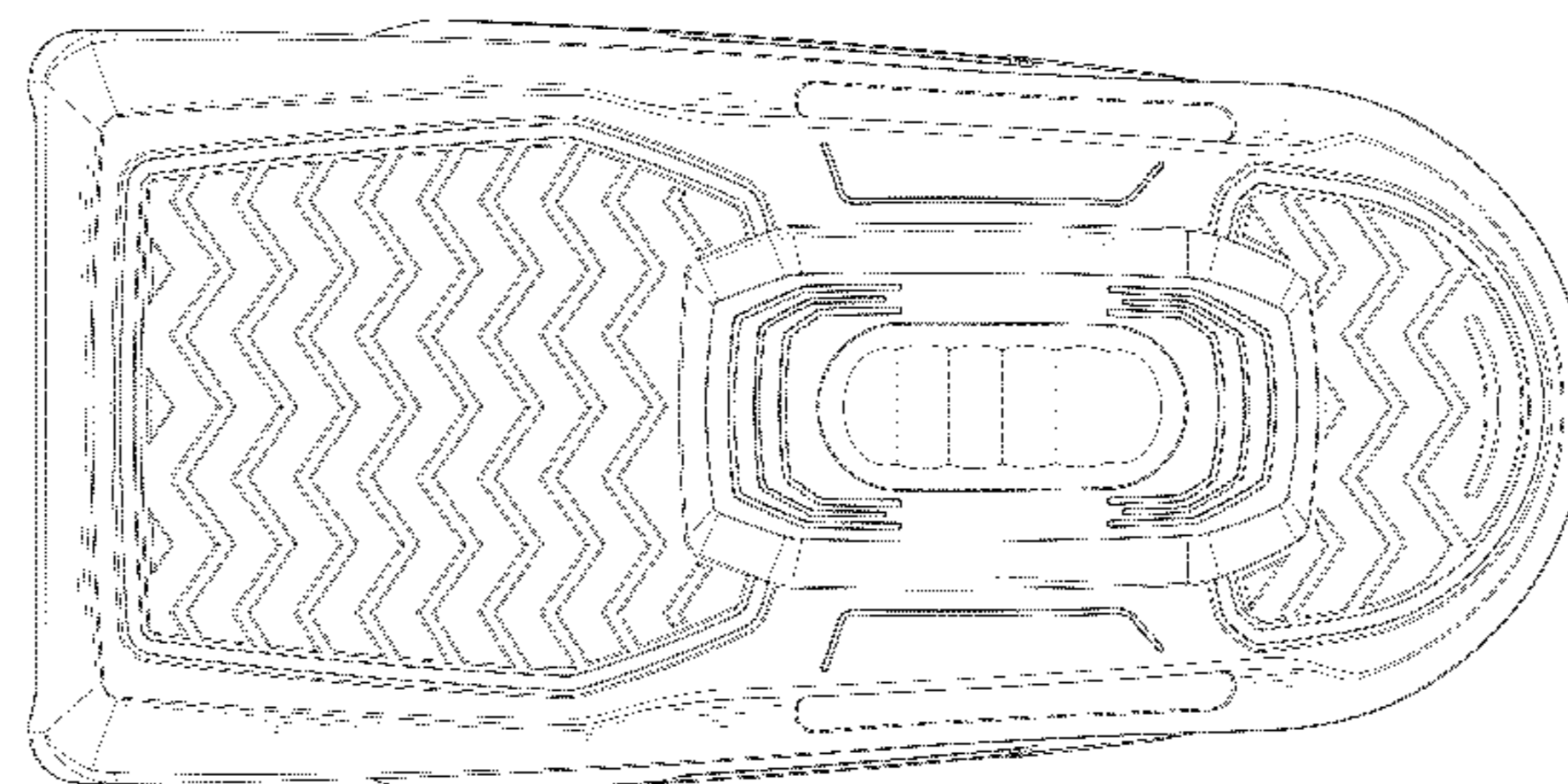
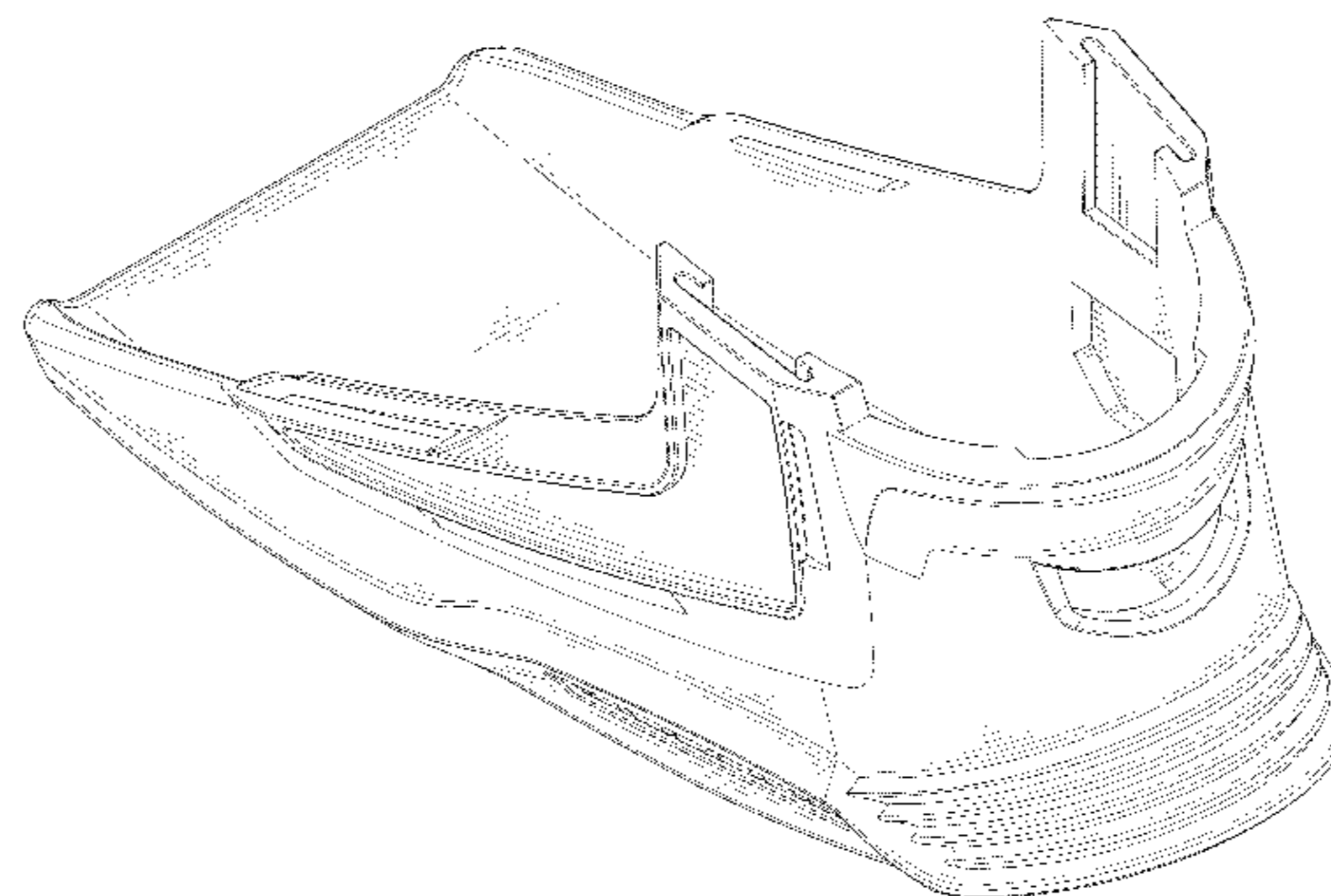
(57) **CLAIM**

The ornamental design for a rehabilitation shoe, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a rehabilitation shoe showing my new design;
FIG. 2 is a front elevational view thereof, a rear elevational view being a mirror image;
FIG. 3 is a left elevational view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof; and,
FIG. 7 is a perspective view shown in use.
The broken lines are shown for the purpose of illustrating portions of the rehabilitation shoe that form no part of the claimed design.

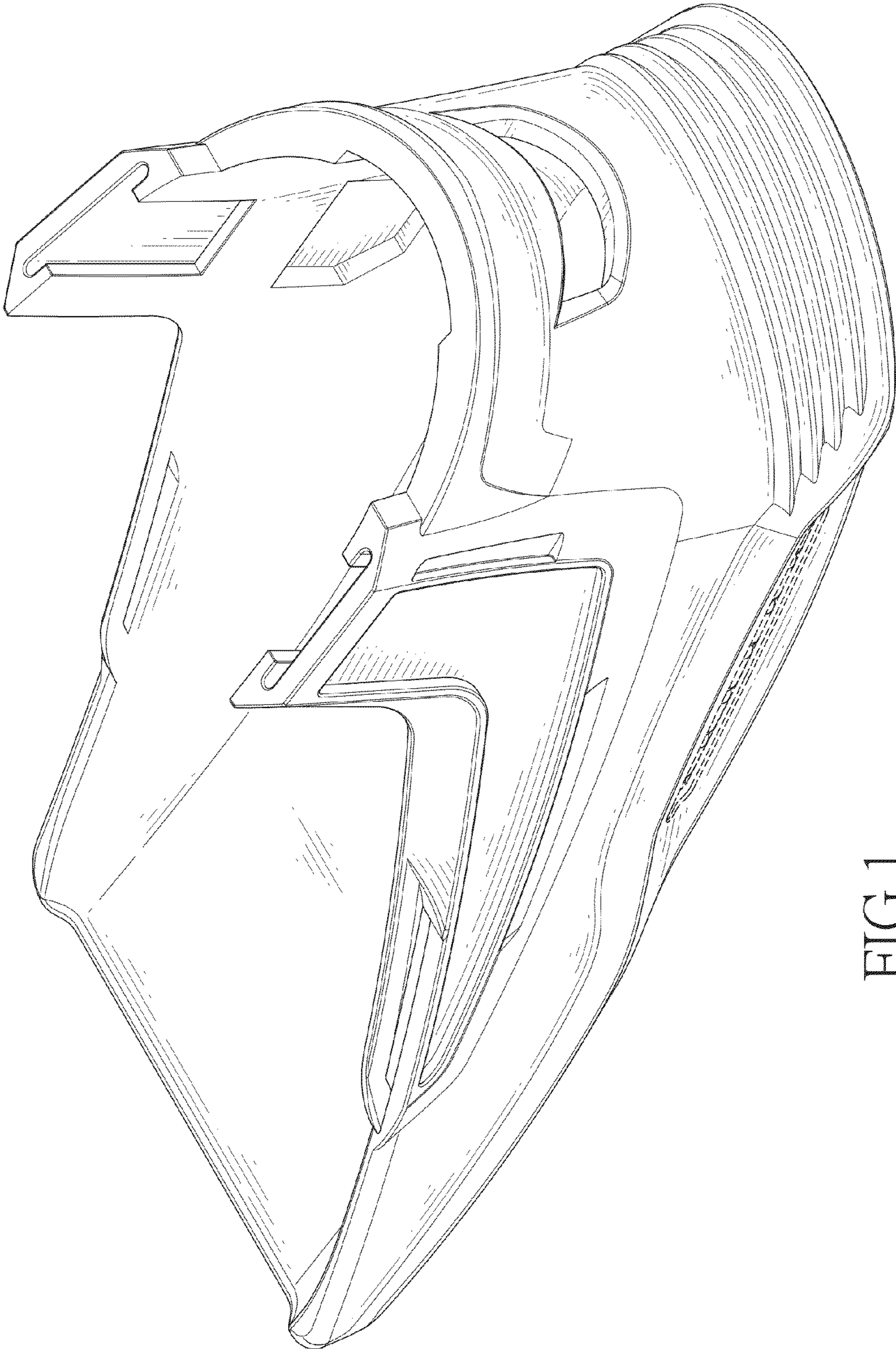

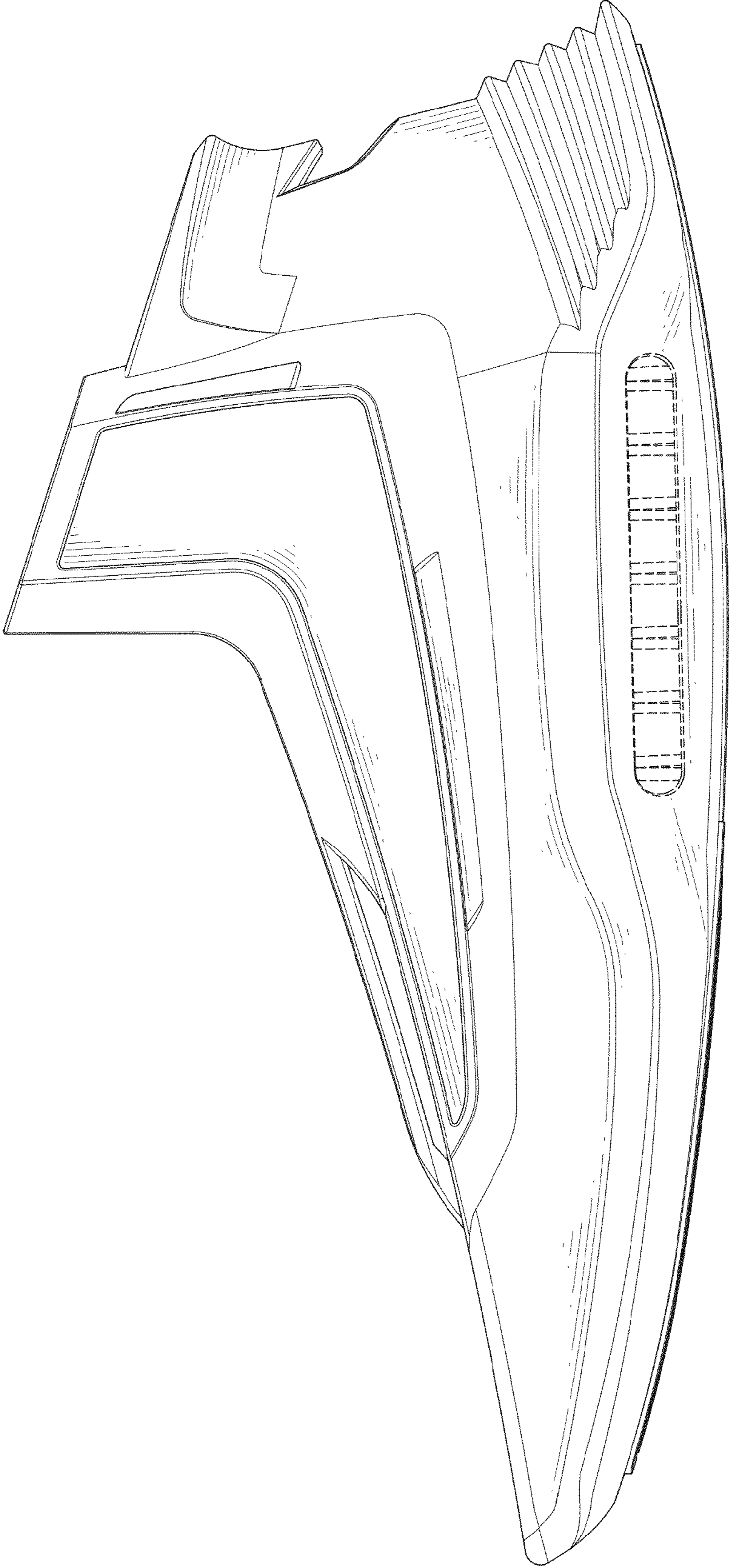

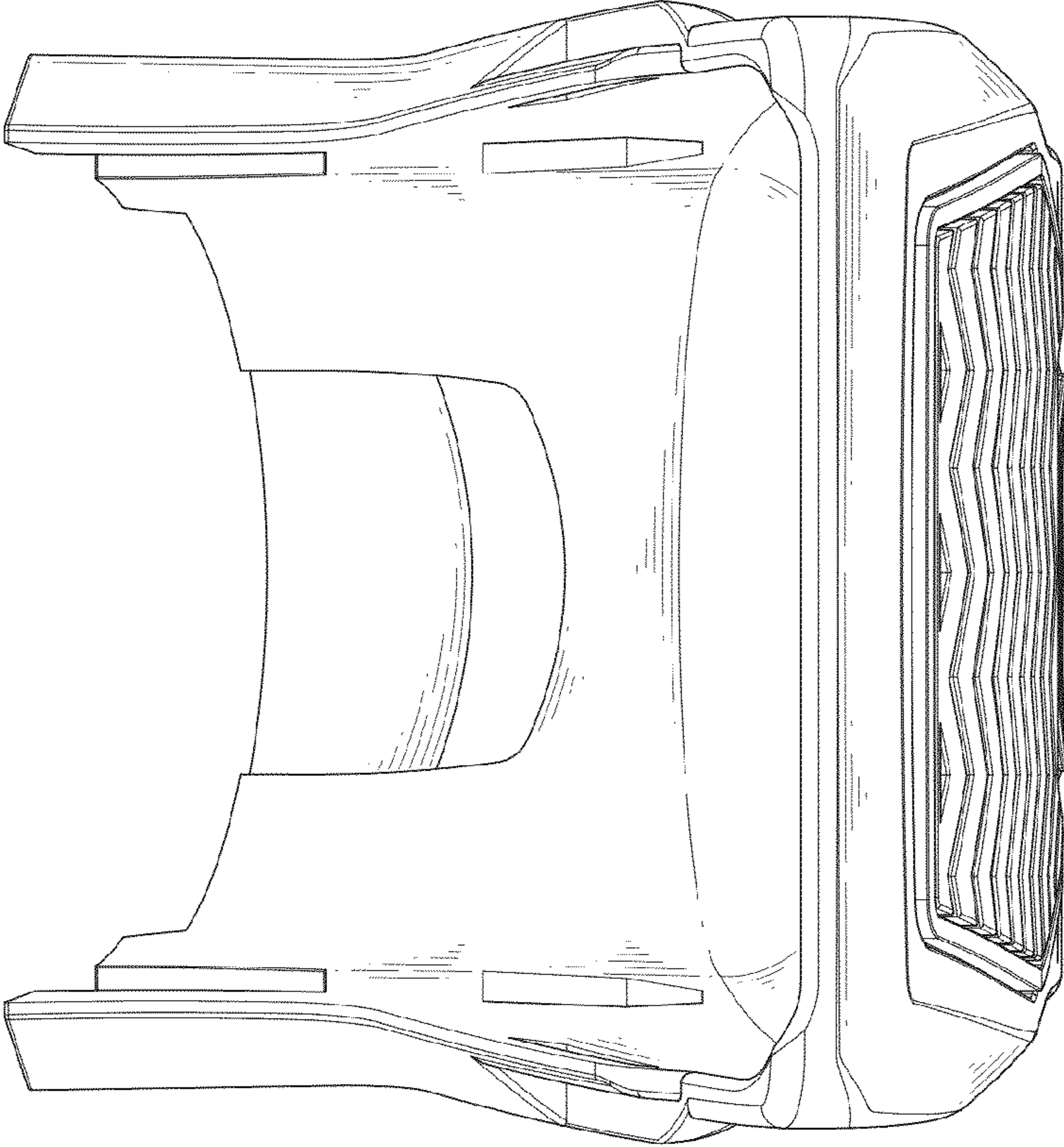

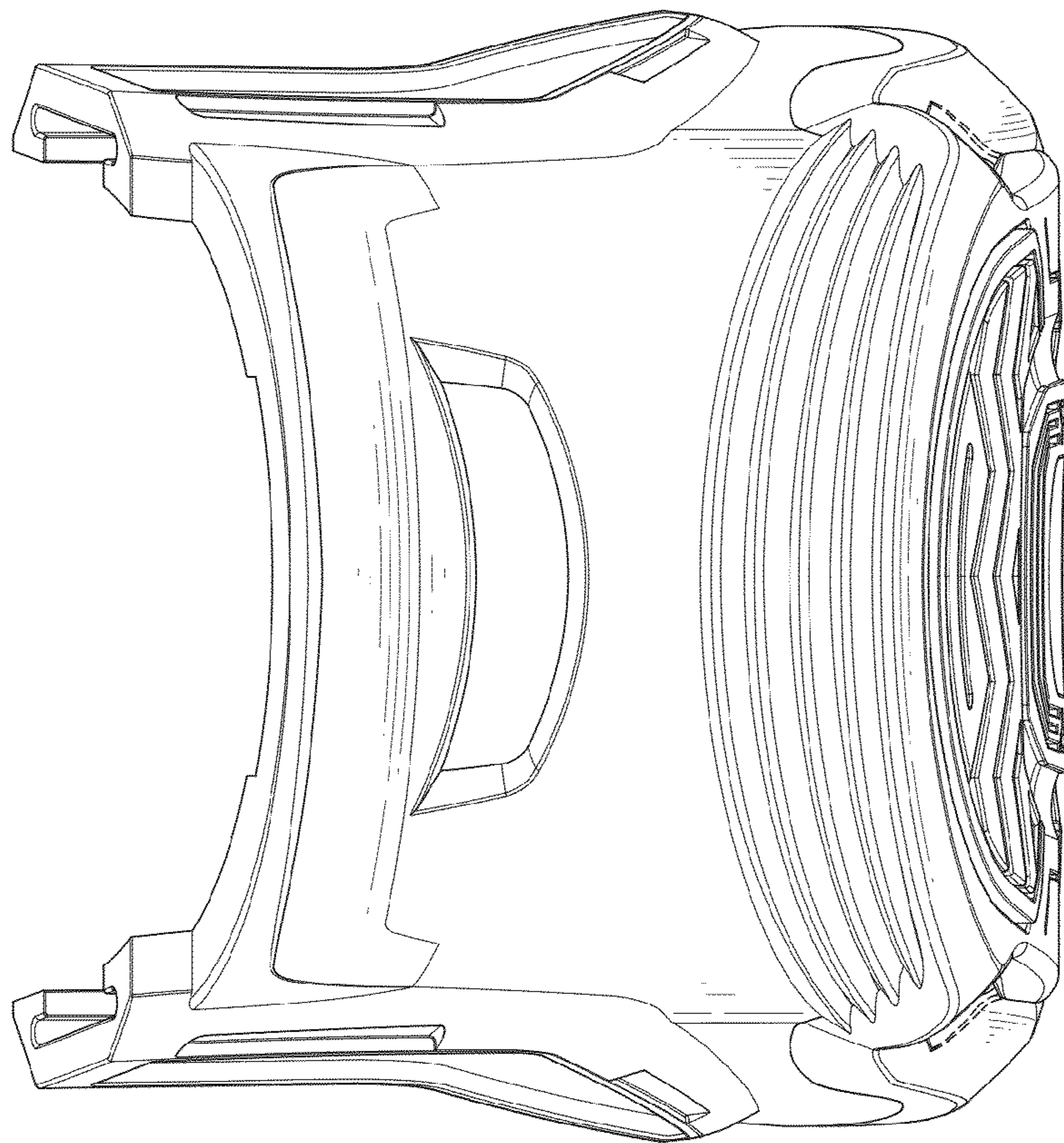

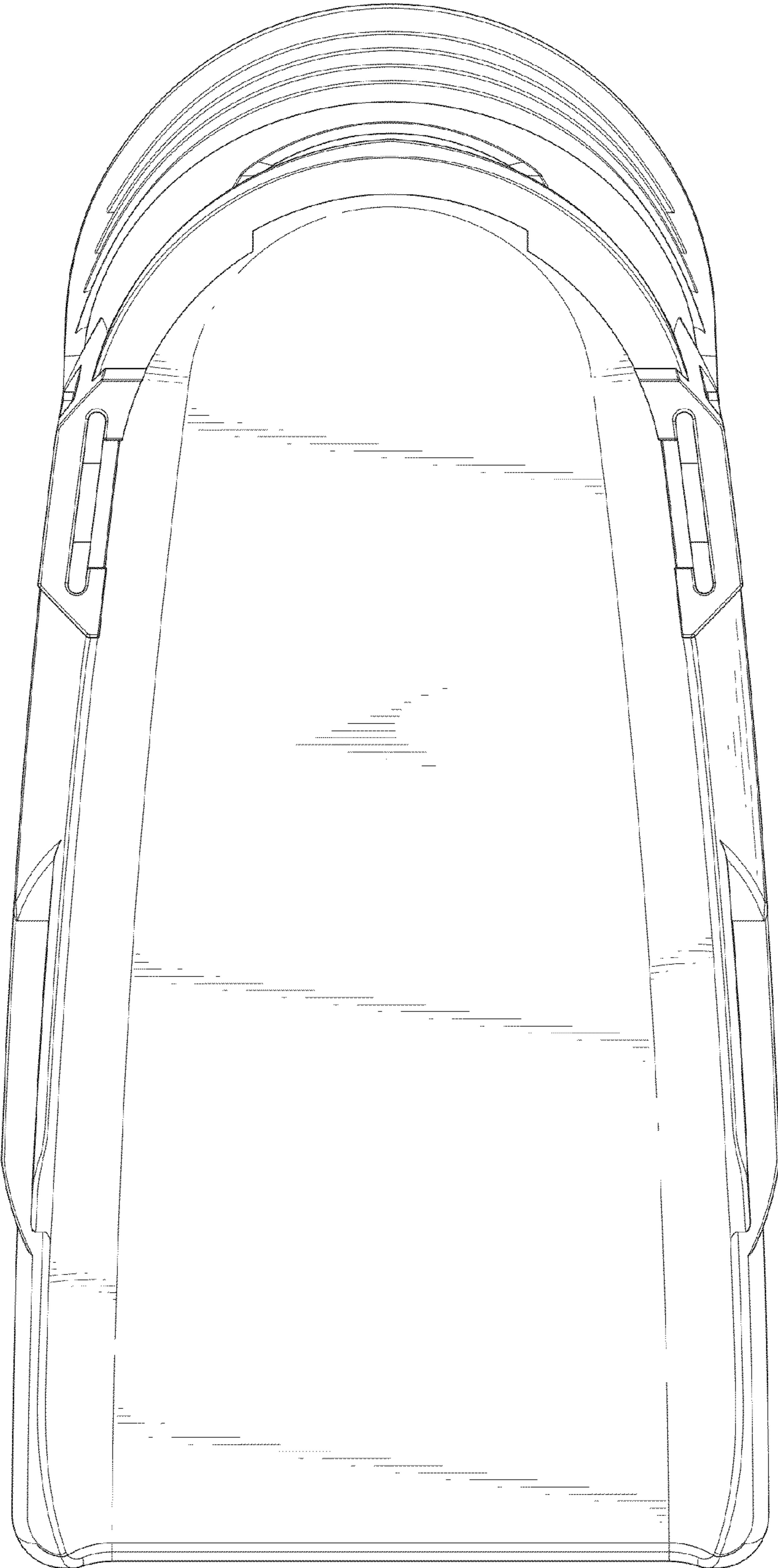

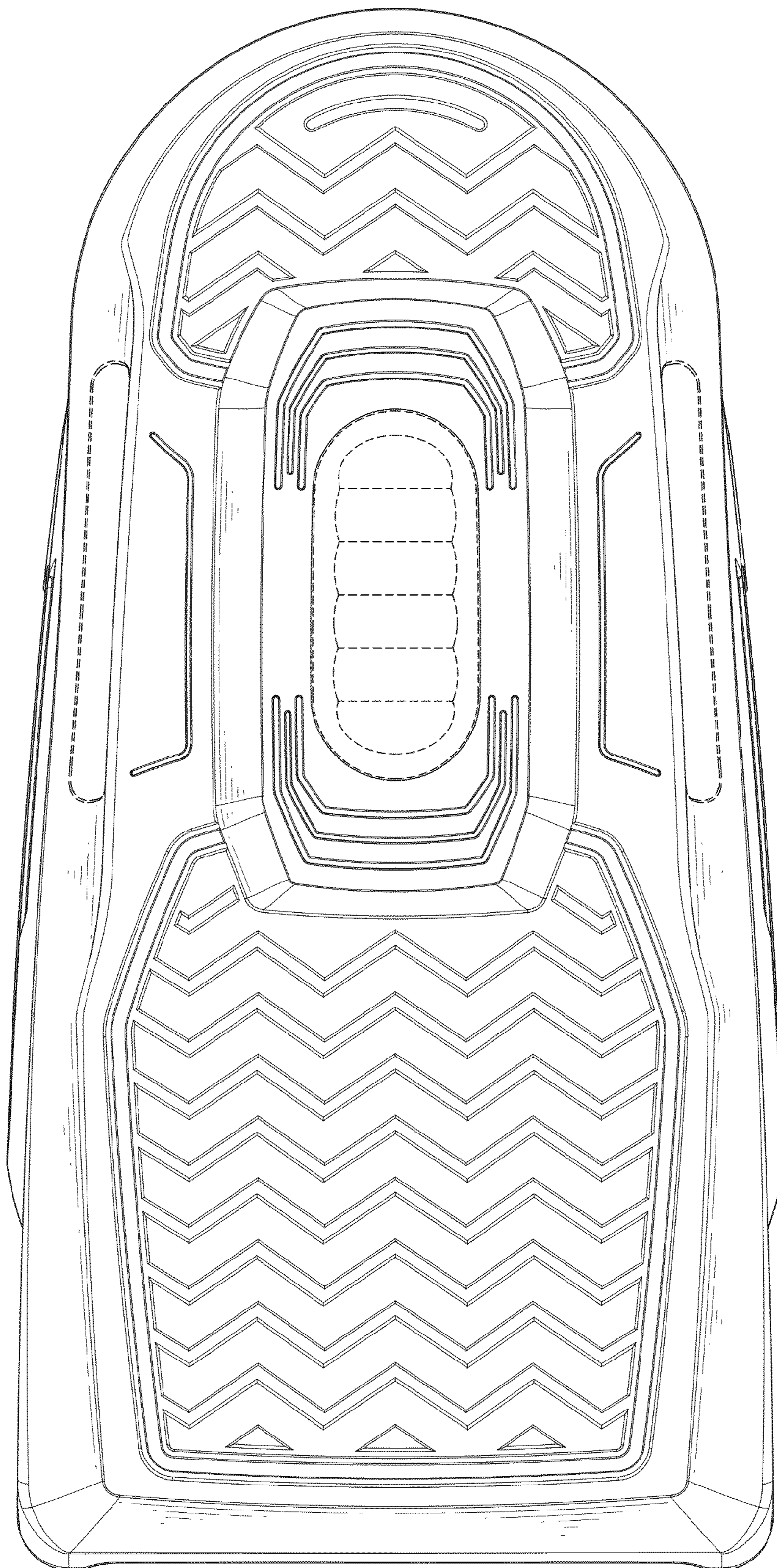

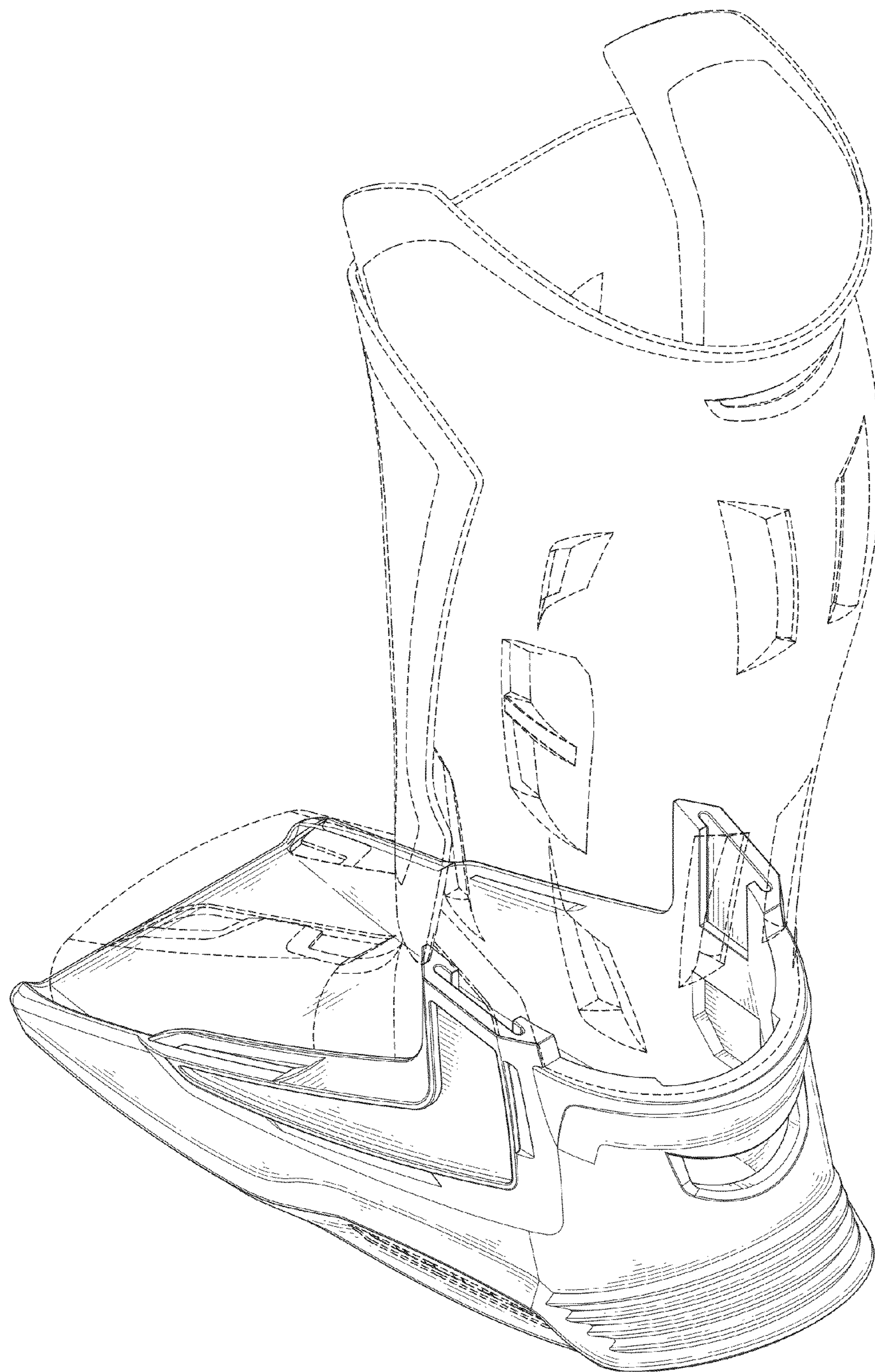
