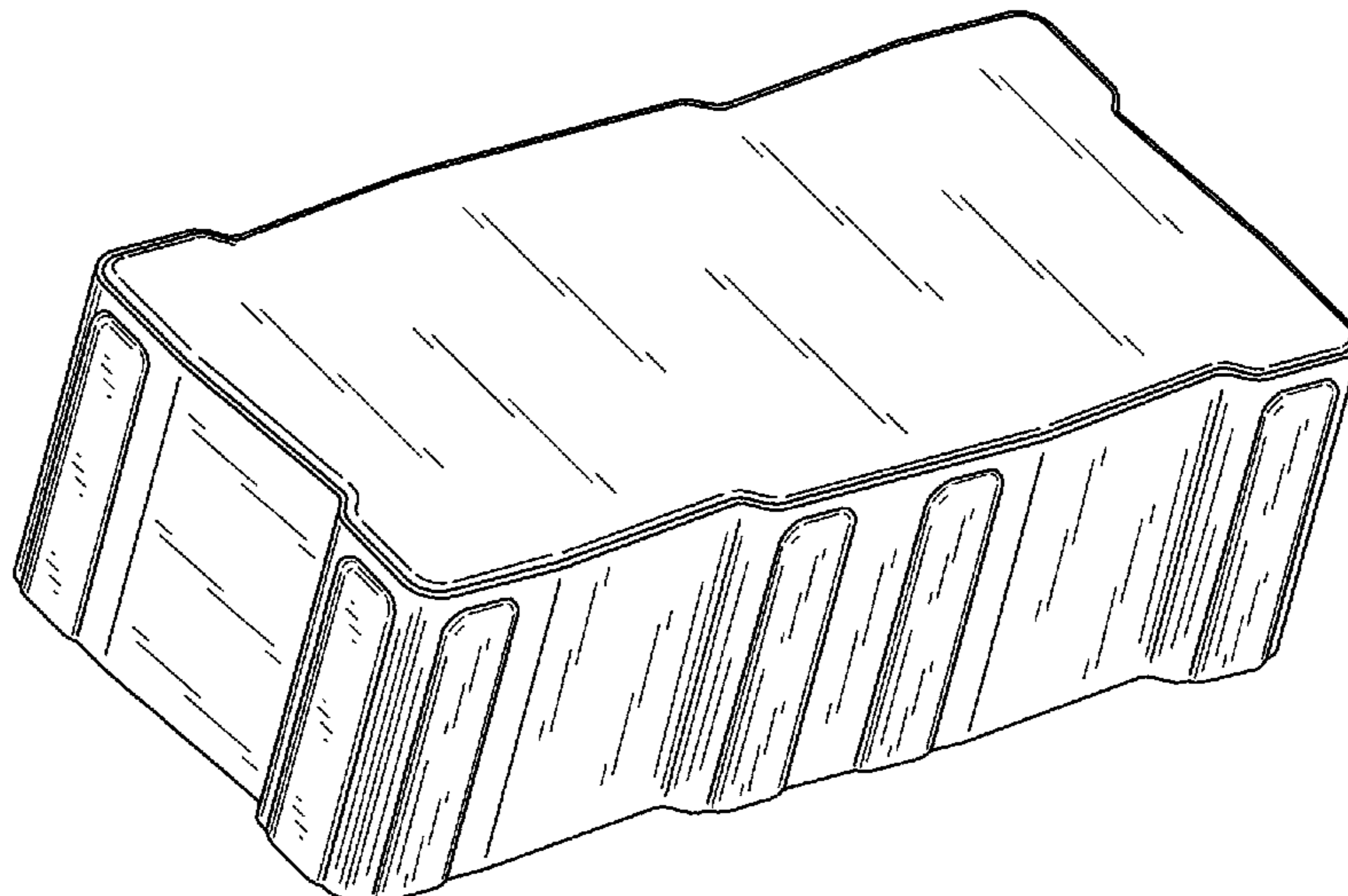
(57) **CLAIM**

I claim the ornamental design for a paver stone, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the top side of a paver stone. FIG. 2 is a front elevation view of the paver stone, the back elevation view being the same as the front elevation view. FIG. 3 is a right side elevation view of the paver stone, the left side elevation view being the same as the right side elevation view. FIG. 4 is a top plan view of the paver stone; and, FIG. 5 is a bottom plan view of the paver stone.

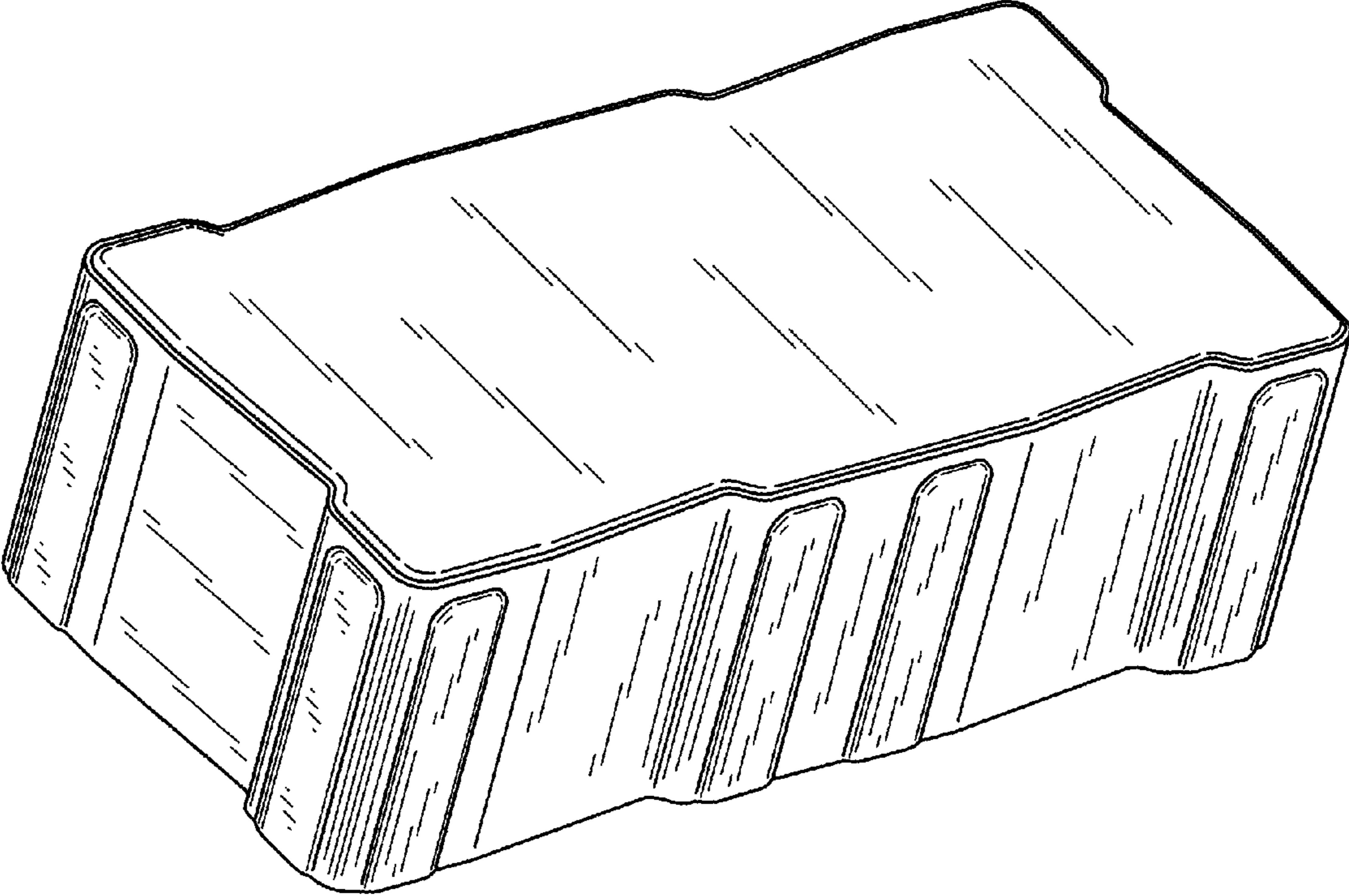

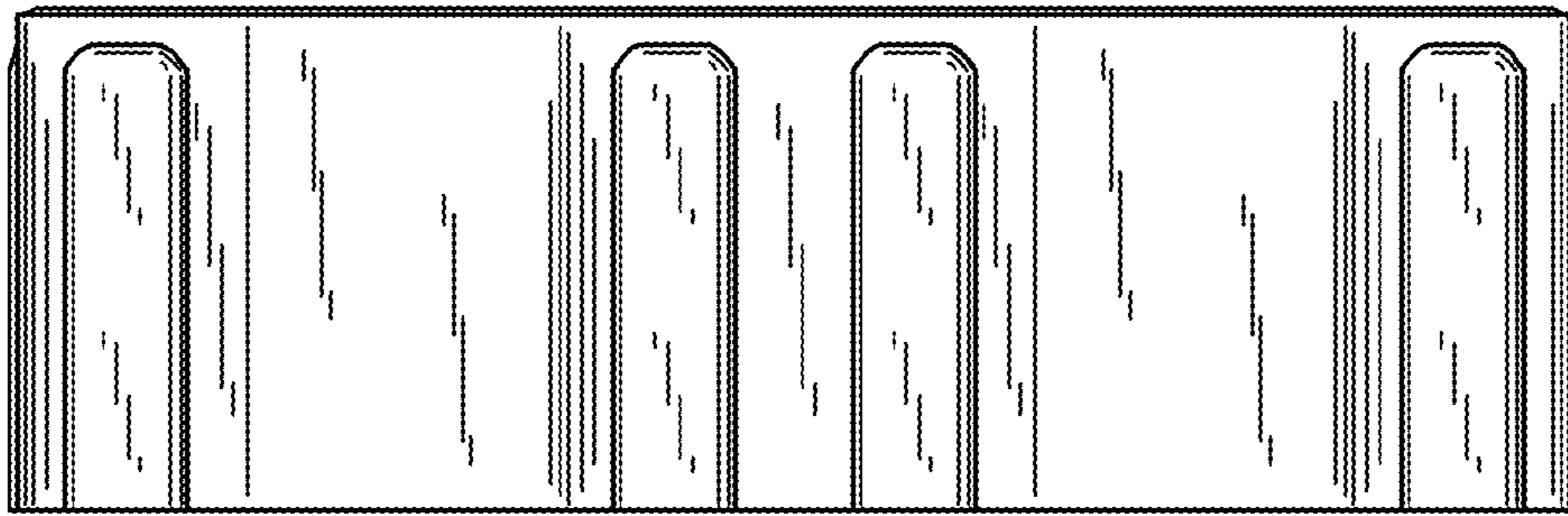

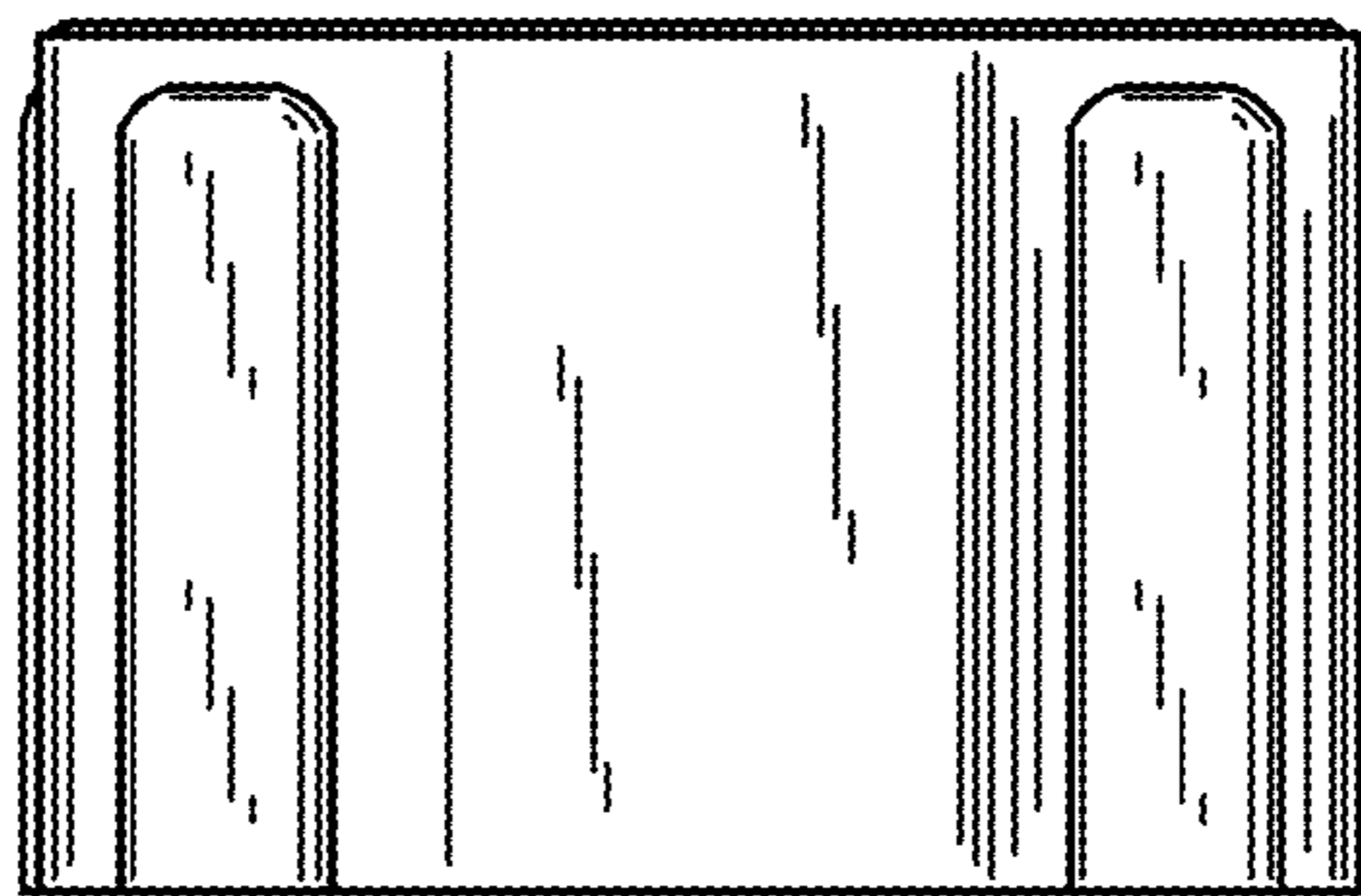

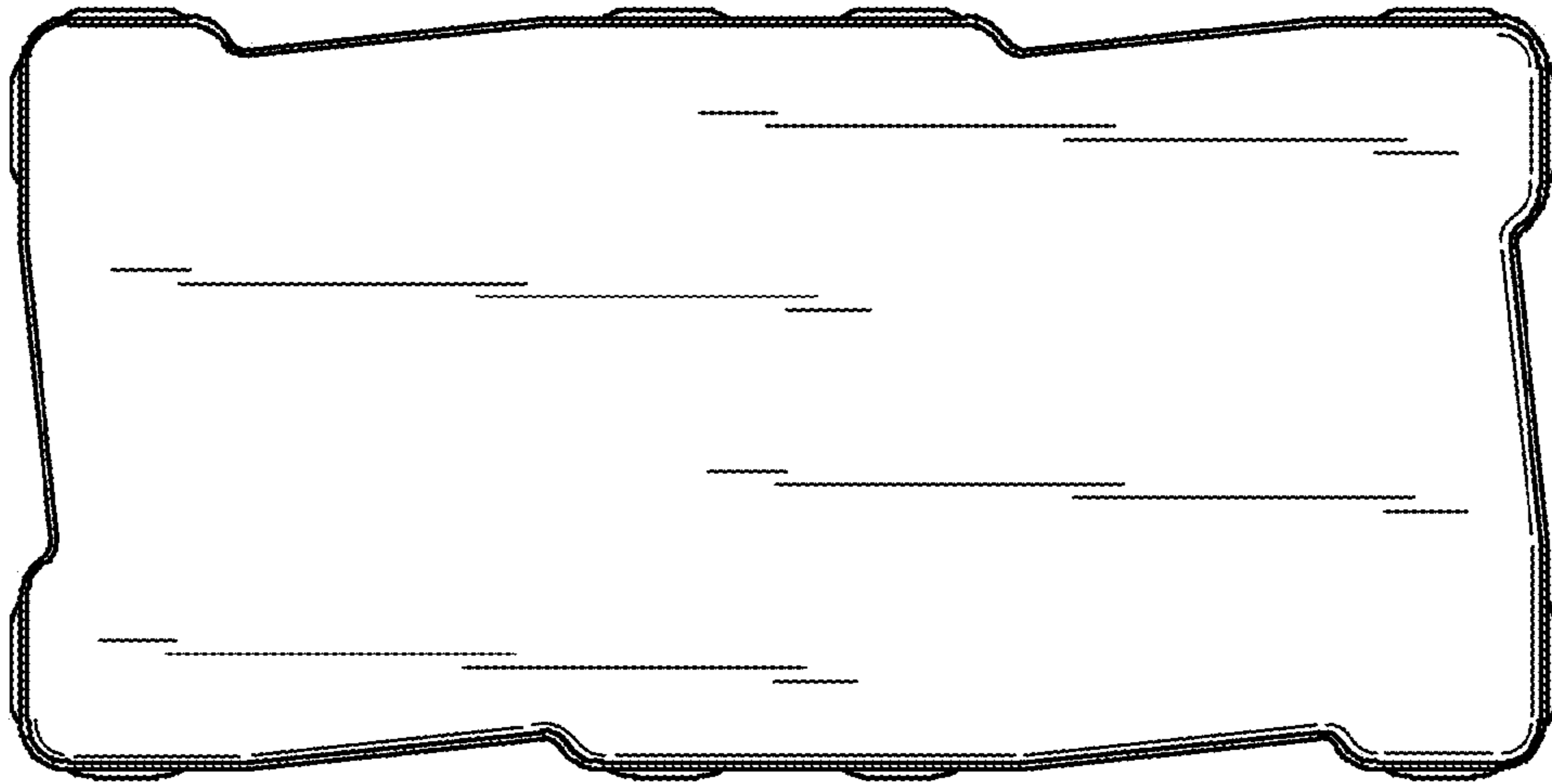

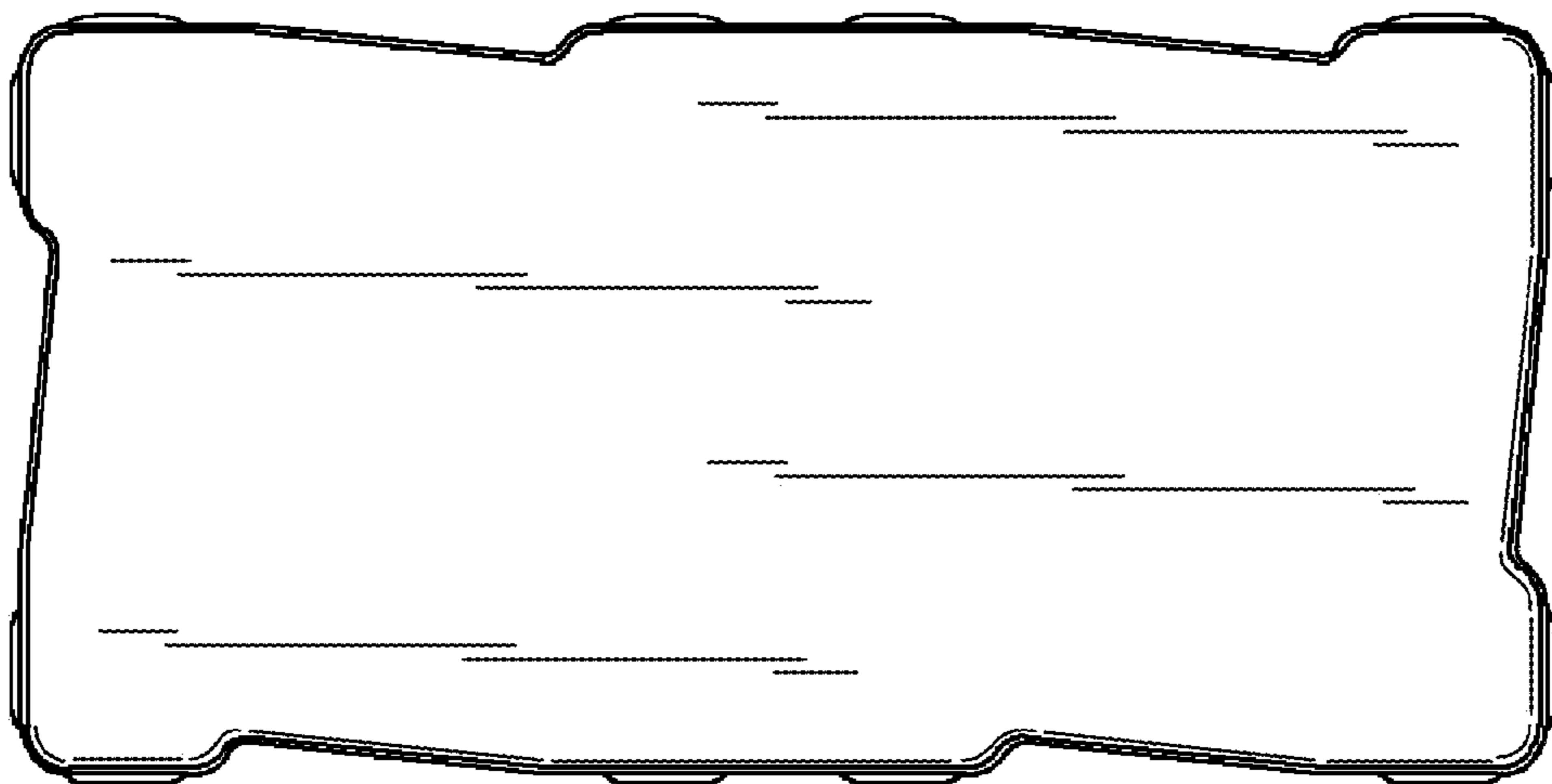
