(57) **CLAIM**

The ornamental design for a lingerie underwear, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the lingerie underwear, showing our new design;

FIG. 2 is a front elevation view thereof; and,

FIG. 3 is a left side elevation view thereof.

The dash-dot-dash broken lines represent the boundary of the claimed design. The dash-dash broken lines represent portions of the lingerie underwear that forms no part of the claim.

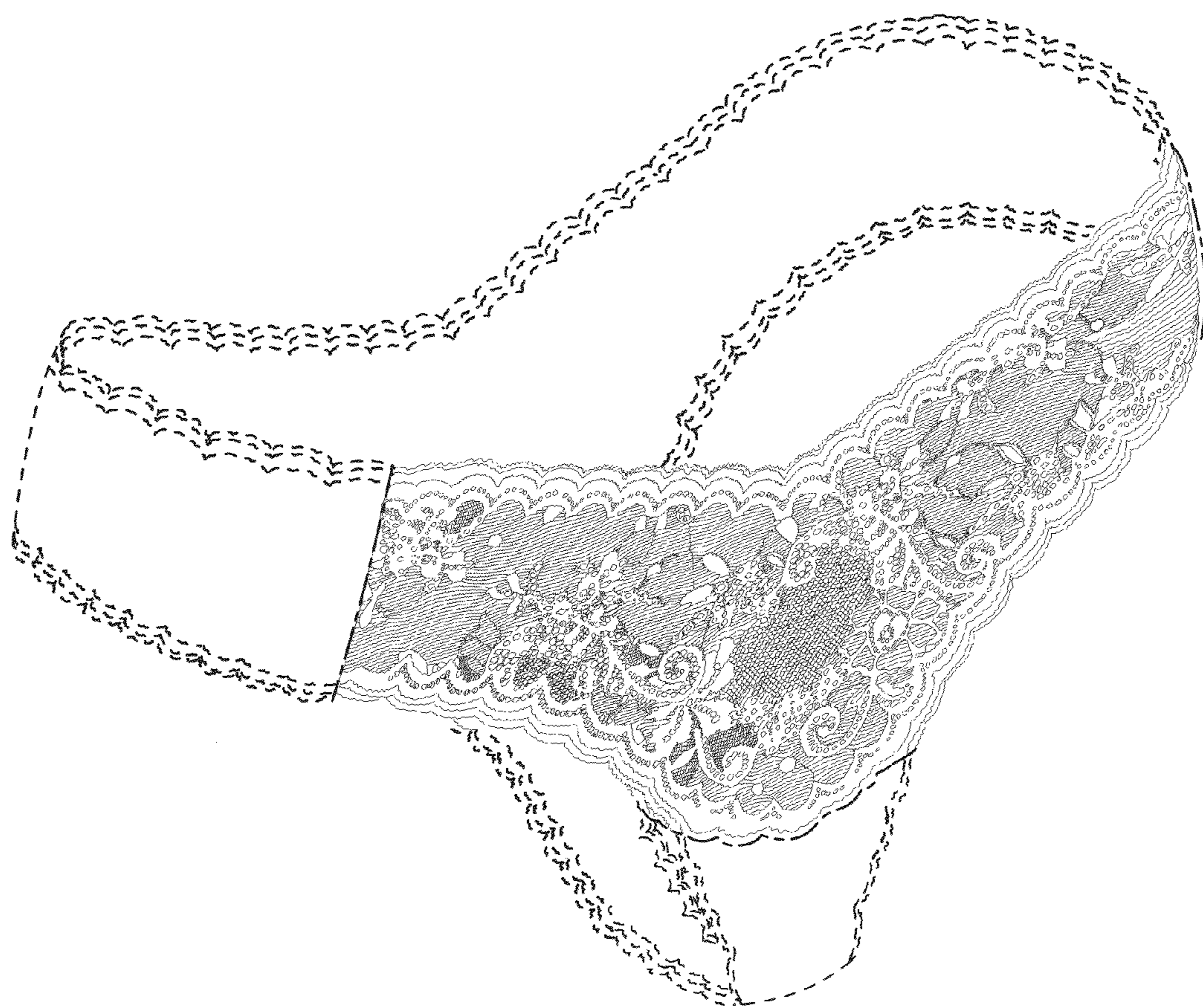

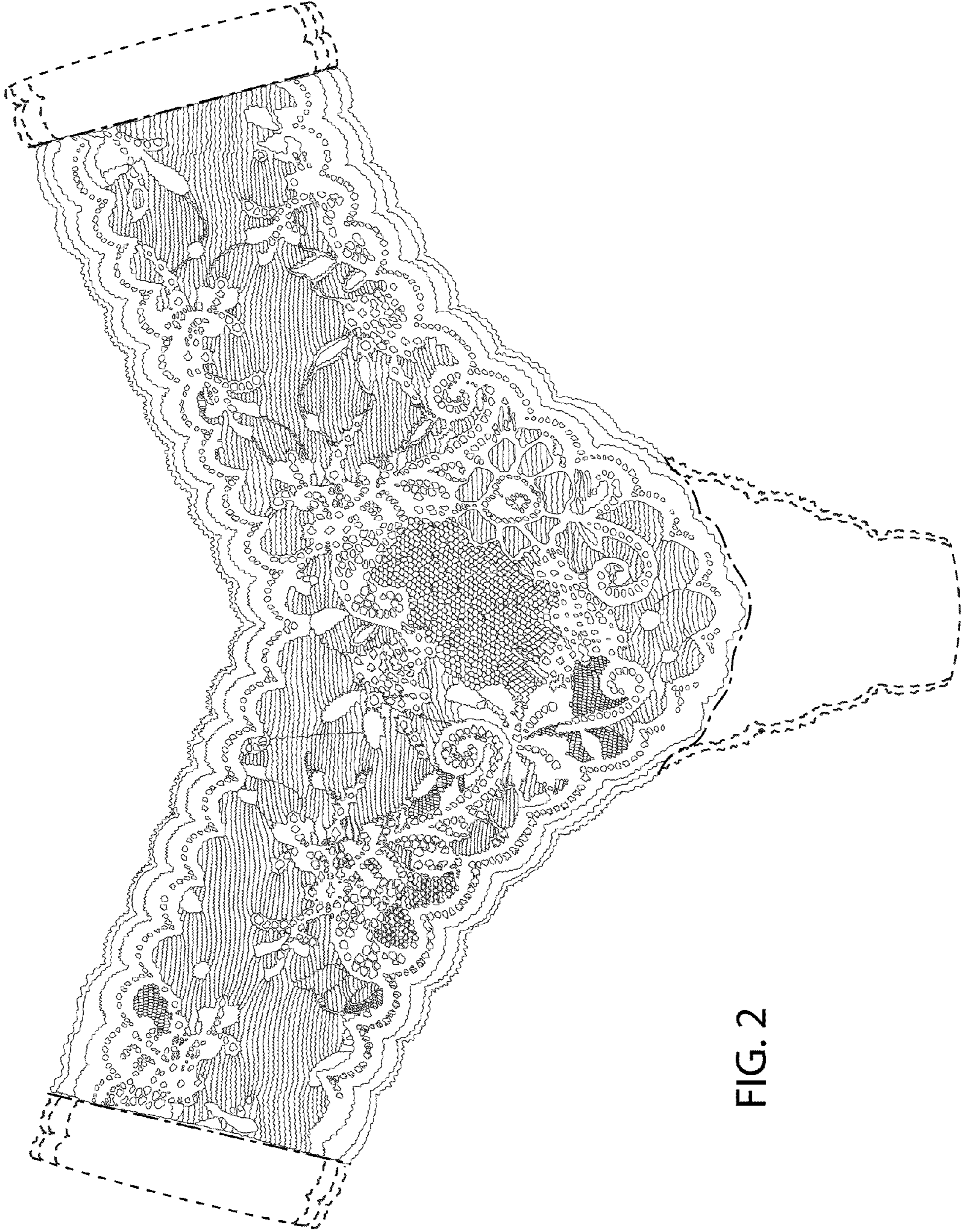

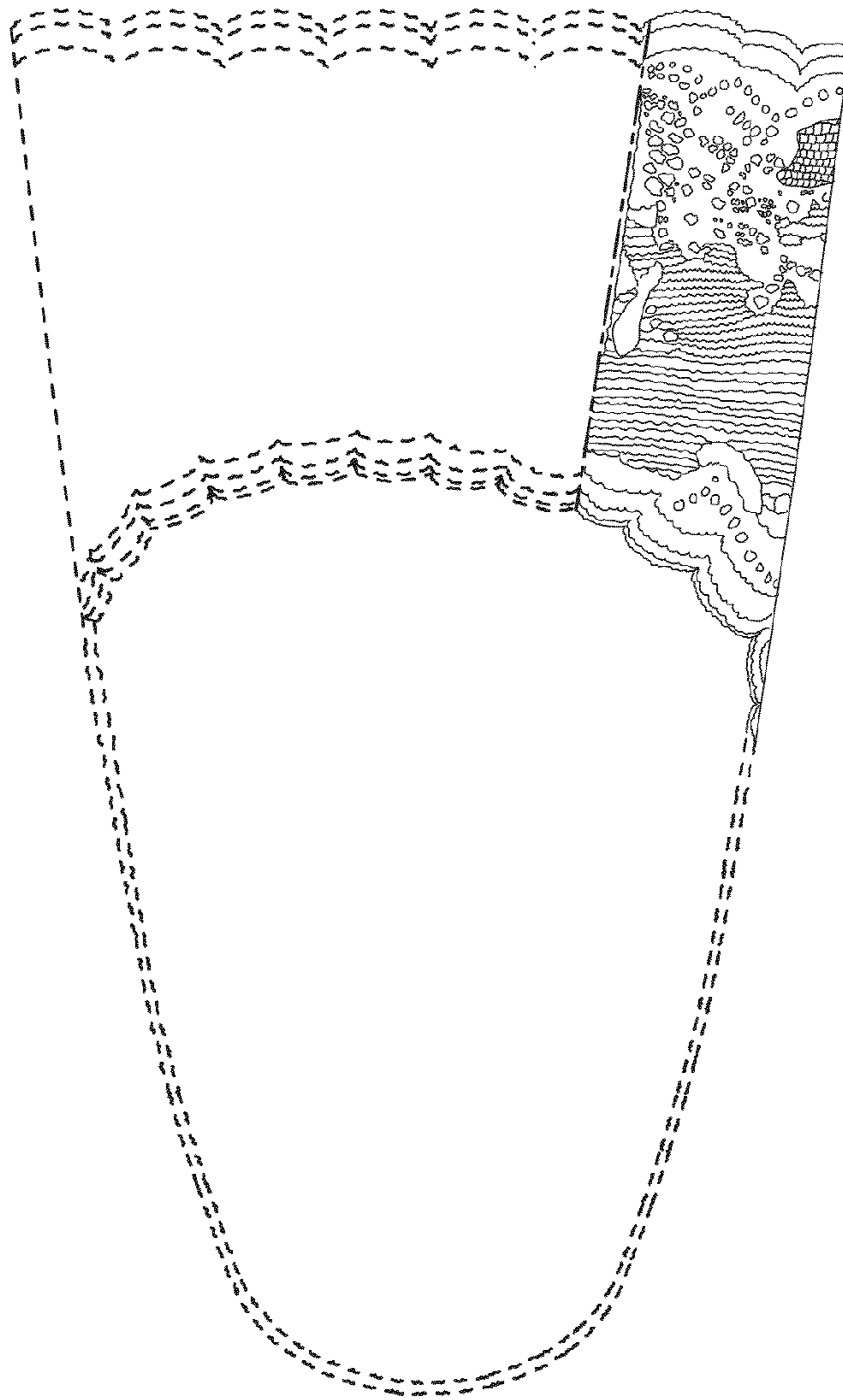
