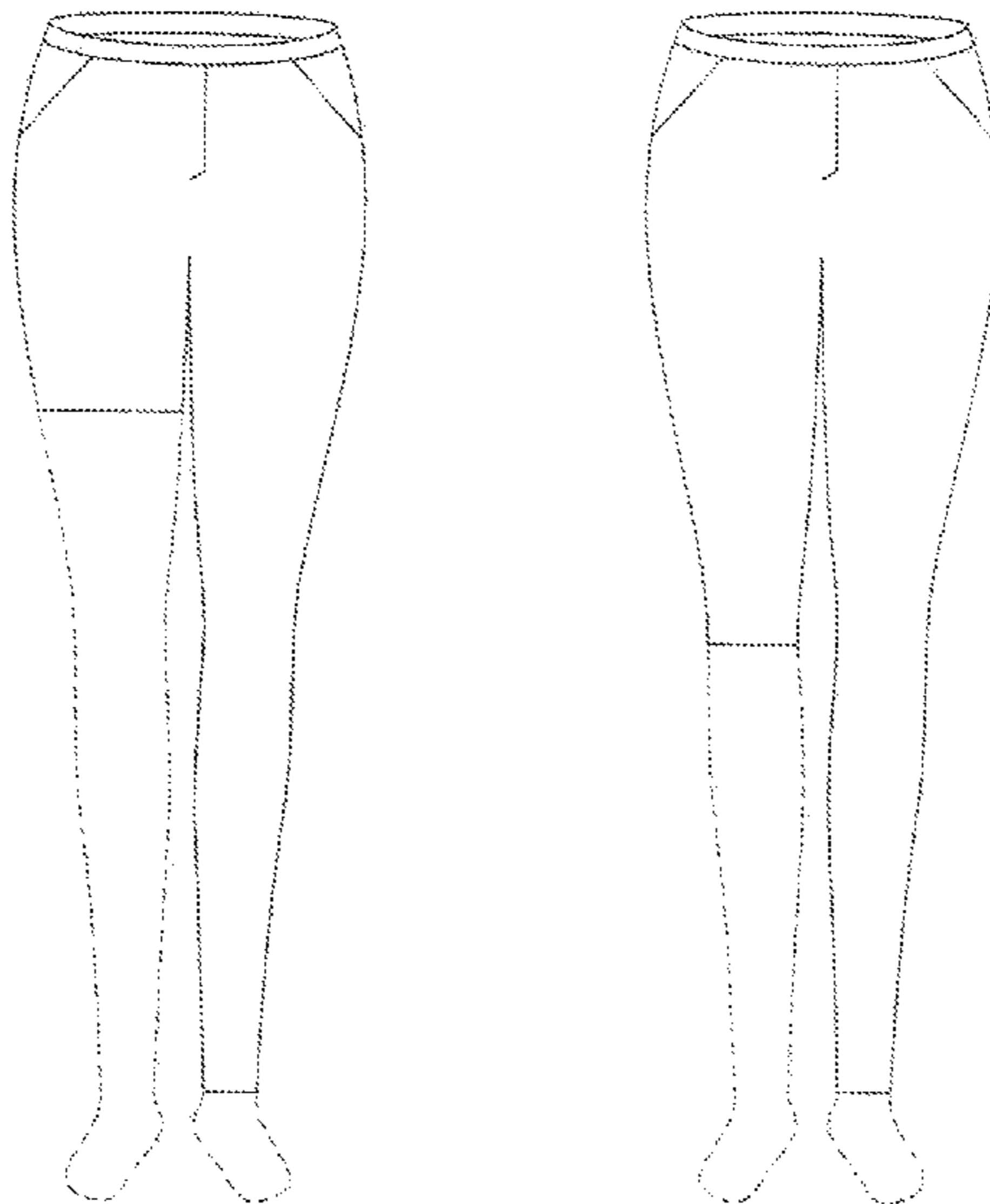

DESCRIPTION

FIG. 1 is a front view of a first embodiment of asymmetrical pants showing my new design;
FIG. 2 is a back view thereof;
FIG. 3 is a left side view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a front view of a second embodiment of asymmetrical pants showing my new design;
FIG. 6 is a back view thereof;

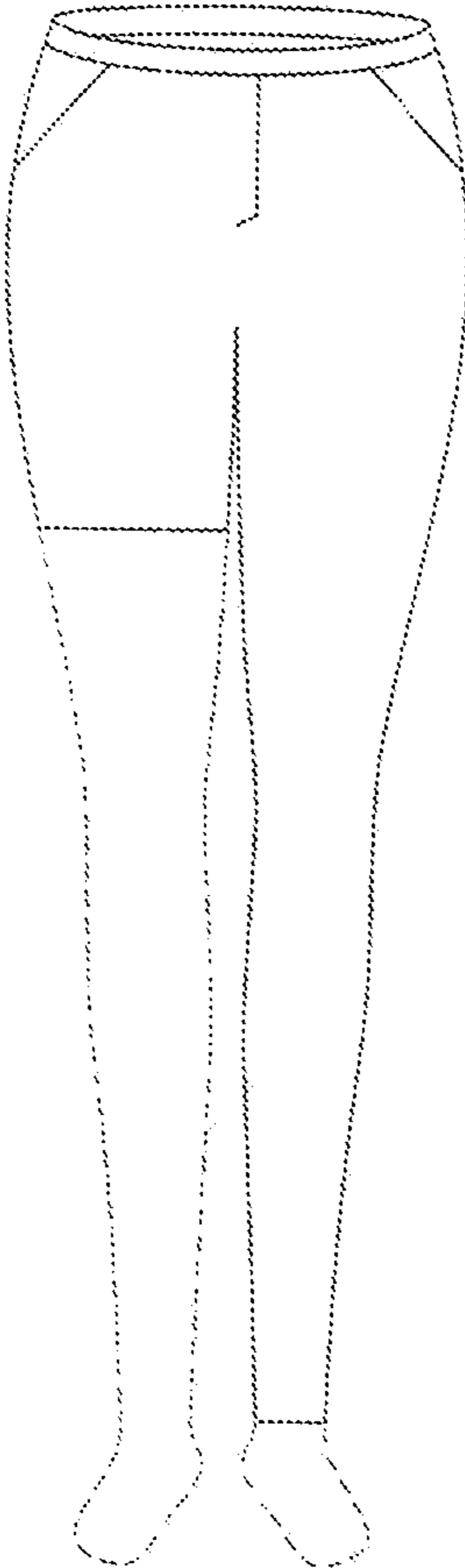

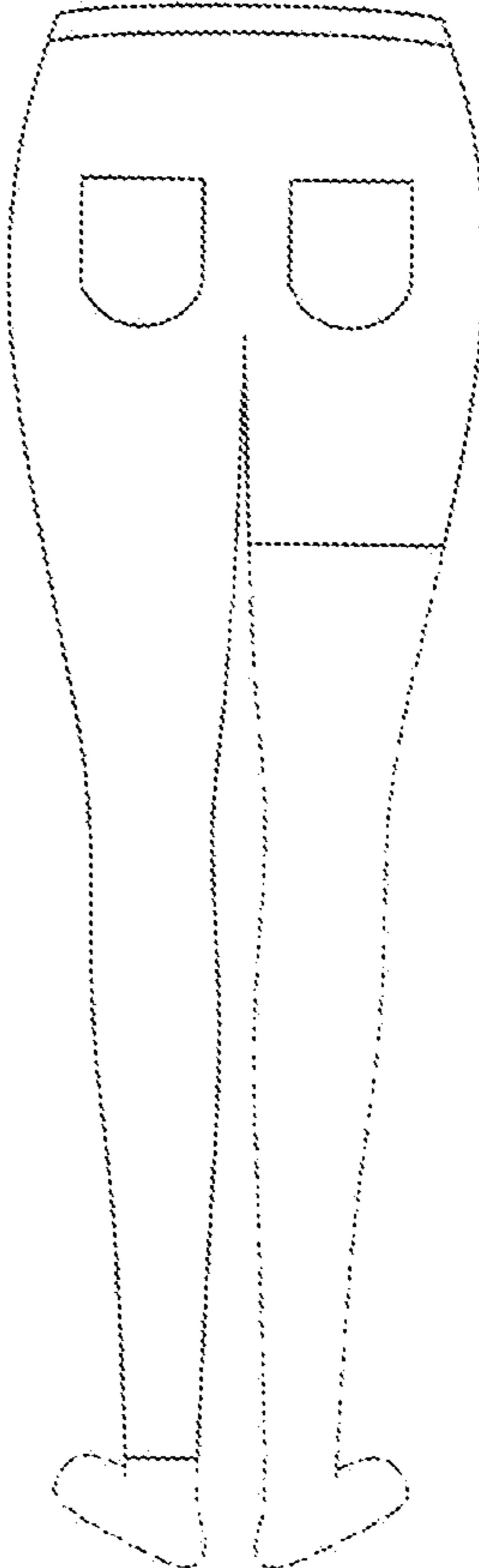

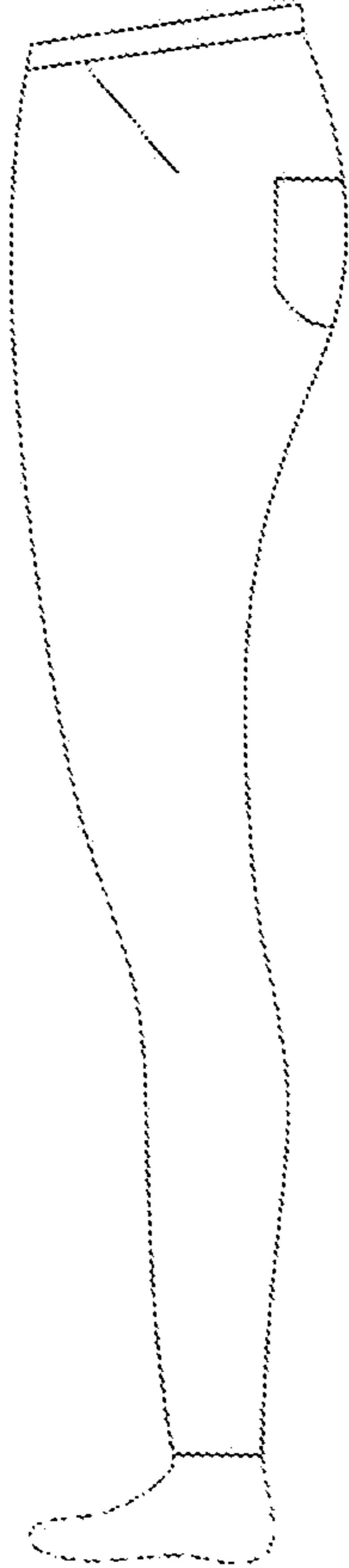

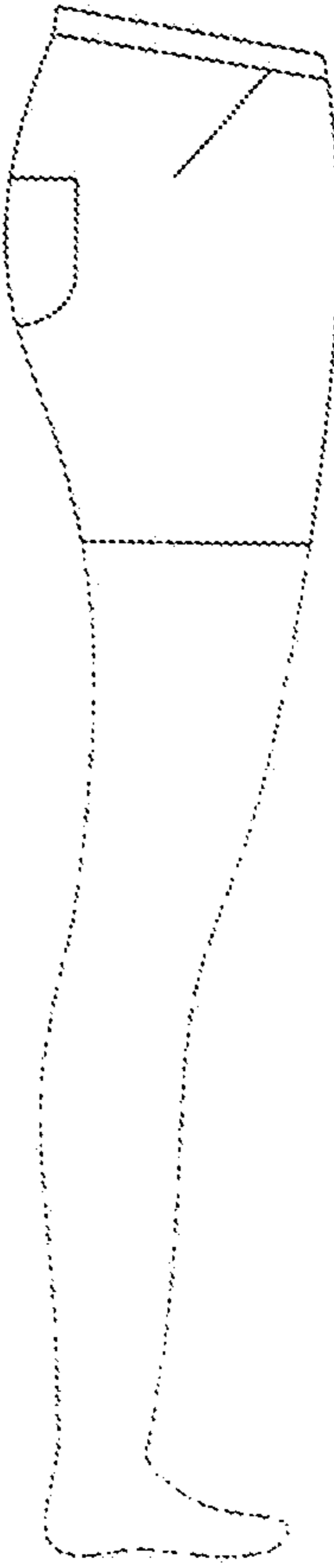

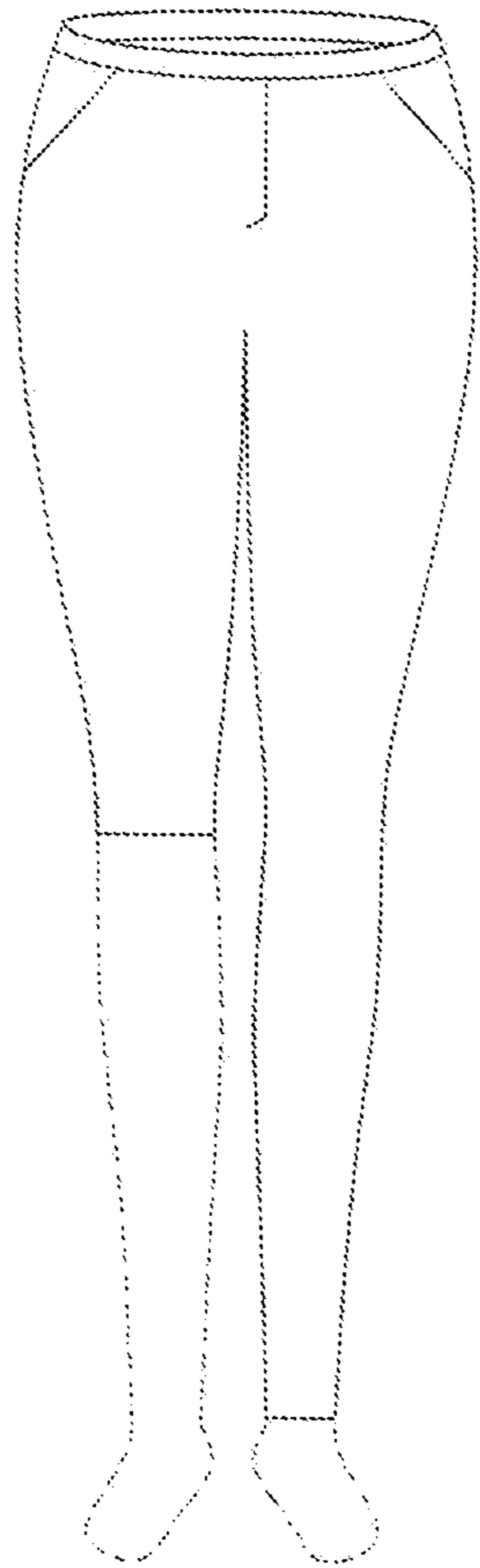

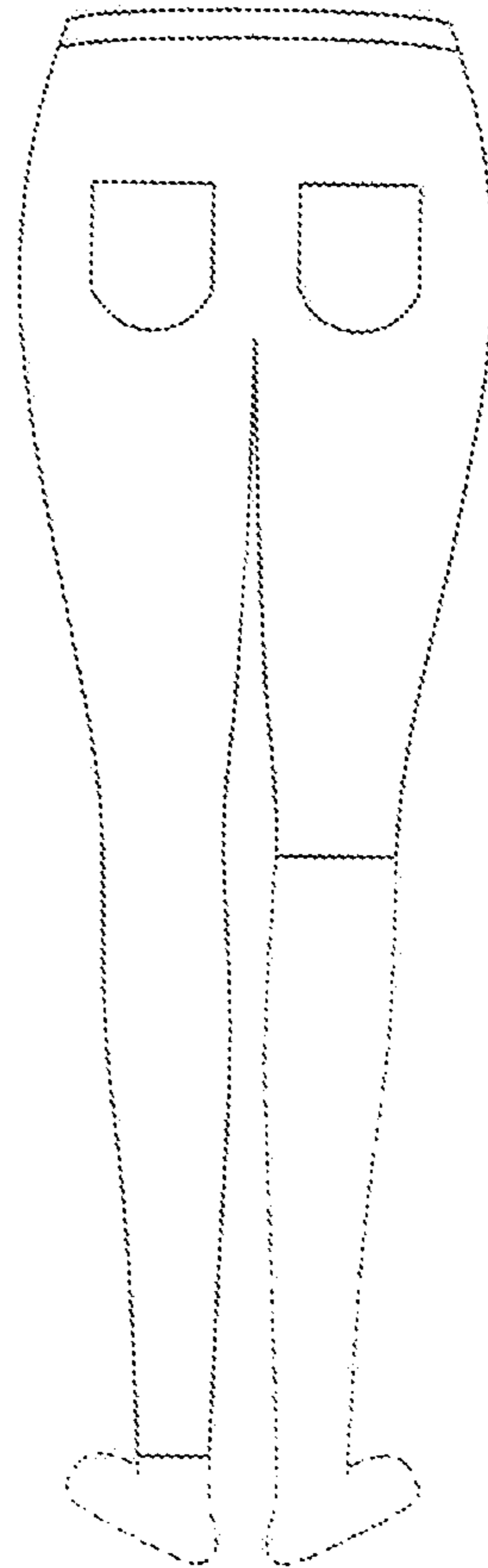

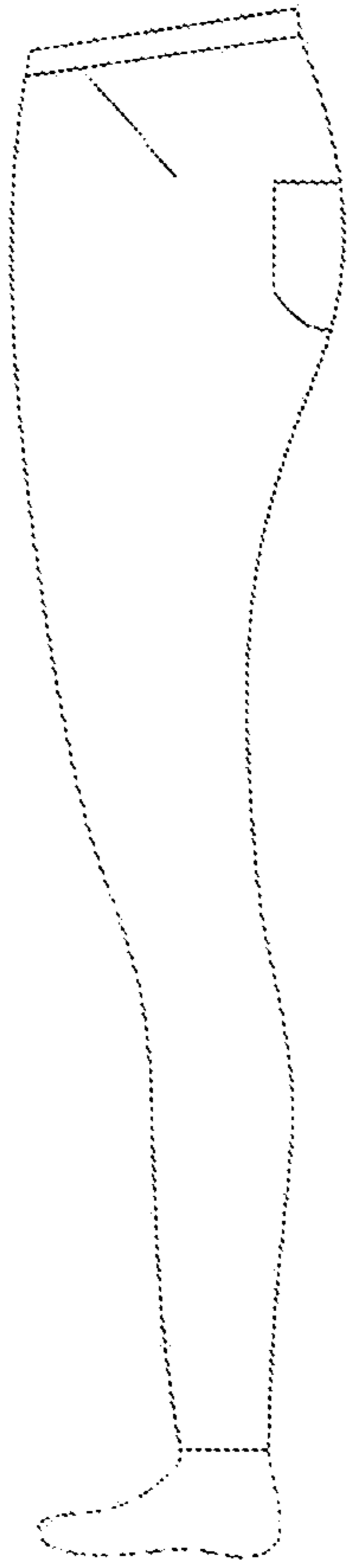

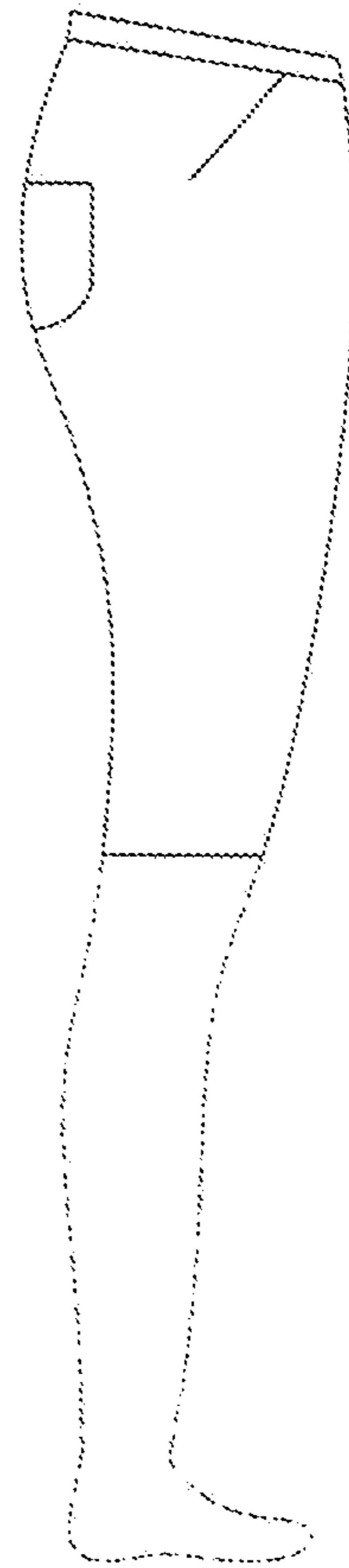
