(57) The ornamental design for pants, as shown and described.

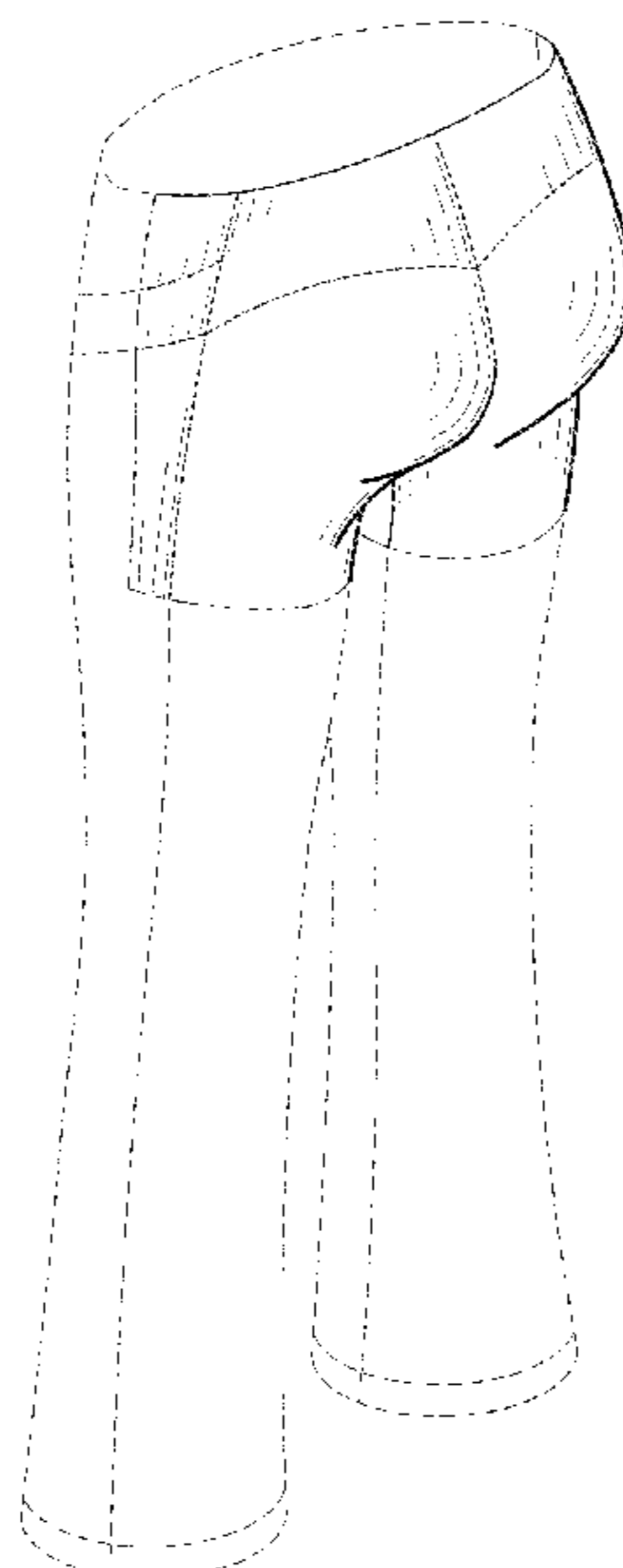
DESCRIPTION

FIG. 1 is a rear view of pants showing my new design; FIG. 2 is a left side view of the pants of FIG. 1, the right side view is a mirror image thereof; FIG. 3 is a front view of the pants of FIG. 1; and, FIG. 4 is a perspective view of the pants of FIG. 1. The short dashed lines indicate stitching. Dash-dot lines represent boundary of the claimed area. The long dashed lines illustrate intended environment of use and form no part of the claimed design. FIG. 3 shows unclaimed features that form no part of the claimed design.

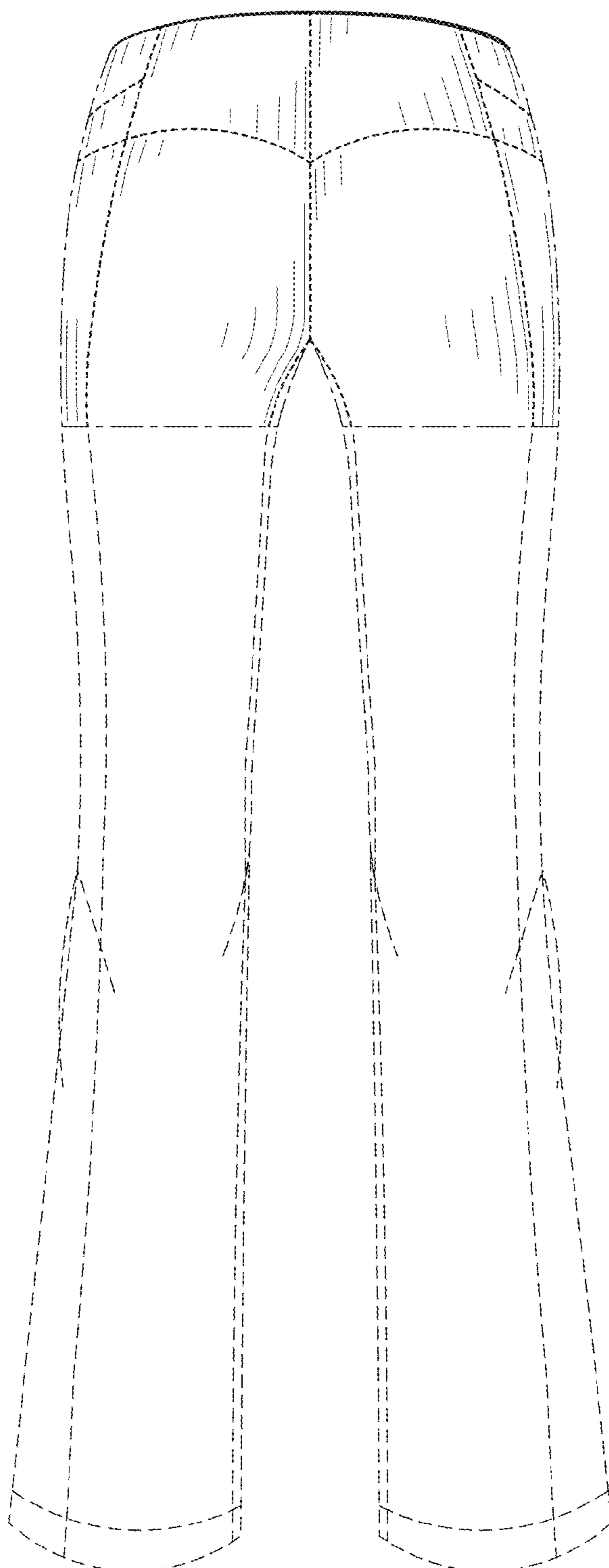

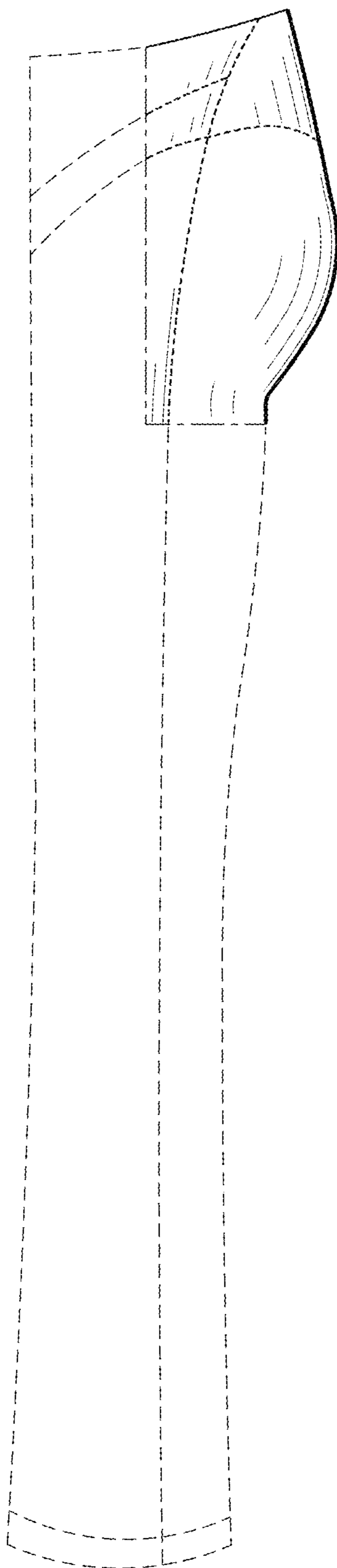

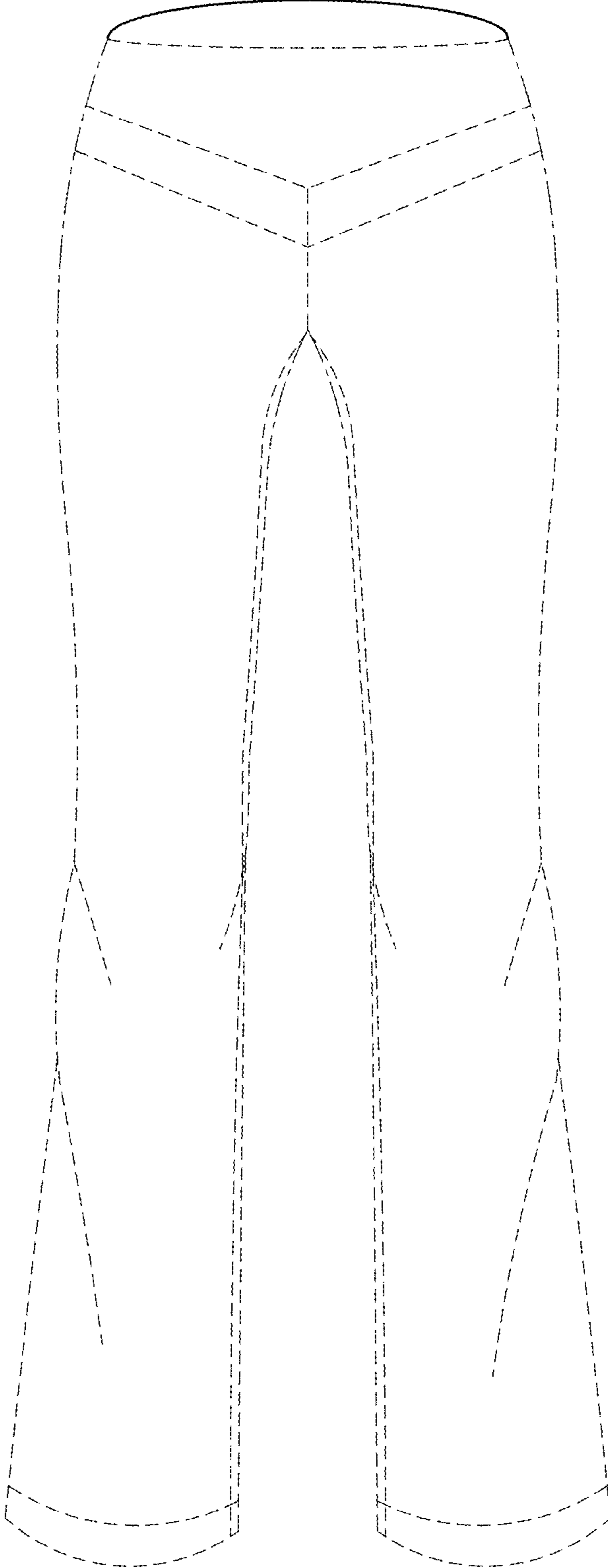

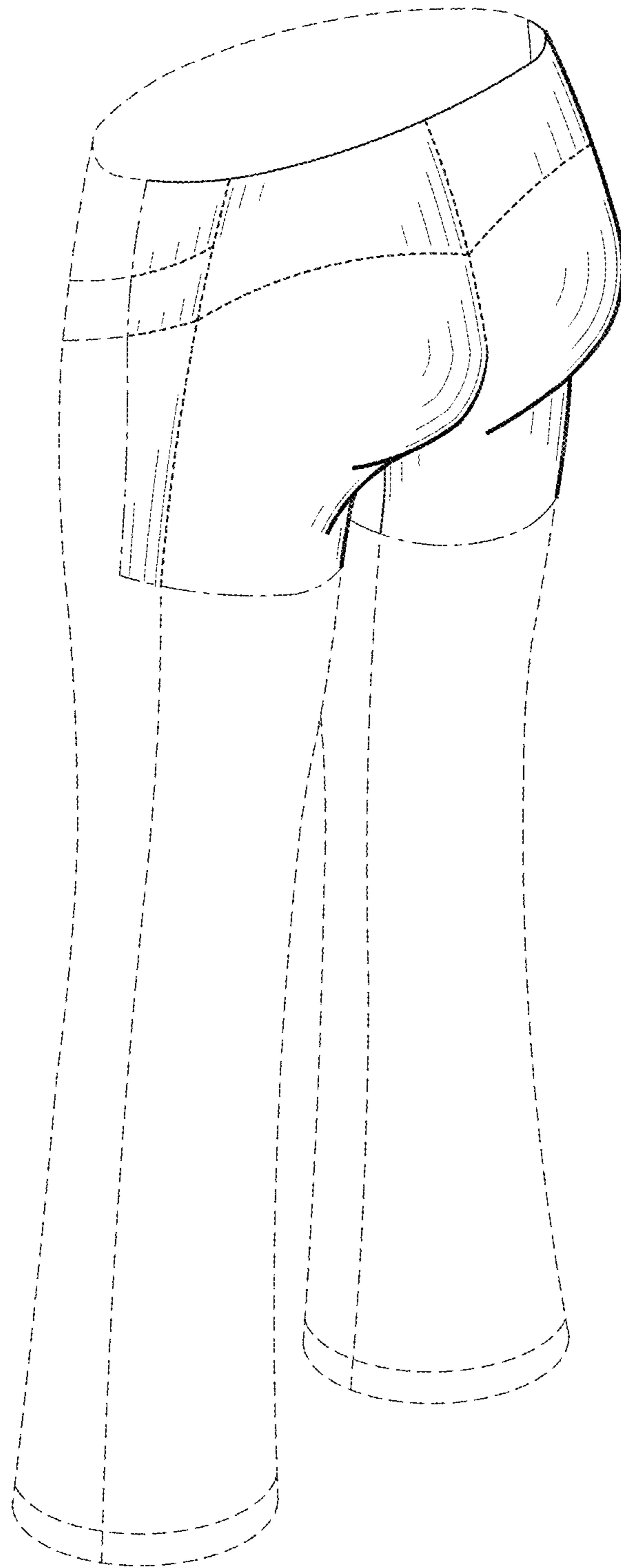
