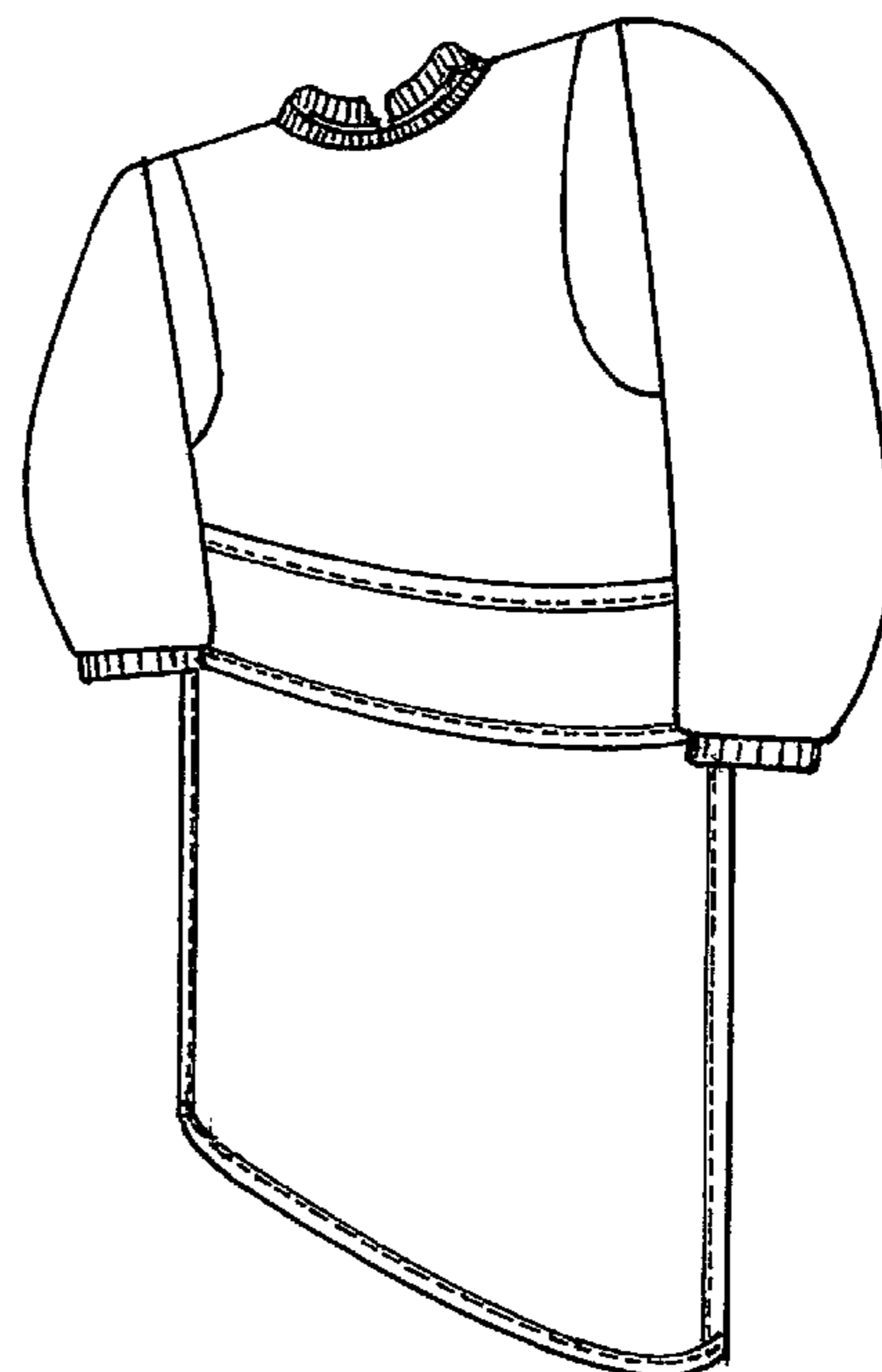
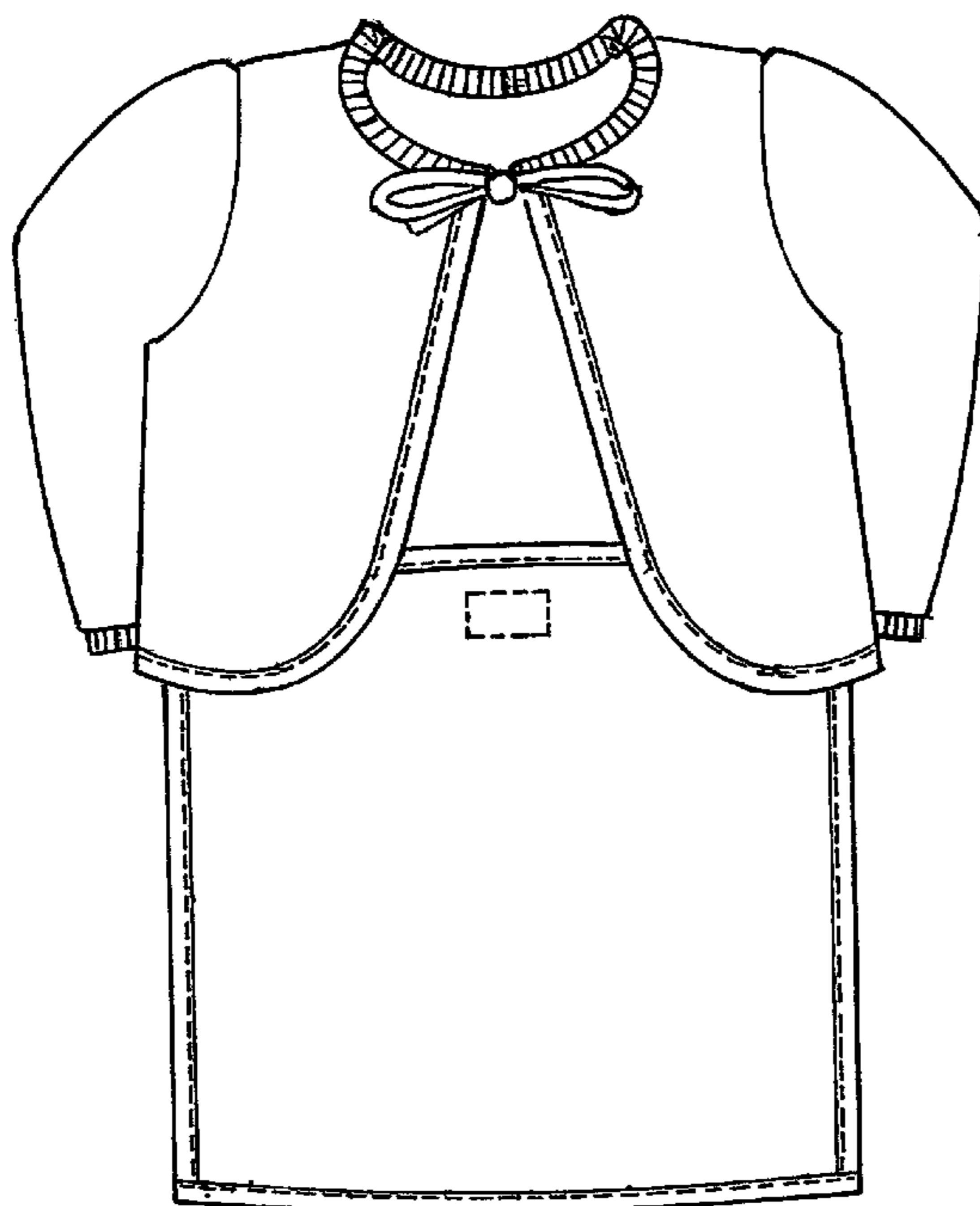
(57) **CLAIM**

The ornamental design for a combined bib with long sleeves and removable lap covering, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the combined bib with long sleeves and removable lap covering embodying my new design, FIG. 2 is a back view thereof, FIG. 3 is a left side view thereof, FIG. 4 is a right side view thereof, FIG. 5 is a top view thereof, FIG. 6 is a bottom view thereof, FIG. 7 is a perspective front view thereof; and, FIG. 8 is a sectional view in the direction of line 8-8 shown in FIG. 1 up to the stop line therein. The broken lines of FIGS. 1, 2, 3, 4, 7 and 8 show stitching on the combined bib with long sleeves and removable lap covering.

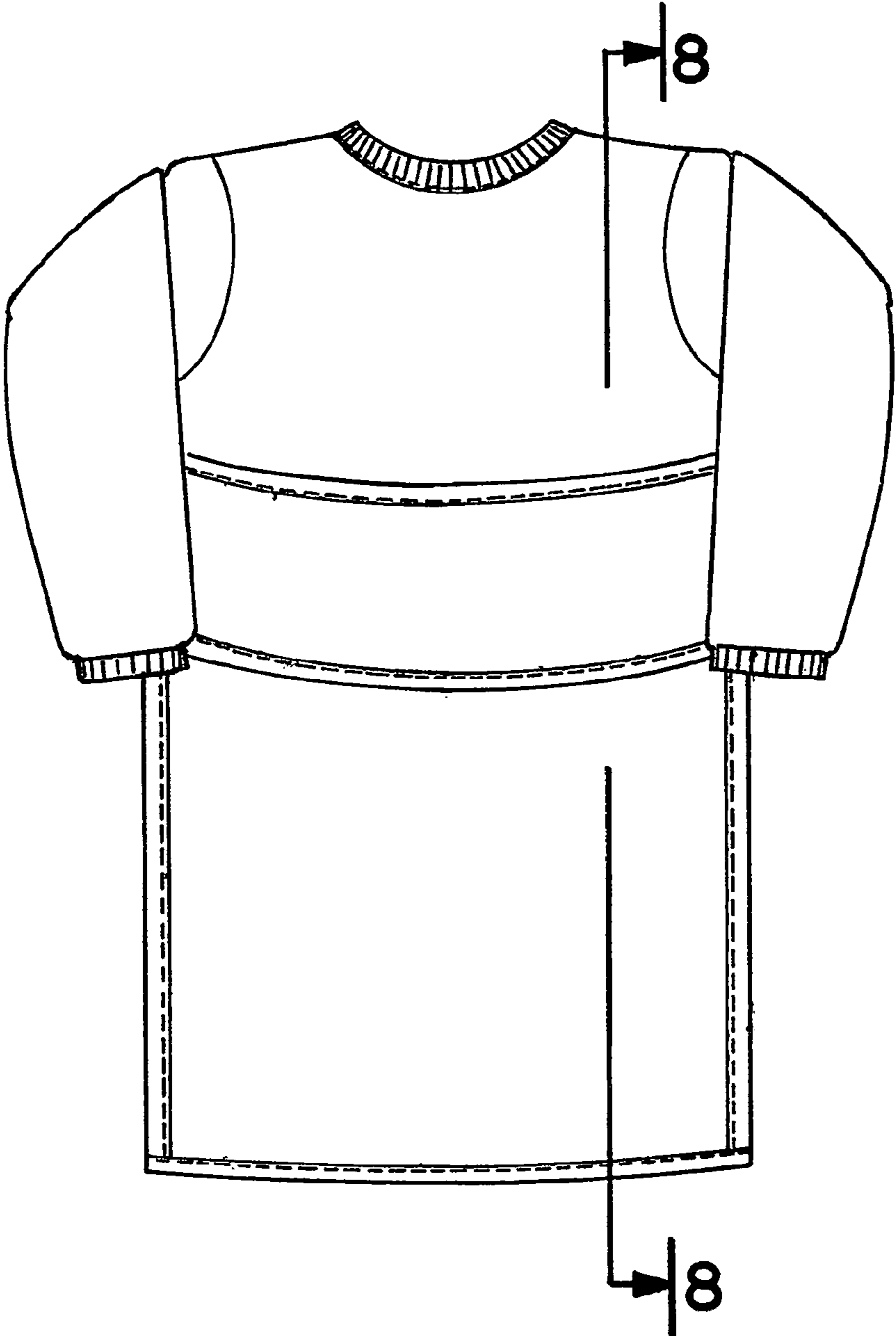

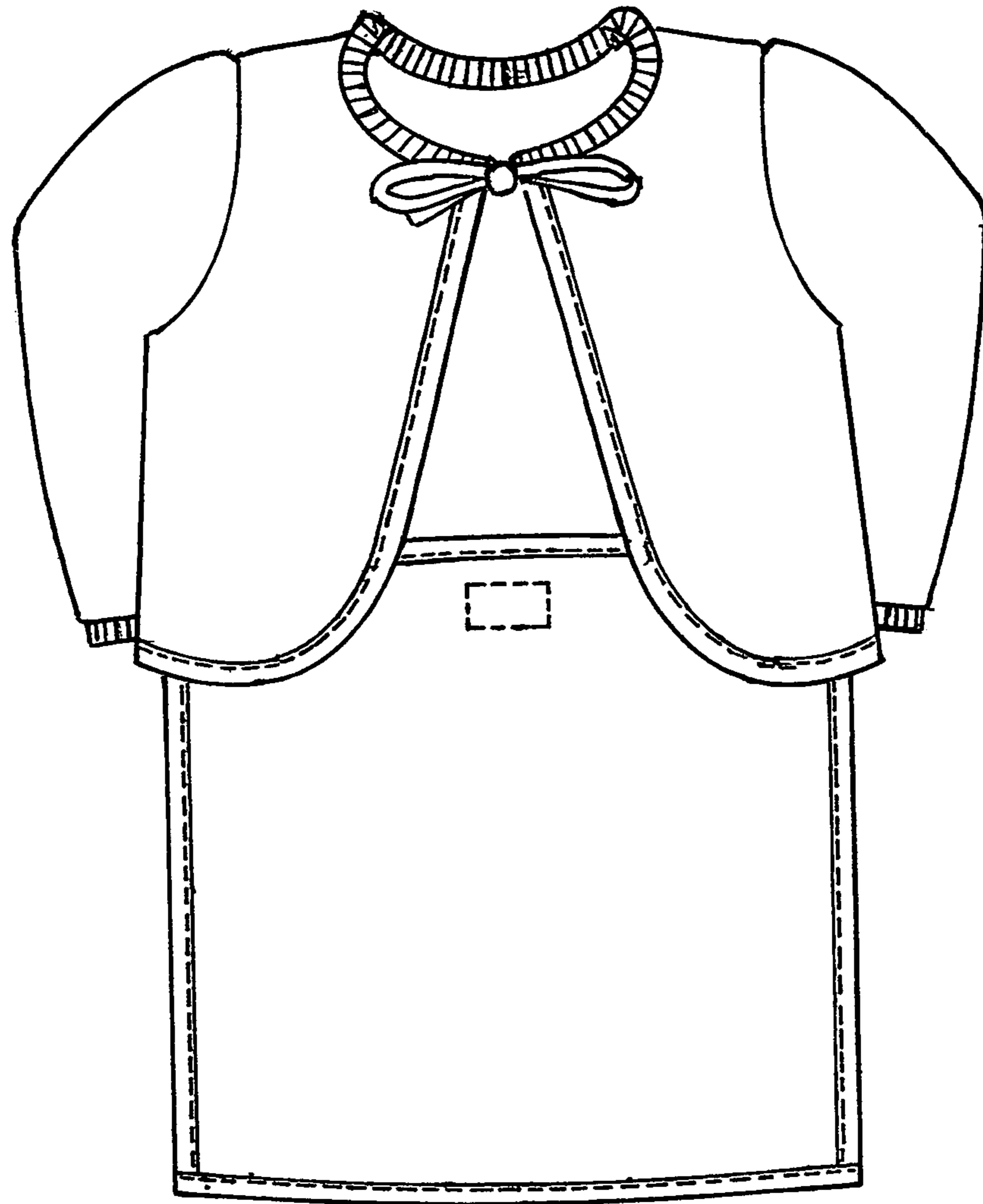

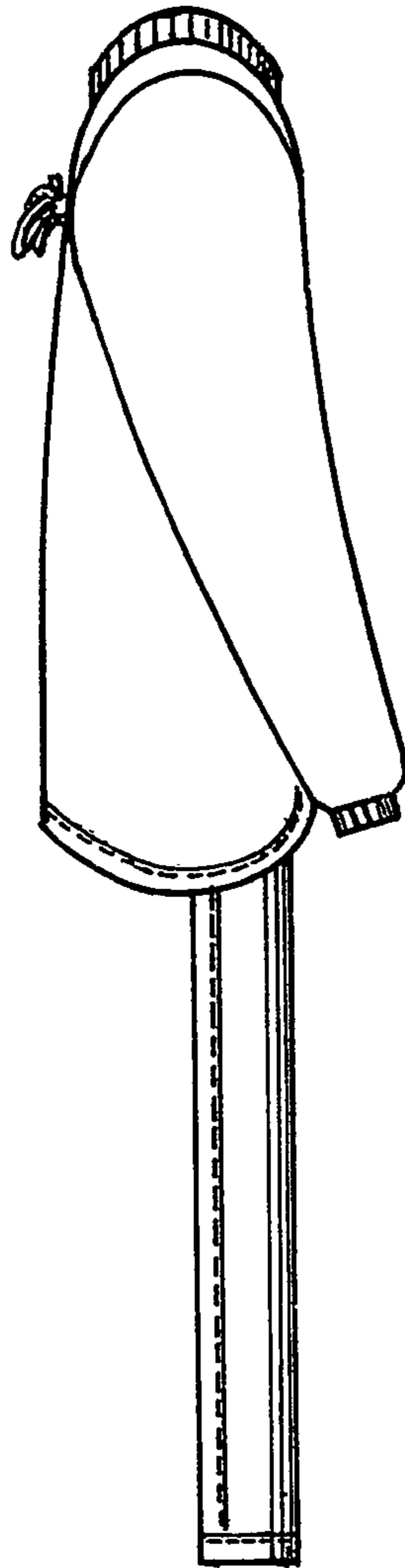

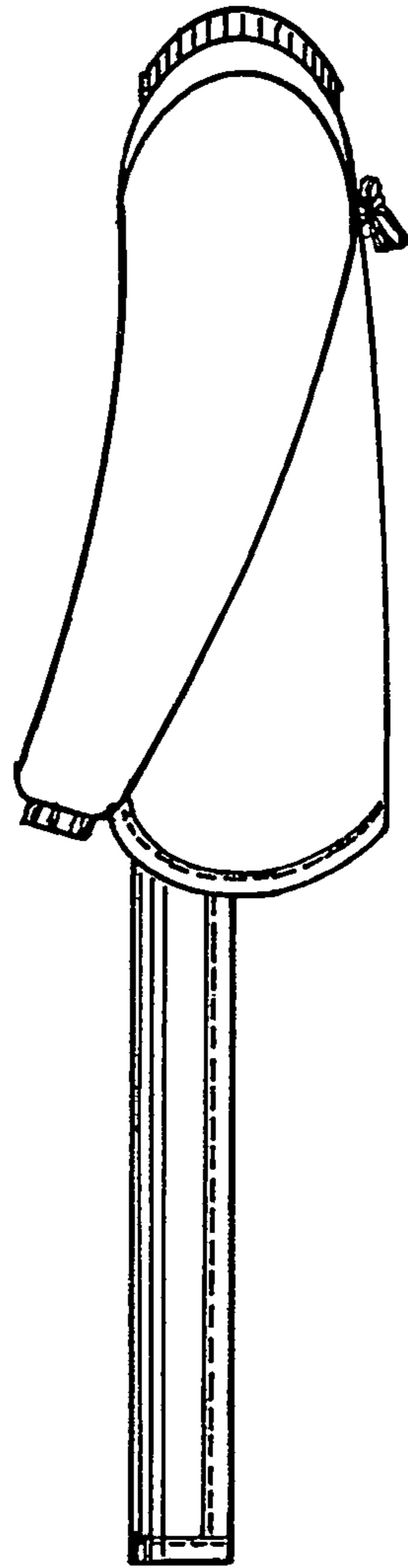

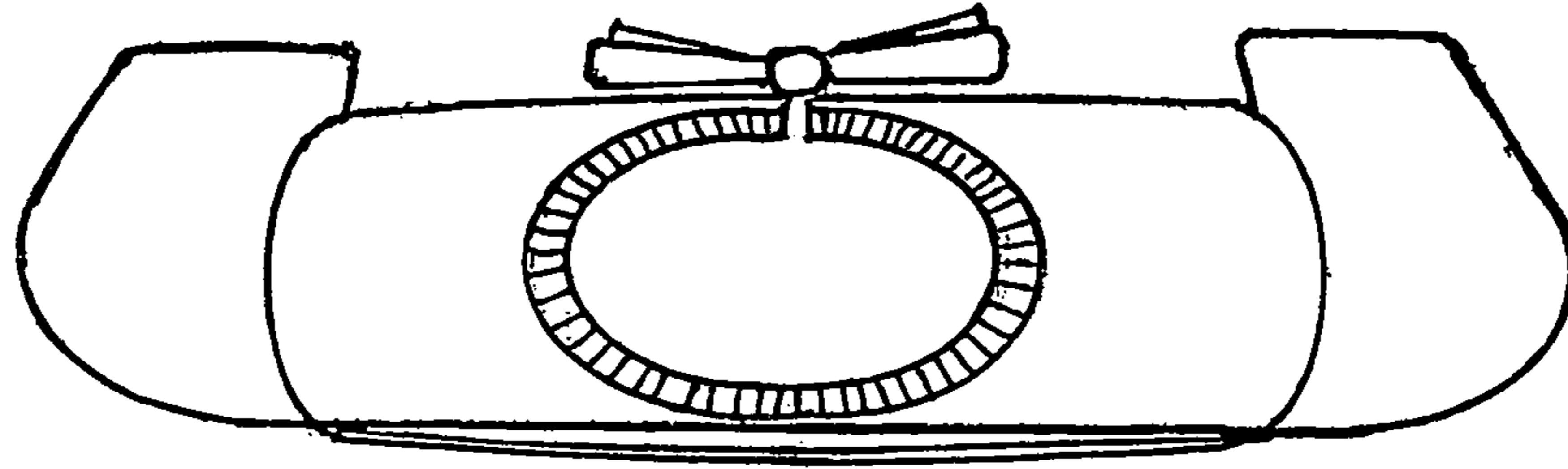

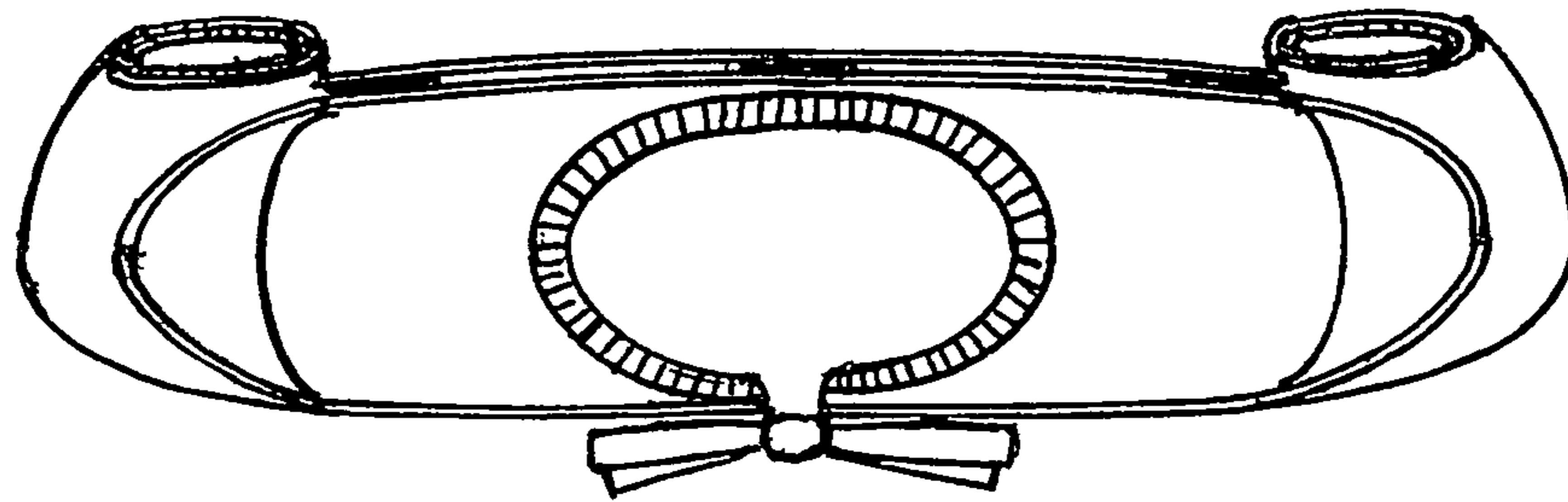

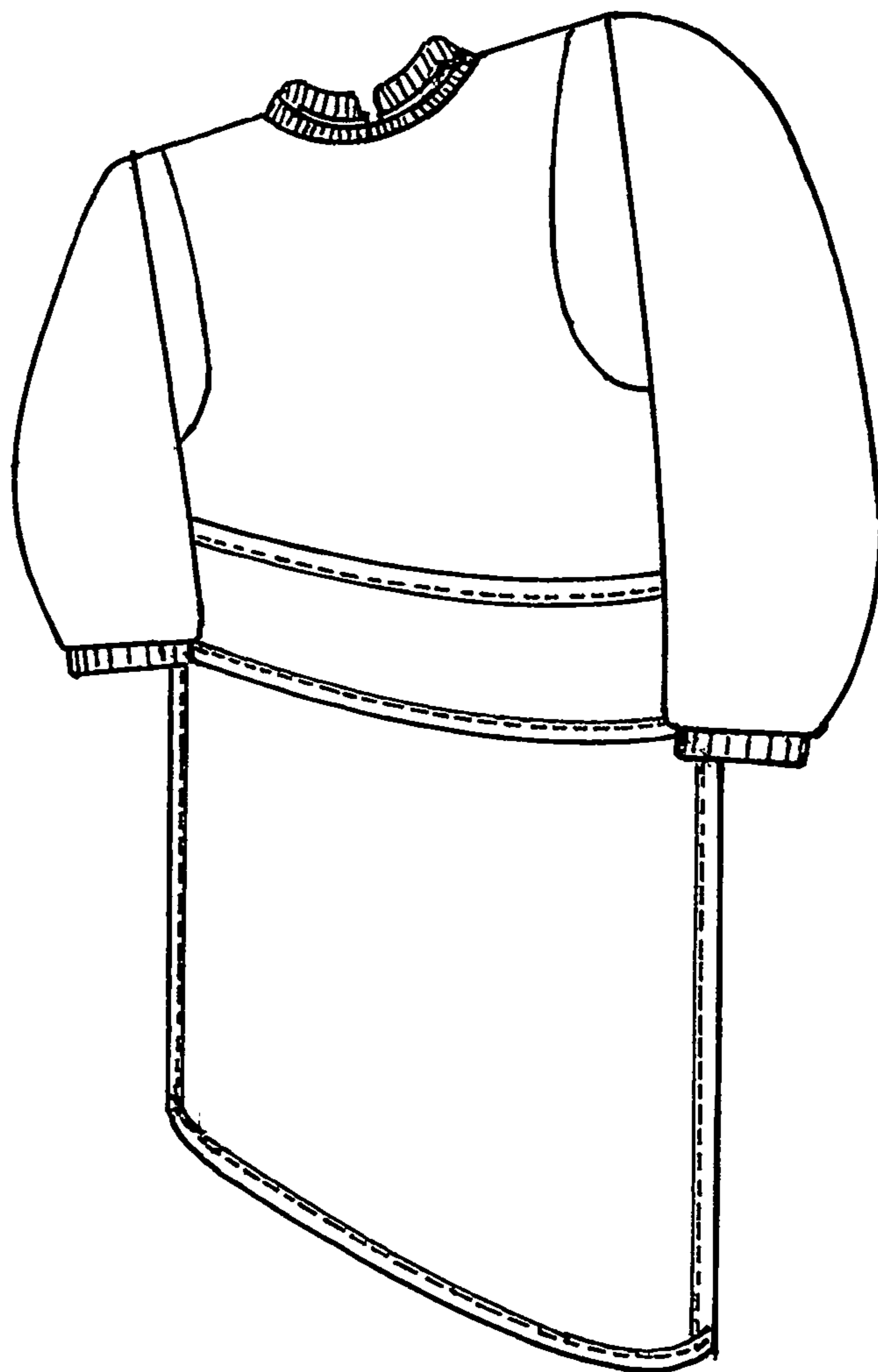

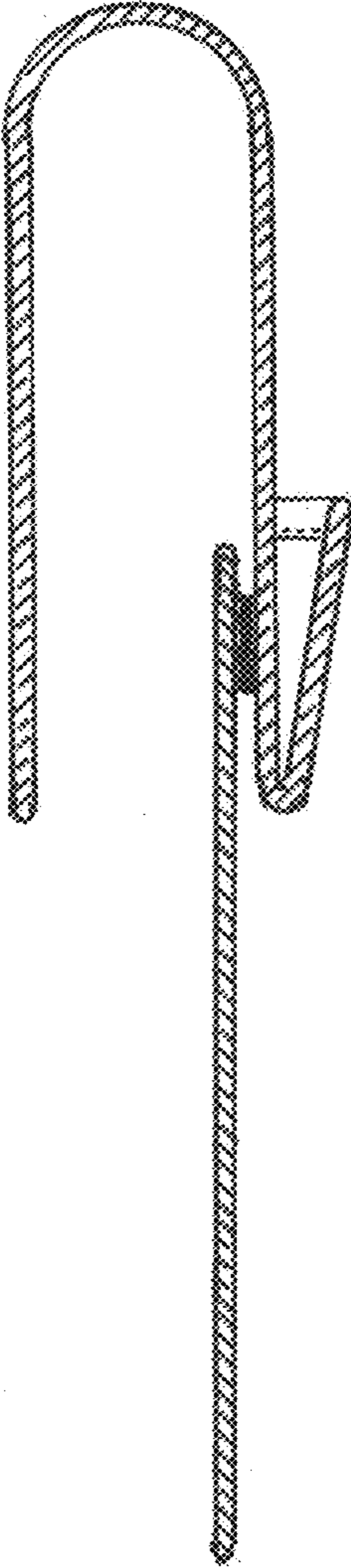
