(57) **CLAIM**

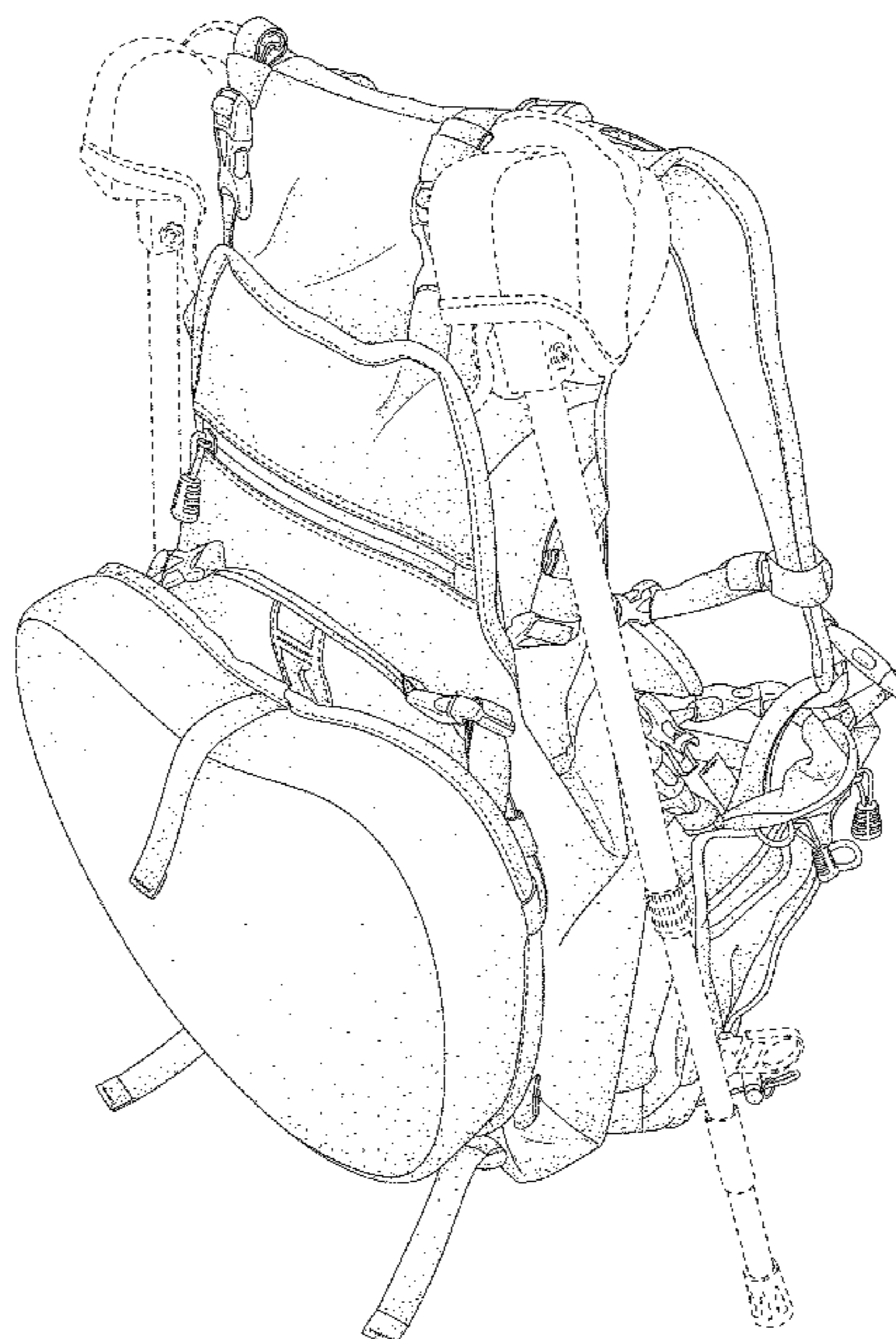
I claim the ornamental design for a turkey pack, as shown and described in FIGS. 1-7.

**DESCRIPTION**

FIG. 1 is a left-rear perspective view of the turkey pack; FIG. 2 is a rear view of the turkey pack shown in FIG. 1; FIG. 3 is a front view of the turkey pack shown in FIG. 1; FIG. 4 is a right-side view of the turkey pack shown in FIG. 1; FIG. 5 is a left-side view of the turkey pack shown in FIG. 1; FIG. 6 is a top view of the turkey pack shown in FIG. 1; and, FIG. 7 is a bottom view of the turkey pack shown in FIG. 1. Applicant expressly reserves the right to modify FIGS. 1-7 to include, in line drawing format, any one or all of the features shown (i.e., shown in either dashed-lines or solid lines) in FIGS. 1-7.

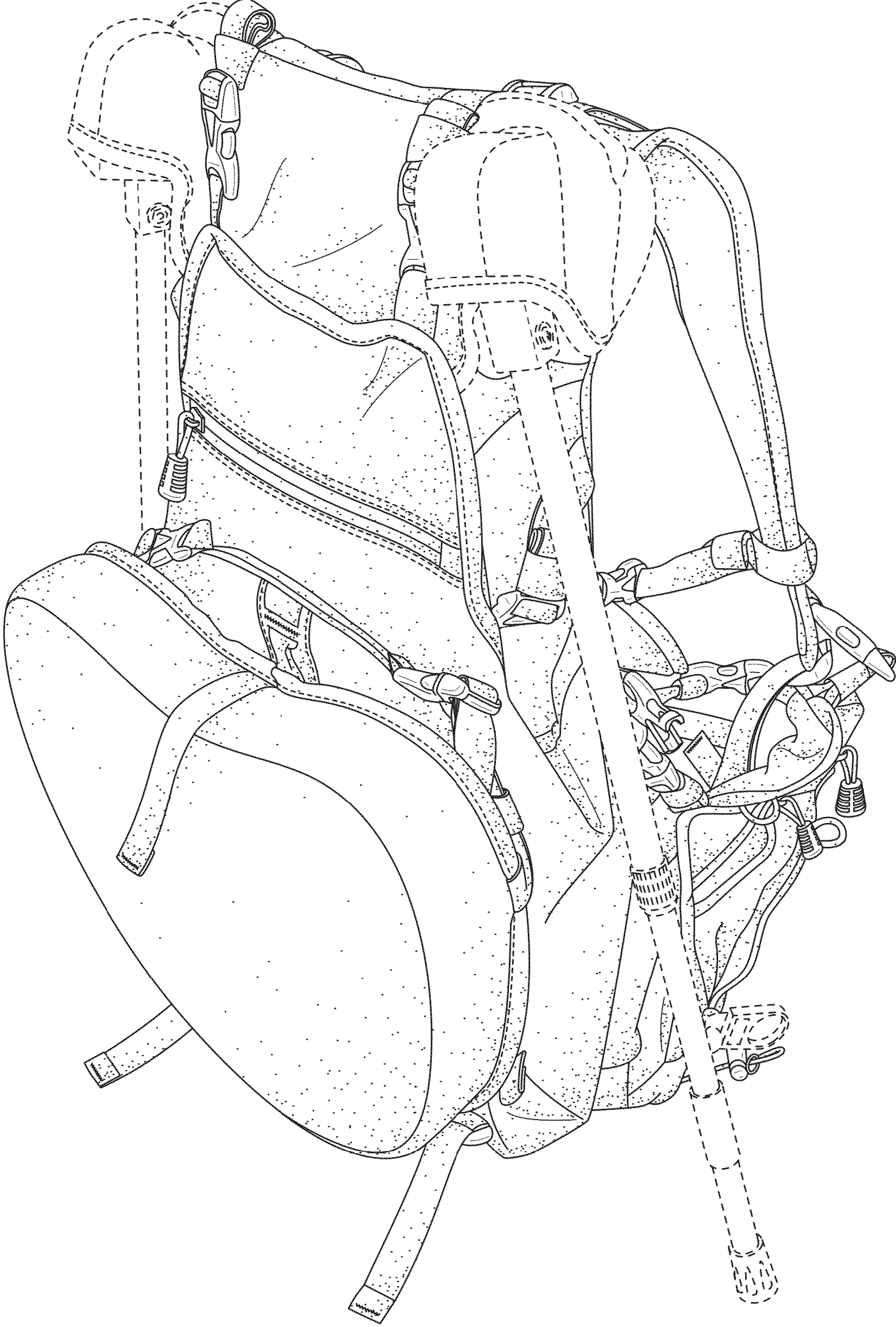

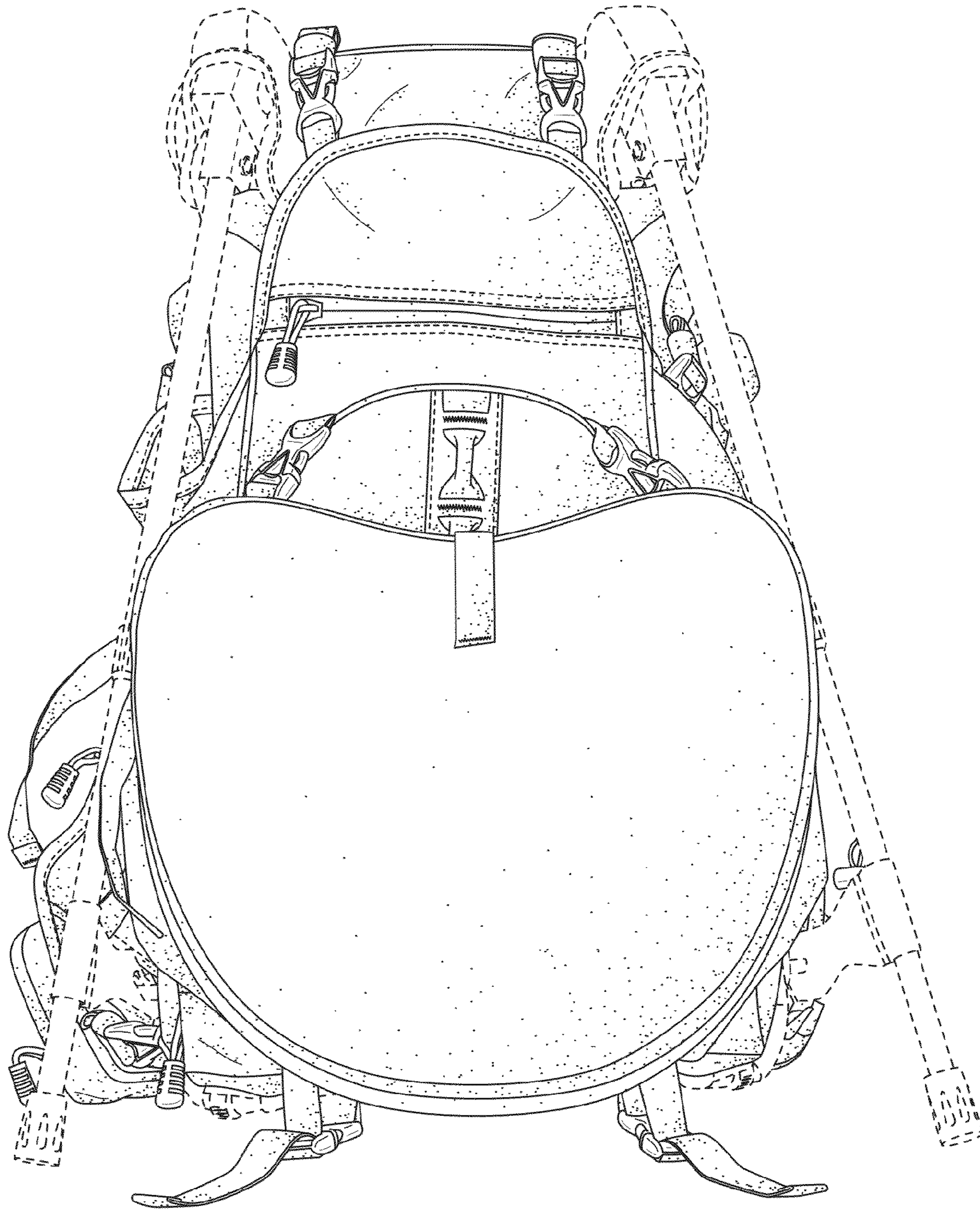

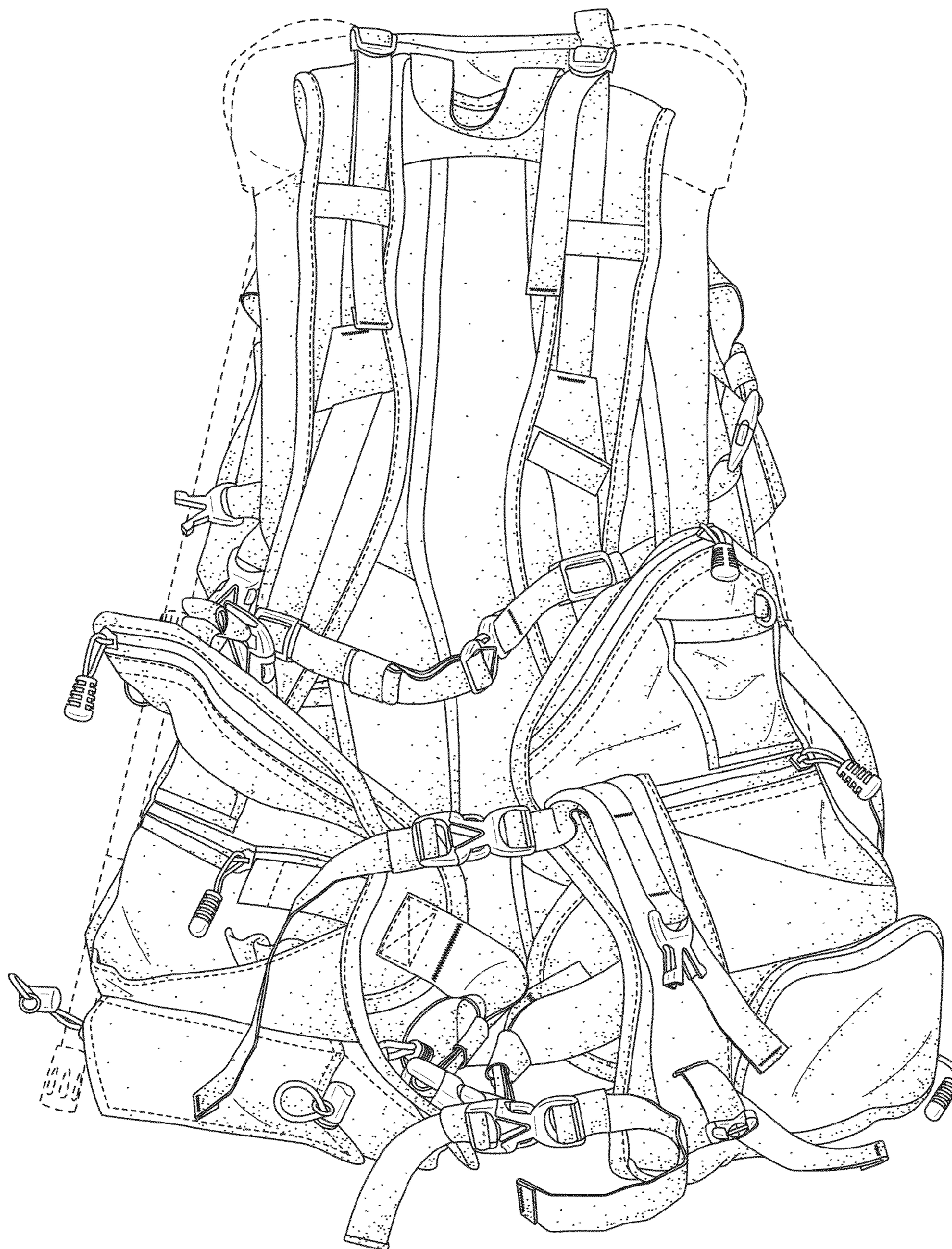

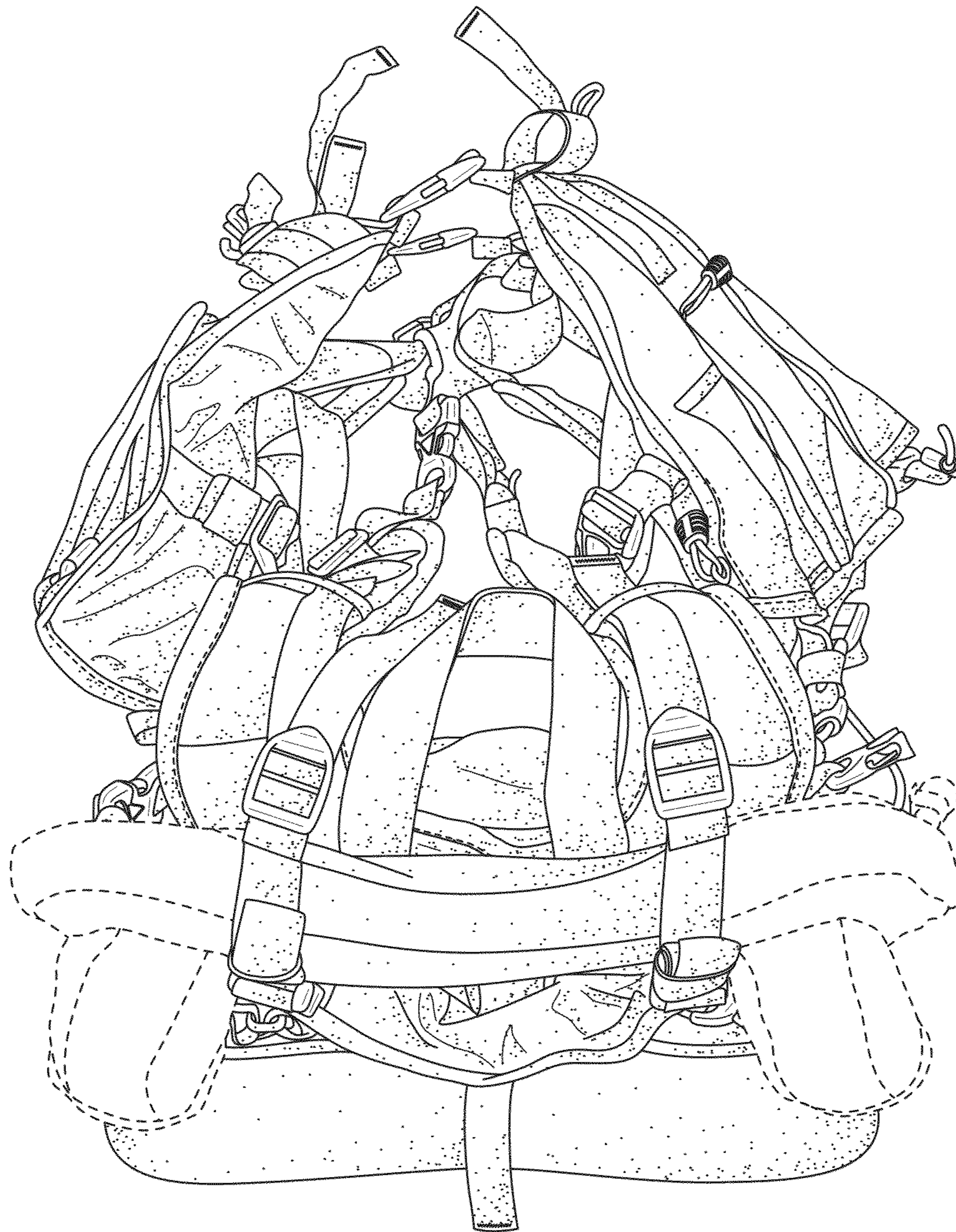

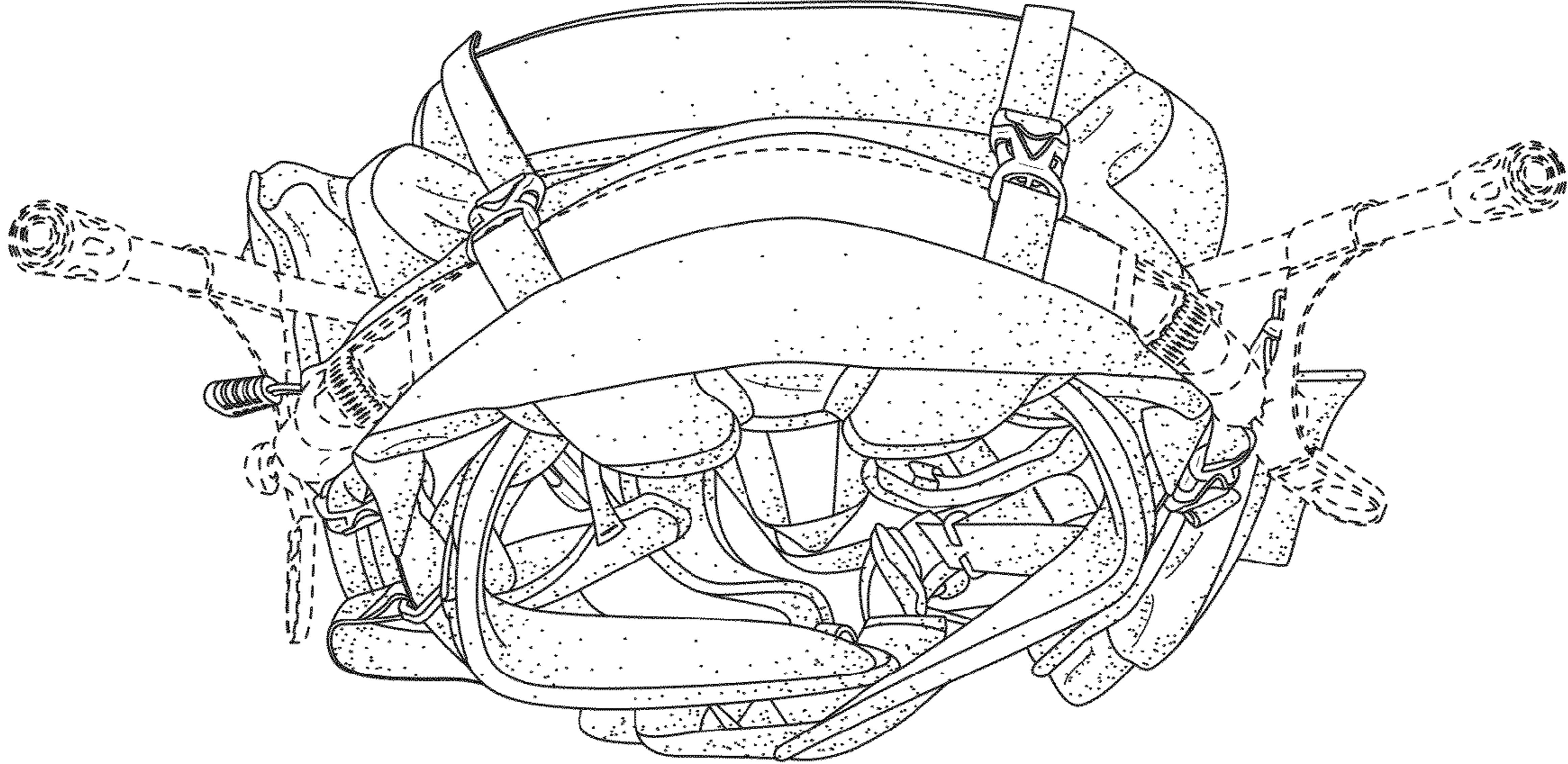
