(57) **CLAIM**

The ornamental design for an automotive vehicle seat with ornamental beading, as shown and described.

DESCRIPTION

FIG. 1 is a front, side, perspective view of an automotive vehicle seat with ornamental beading showing our new design;

FIG. 2 is an enlarged detail view at 2 in FIG. 1 of ornamental beading used in our new design;

FIG. 3 is a further enlarged detail view in cross-section, at 3-3 in FIG. 1, of an ornamental beading of our new design;

FIG. 4 is a front view of an automotive vehicle seat with ornamental beading showing our new design;

FIG. 5 is a rear view thereof;

FIG. 6 is a left side view thereof;

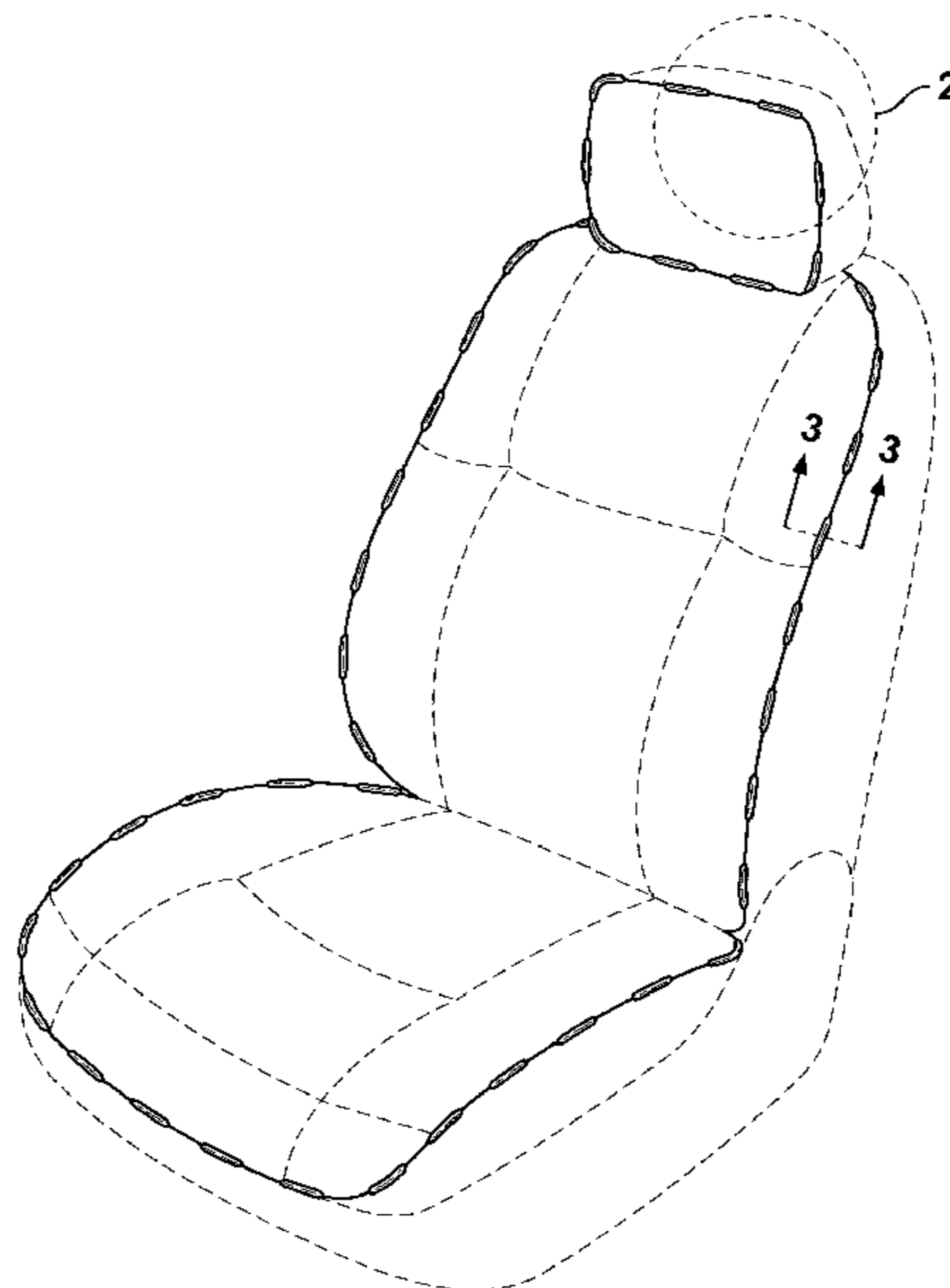
FIG. 7 is a right side view thereof;

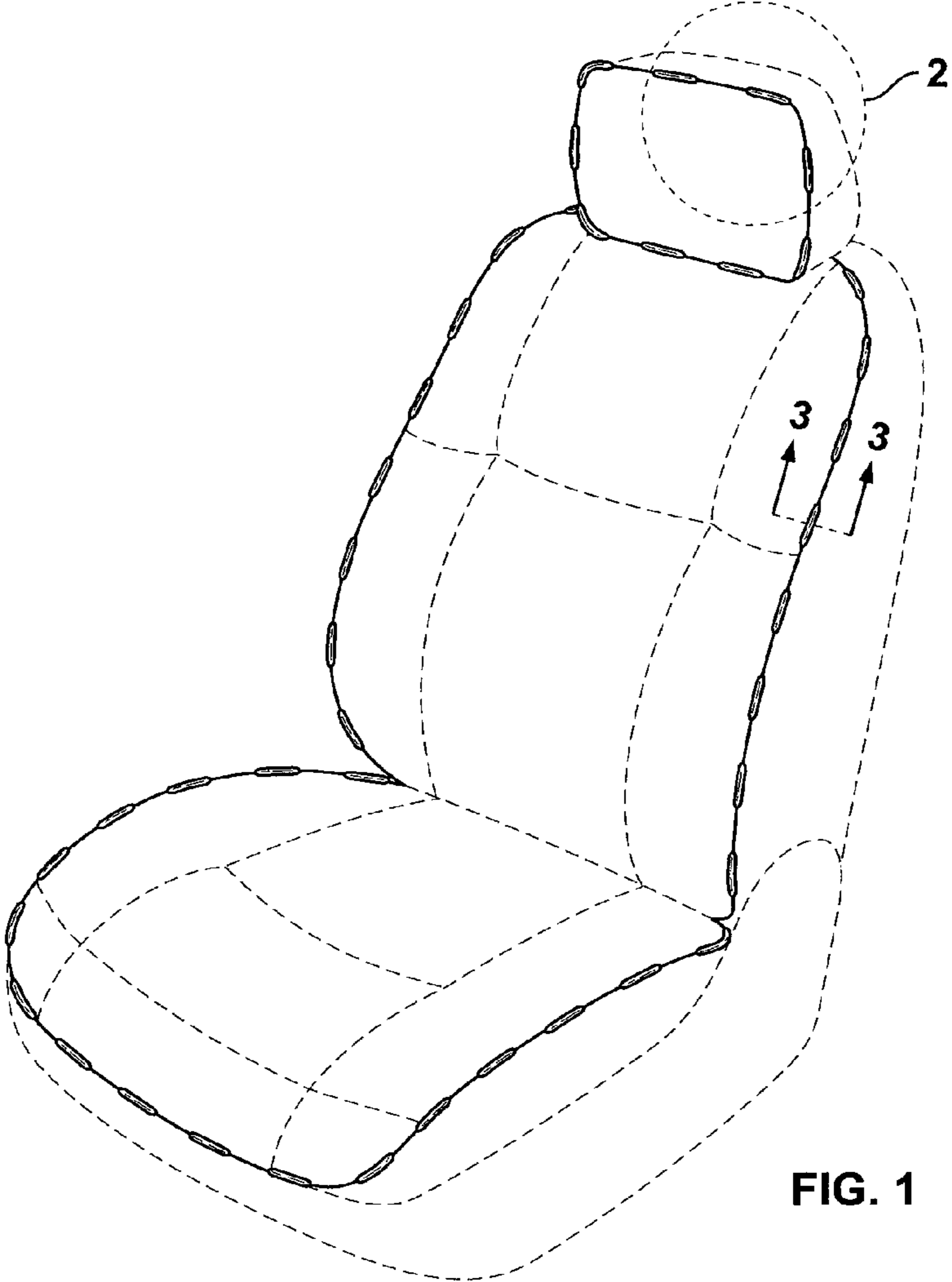

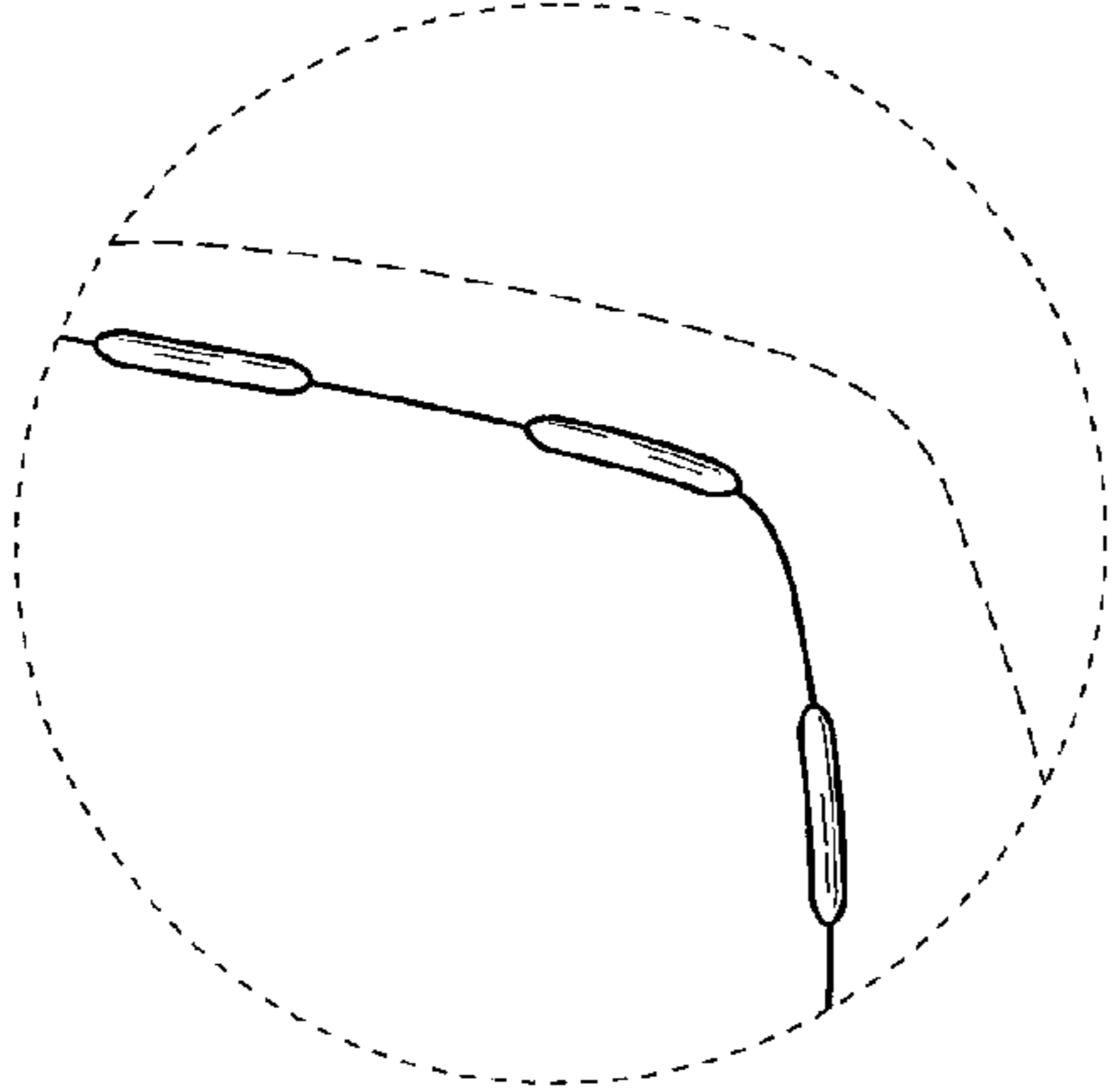

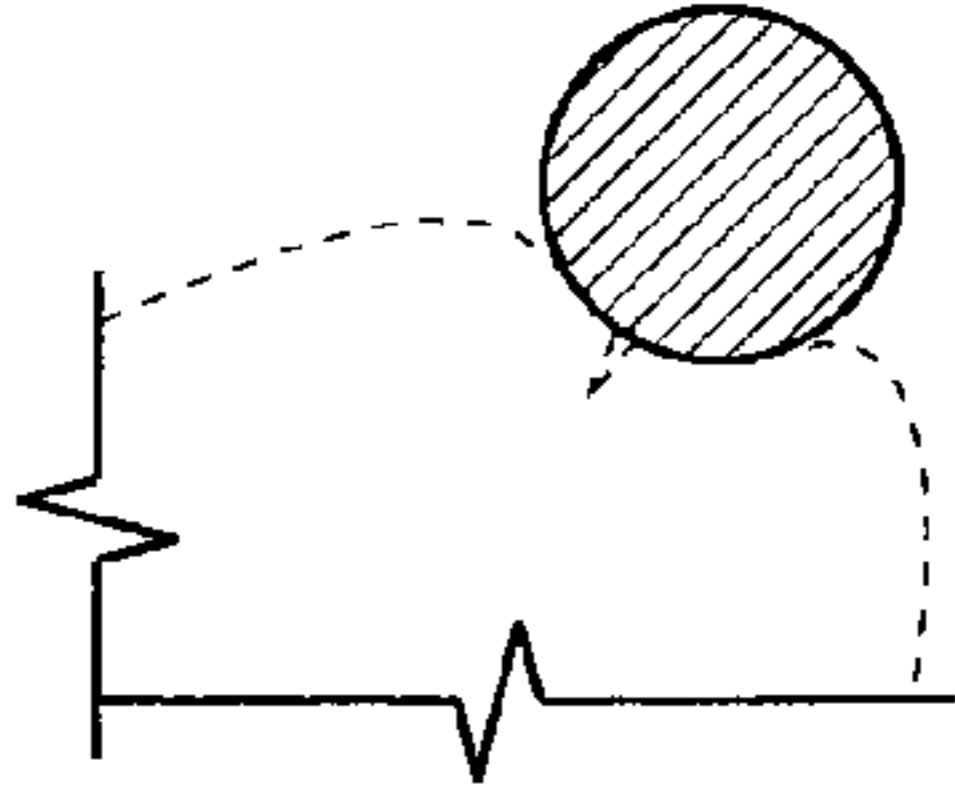

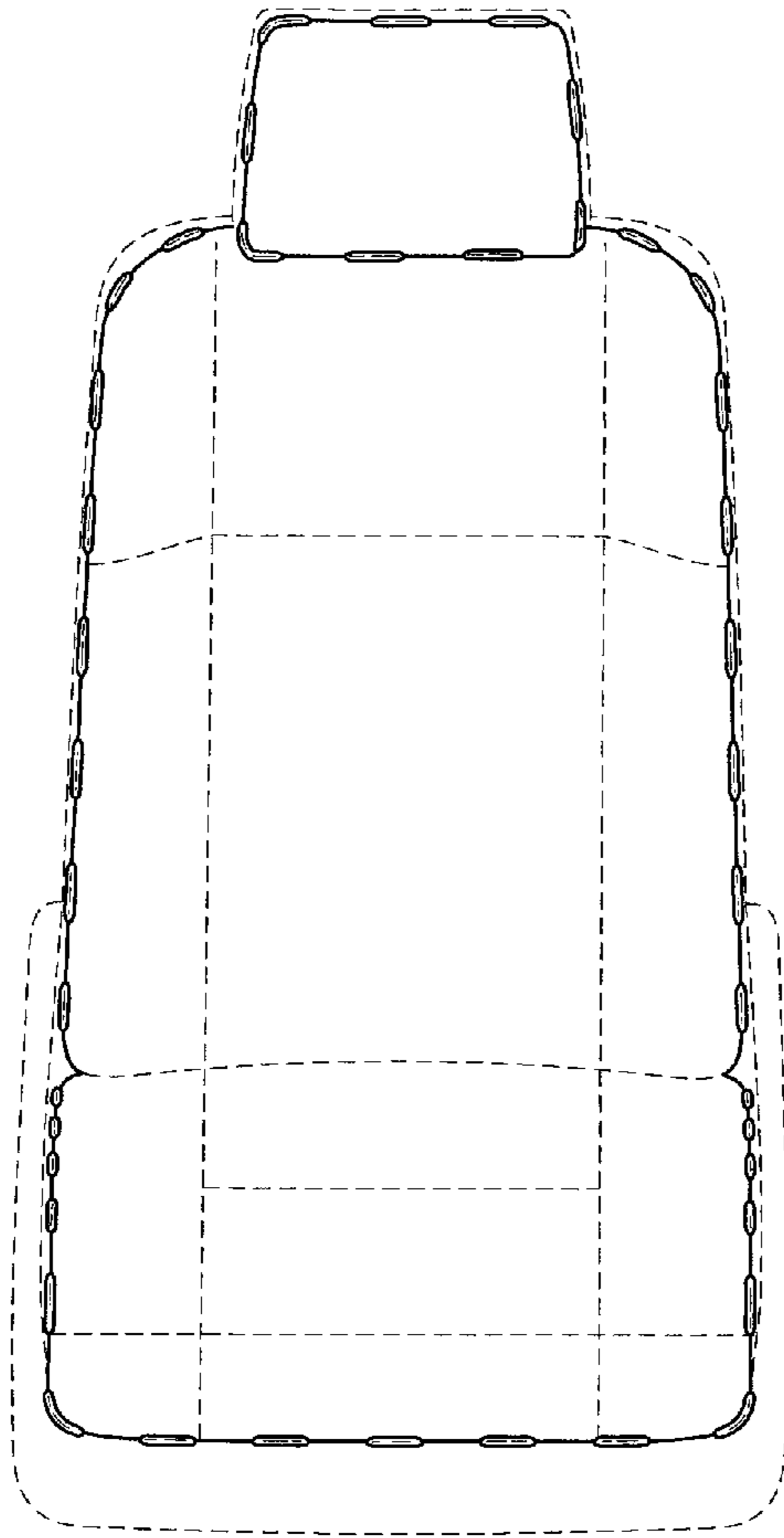

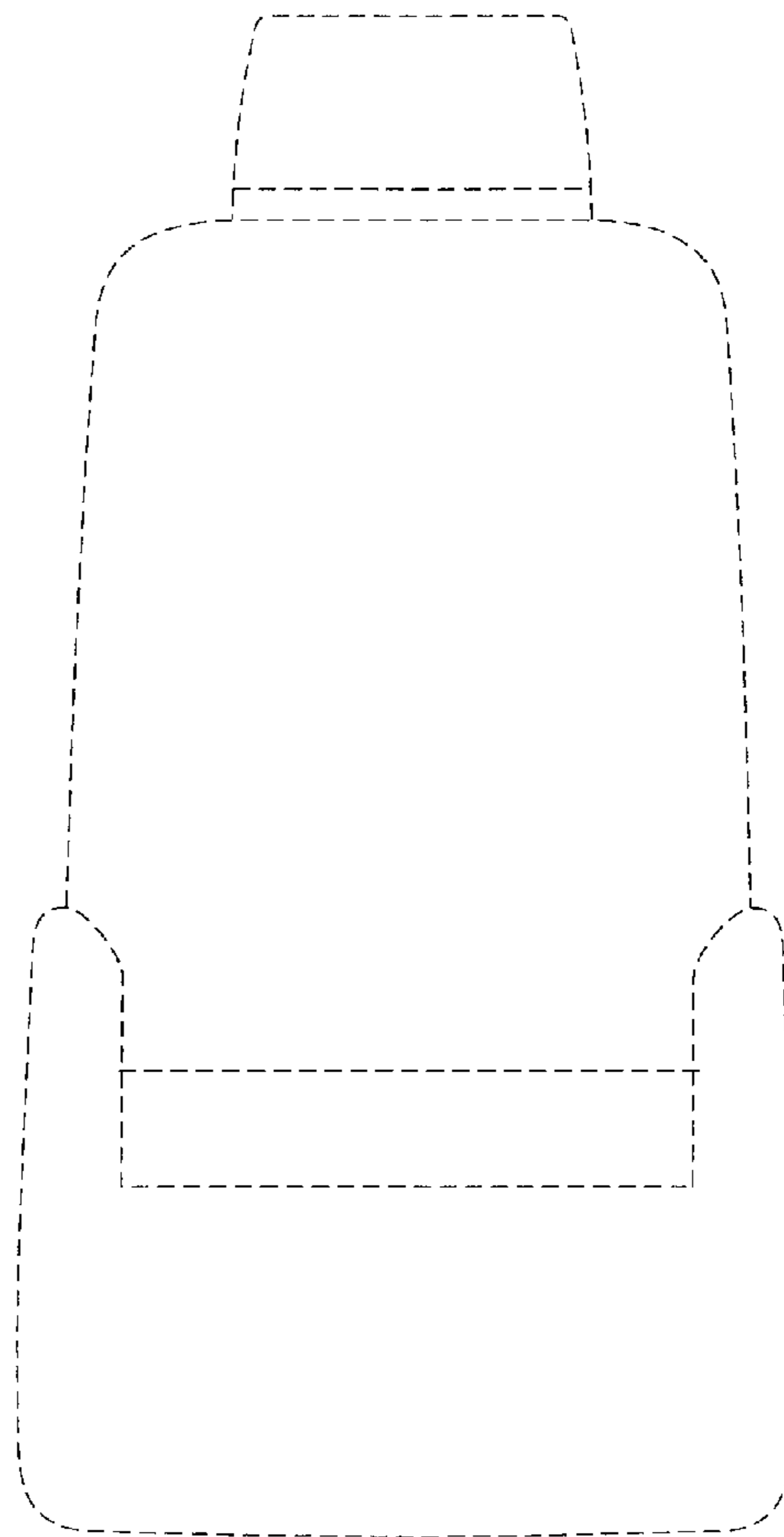

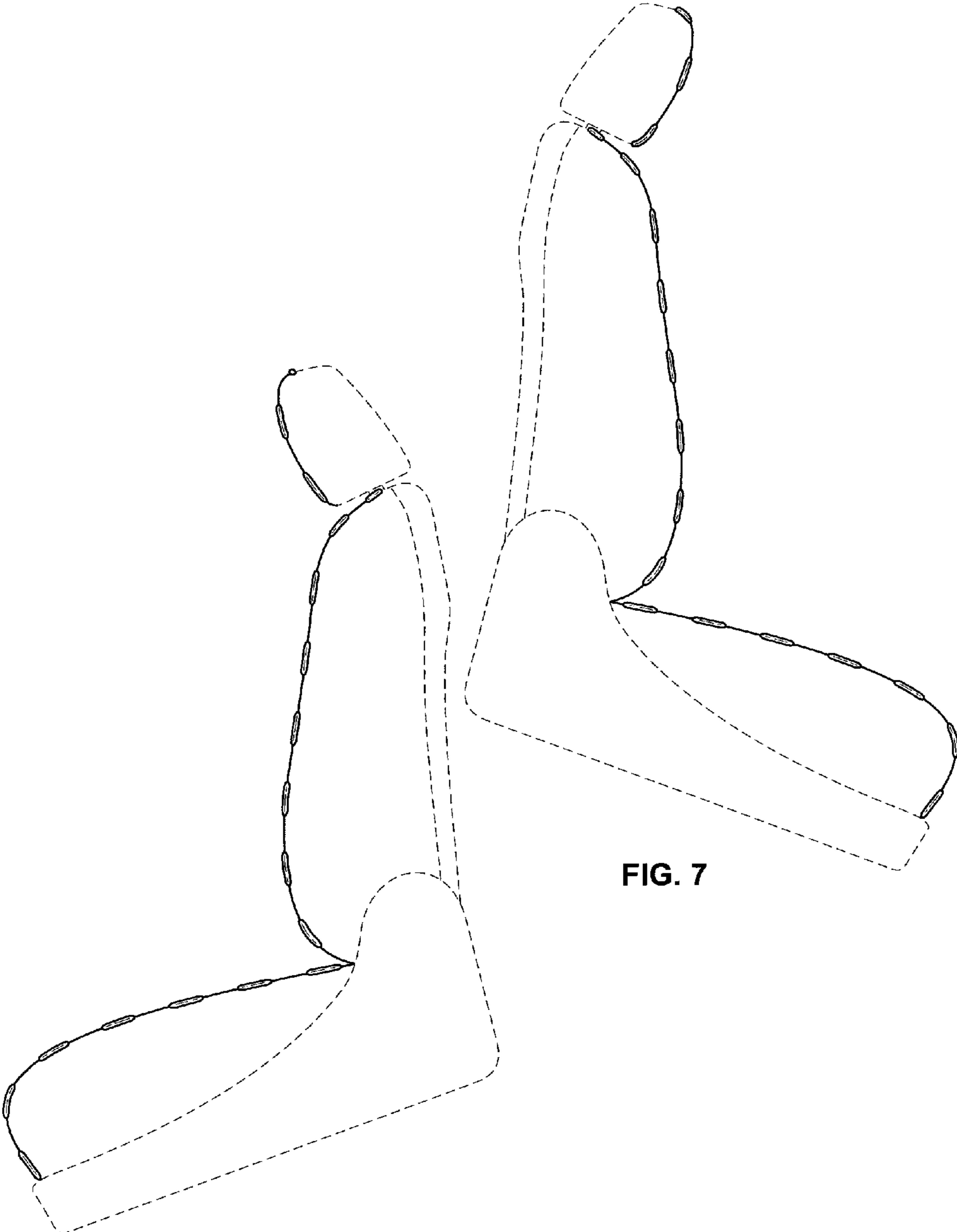

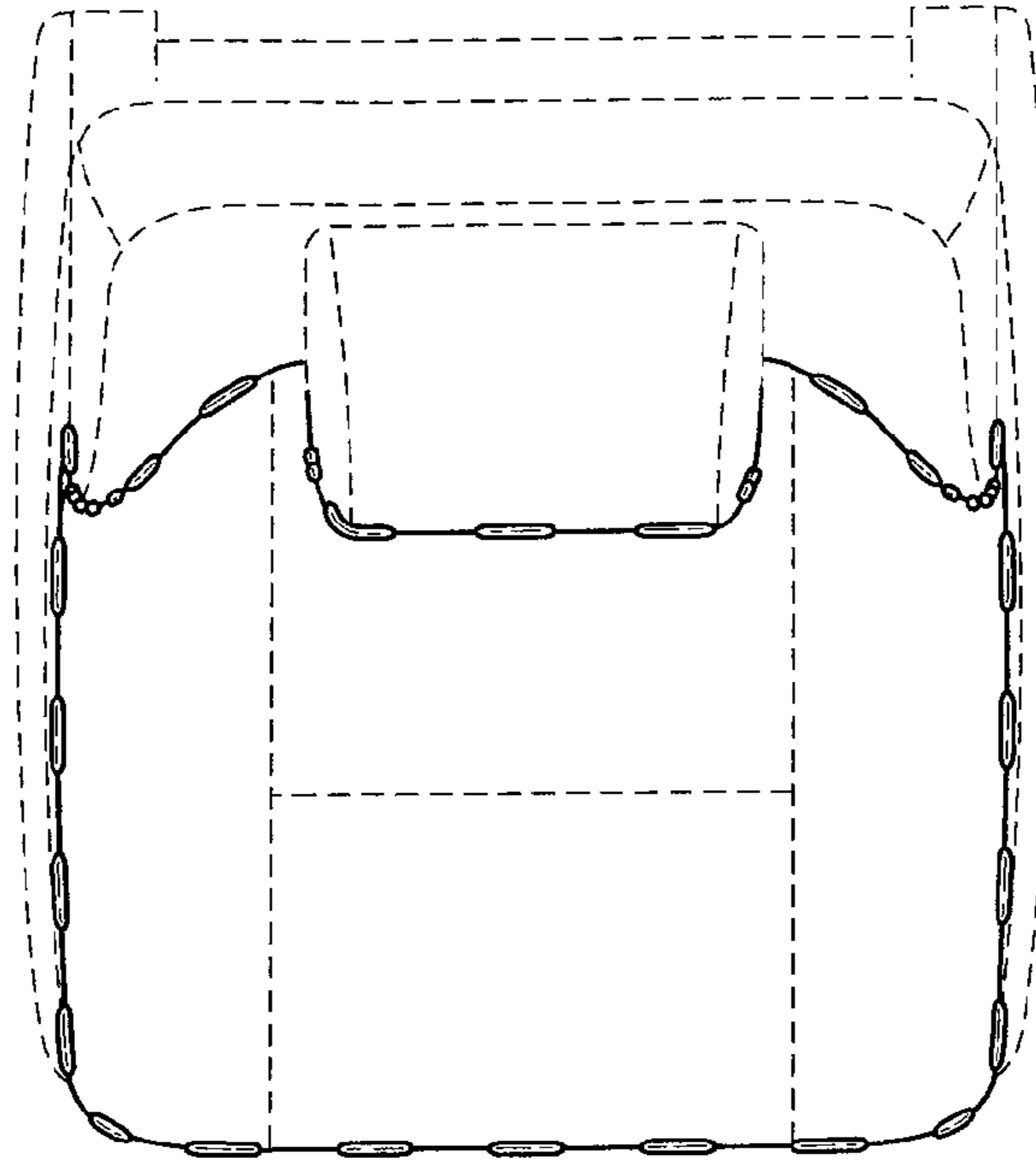

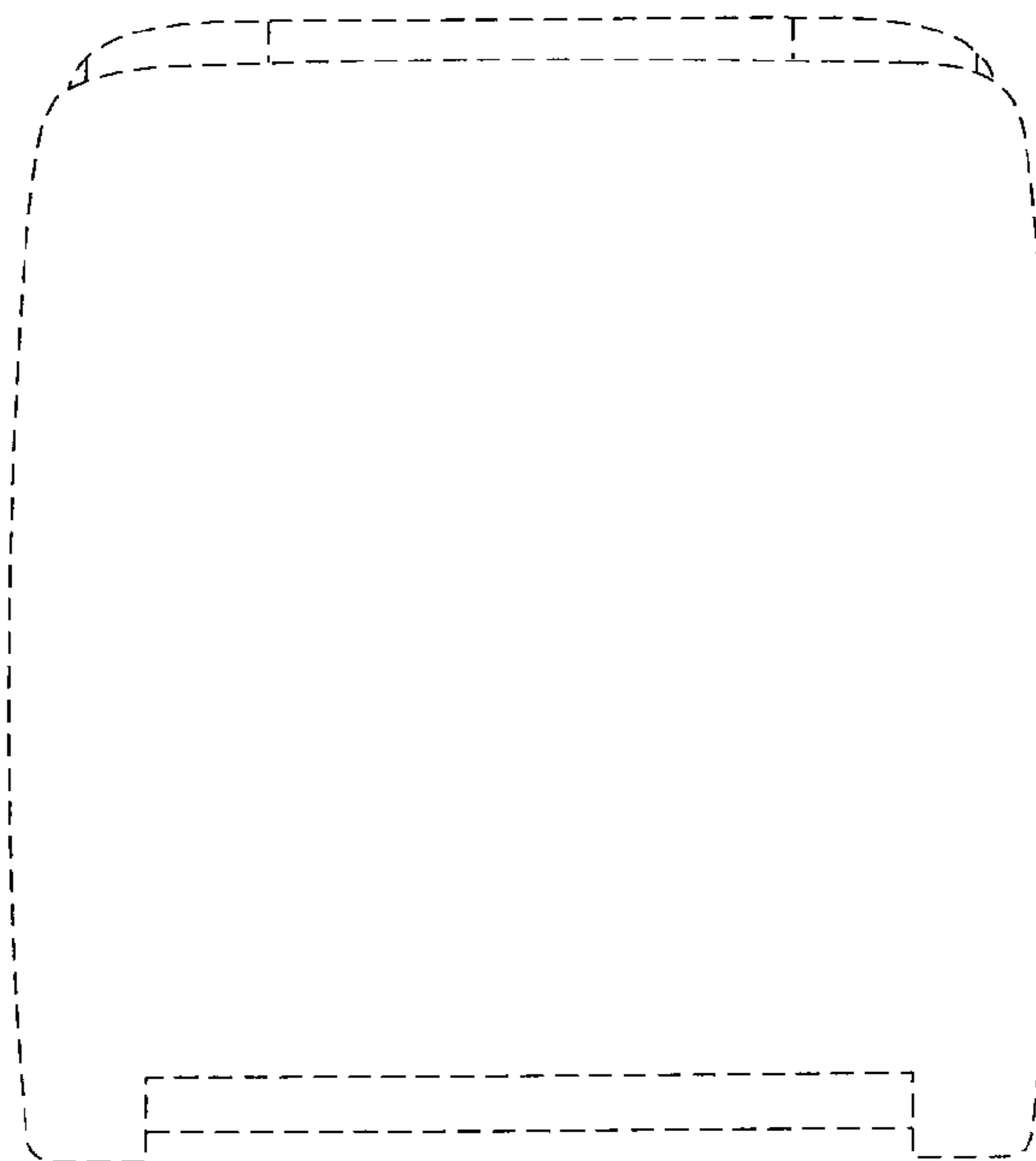
