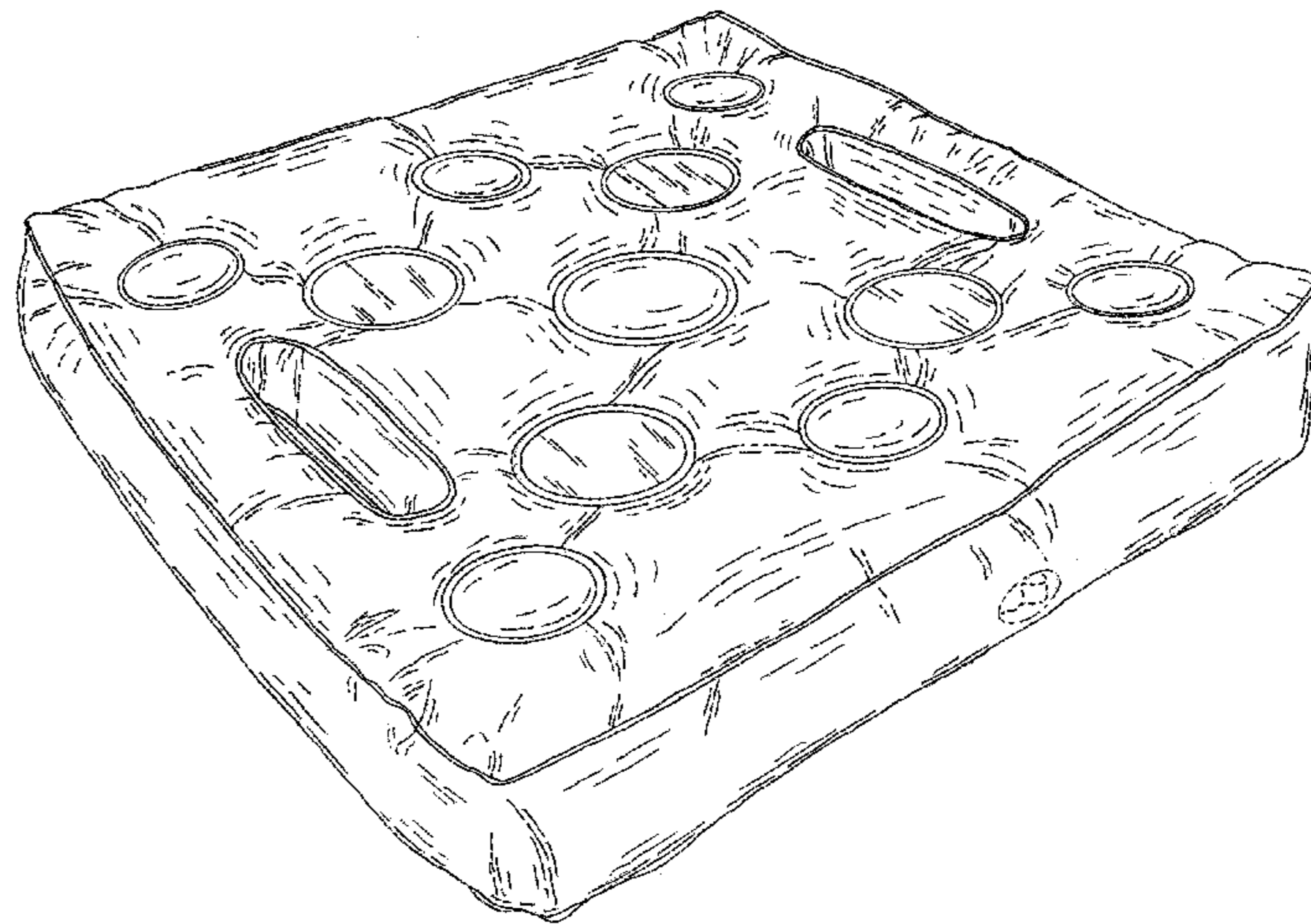
(57) **CLAIM**

The ornamental design for a seat cushion, as shown.

DESCRIPTION

FIG. 1 is a bottom perspective view of a seat cushion showing my new design;
FIG. 2 is a bottom view thereof;
FIG. 3 is a front view thereof; the rear view being a mirror image thereto;
FIG. 4 is a side view thereof, the opposite side being a mirror image thereto;
FIG. 5 is a perspective view thereof; and,
FIG. 6 is a top view thereof.
The broken (dash-dot) lines shown in figures illustrate unclaimed structural features that form no part of the claimed design.

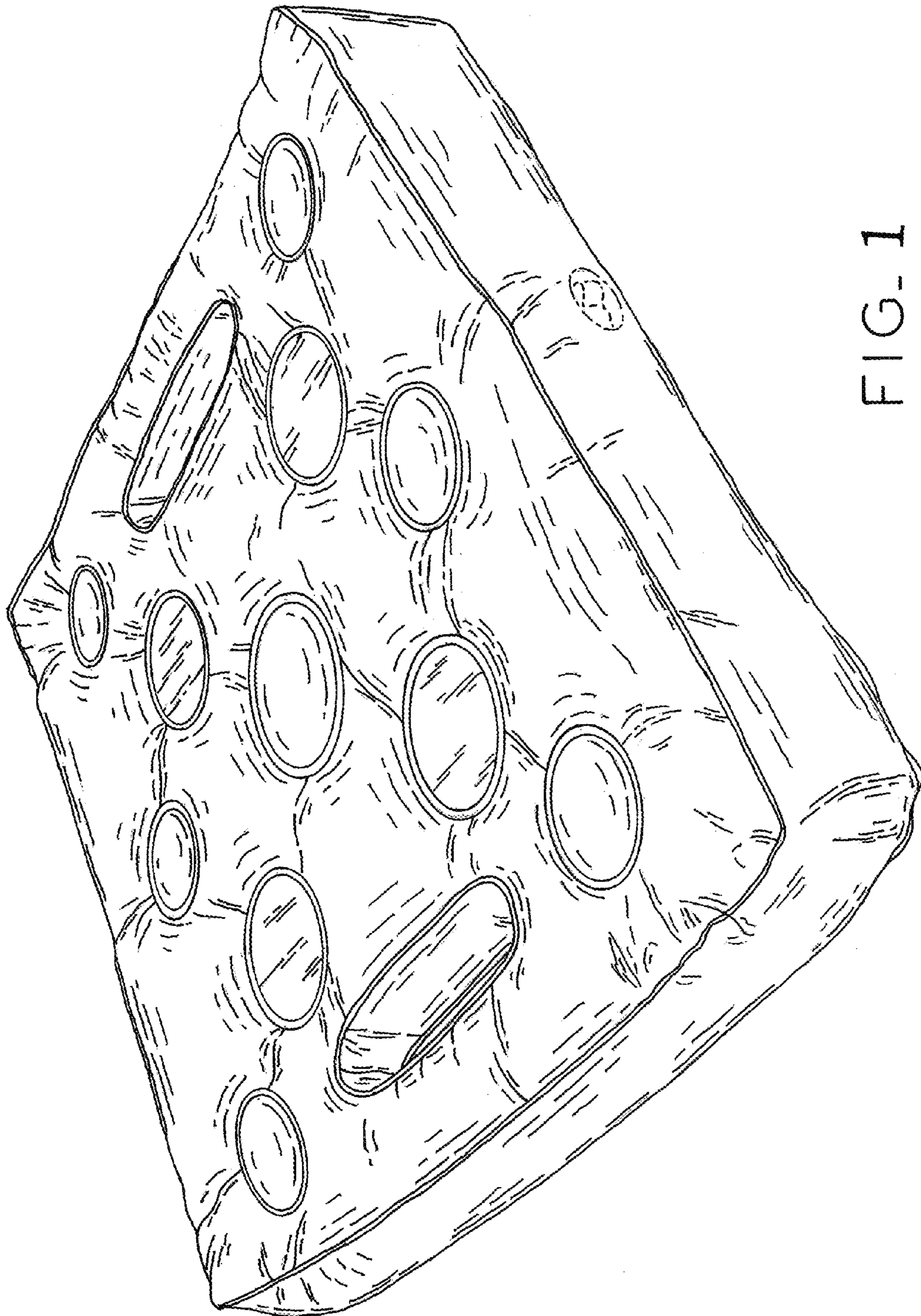

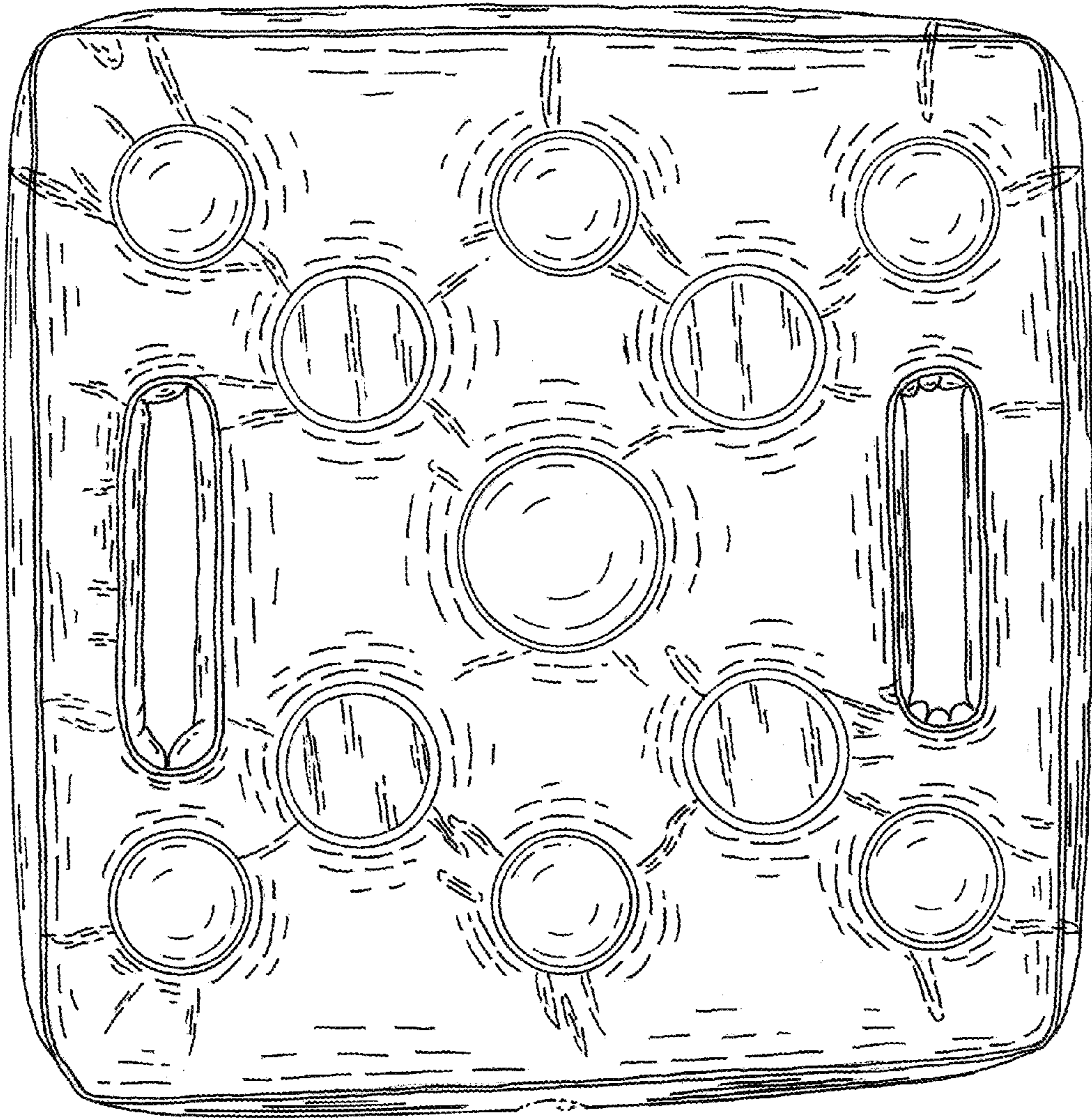

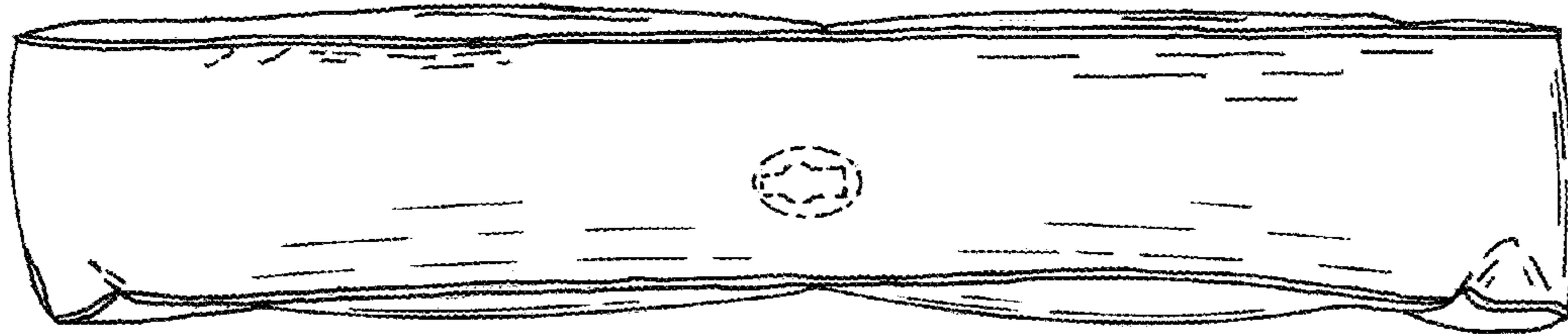

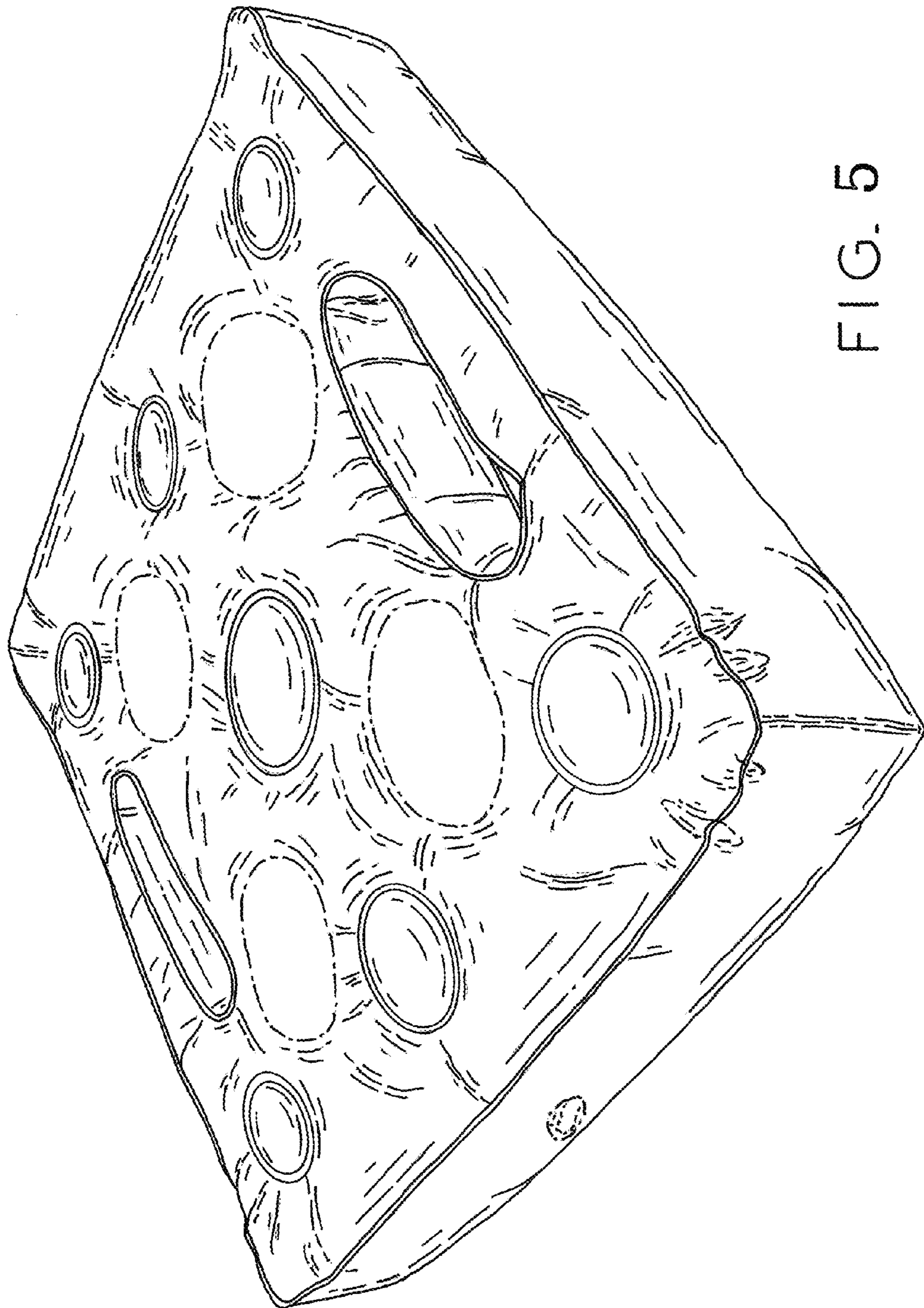

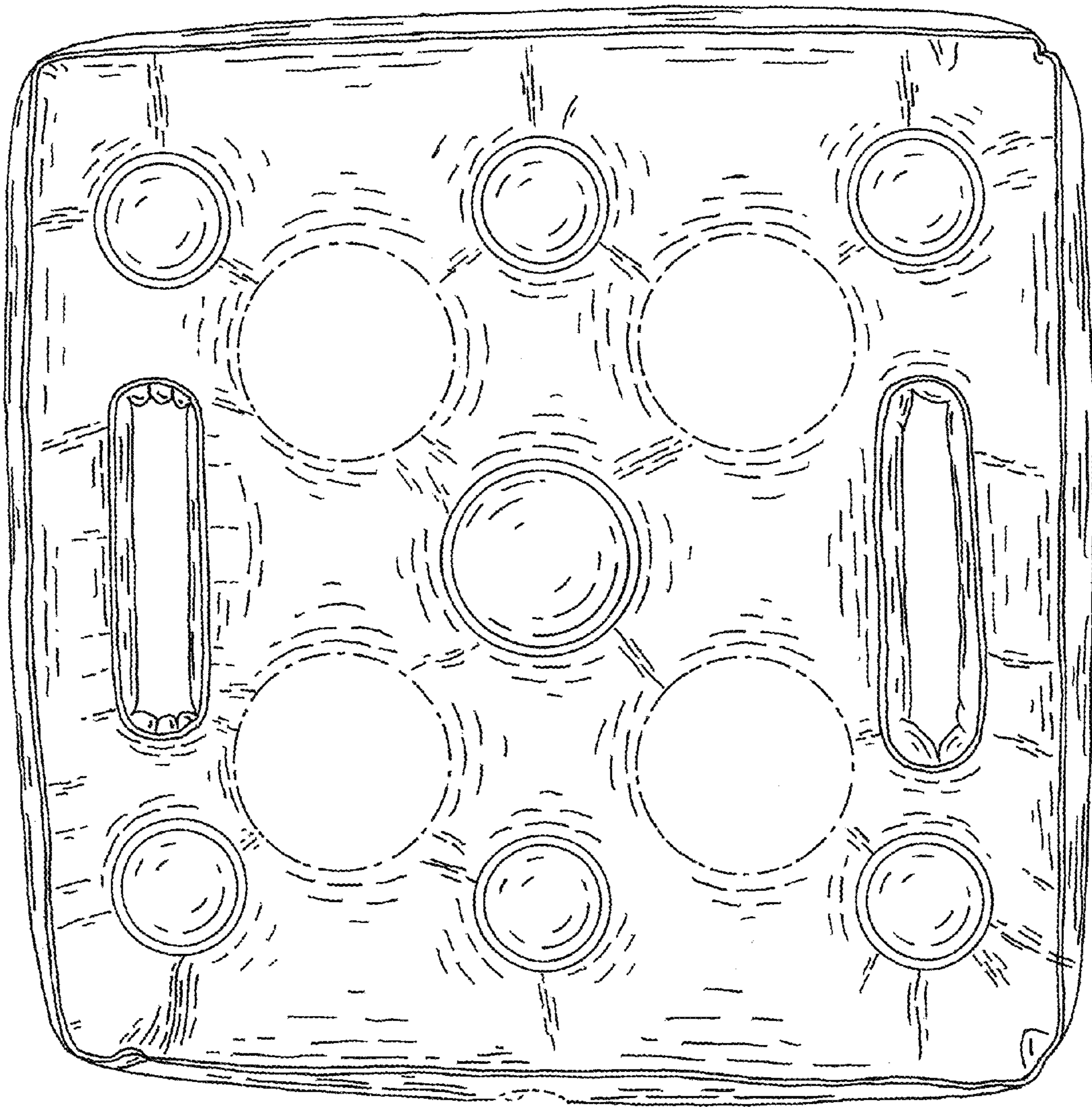
