The ornamental design for the food brining container, as shown and described.

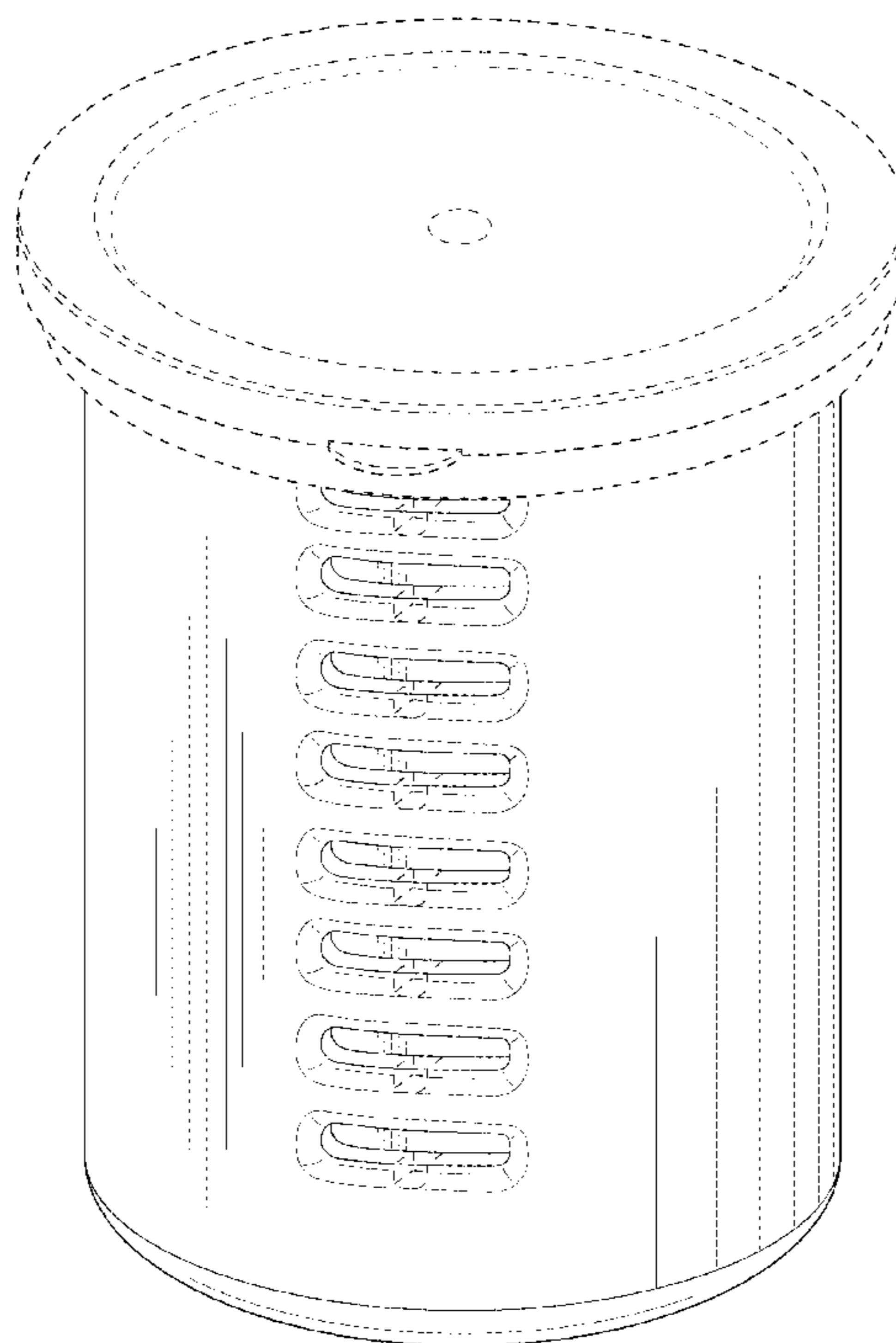
DESCRIPTION

FIG. 1 is an isometric view of a food brining container in accordance with an exemplary embodiment of my design; FIG. 2 is a left side elevation view of the food brining container of FIG. 1; FIG. 3 is a right side elevation view of the food brining container of FIG. 1; FIG. 4 is a front elevation view of the food brining container of FIG. 1, the rear view being a mirror image thereof; FIG. 5 is a top view of the food brining container of FIG. 1; and, FIG. 6 is a bottom view of the food brining container of FIG. 1.

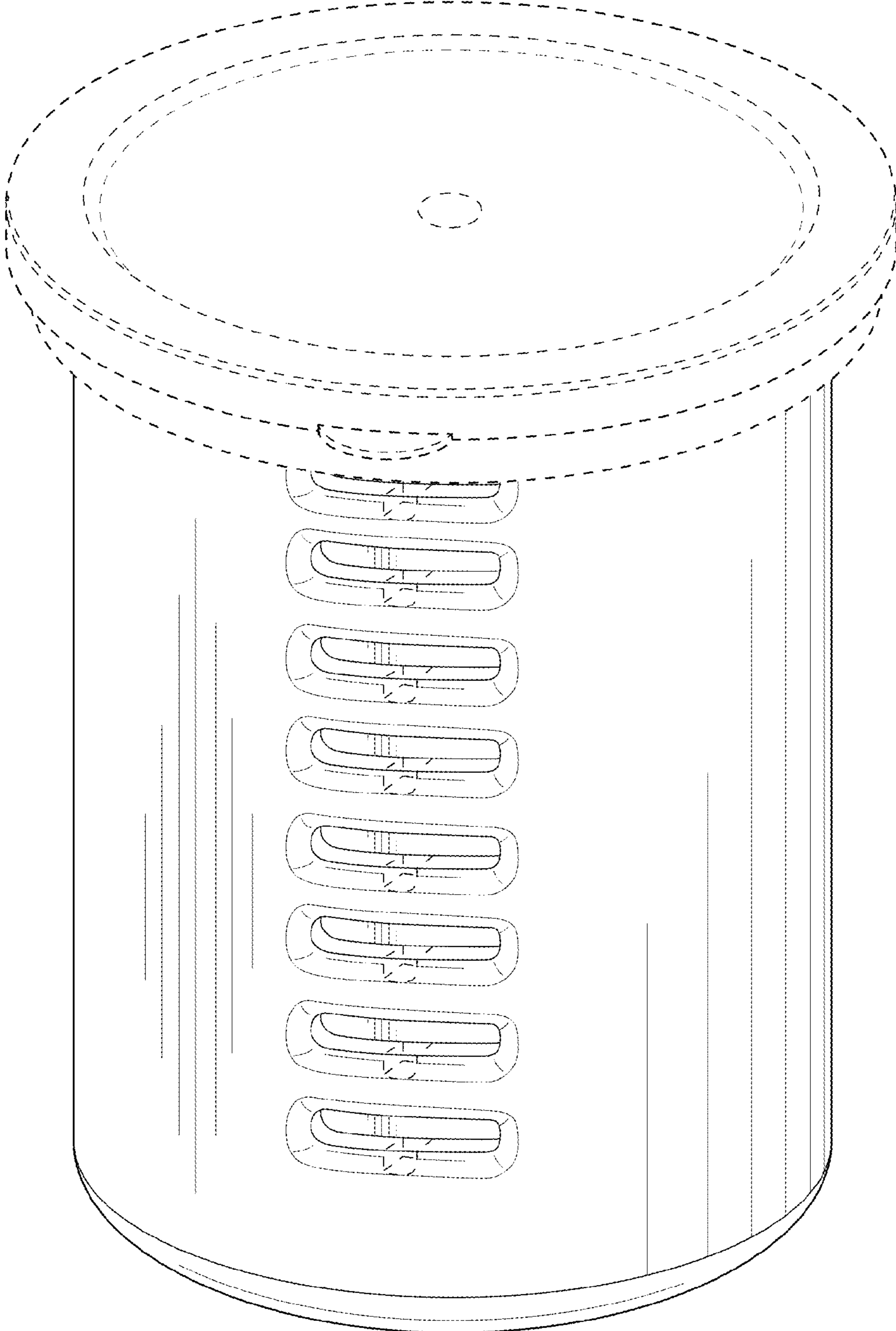

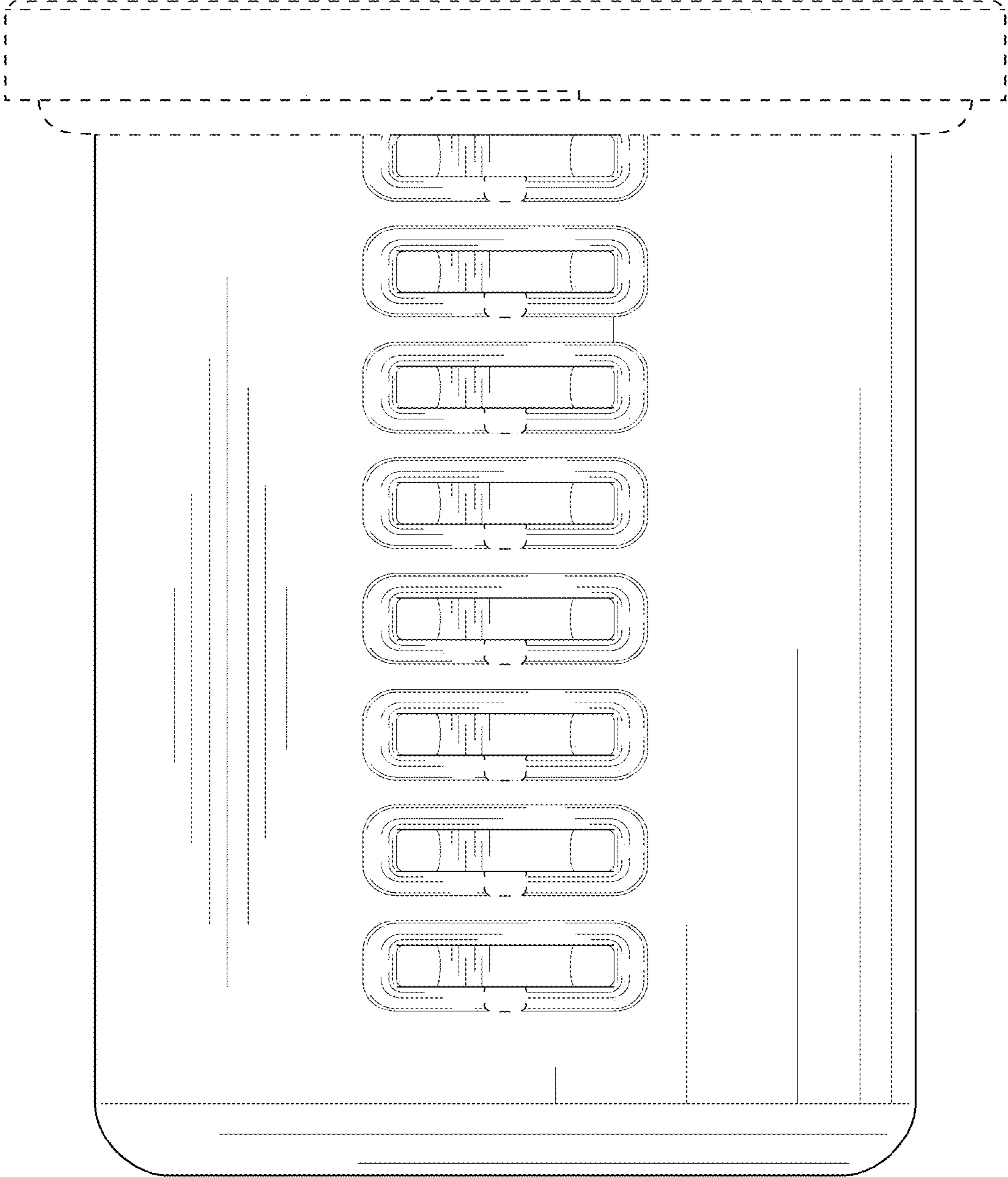

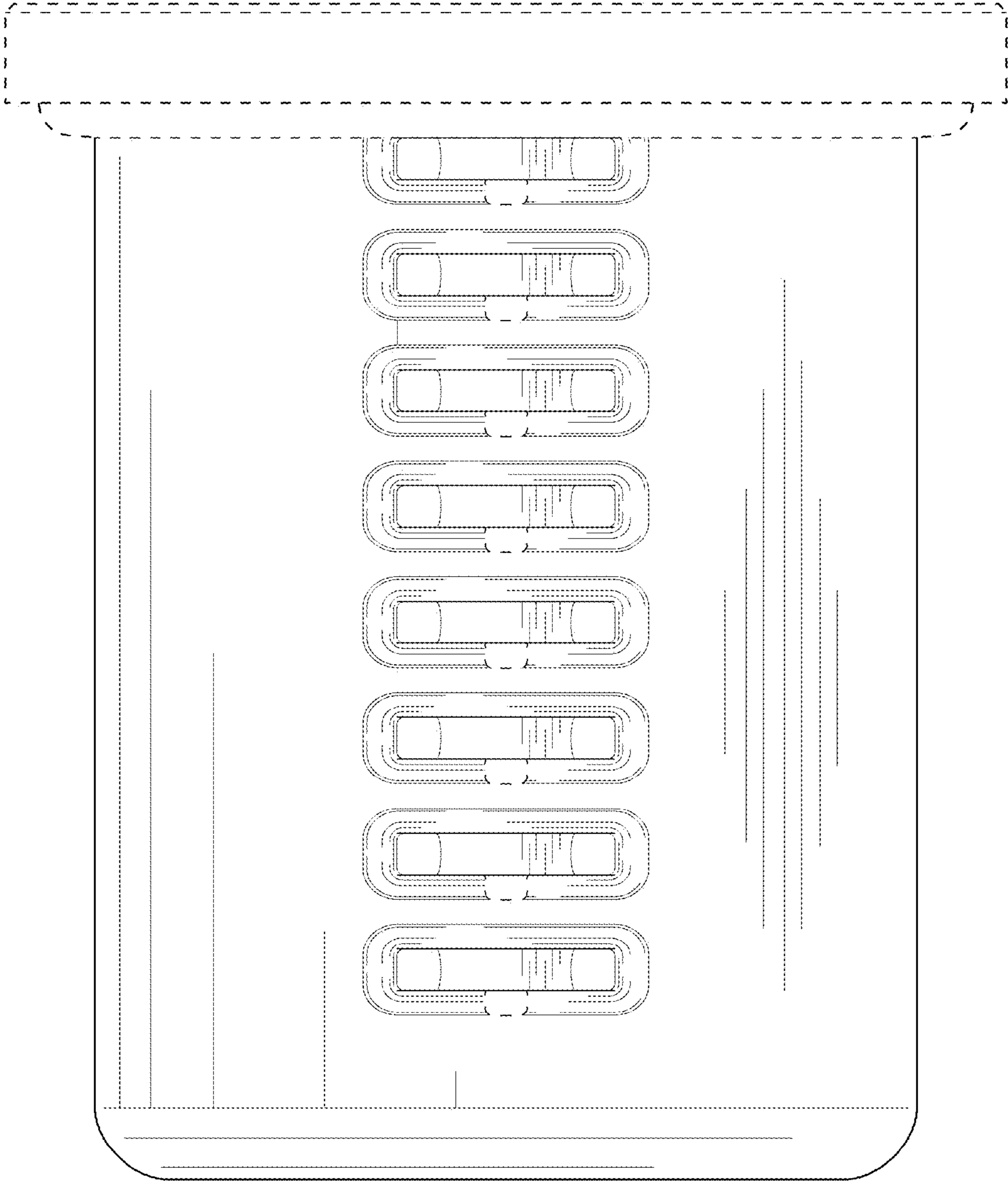

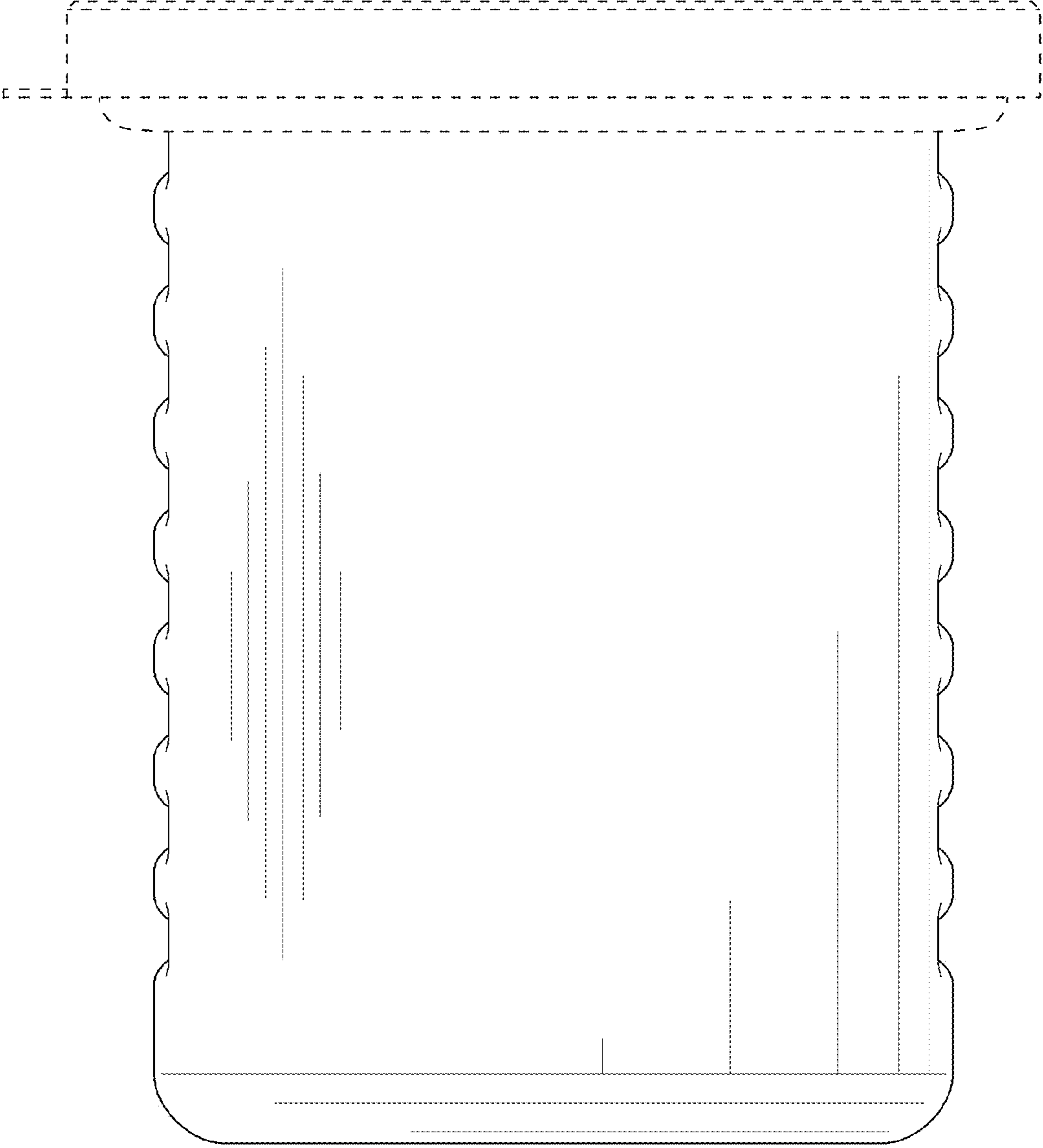

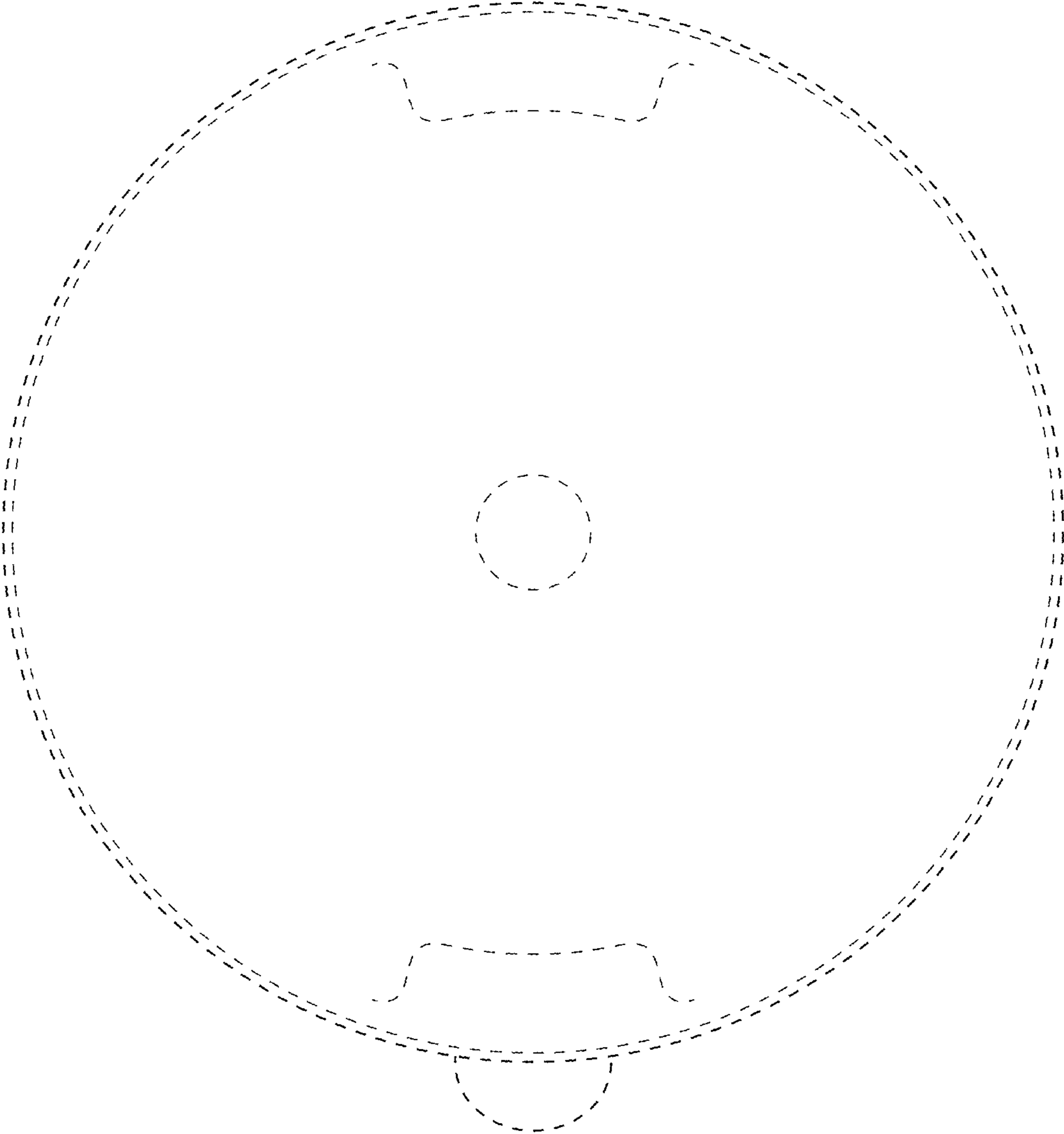

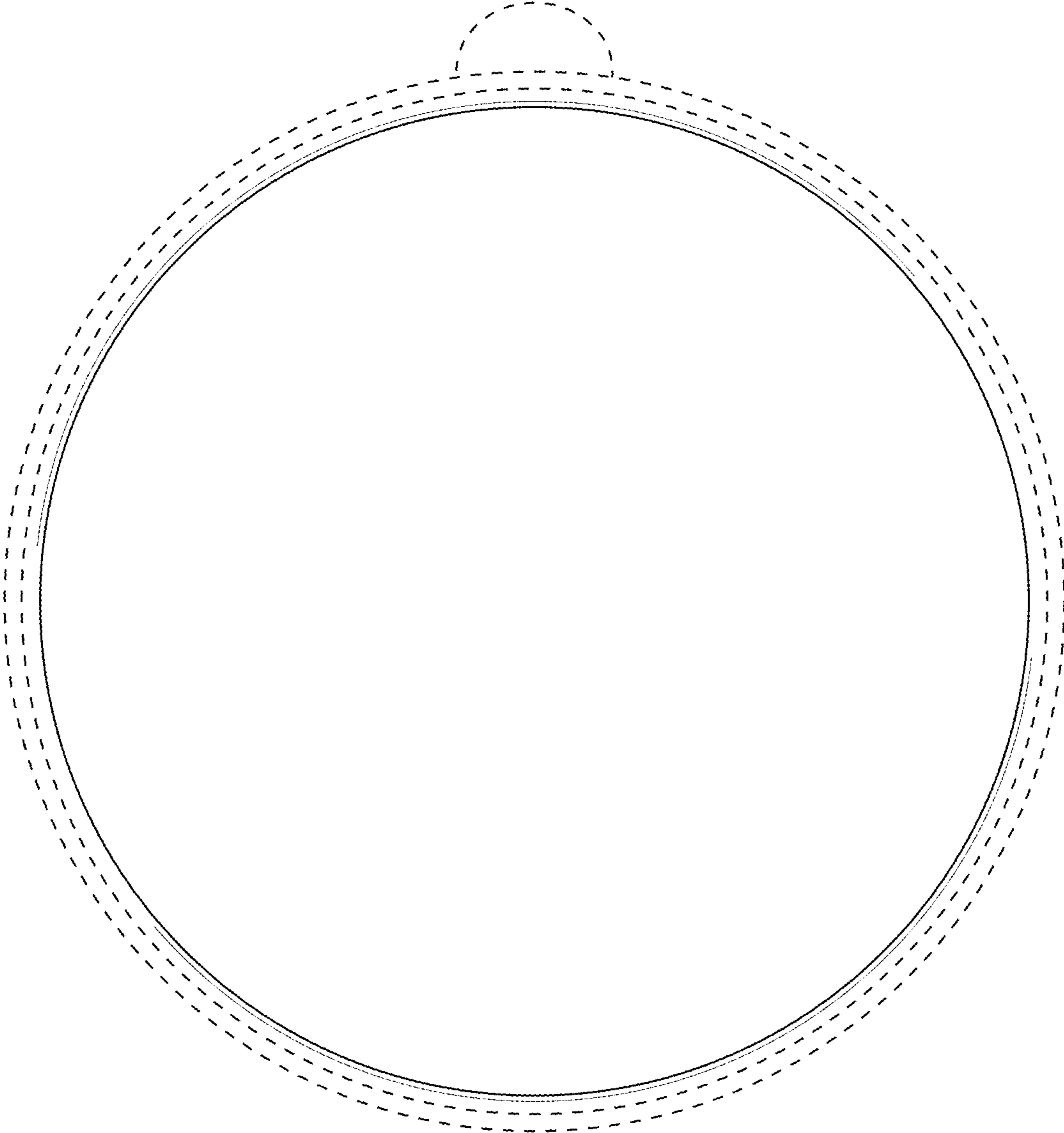
