(57) **CLAIM**

The ornamental design for a drop-prevention strap for a rolled product, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a drop-prevention strap for a rolled product showing our new design; FIG. 2 is a side elevational view thereof; FIG. 3 is a side, front, and top perspective view thereof; and, FIG. 4 is a side, front, and top perspective view thereof shown installed on a structure and holding a rolled product, where the objects in broken lines are shown for the purpose of illustrating environment and form no part of the claimed design.

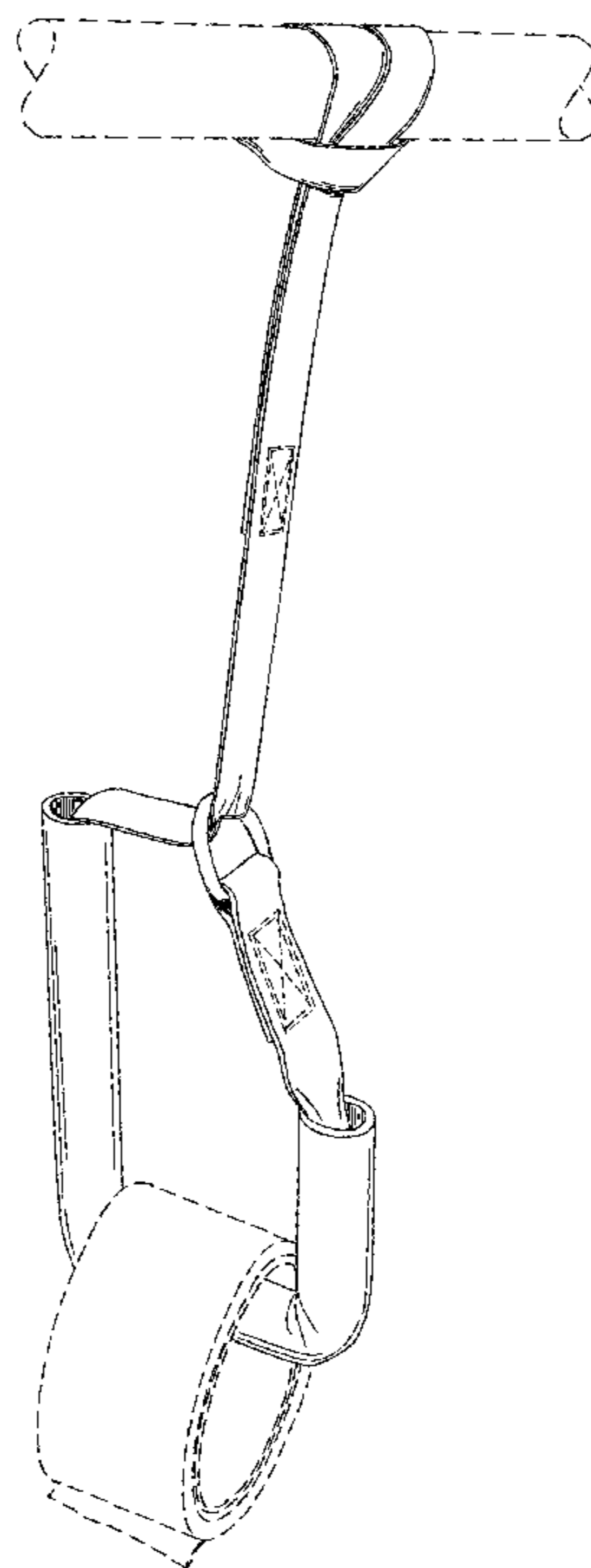

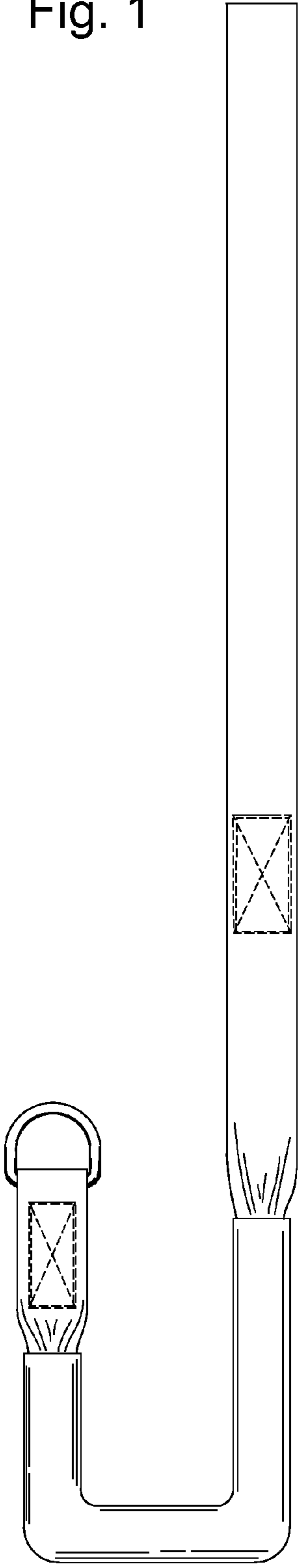

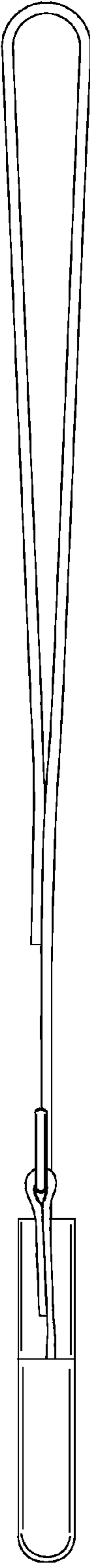

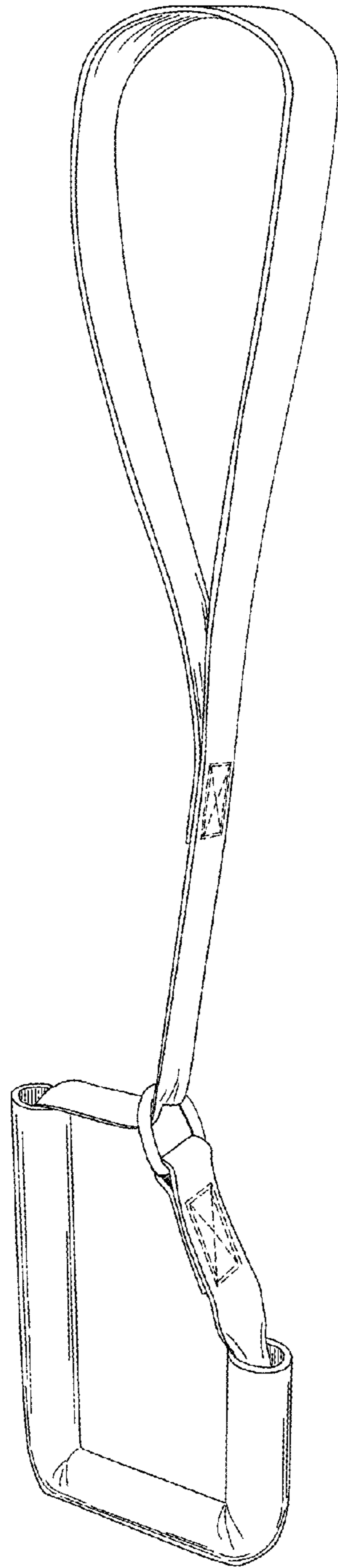
