The ornamental design for a front bumper for a vehicle, as shown and described.

**DESCRIPTION**

FIG. 3 is a left perspective view thereof;

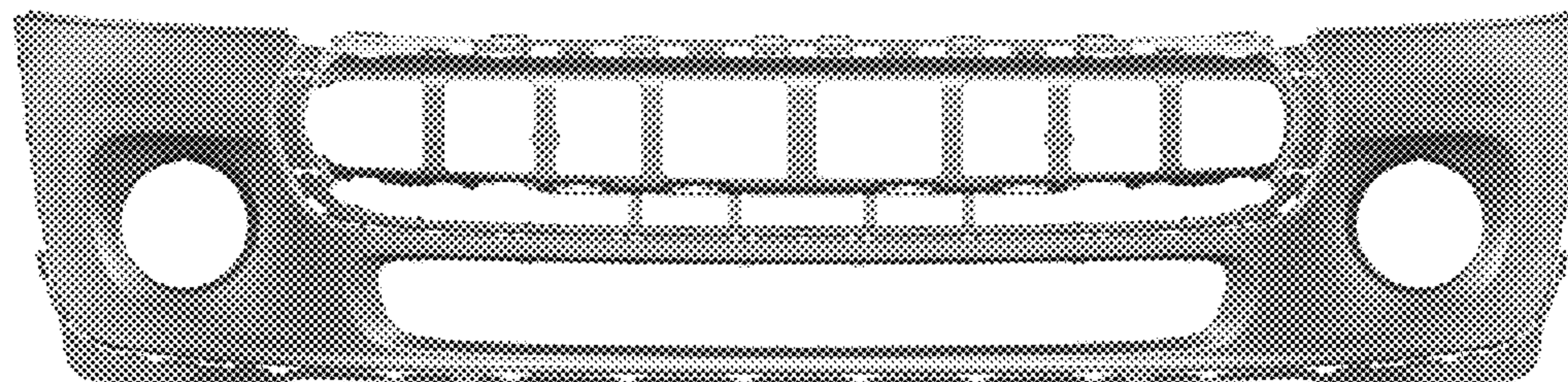
FIG. 4 is a right side view thereof;

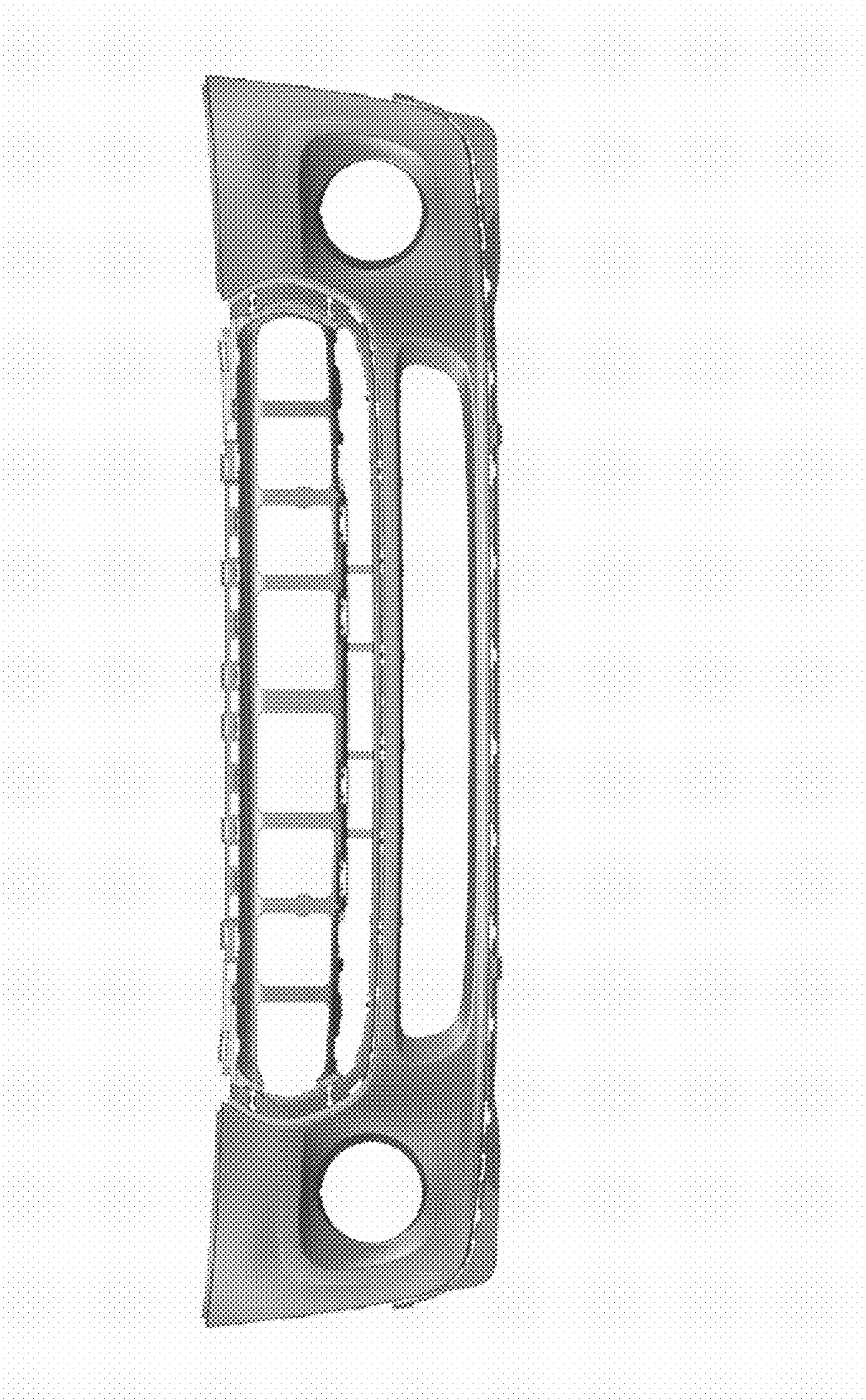

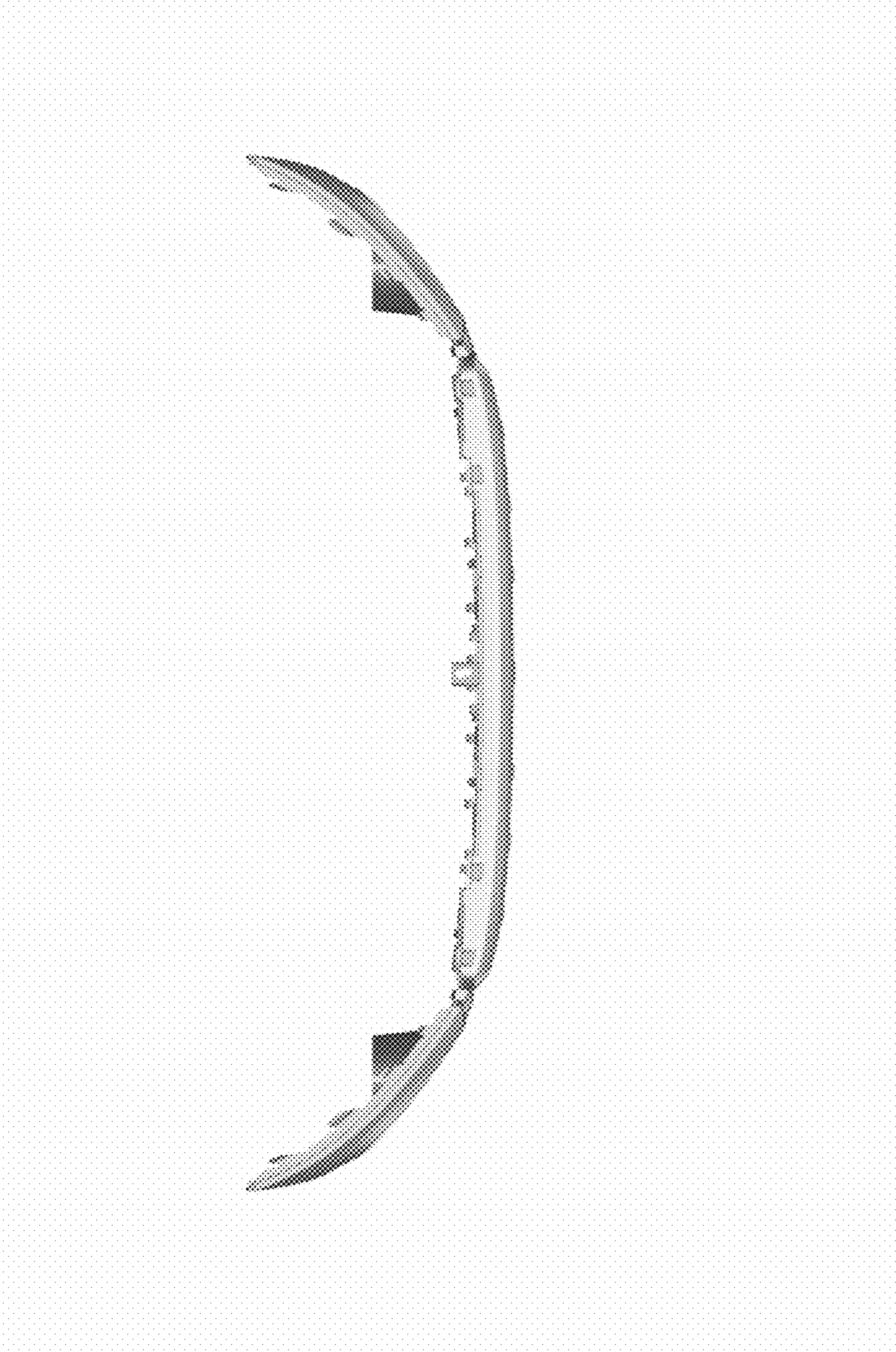

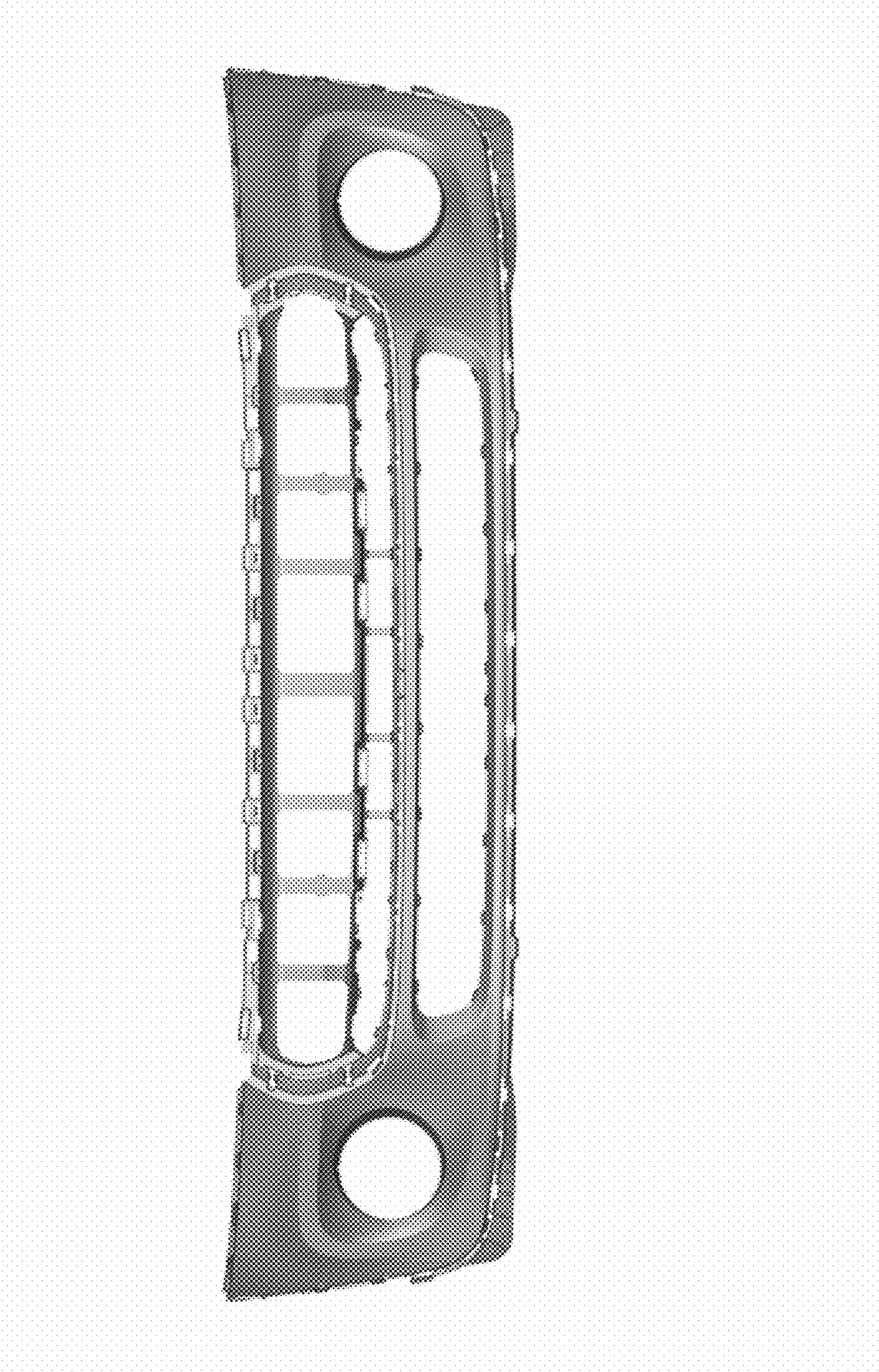
