The ornamental design for a display screen with icon group and display screen with icon set, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a display screen with icon group showing the new design;

FIG. 2 is another embodiment thereof;

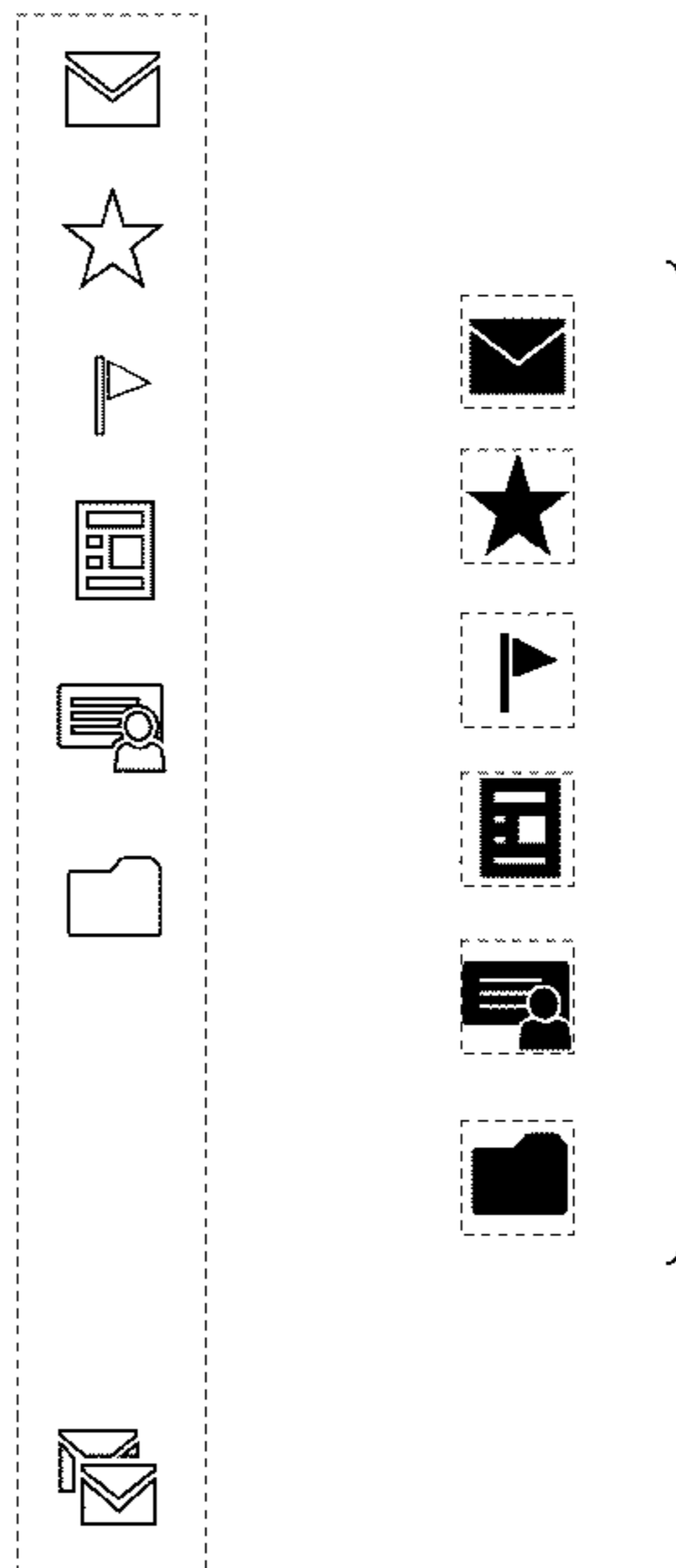
FIG. 3 is a front view of a display screen with icon set showing the new design;

FIG. 4 is another embodiment thereof; and,

FIG. 5 is a front view of the display screen with icon group of FIG. 1 shown on a device.

The icons in FIGS. 3-4 are arranged relatively on the drawing sheet for the convenience of display, and their relative positioning forms no part of the claimed design.

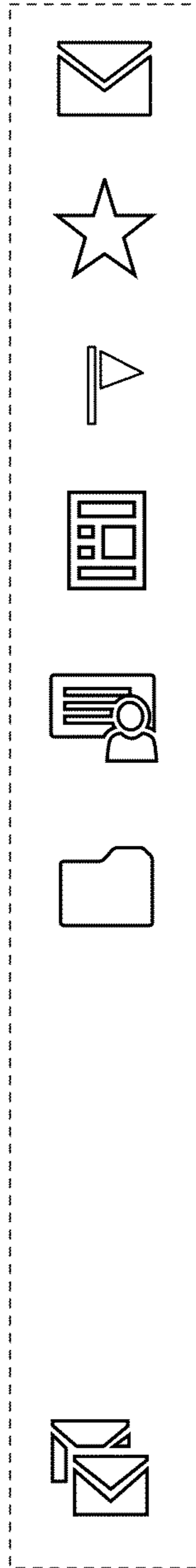

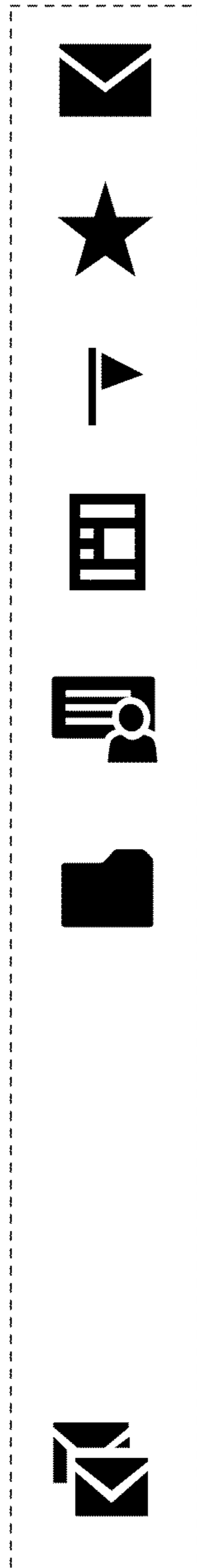

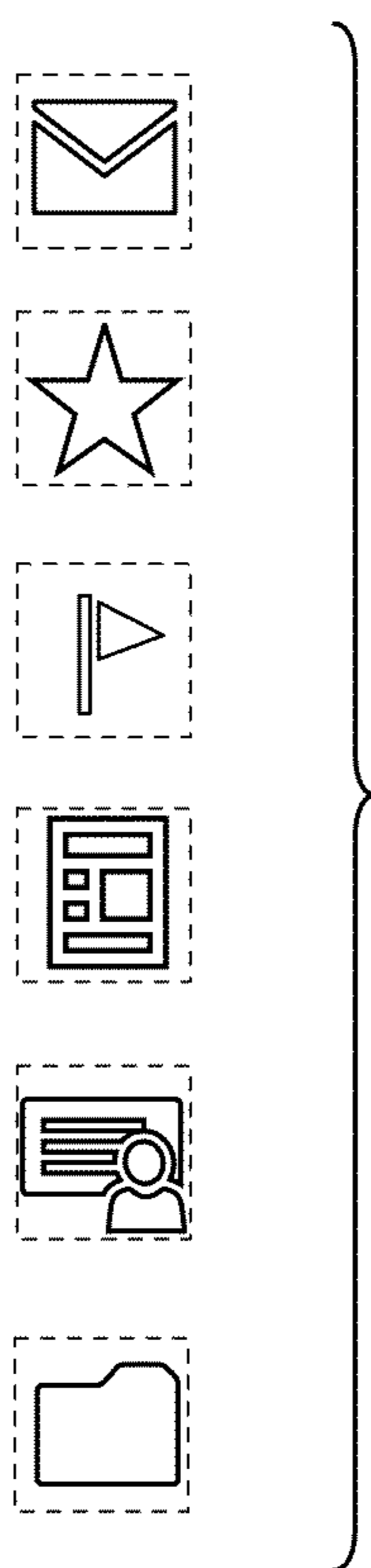

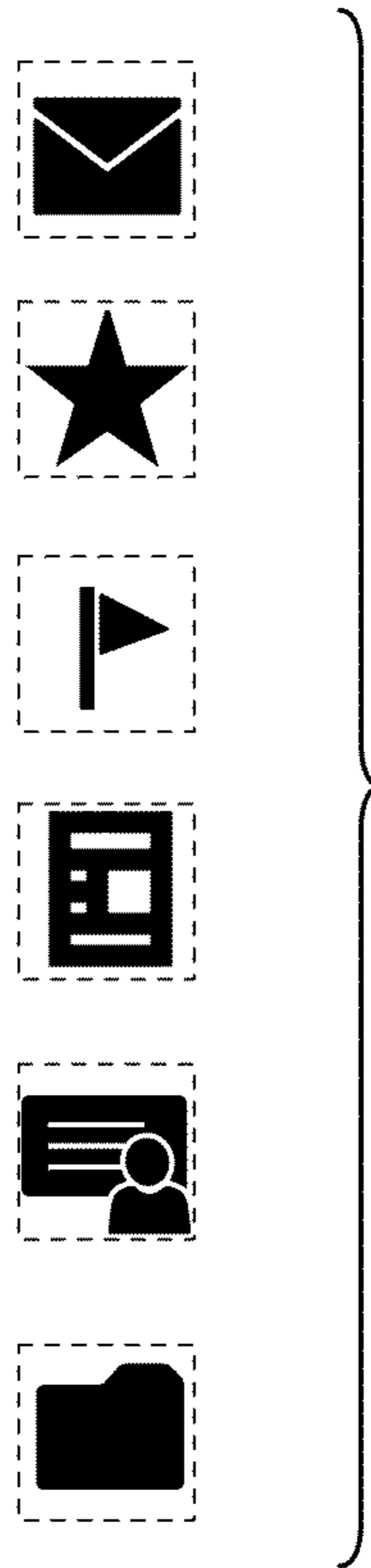

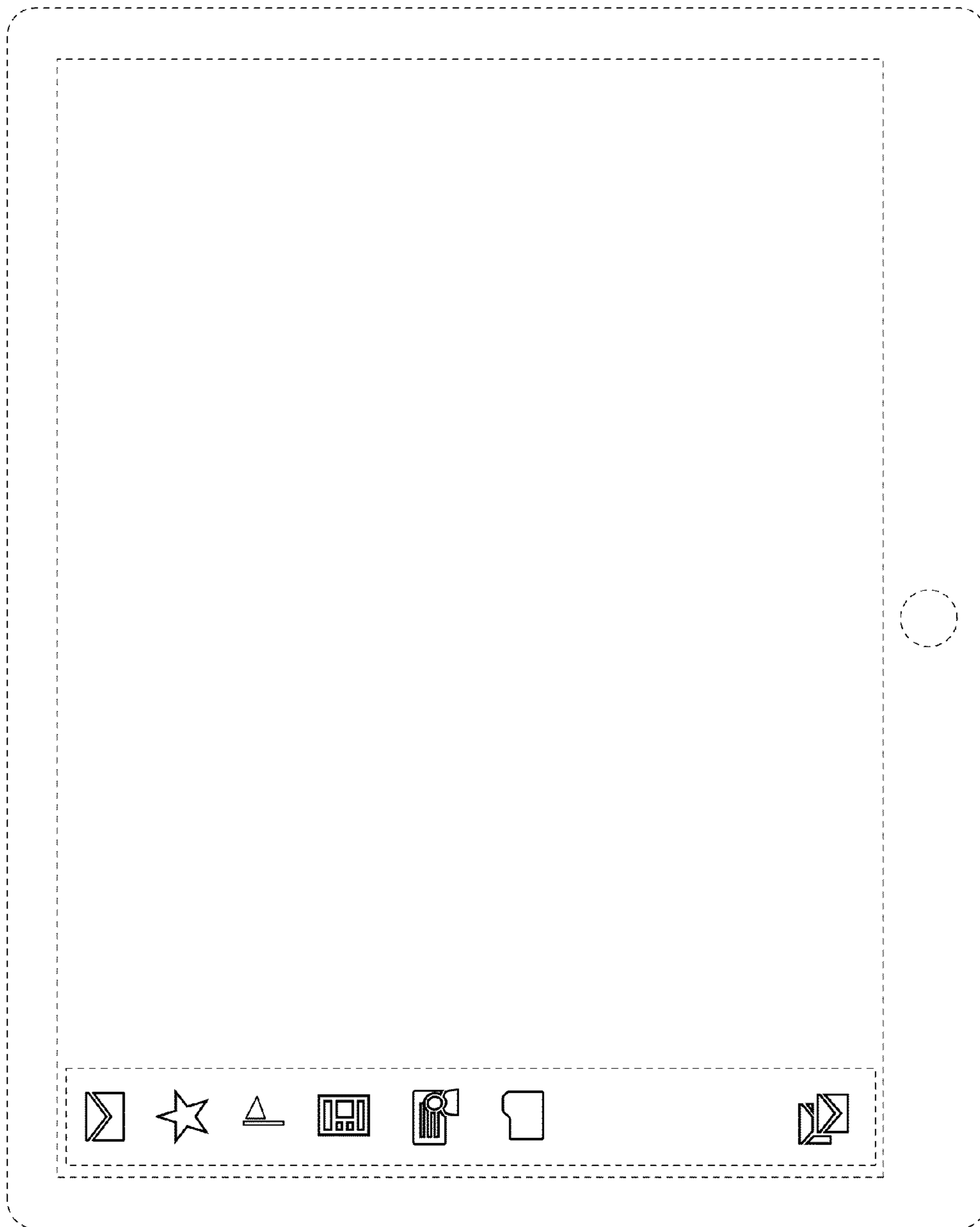
