(57) **CLAIM**

We claim the ornamental design for a TV receiver display with animated graphical user interface, as shown and described.

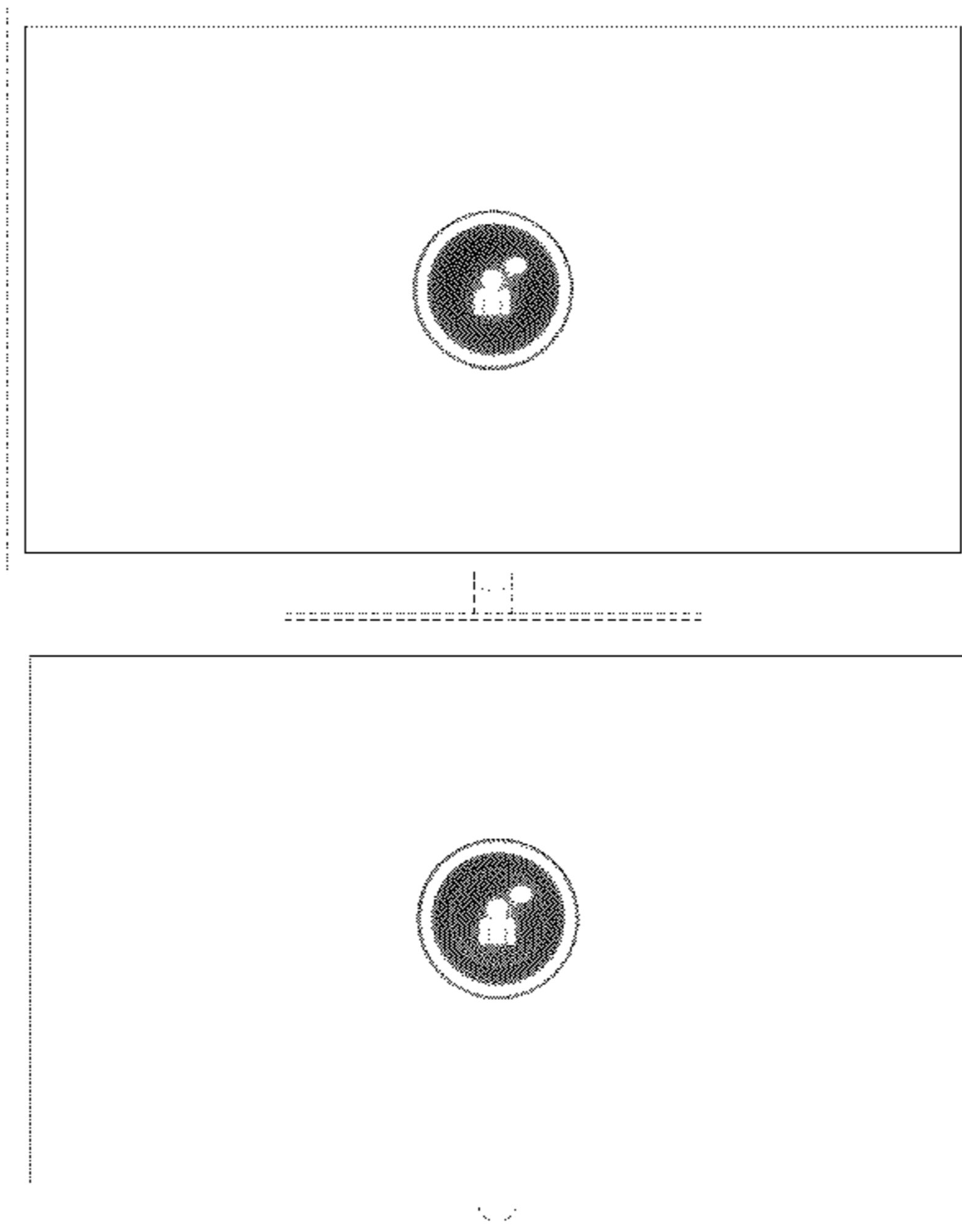

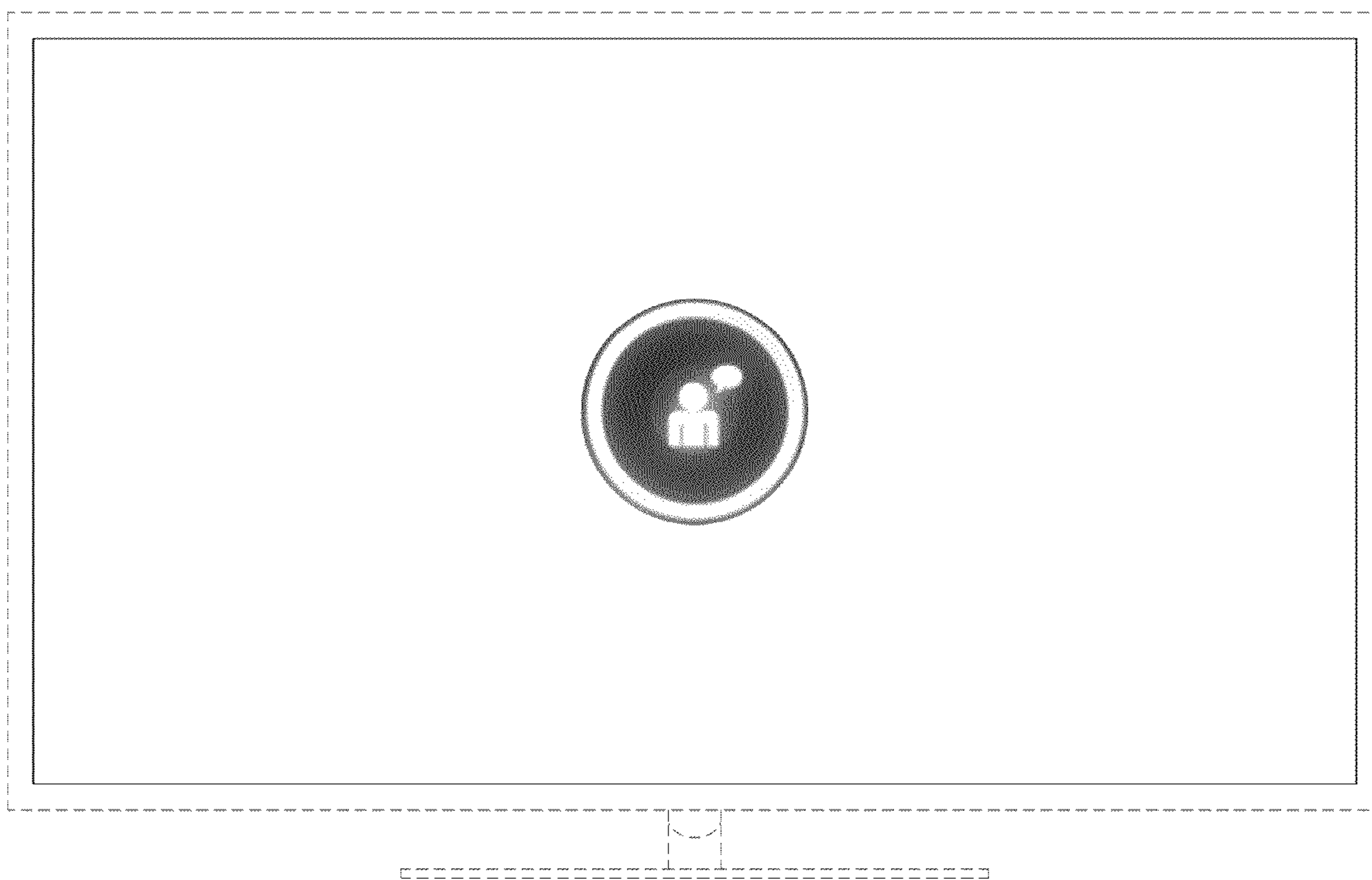

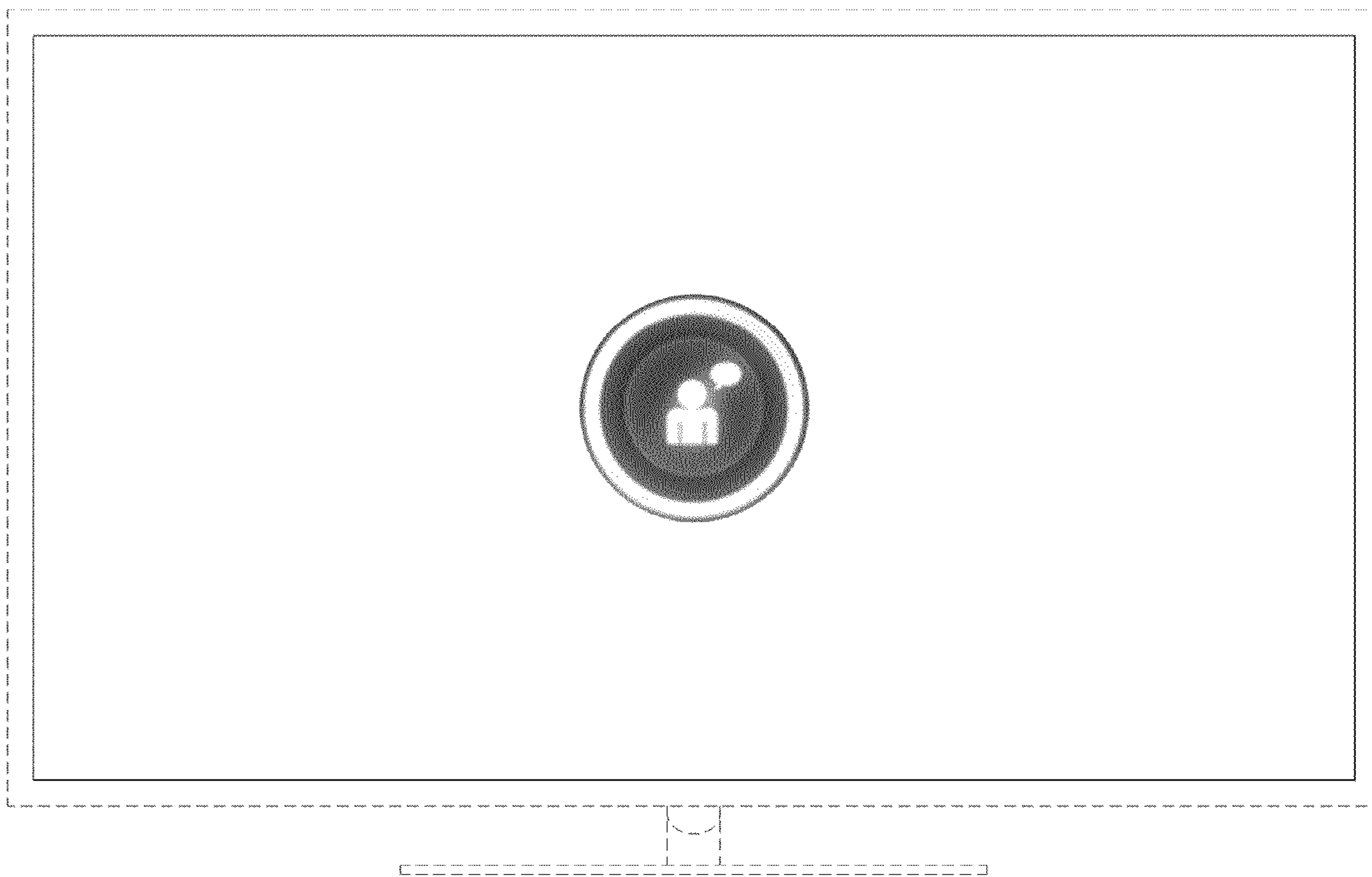

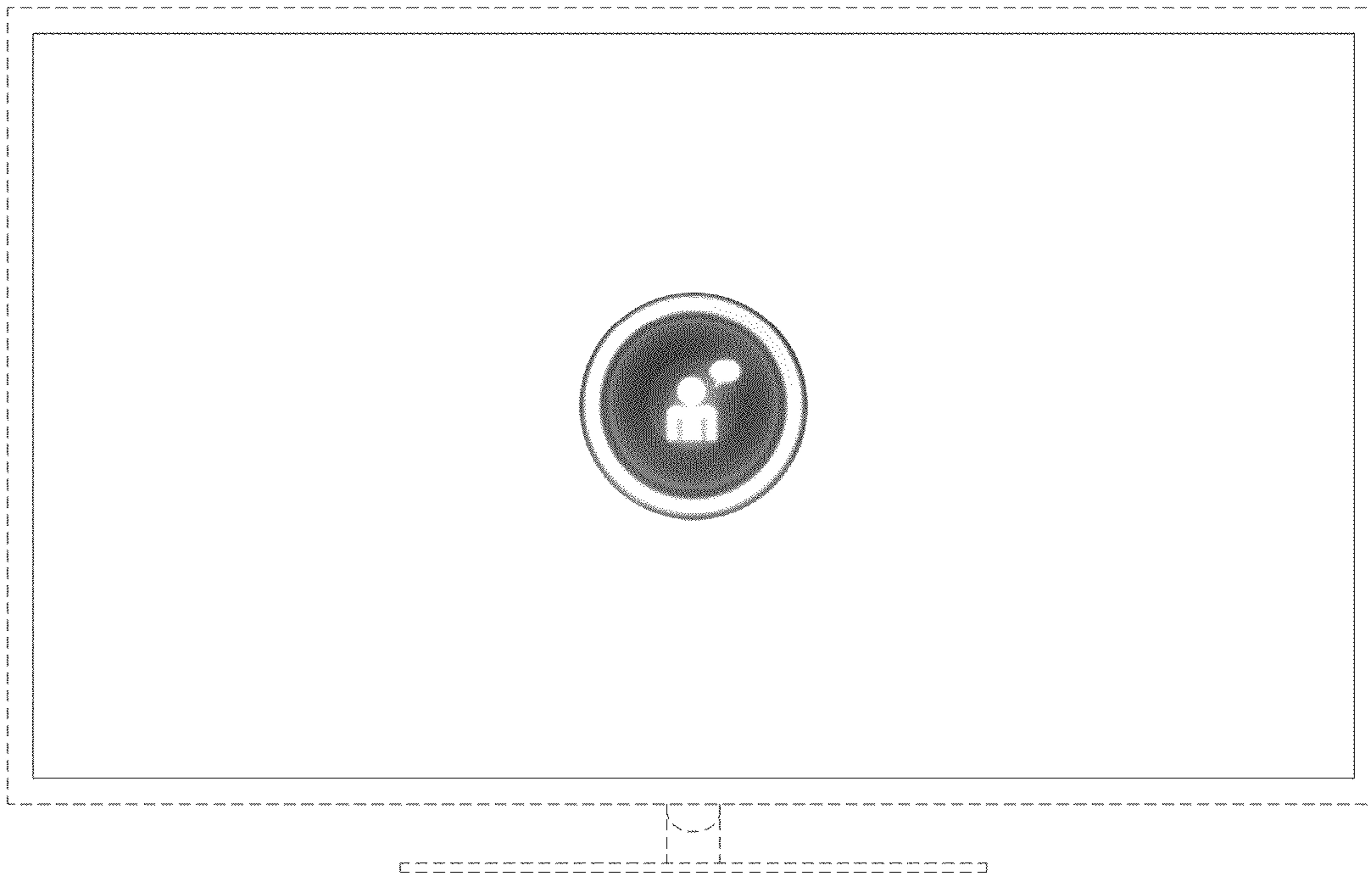

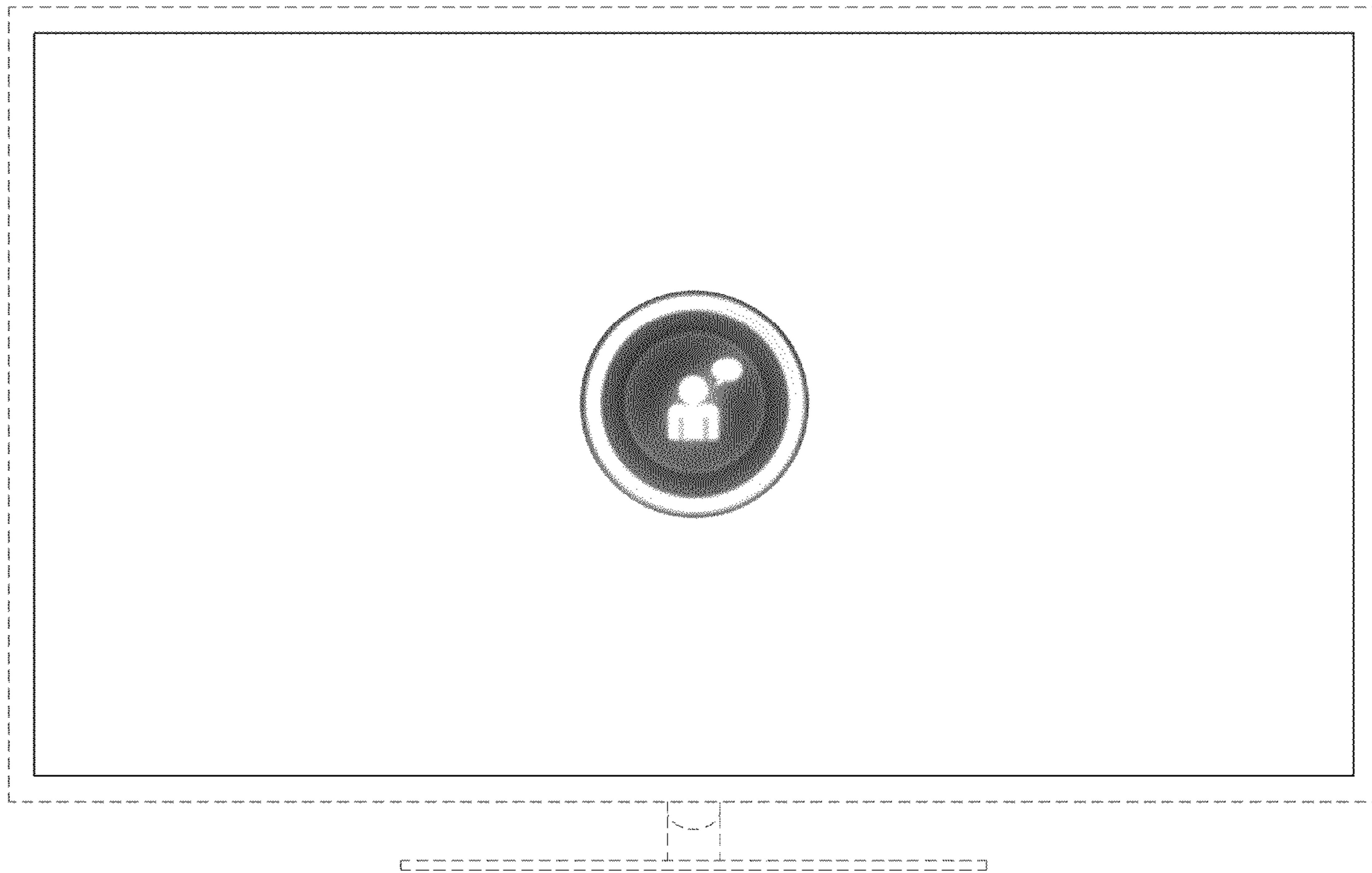

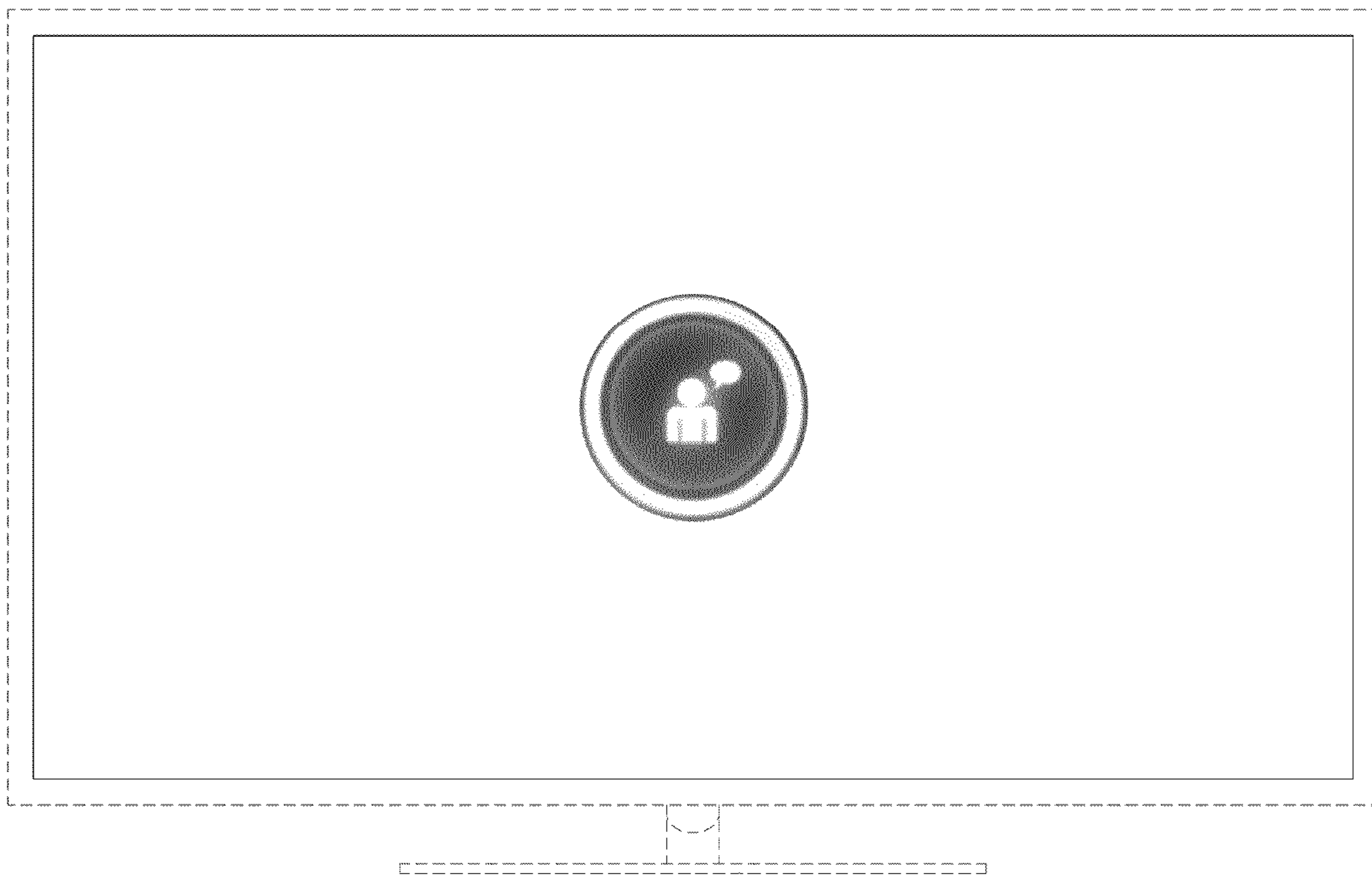
