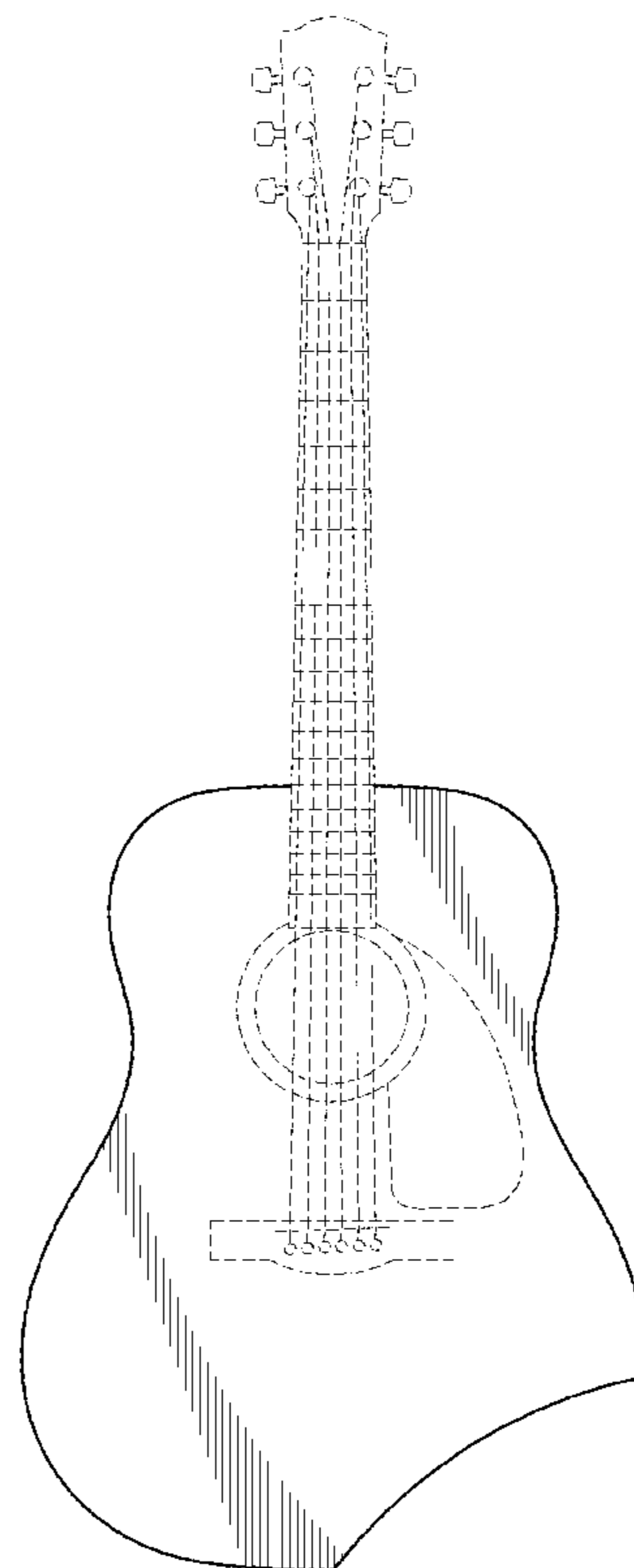
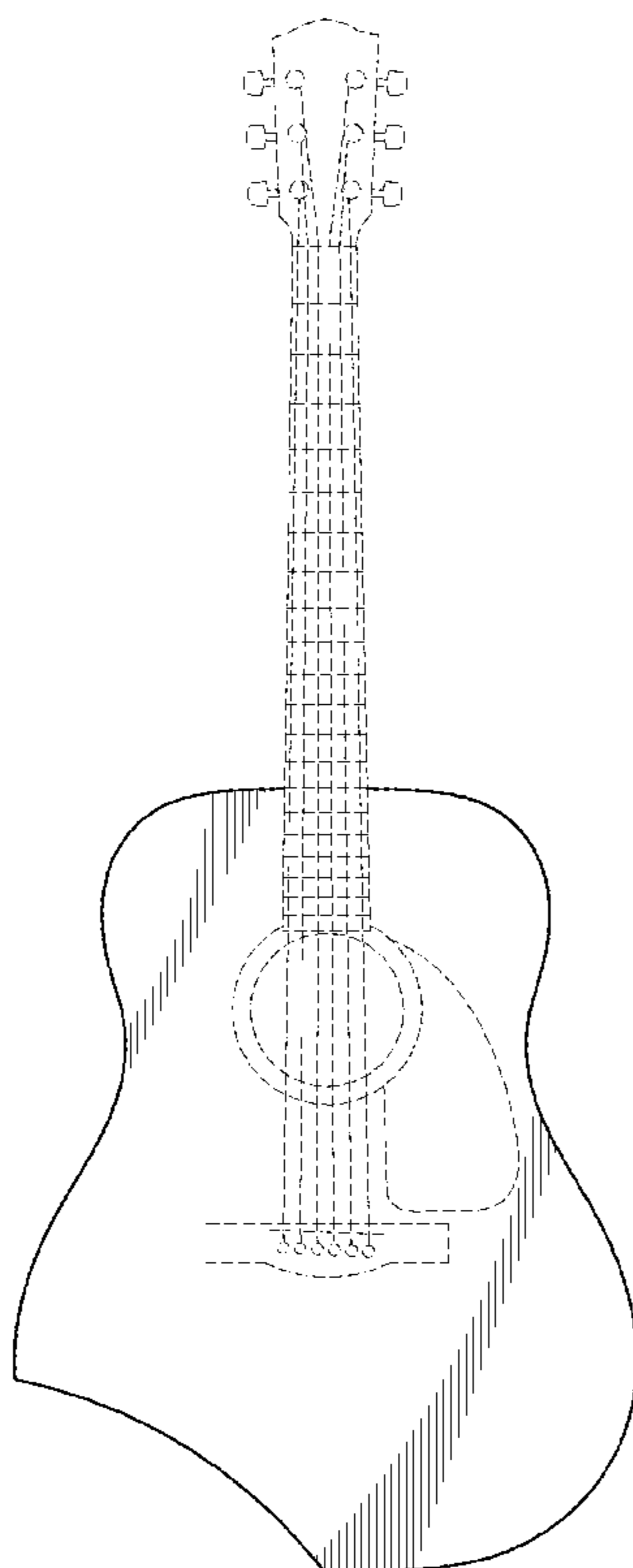
The ornamental design for a guitar, as shown and described.

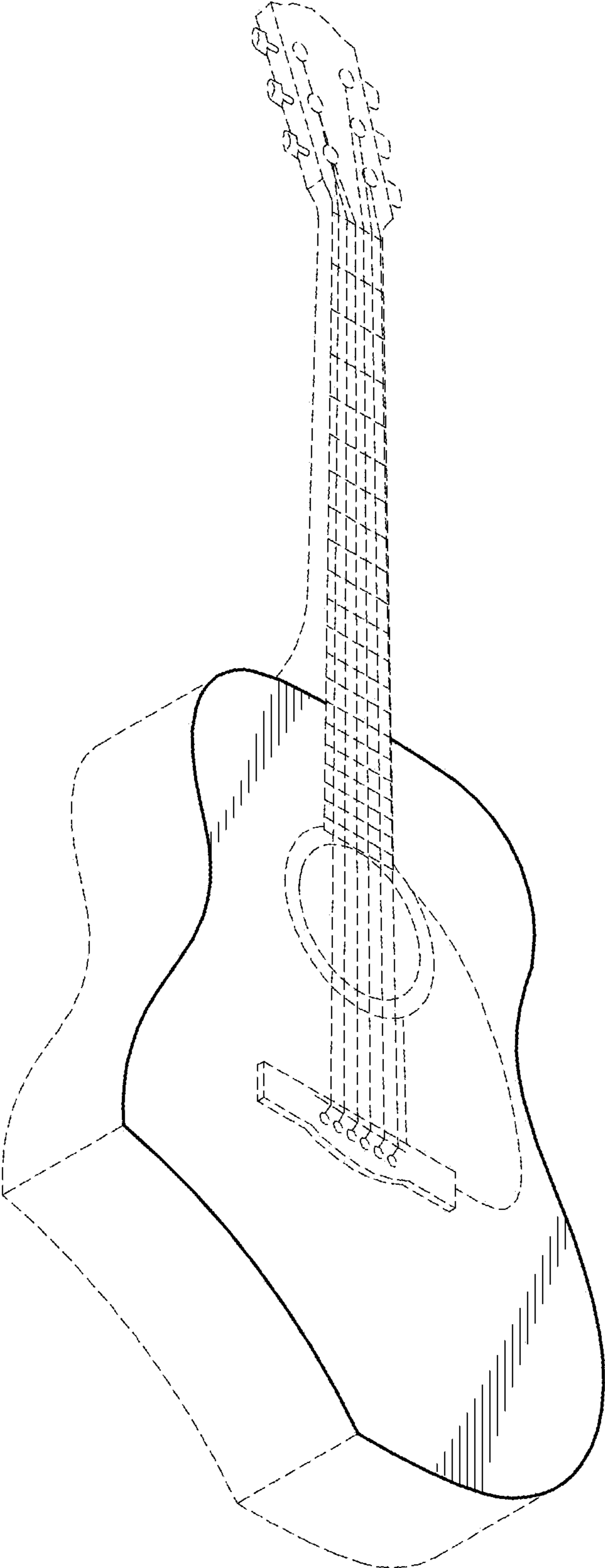
**DESCRIPTION**

FIG. 8 is a bottom view thereof.

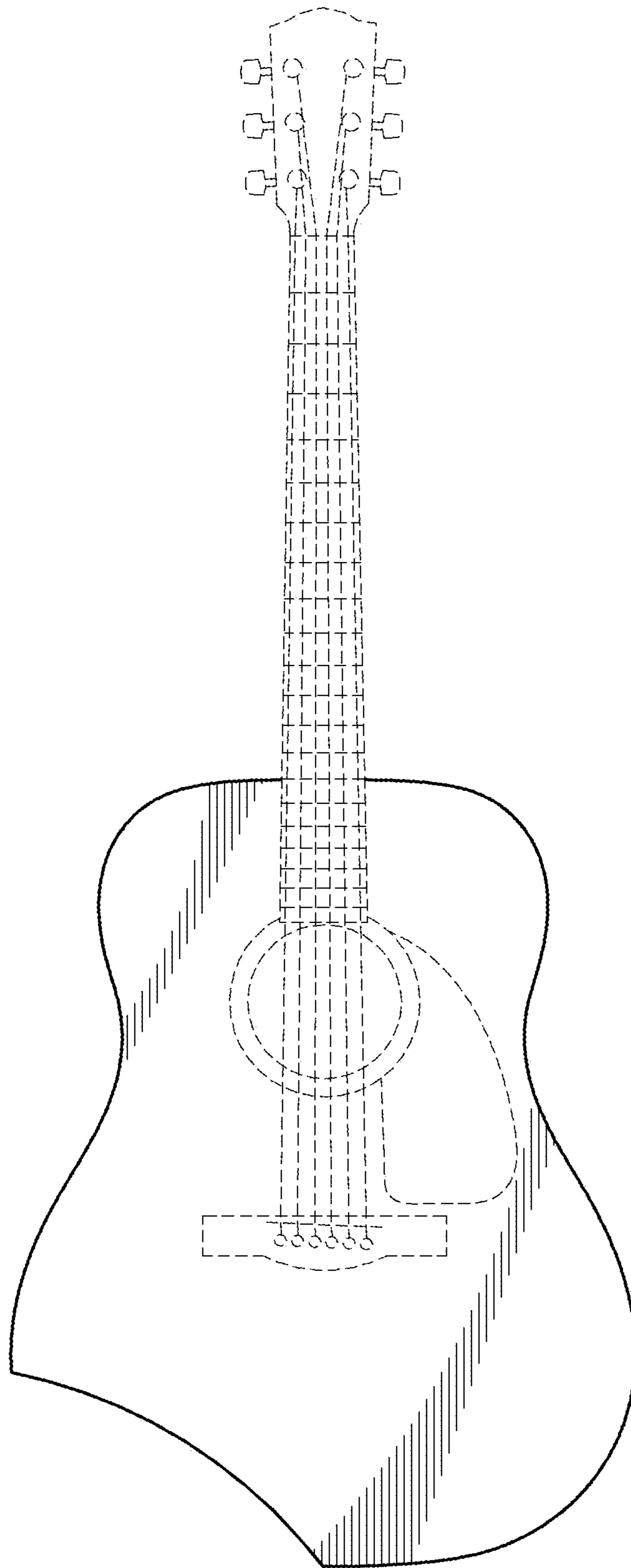

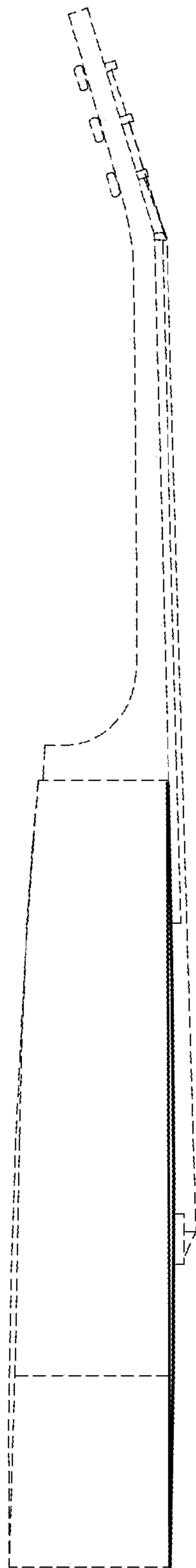




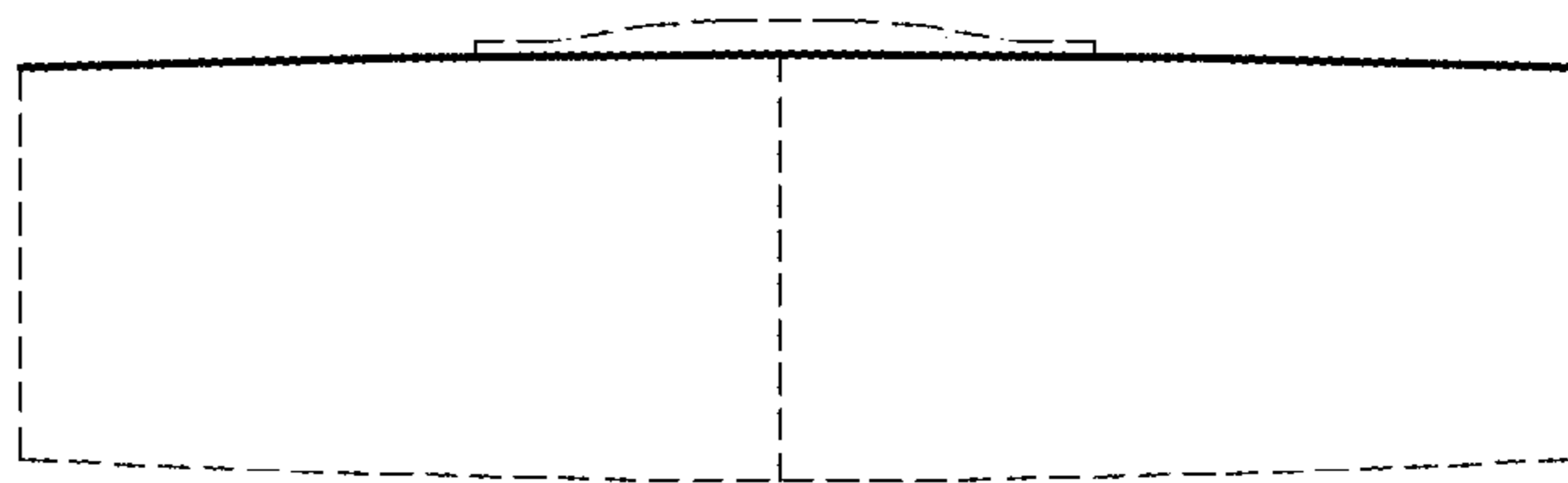

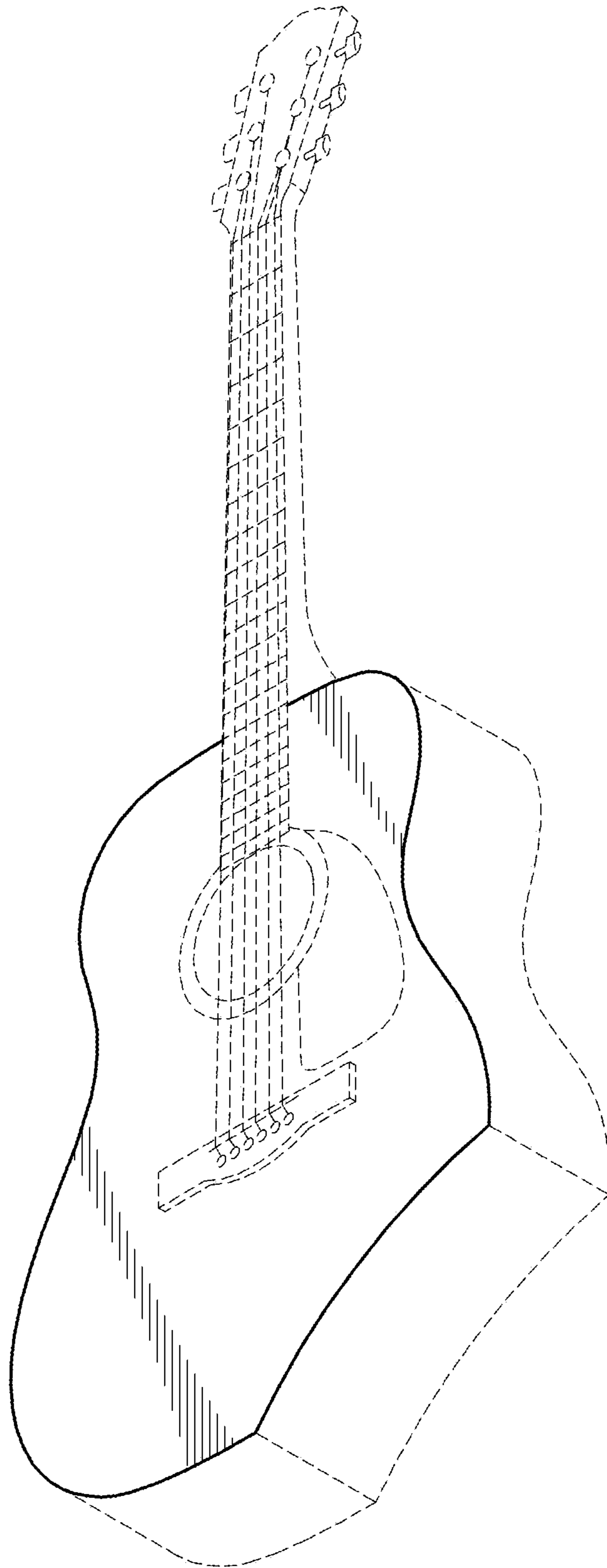

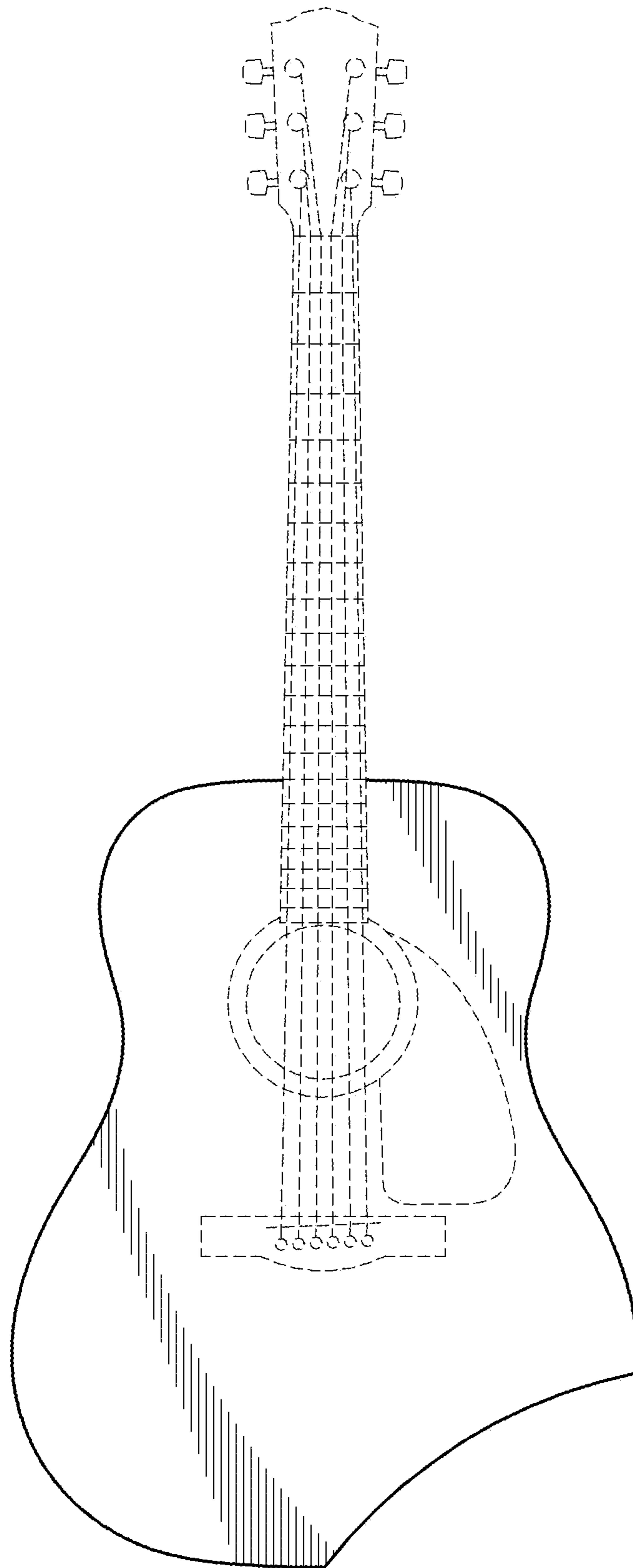

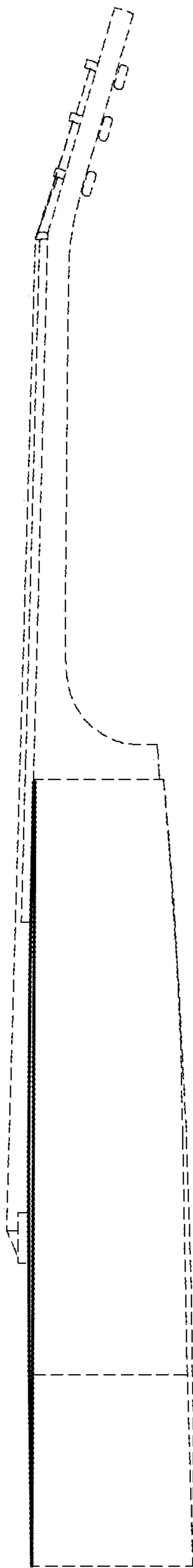

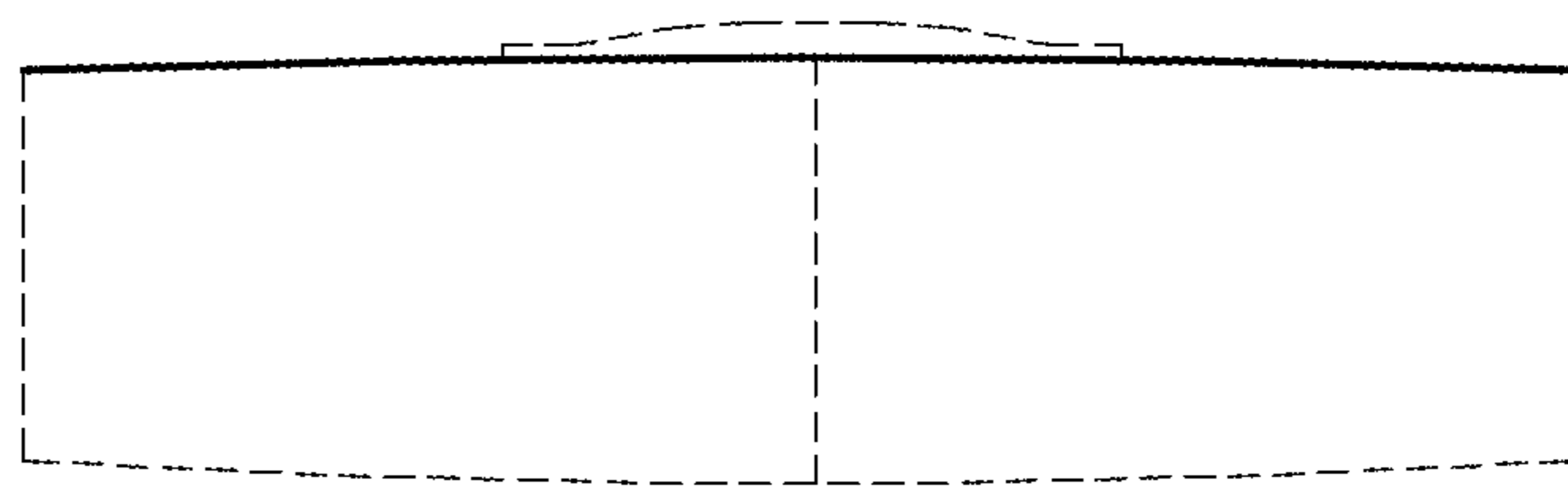
