The ornamental design for blackjack game, as shown and described.

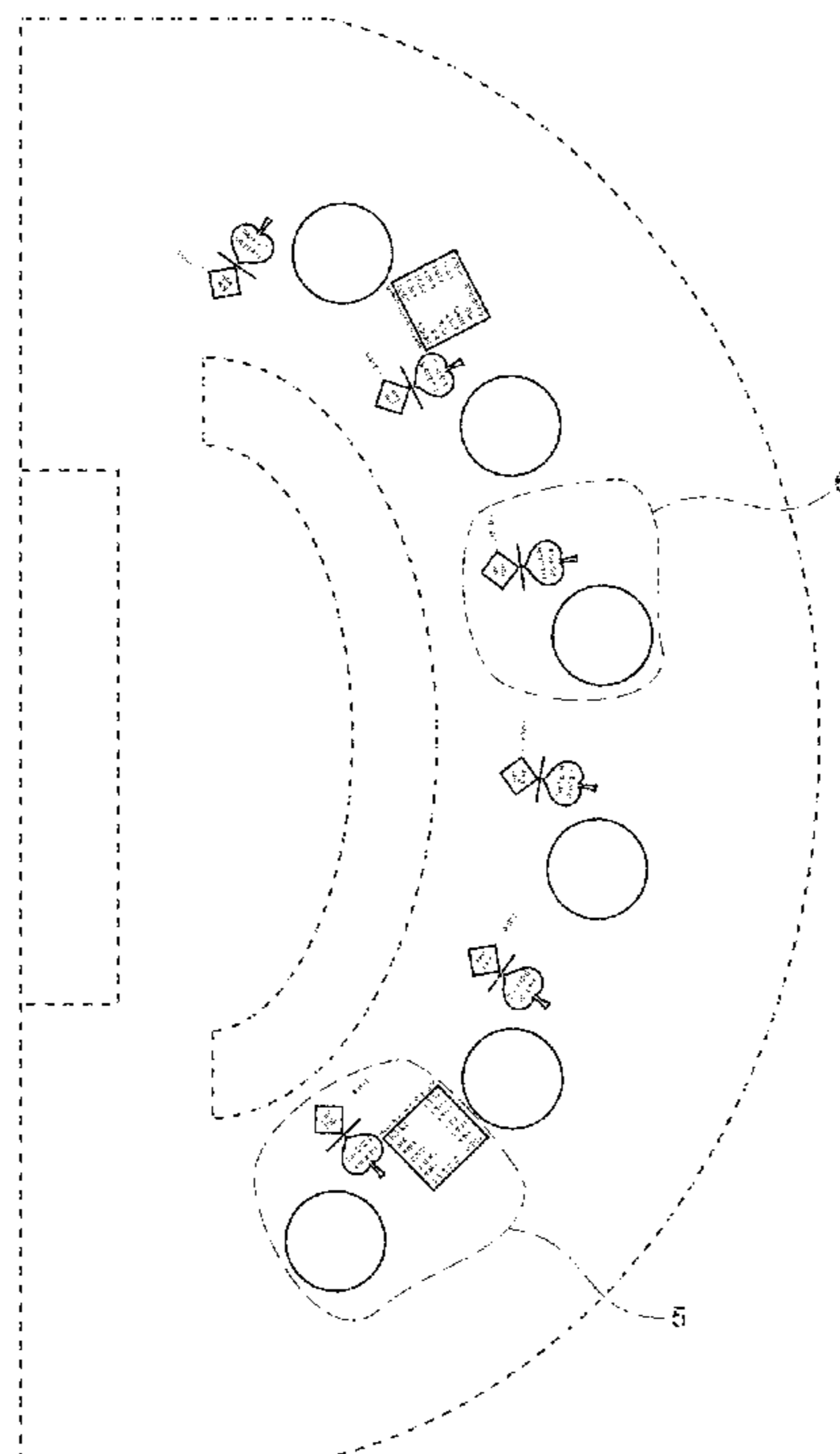
DESCRIPTION

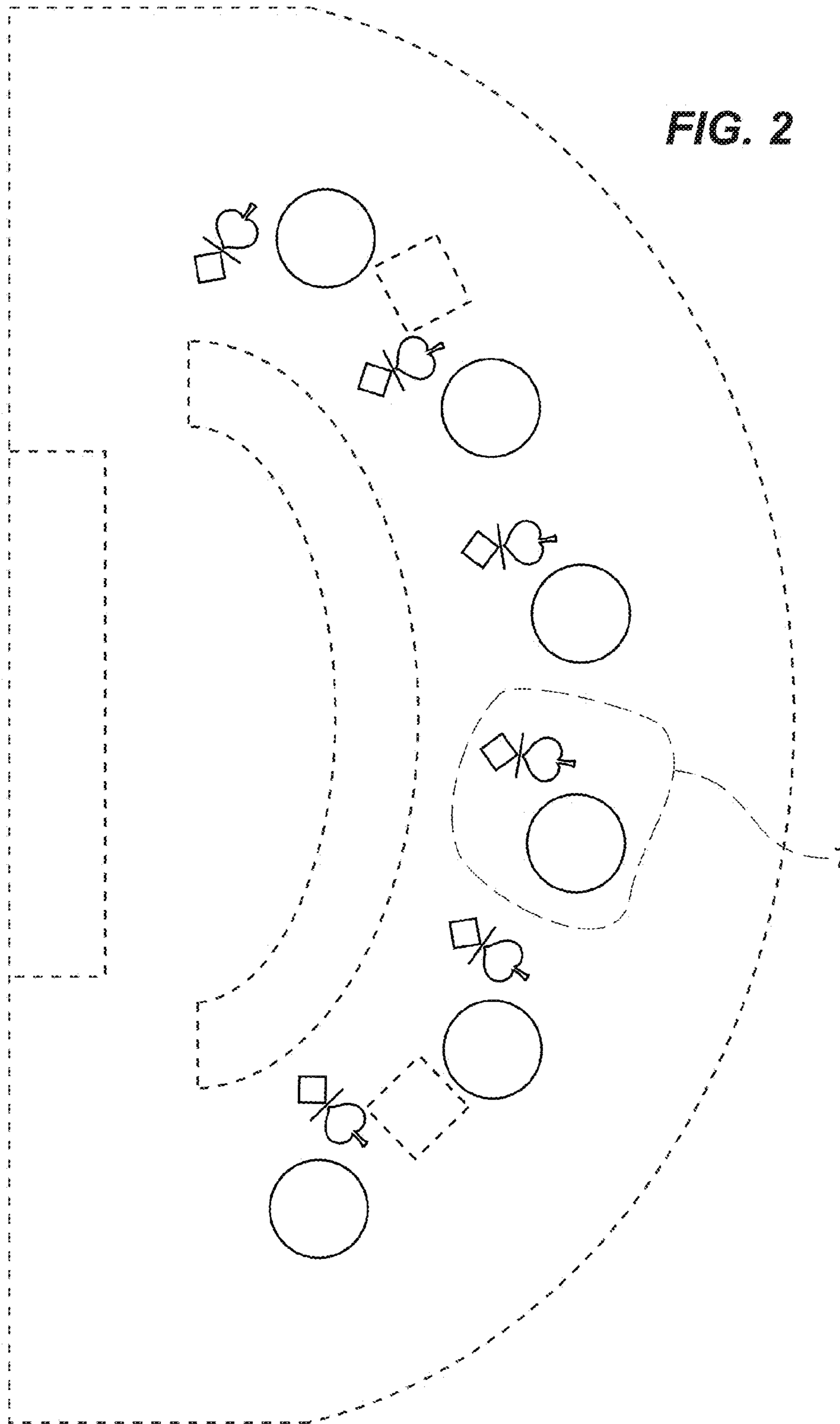
FIG. 1 is a top plan view of a first embodiment of a blackjack game.

 The portions shown in broken lines in the drawings illustrate an environment and are not part of the claimed design.

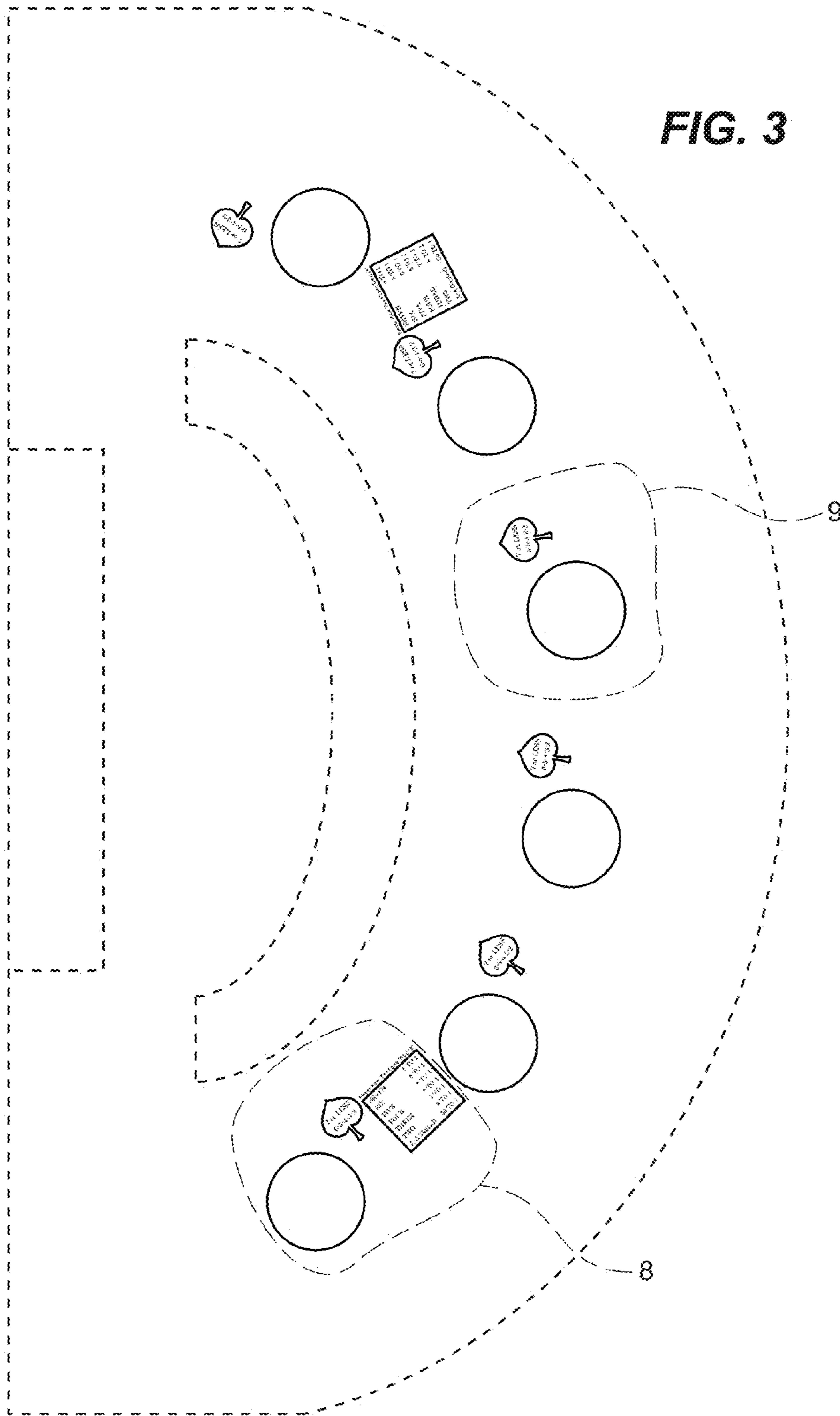

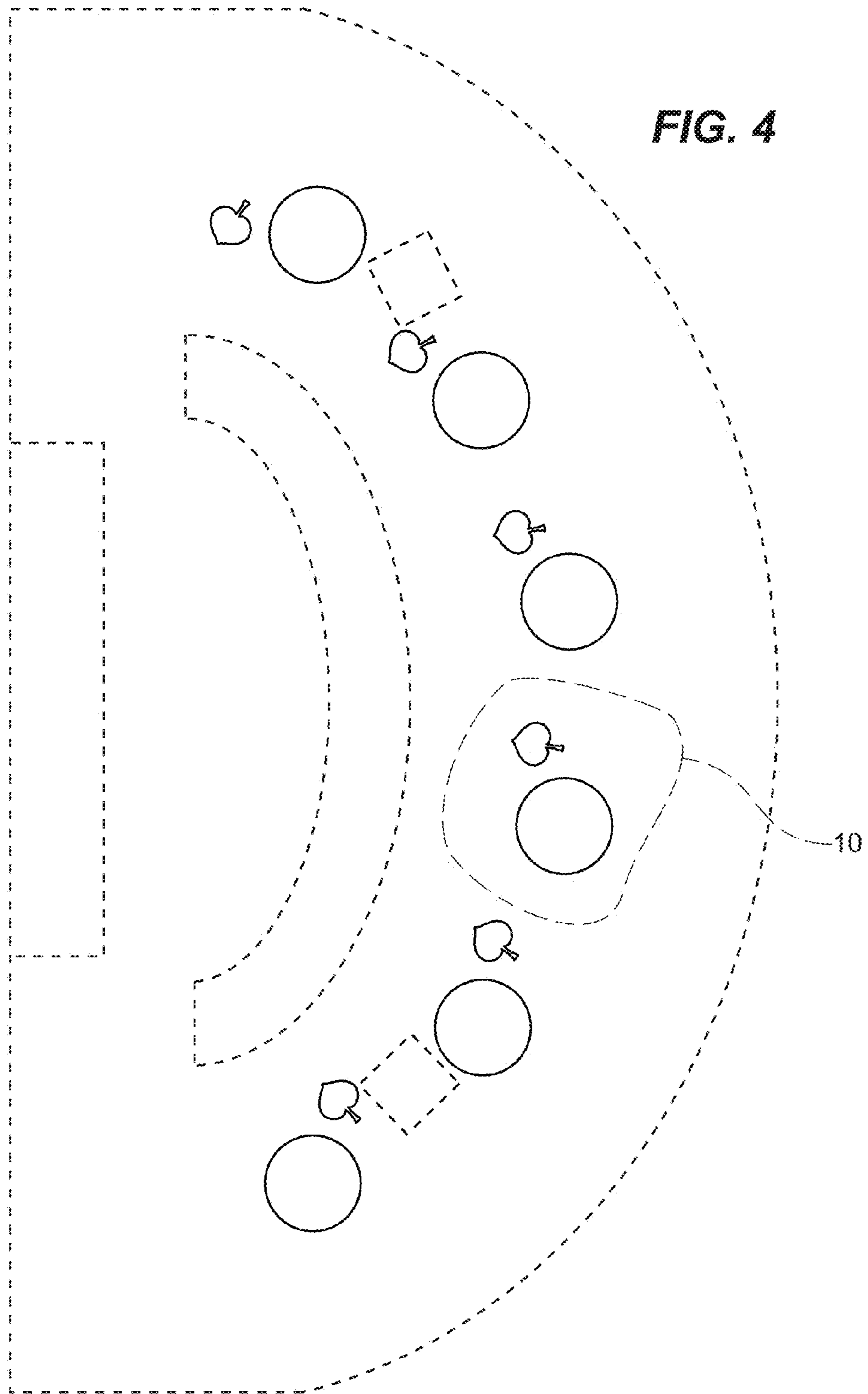

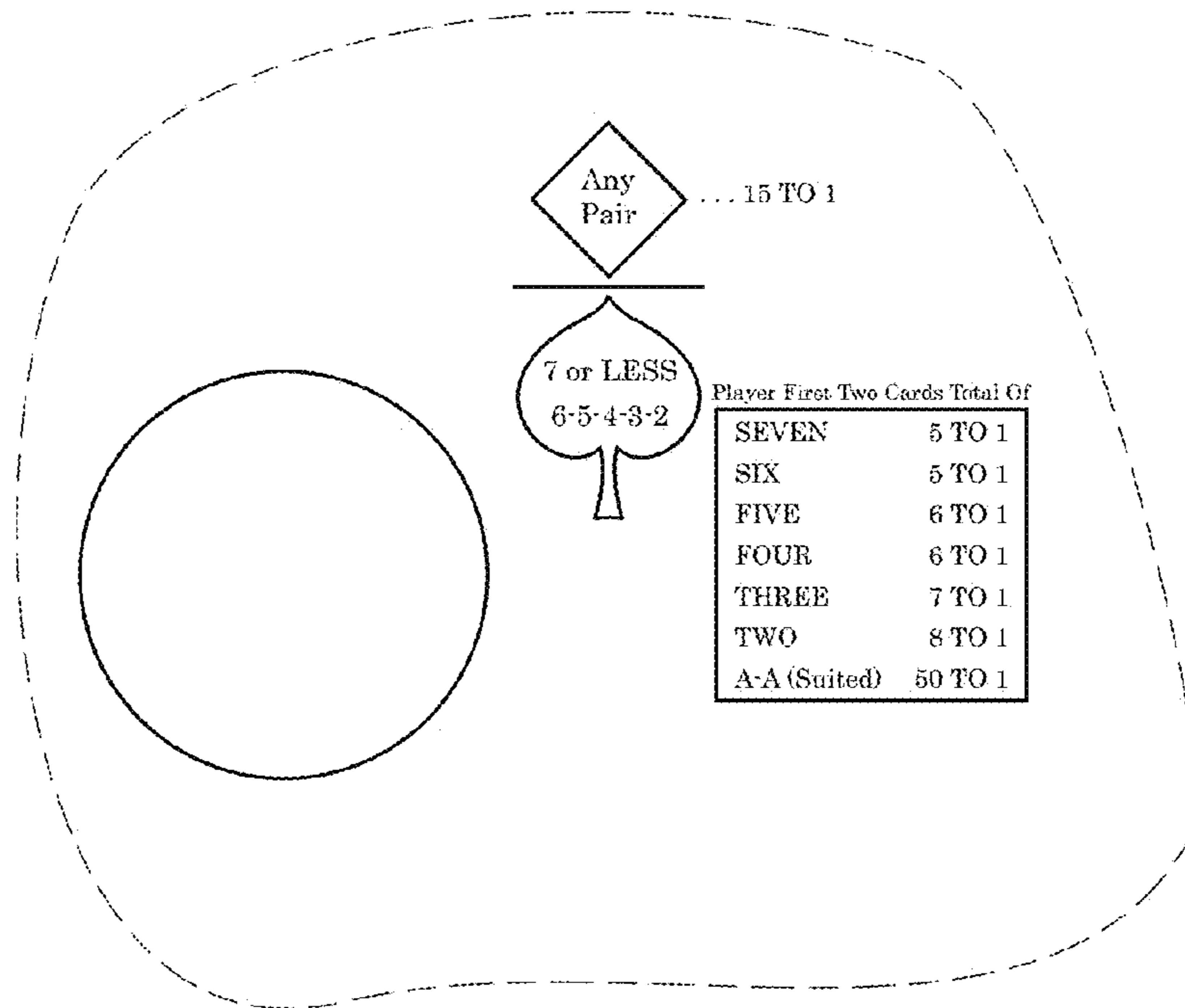

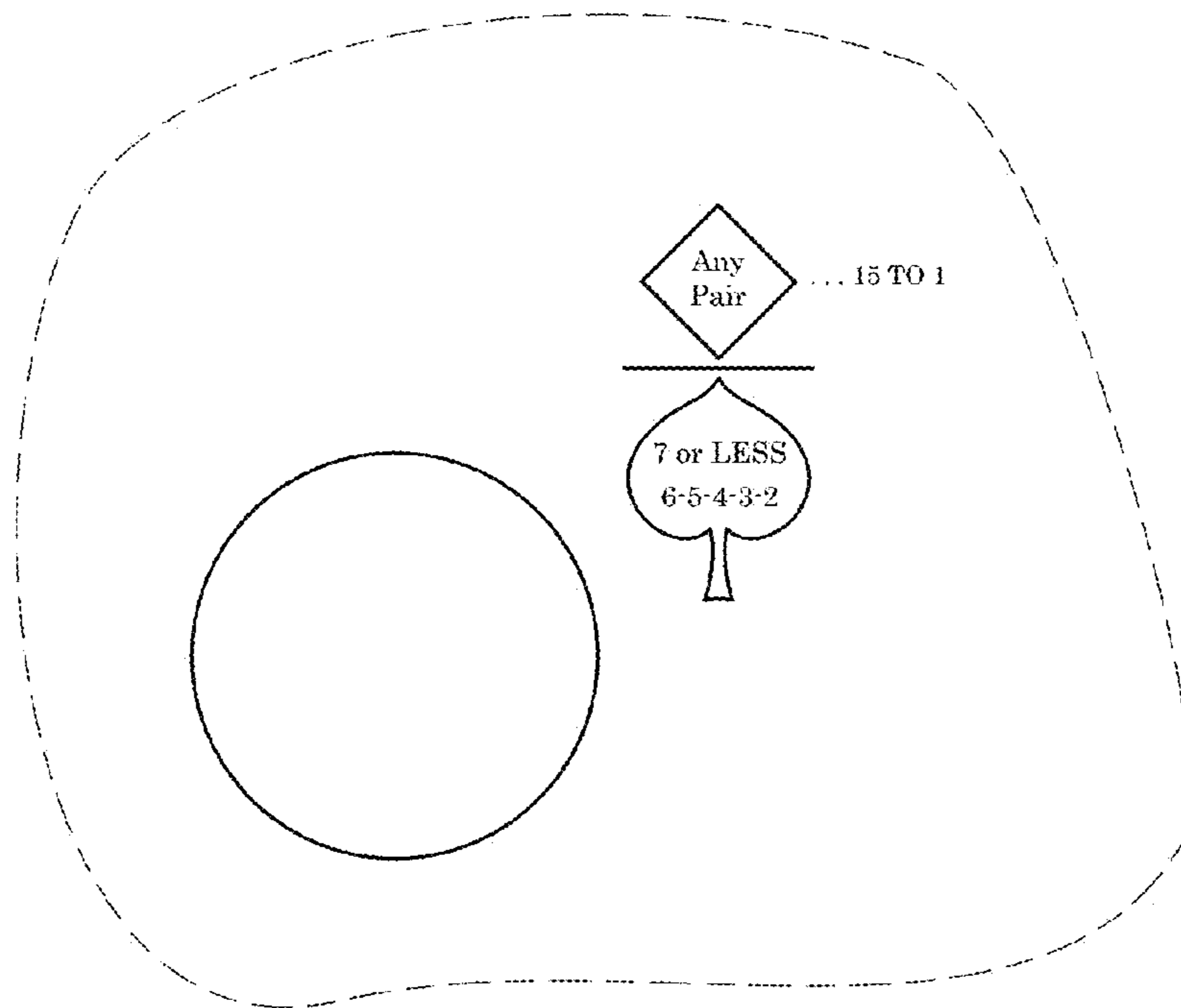

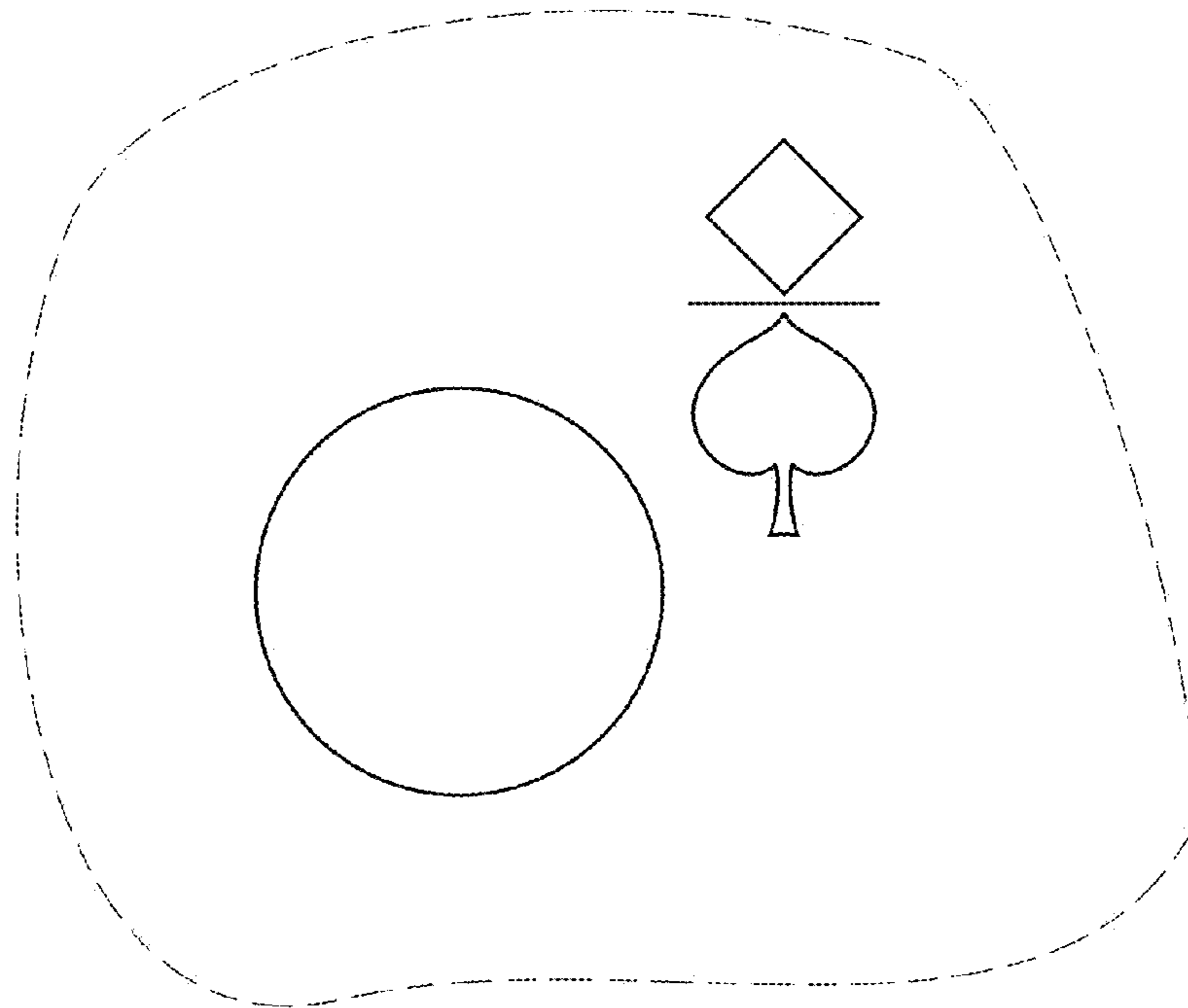

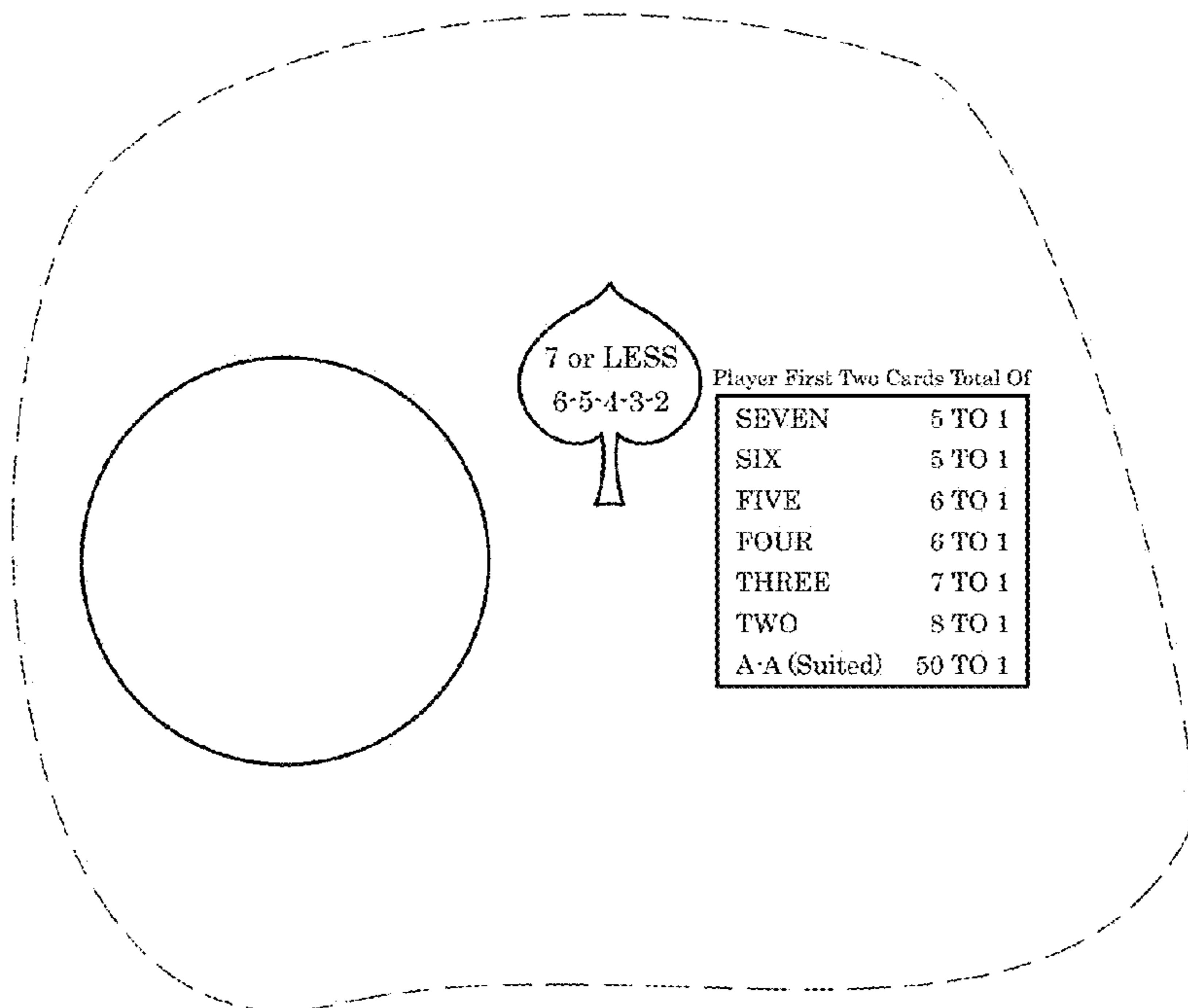

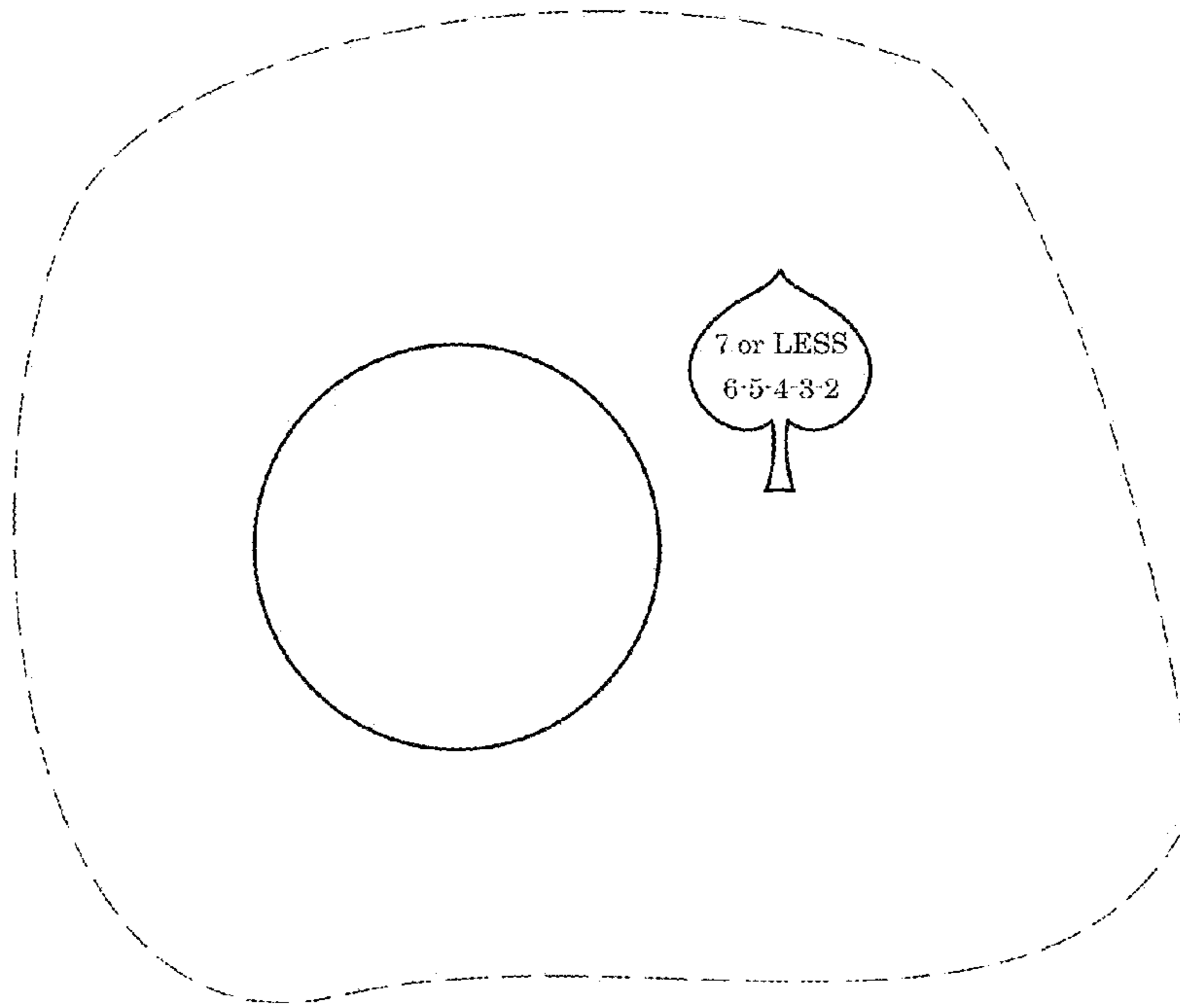
