(57) **CLAIM**

What is claimed is the ornamental design for a receiver extension tube for a firearm, as shown.

DESCRIPTION

FIG. 3 shows a top plan view of a receiver extension tube for a firearm.

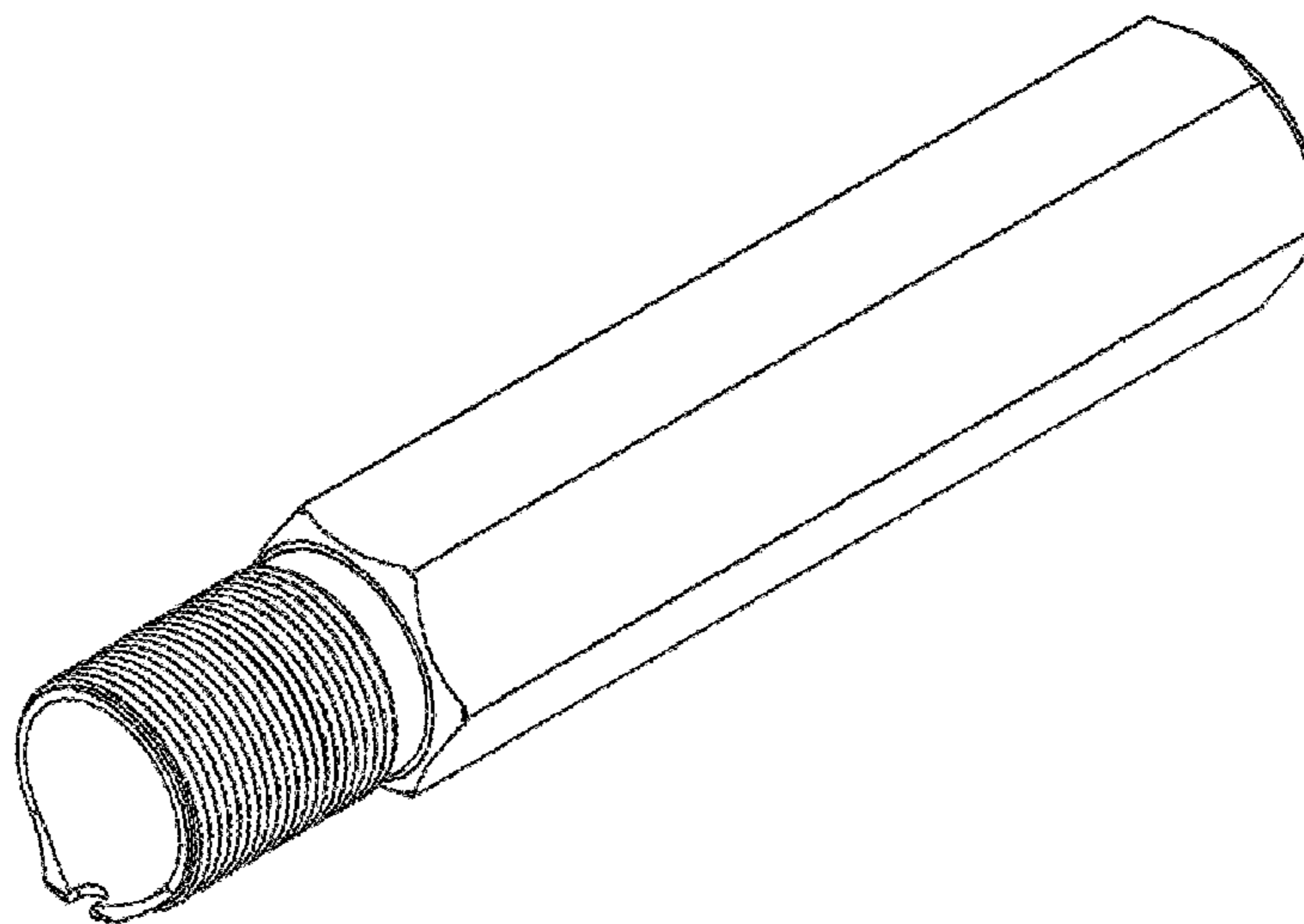
FIG. 4 shows a rear plan view of a receiver extension tube for a firearm.

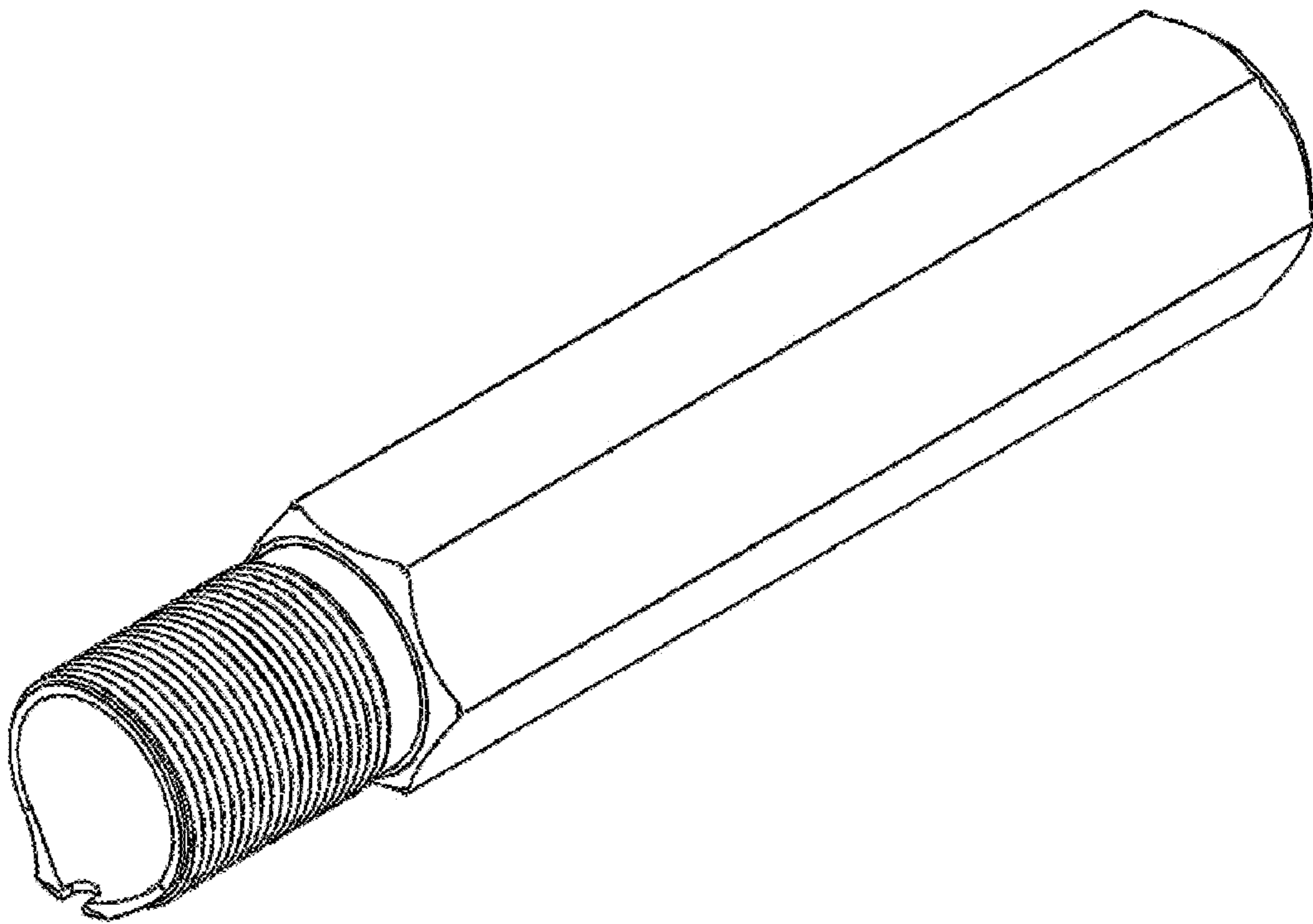

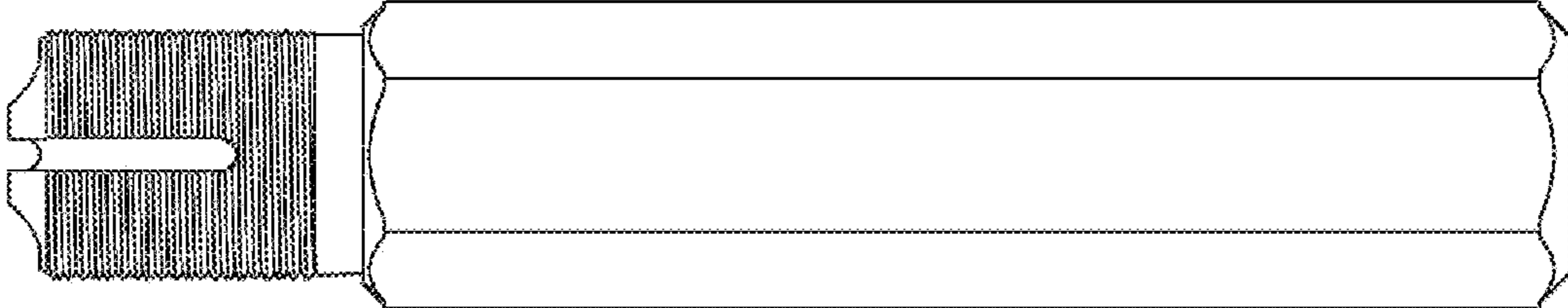

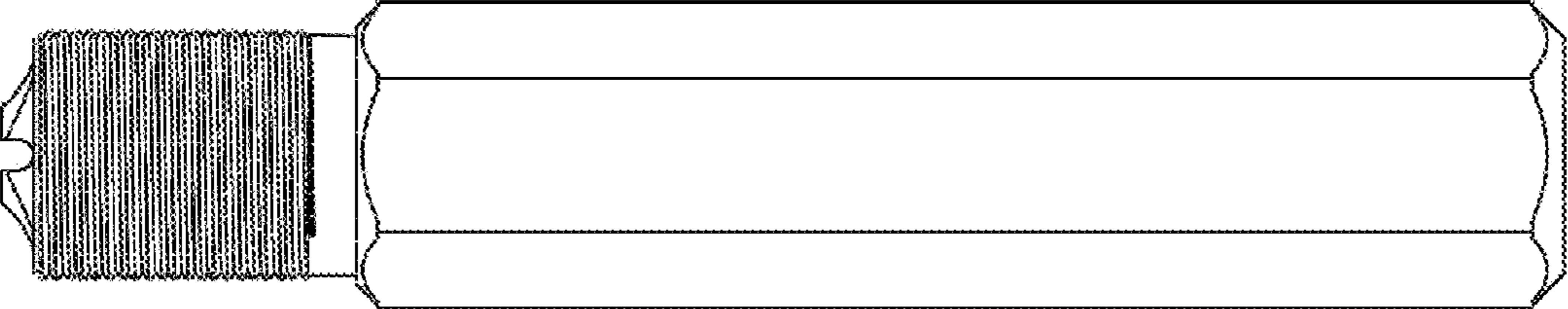

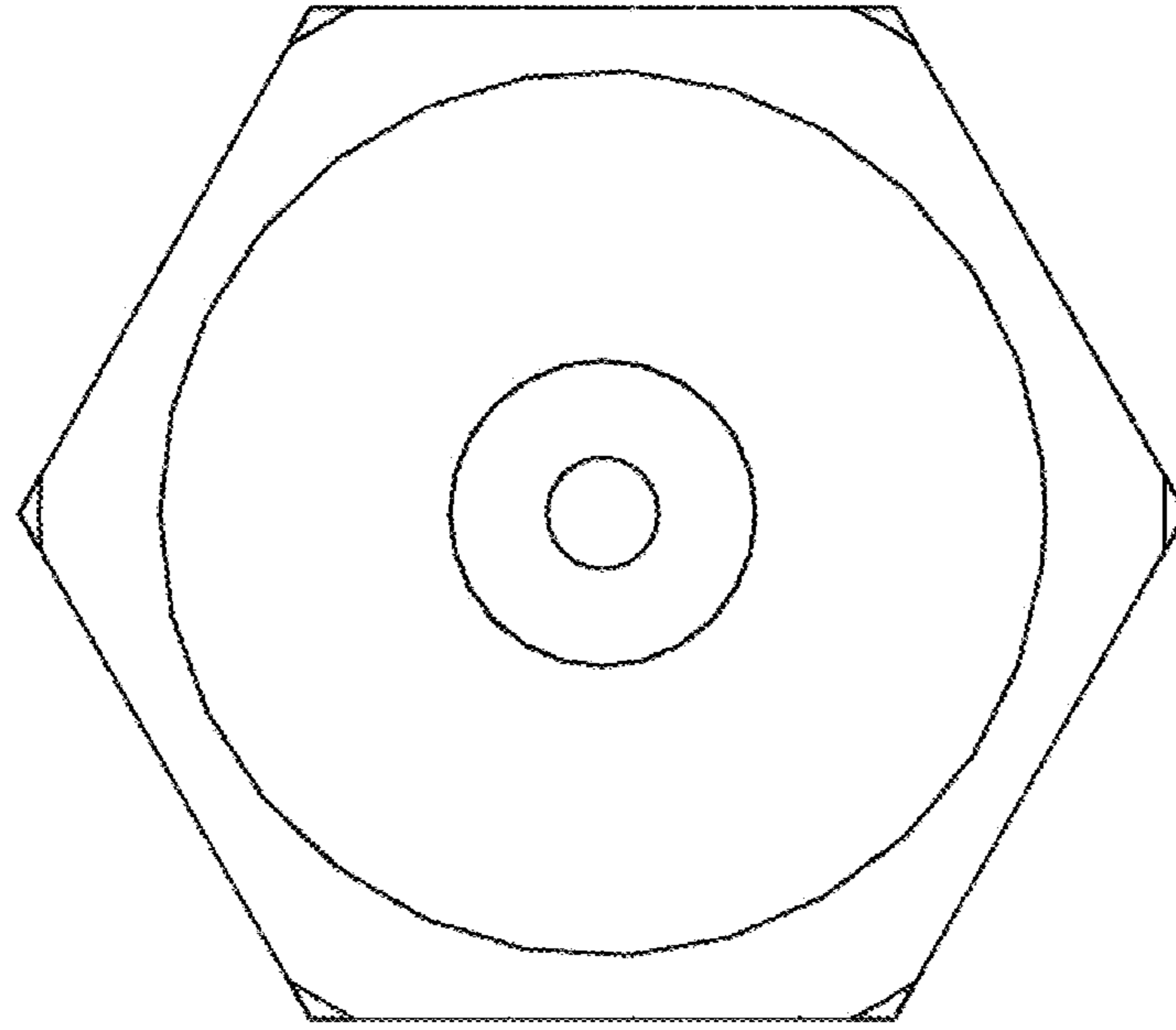

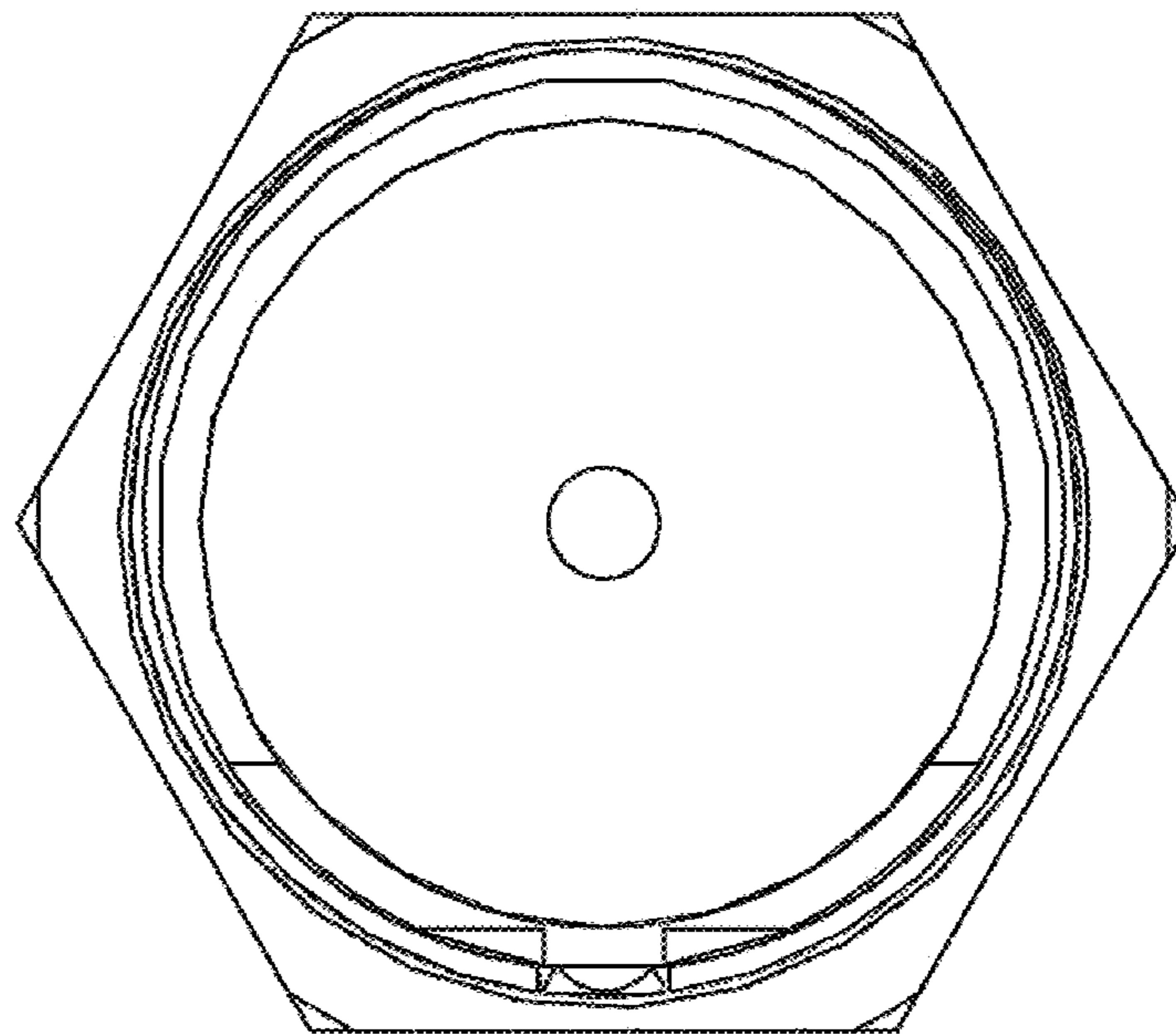

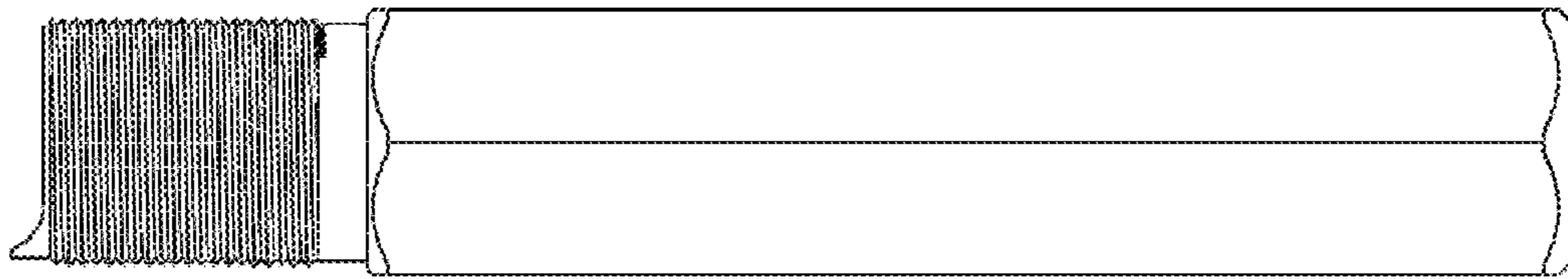

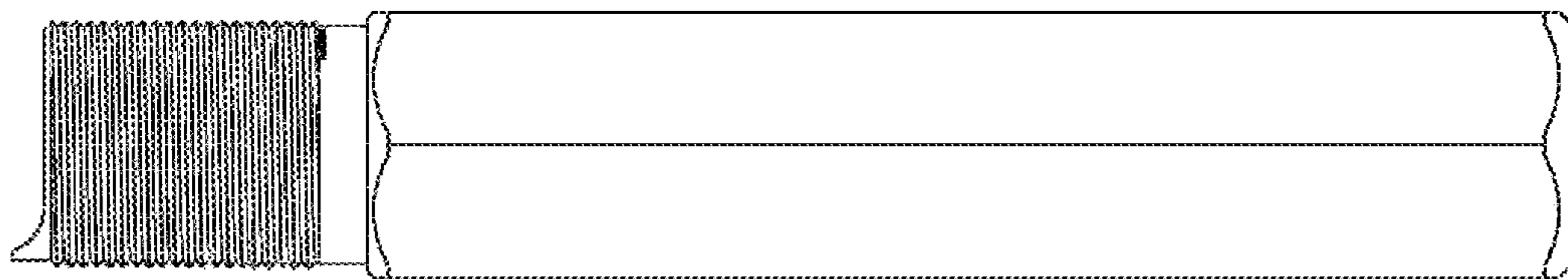
