FIG. 4 is a top plan view of the sink mixer of FIG. 1.

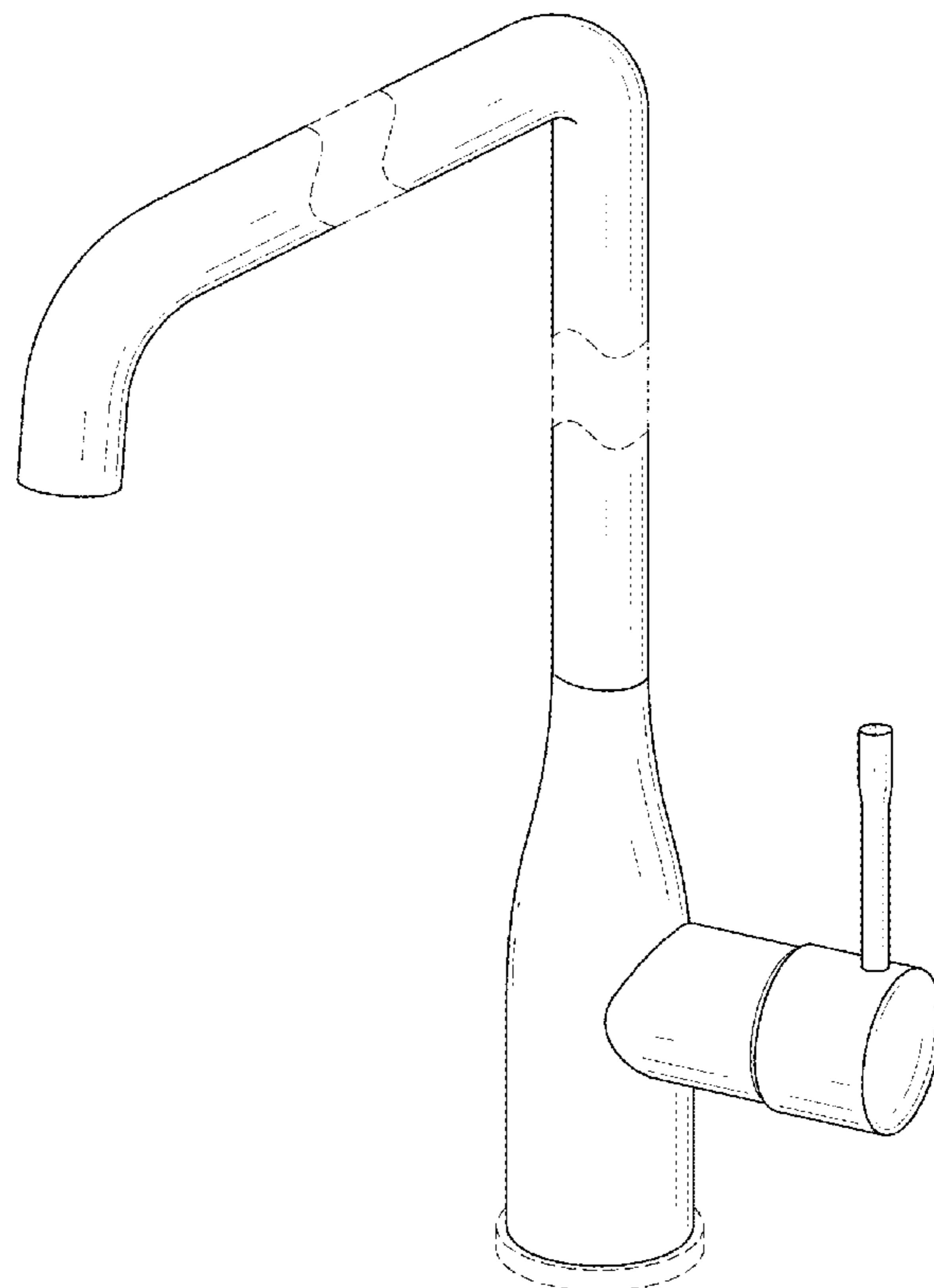
FIG. 5 is a rear view of the sink mixer of FIG. 1.

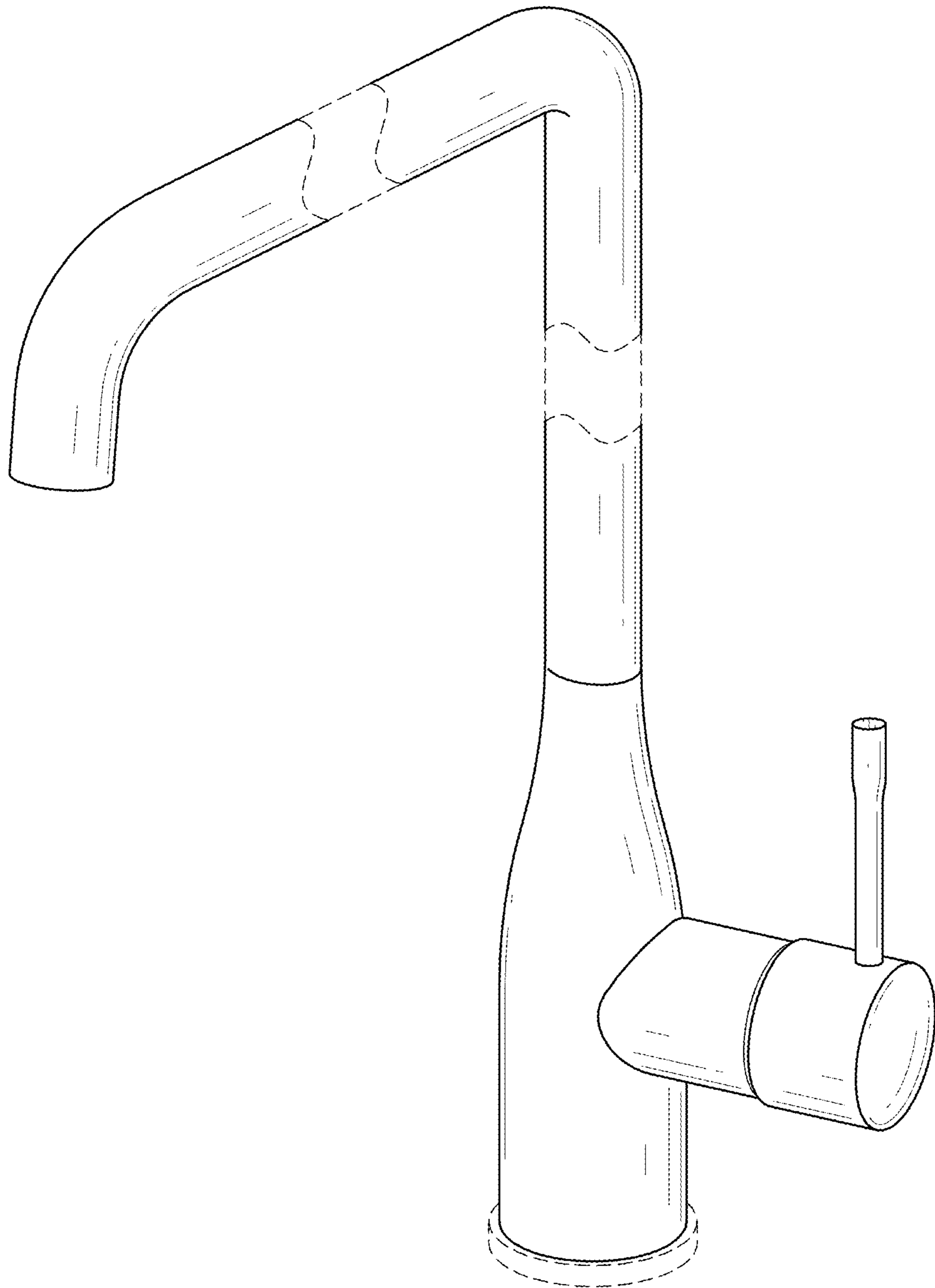

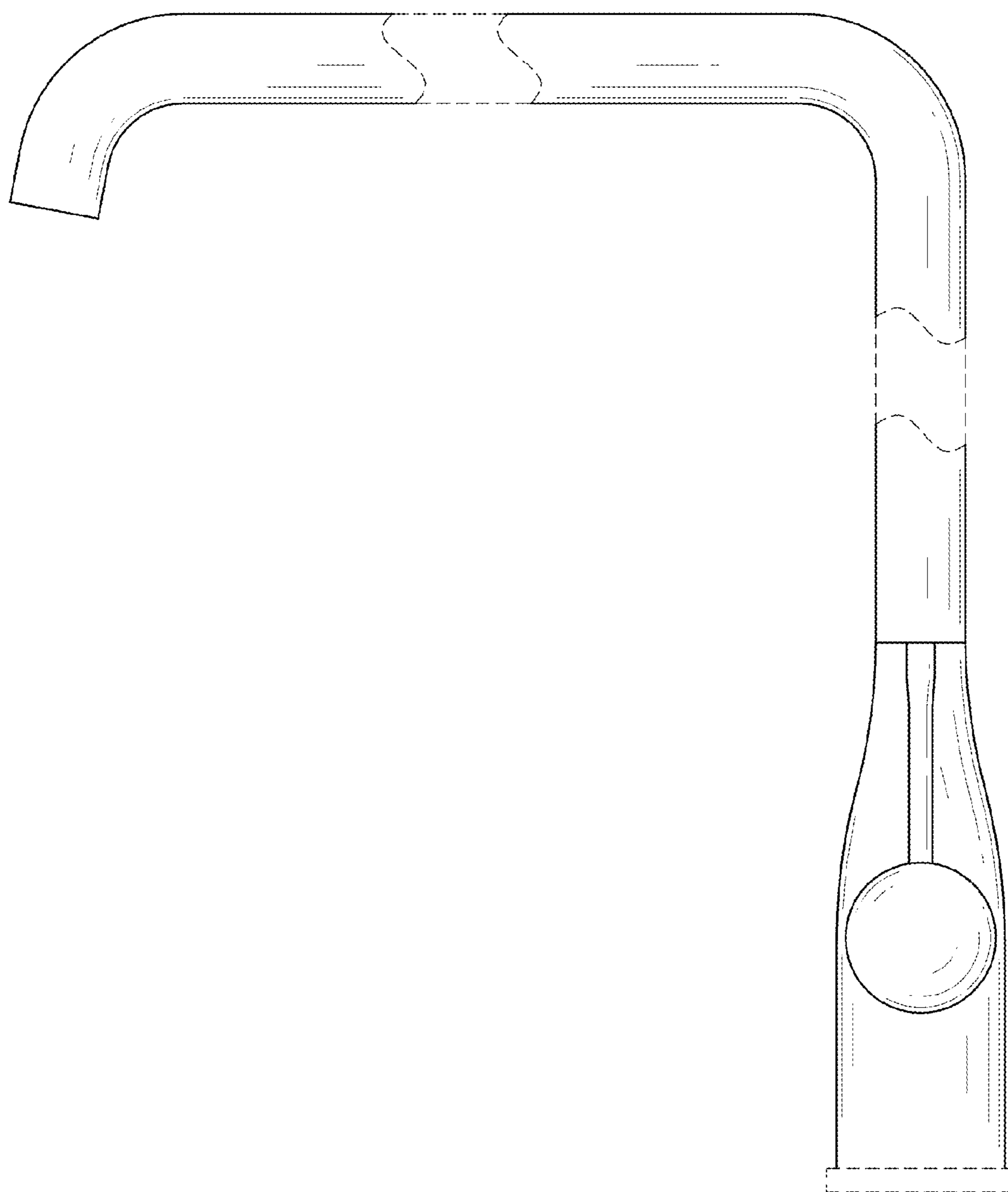

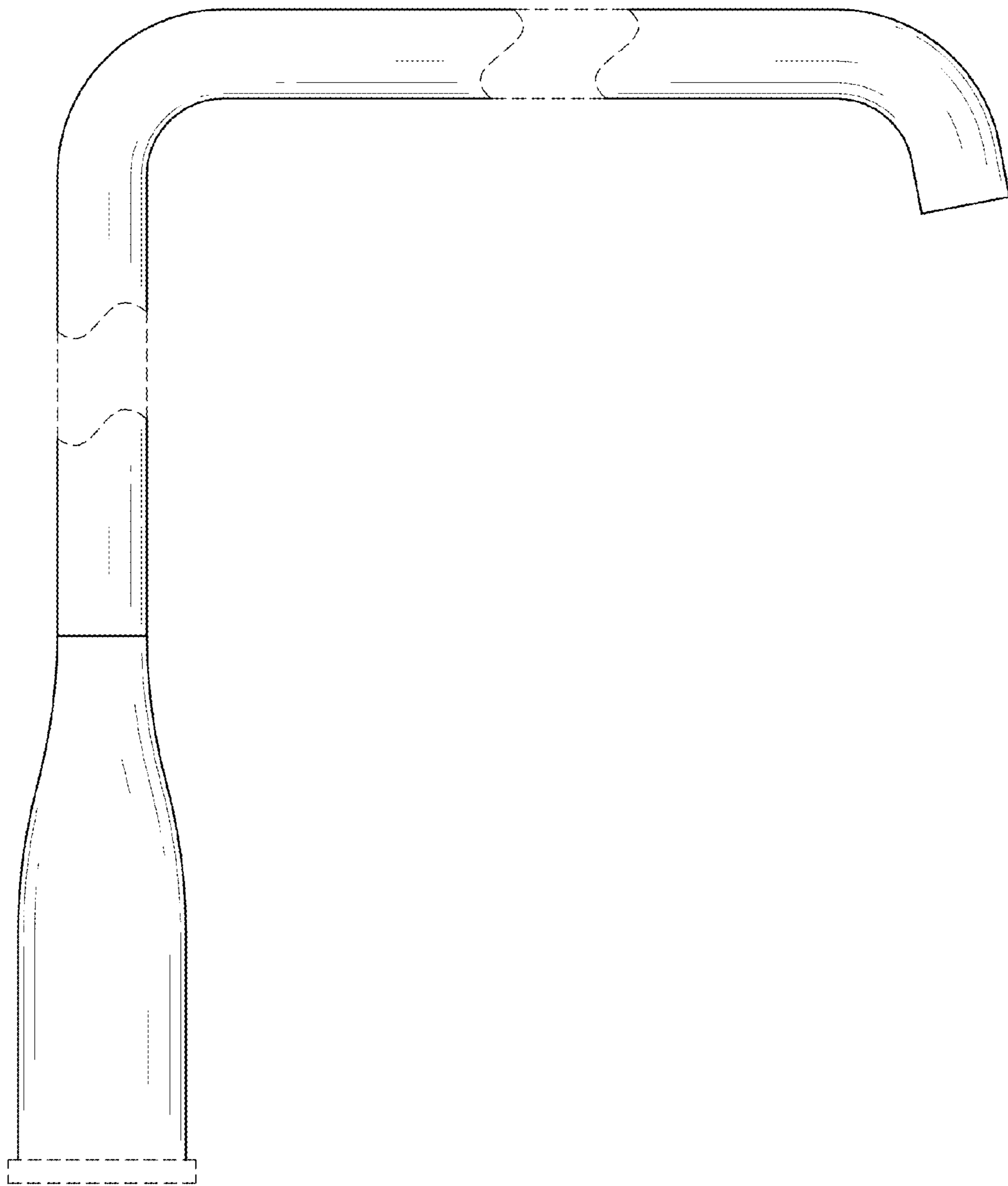

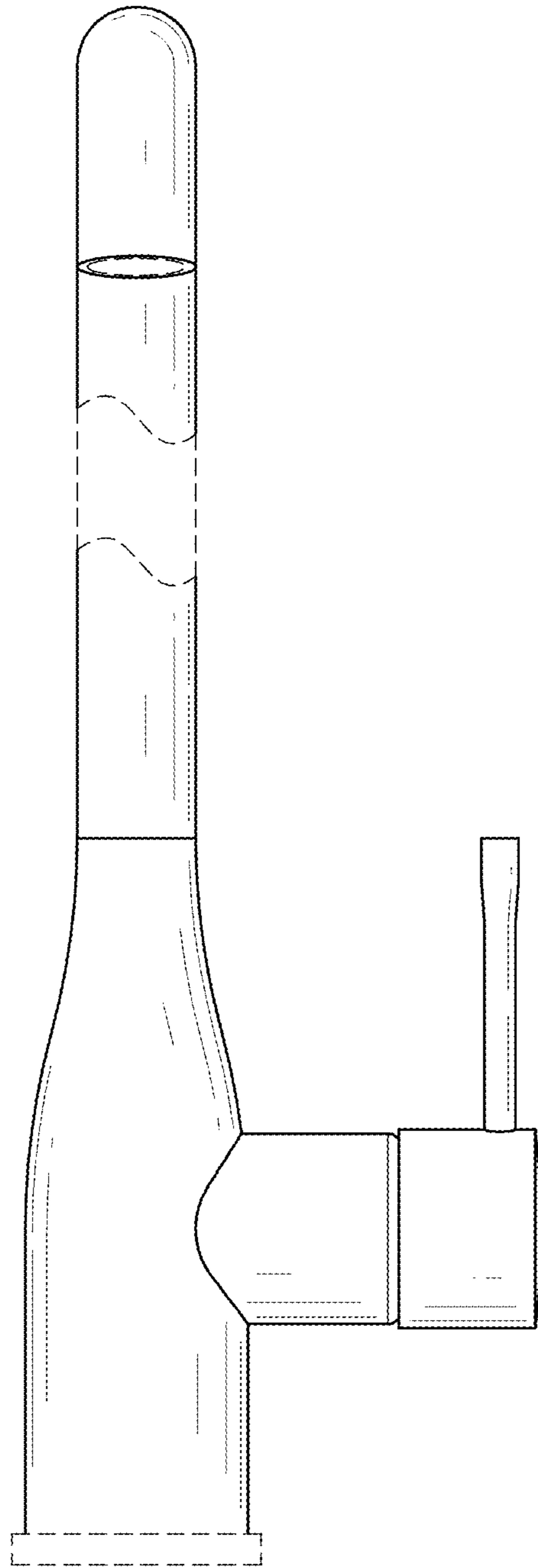

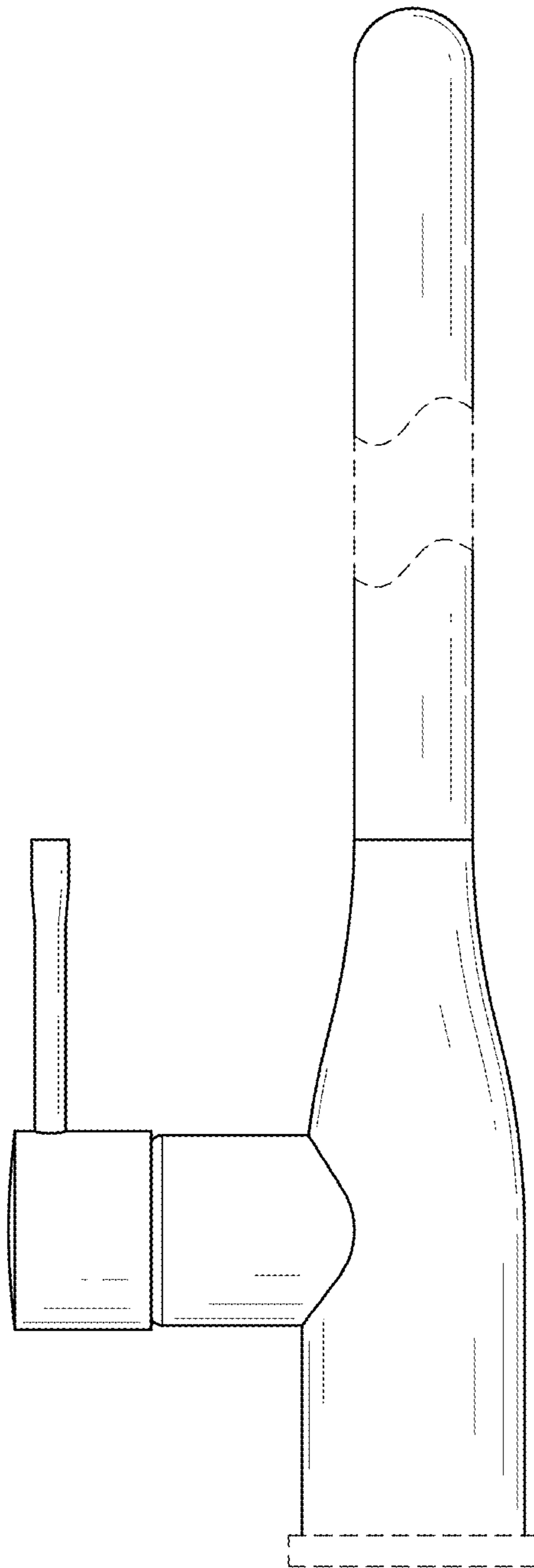

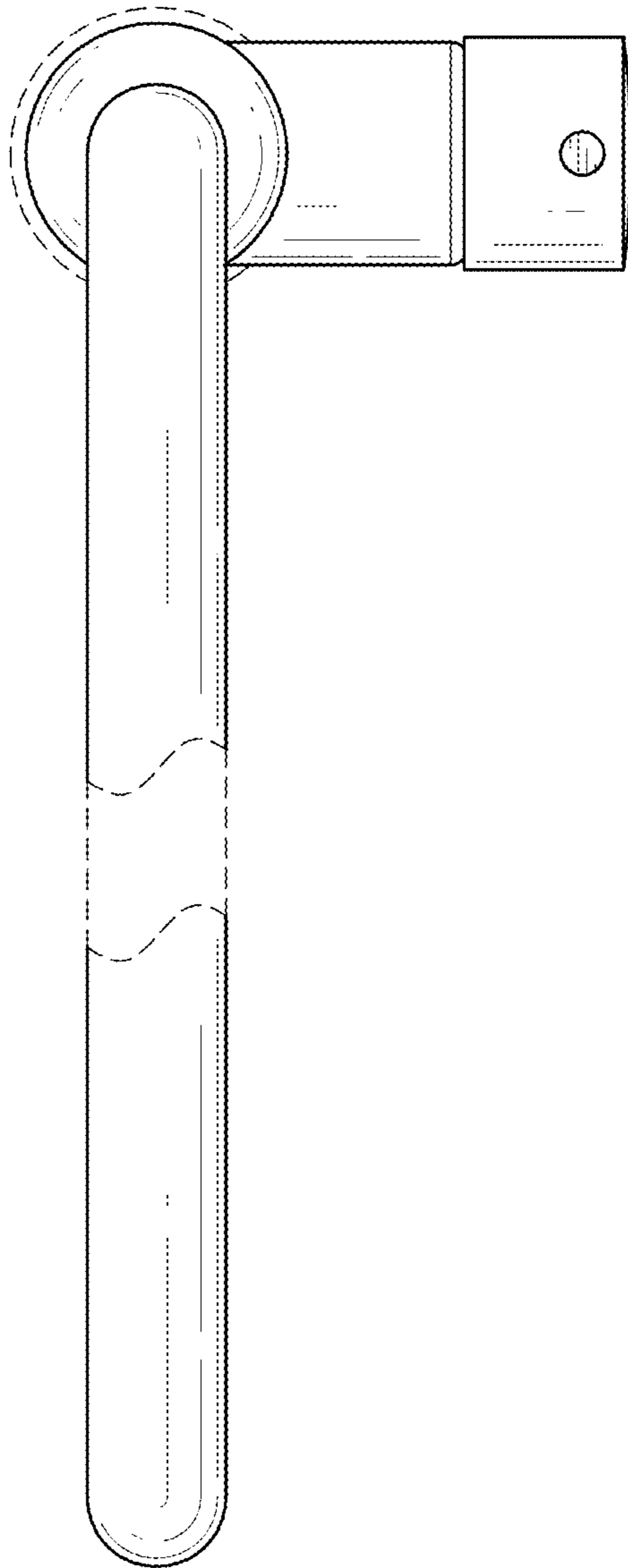

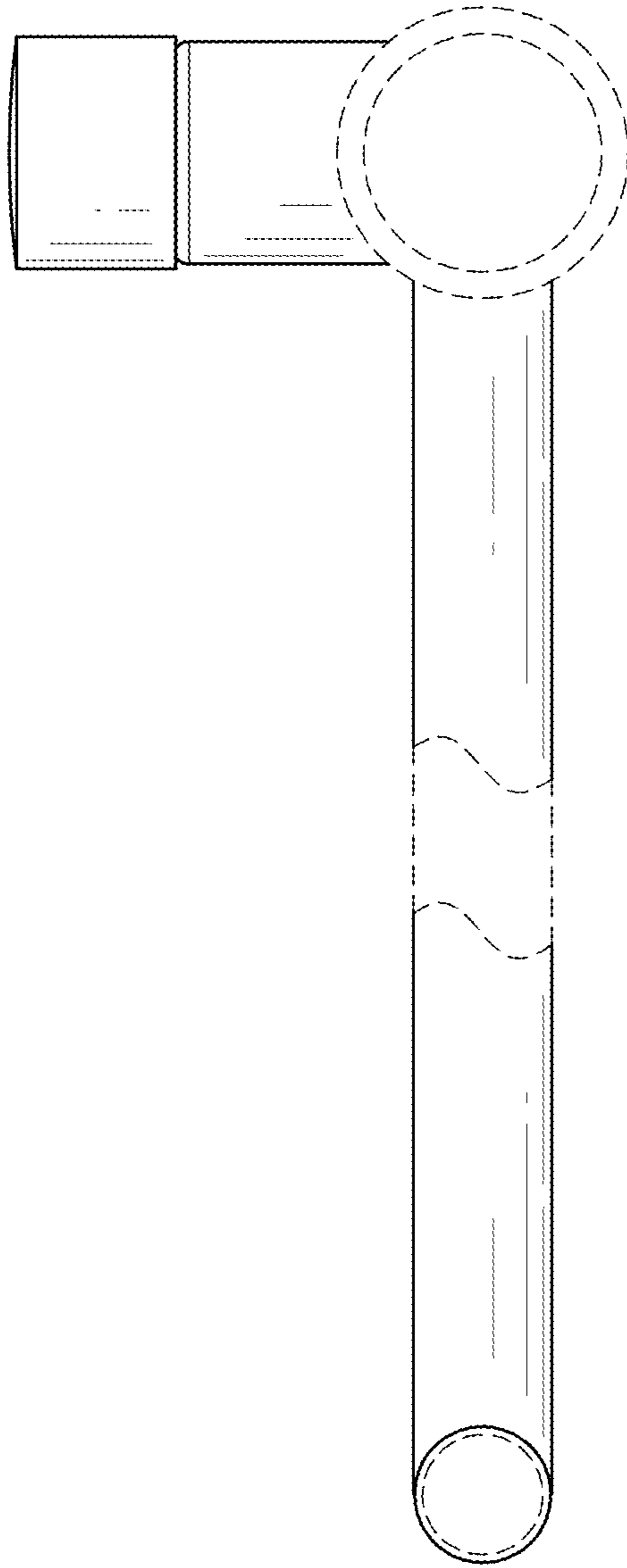
