(57) **CLAIM**

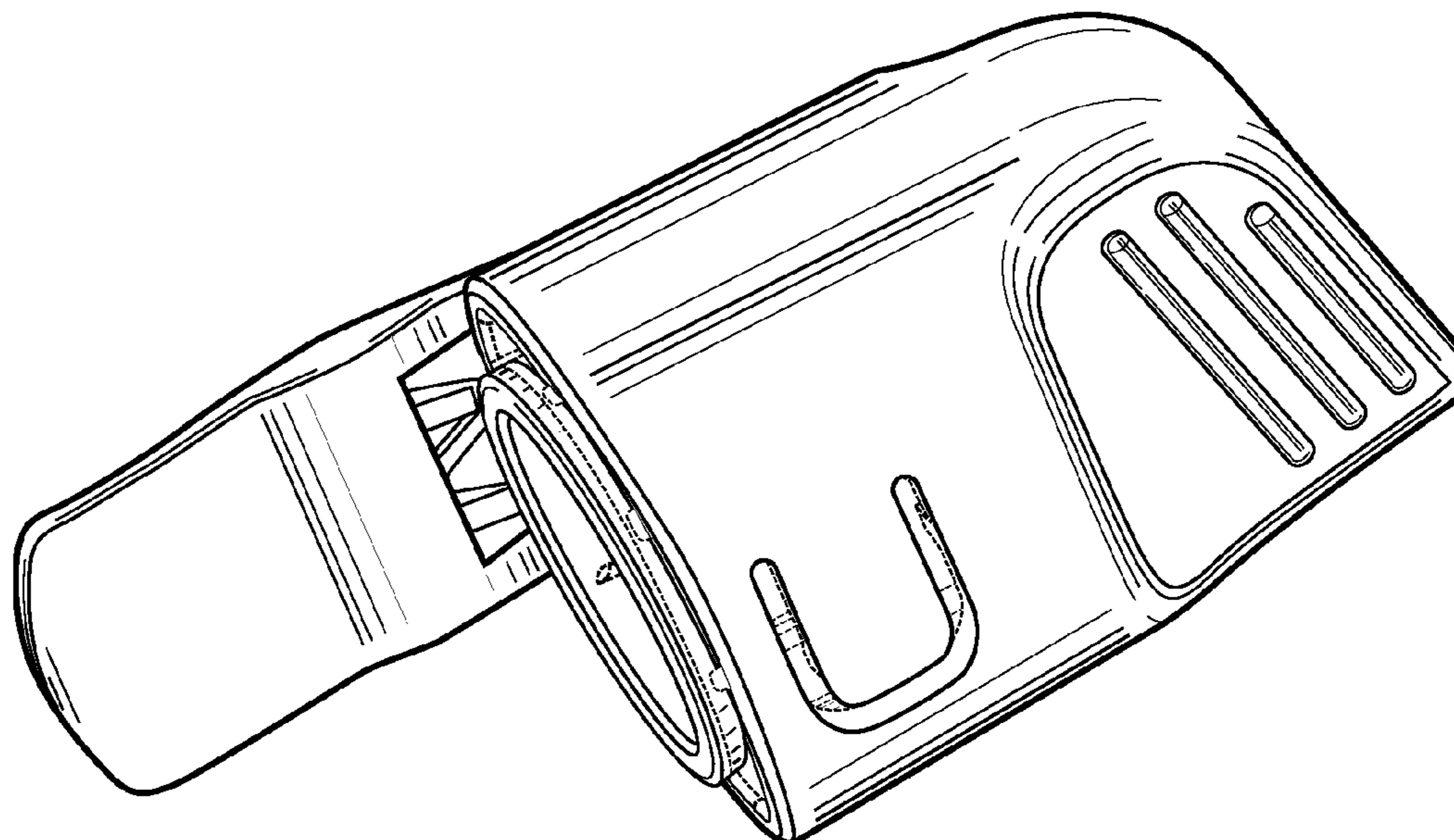
The ornamental design for a pen needle outer cover with

**DESCRIPTION**

FIG. 1 is a perspective view of a preferred embodiment of a  
pen needle outer cover with non-patient end closure;  
FIG. 2 is a left side elevation view thereof;  
FIG. 3 is a rear side elevation view thereof;

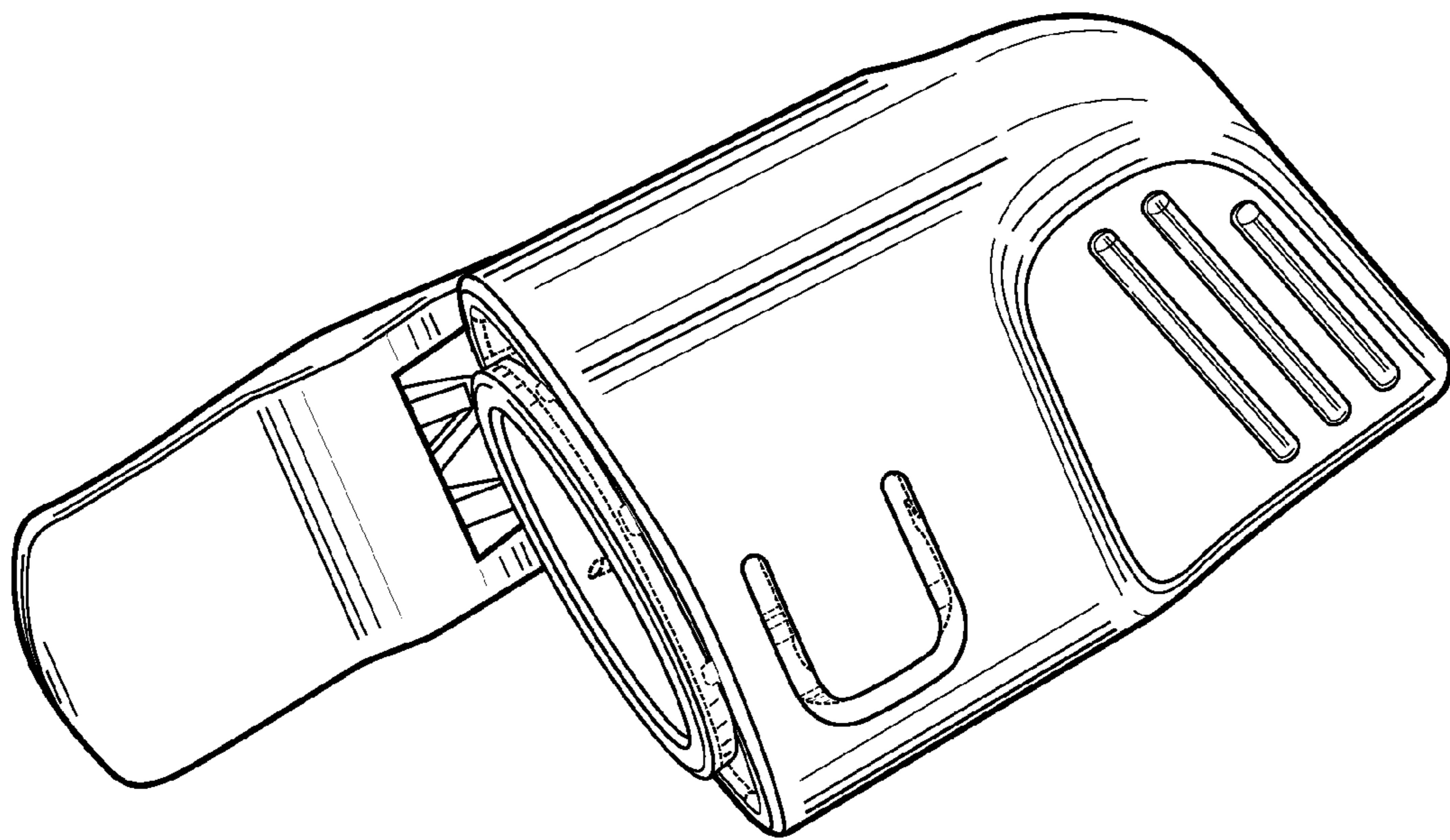

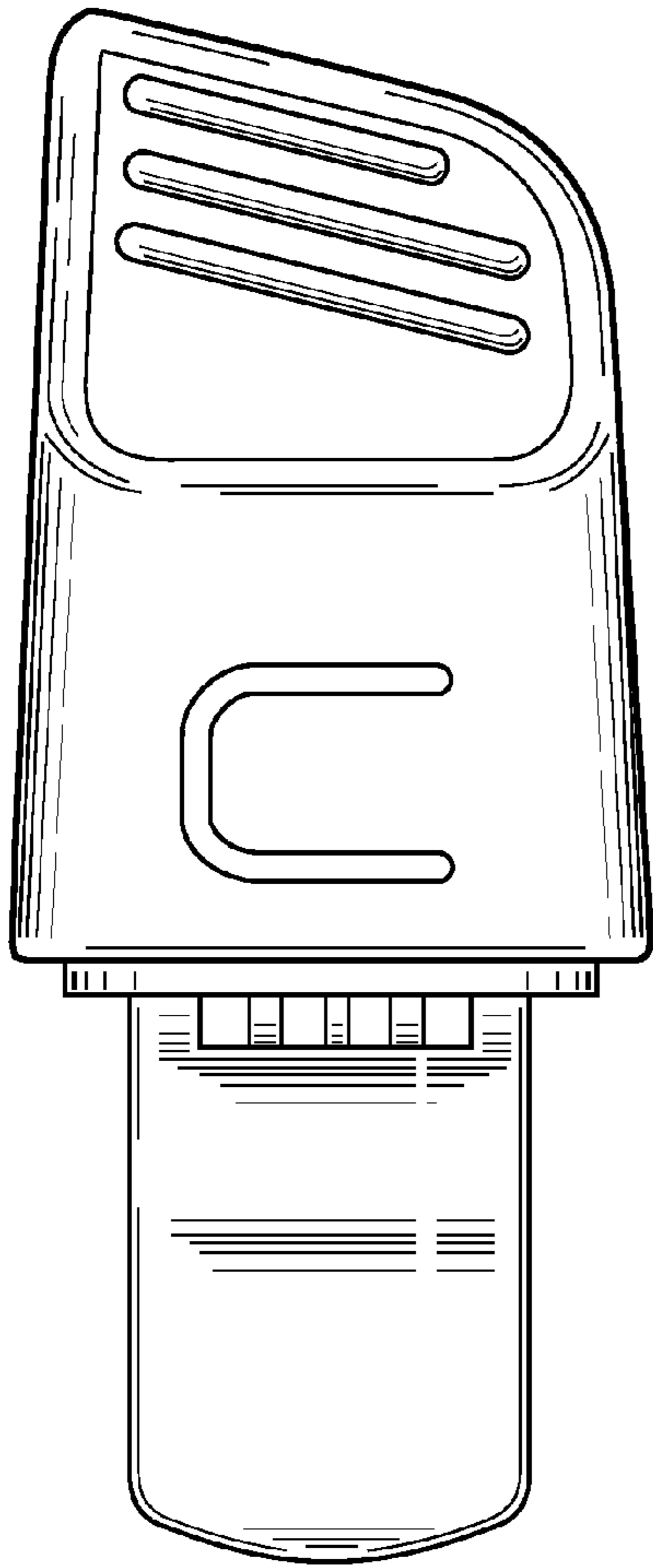

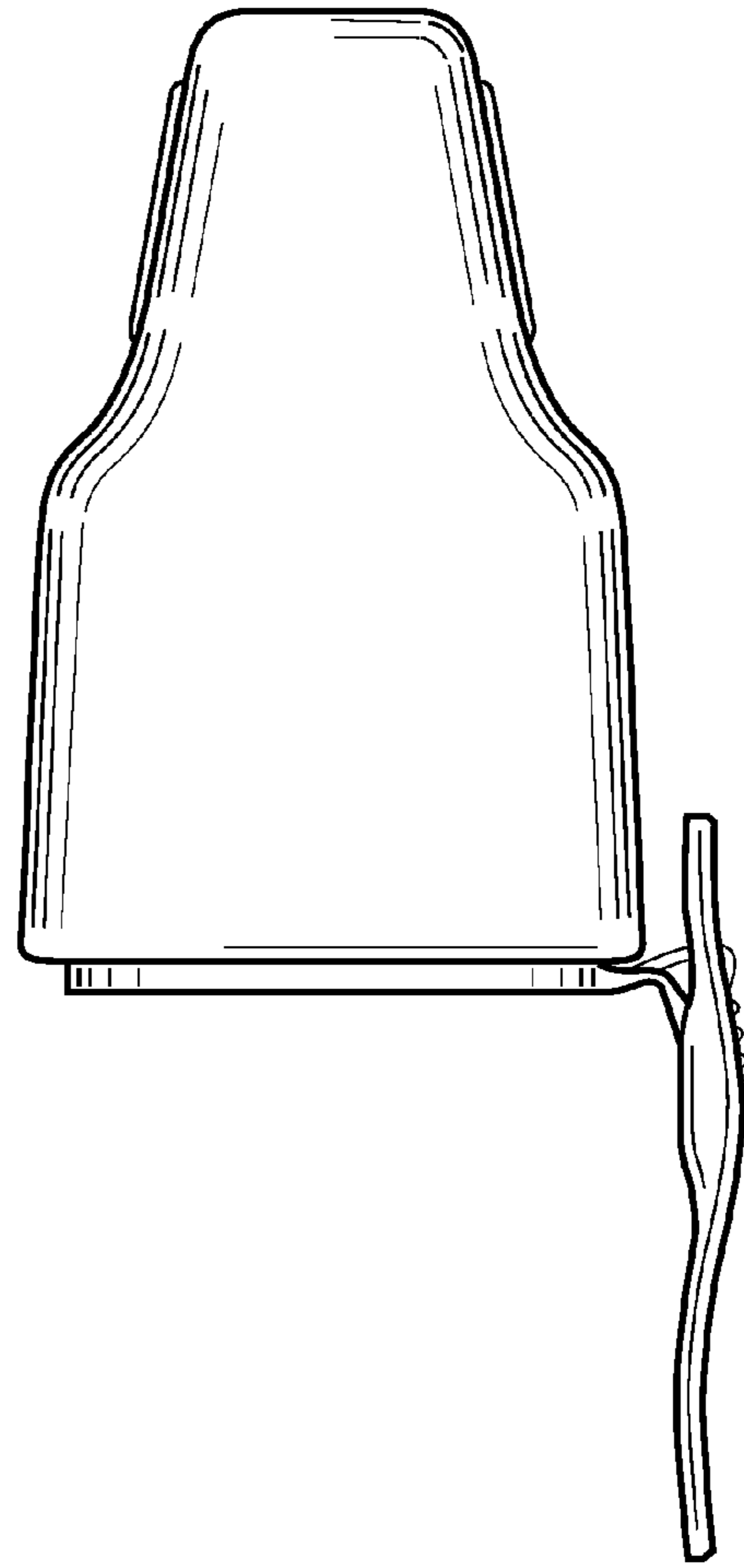

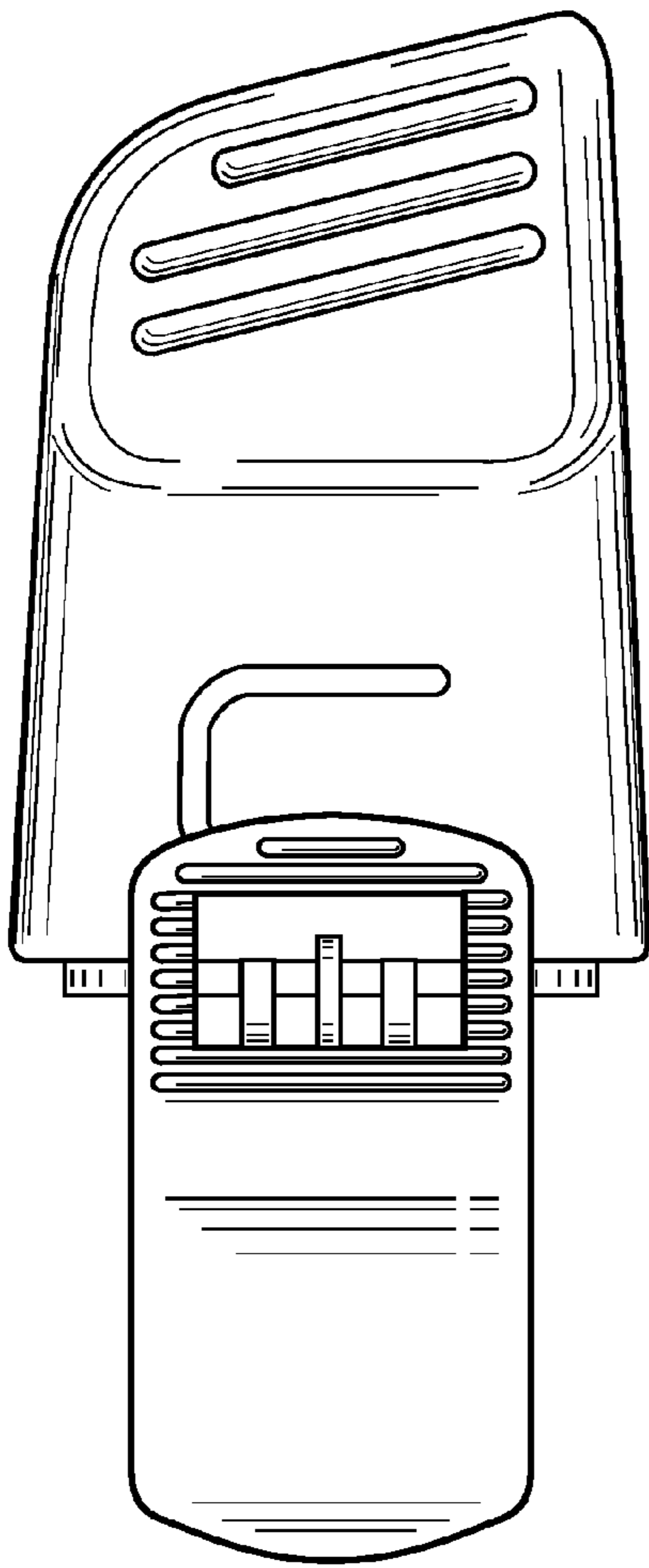

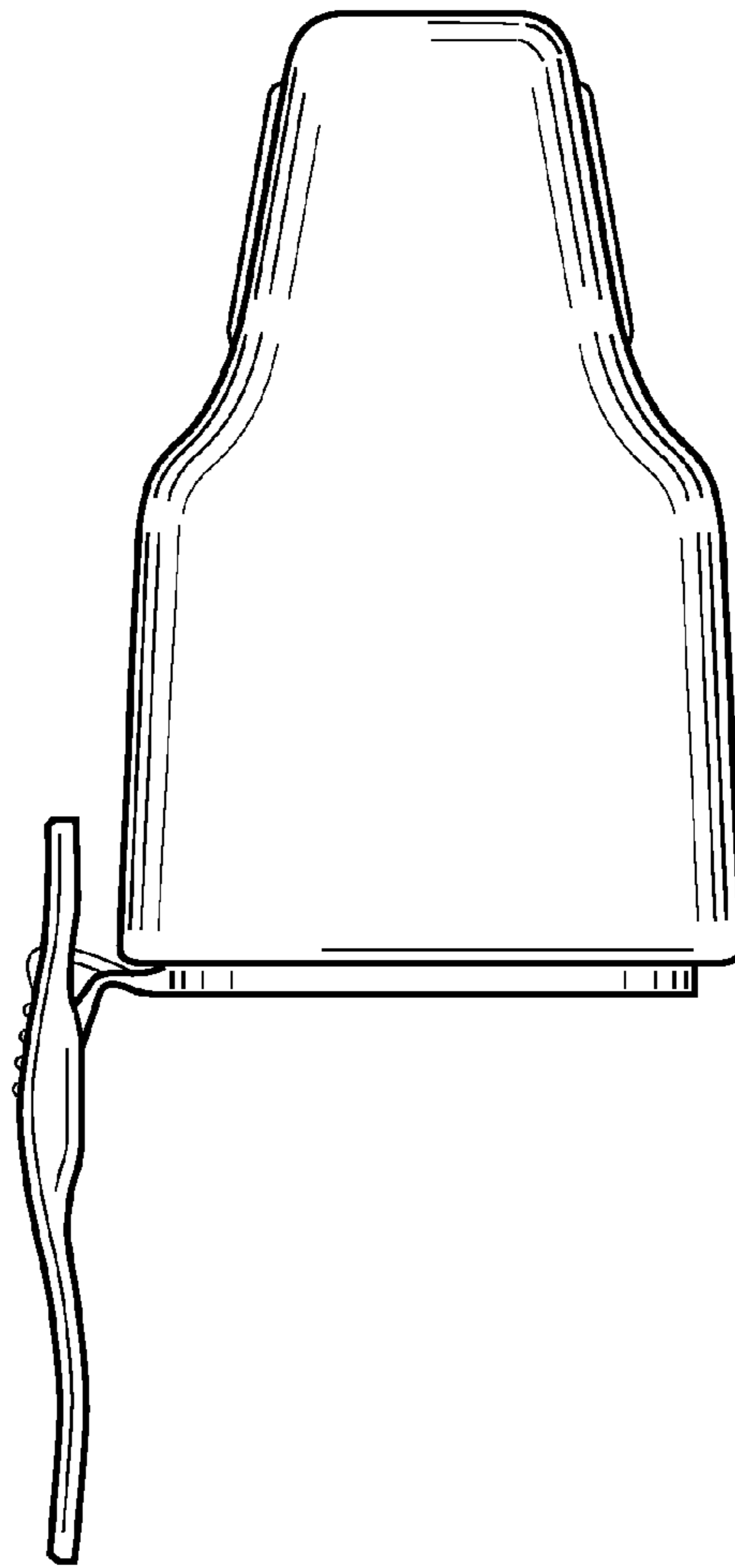

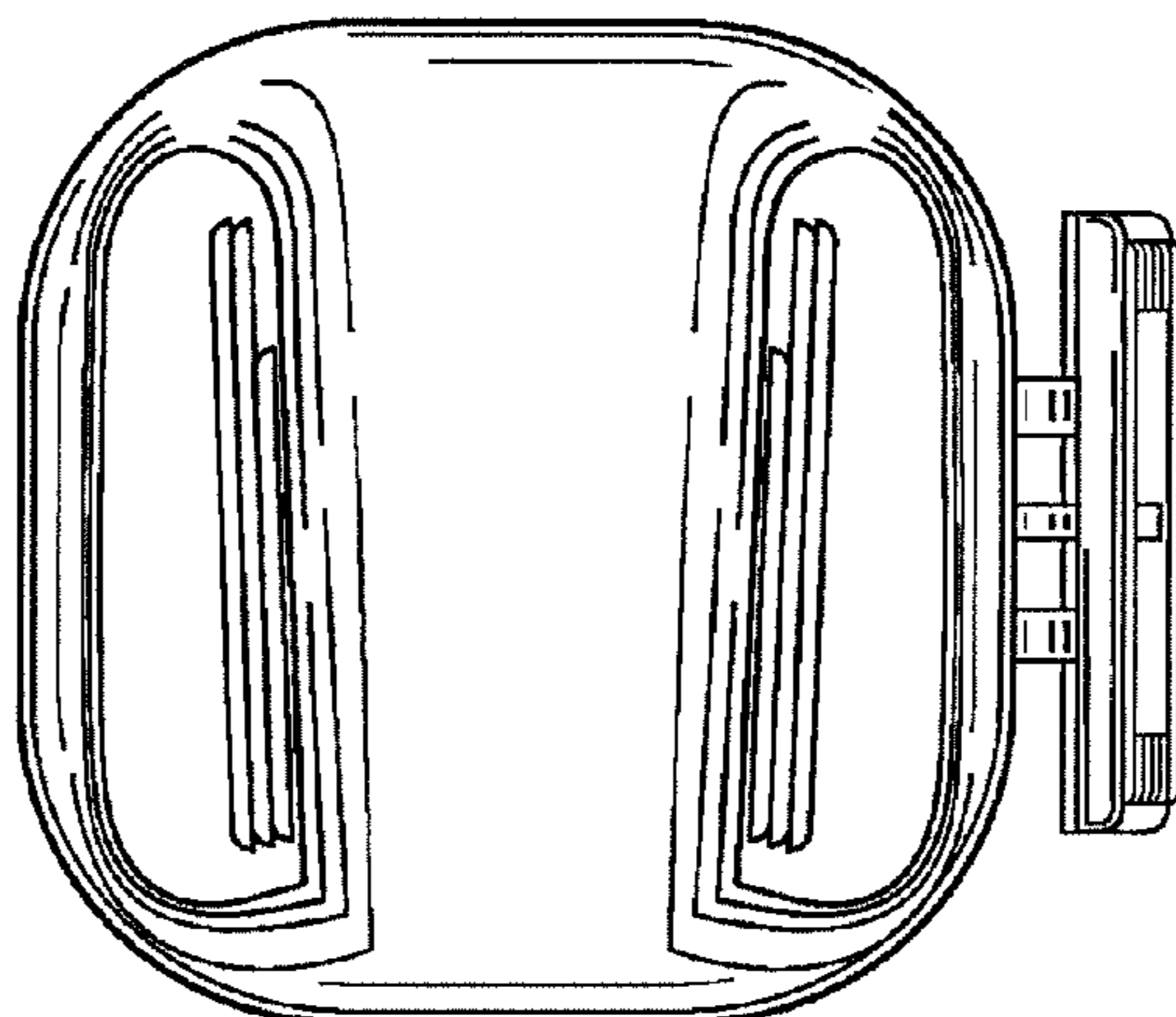

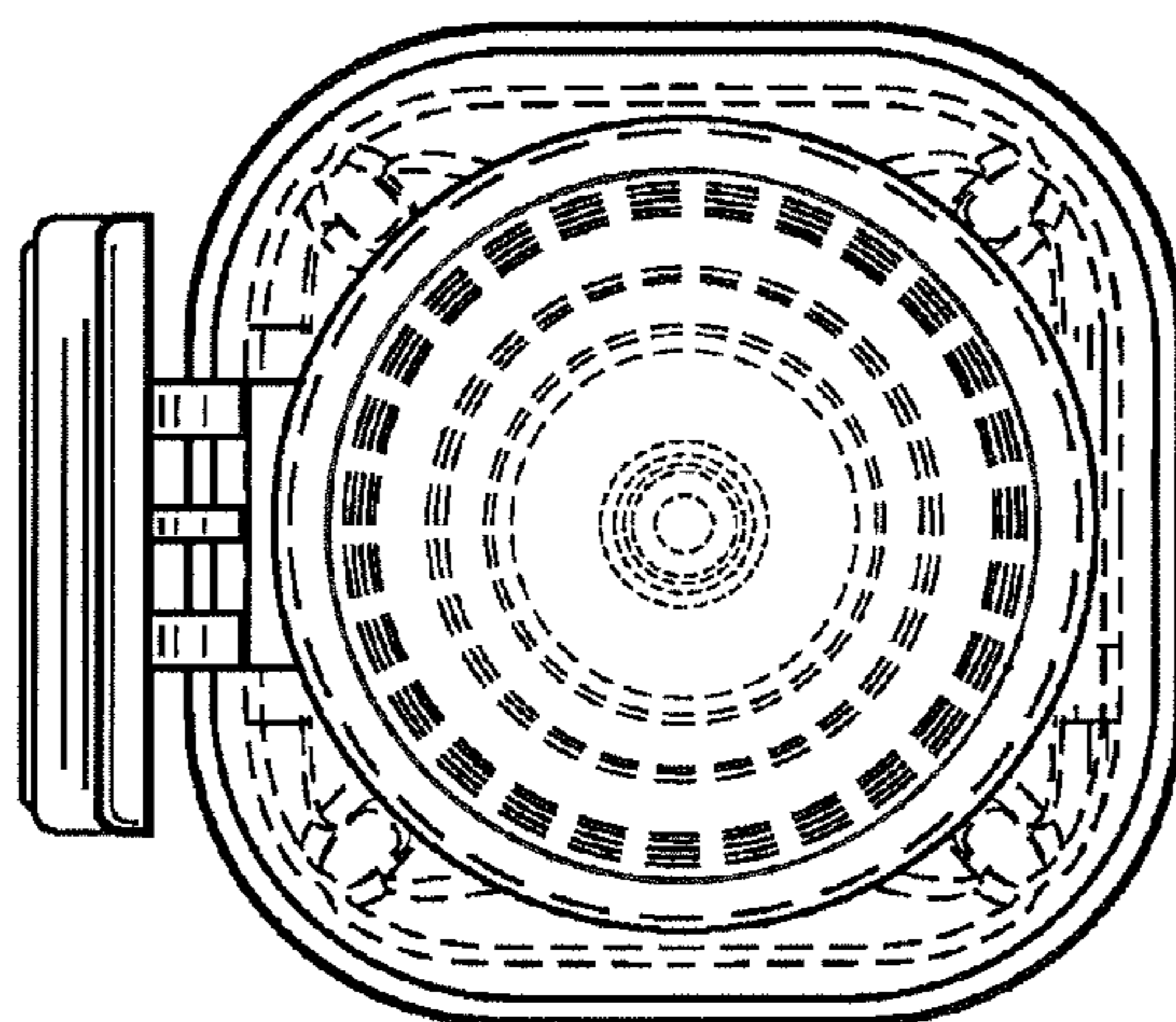
