The ornamental design for a head lamp for automobiles, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a head lamp for automobiles according to the present invention.

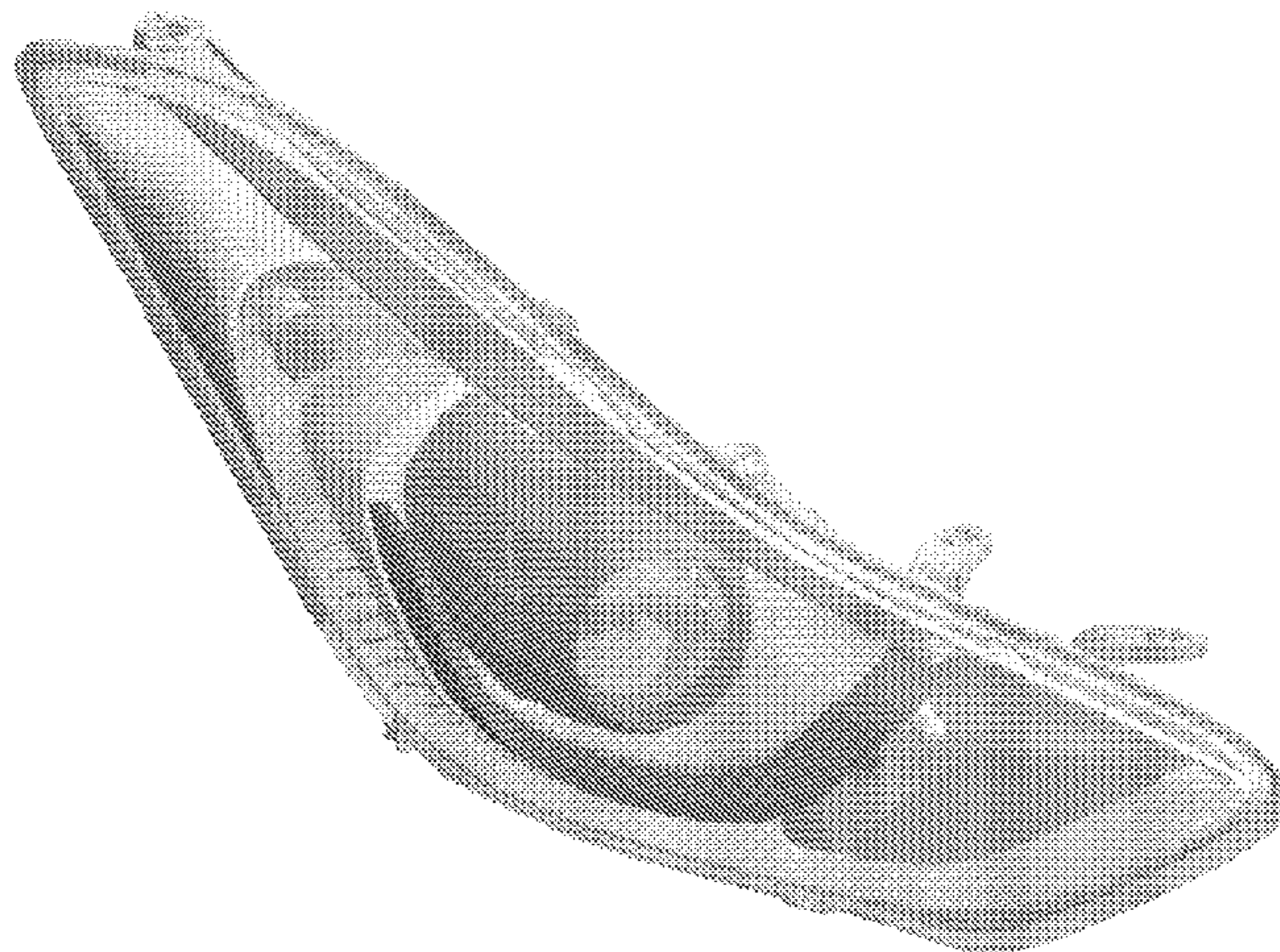

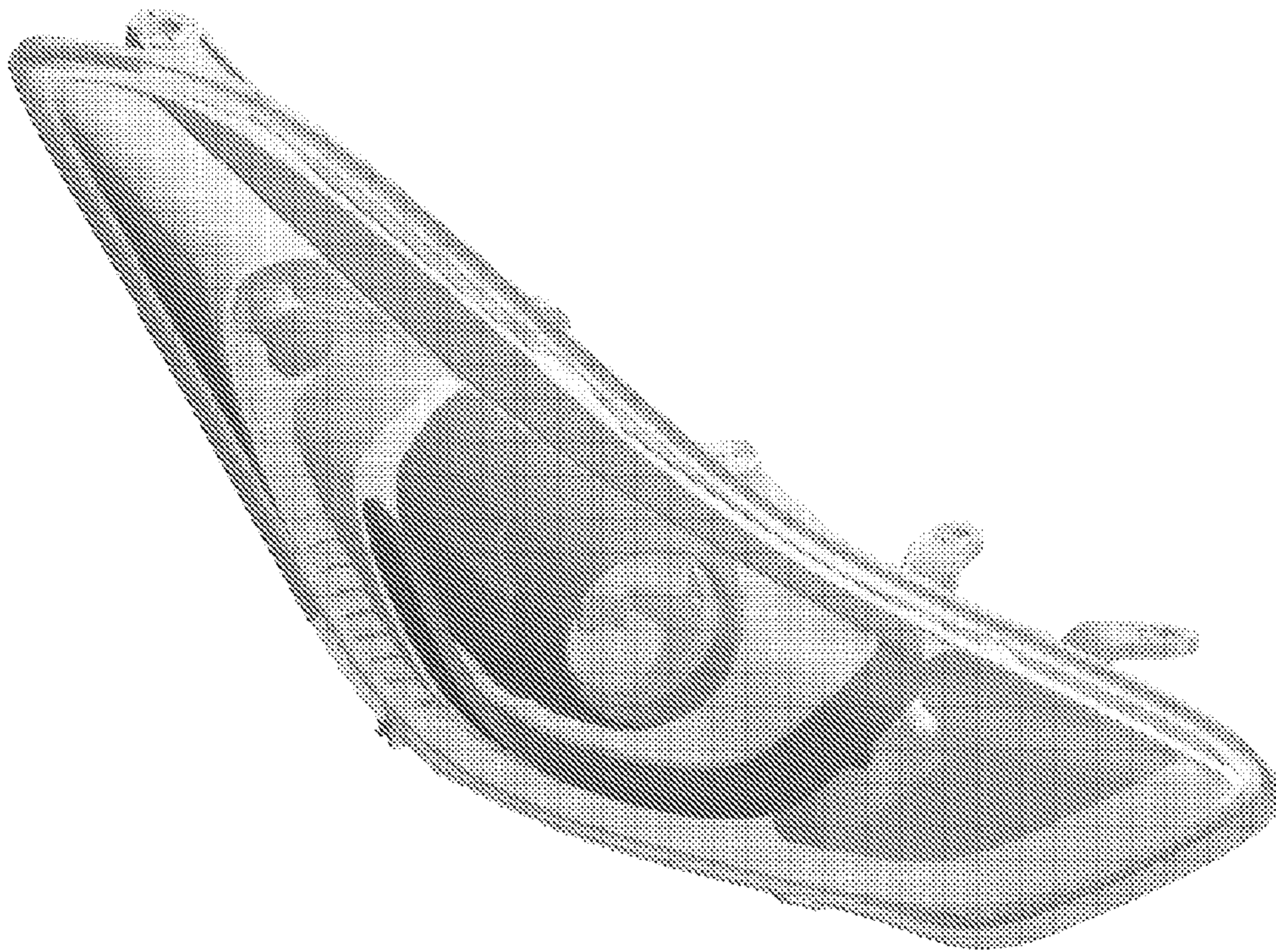

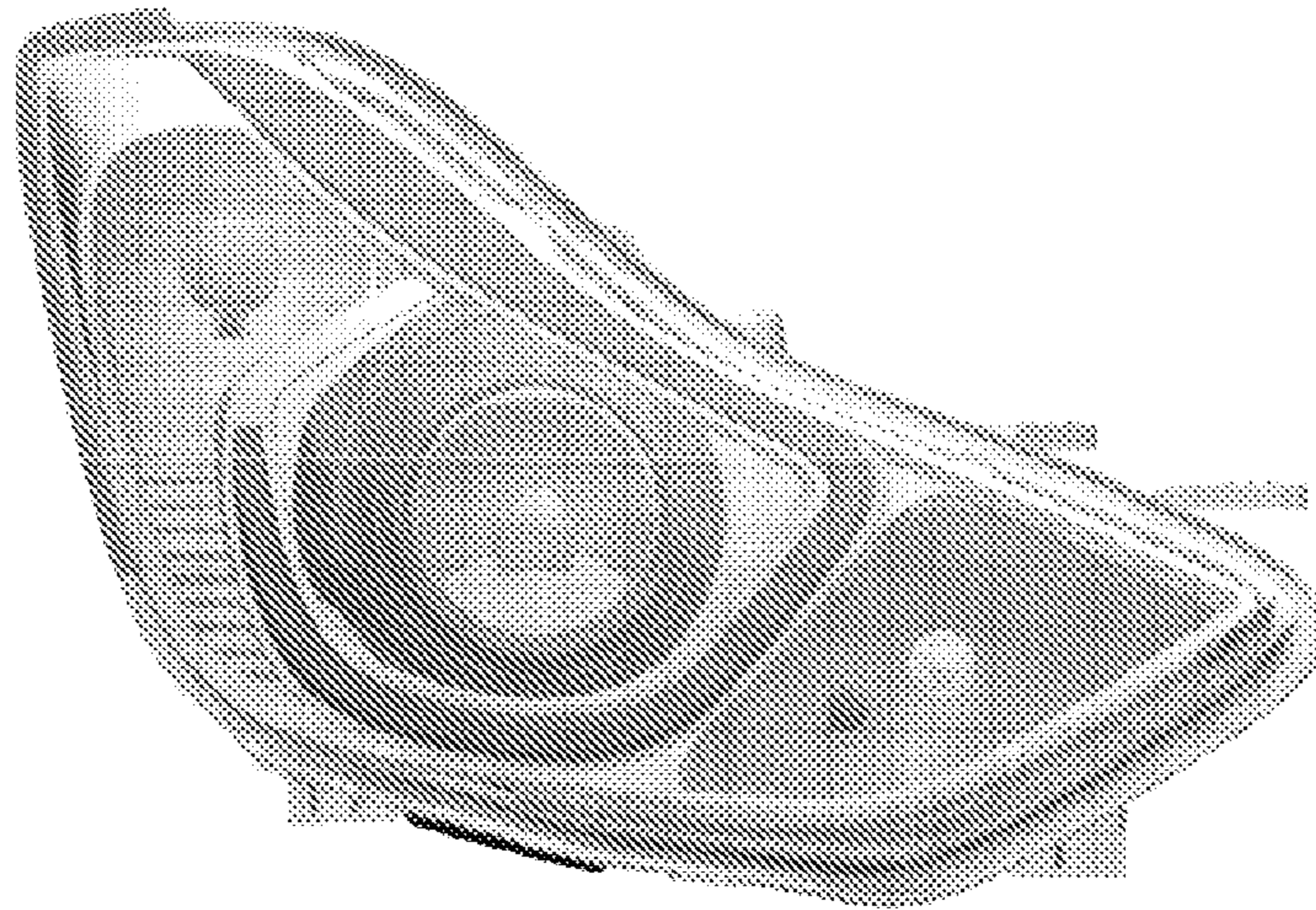

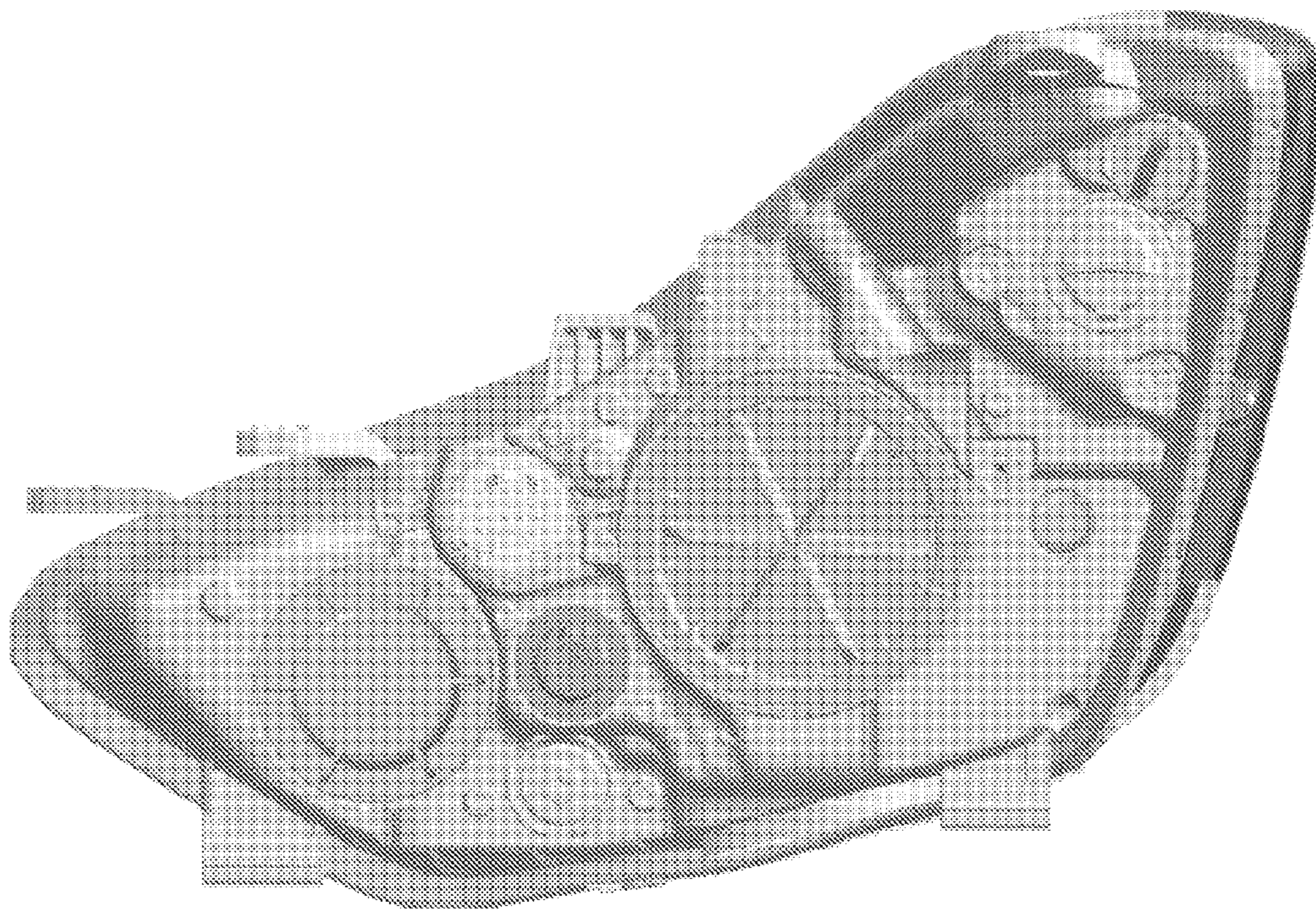

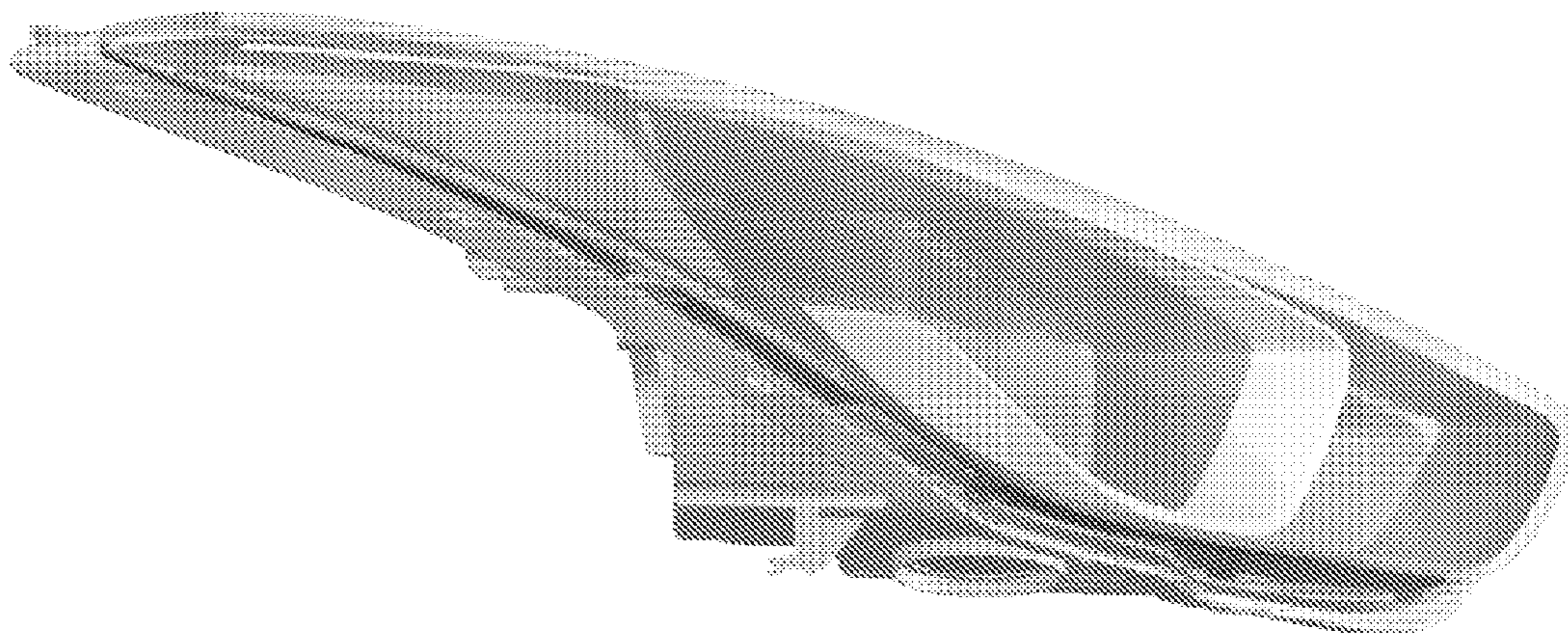

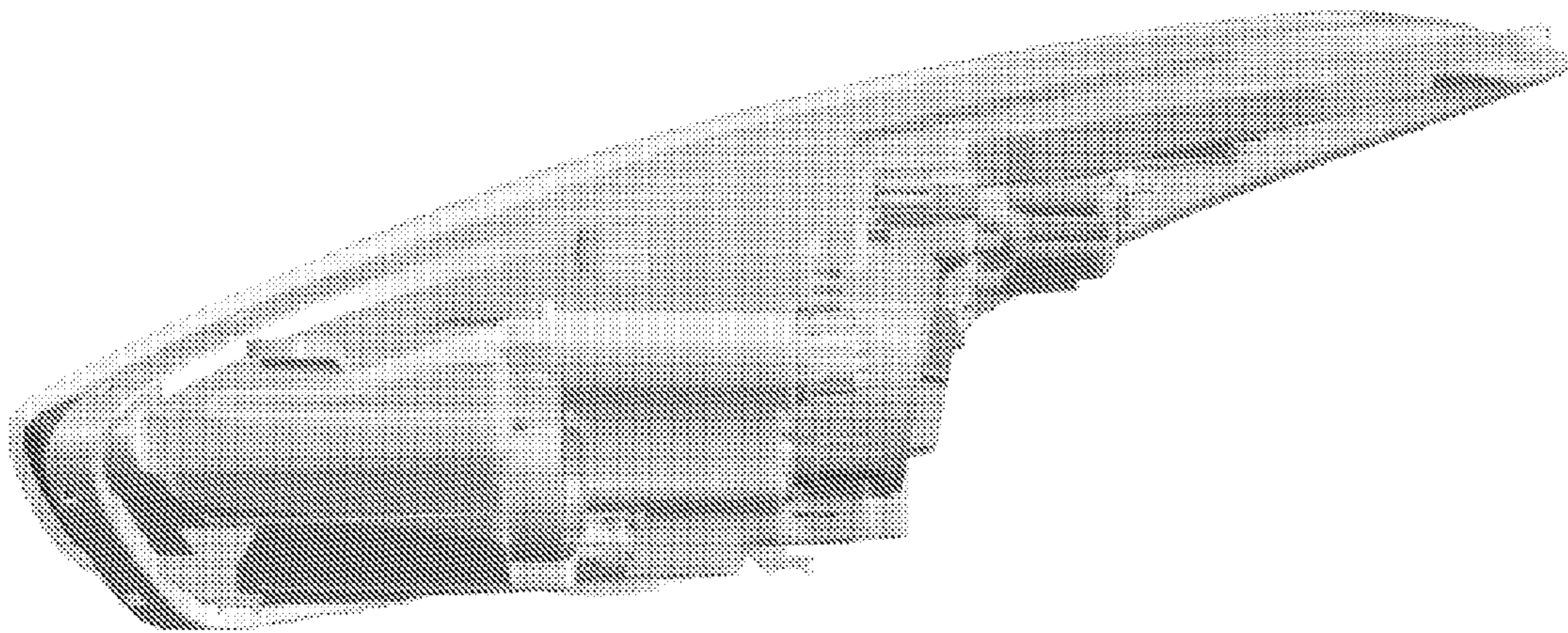

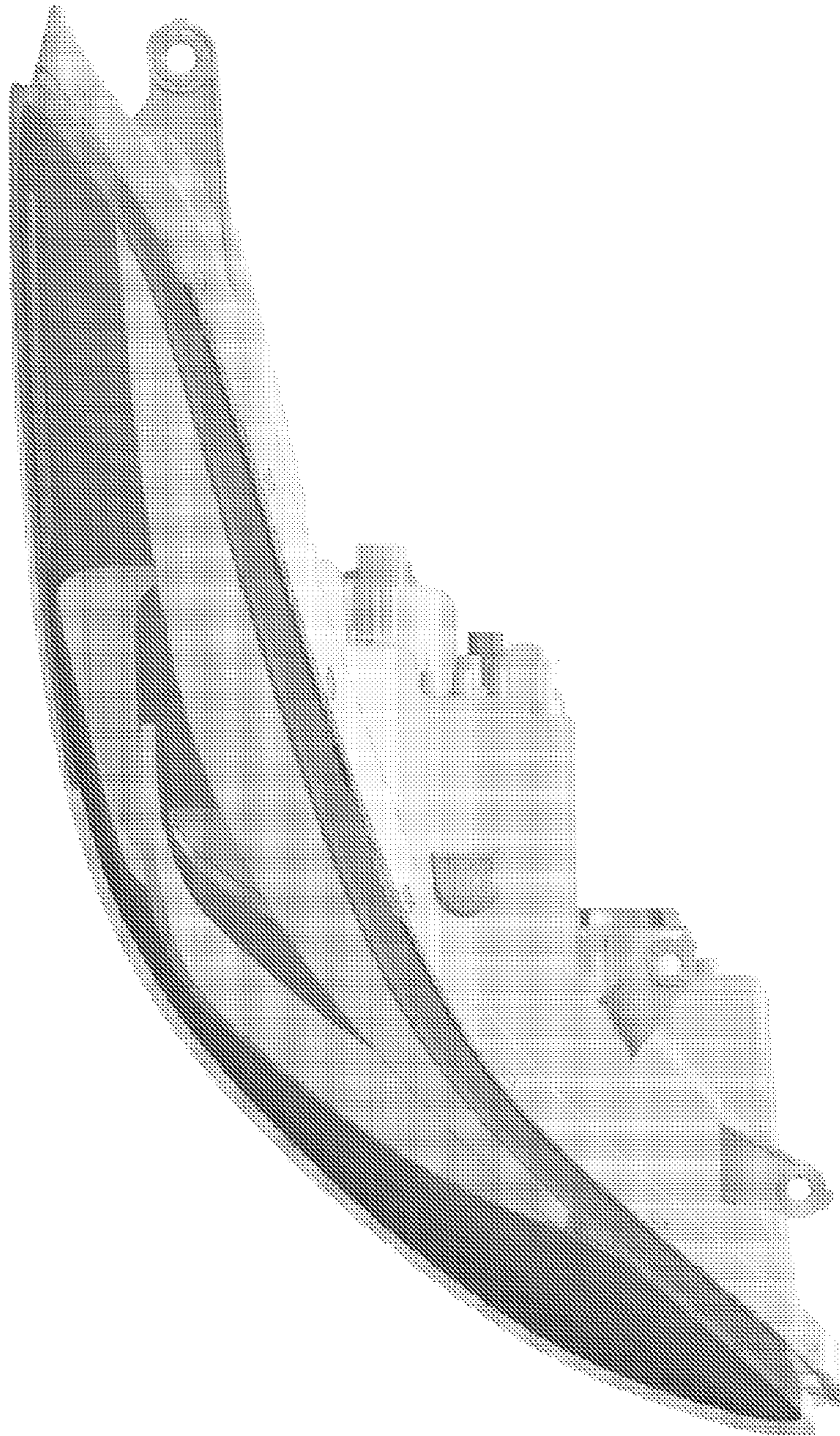
