(57) **CLAIM**

The ornamental design for a safety razor, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and right side perspective view of a safety razor showing my new design; FIG. 2 is a rear, bottom and left side perspective view thereof; FIG. 3 is a front view thereof, the rear view being a mirror image of FIG. 3; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is an enlarged right side view thereof; and, FIG. 7 is an enlarged left side view thereof. The evenly spaced dashed lines illustrate portions of the safety razor and form no part of the claimed design. The dashed-dotted lines denote the boundary of the claim and form no part of the claimed design.

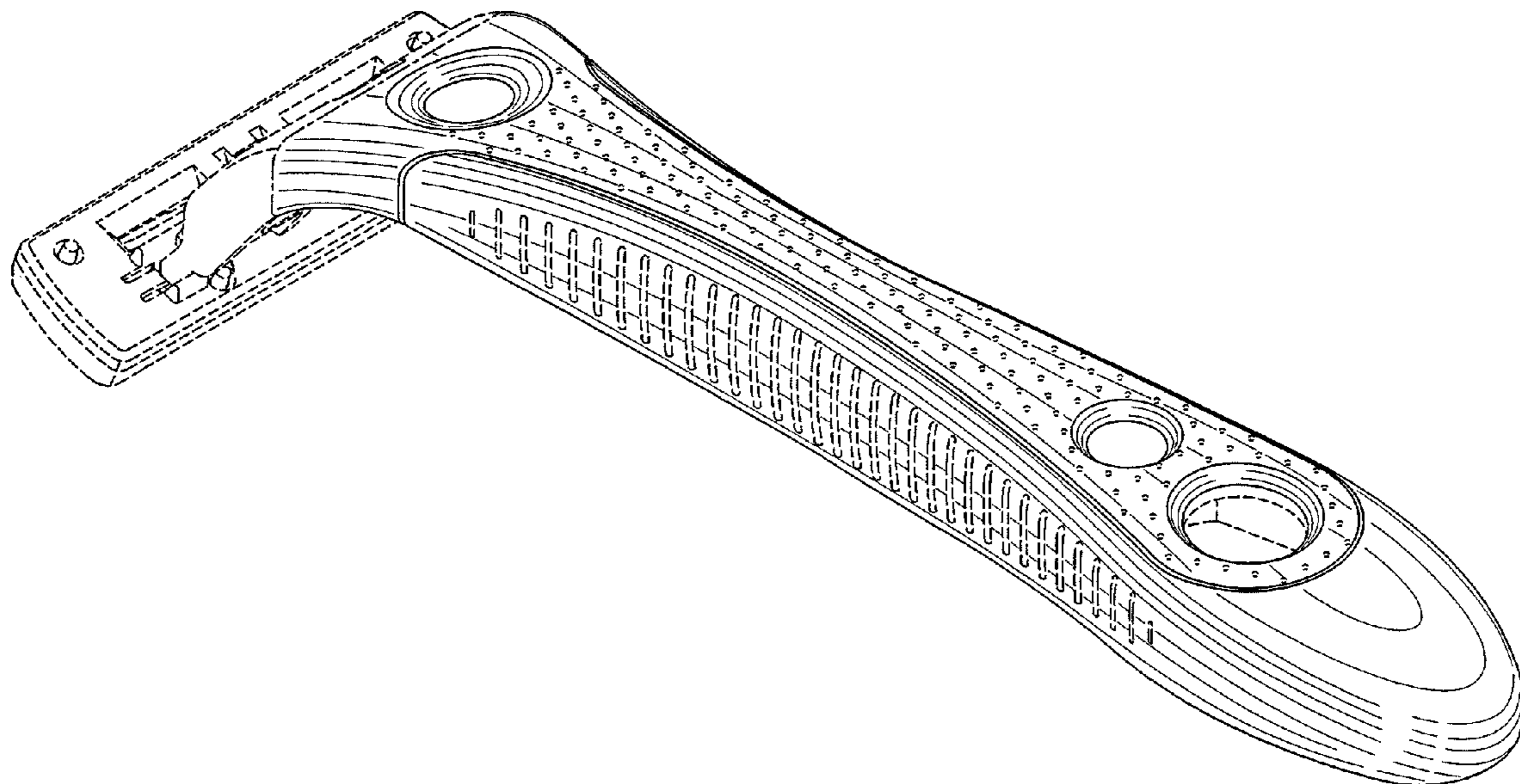

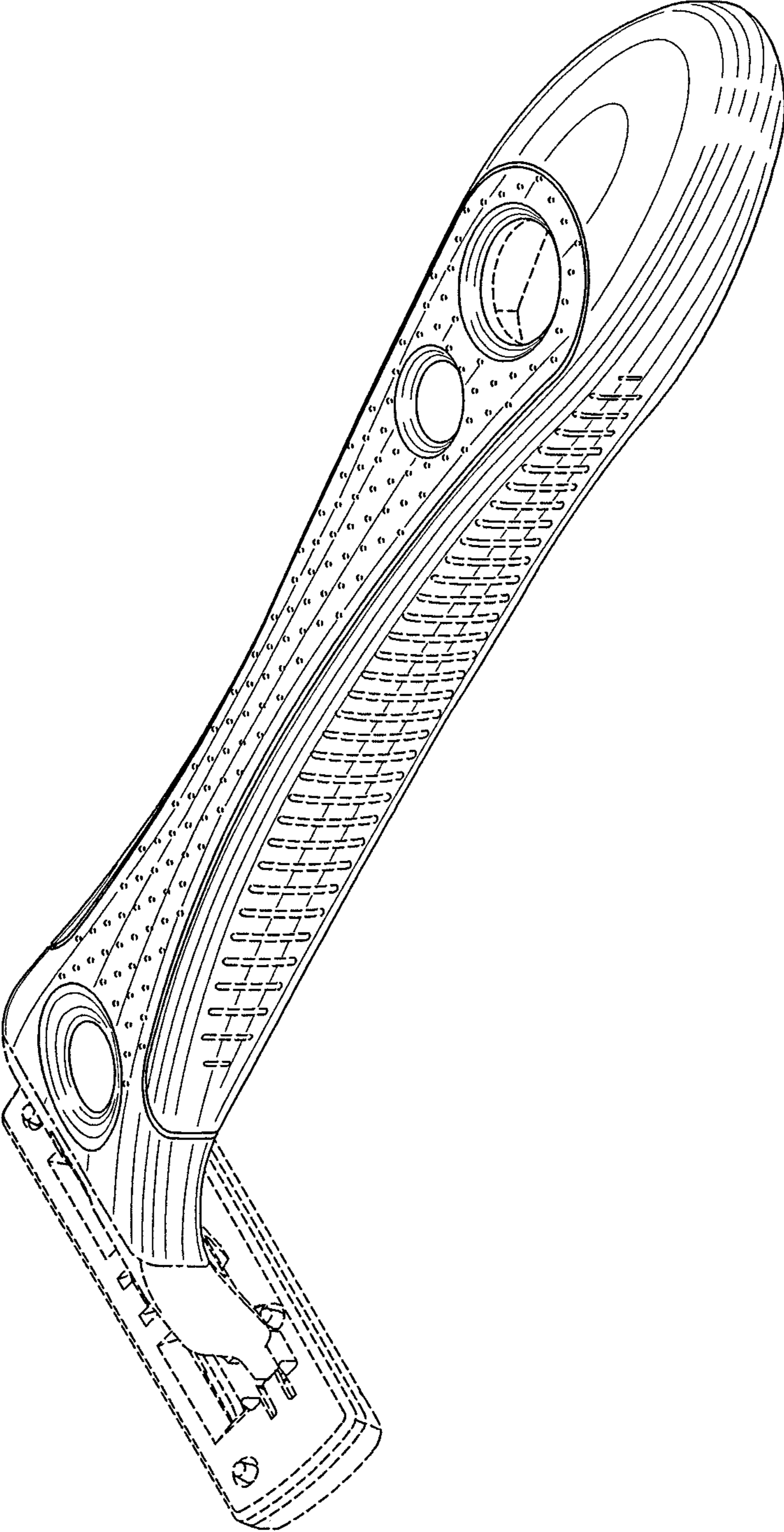

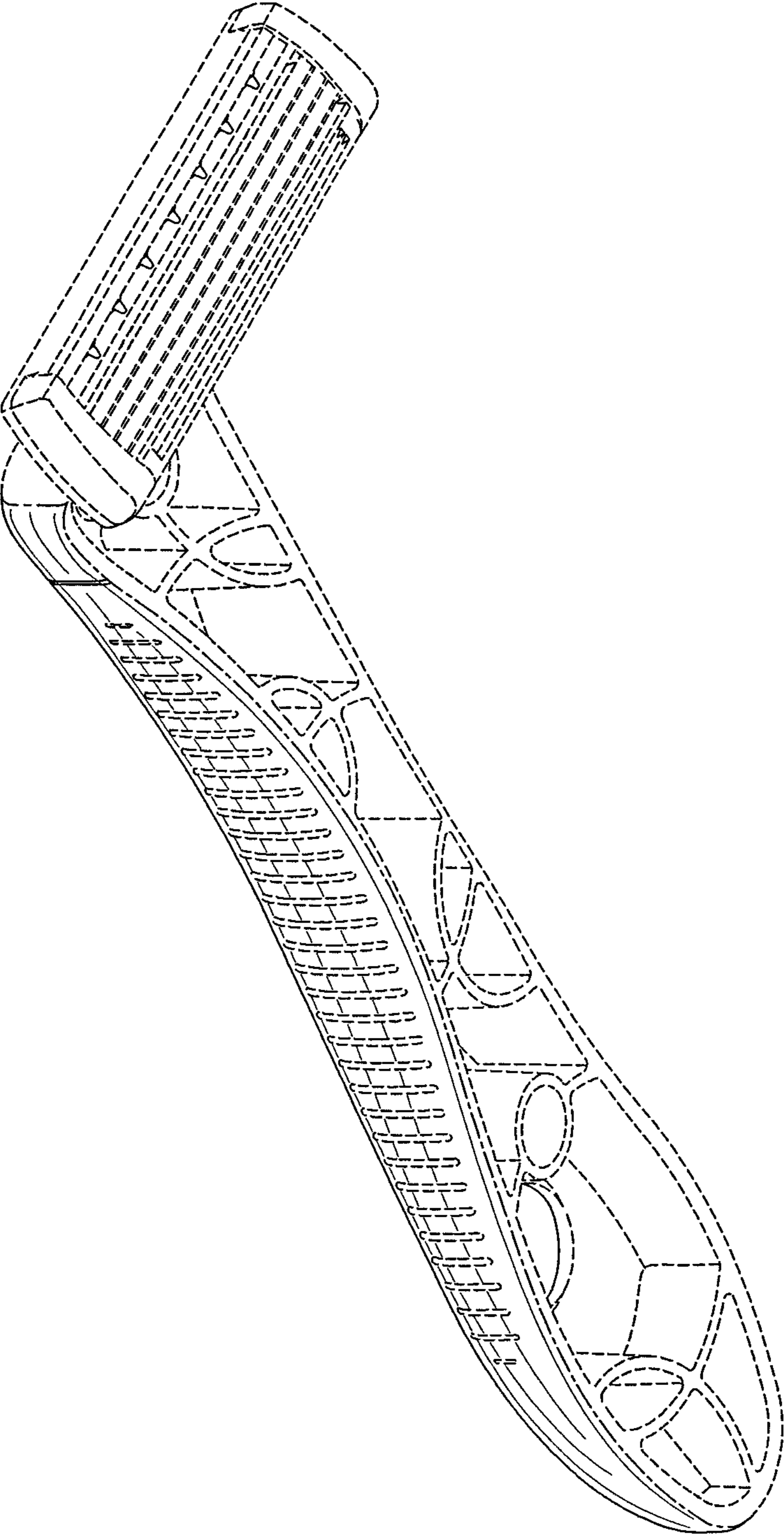

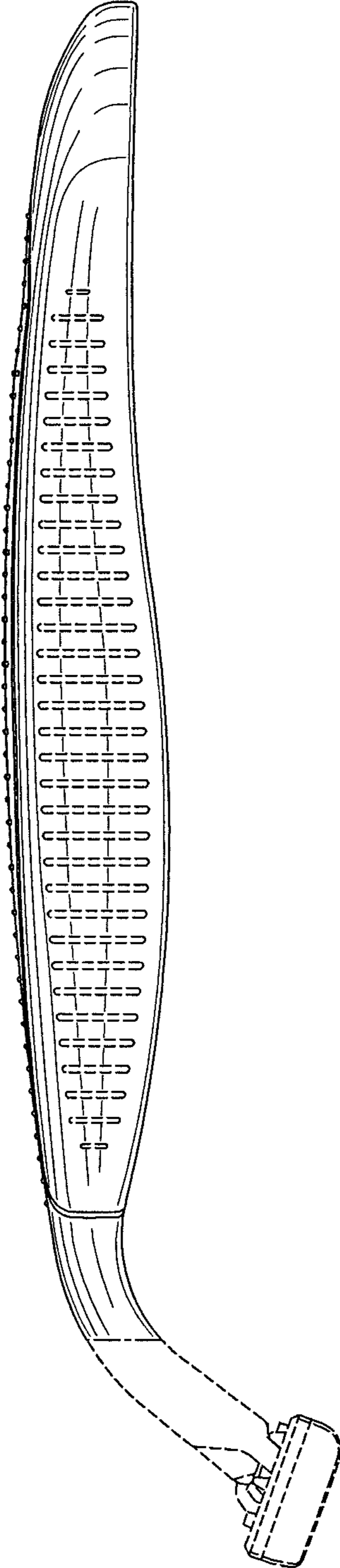

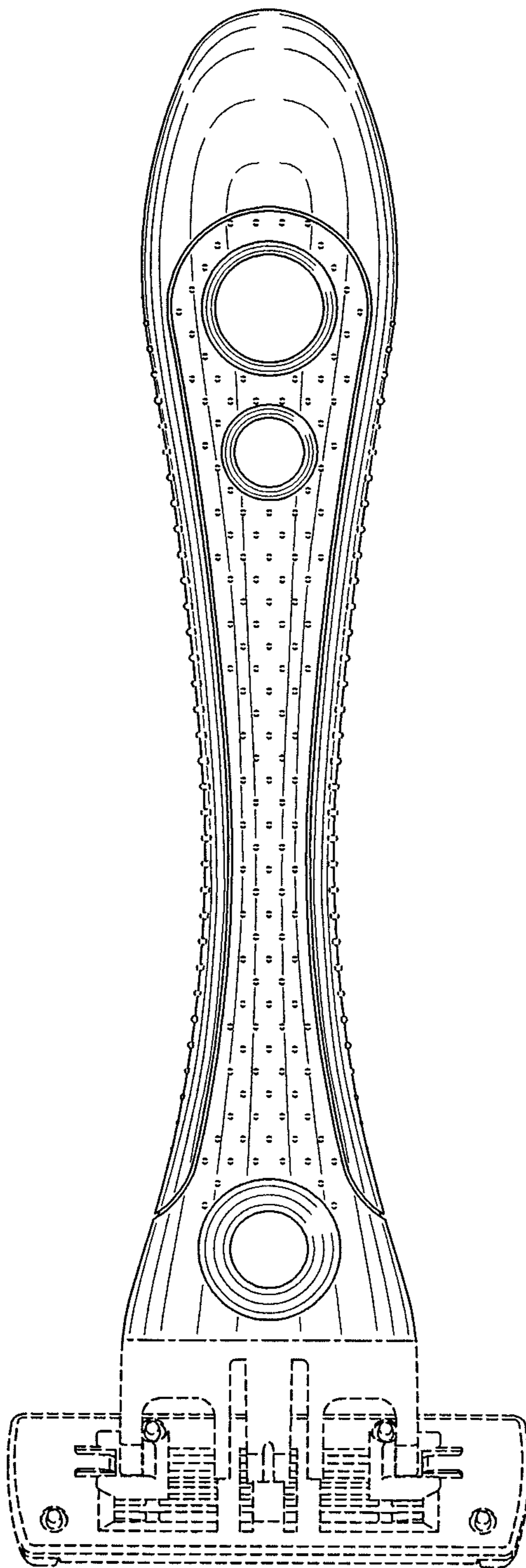

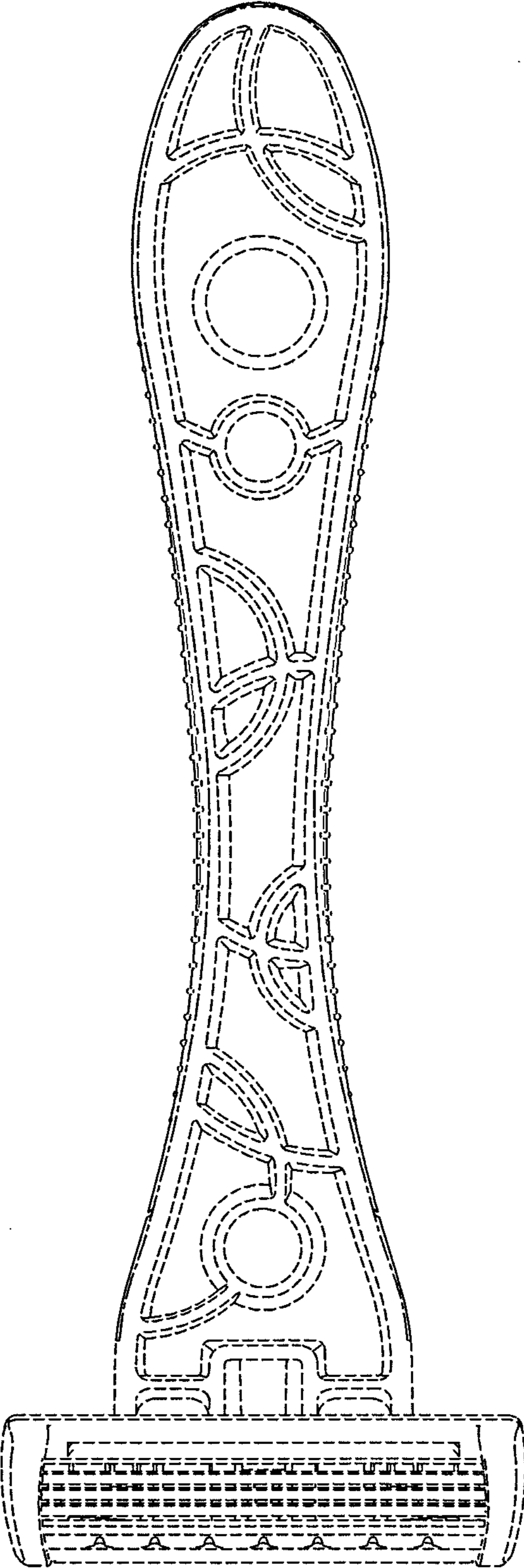

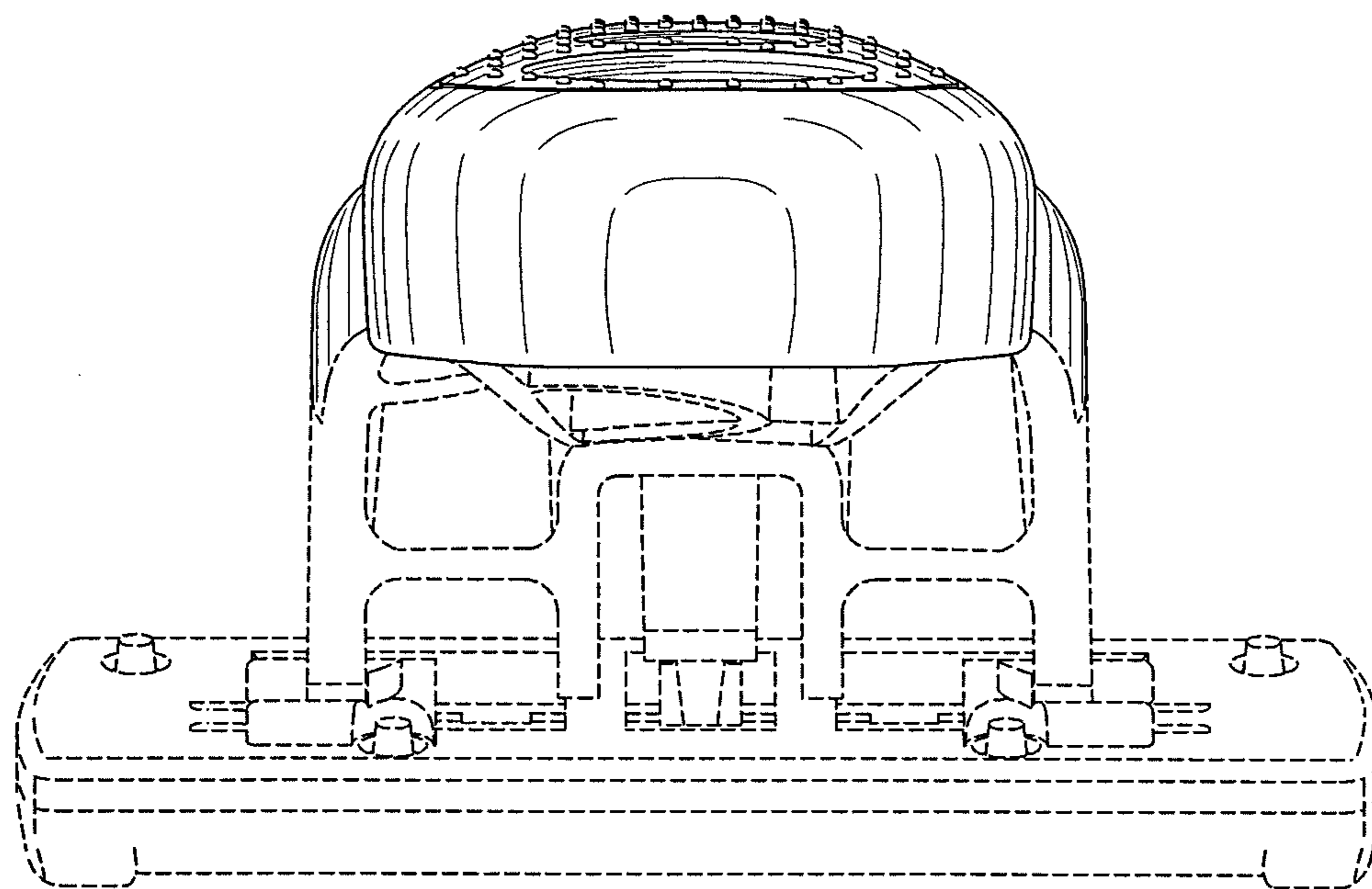
