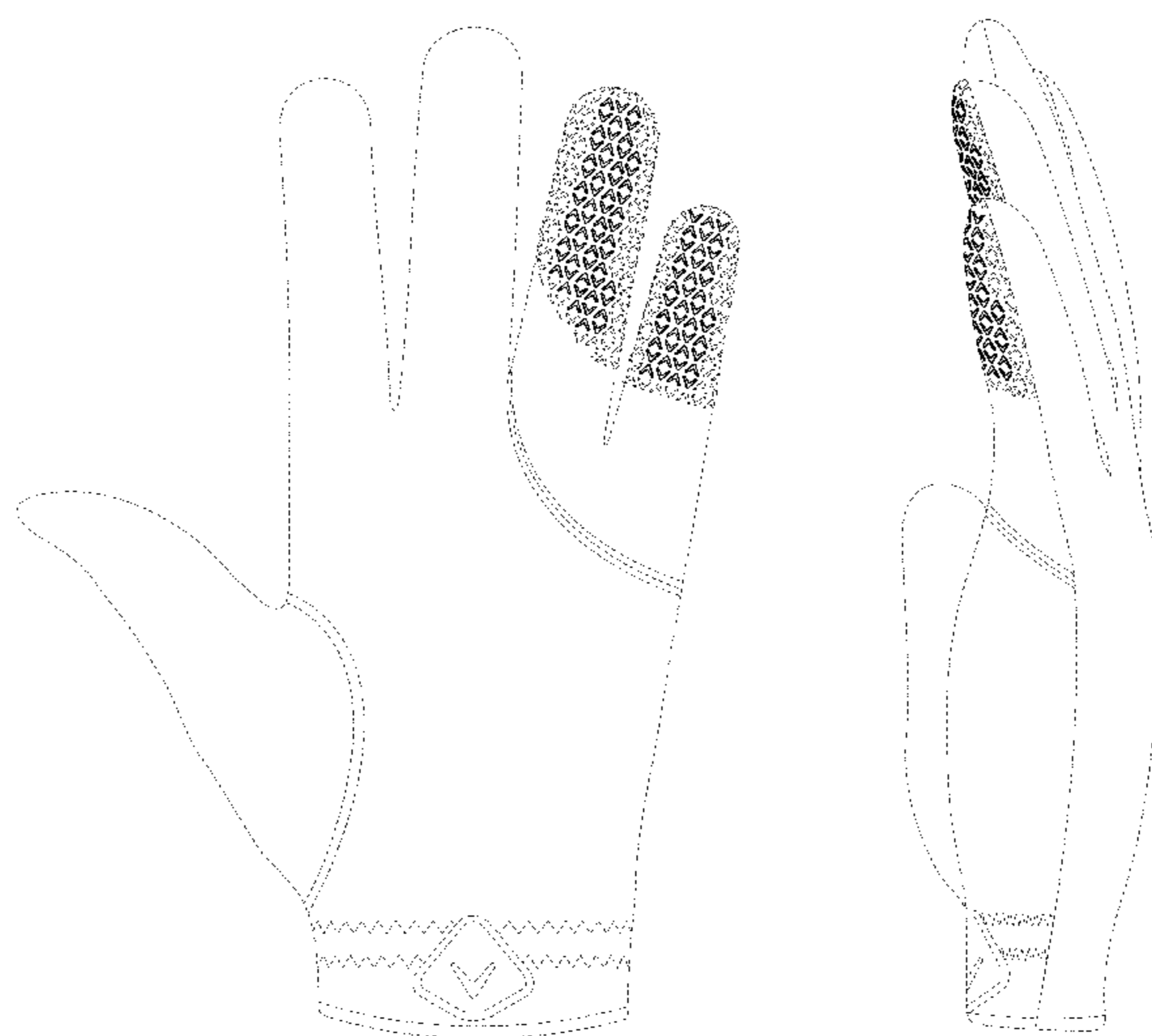
DESCRIPTION

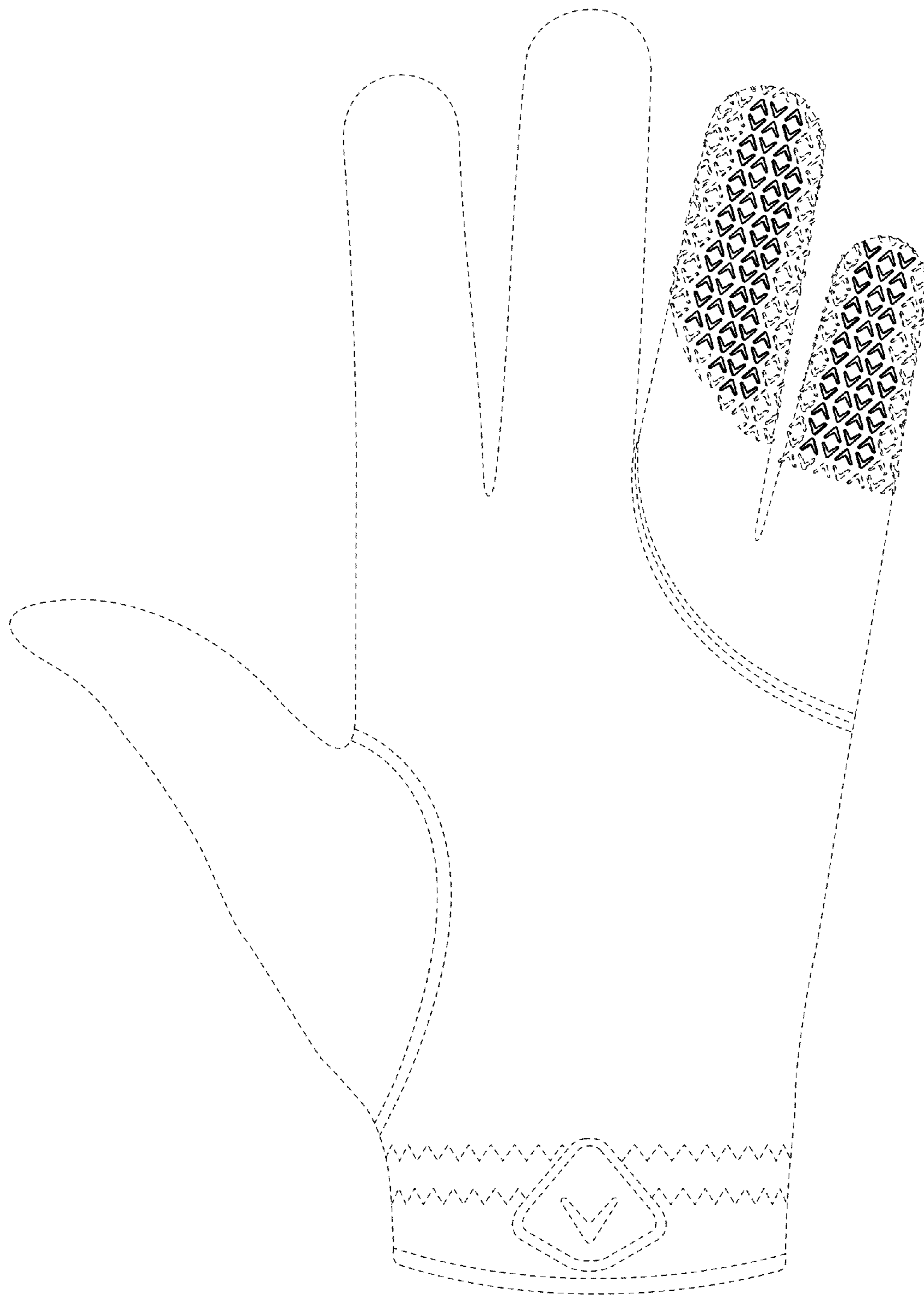

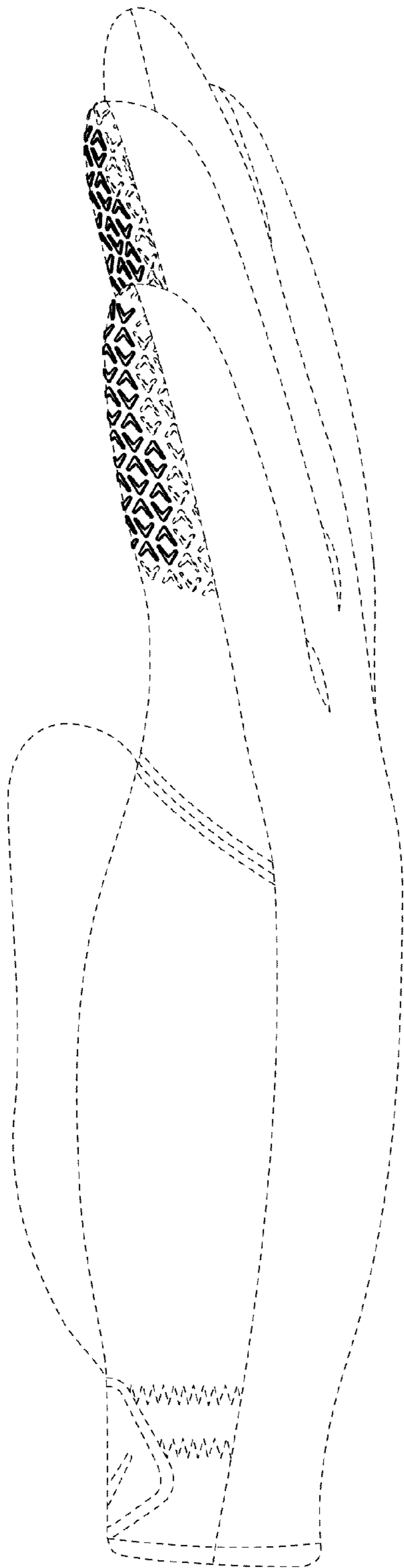

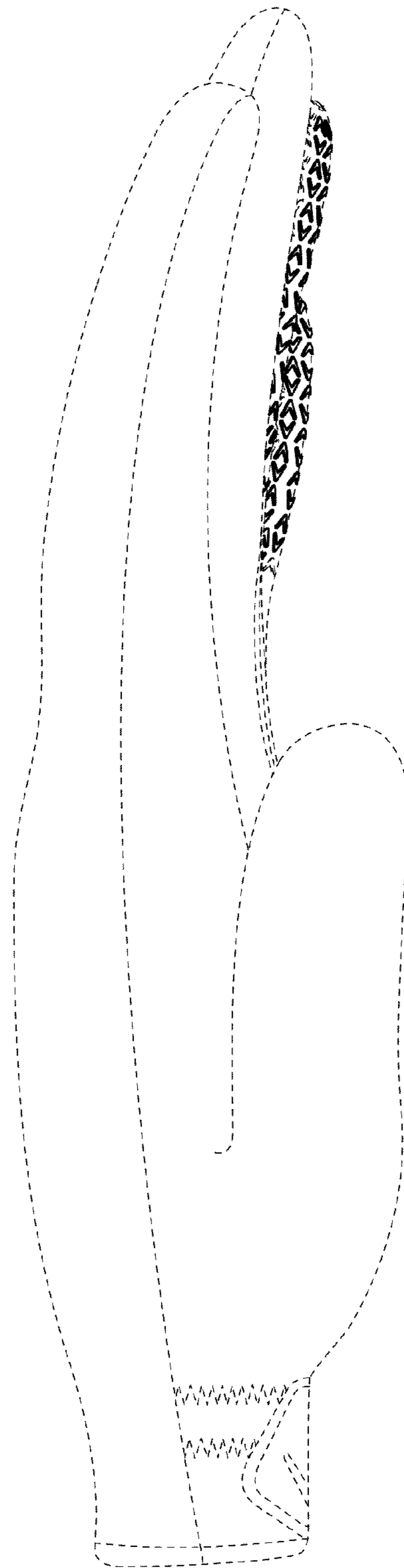

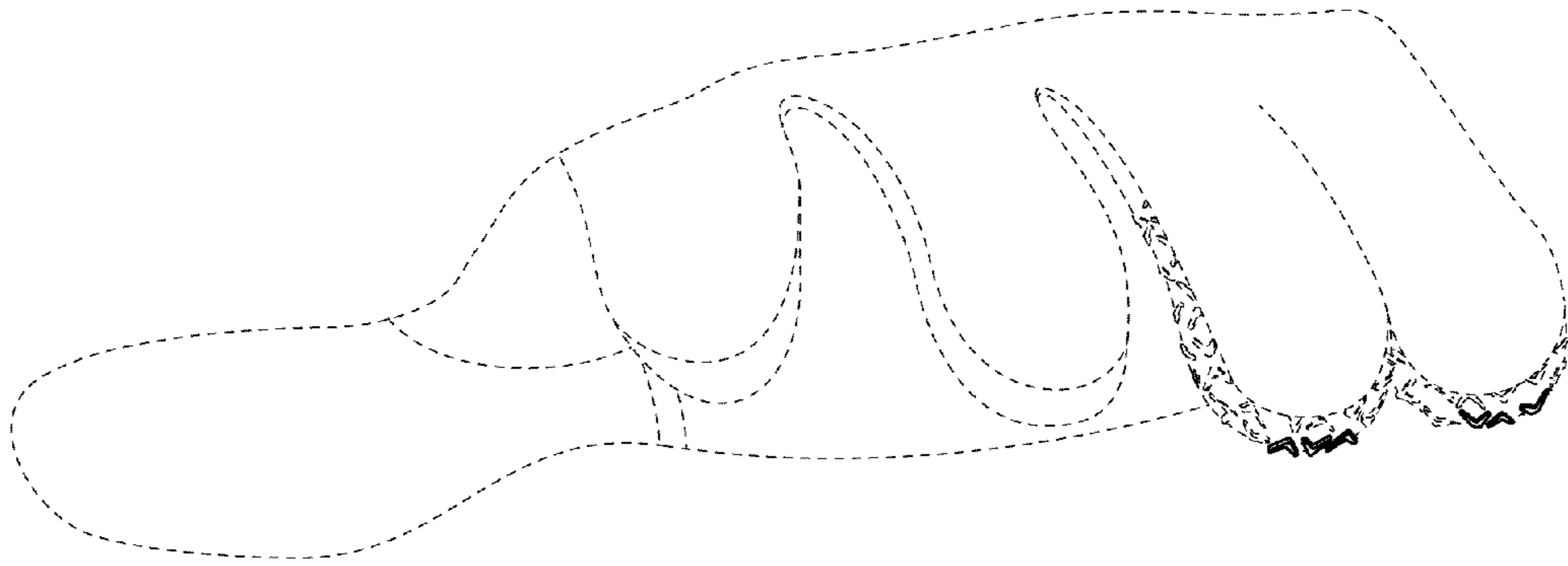

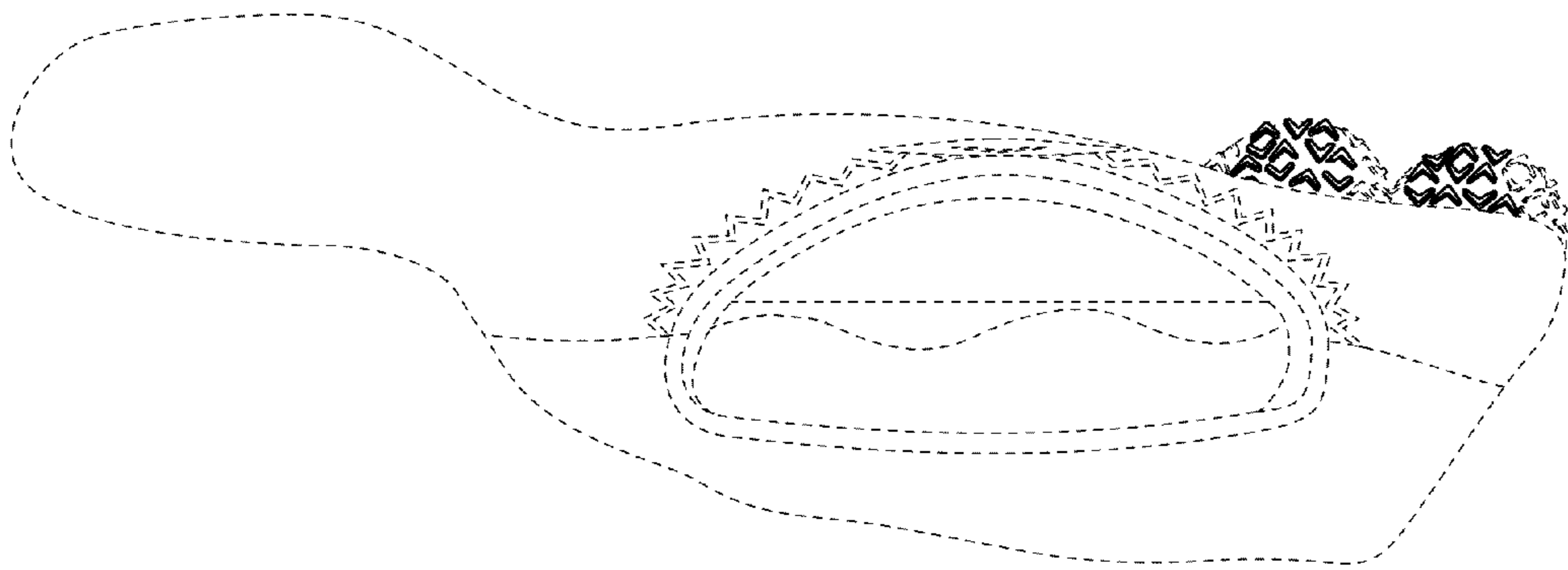
