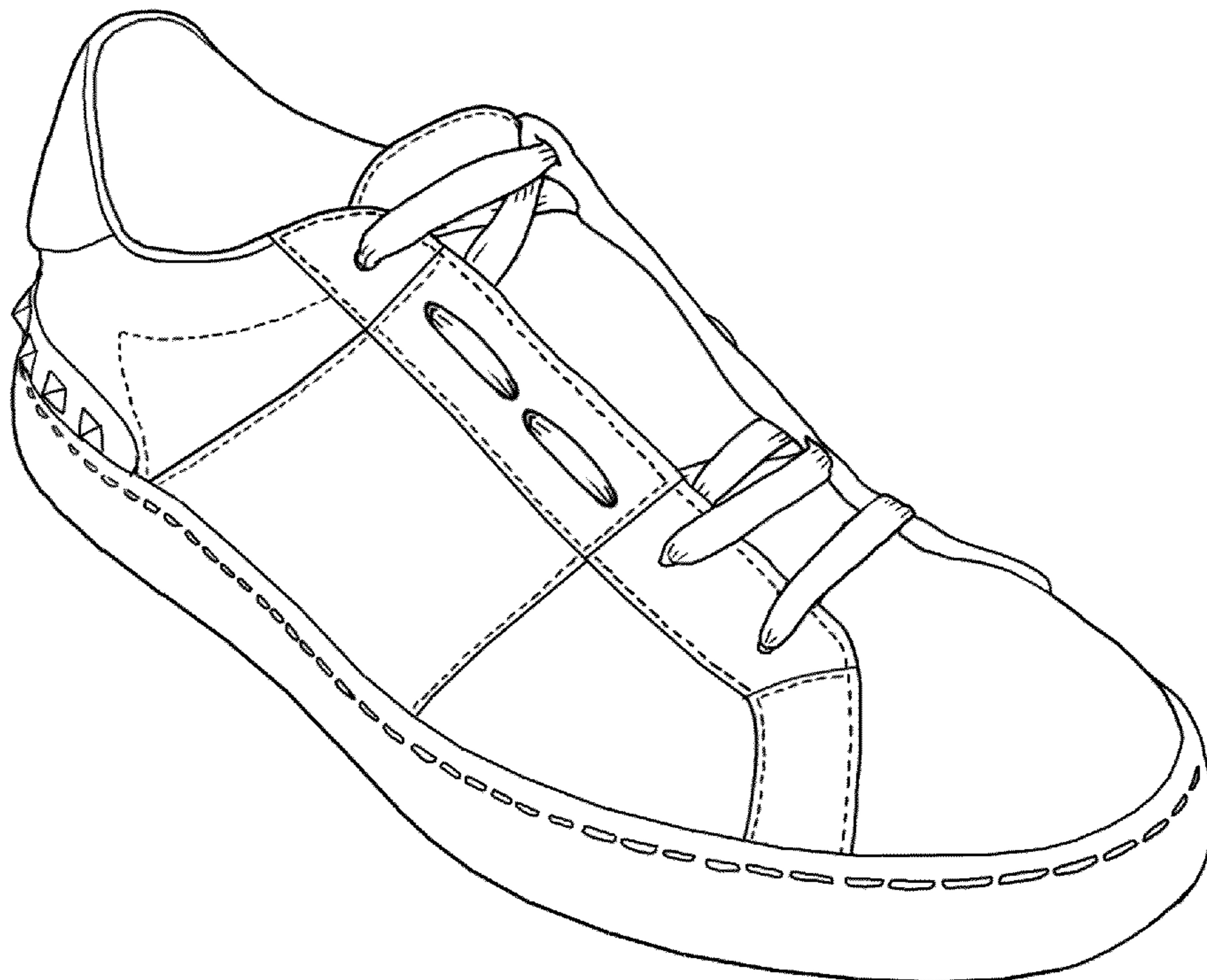

DESCRIPTION

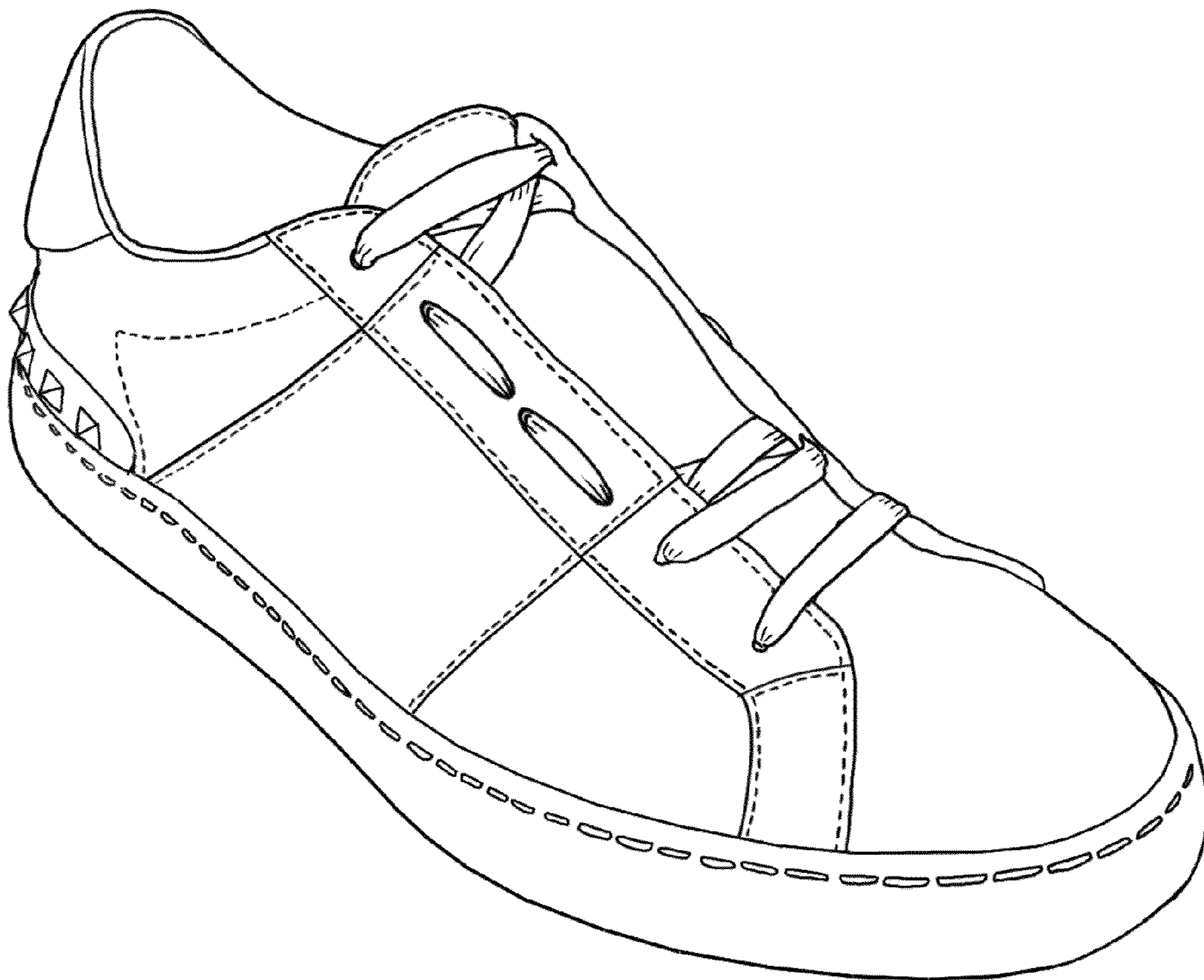

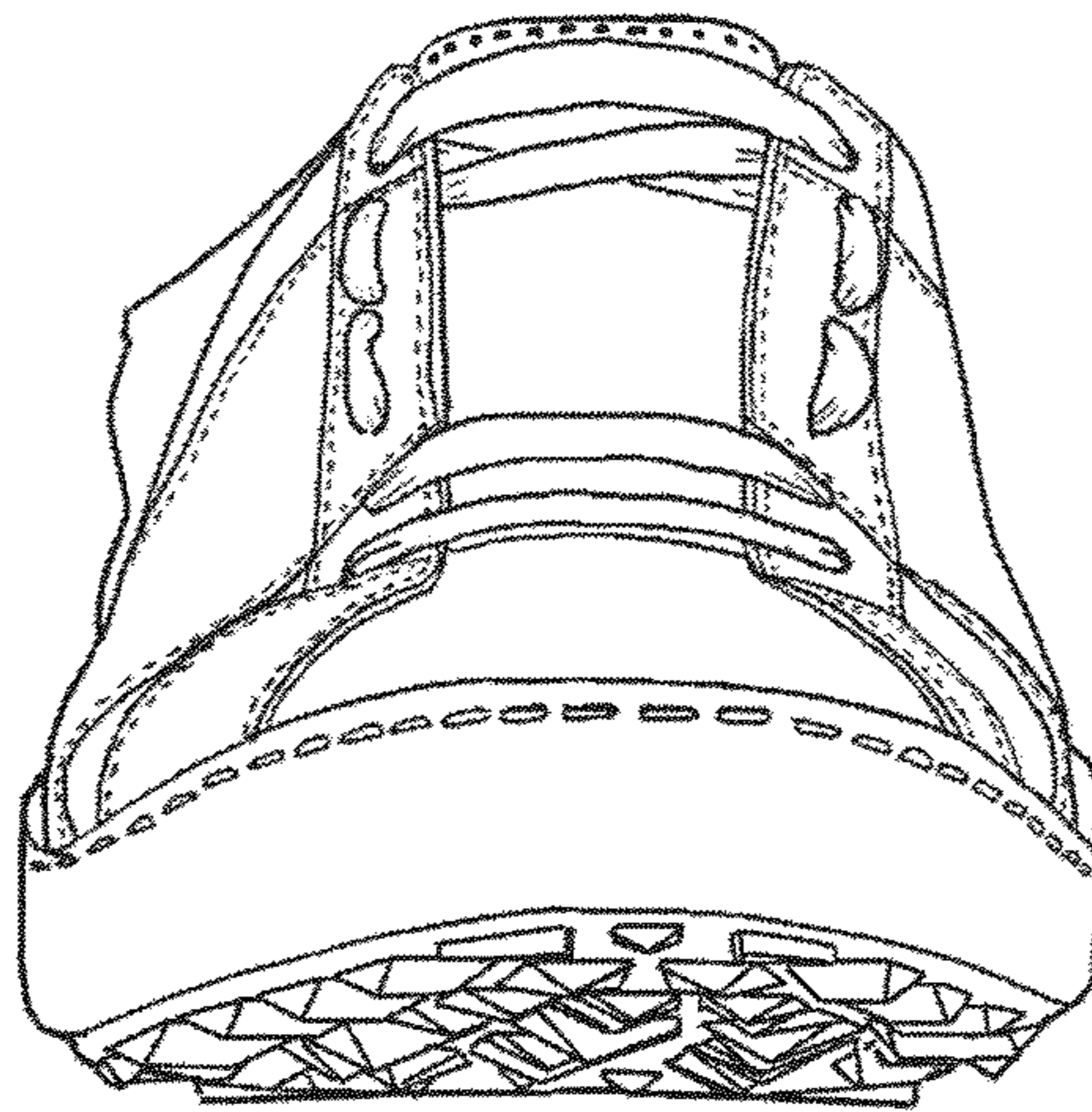

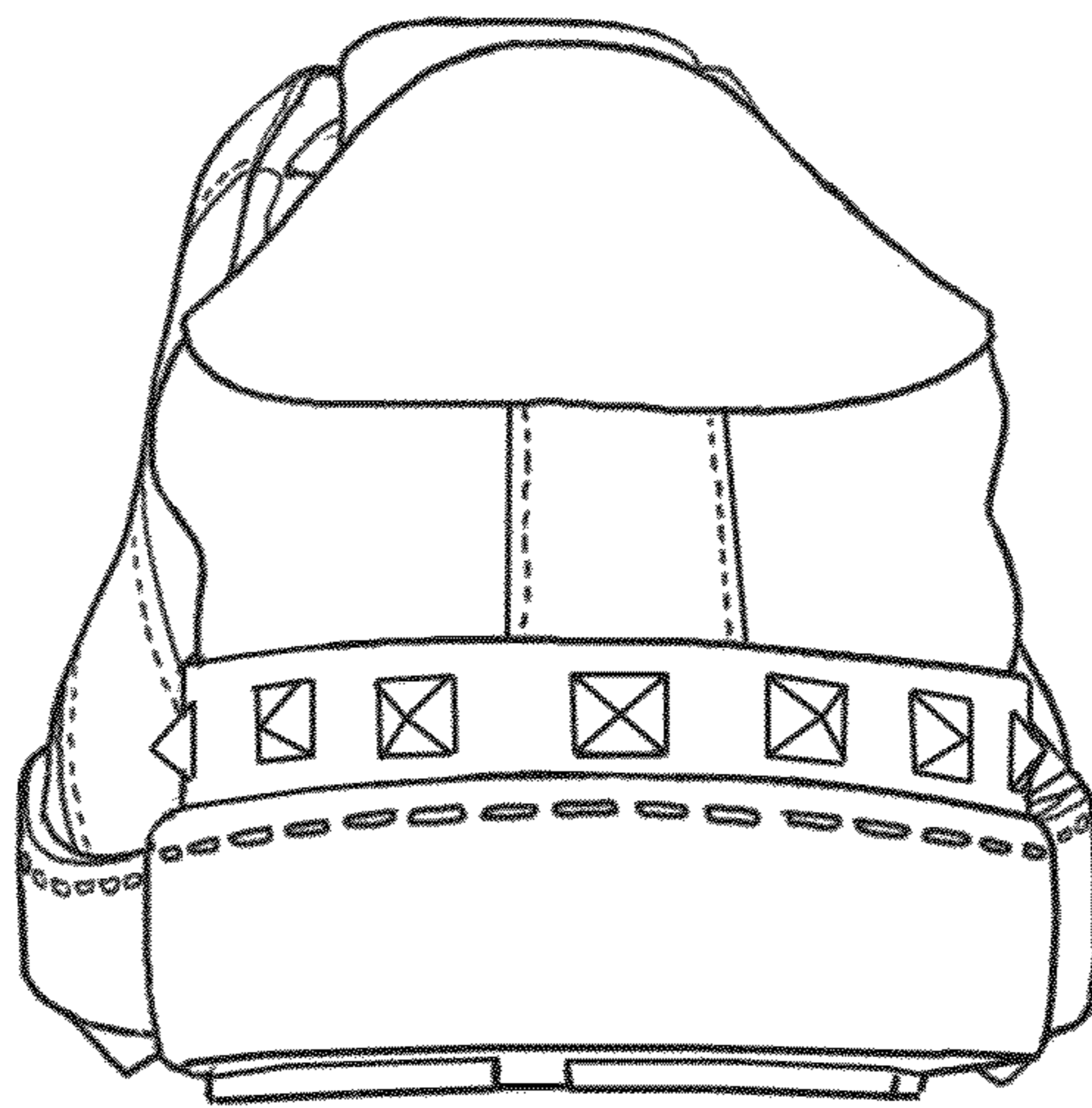

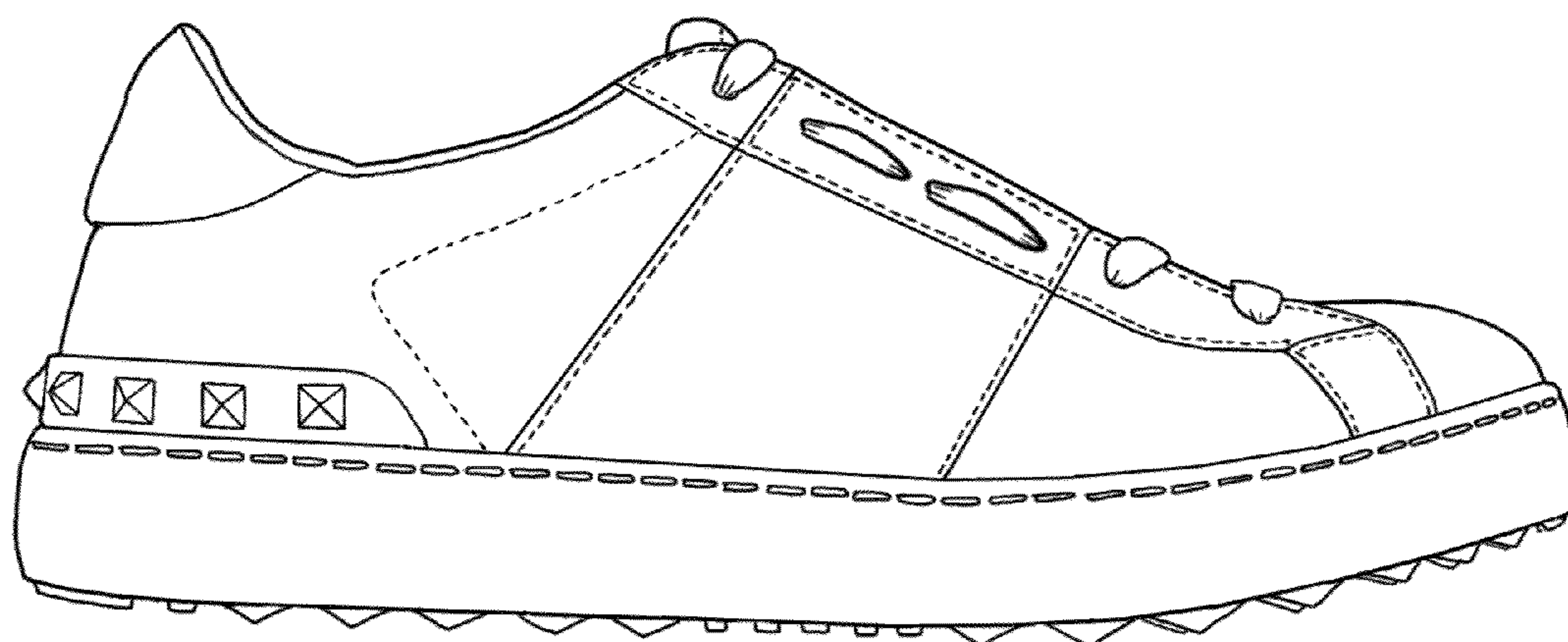

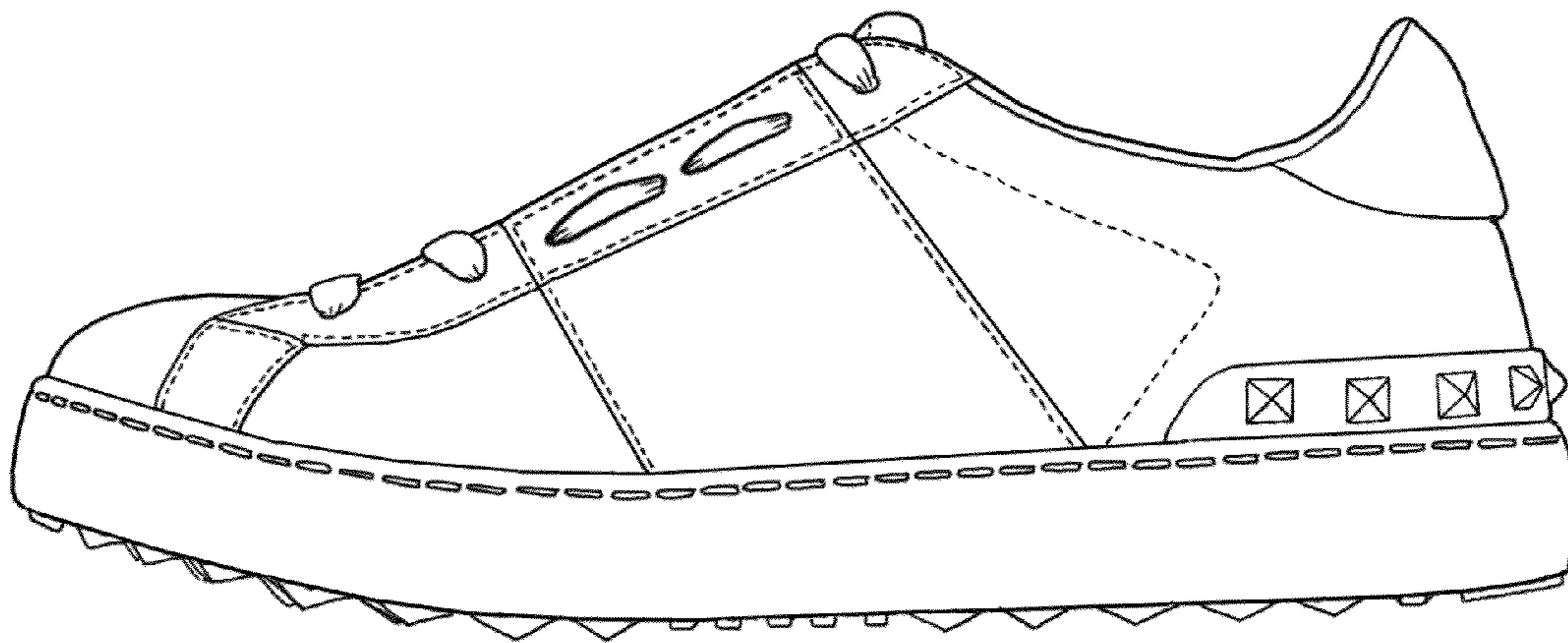

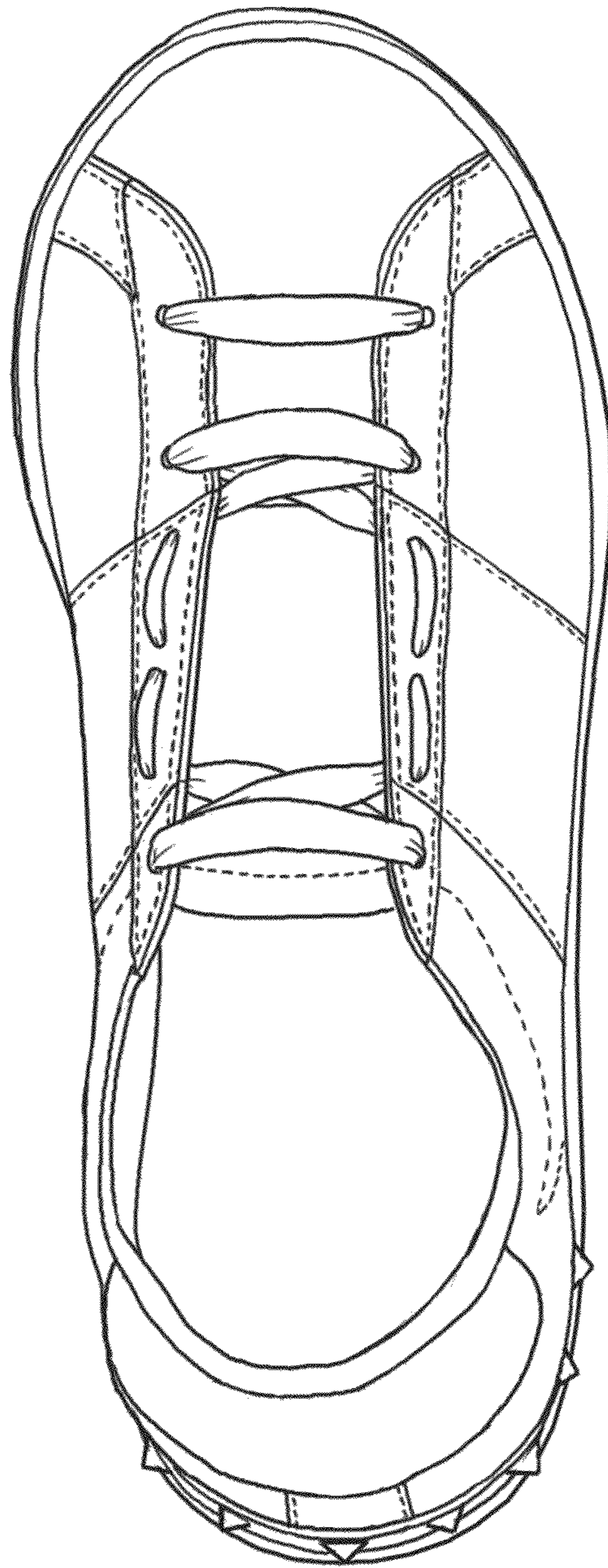

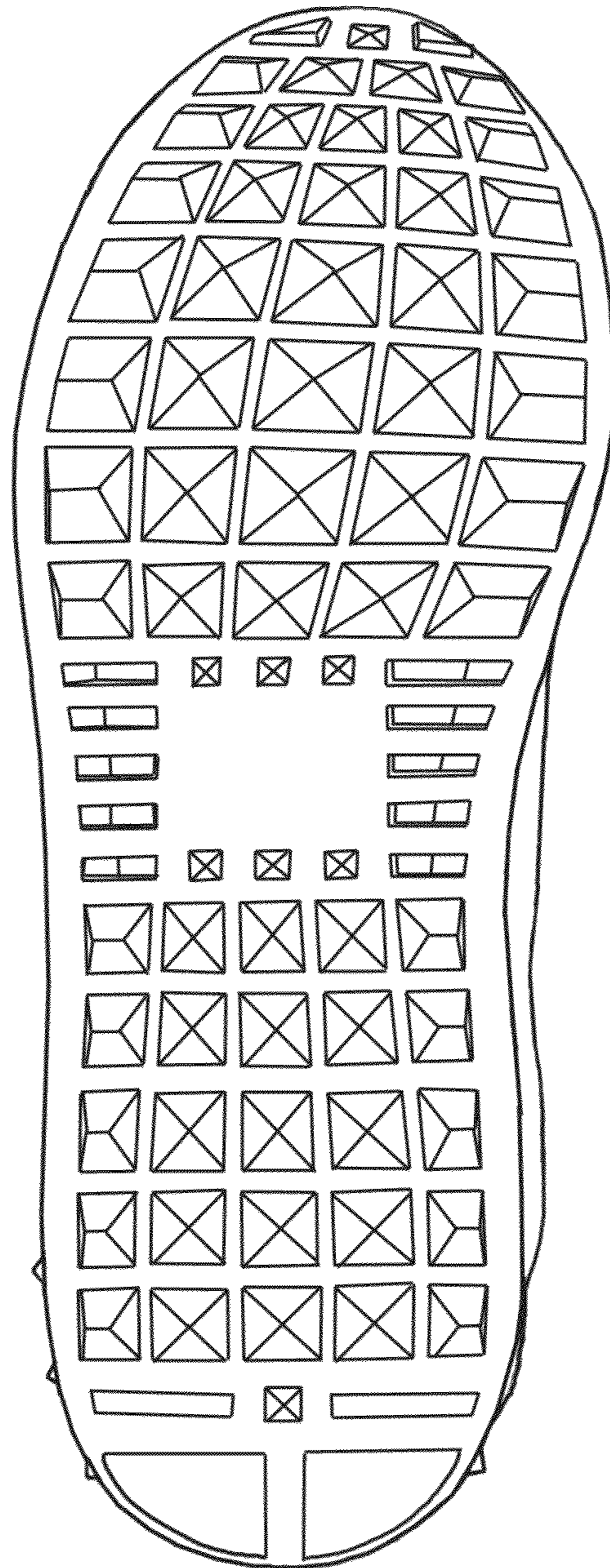
