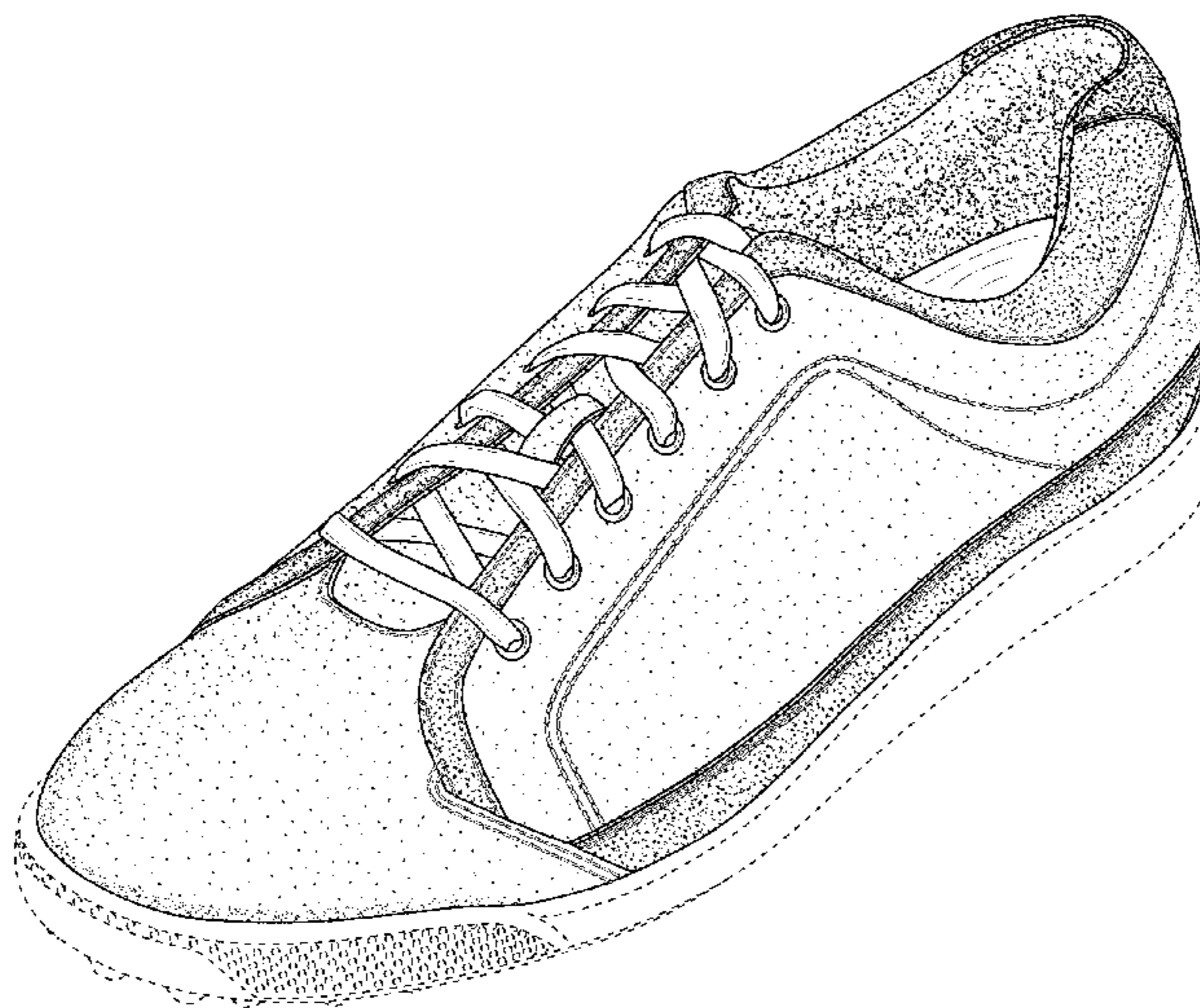
(57) **CLAIM**  
The ornamental design for a golf shoe upper, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a golf shoe upper showing my new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a lateral side elevation view thereof;  
FIG. 4 is a medial side elevation view thereof;  
FIG. 5 is a bottom plan view thereof;  
FIG. 6 is a front elevation view thereof; and,  
FIG. 7 is a rear elevation view thereof.  
The broken lines in FIGS. 1-7 on the bottom of the shoe showing a shoe outsole including traction elements and logos form no part of the claimed design.

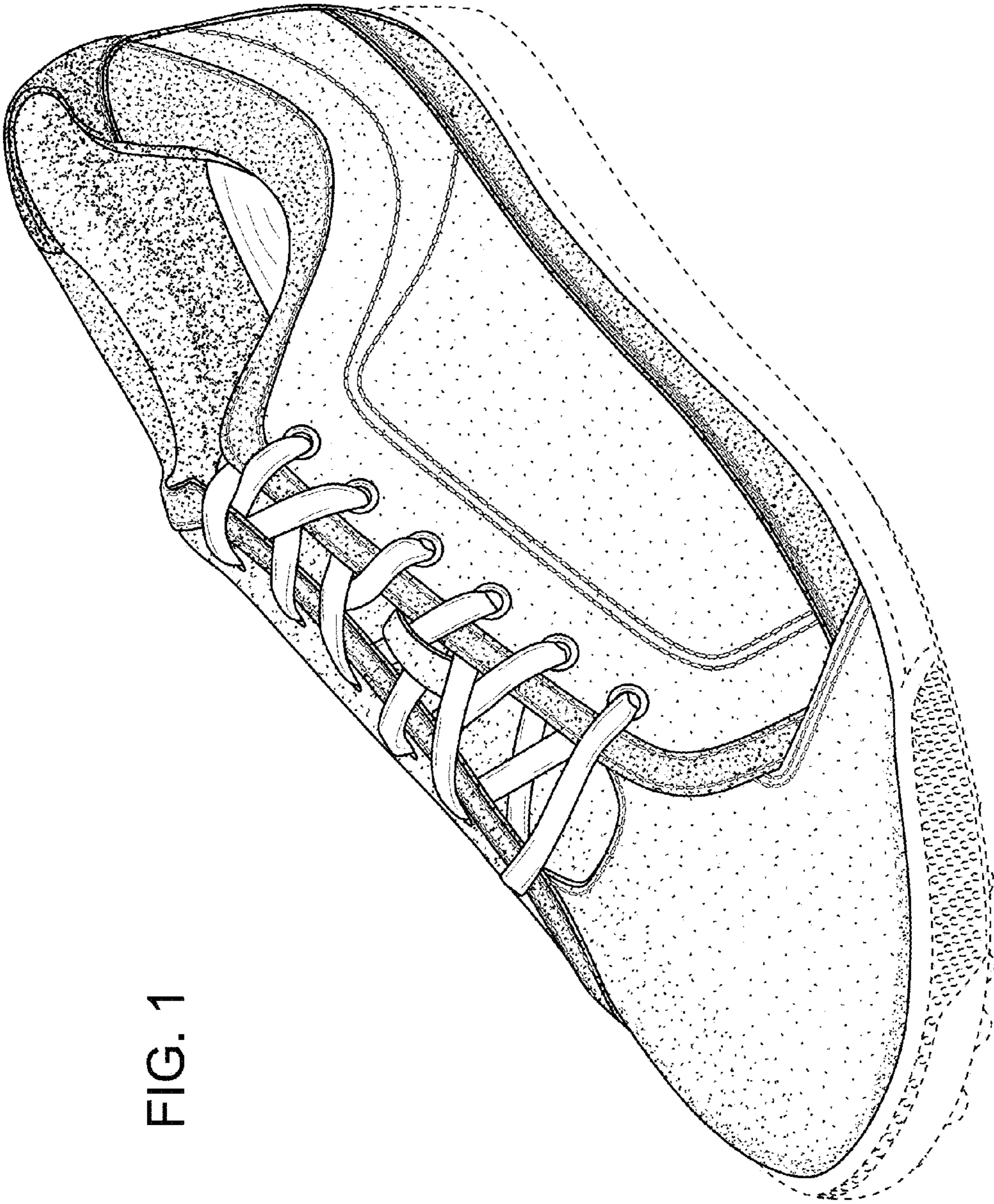

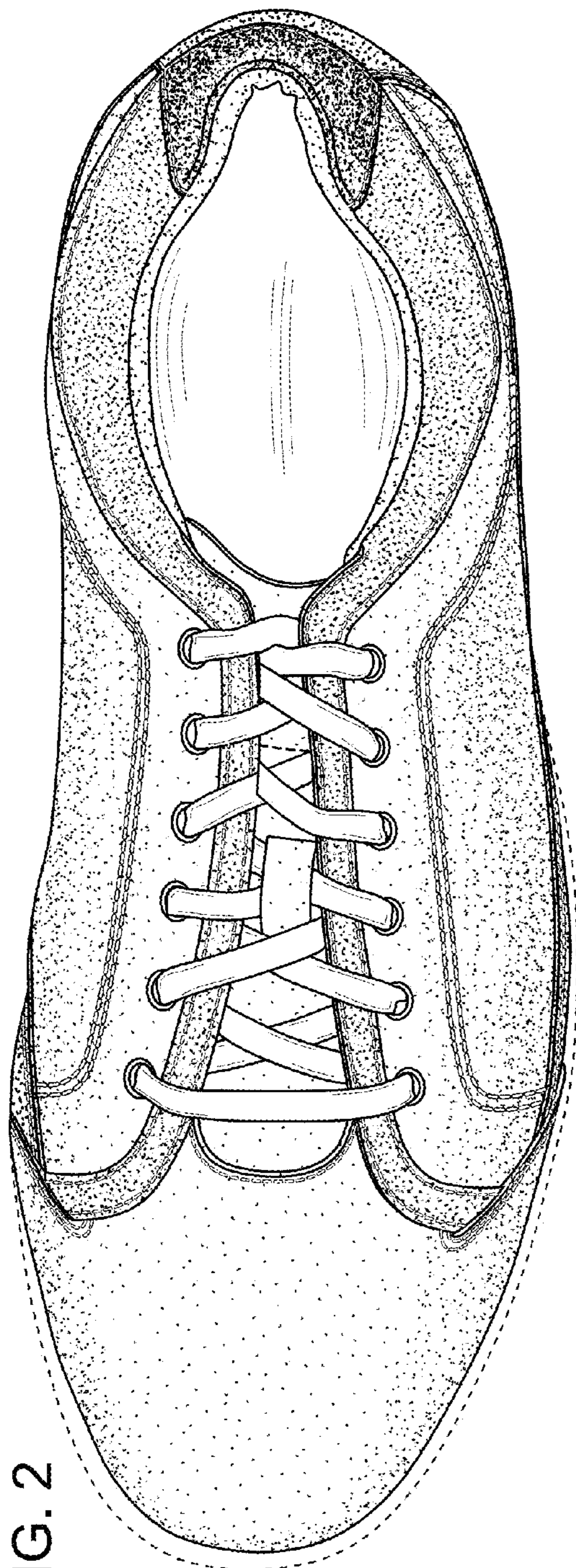

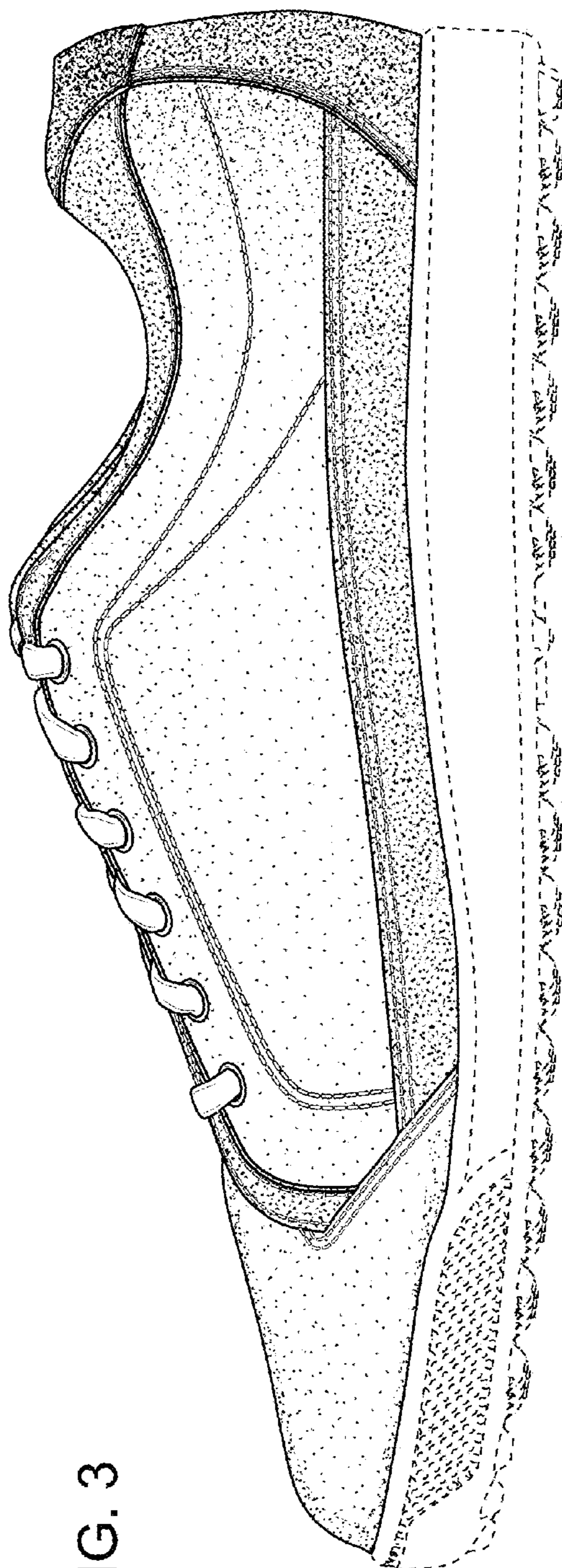

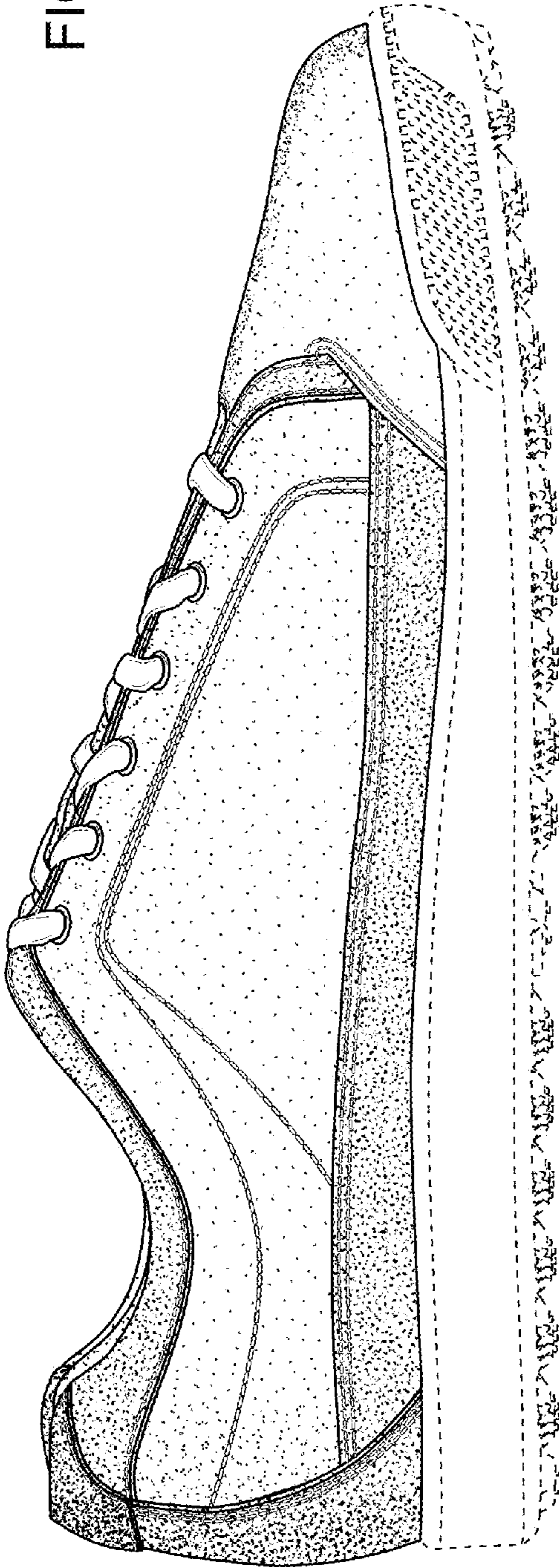
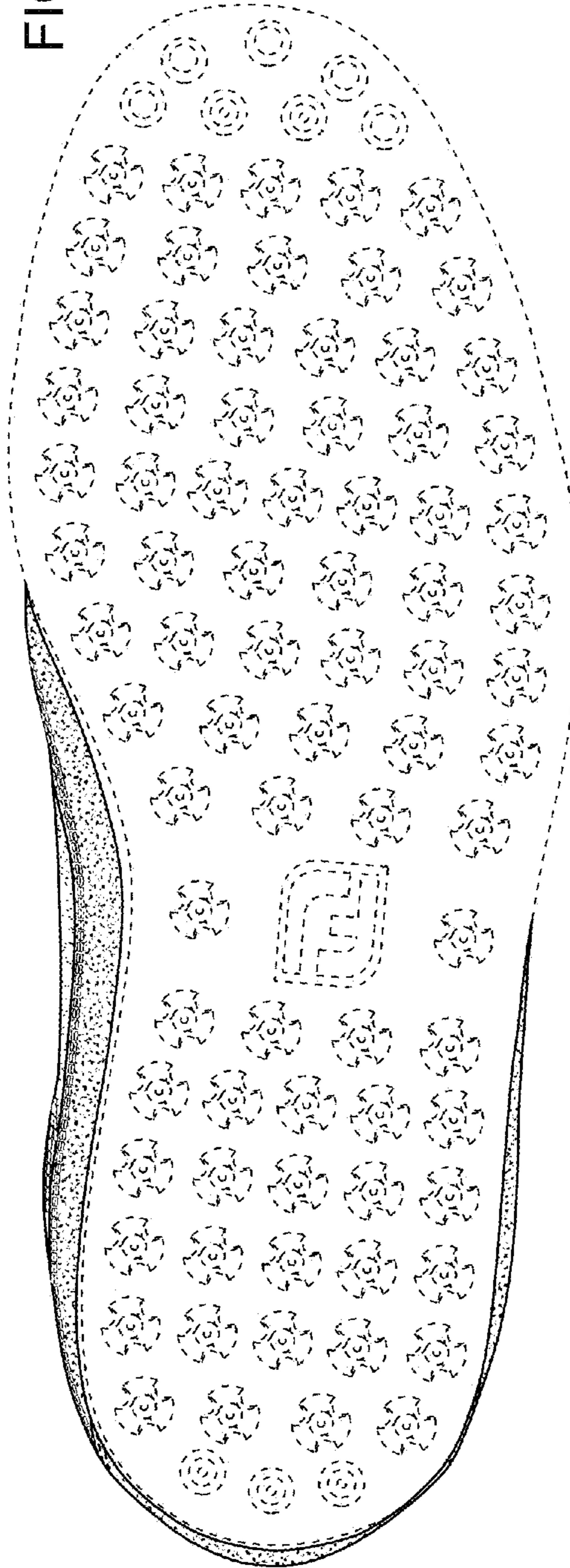

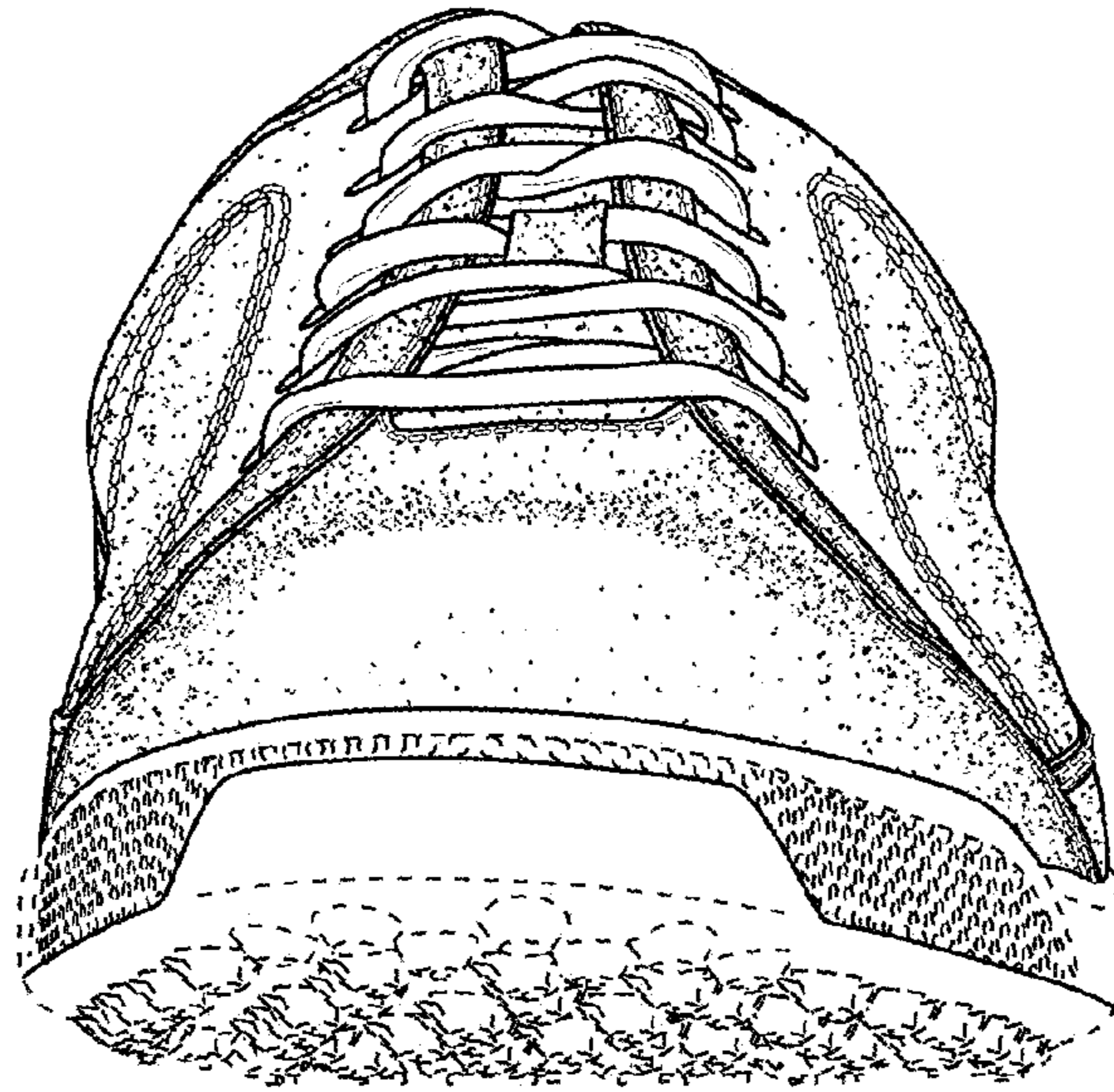

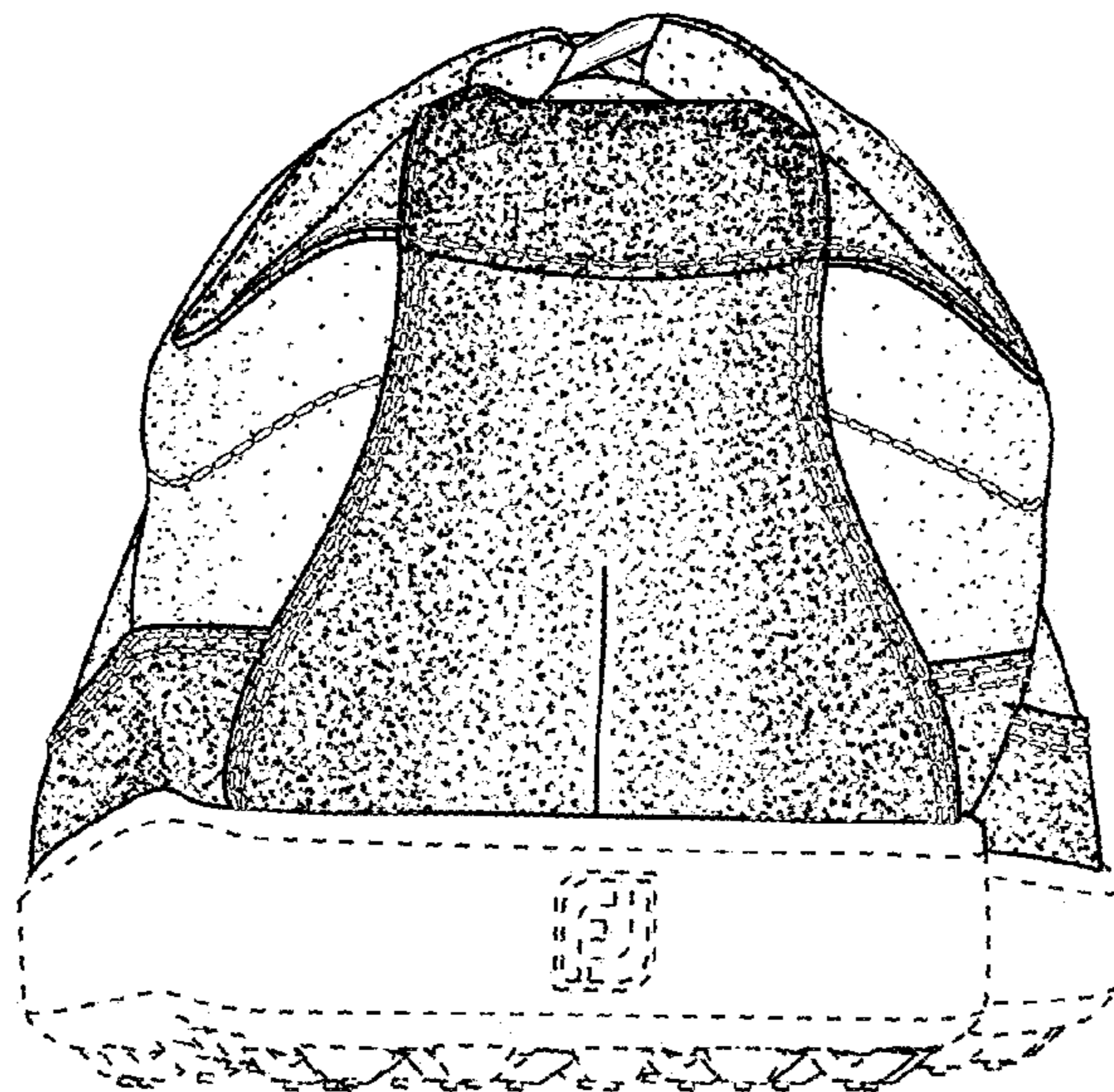
