 FIG. 5 is an enlarged view of the claimed region of FIG. 4 shown in isolation from the remainder of the environment thereof.

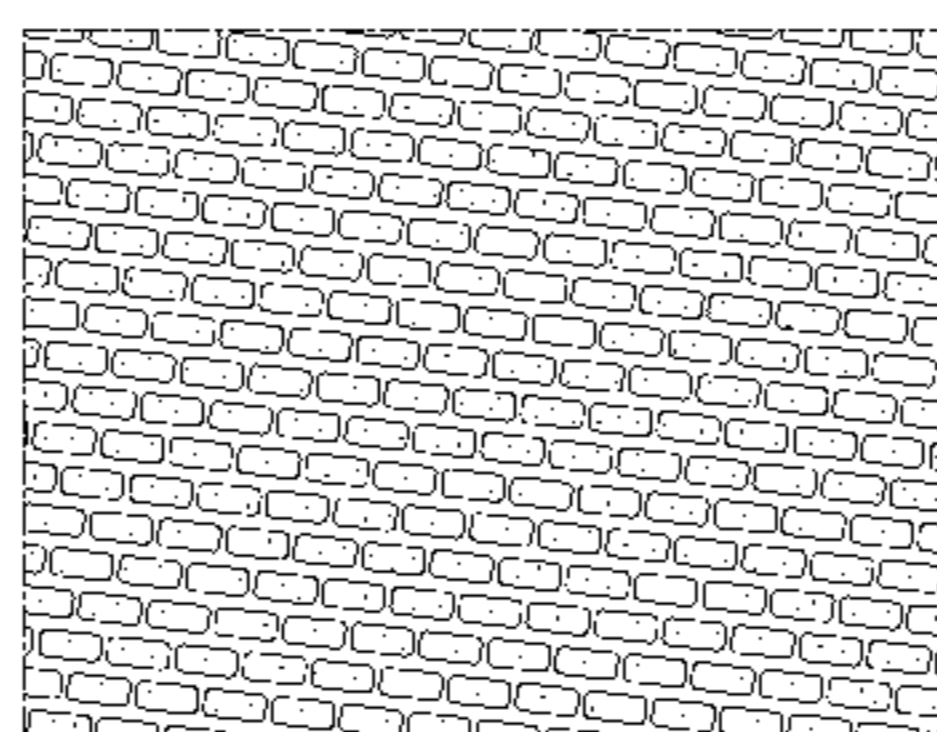
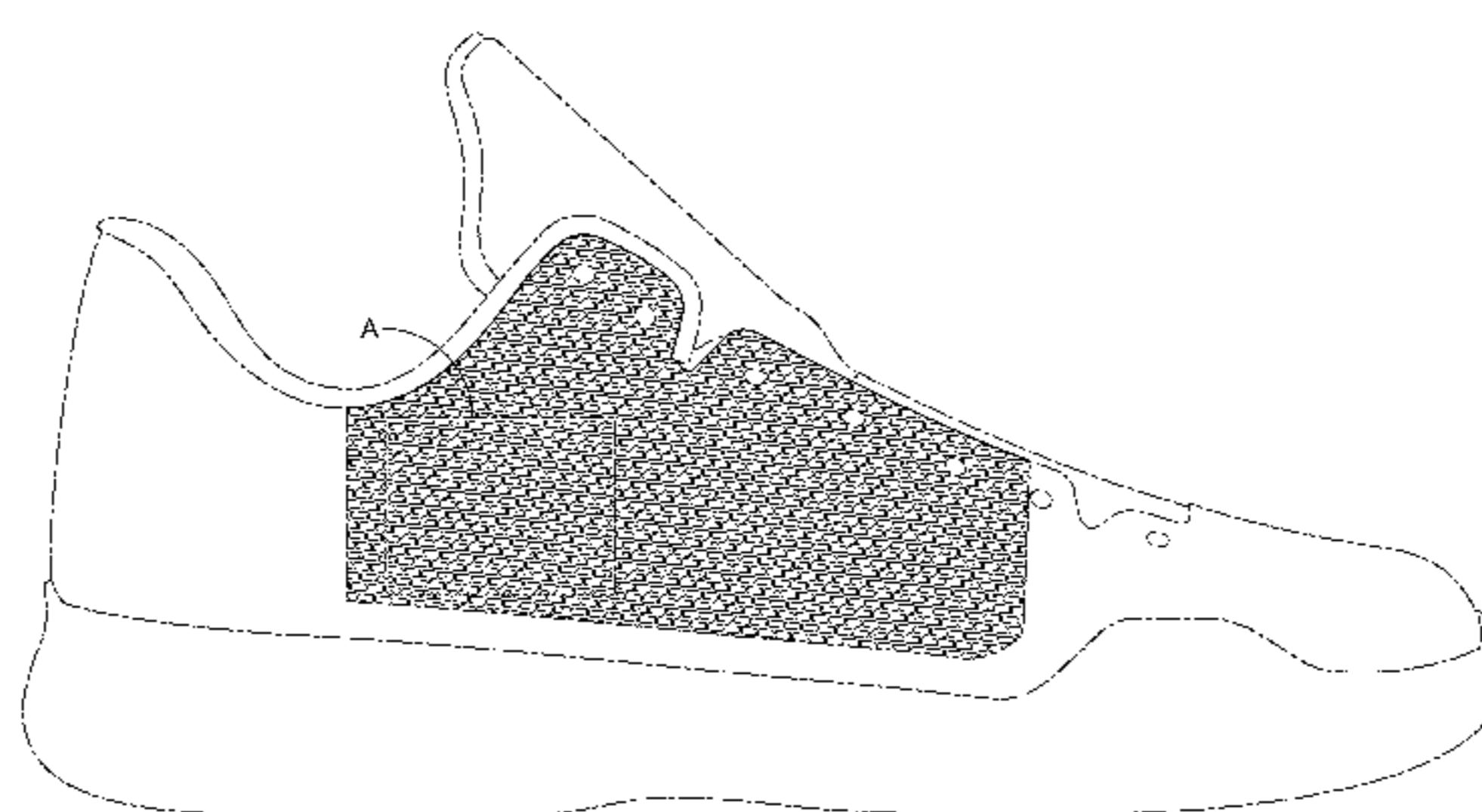

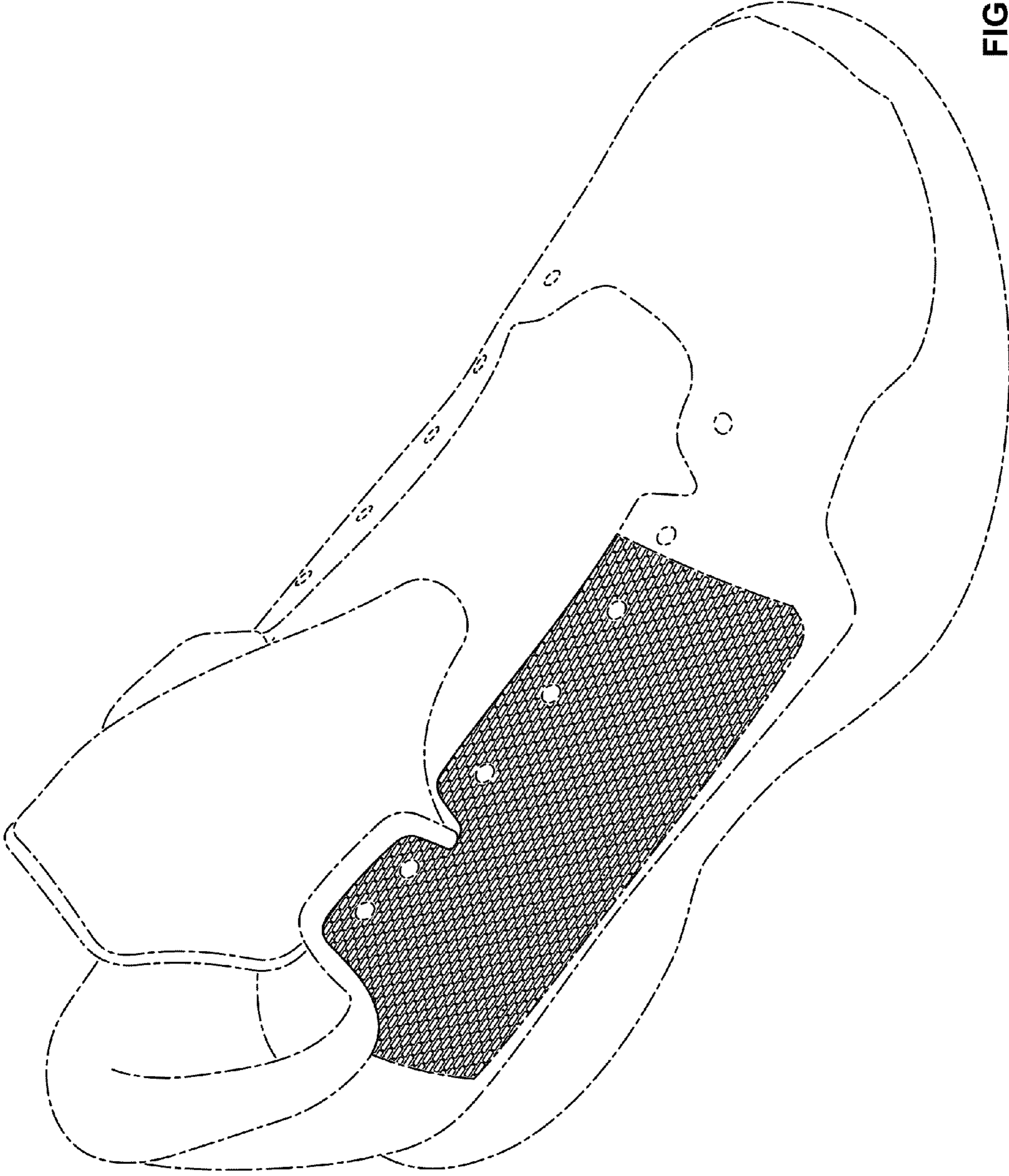

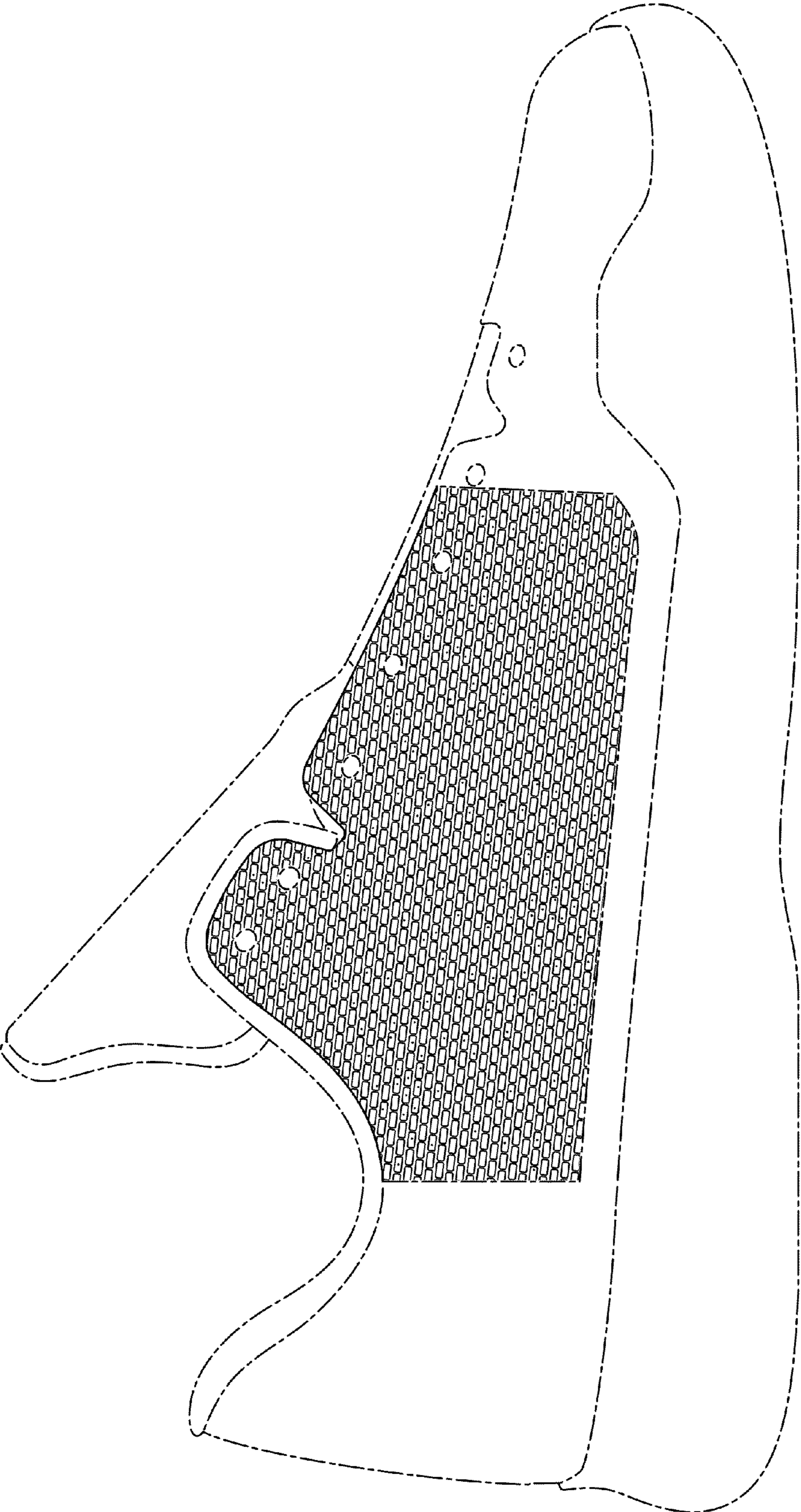

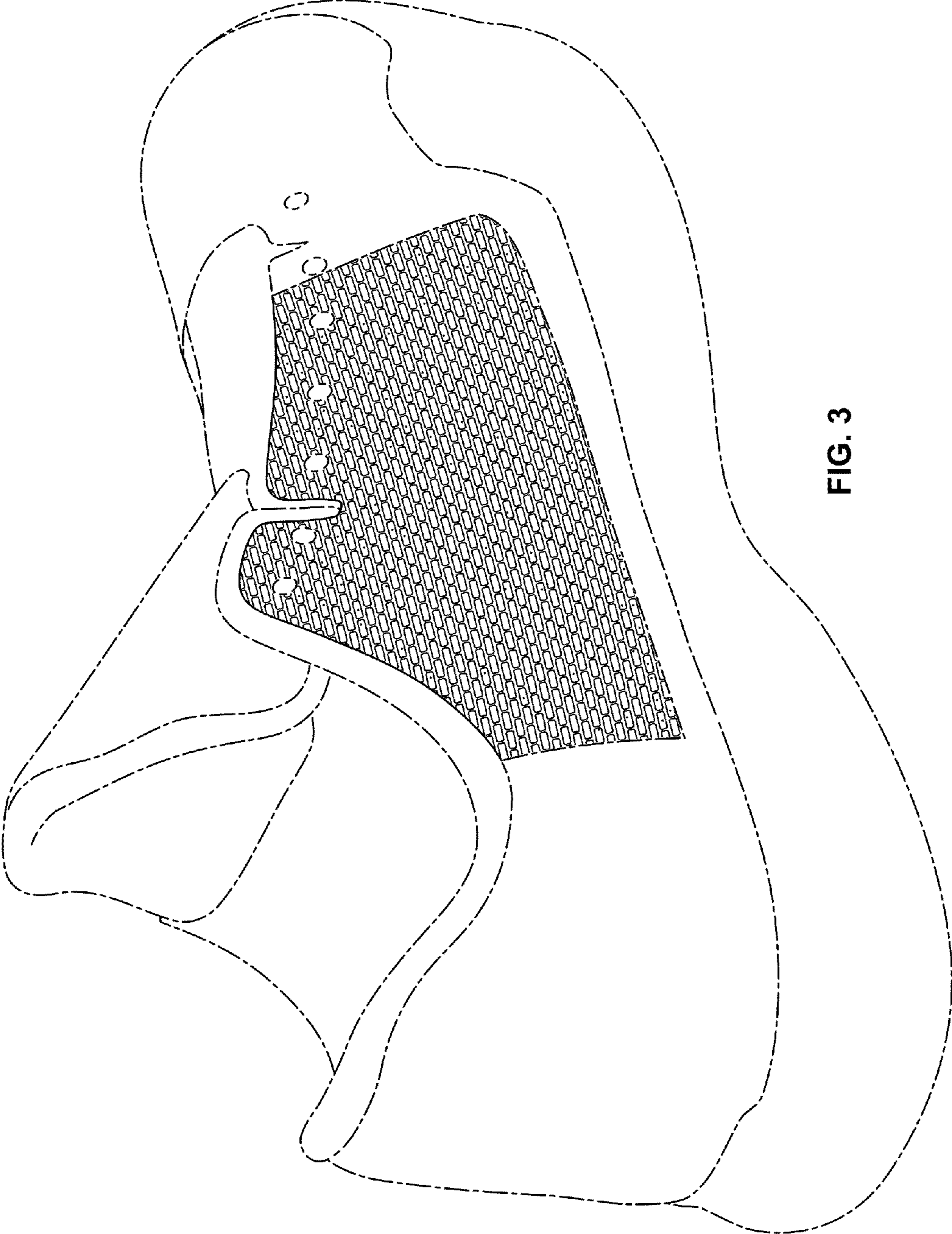

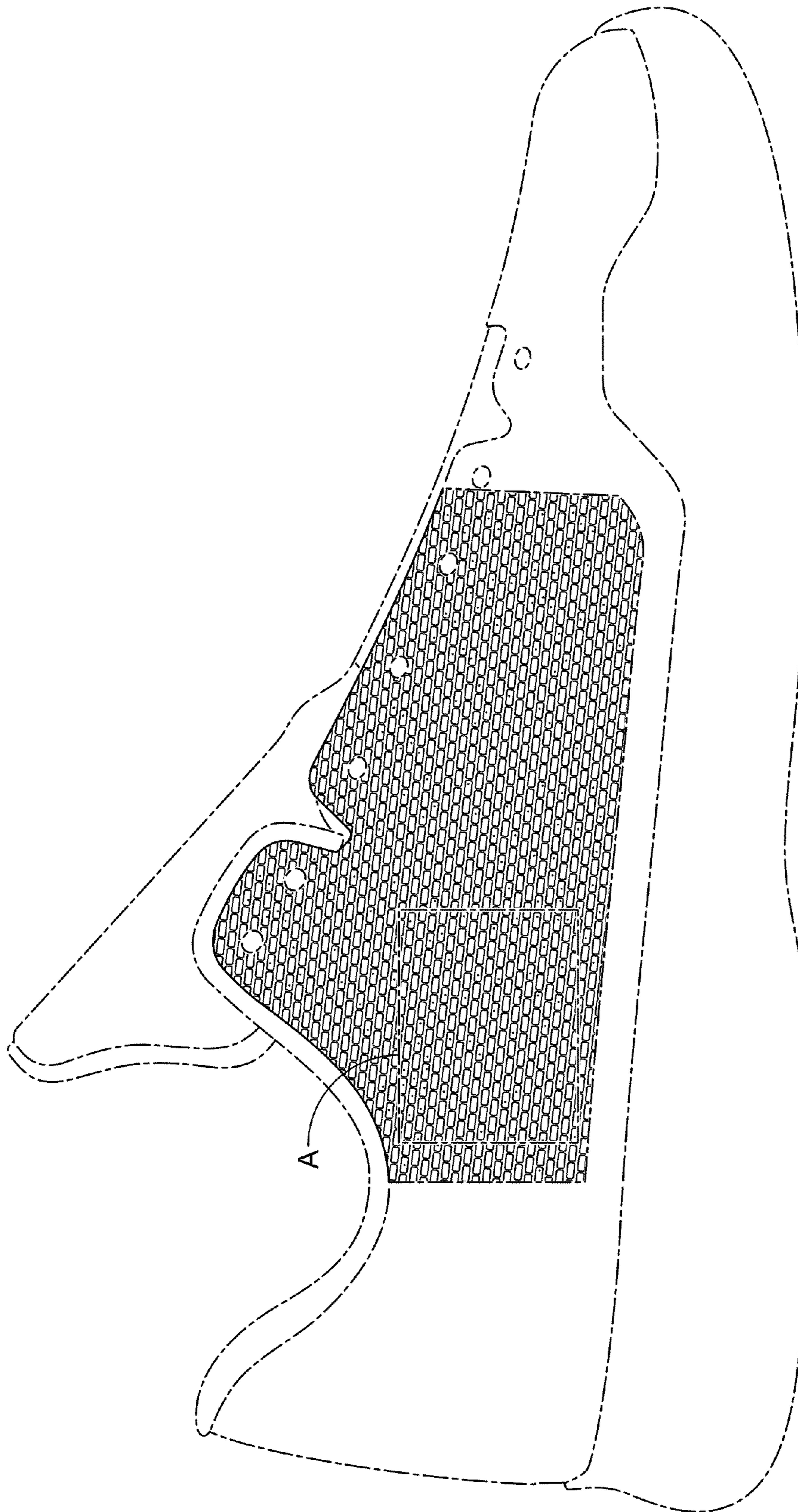

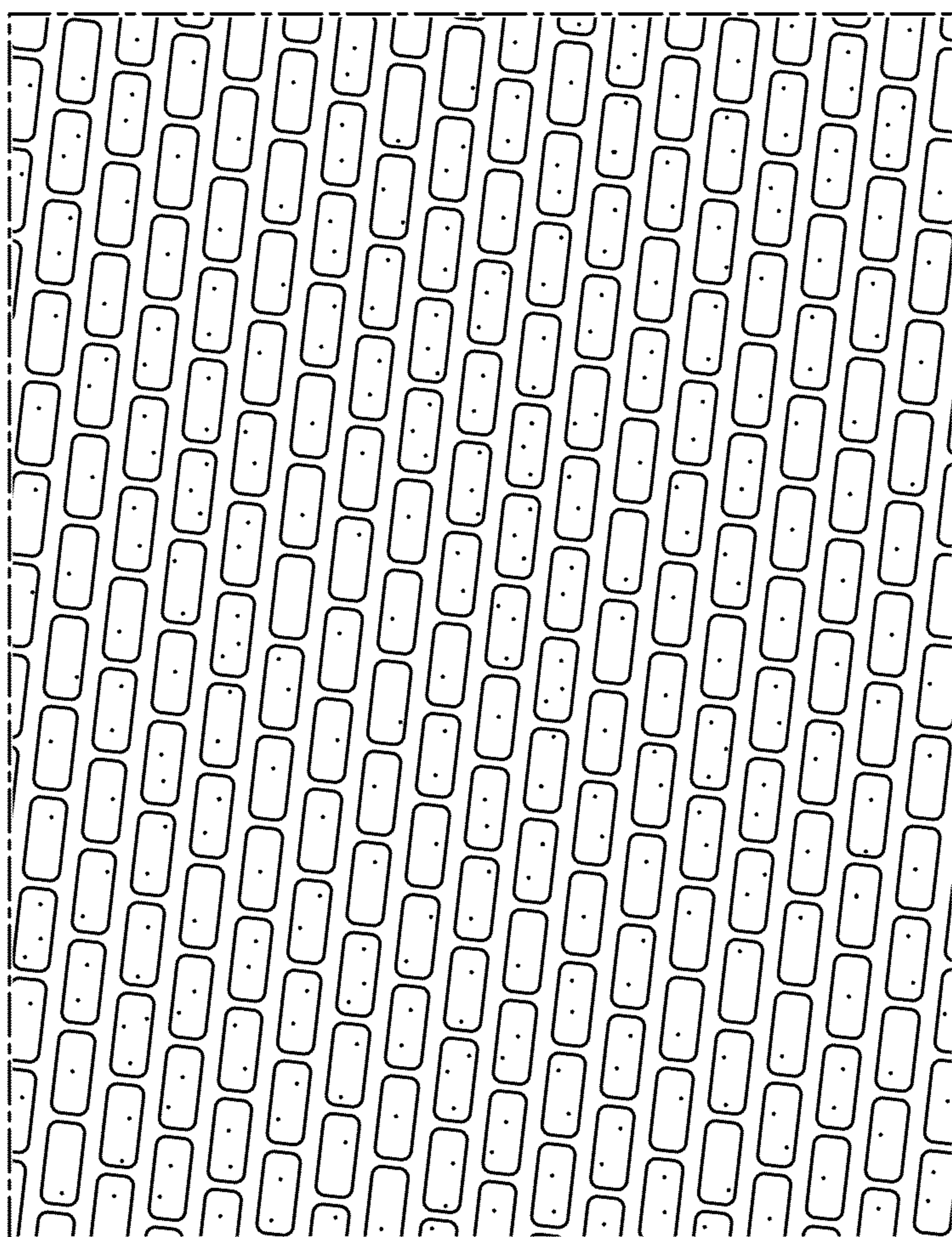
