I claim the ornamental design for a slat wall, as shown and described.

**DESCRIPTION**


FIG. 1 is a perspective view of a slat wall;  
 FIG. 2 is a front view of the slat wall;  
 FIG. 3 is a back view of the slat wall;  
 FIG. 4 is a right side view of the slat wall where the left side view has the same construction;  
 FIG. 5 is a top view of the slat wall; and,  
 FIG. 6 is a bottom view of the slat wall.

The broken lines shown in the drawings are included for purposes of illustrating portions of the slat wall and form no part of the claimed design.









