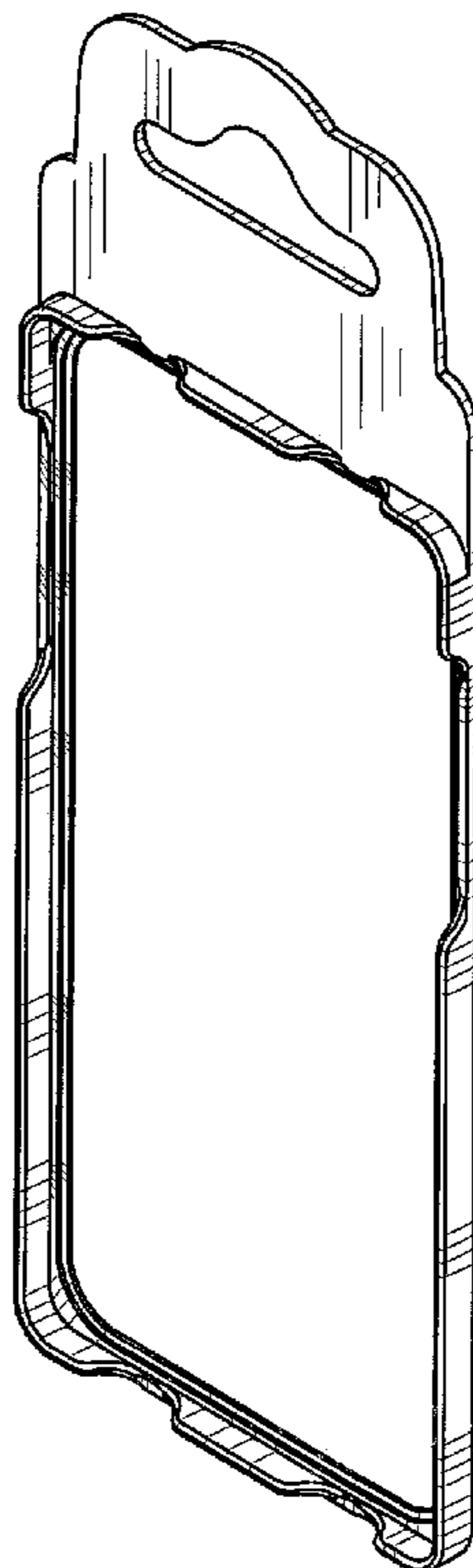
CLAIM

The ornamental design for a film sticking locator for a mobile phone, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a film sticking locator for a mobile phone, showing a new design in accordance with the present invention;

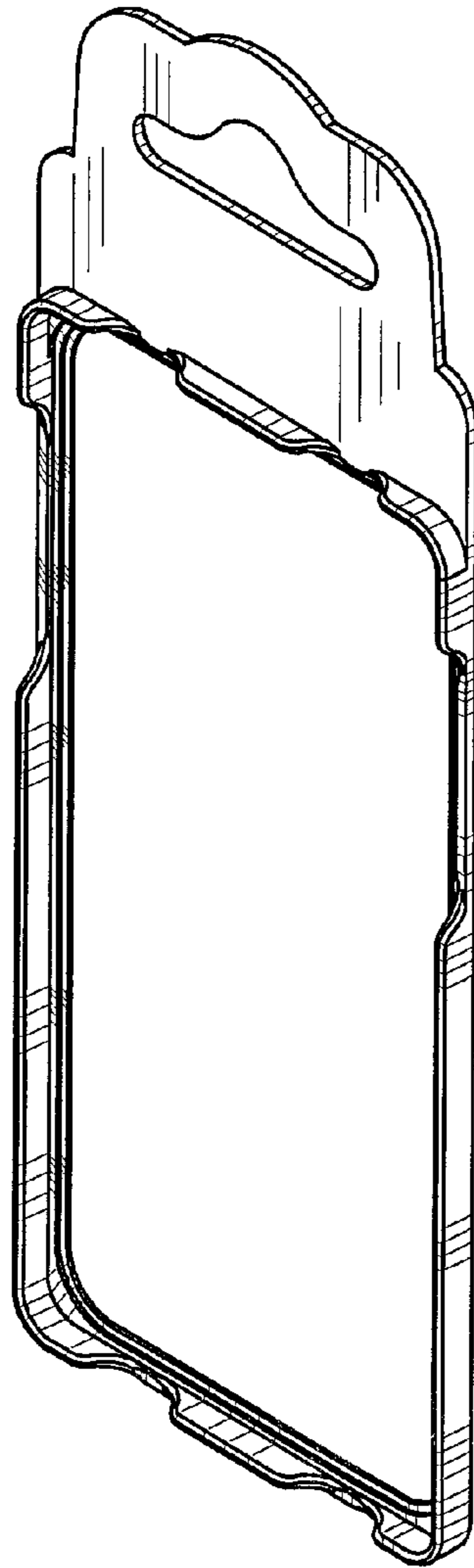

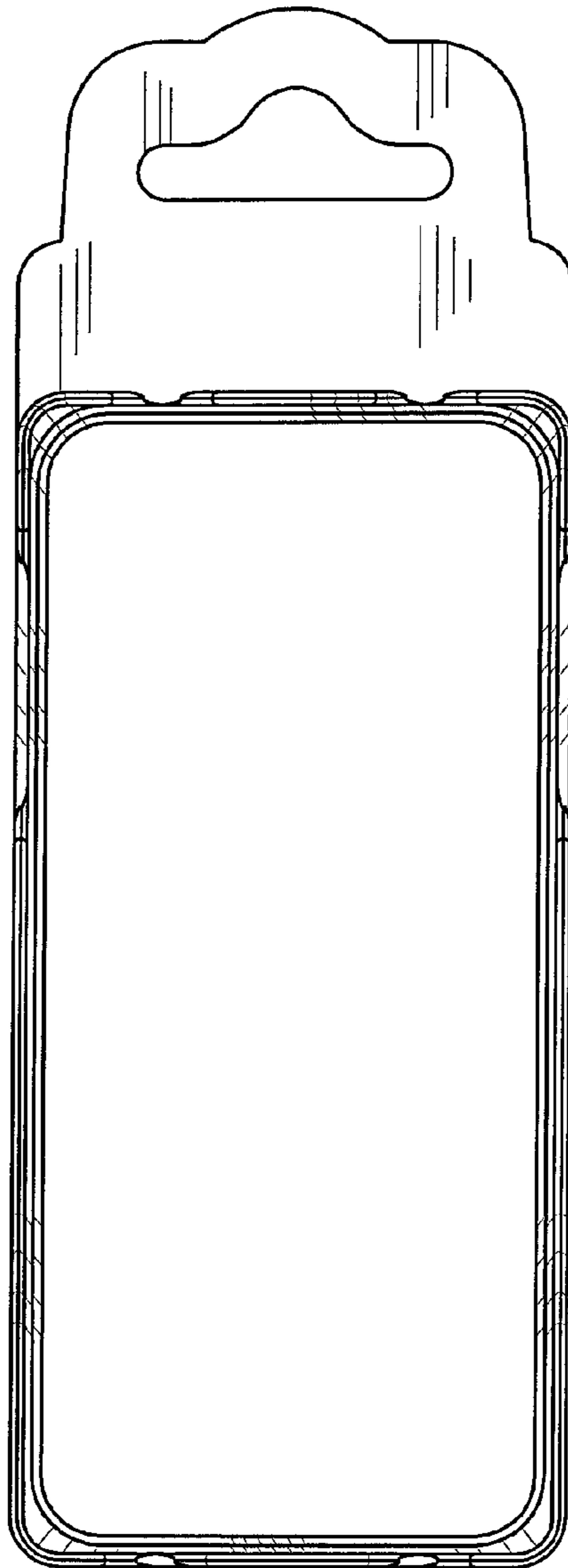

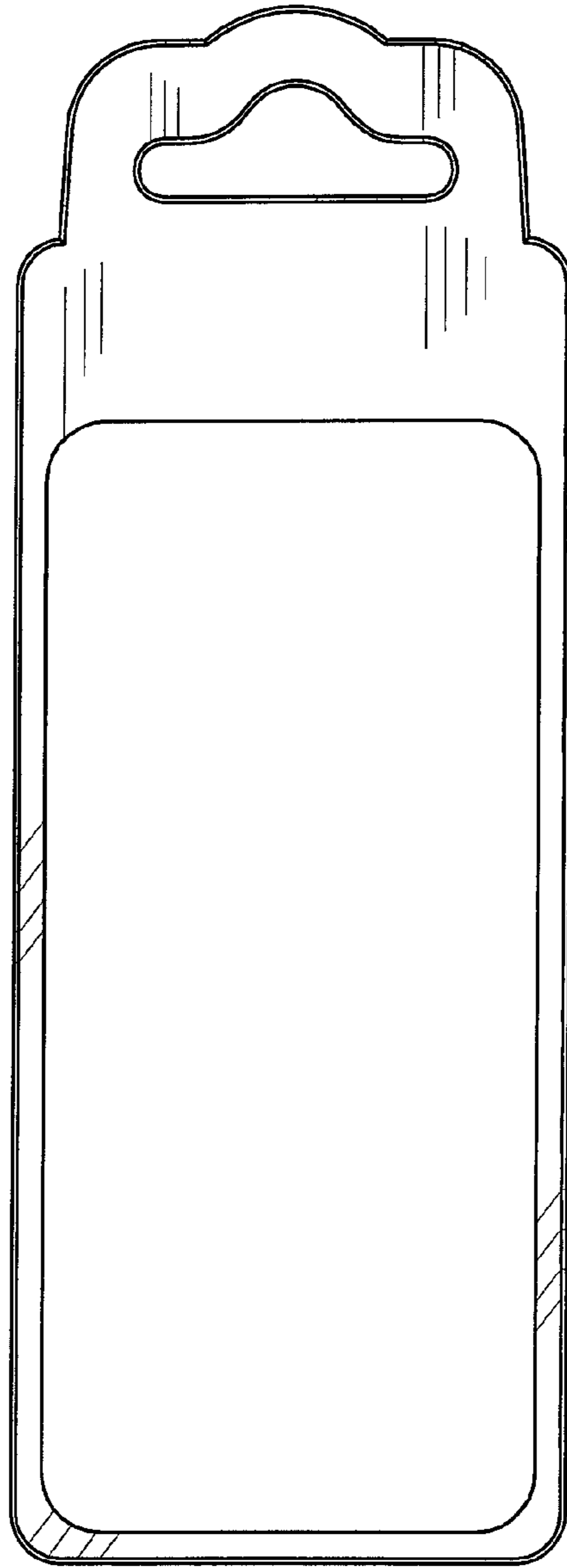

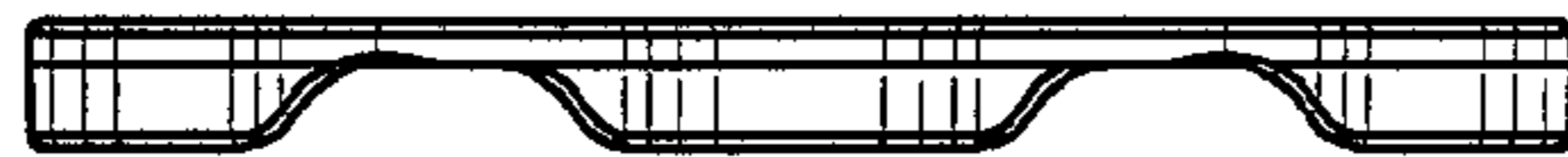

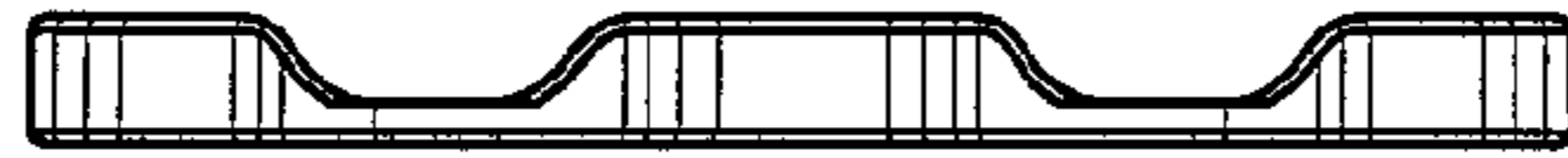
