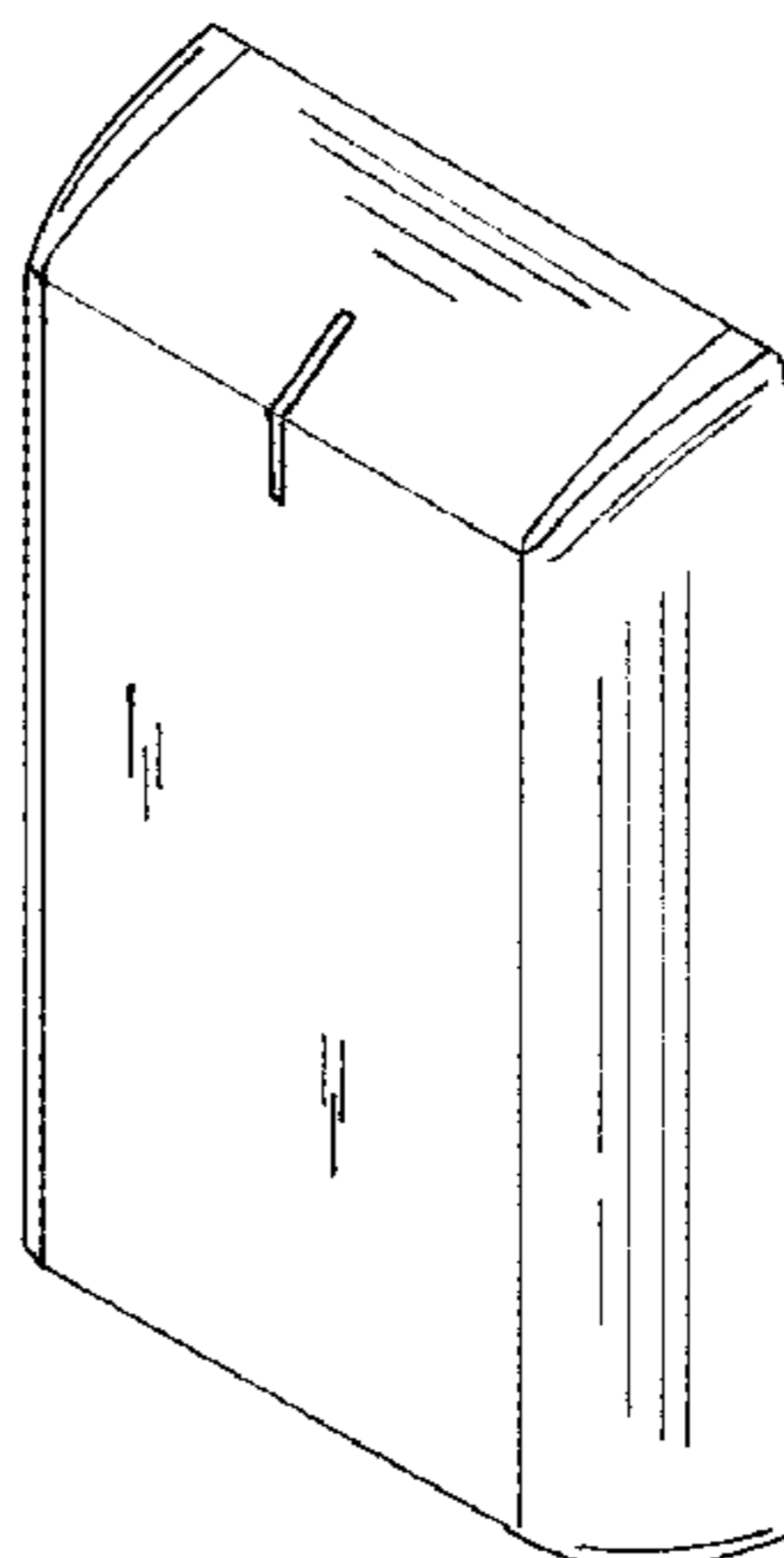


FIG. 10 is a rear elevation view of the escutcheon as shown in FIG. 8;

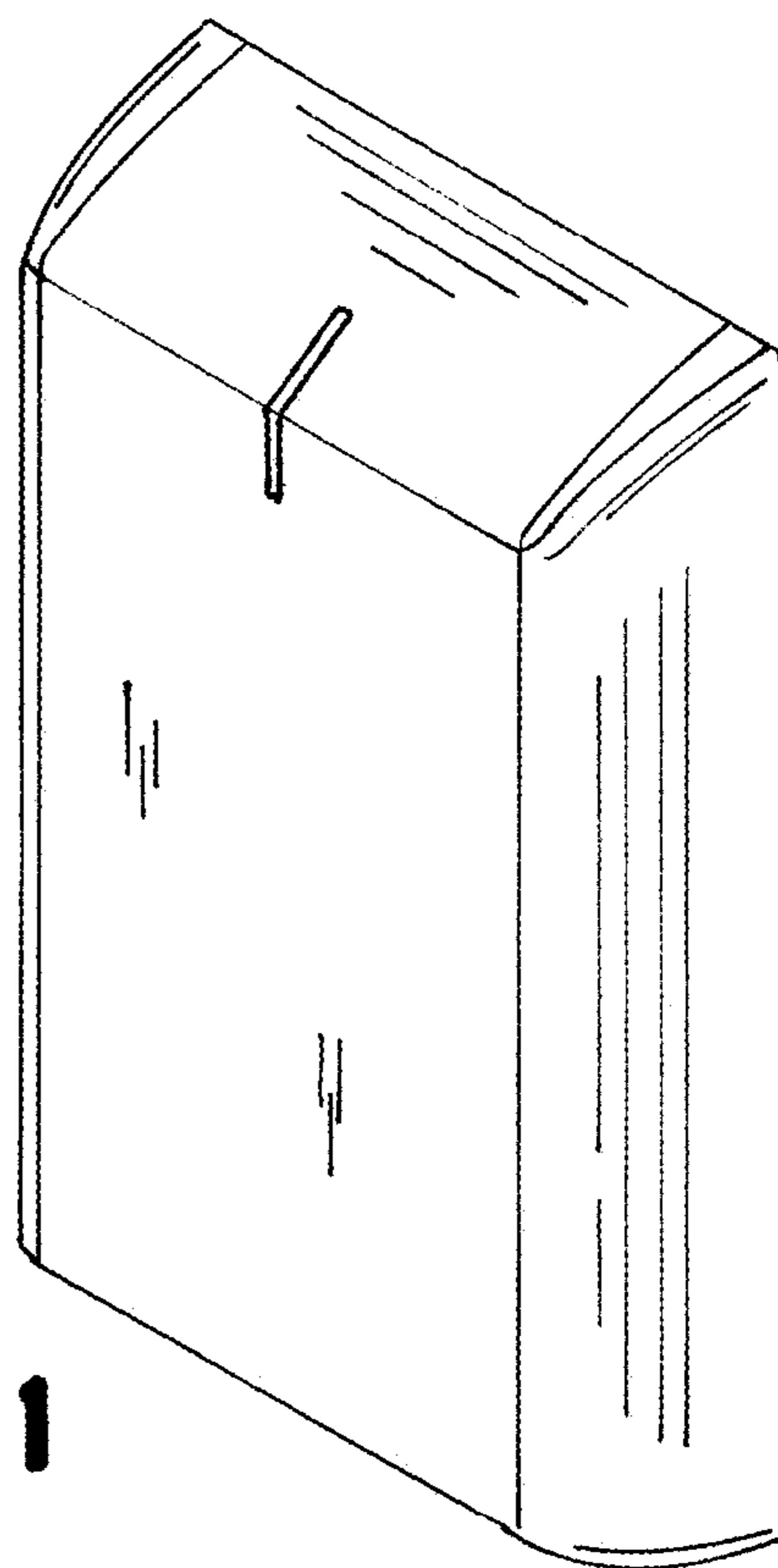

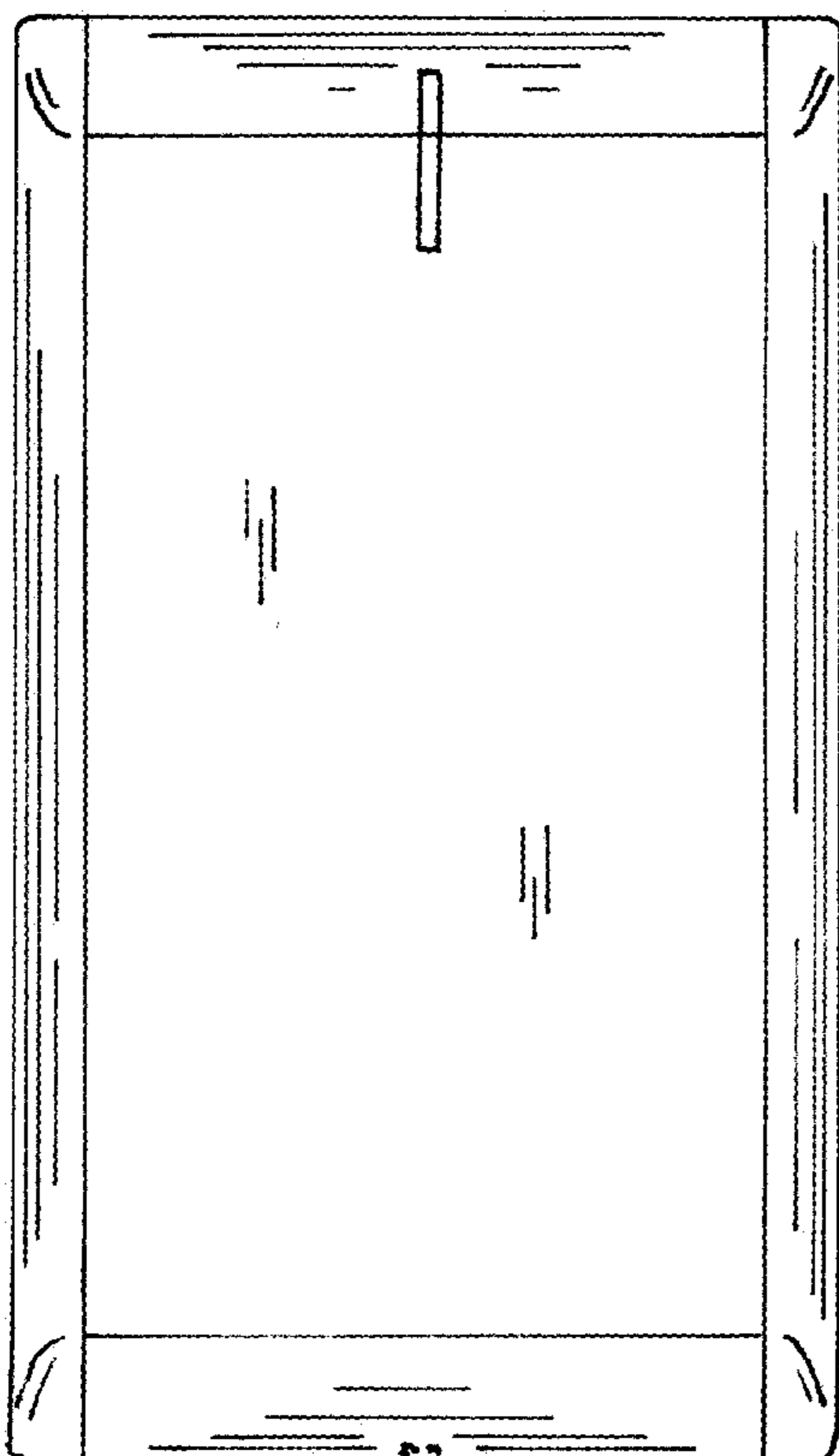

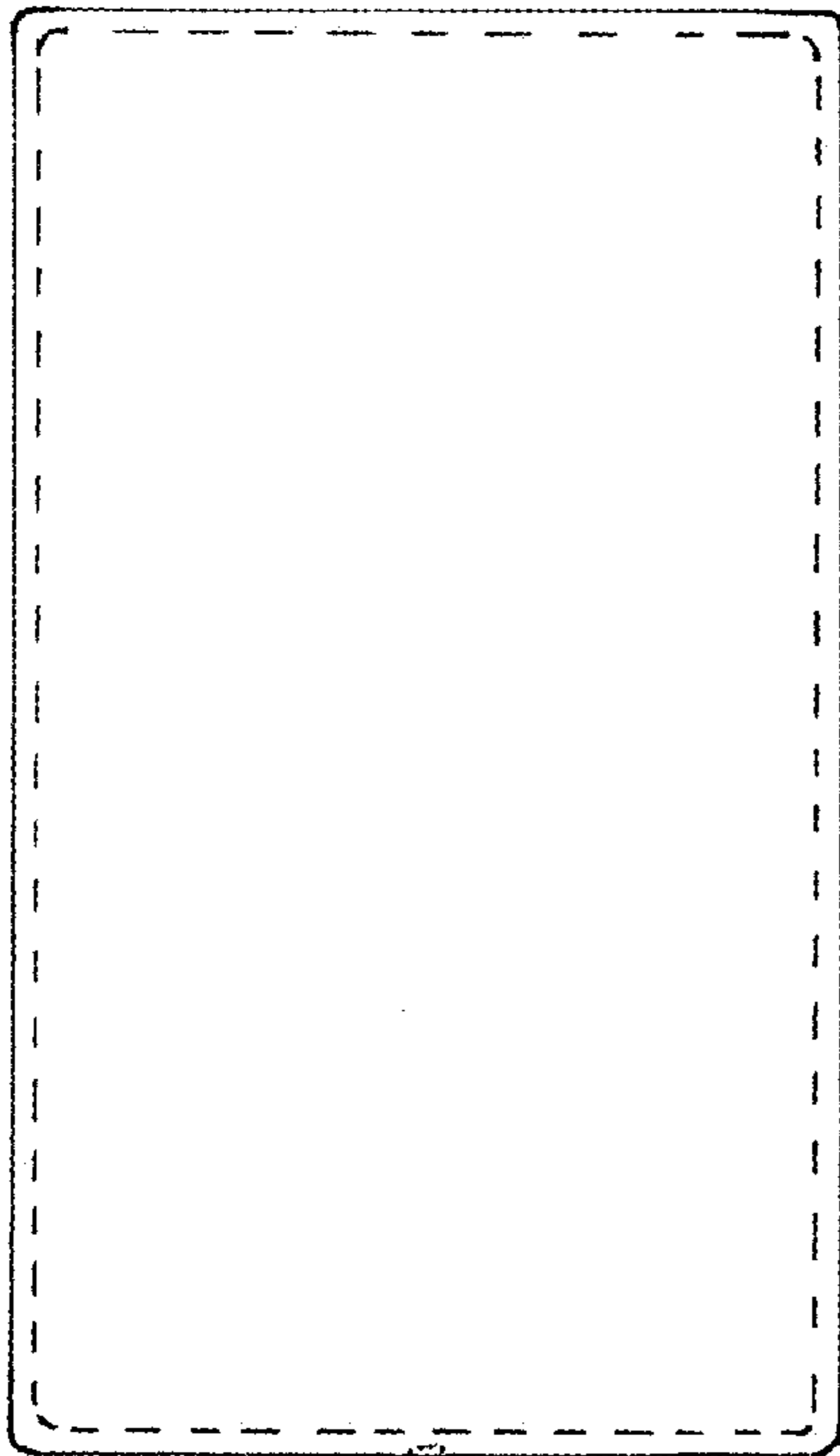

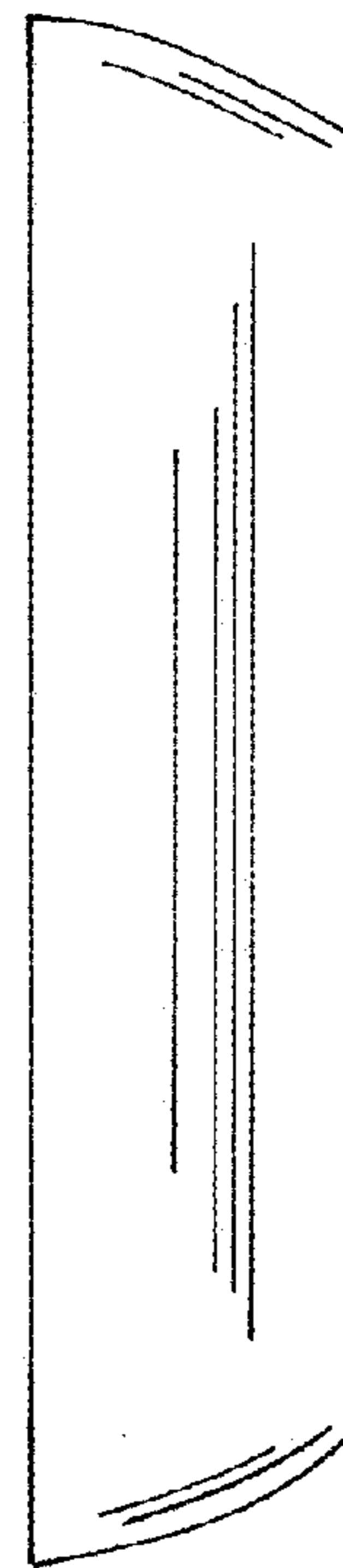

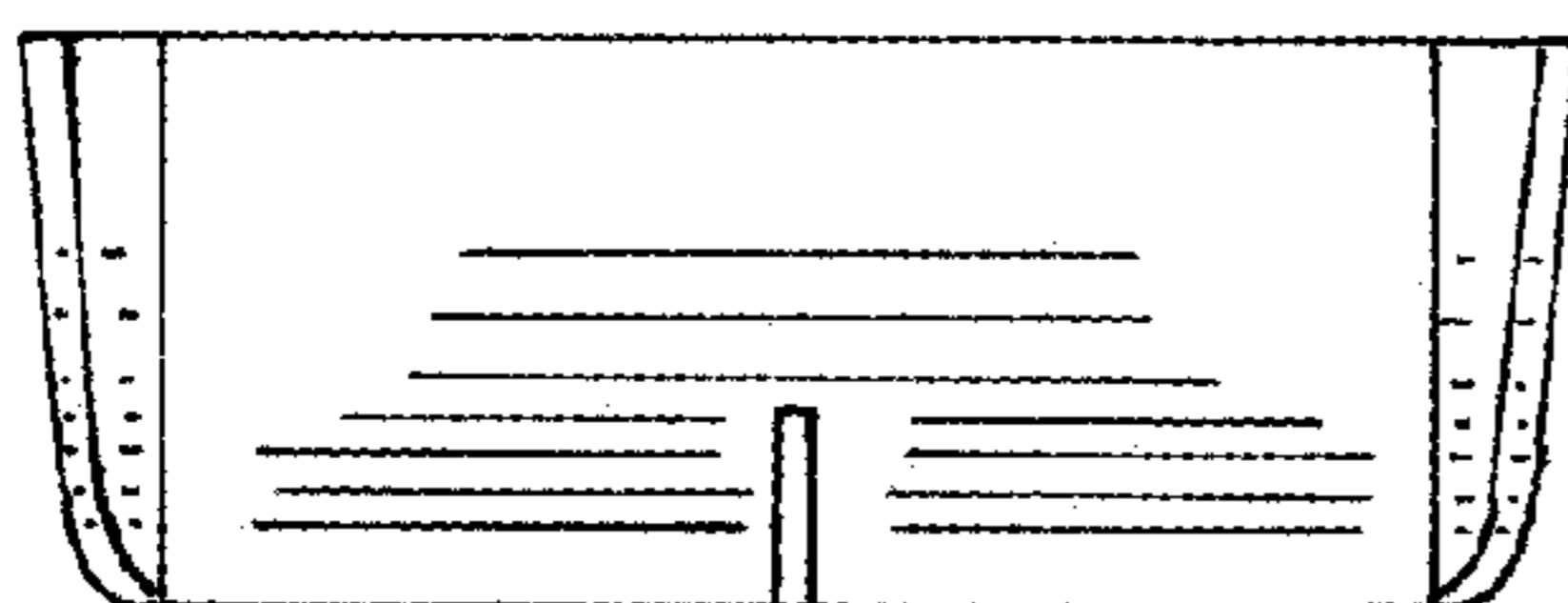

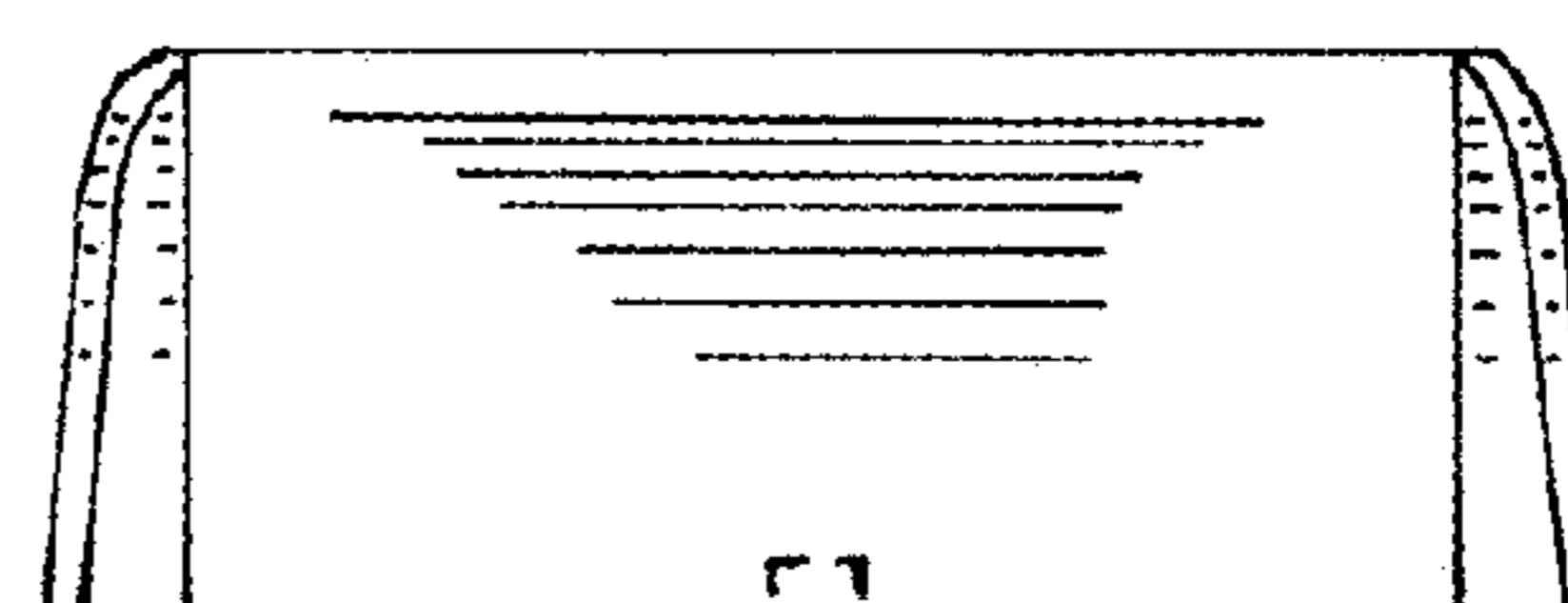

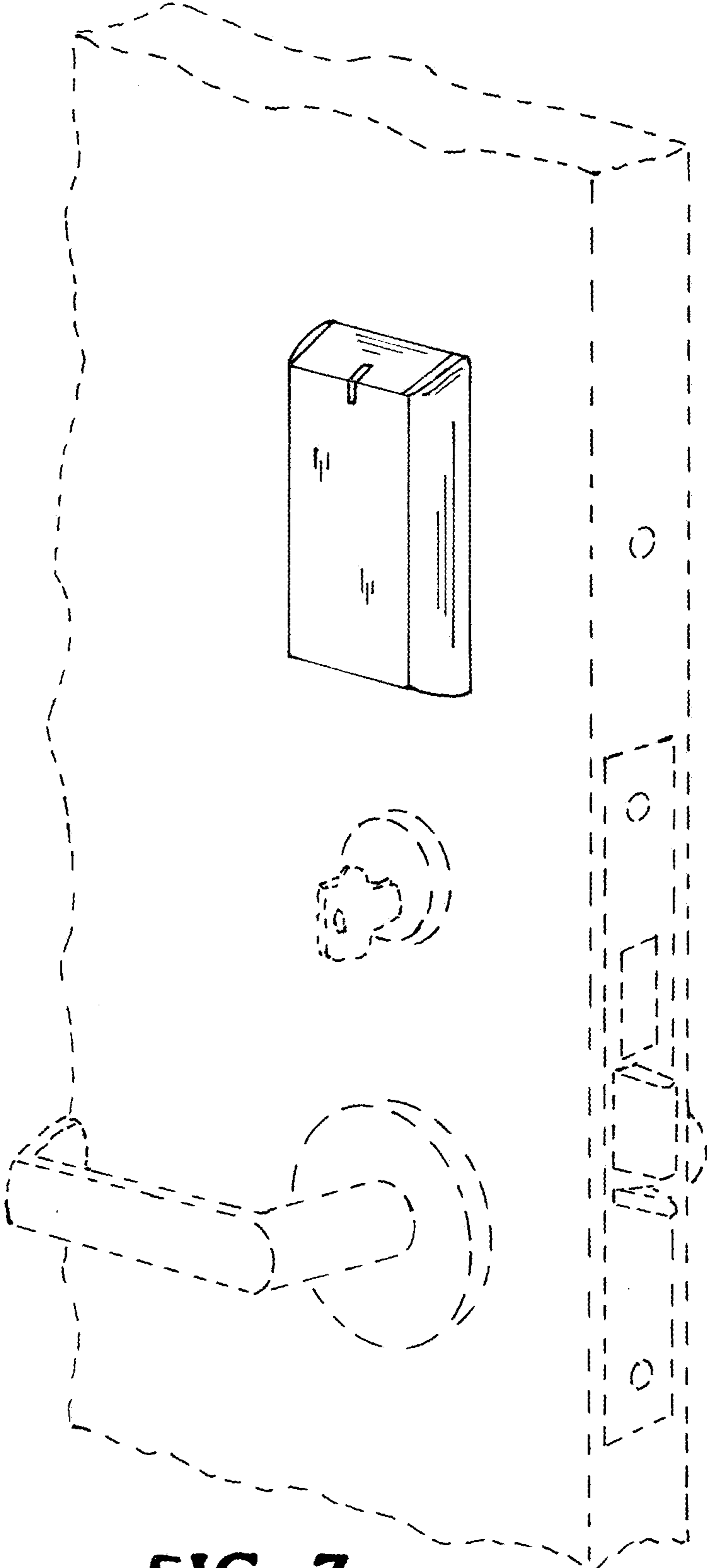

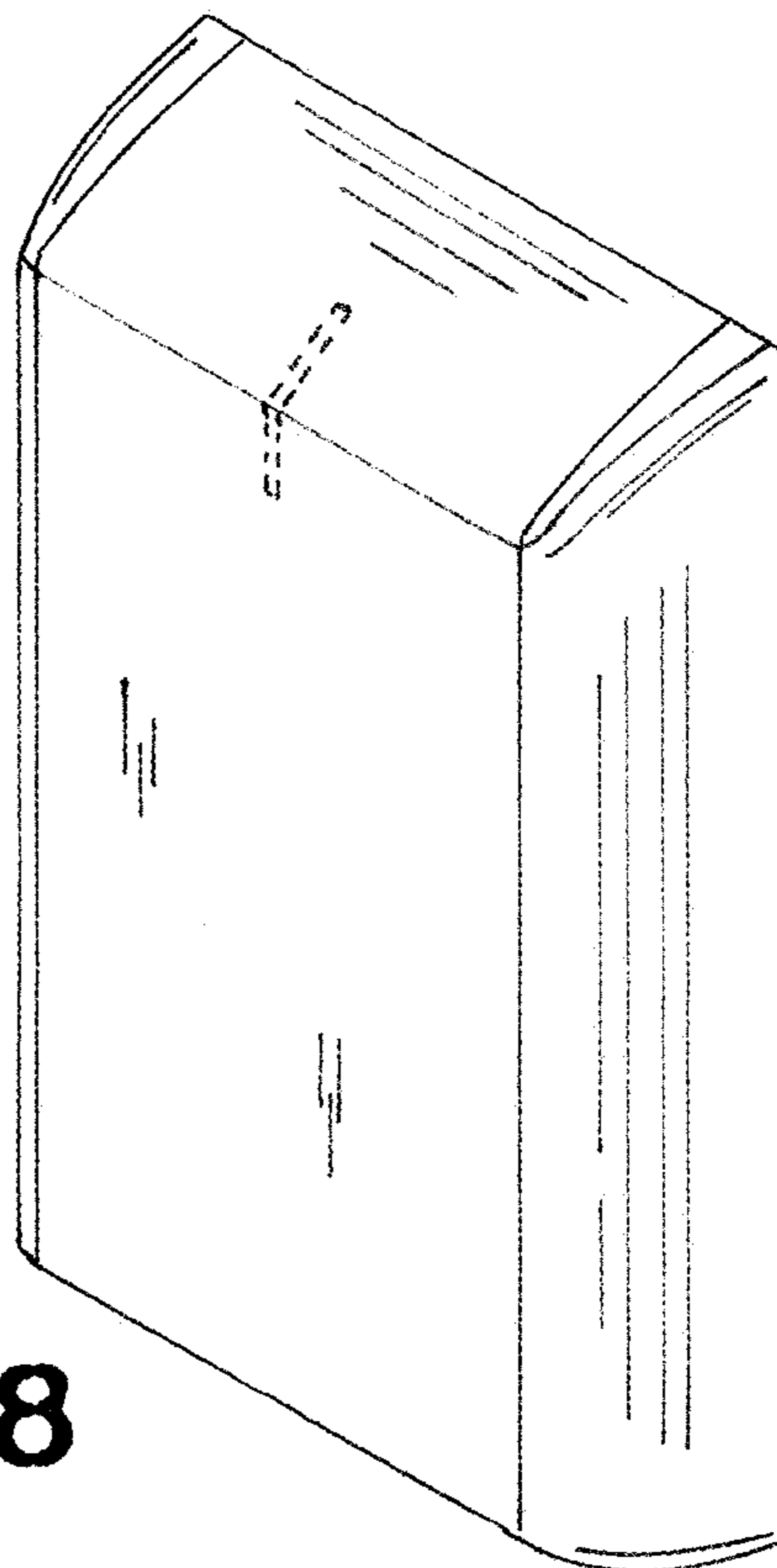

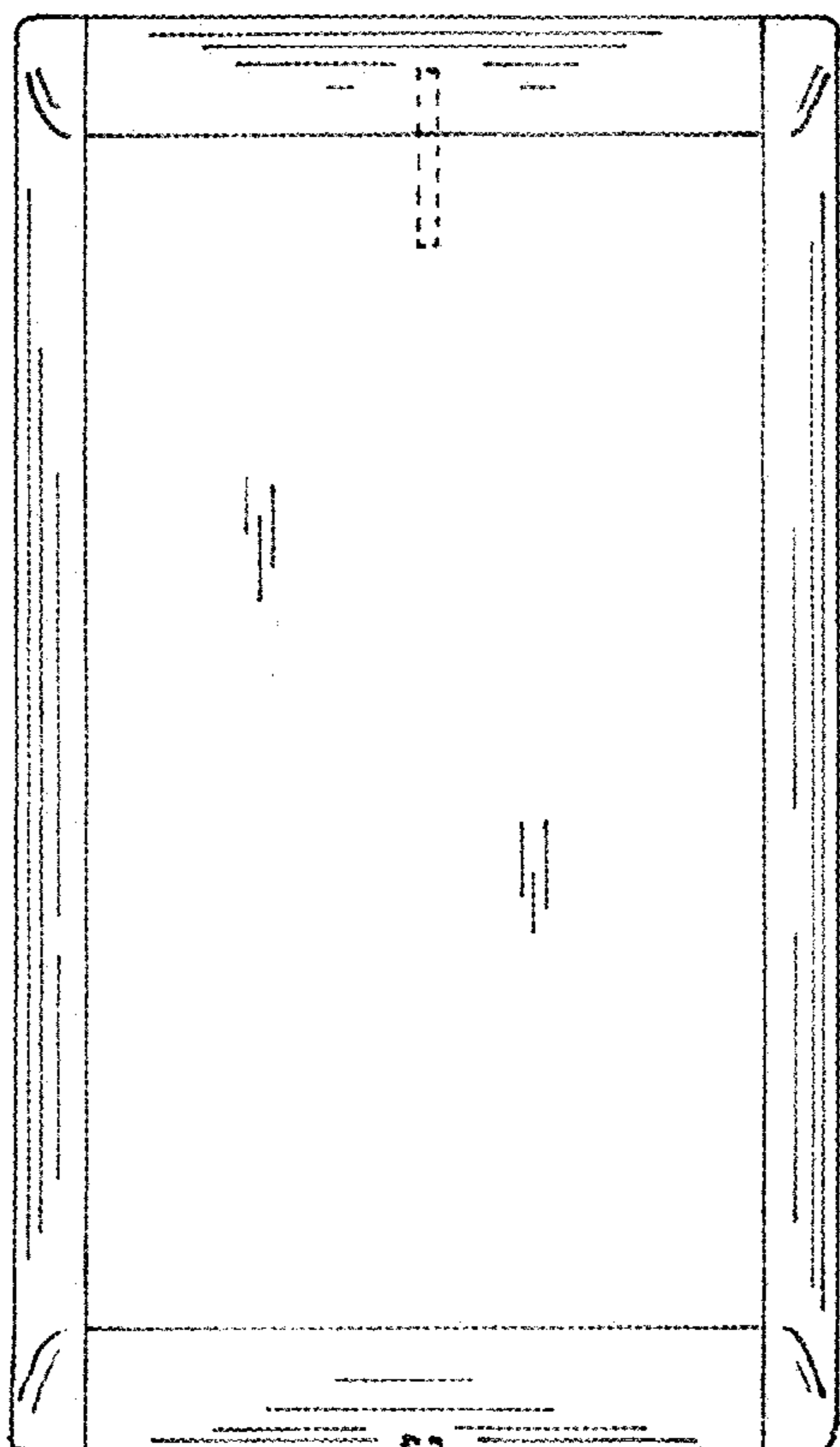

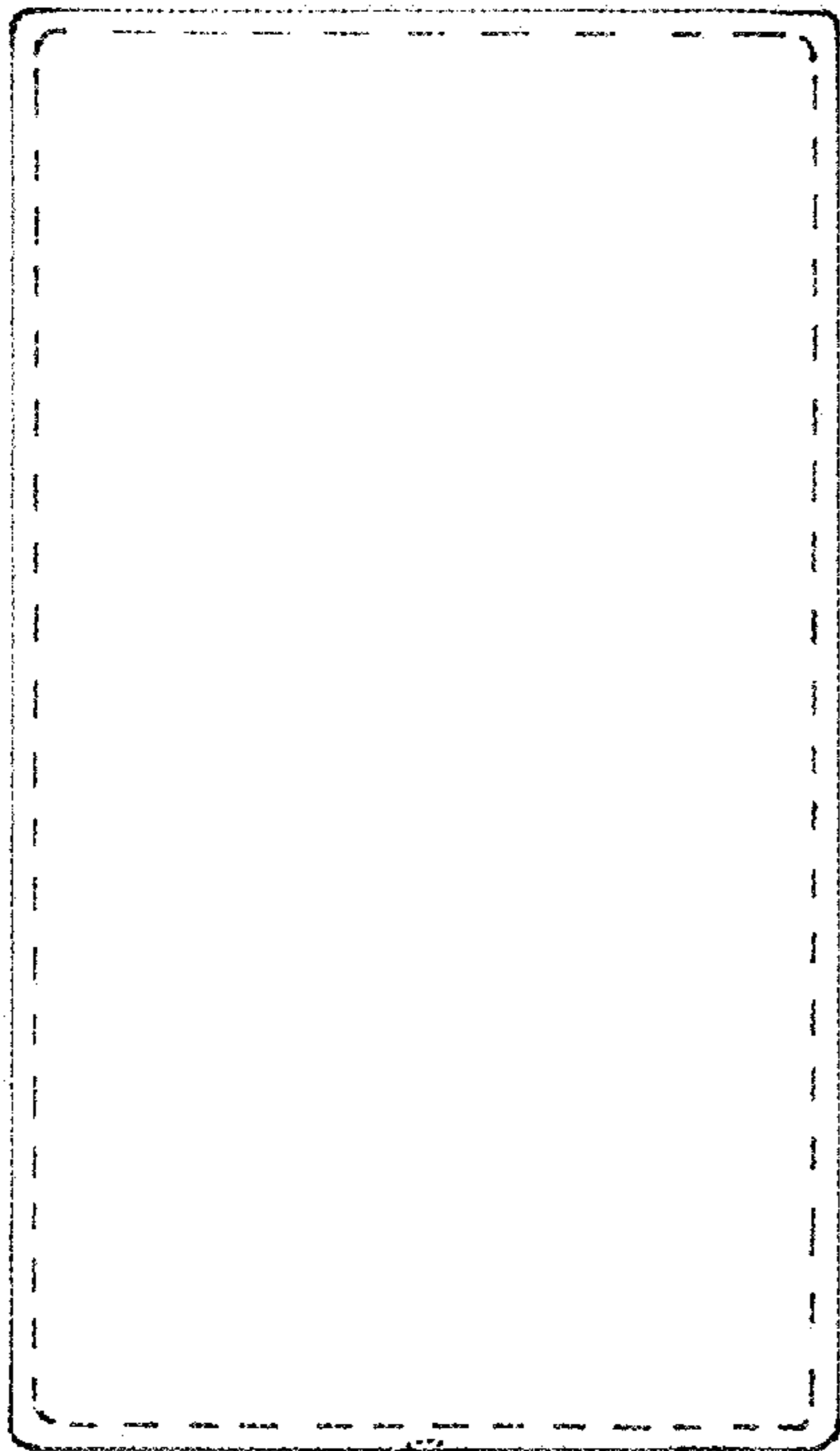

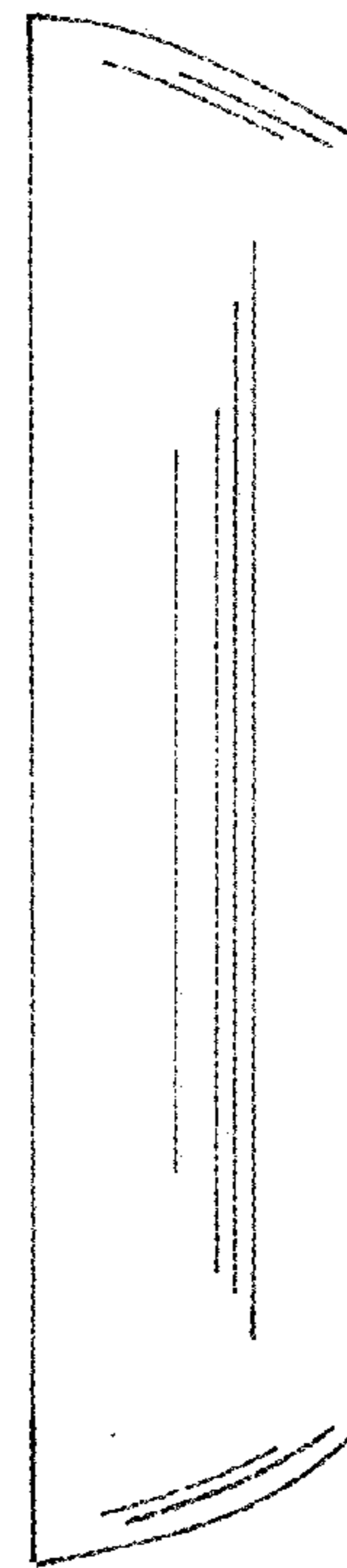

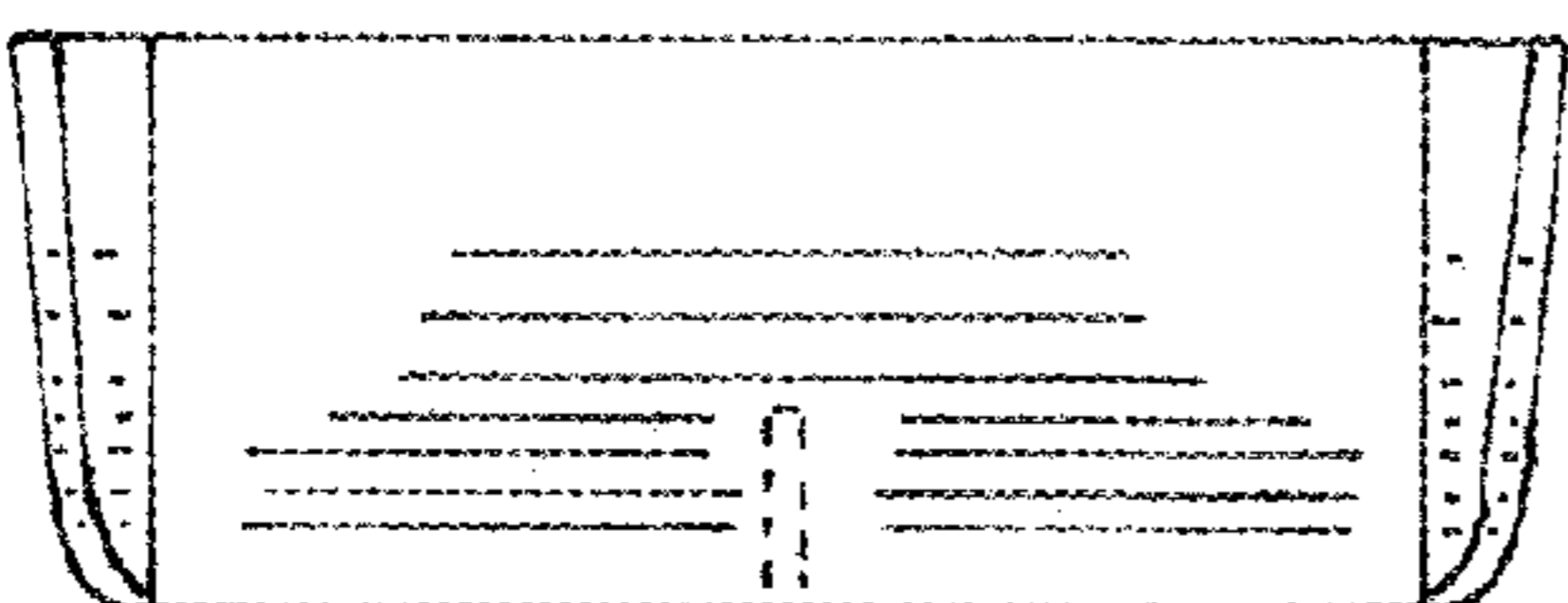

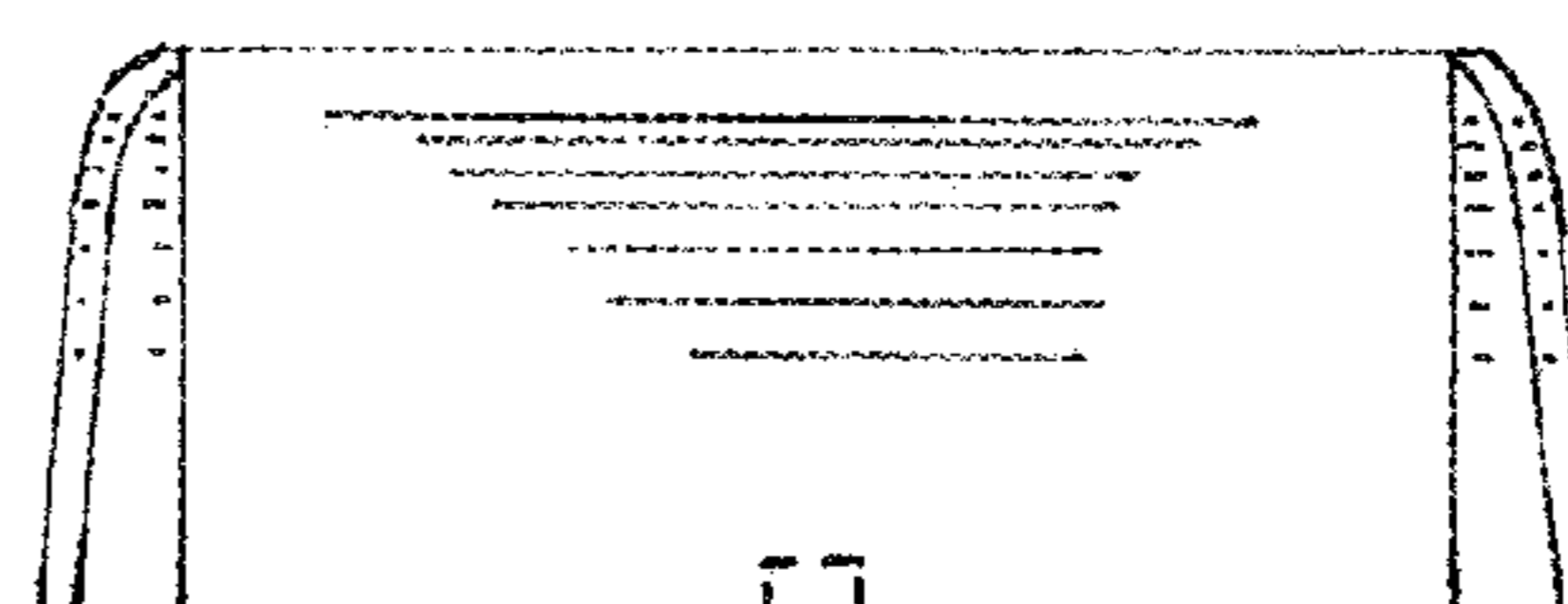

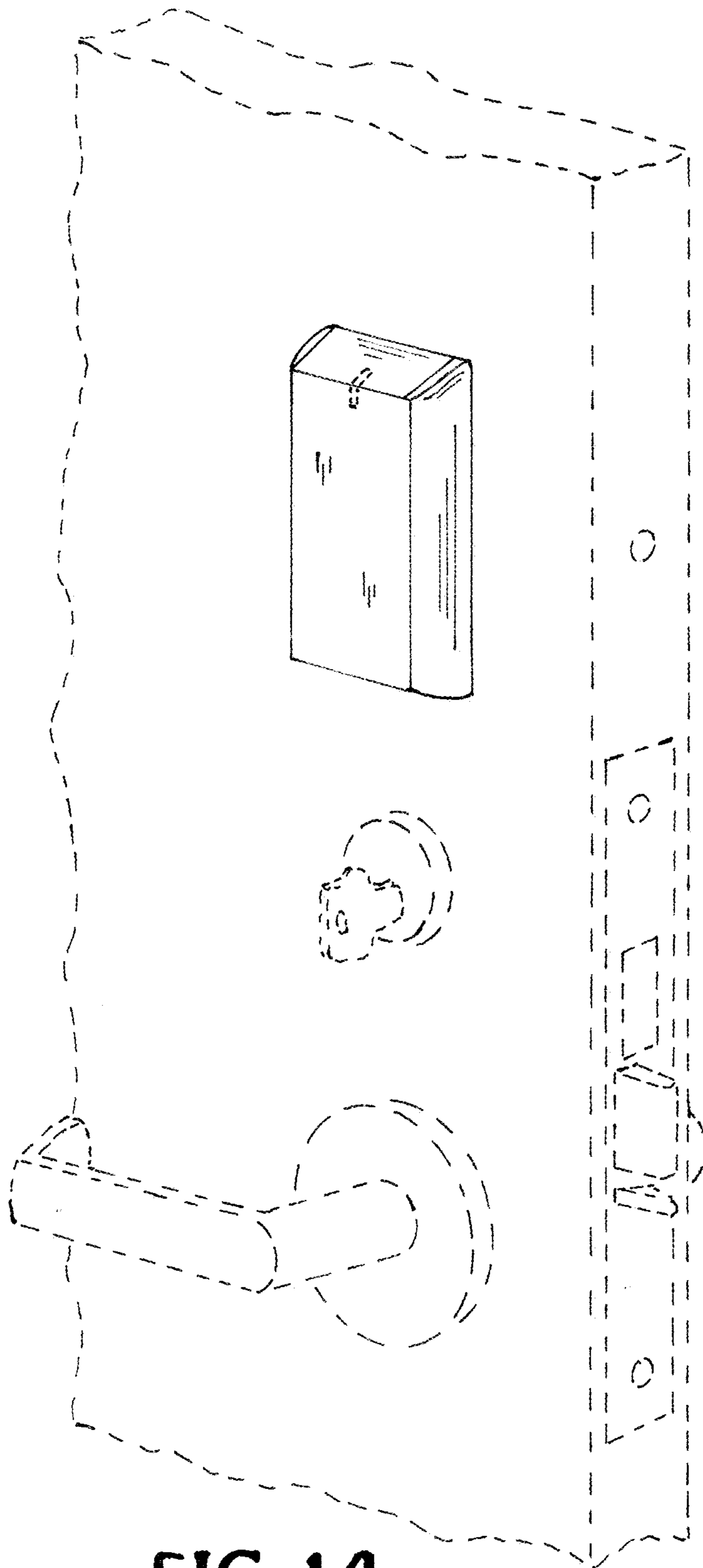

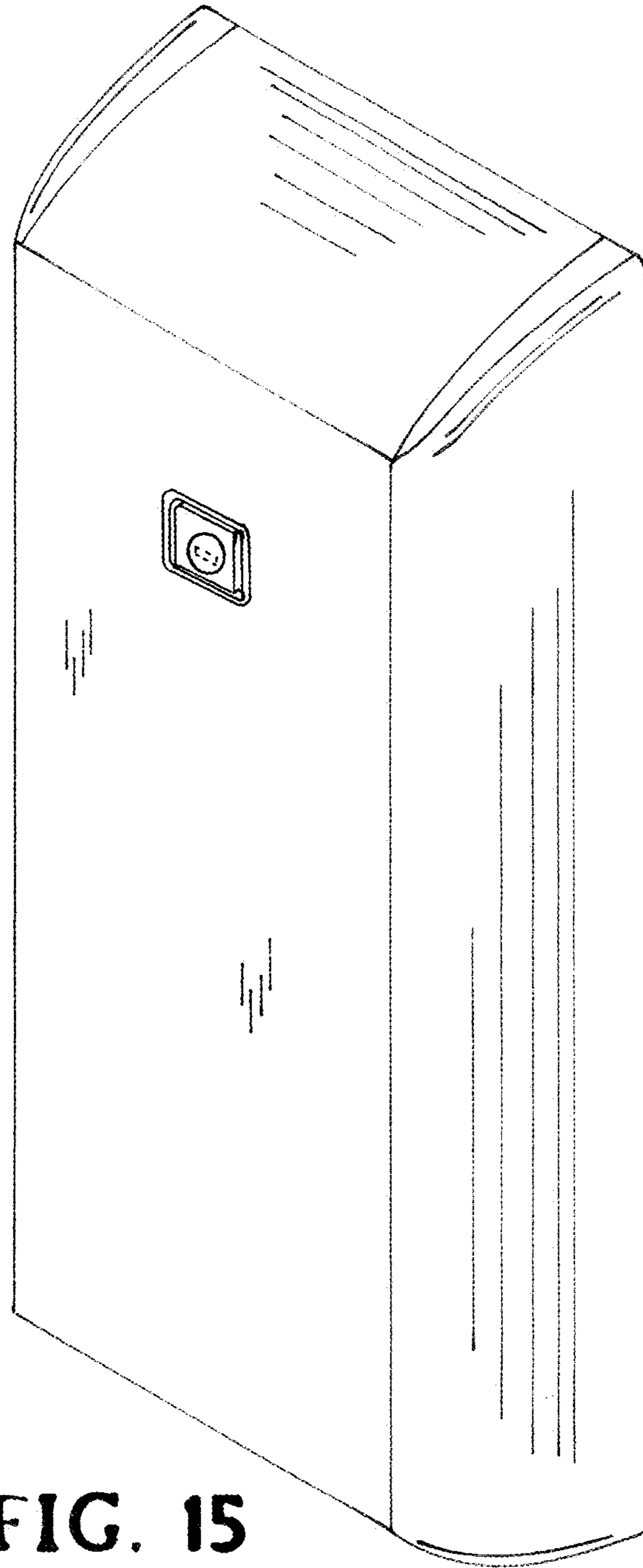

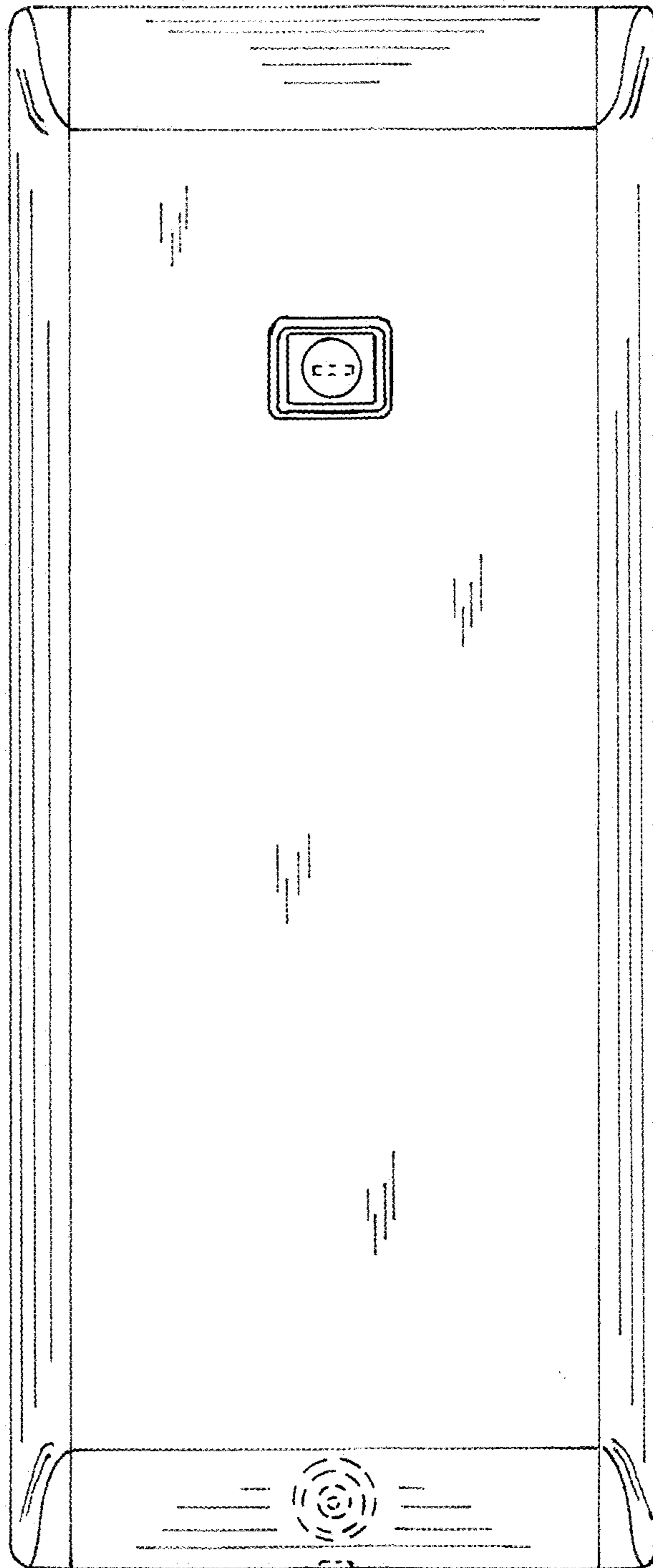

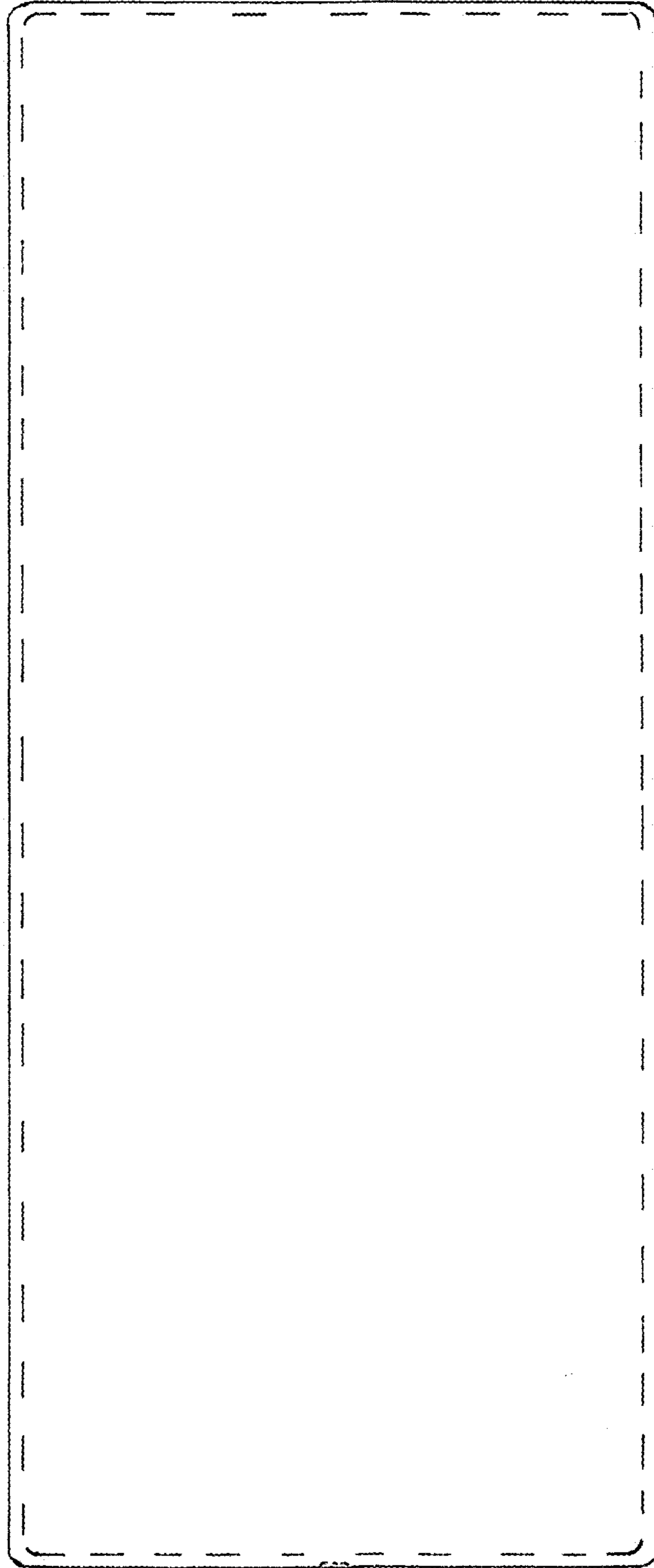

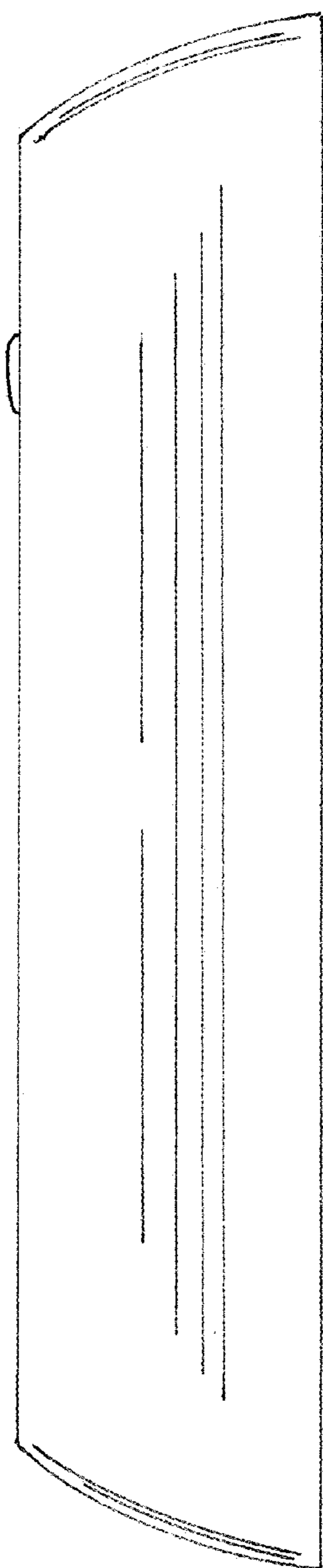

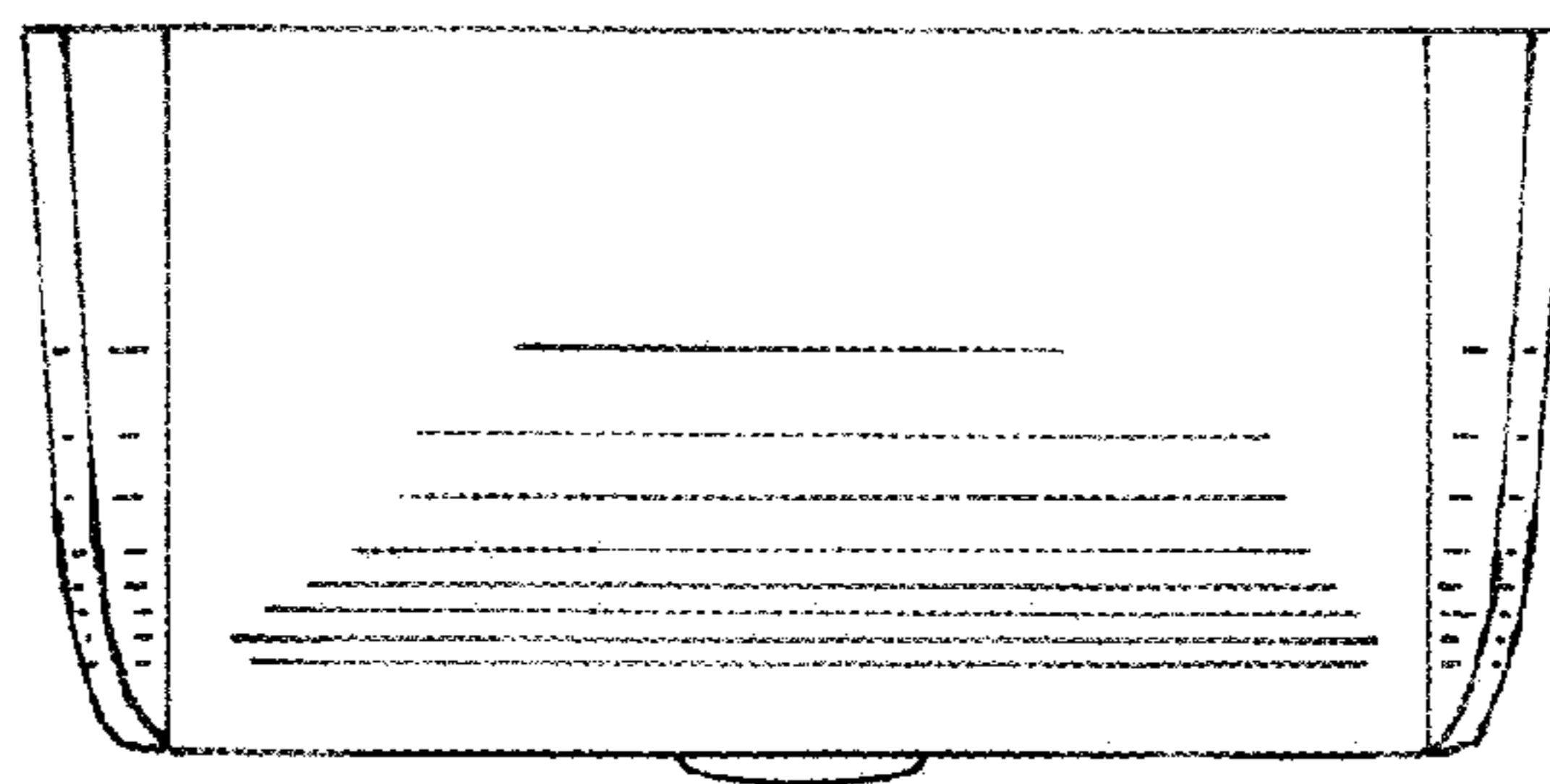

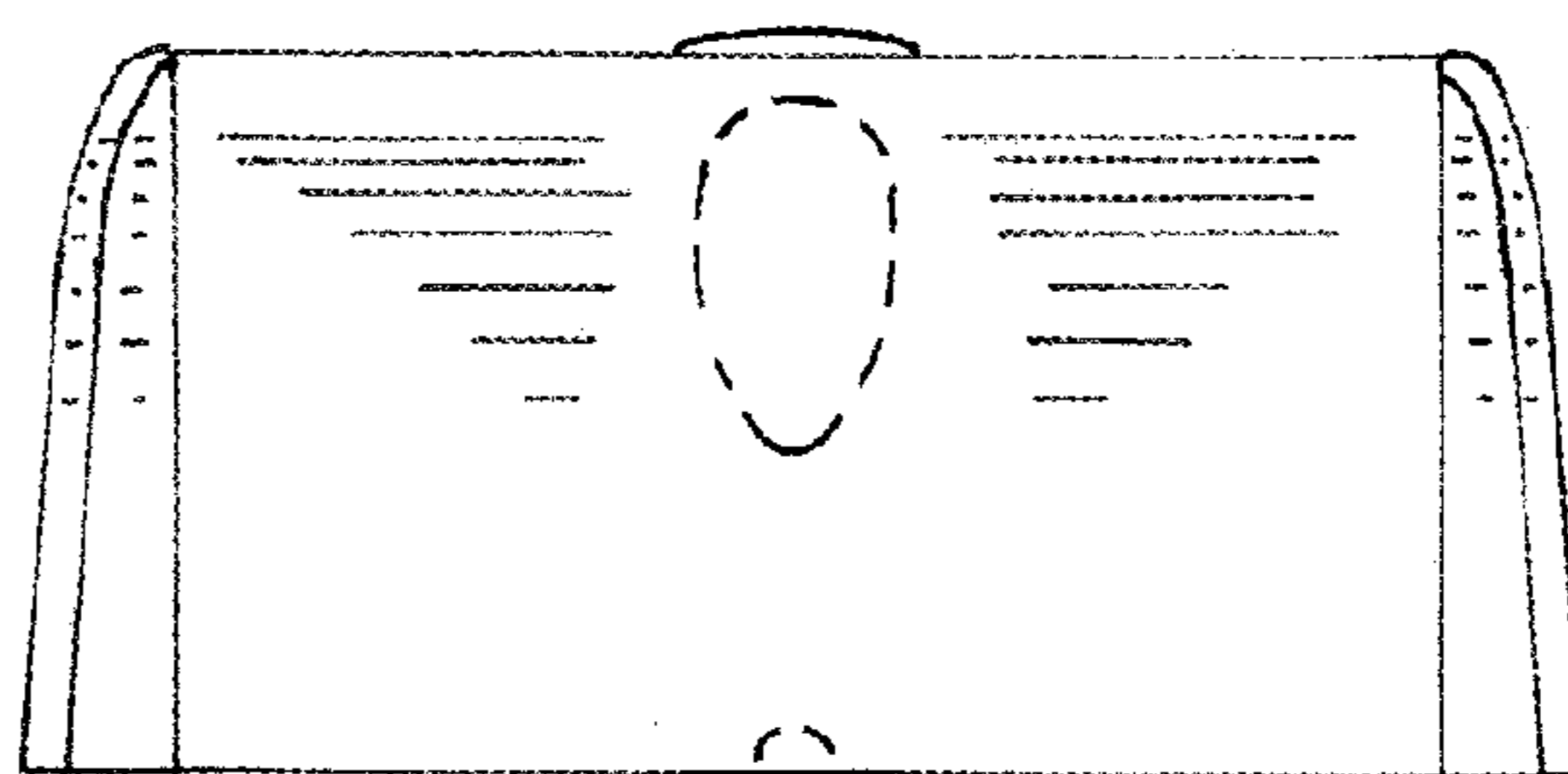

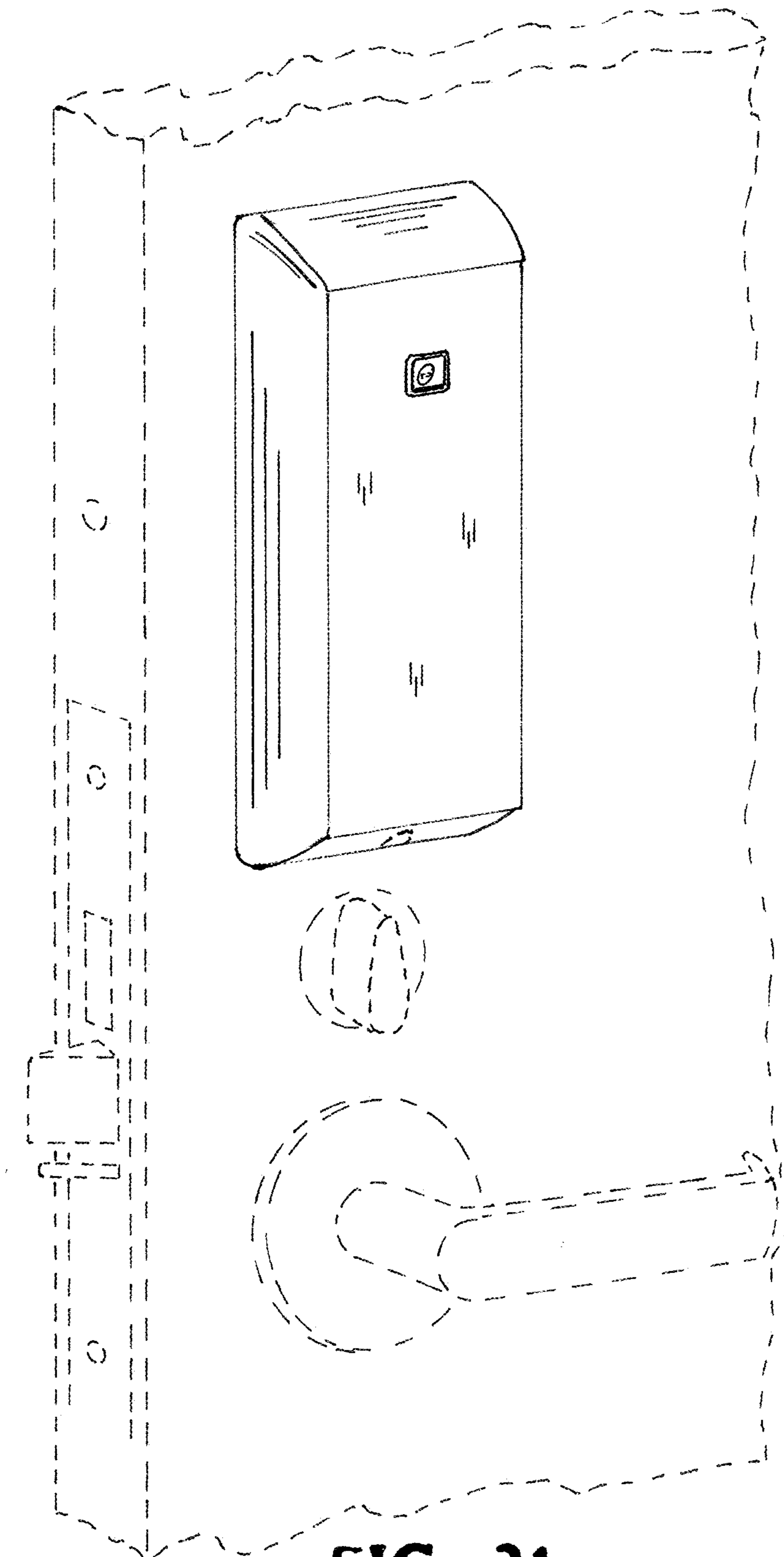

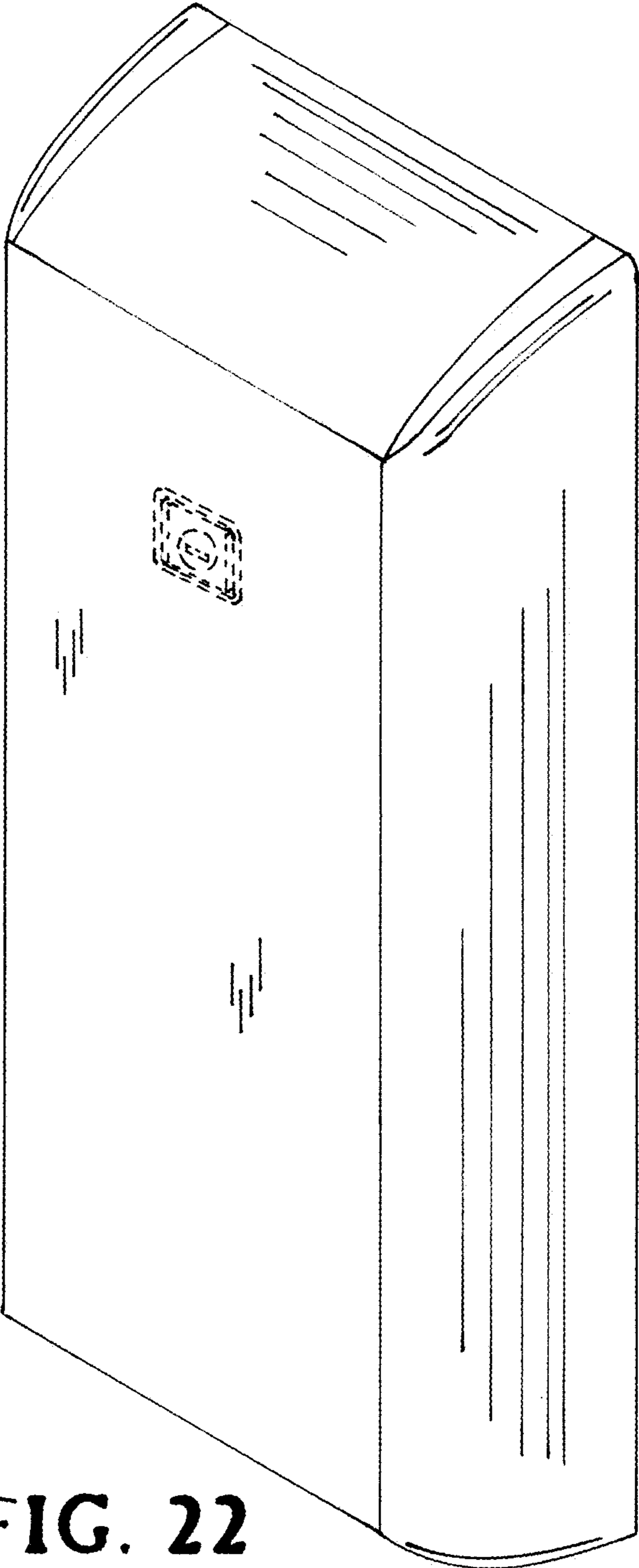

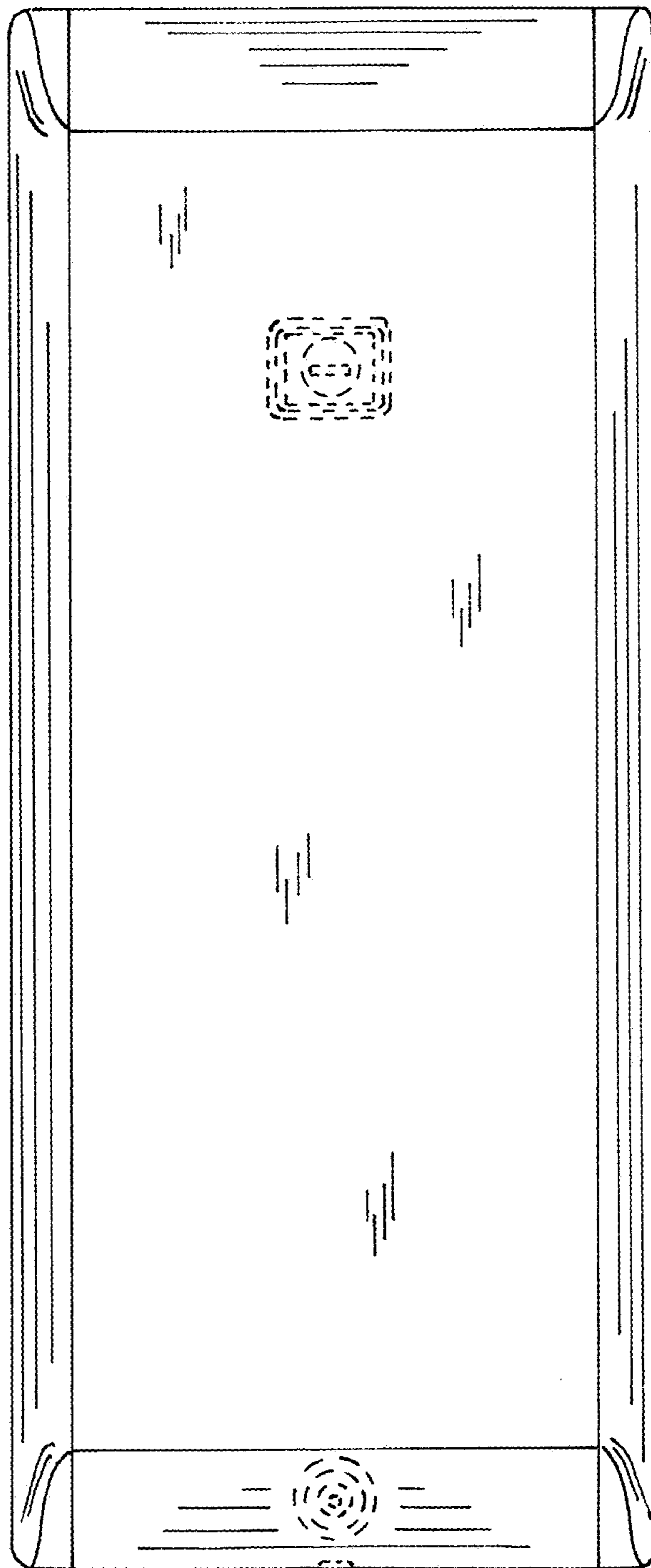

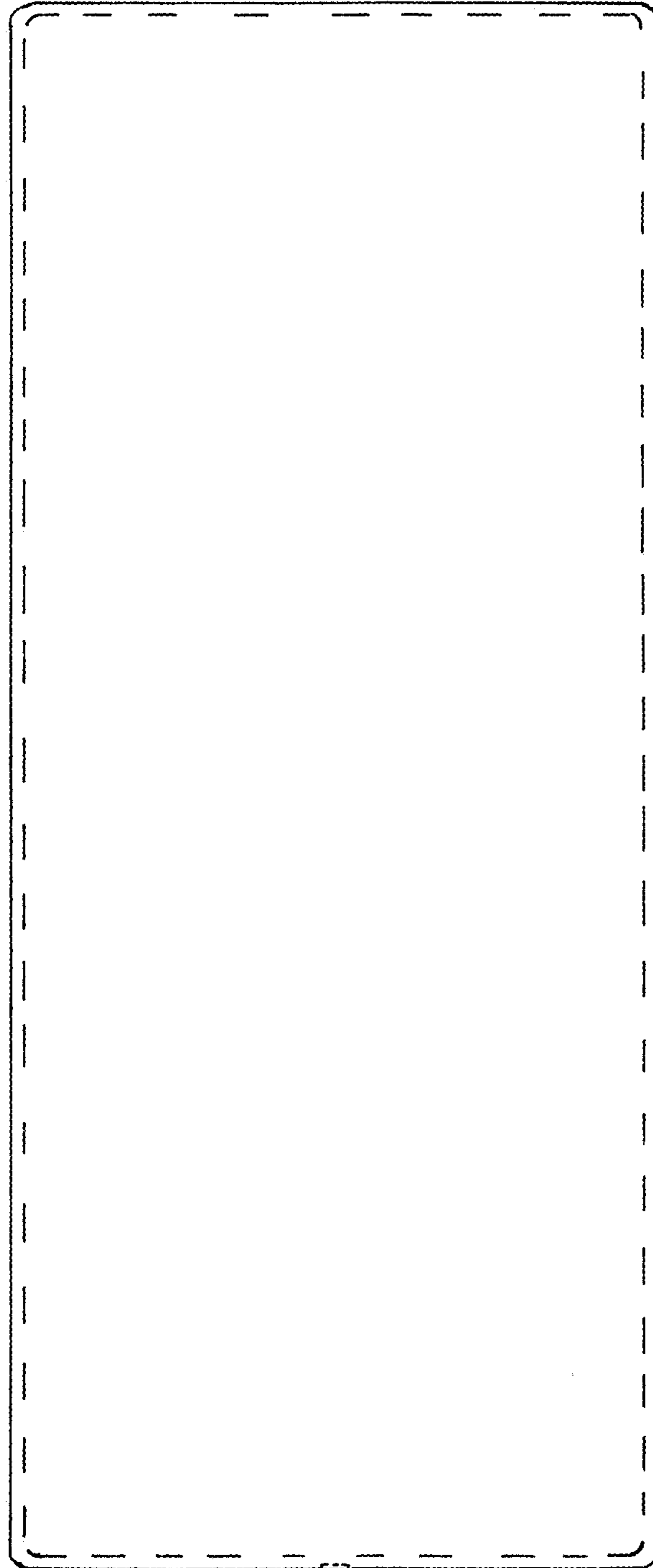

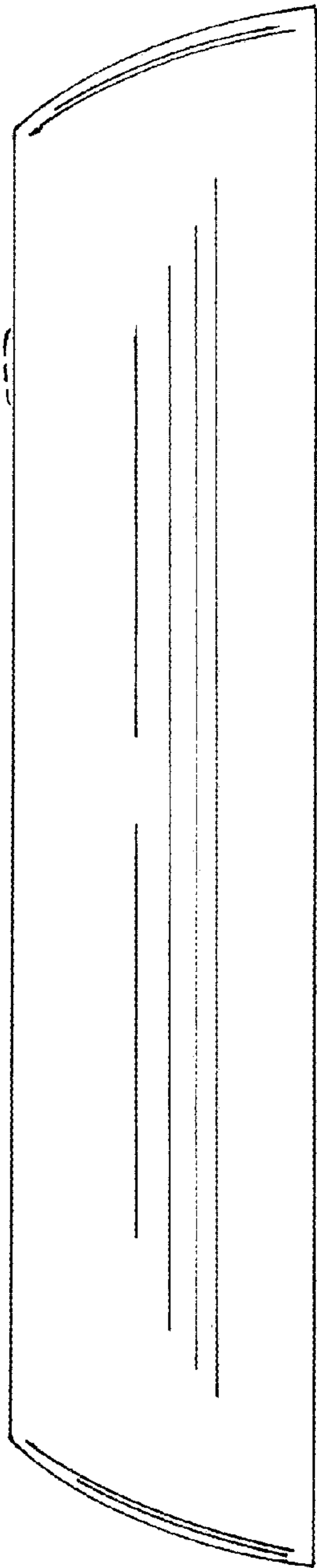

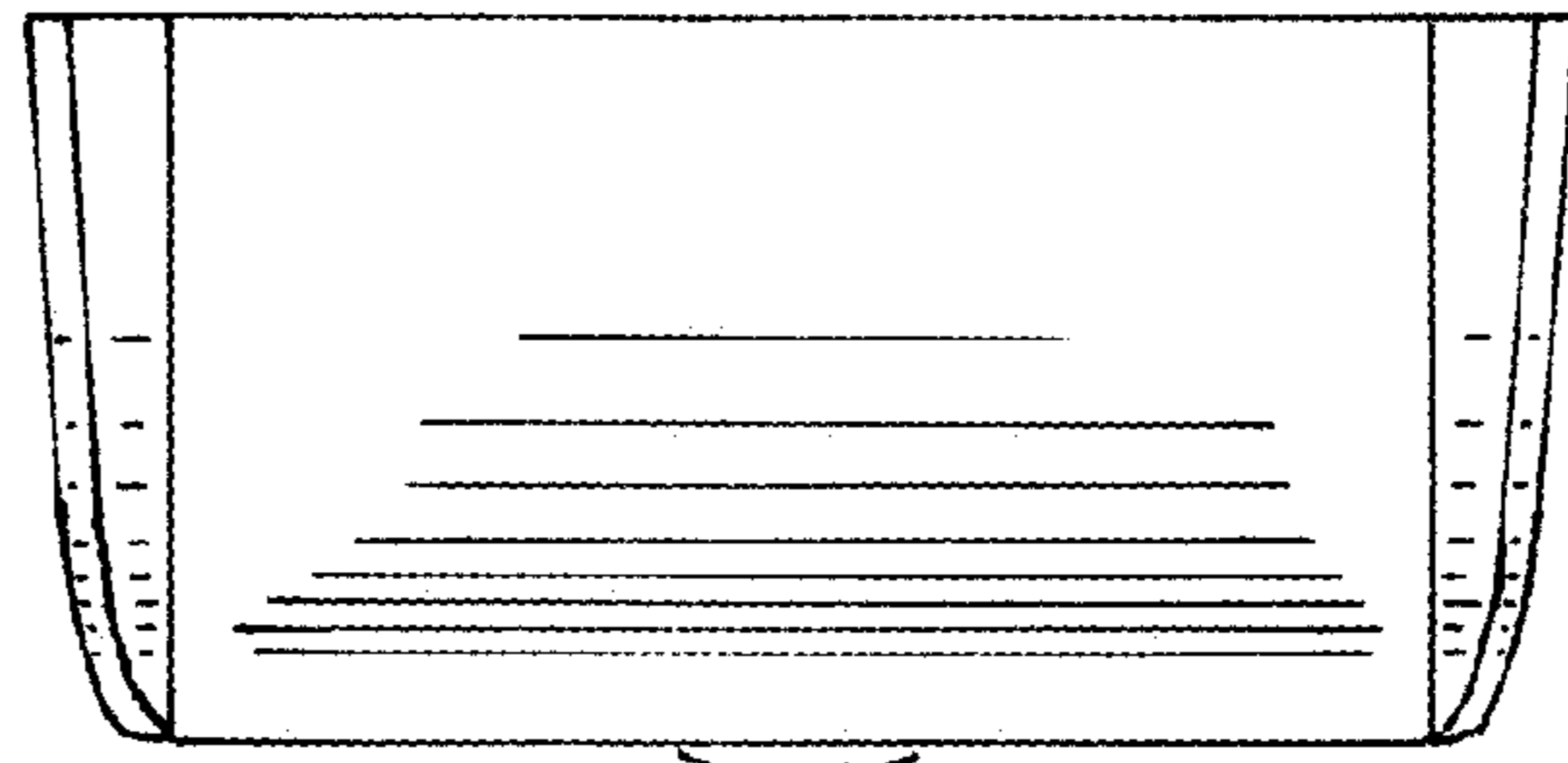

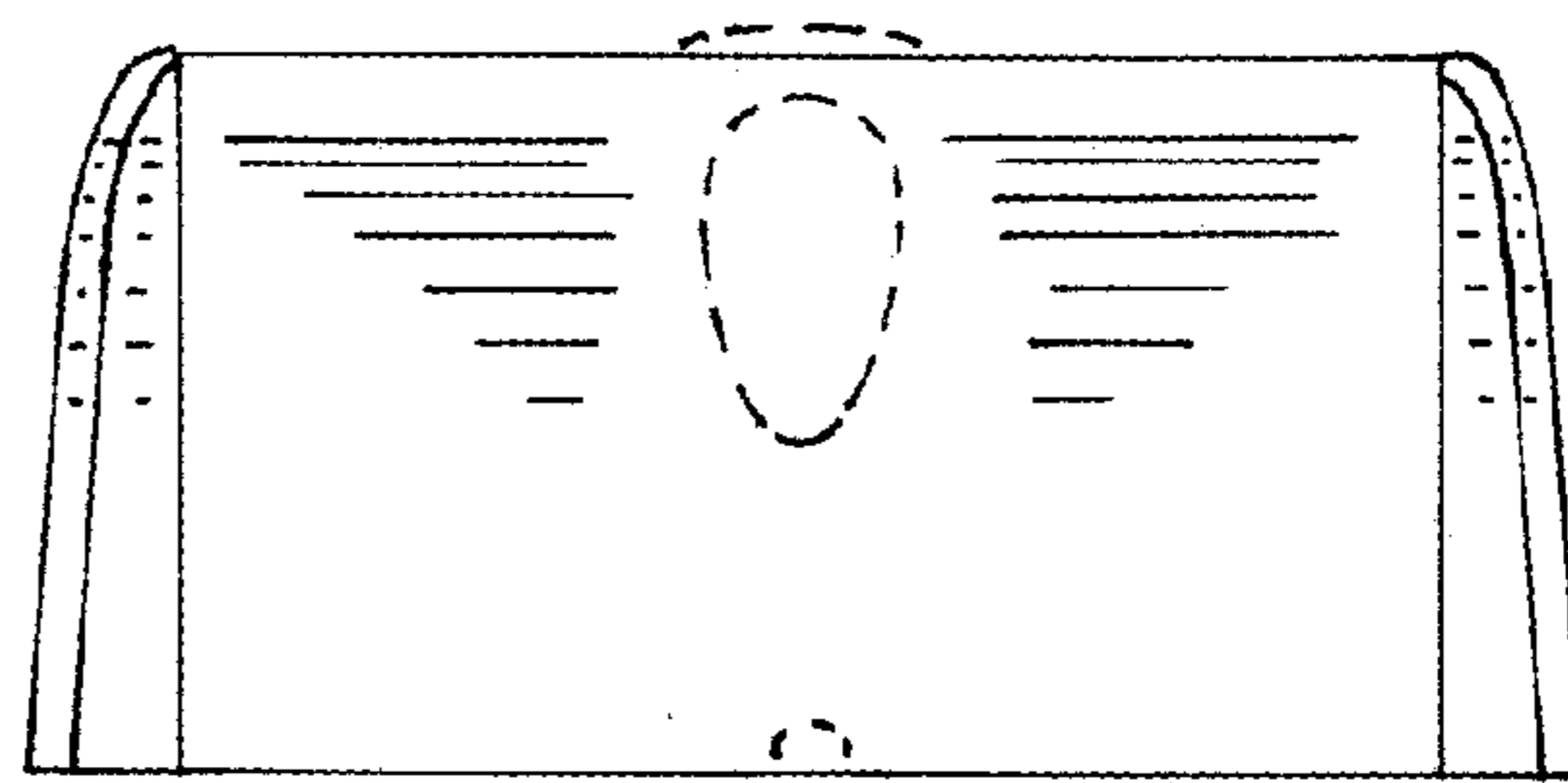

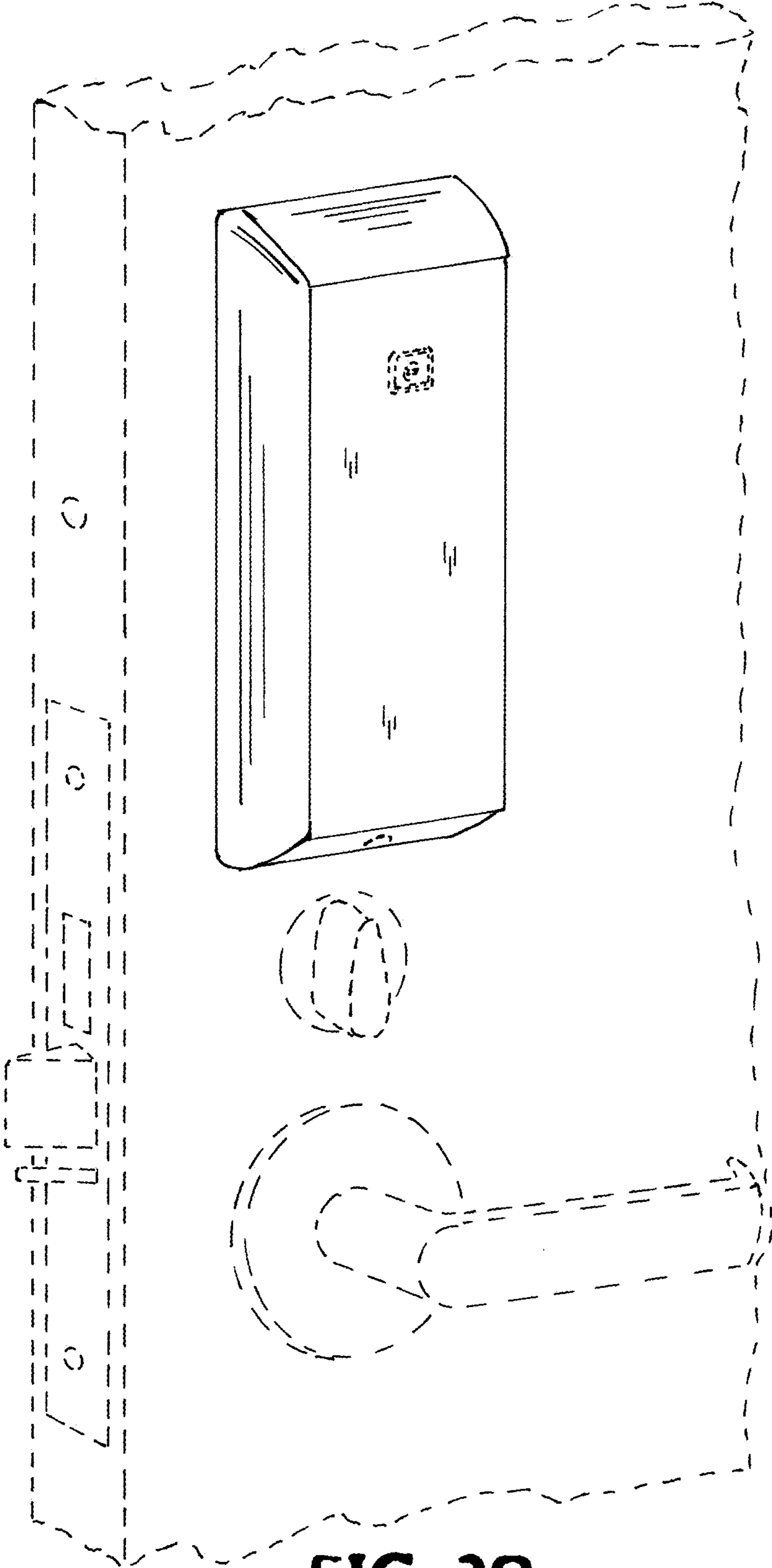
