FIG. 1 shows a top perspective view of a perfume bottle, the reverse angle view being identical.

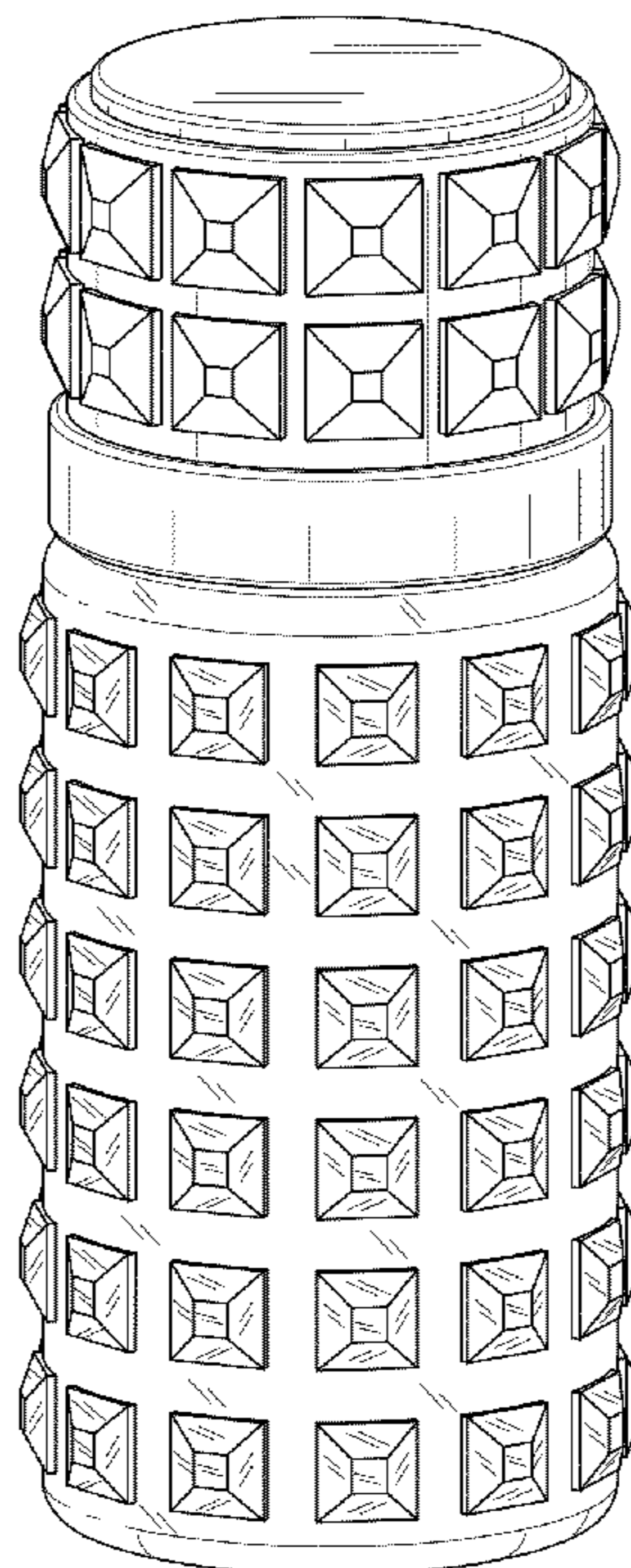
FIG. 2 shows bottom perspective view of the bottle, the reverse angle view being identical.

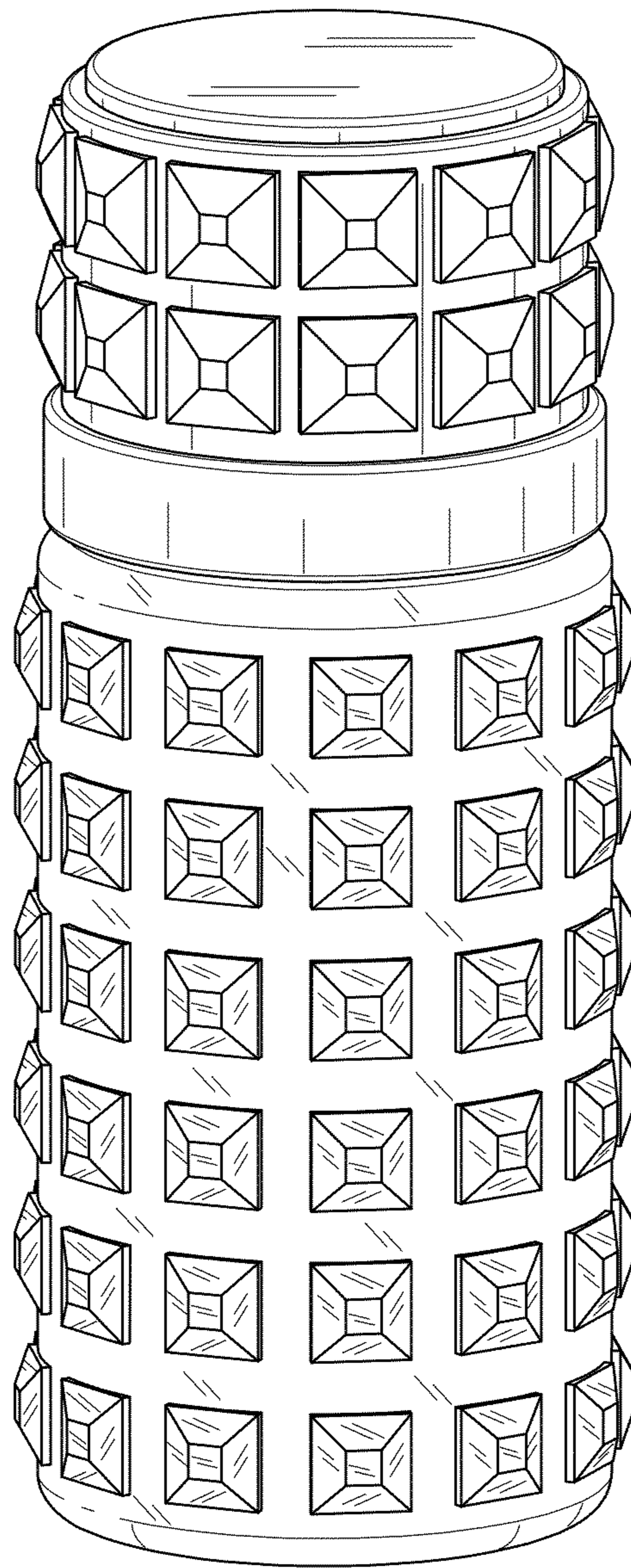

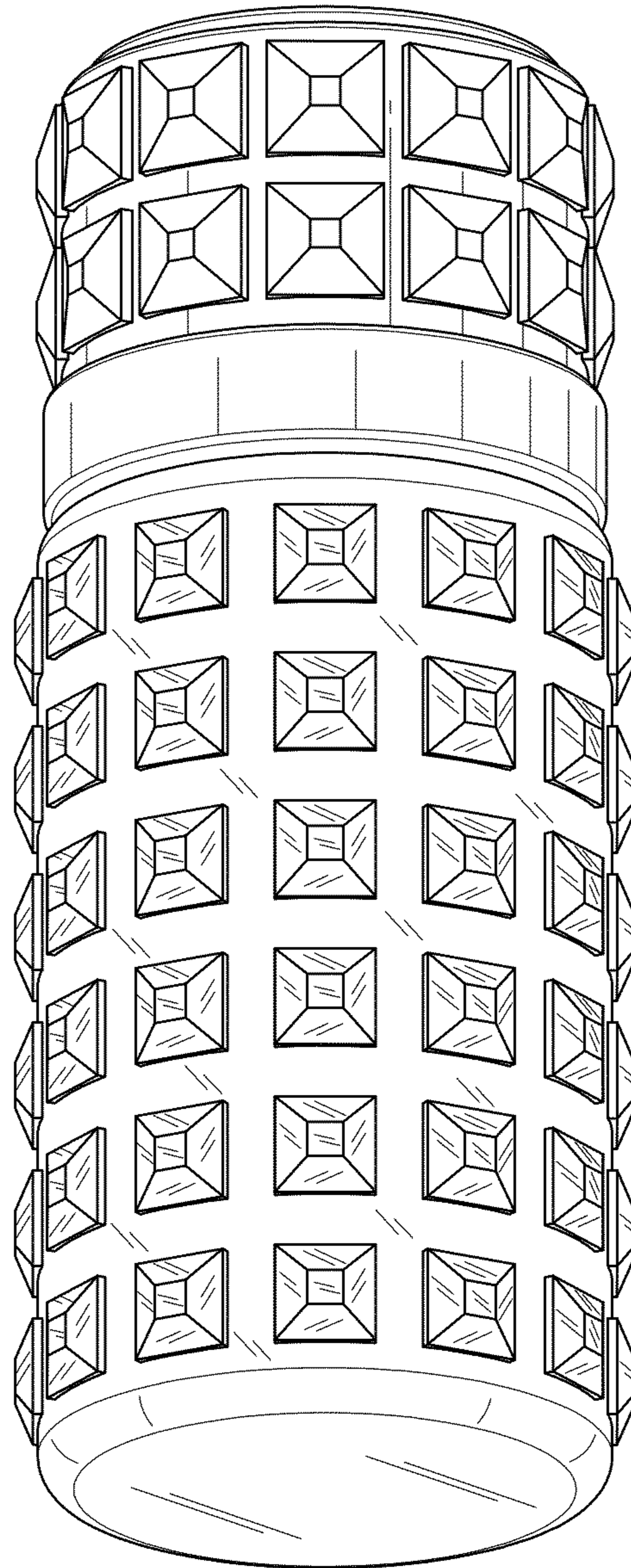

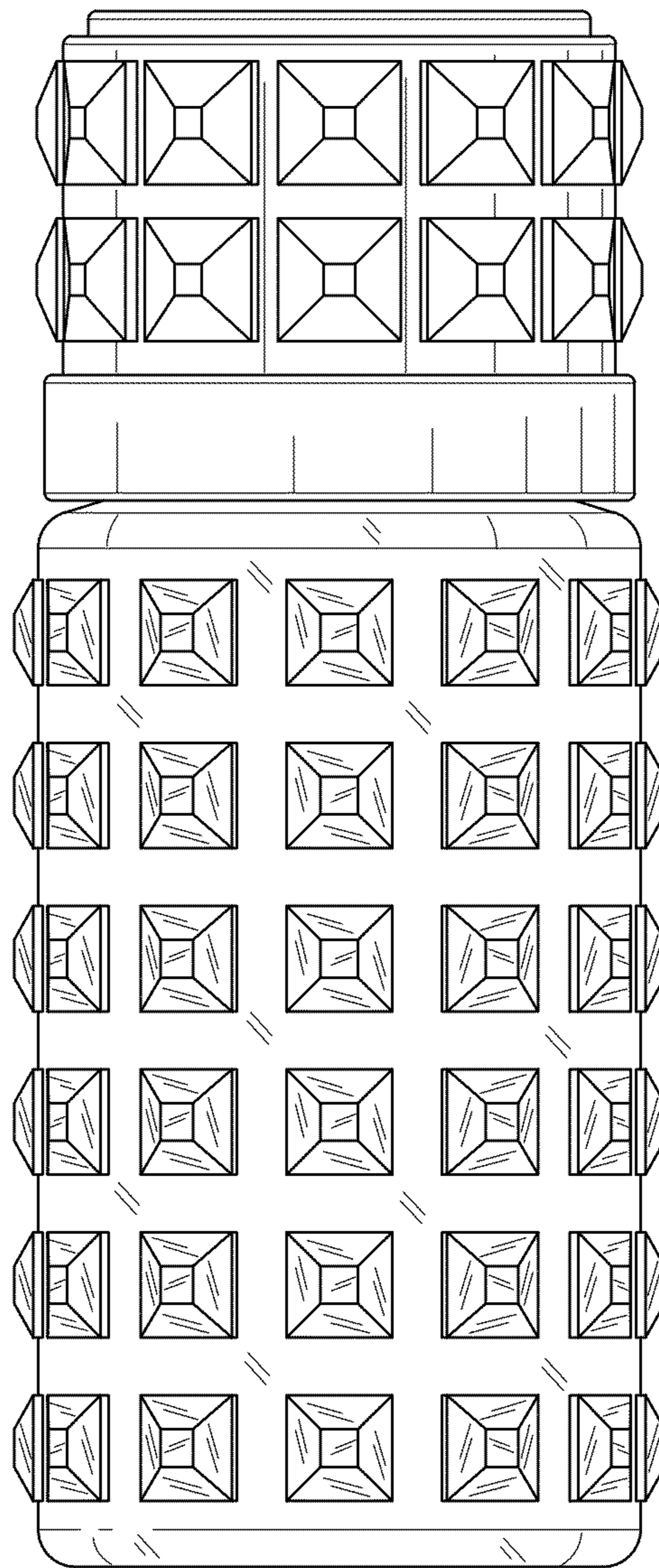

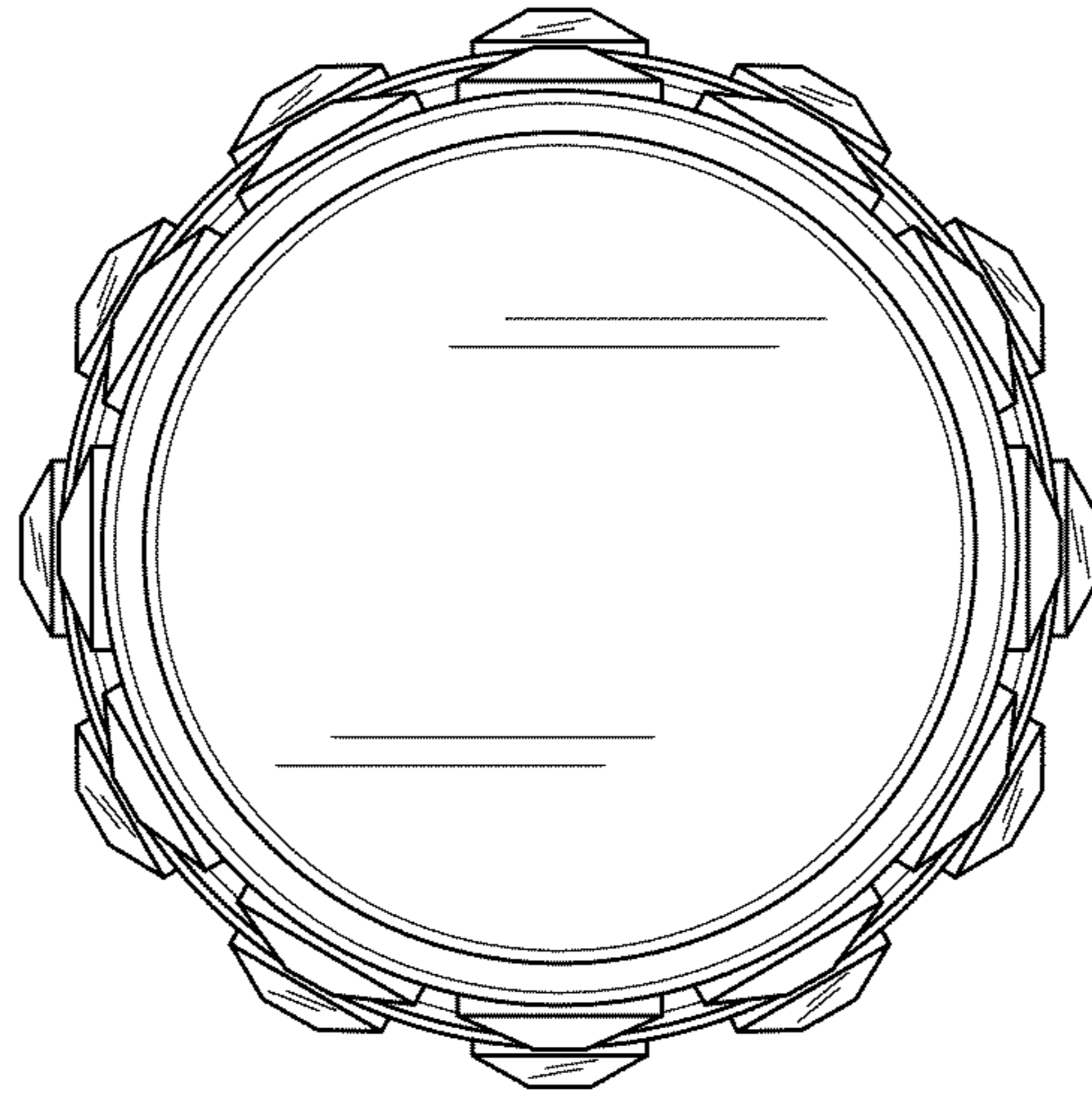

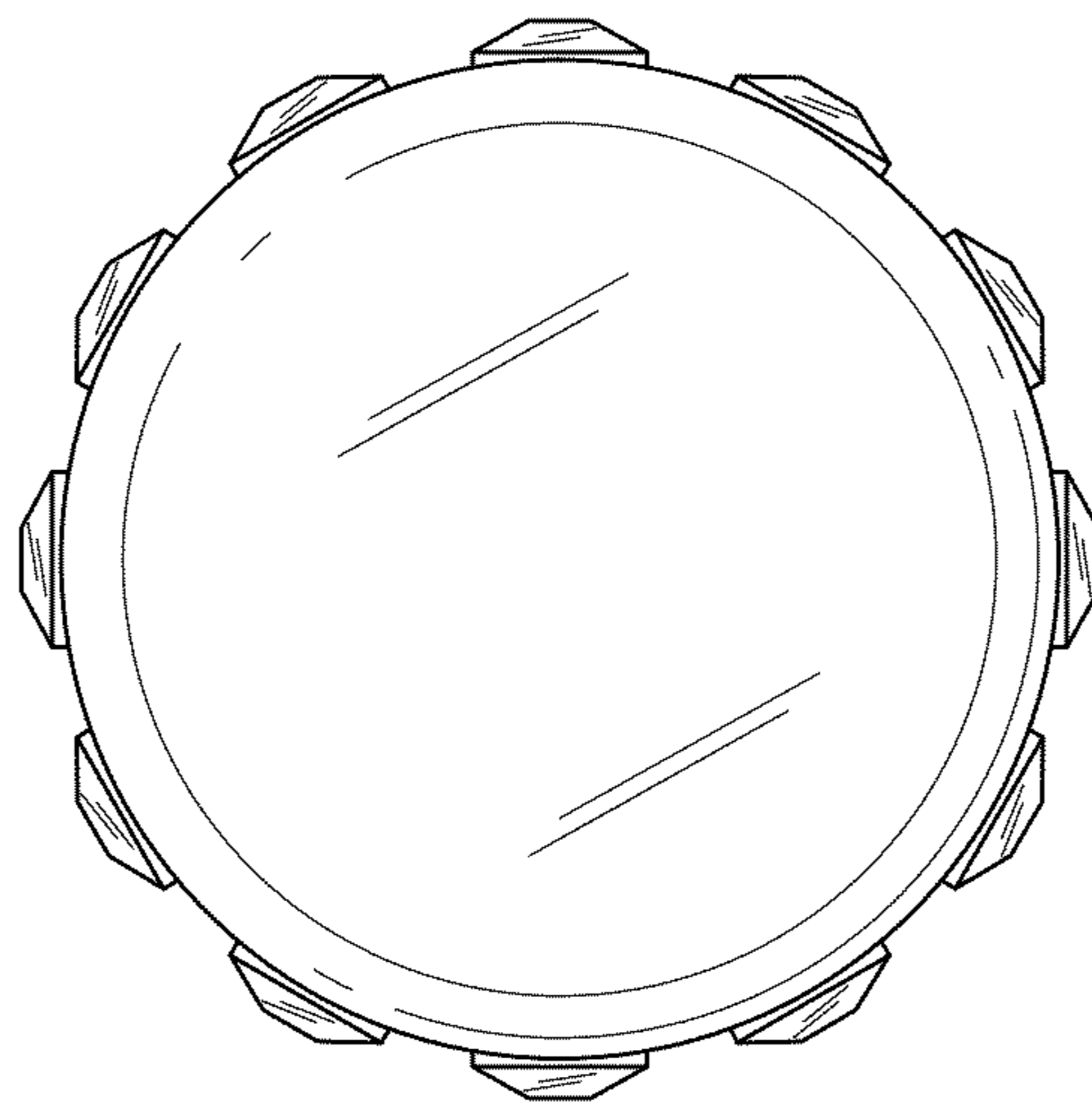
