(57) **CLAIM**

The ornamental design for a thermostatic head, substantially as shown.

DESCRIPTION

FIG. 1 is a front, top, left-hand side perspective view of a thermostatic head comprising a new, original and ornamental design;

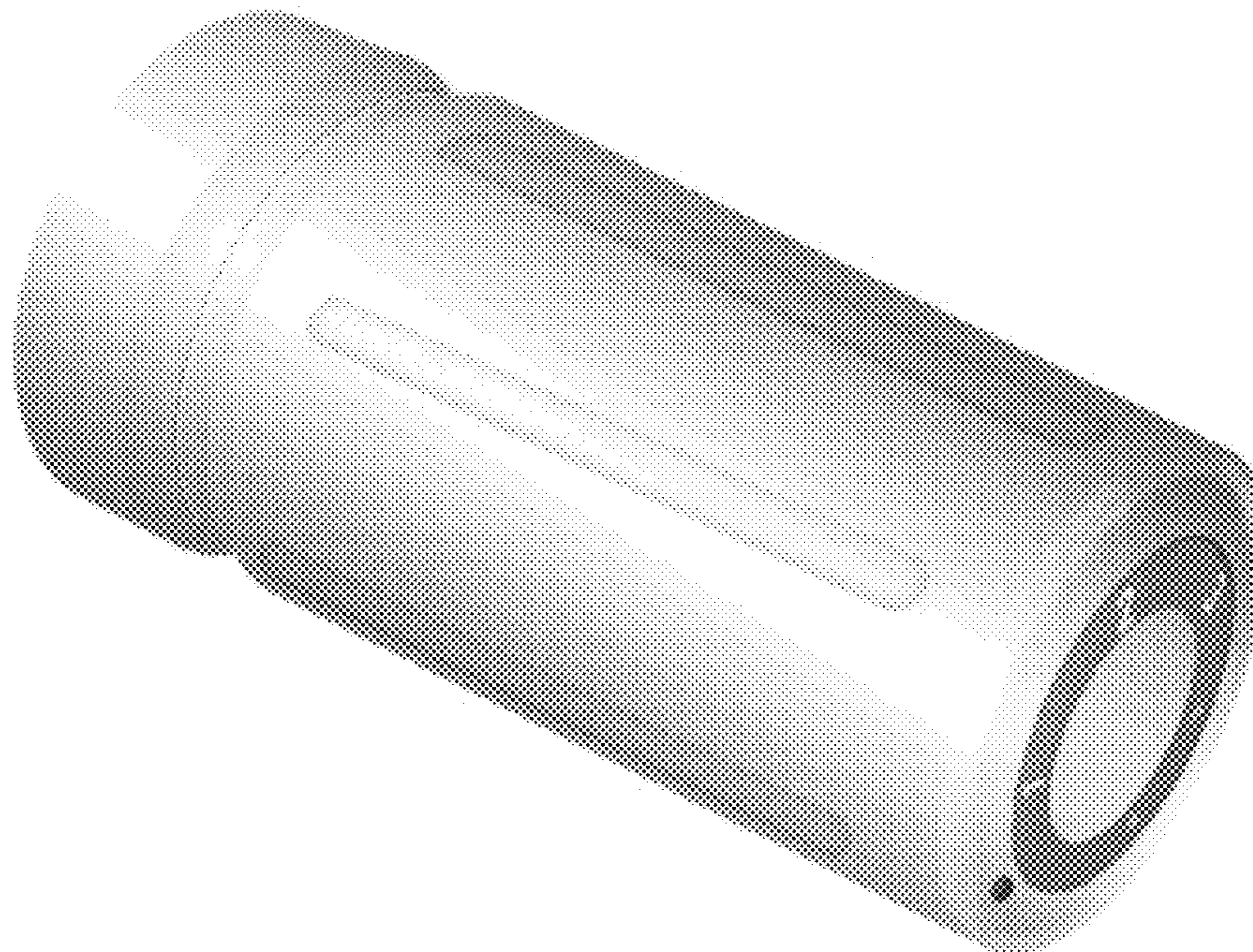

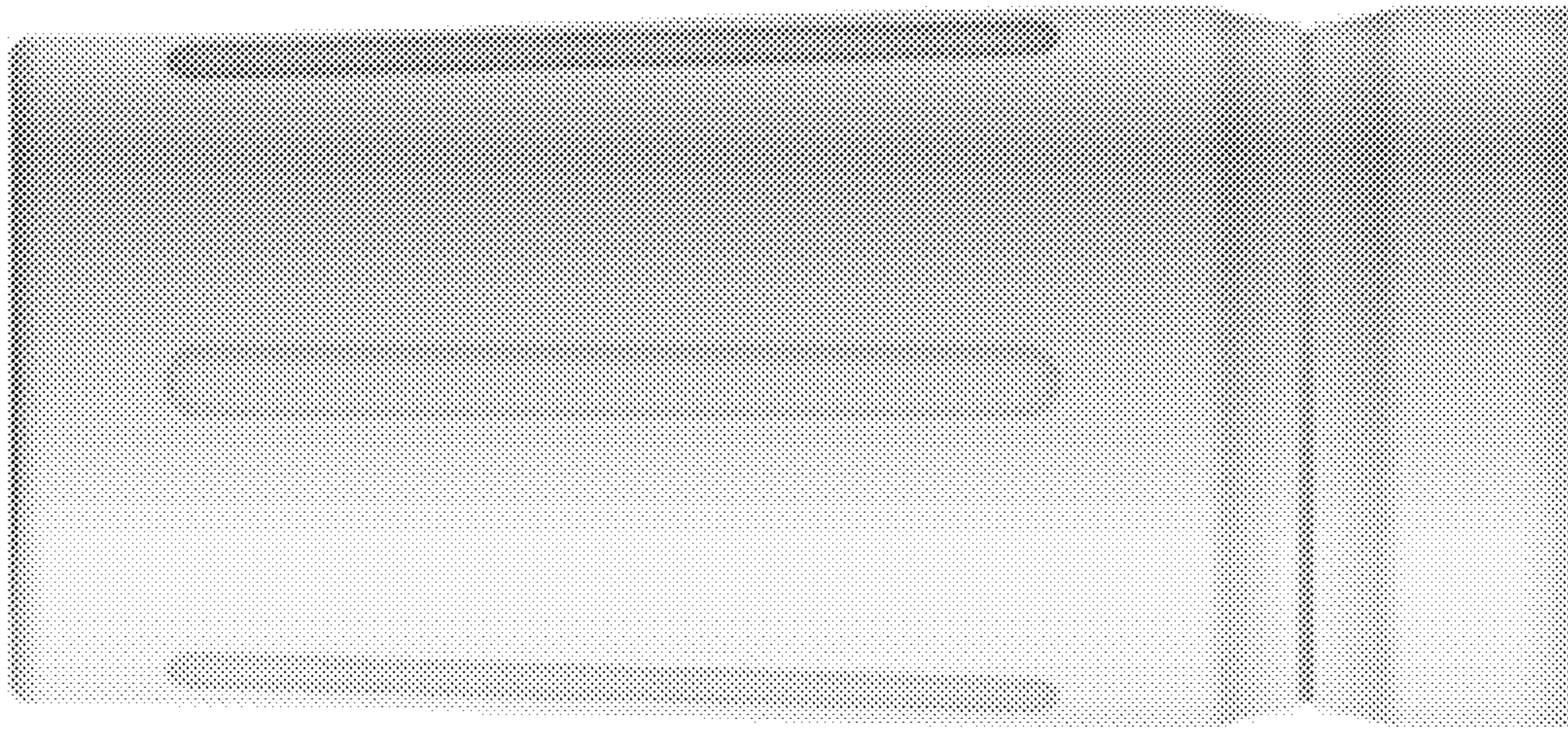

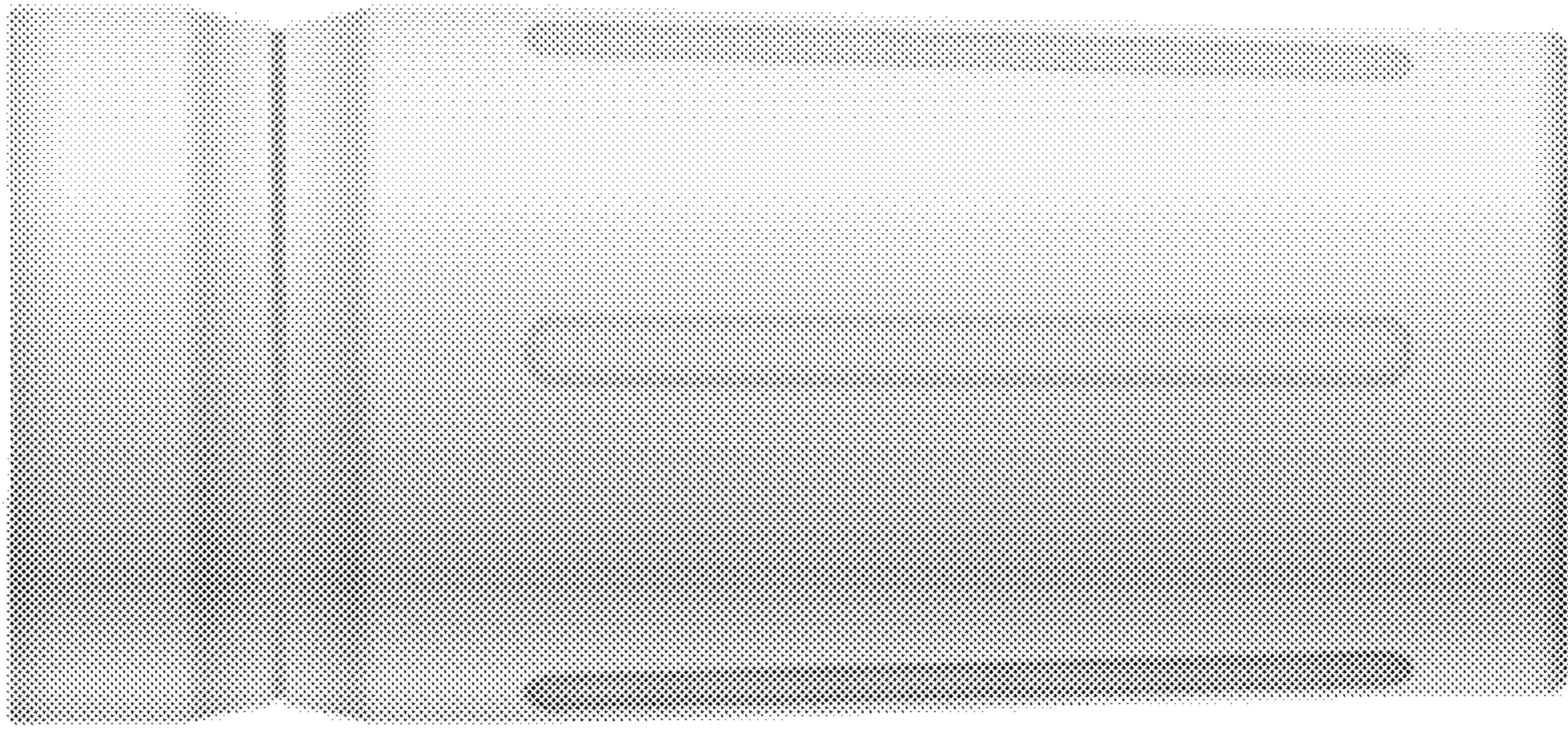

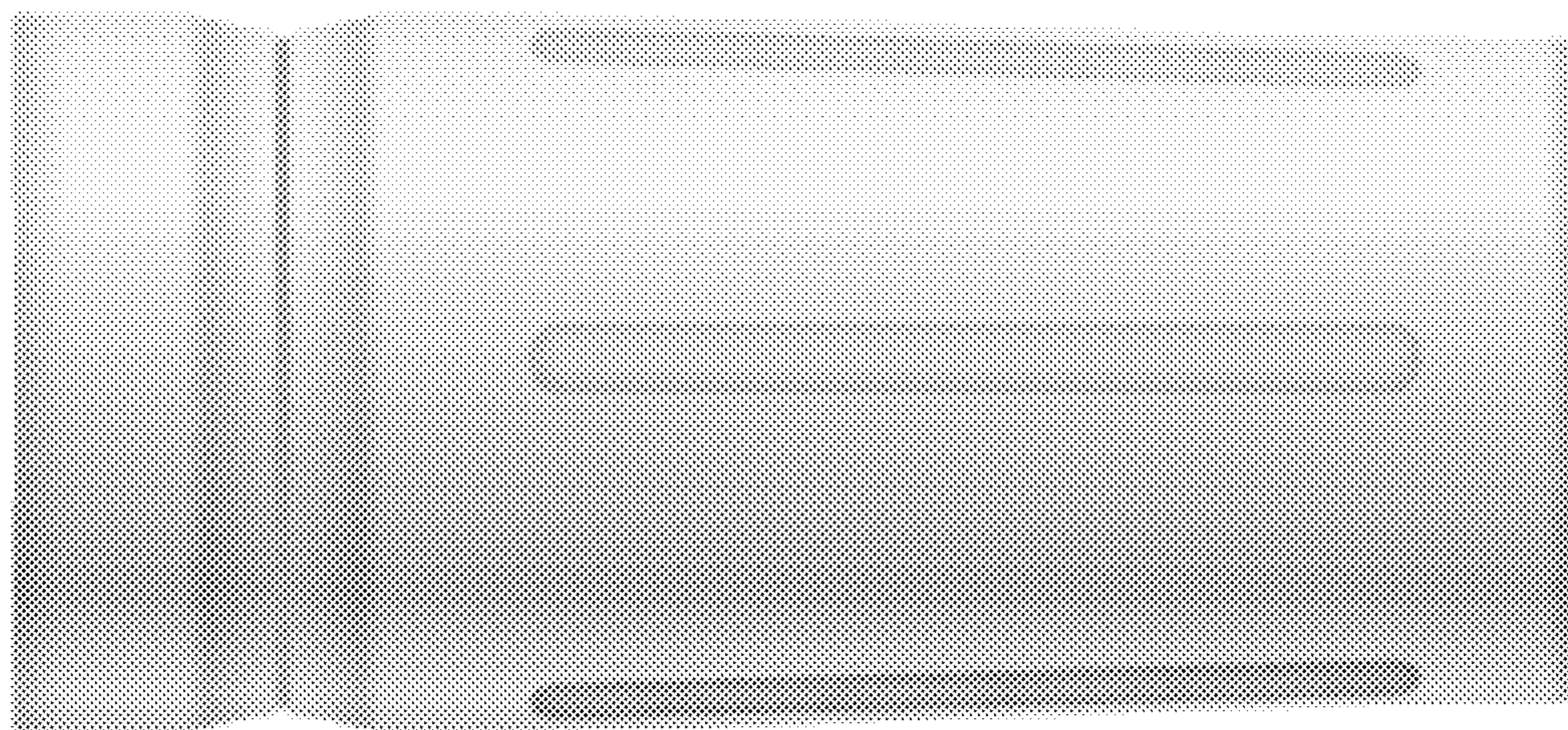

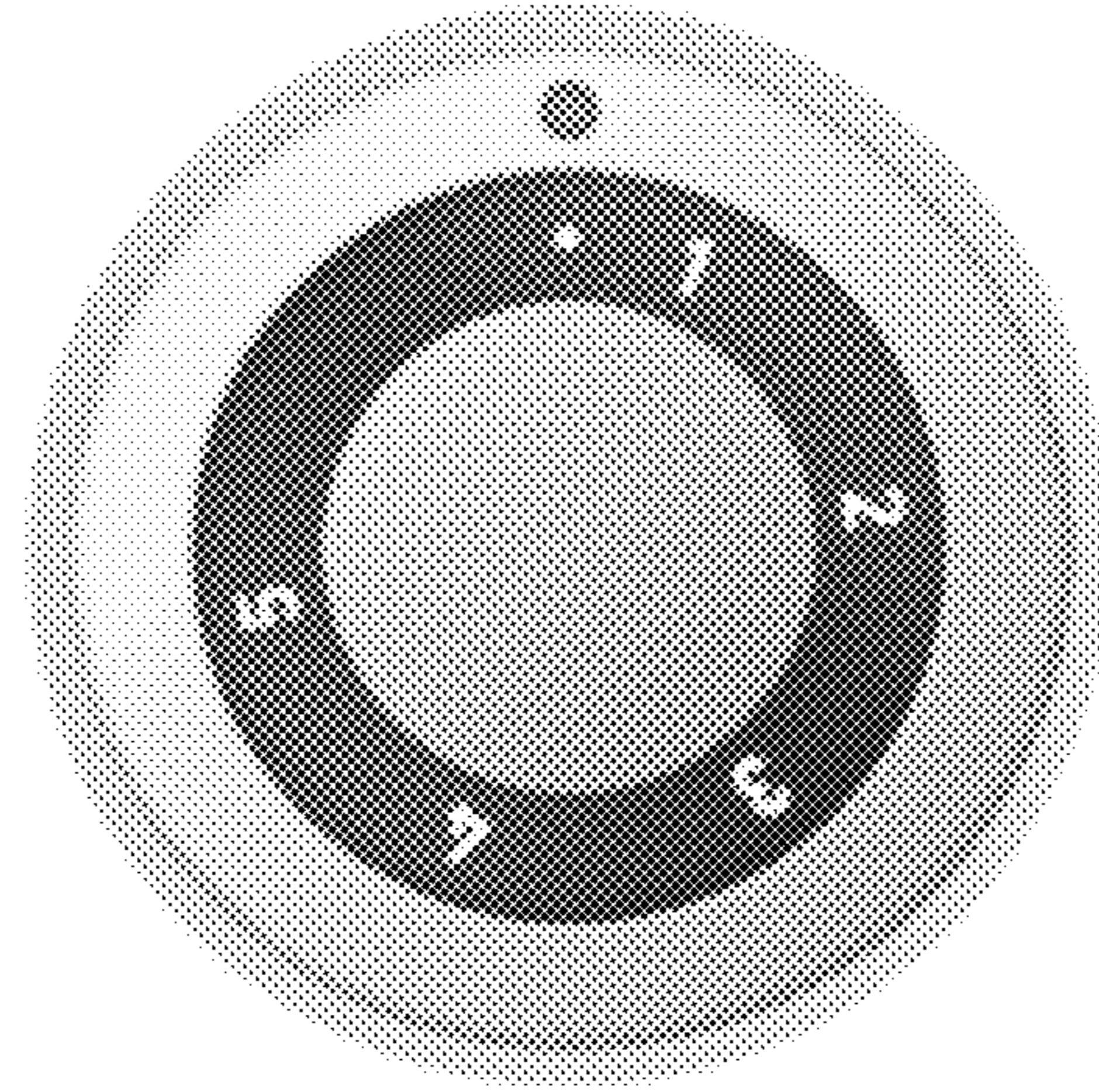

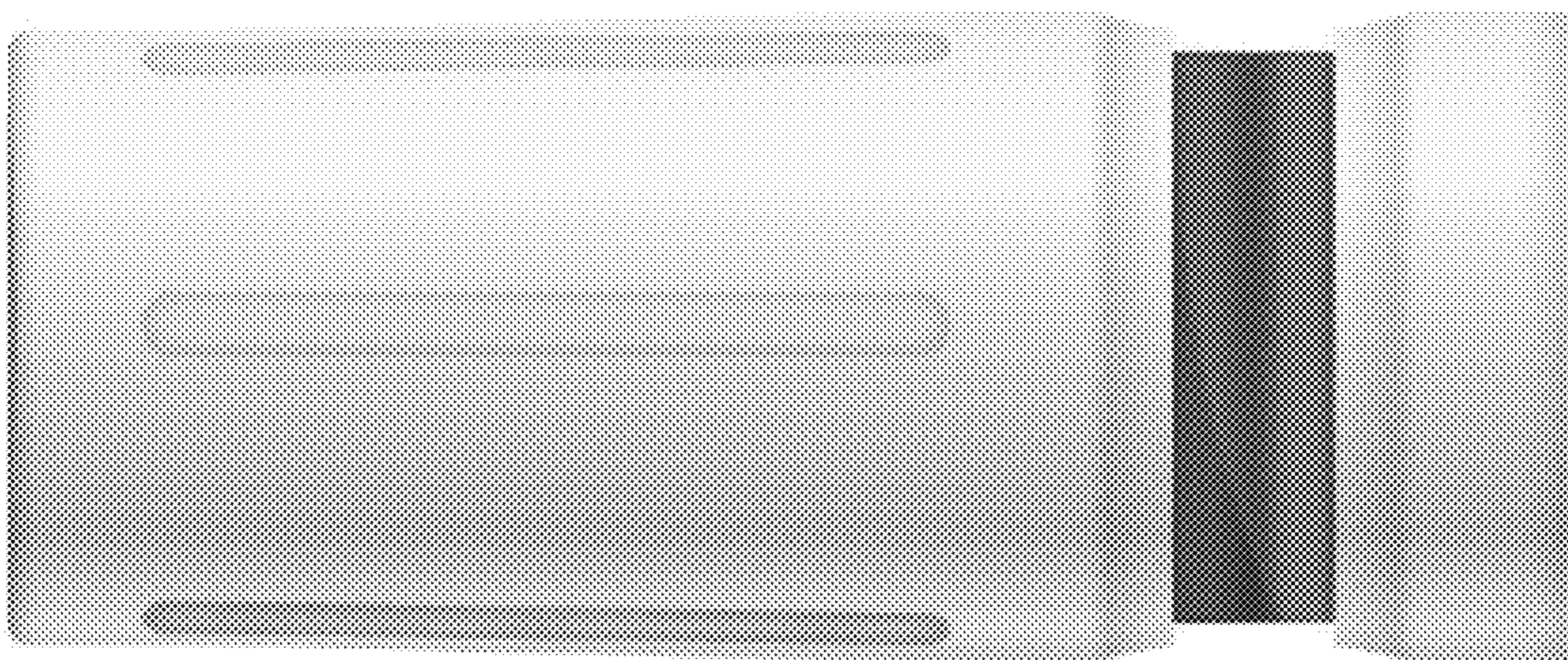

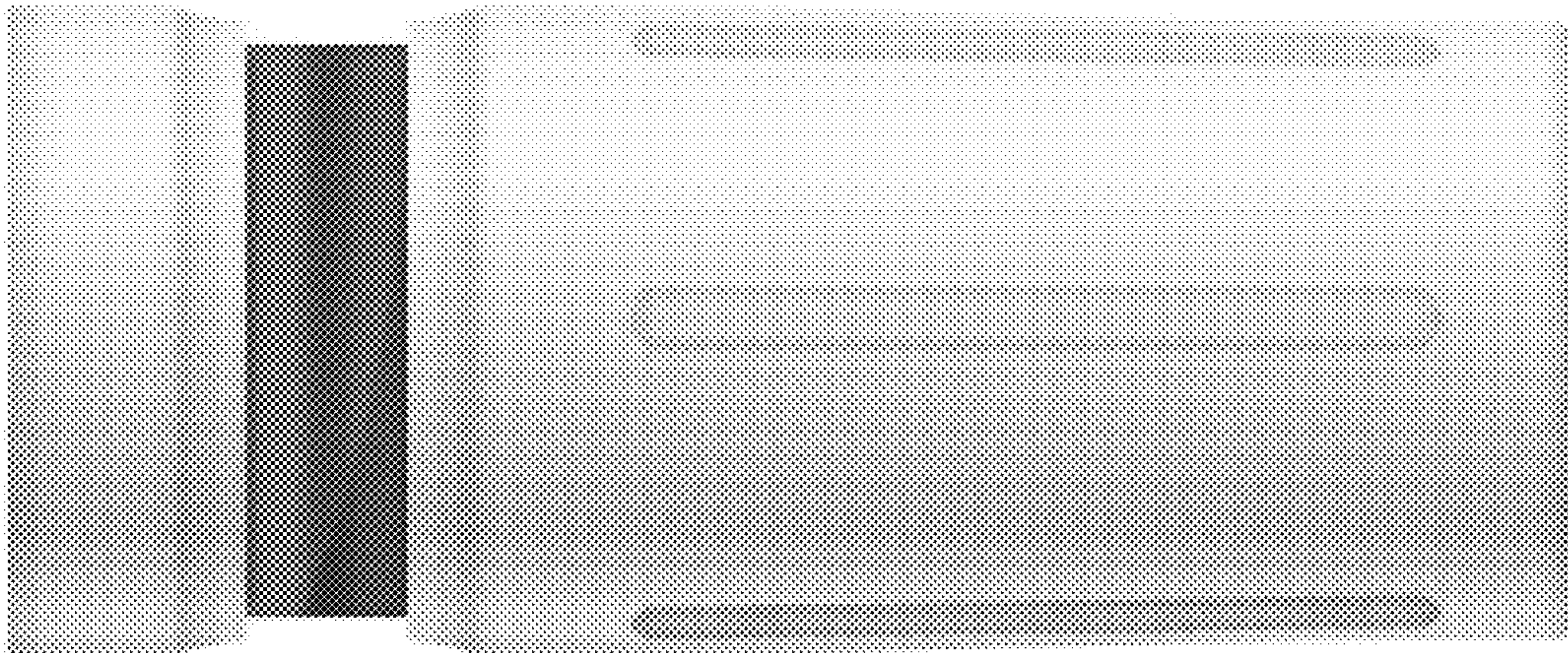

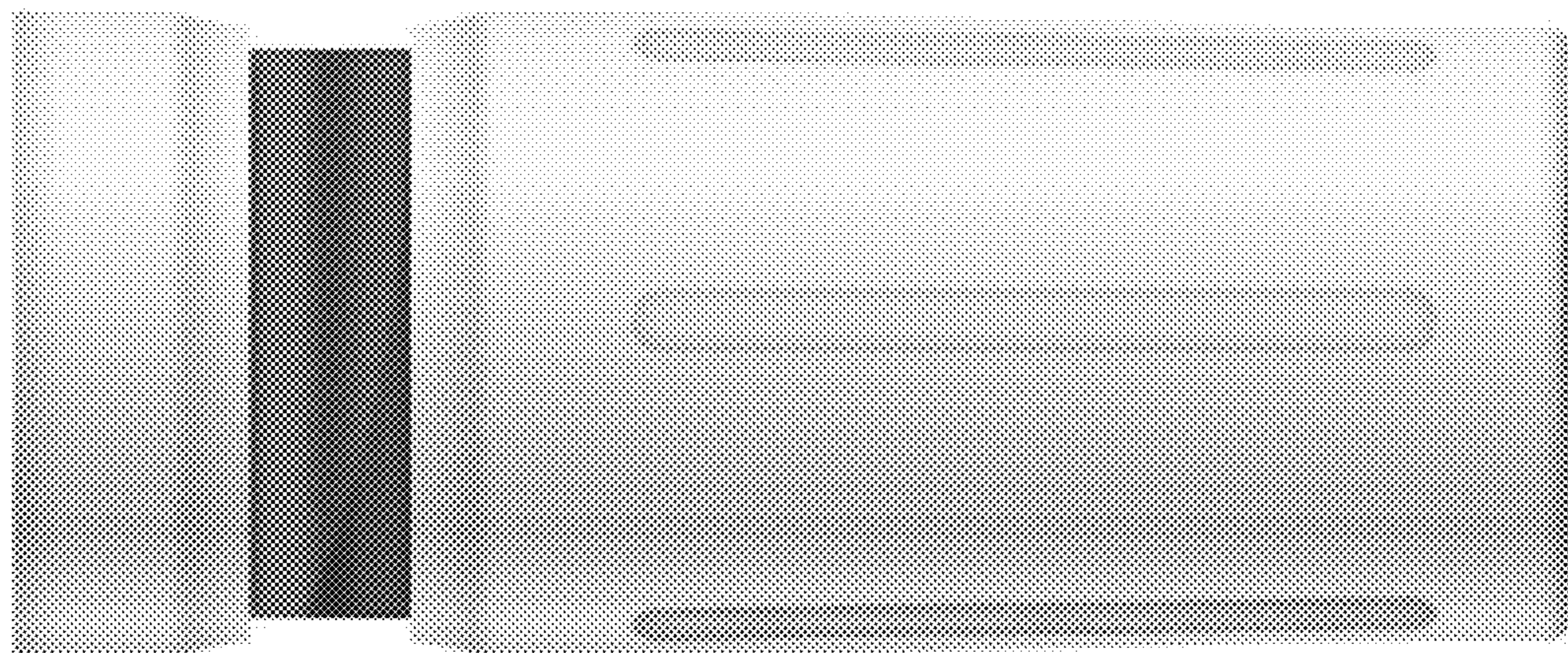
