(57) **CLAIM**

The ornamental design for a tyre, as shown and described.

DESCRIPTION

FIG. 1 is a front, left side perspective view of a tyre showing our new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a right side view thereof, showing a different pattern from that appearing in FIG. 1;

FIG. 4 is a left side view thereof, showing the same pattern as that appearing in FIG. 1; and,

FIG. 5 is a partial front elevational view taken from FIG. 2 and shown in an enlarged scale.

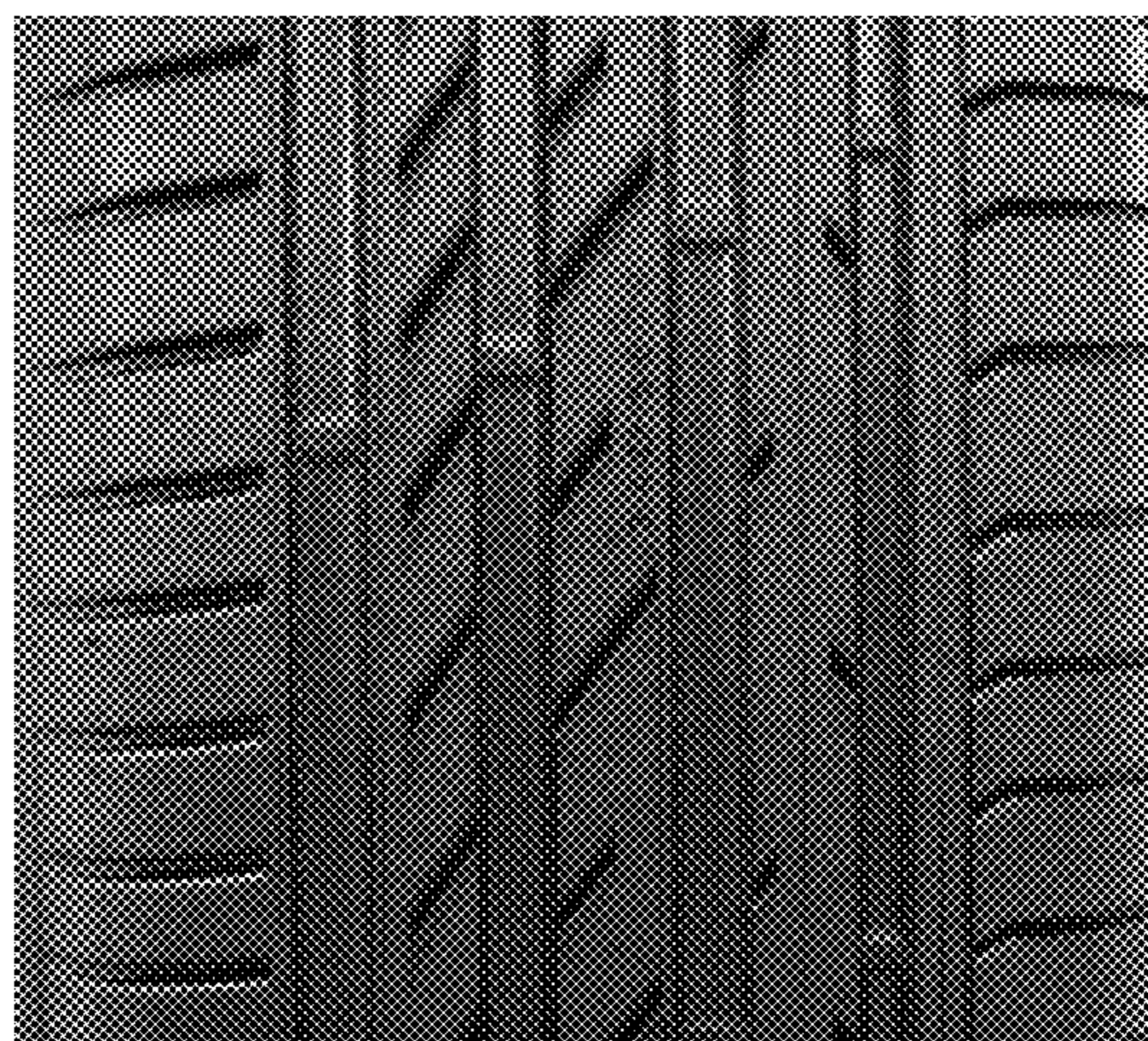
