(57) **CLAIM**

The ornamental design for a surface design for a pneumatic tire, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pneumatic tire with the ornamental surface design;

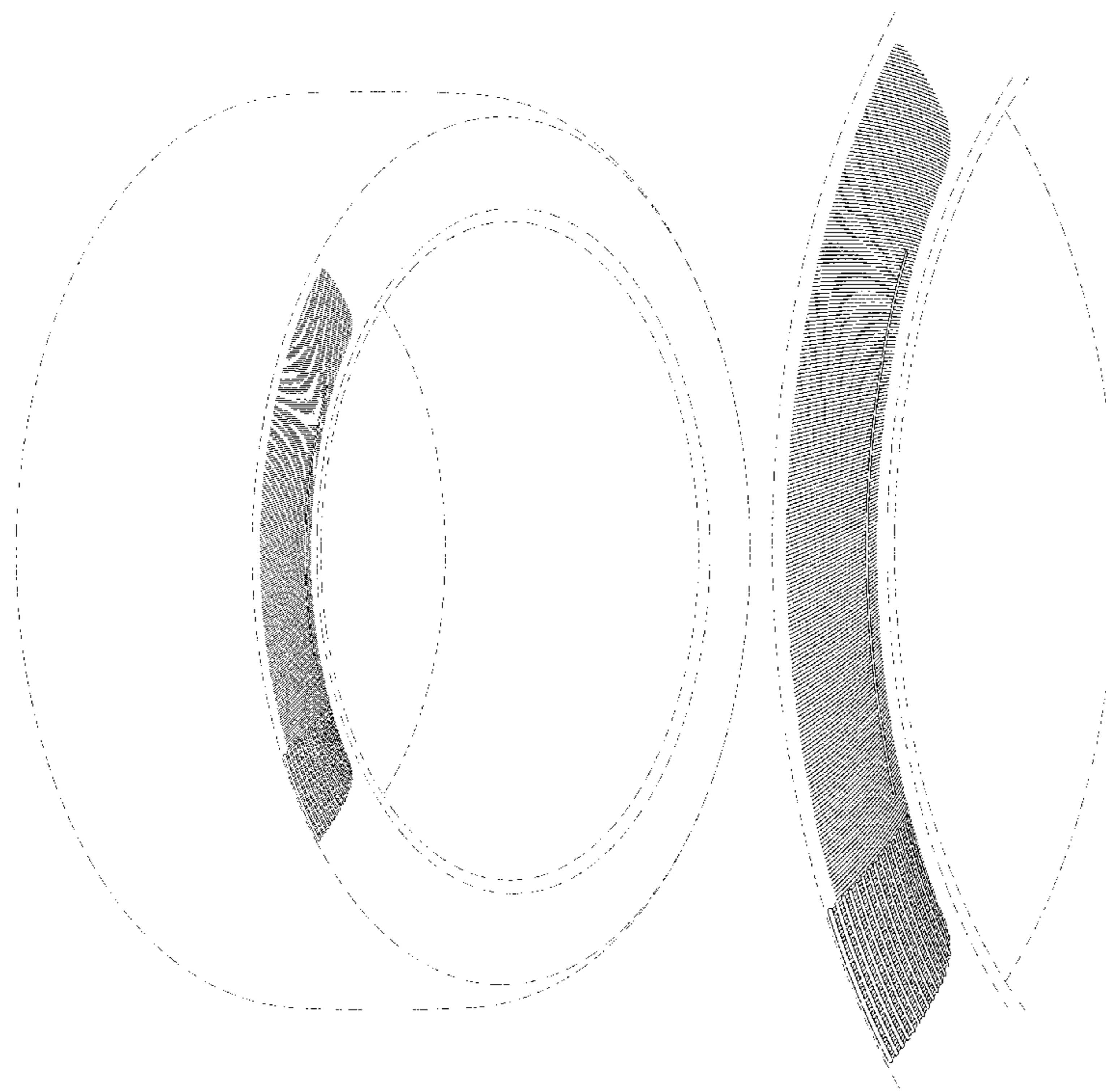
FIG. 2 is a side elevational view of a pneumatic tire with the ornamental surface design, the opposite view being the mirror-image thereof;

FIG. 3 is a front elevational view of a pneumatic tire with the ornamental surface design, the opposite view being the mirror-image thereof; and,

FIG. 4 is a detailed view of the ornamental surface design as shown in FIG. 1.

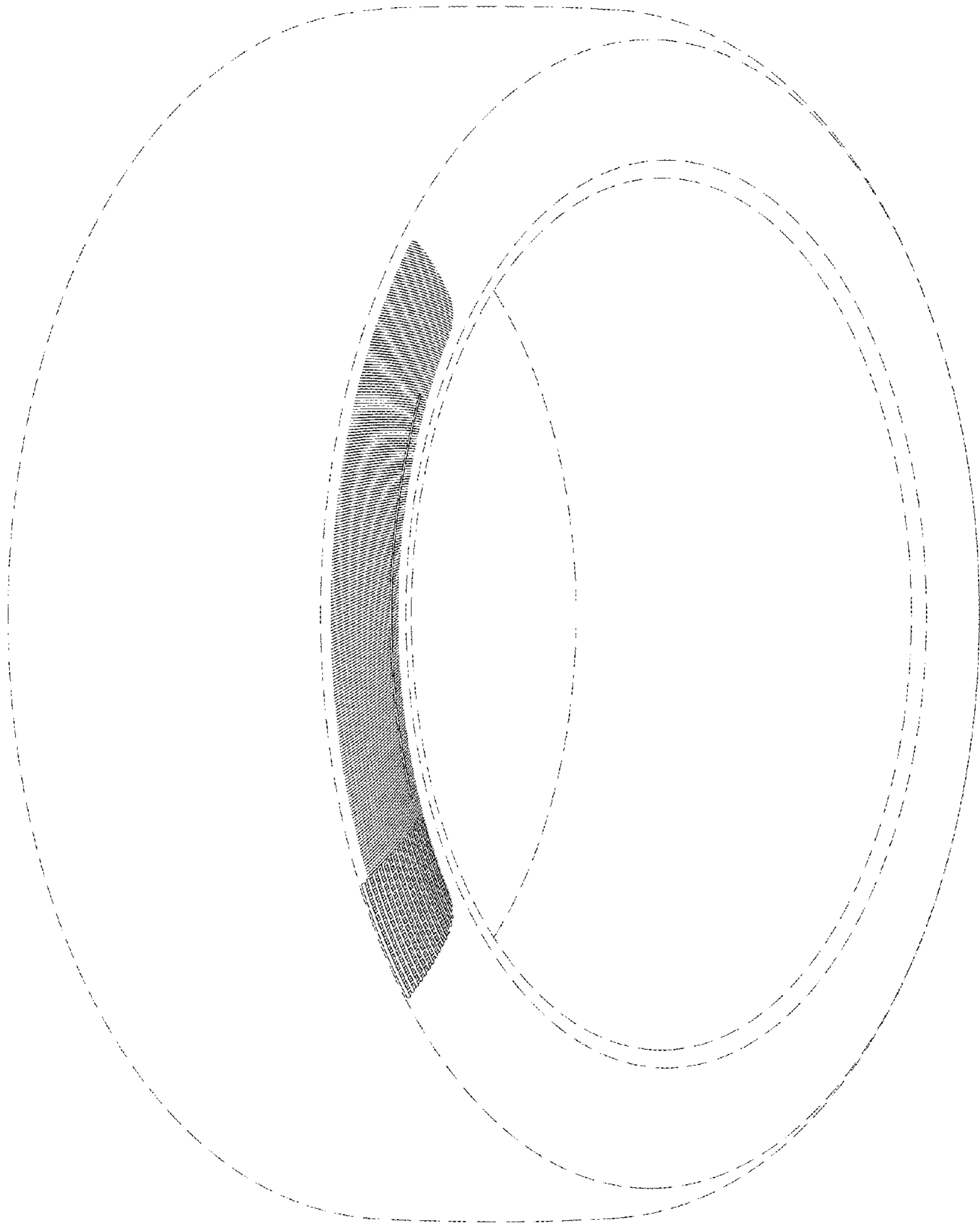

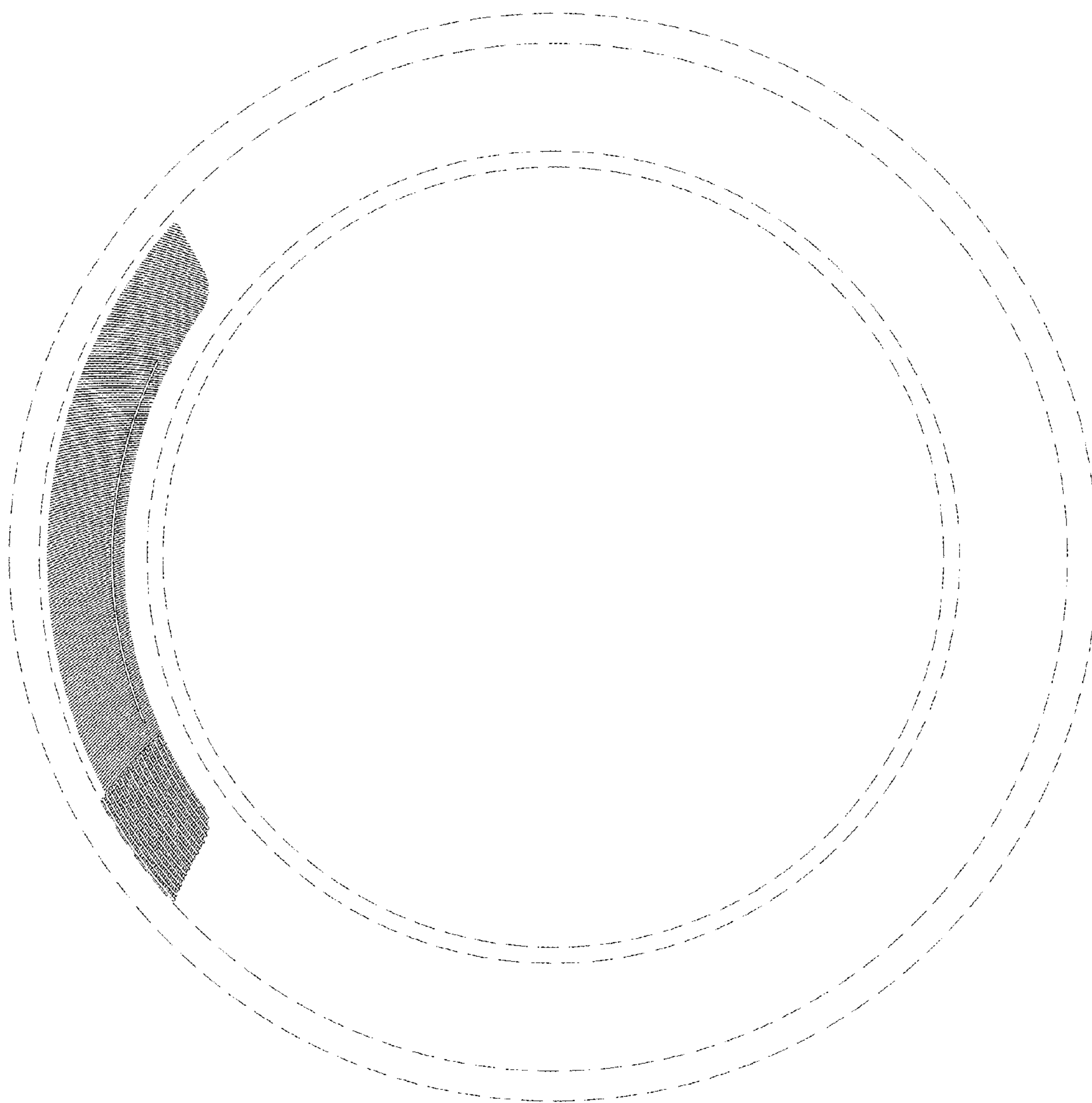

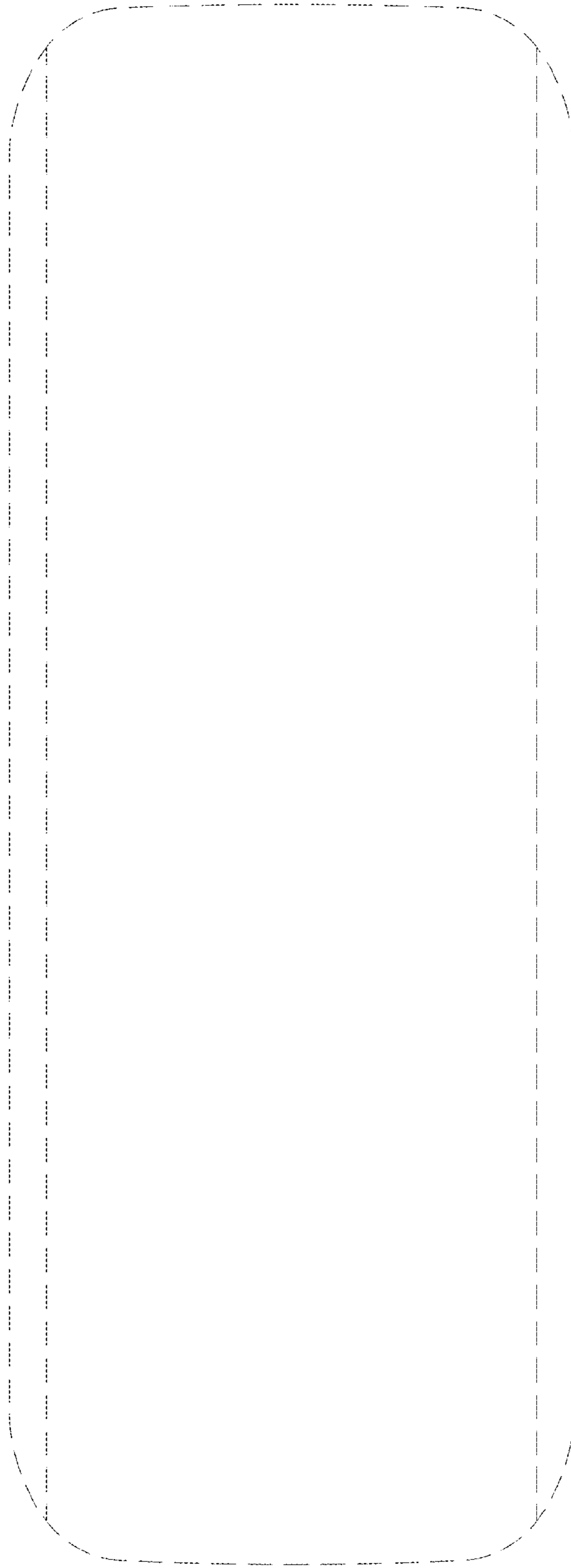

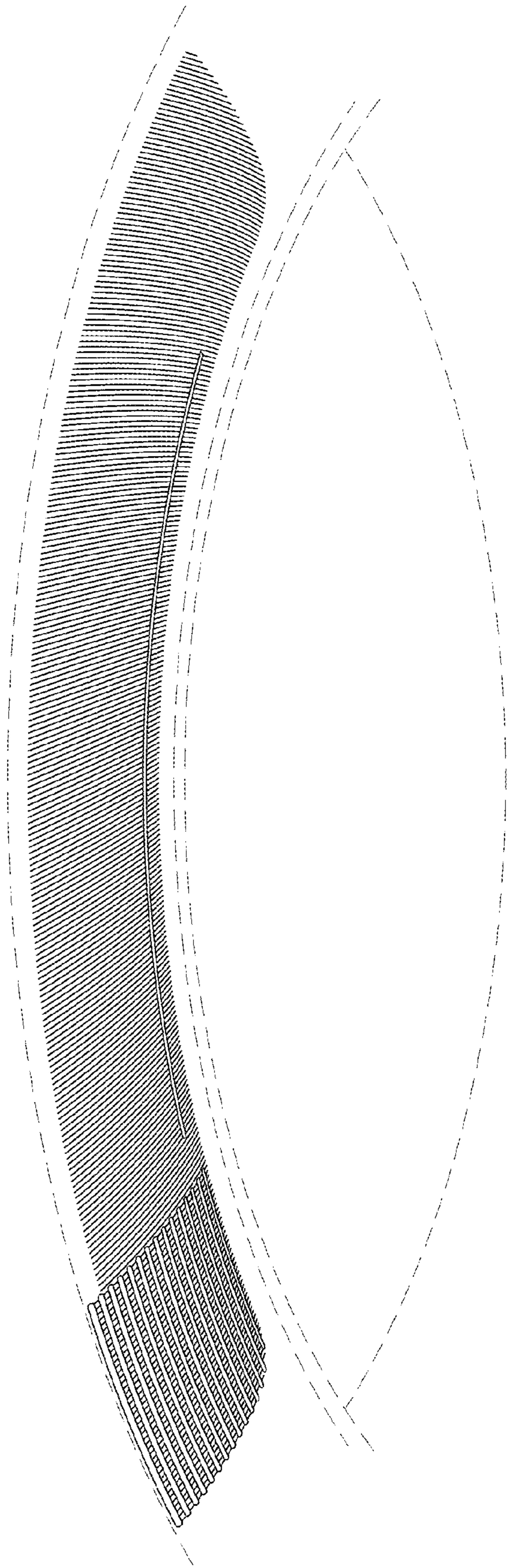
