DESCRIPTION

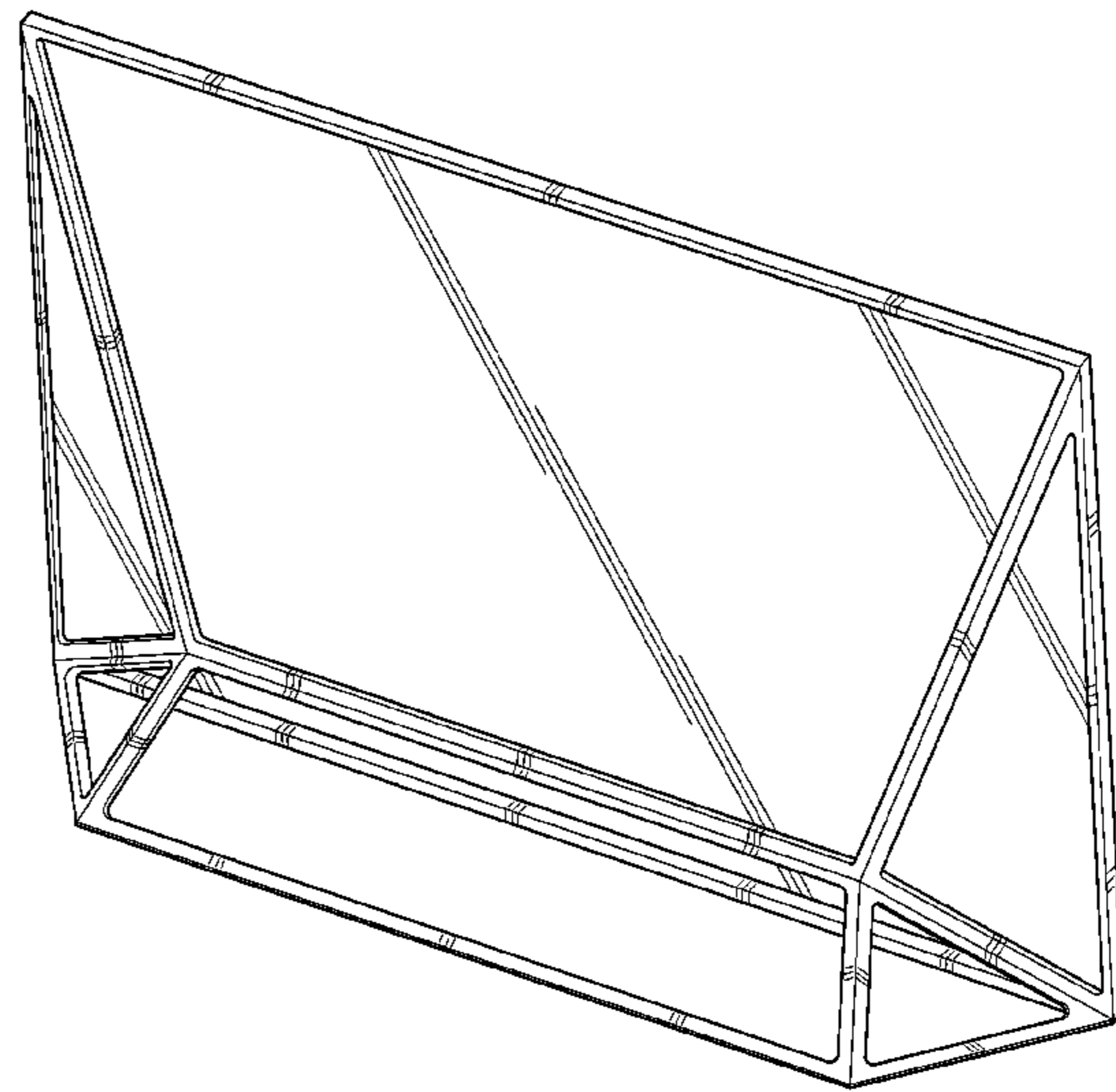
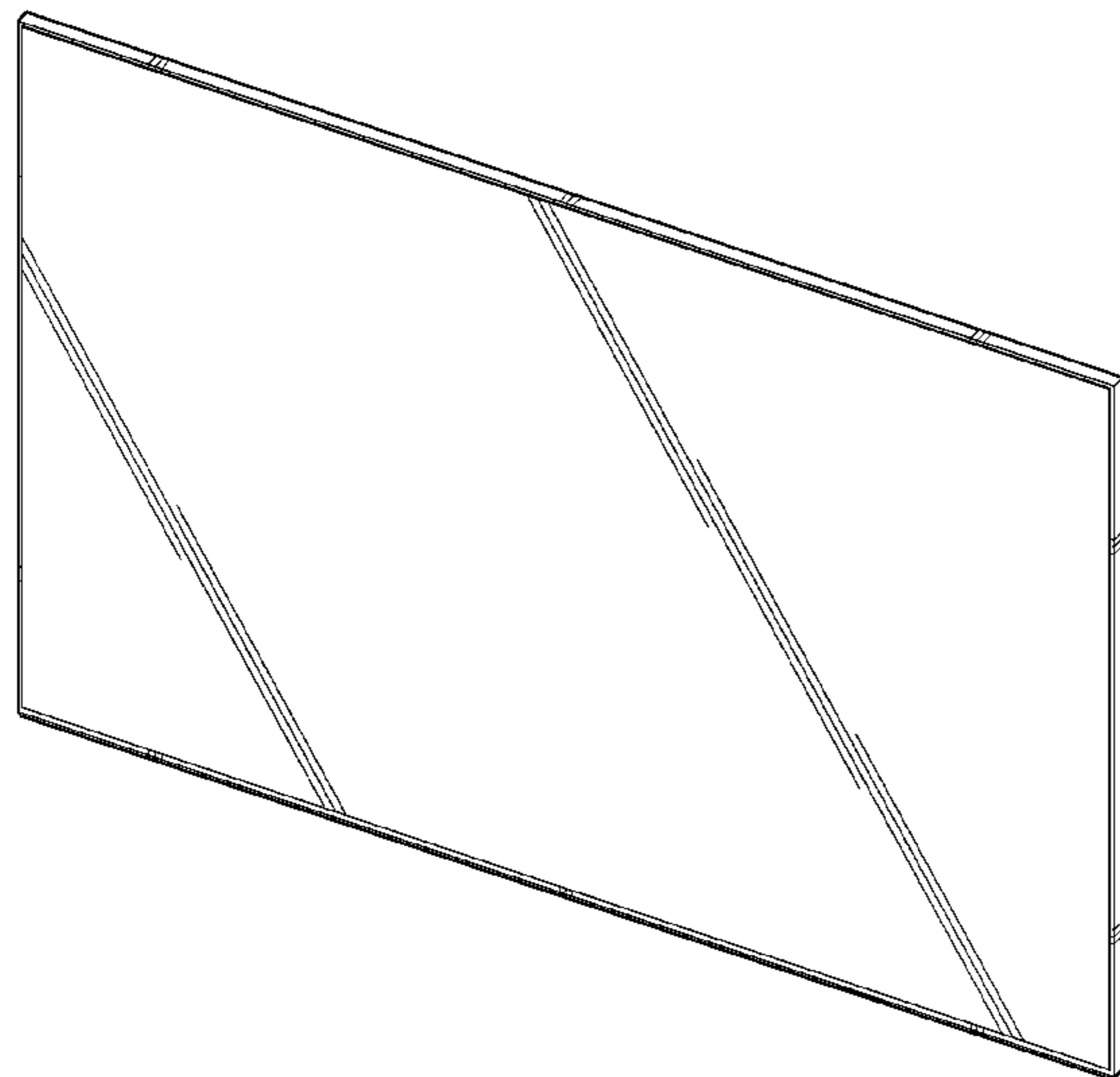

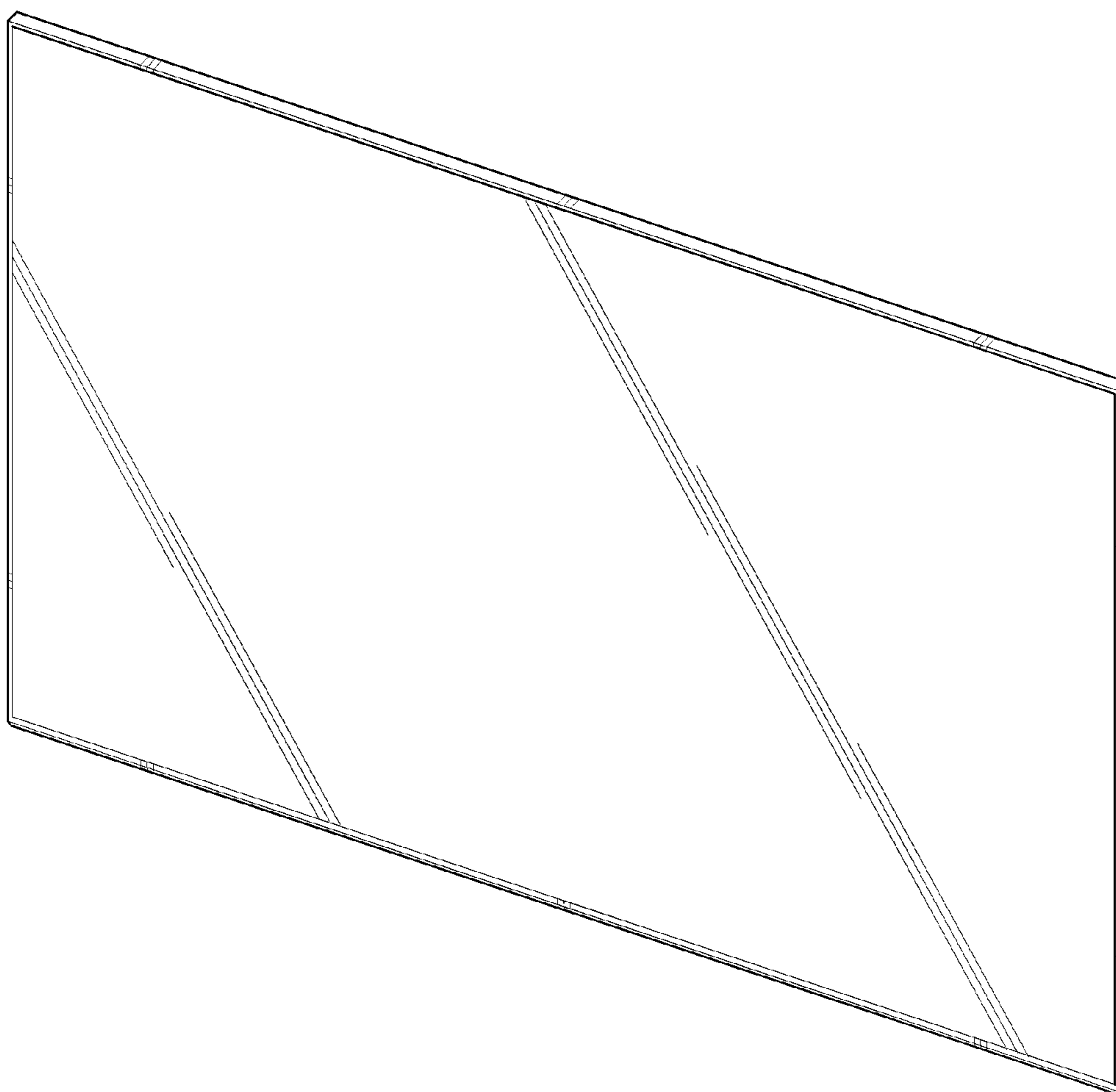

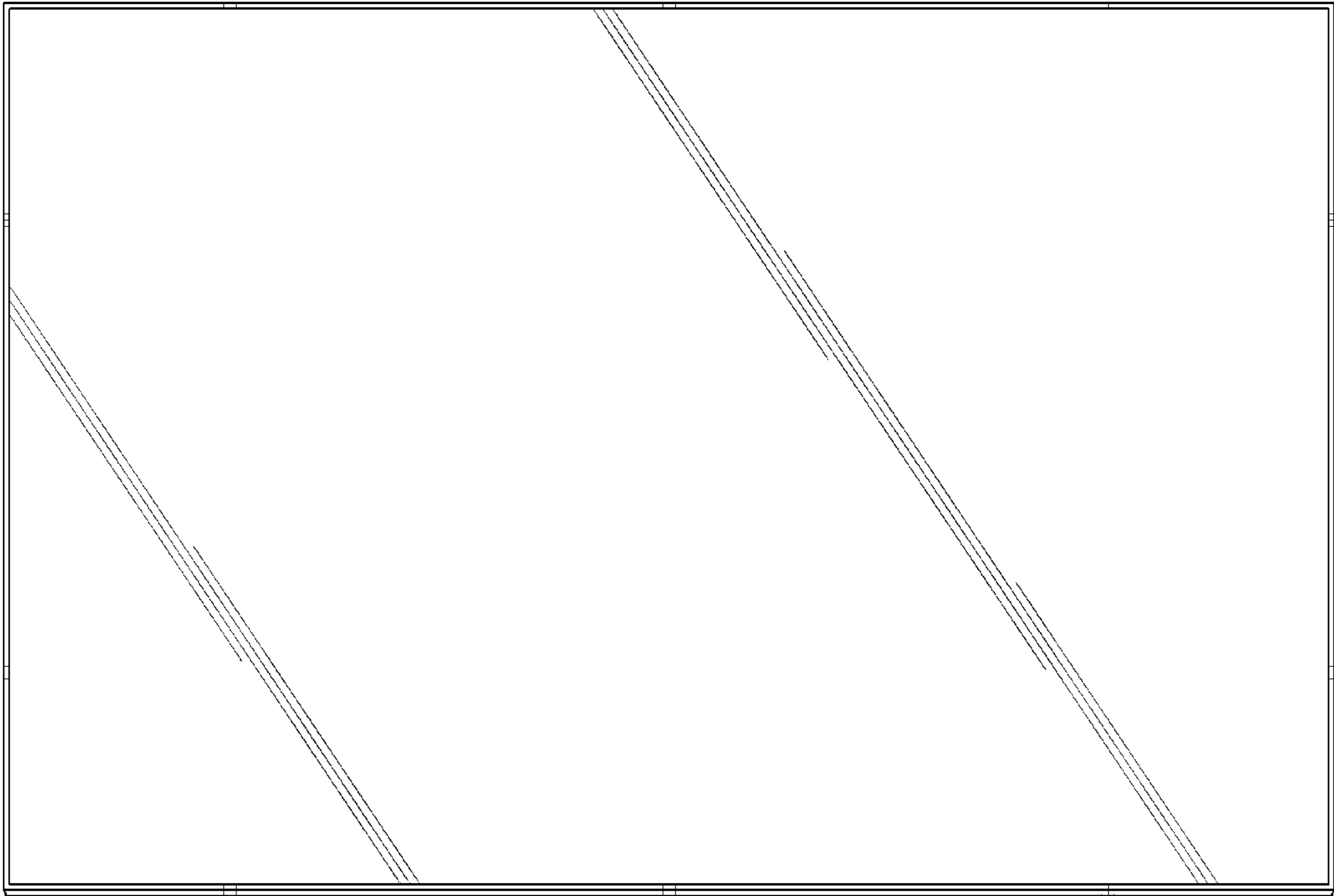

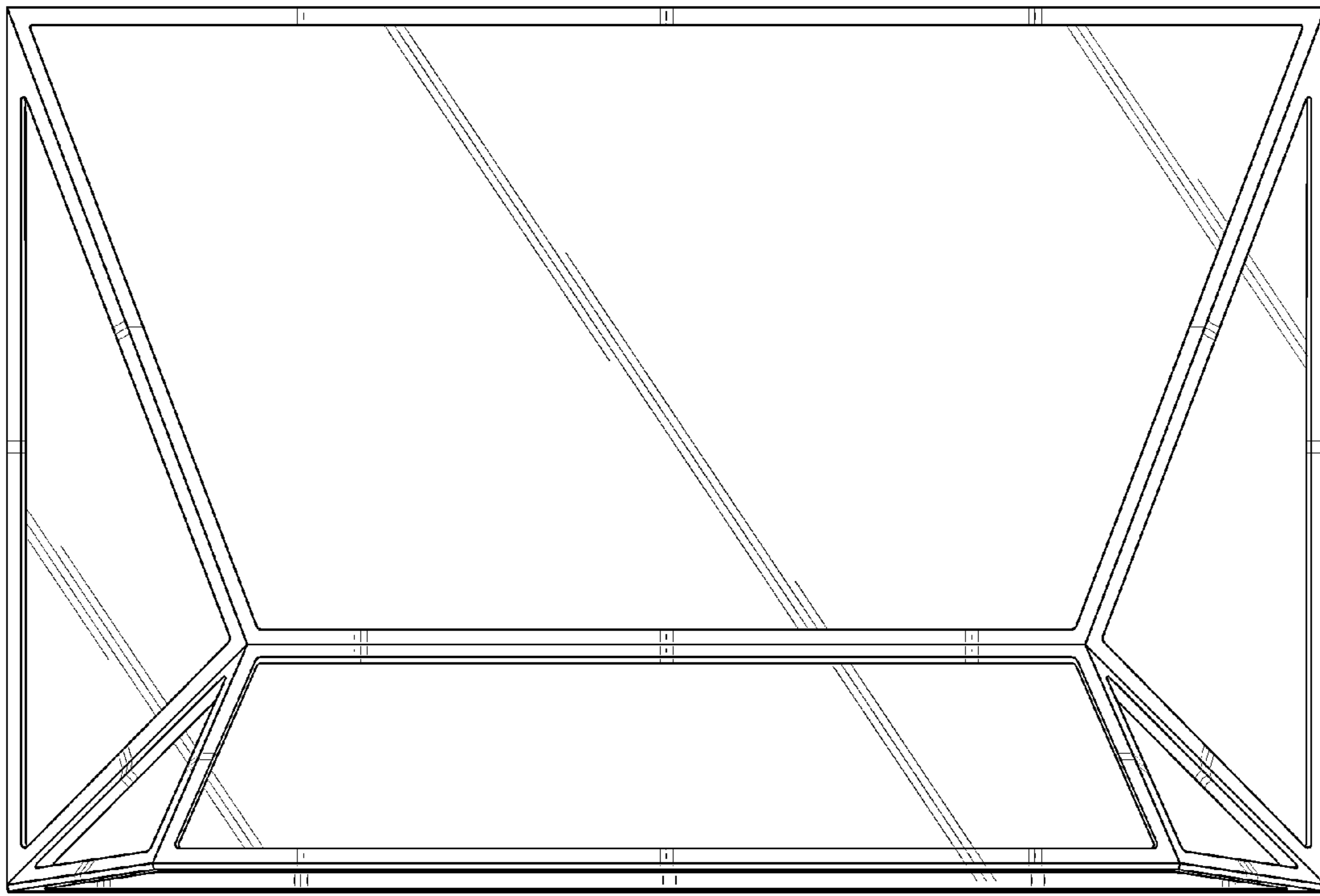

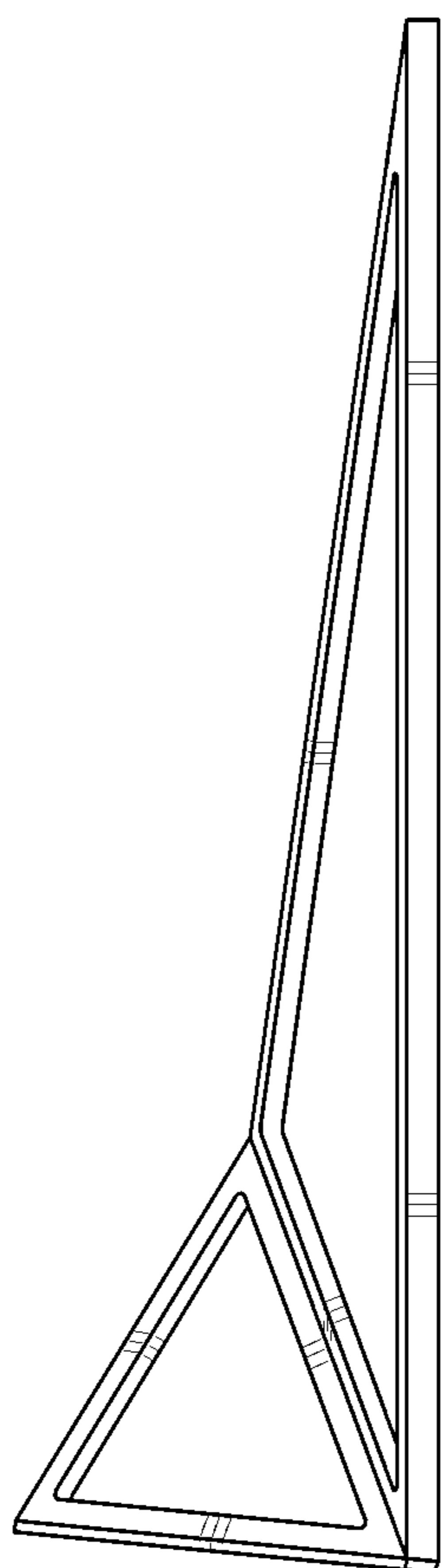

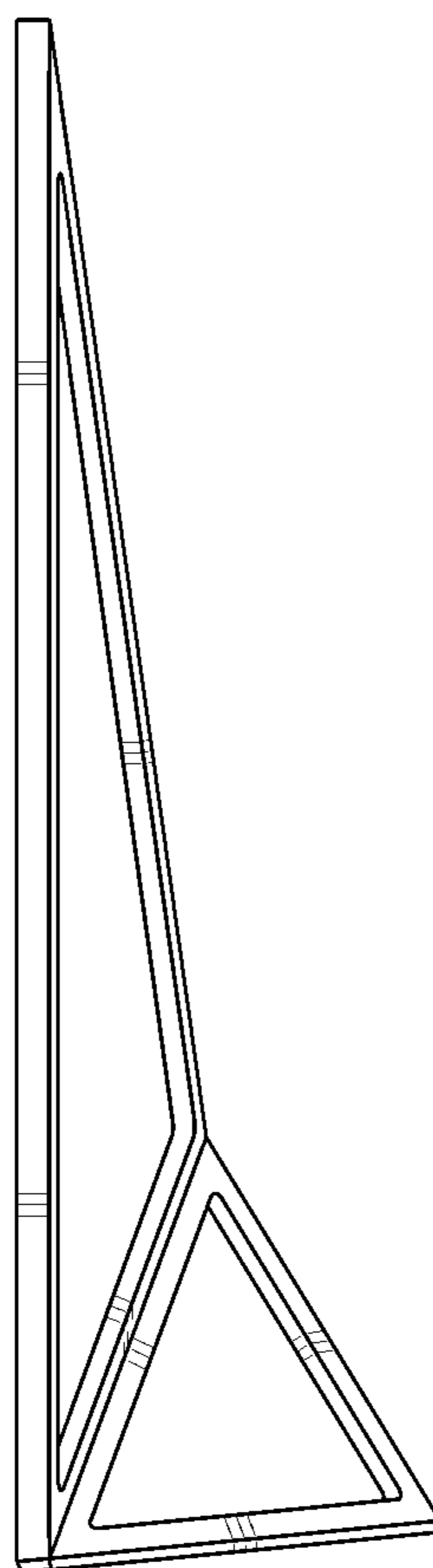

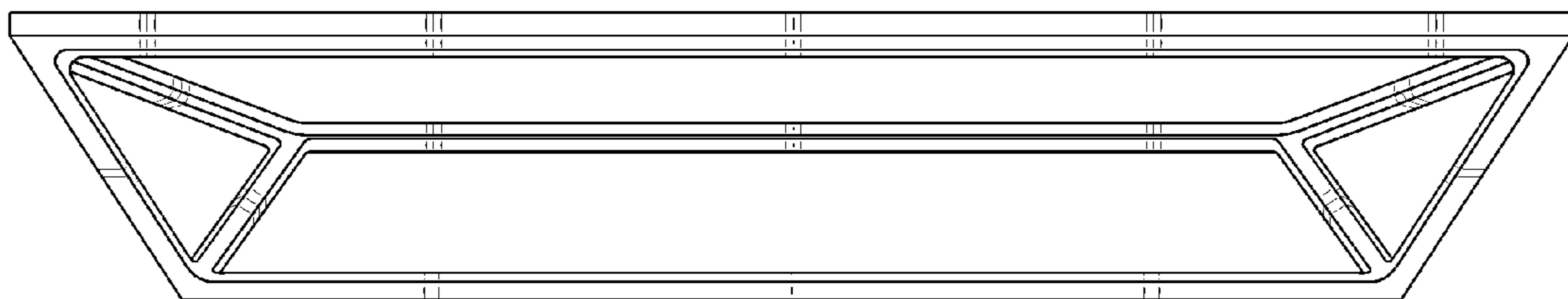
