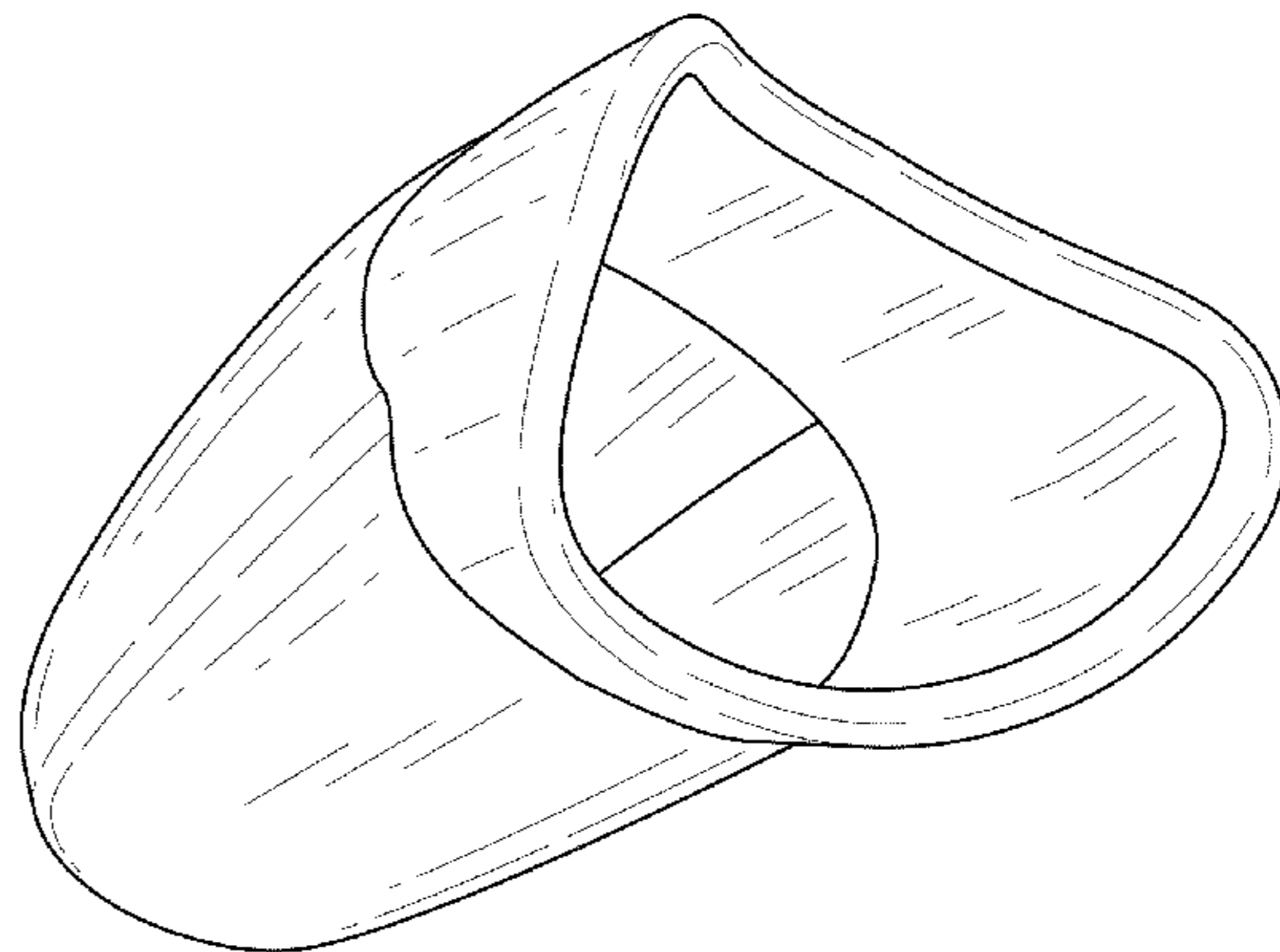
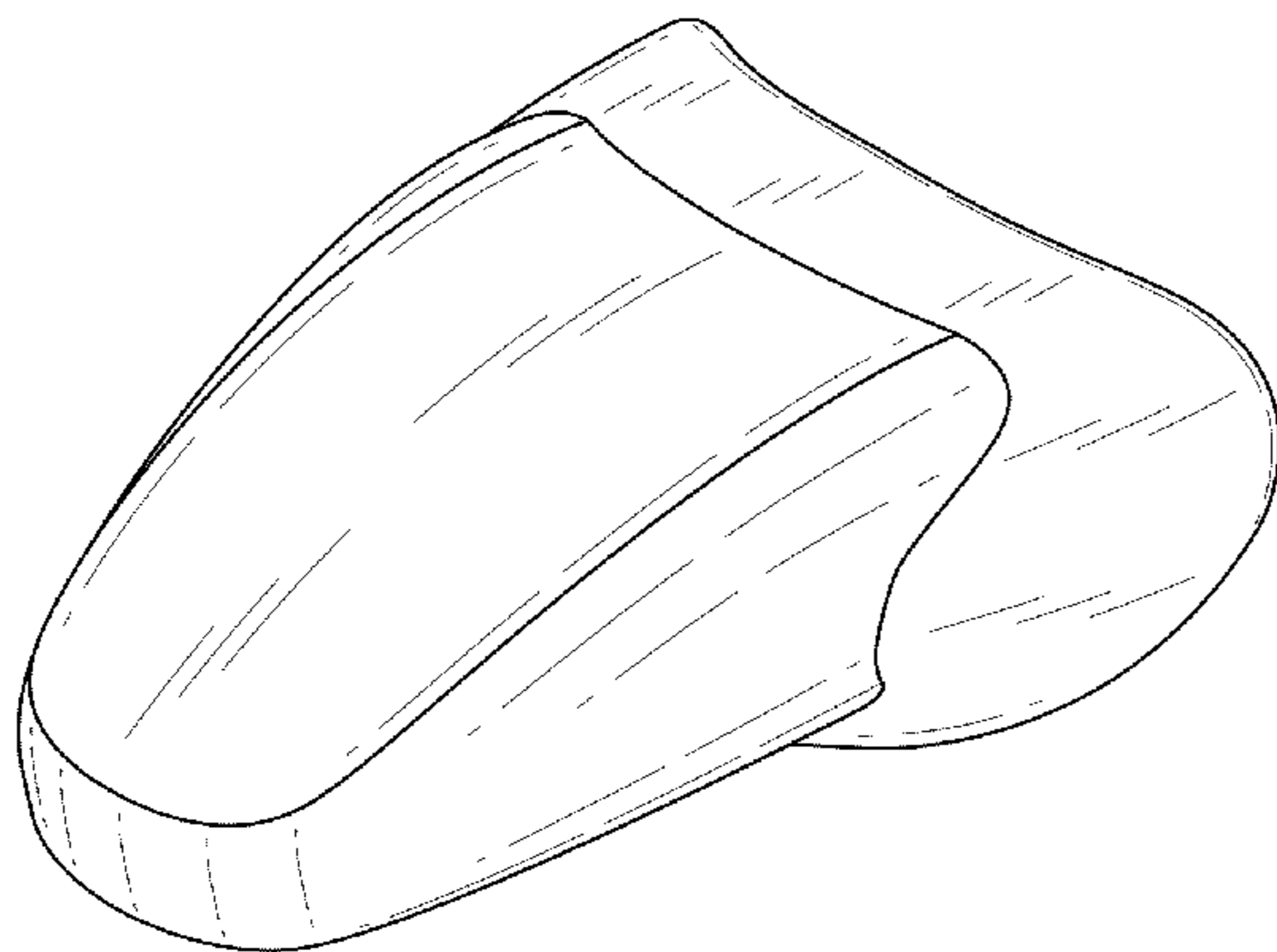
(57) **CLAIM**

The ornamental design for a sleek voice mask, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of the sleek voice mask; FIG. 2 is the bottom front perspective view of the sleek voice mask shown in FIG. 1; FIG. 3 is the rear view of the folding voice mask shown in FIG. 1; FIG. 4 is the front view of the folding voice mask shown in FIG. 1; FIG. 5 is the left side view of the folding voice mask shown in FIG. 1; FIG. 6 is the right side view of the folding voice mask shown in FIG. 1; FIG. 7 is the top view of the folding voice mask shown in FIG. 1; and, FIG. 8 is the bottom view of the folding voice mask shown in FIG. 1.

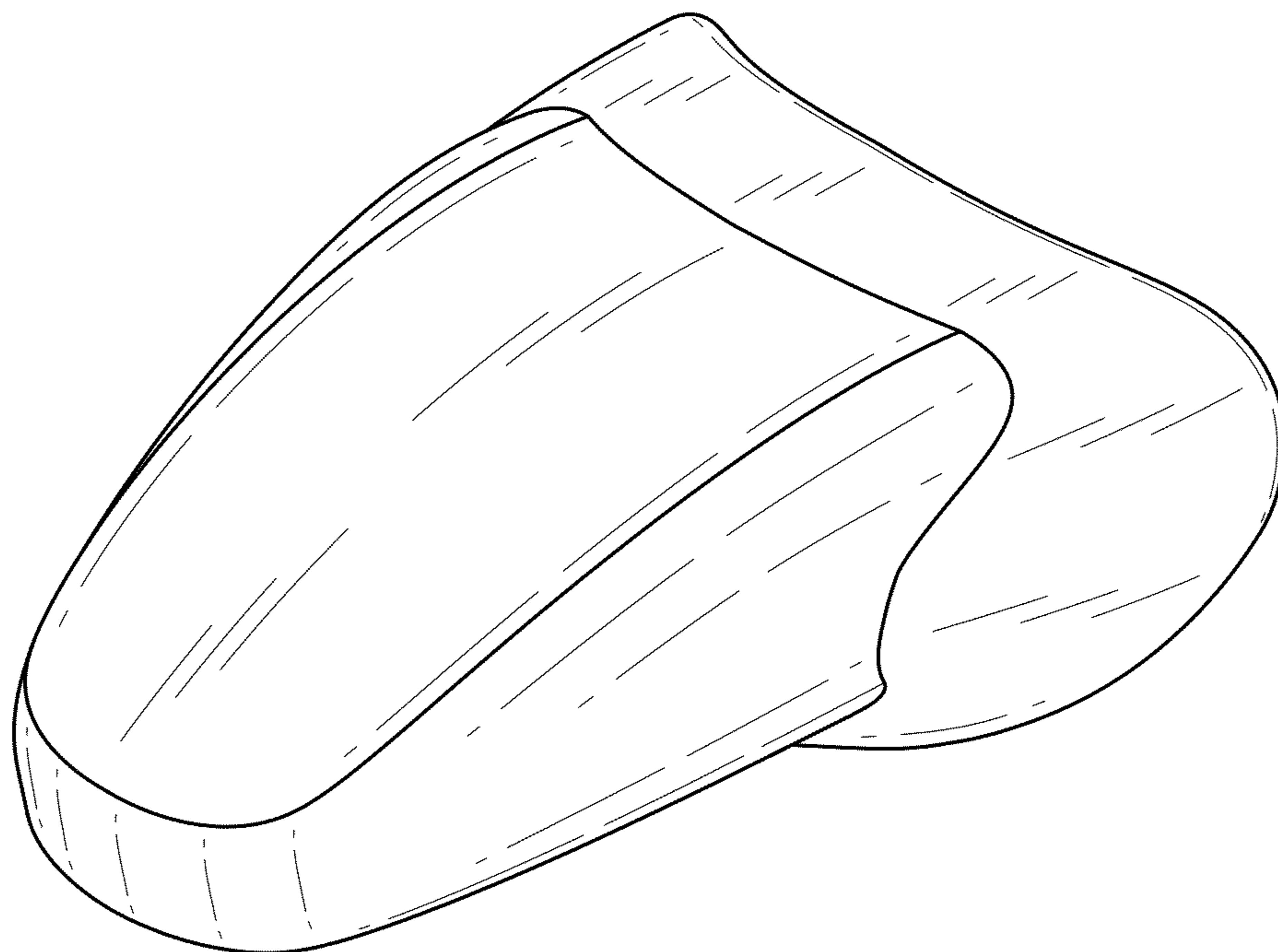

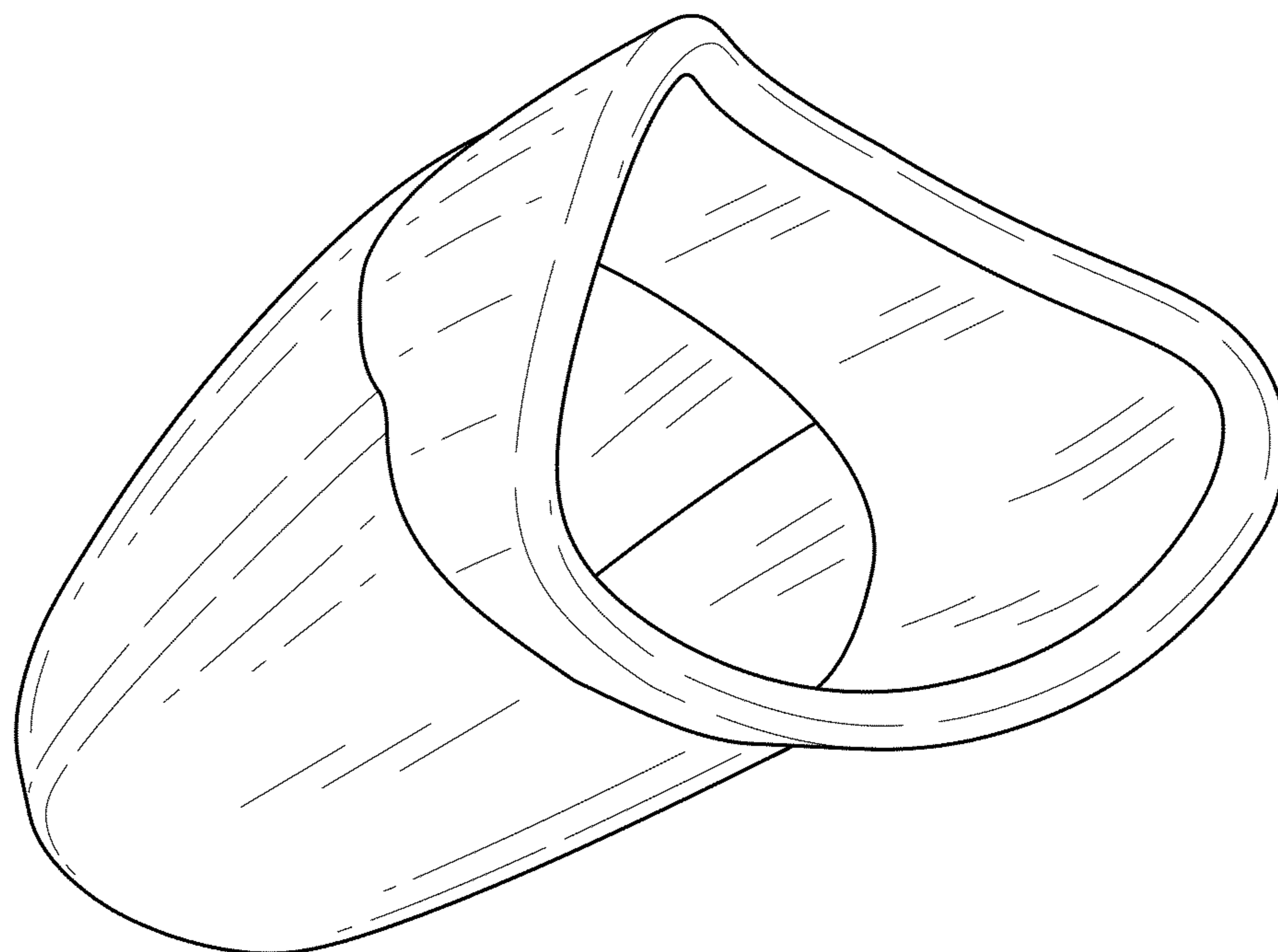

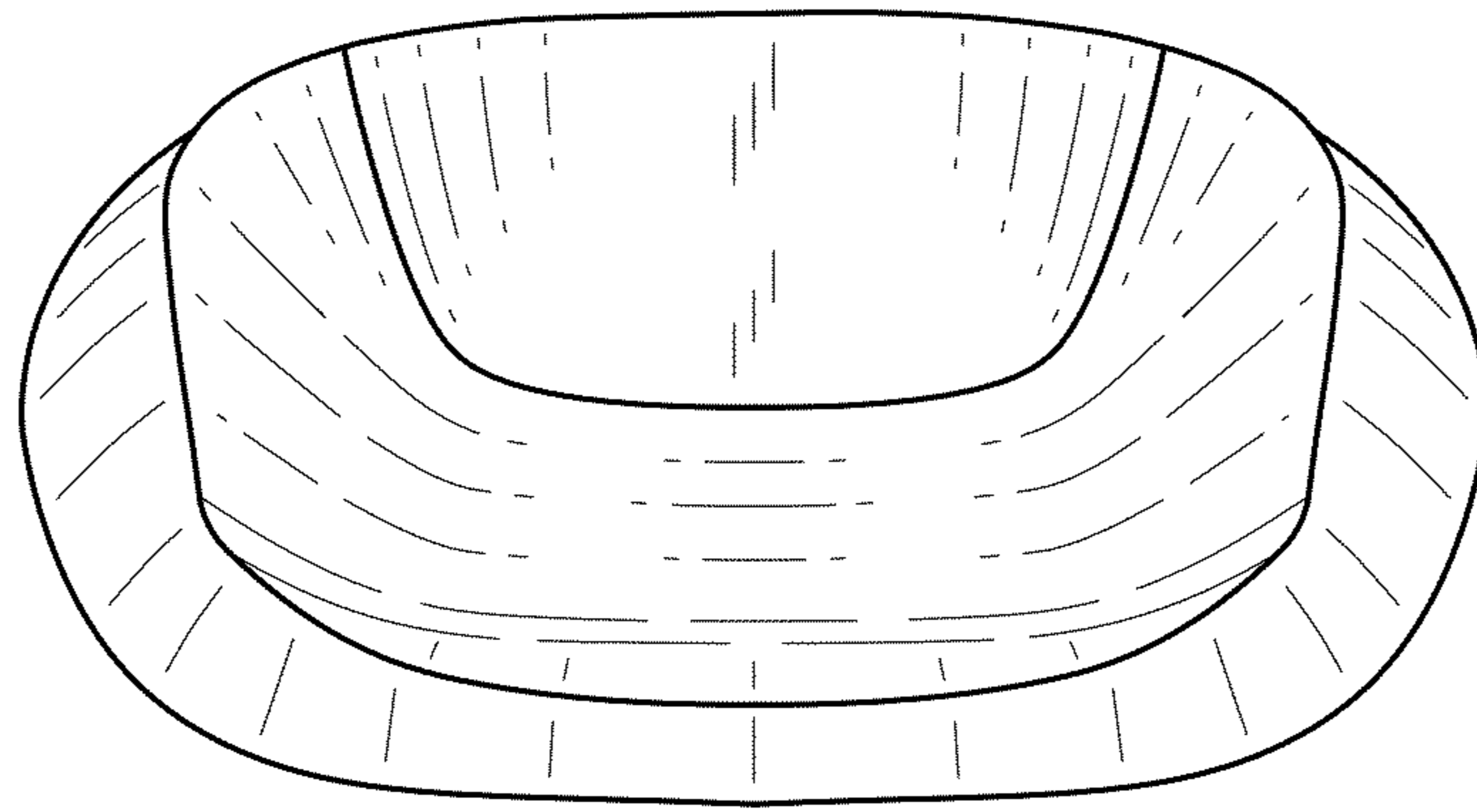

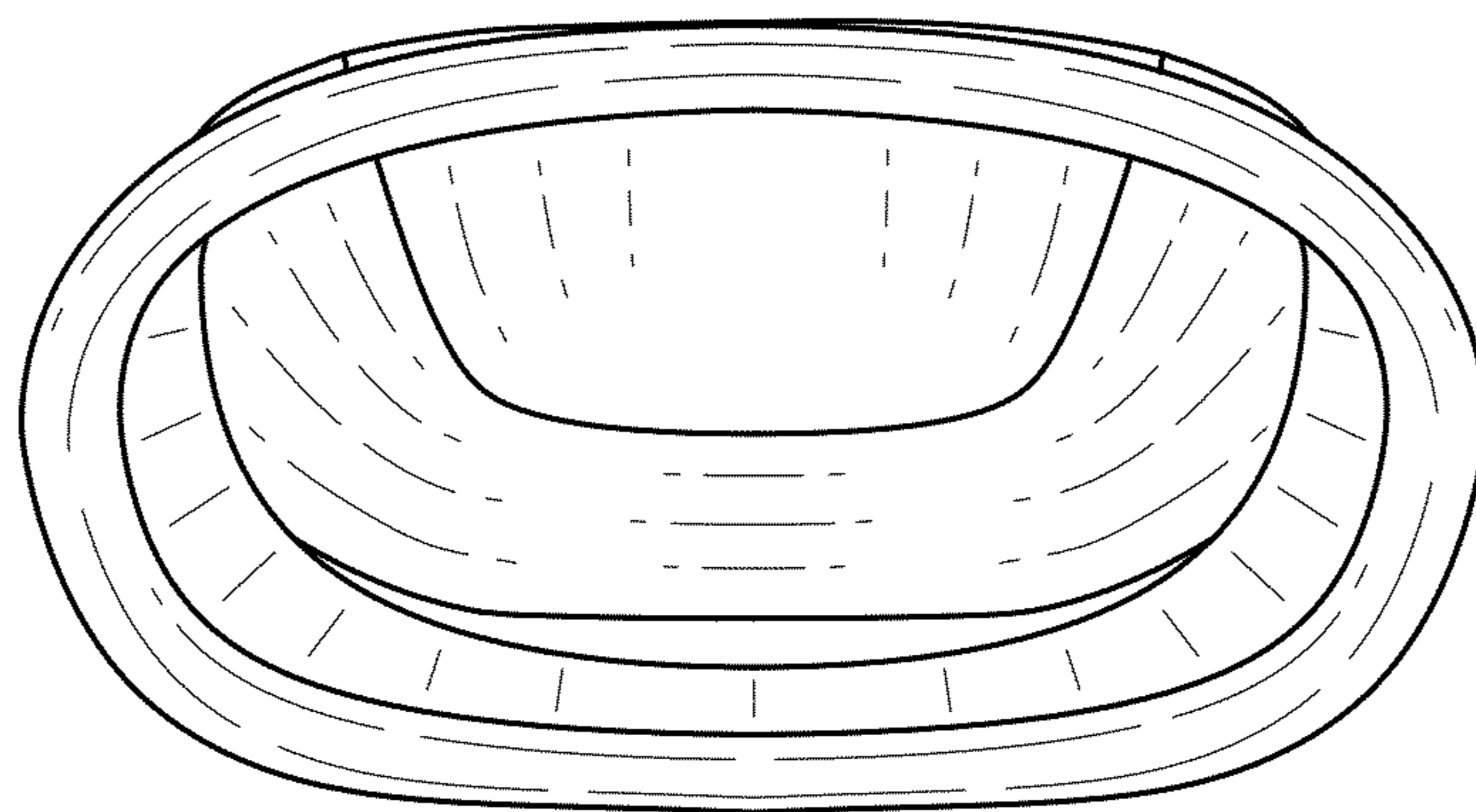

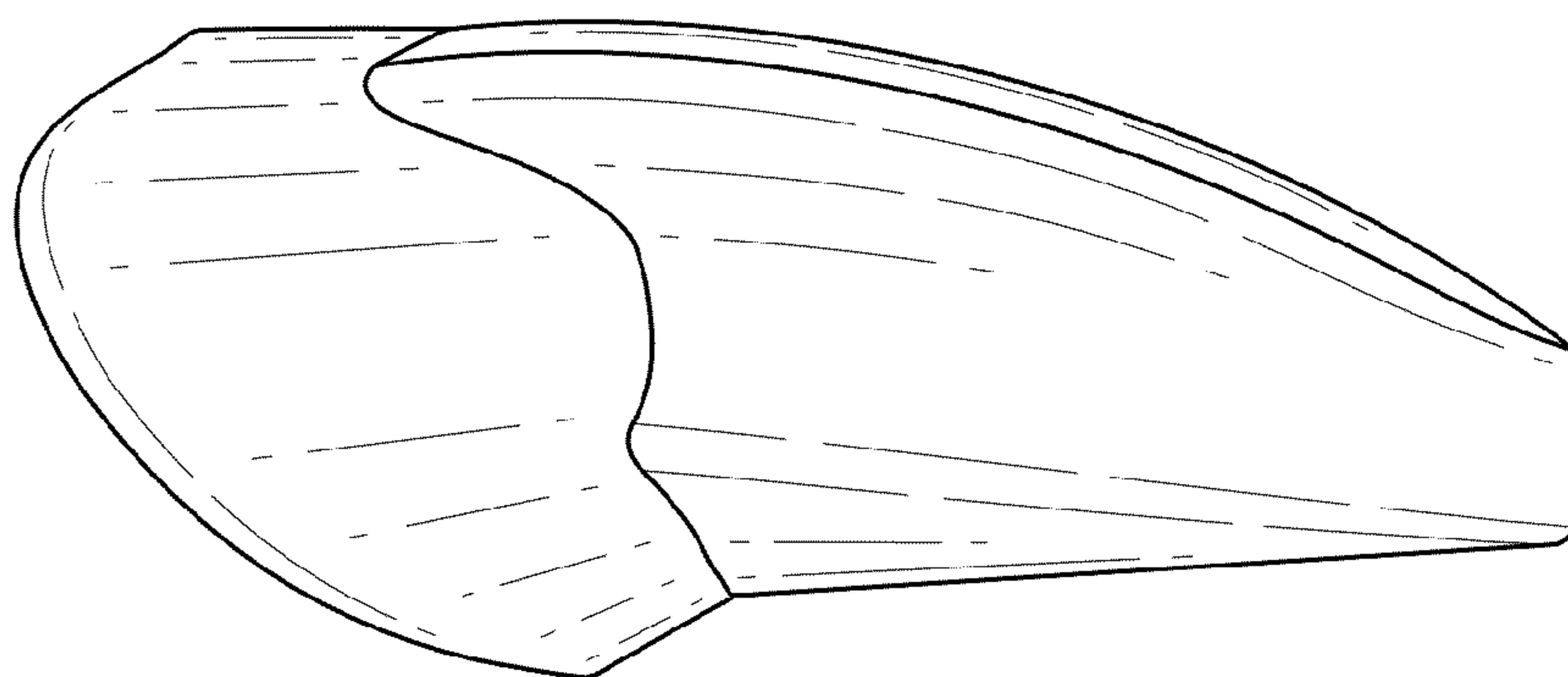

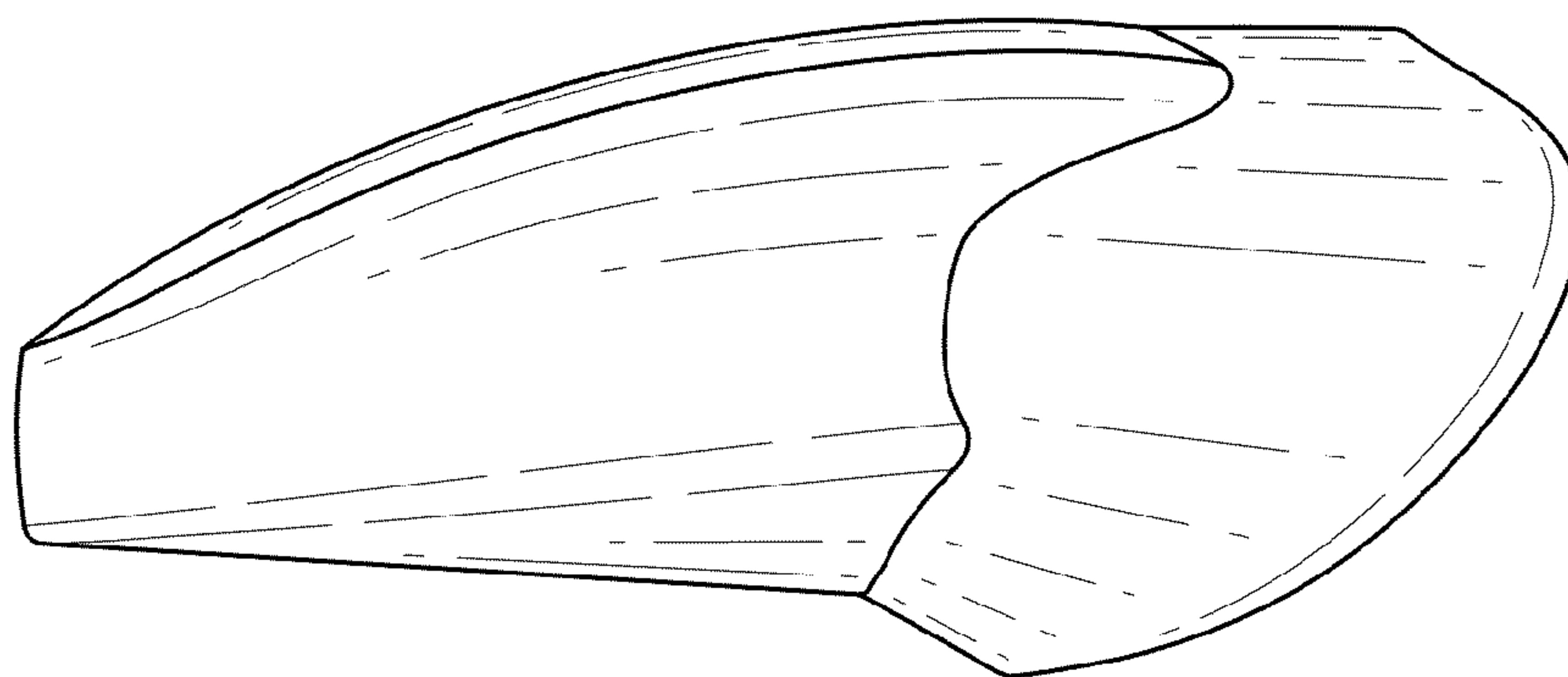

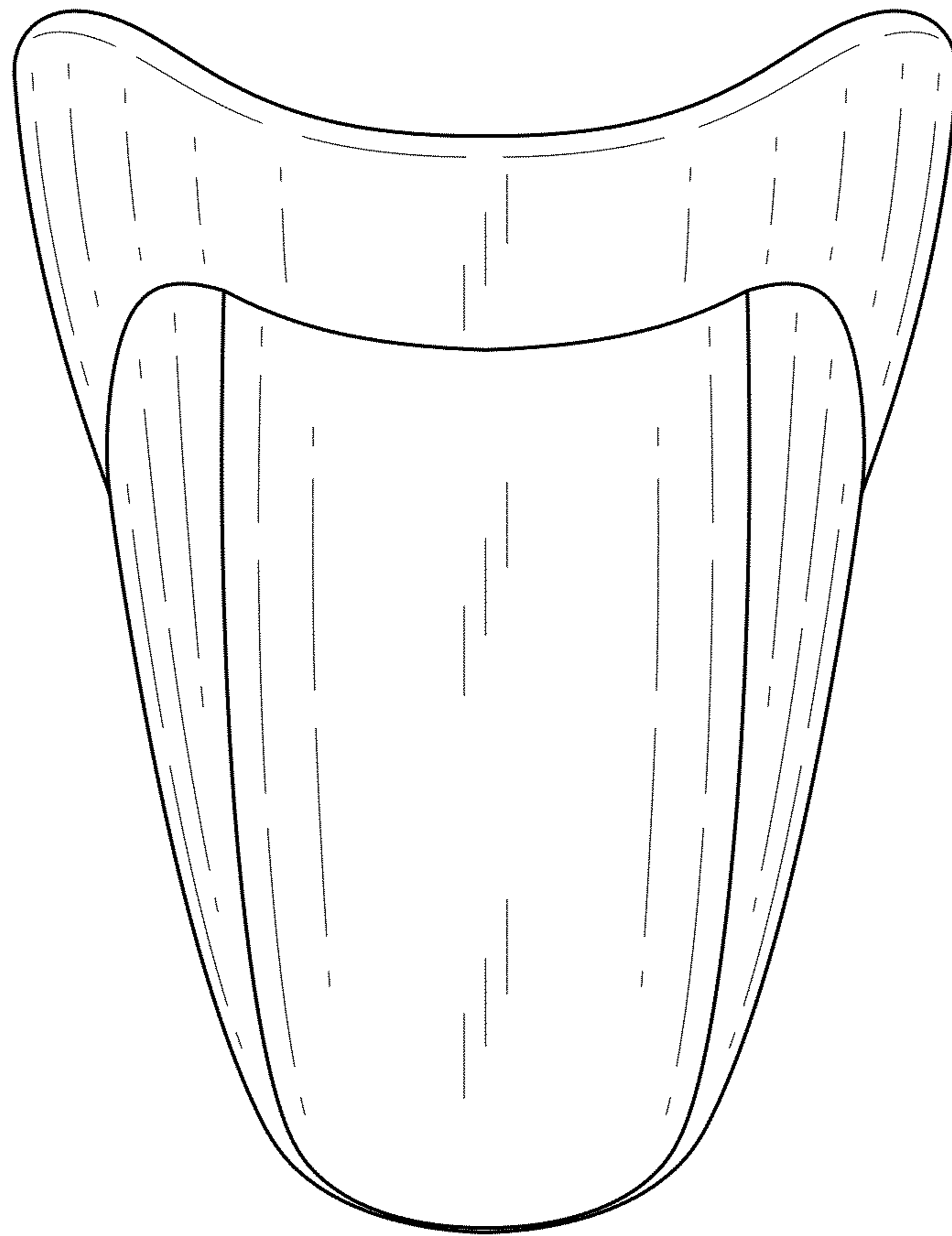

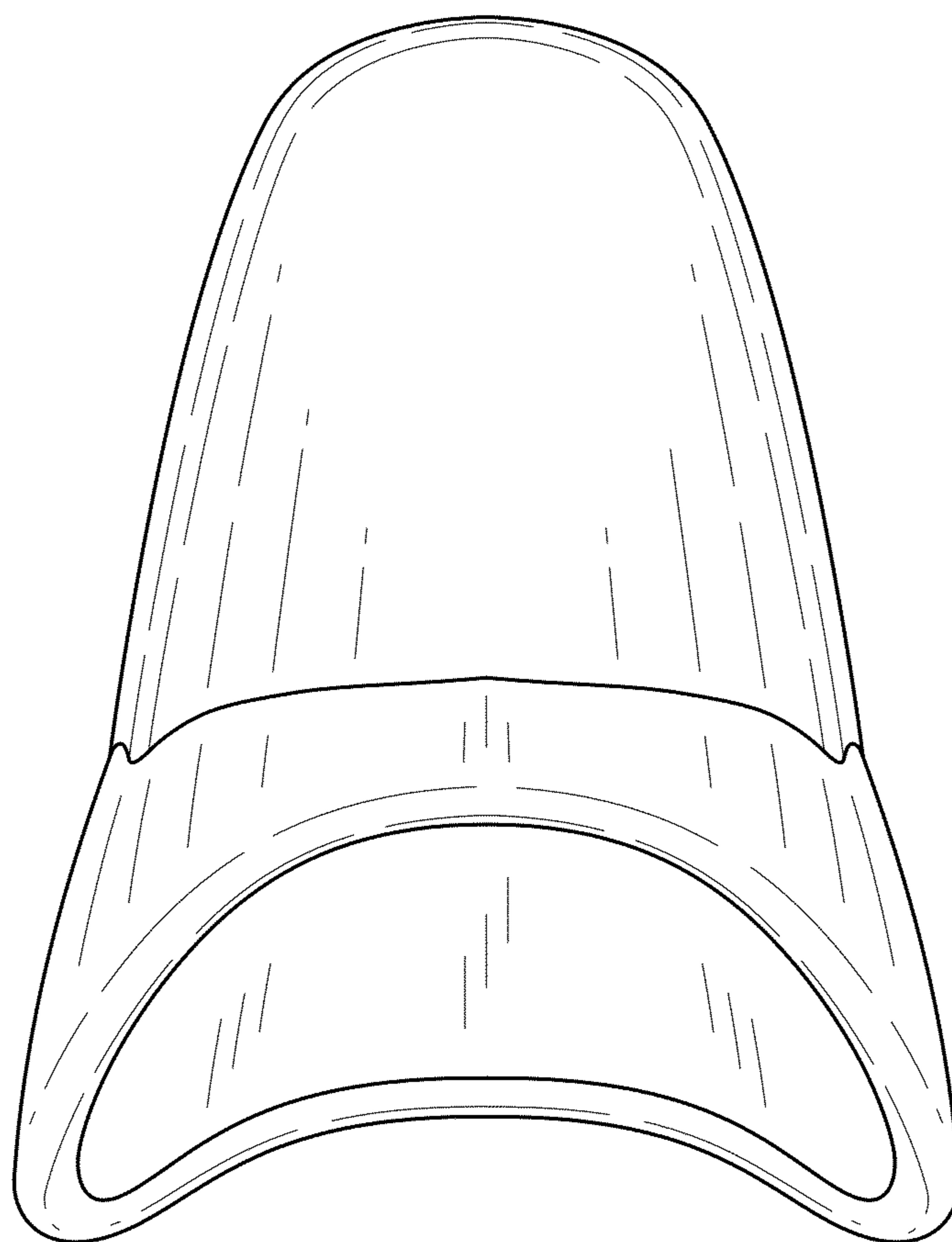
